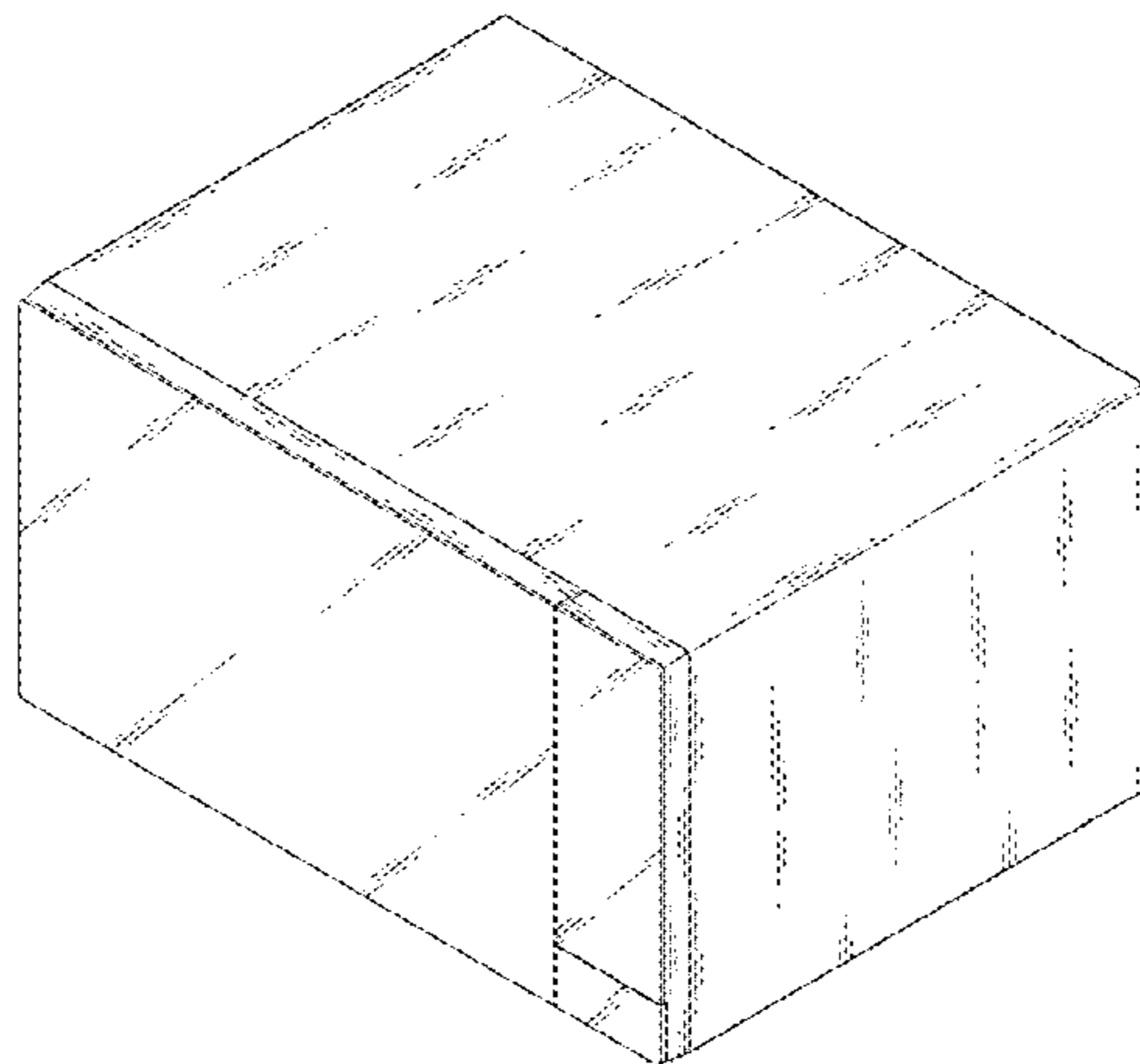
(57) **CLAIM**

The ornamental design for a microwave oven, as shown and described.

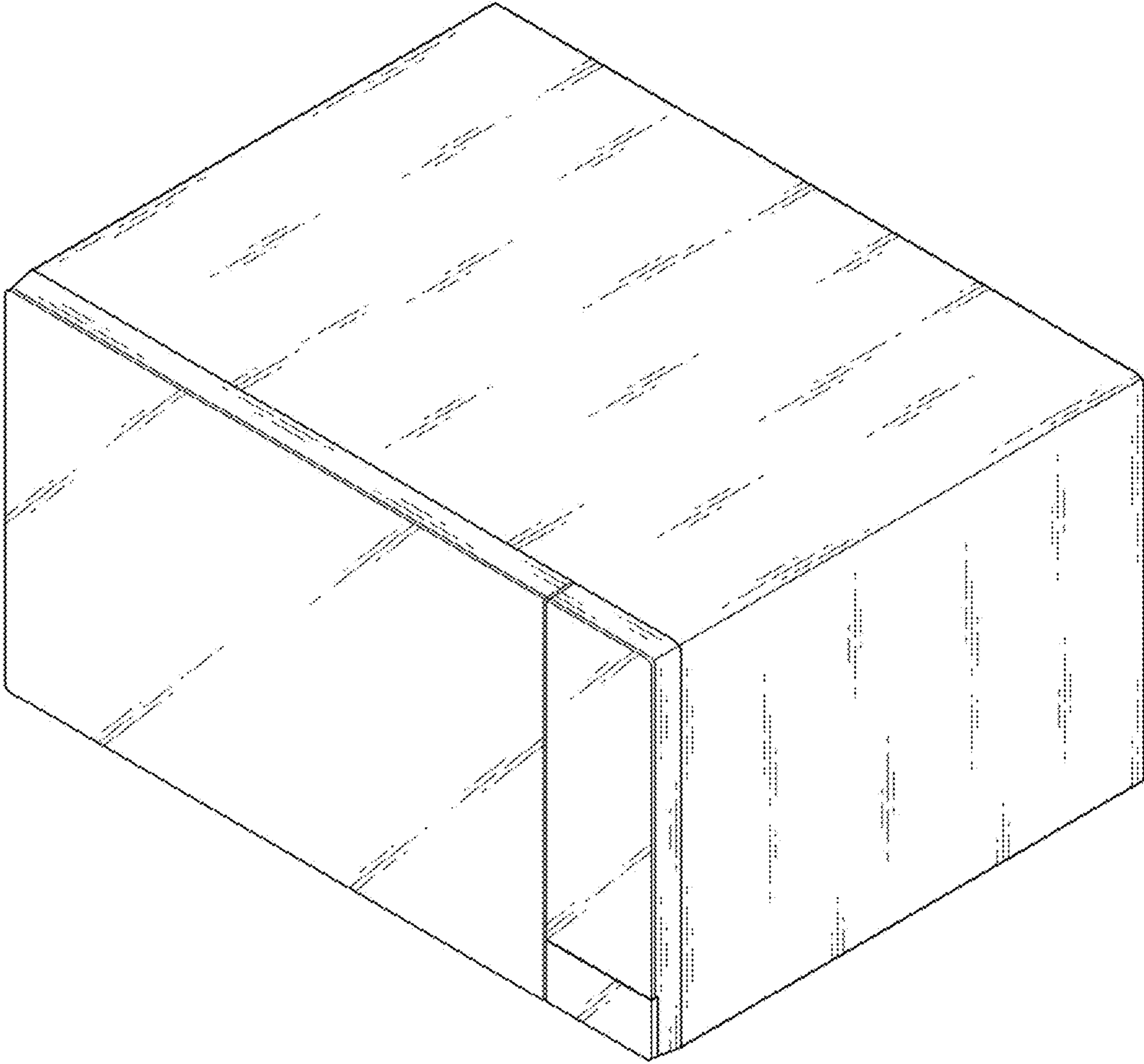
**DESCRIPTION**

1.7 is a bottom plan view thereof.

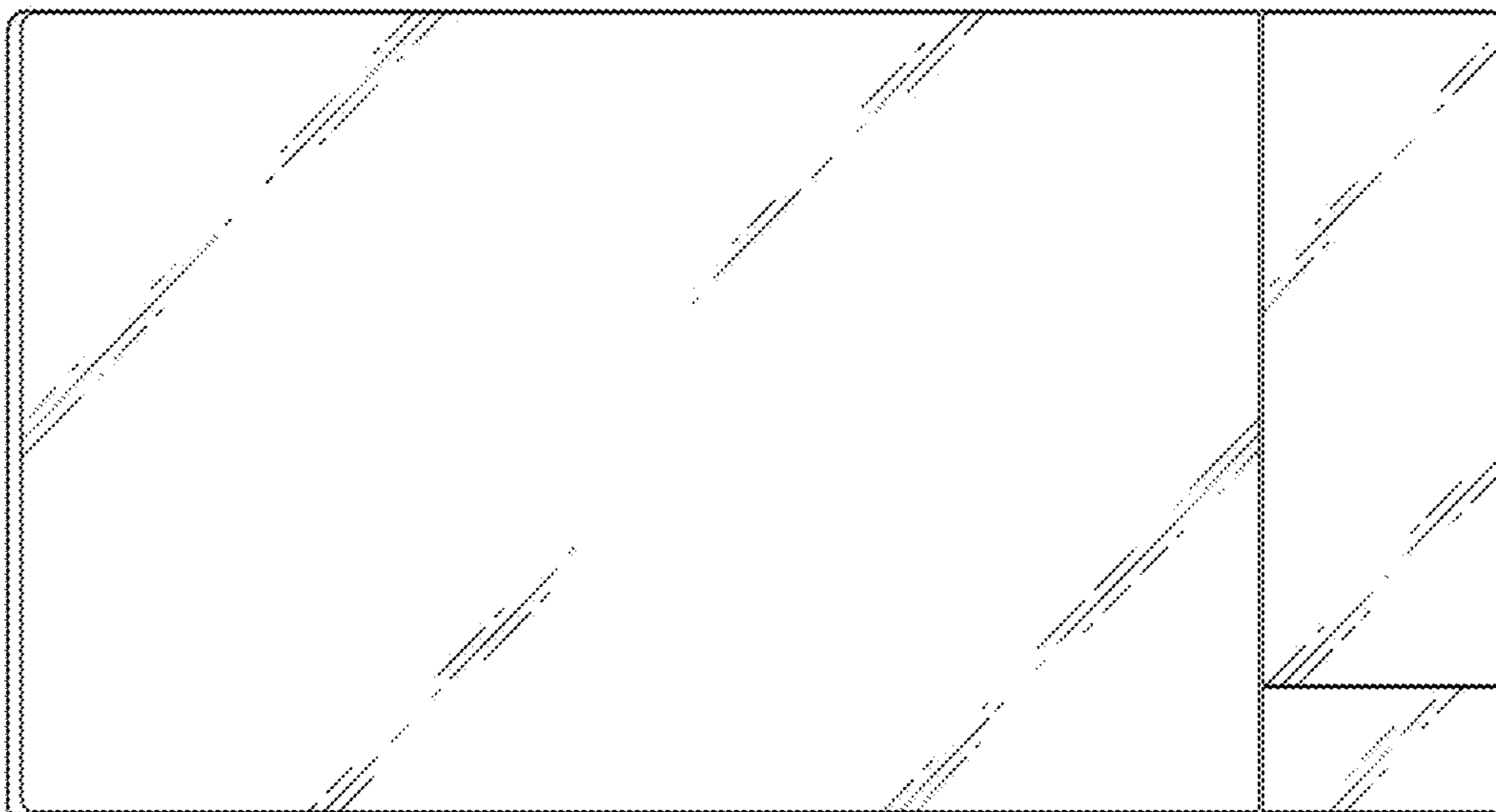

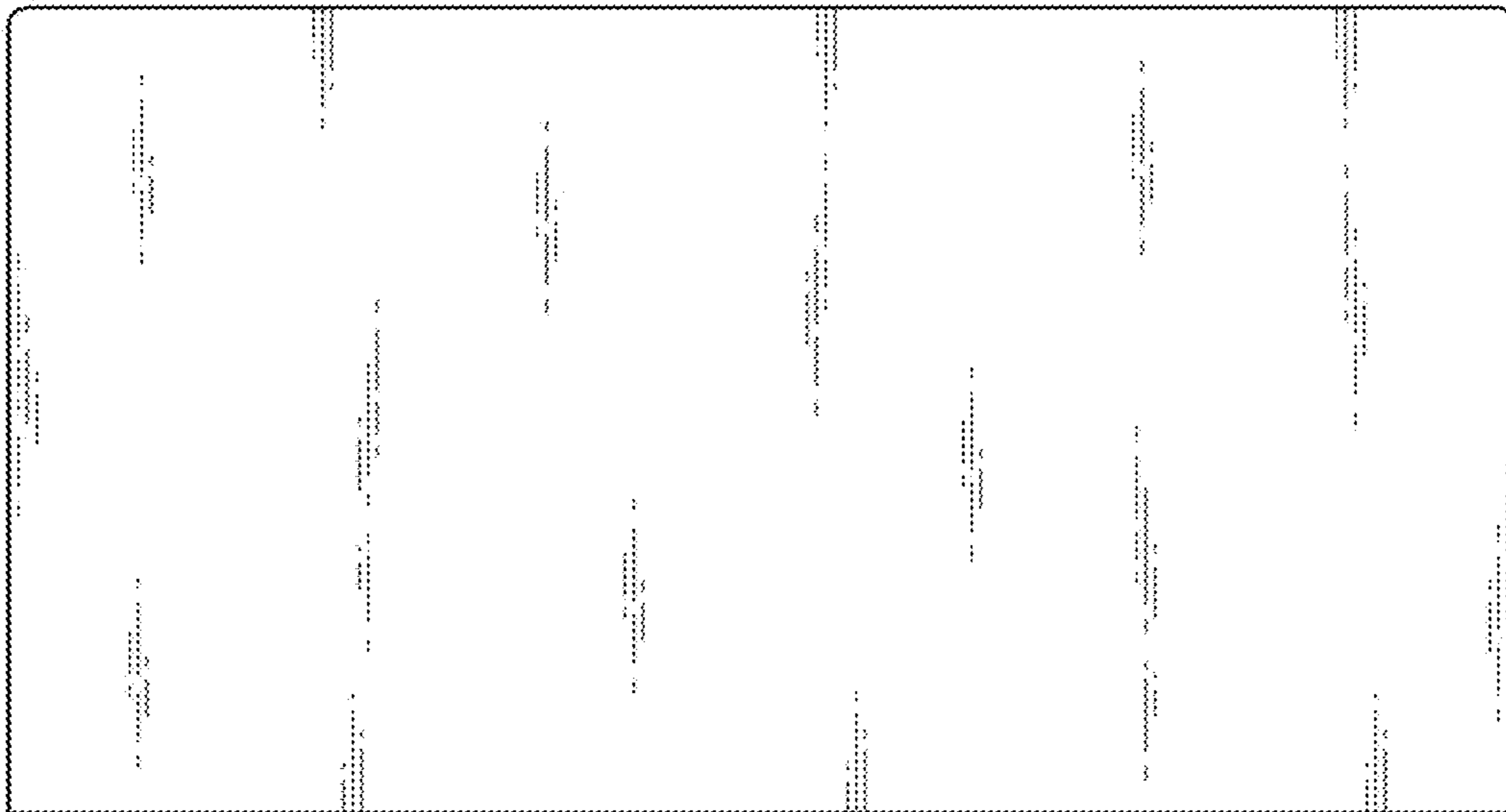

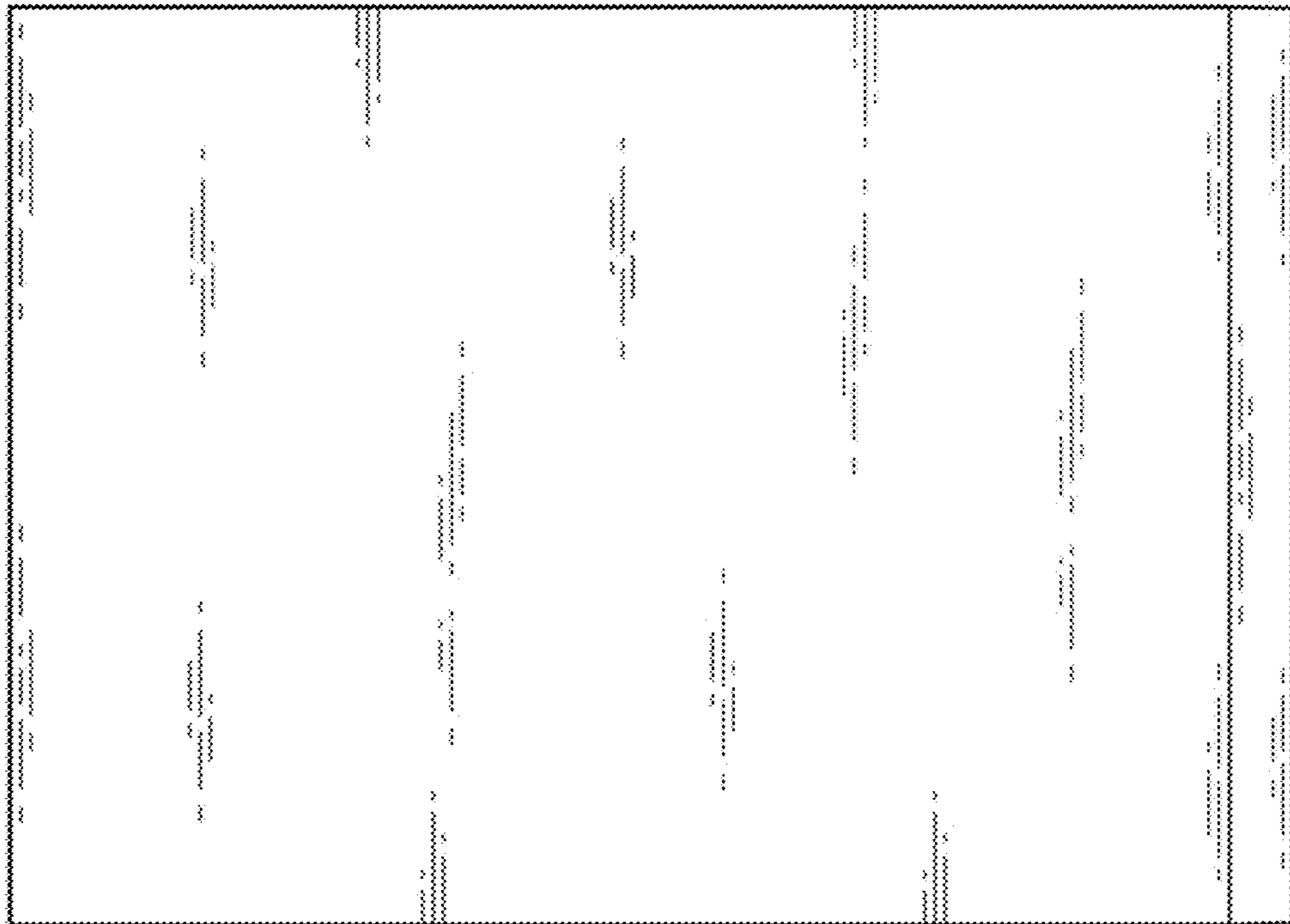

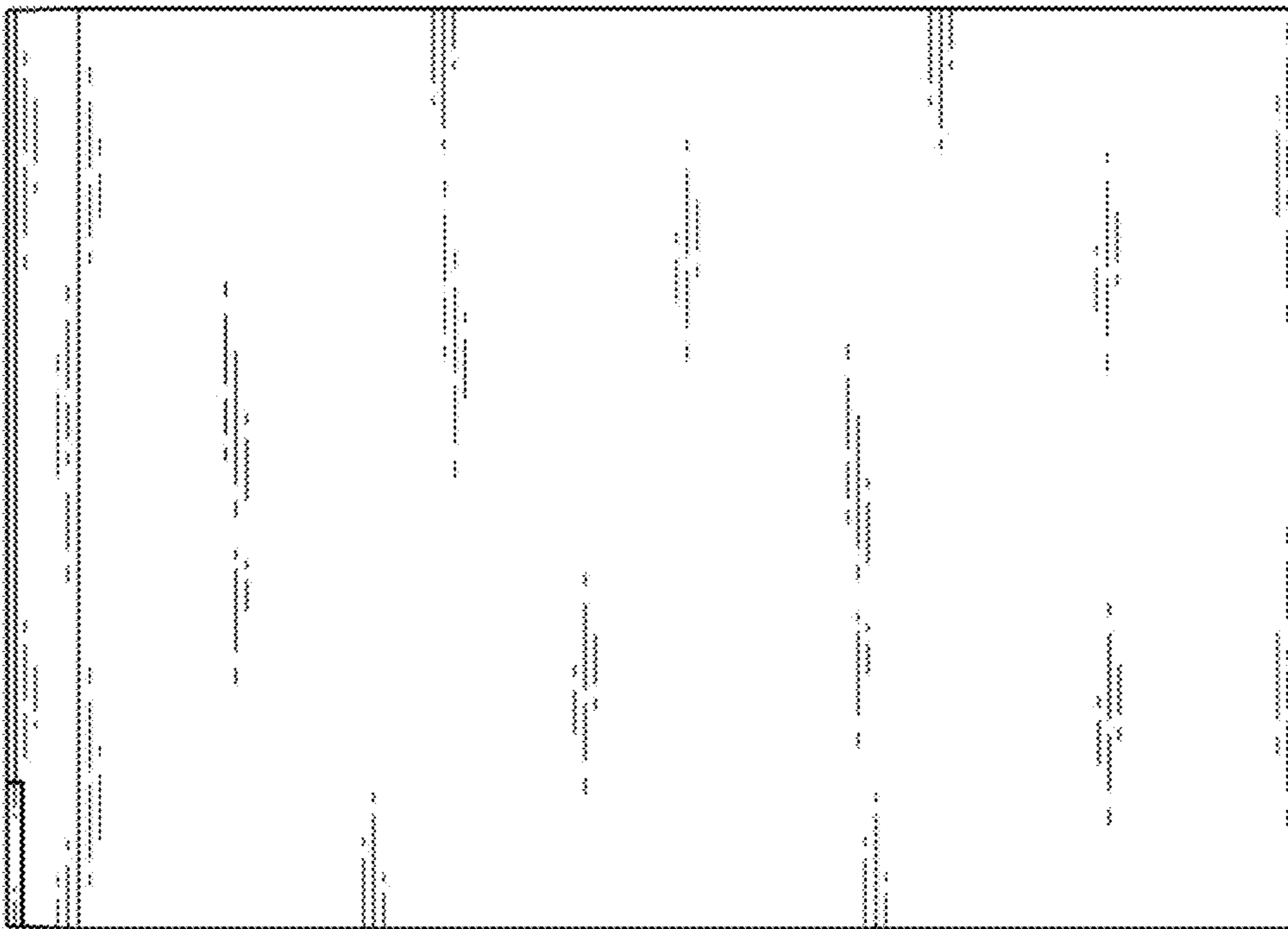

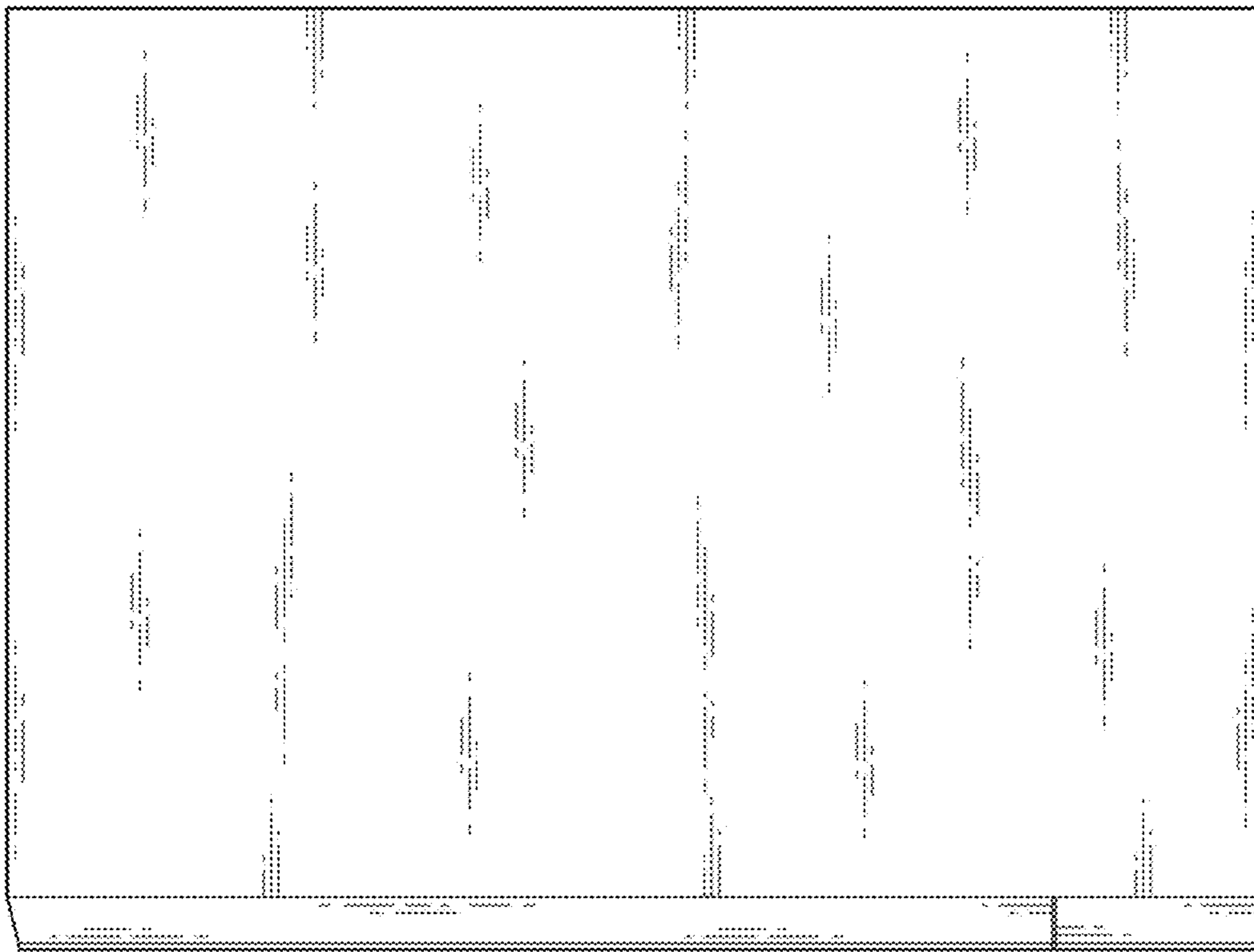
