DESCRIPTION

FIG. 4 is a perspective view from above and to one side thereof; and,

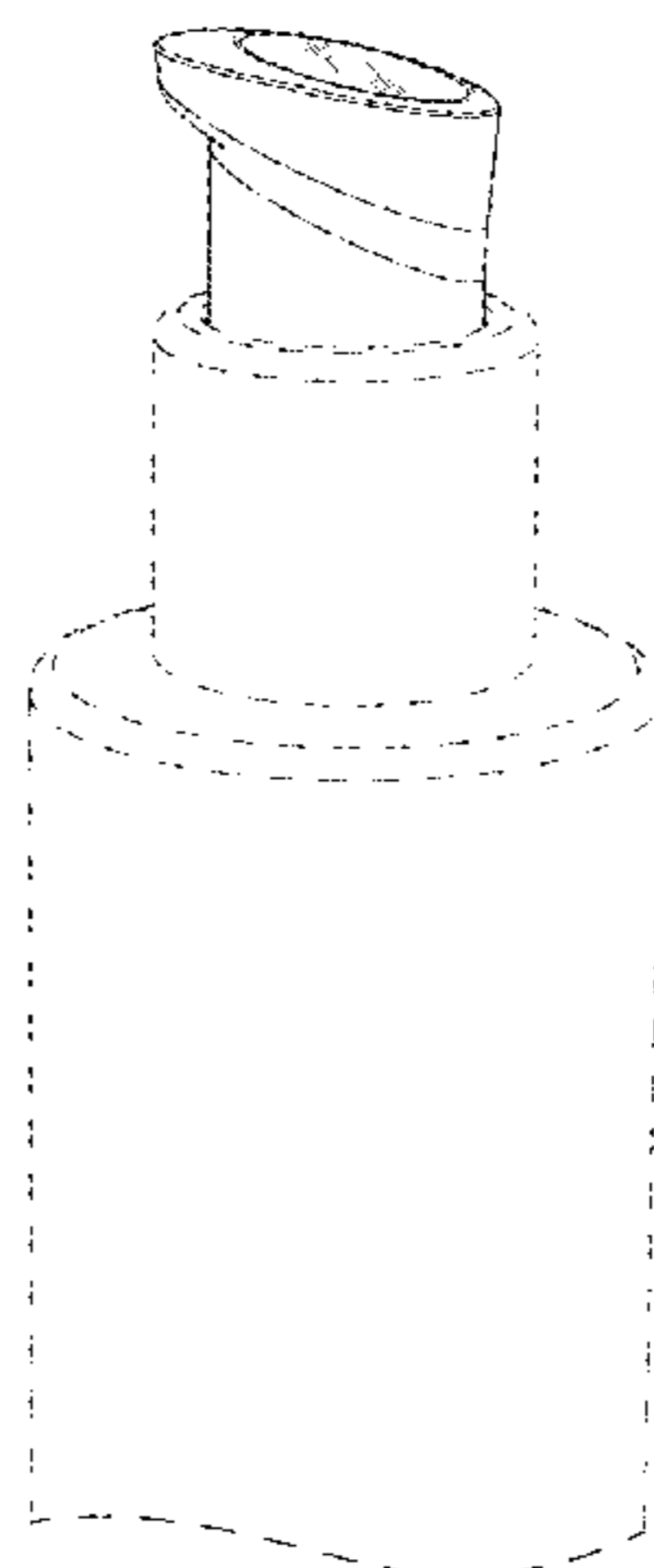
FIG. 5 is a left side elevation view thereof, while the right side elevation view is a mirror image of FIG. 5.

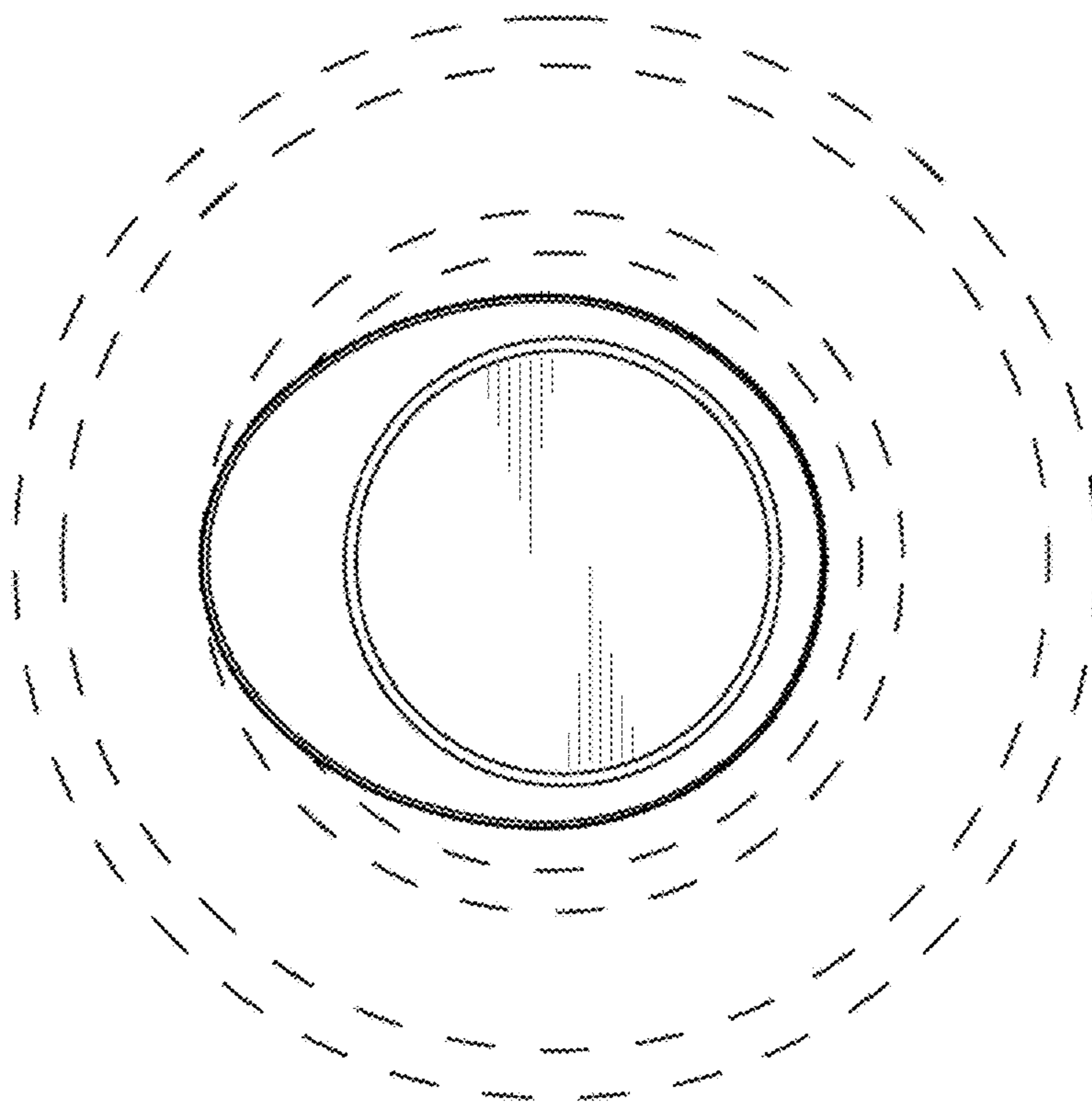

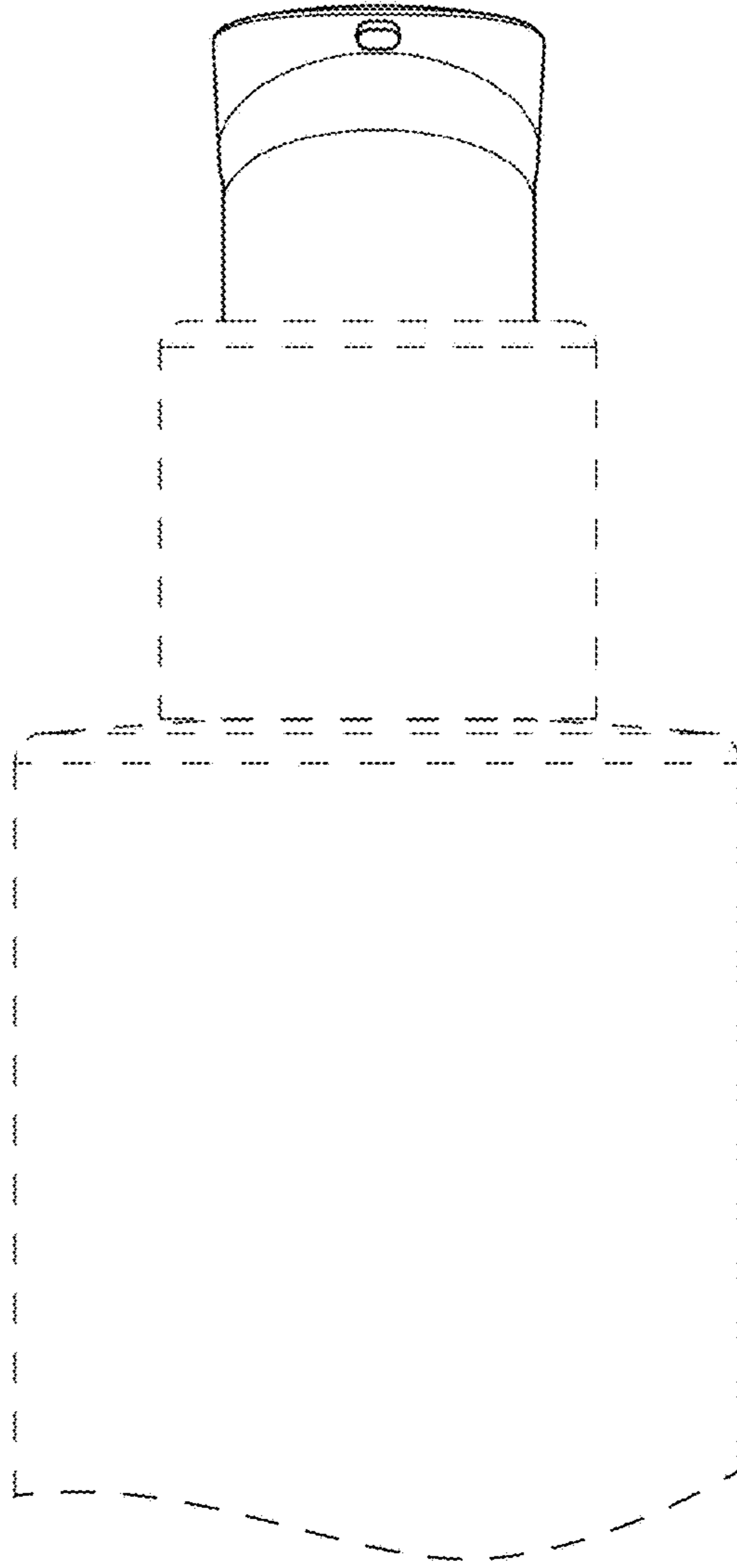

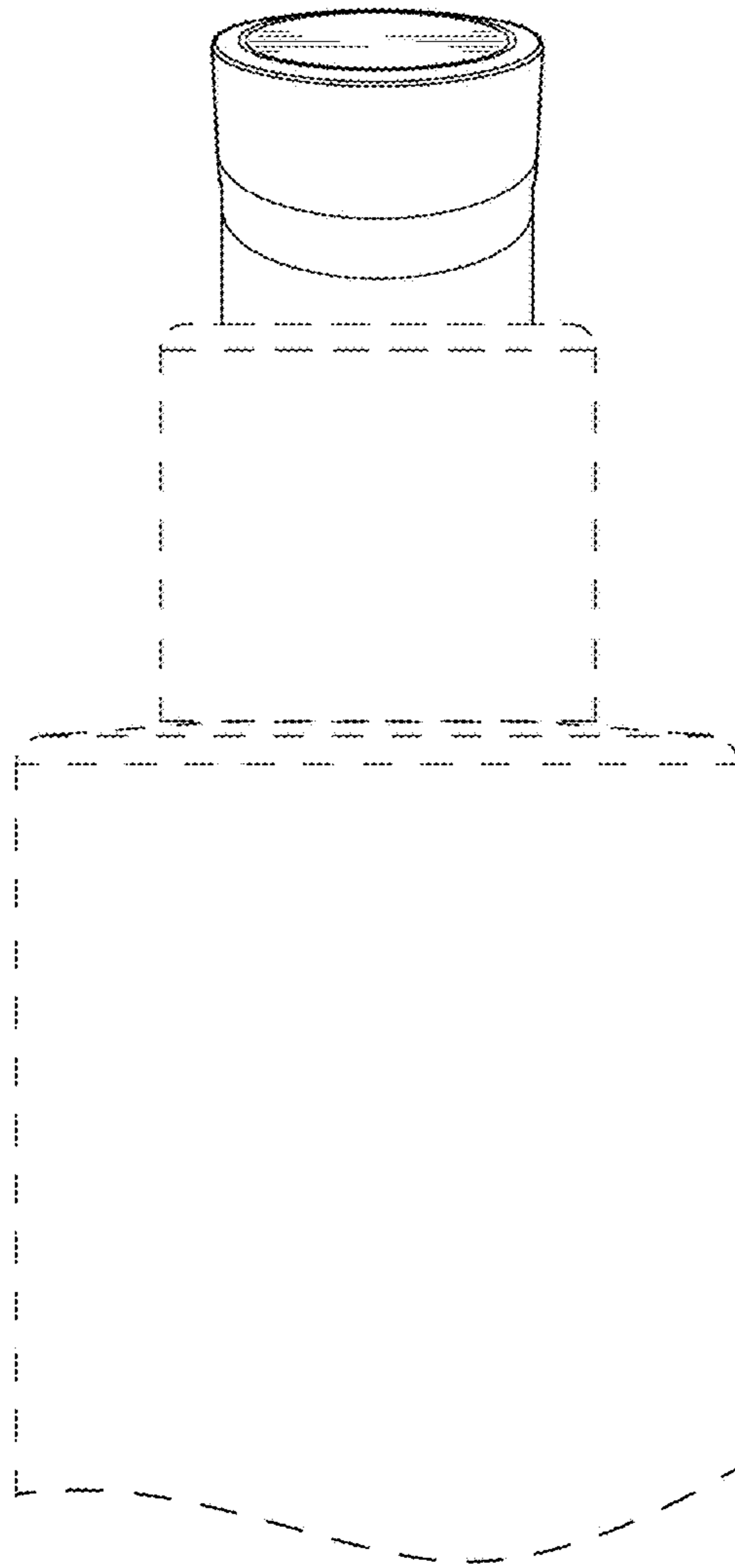

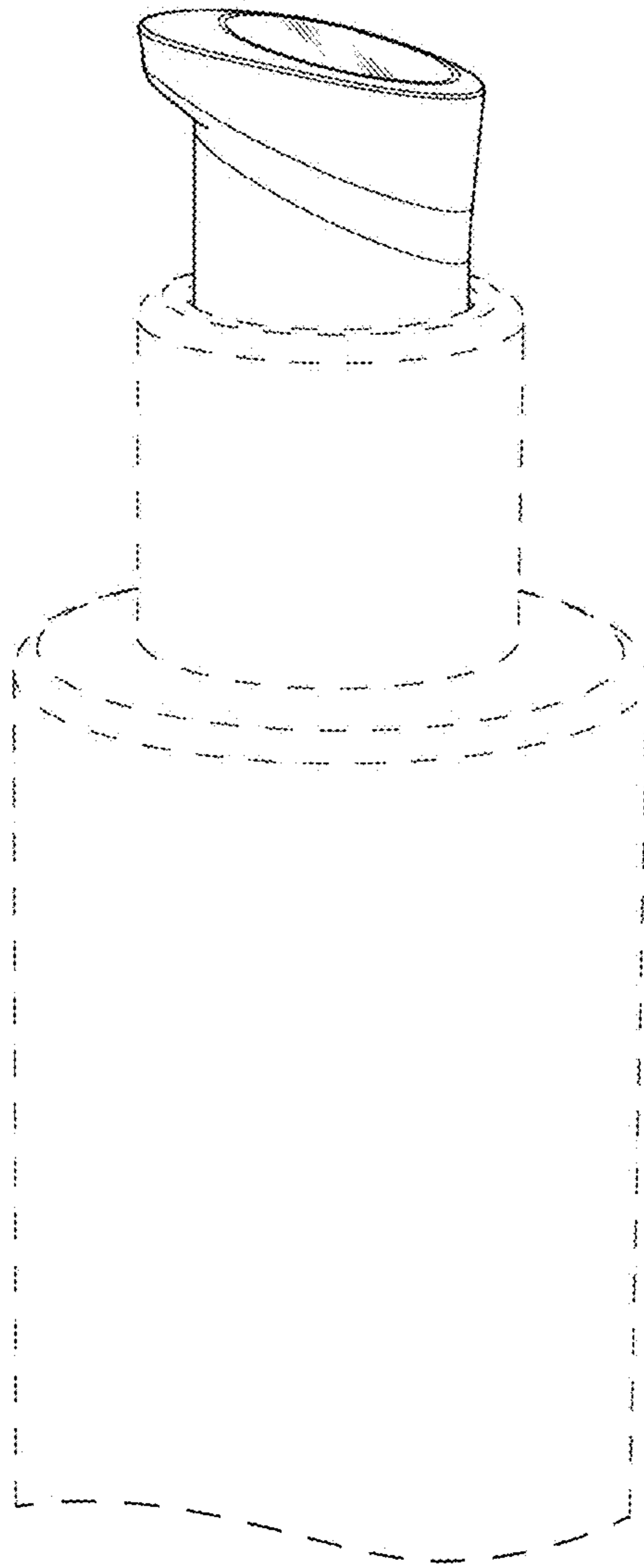

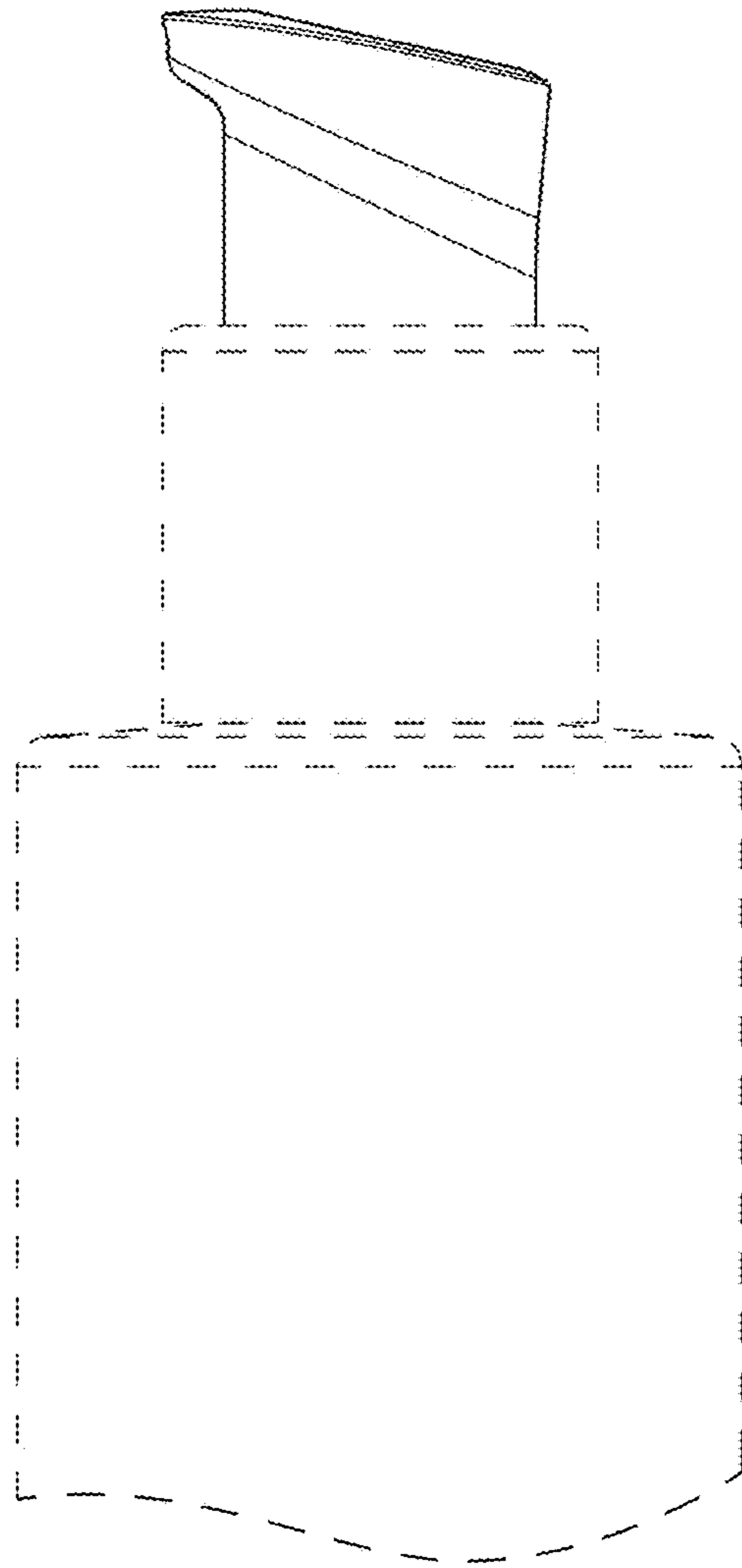
