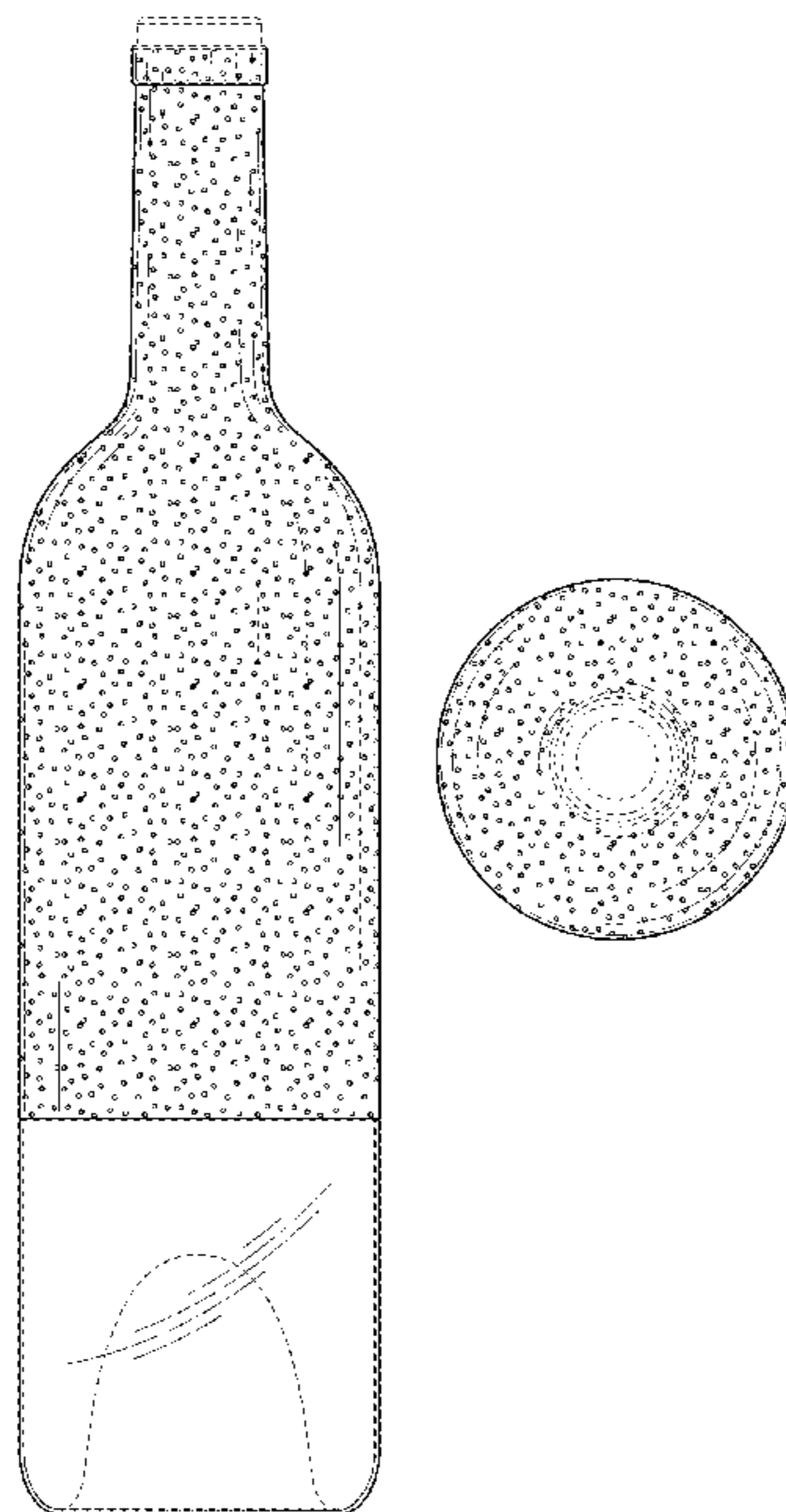
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bottle showing my new design;
 FIG. 2 is a front view of the bottle shown in FIG. 1, with the rear and side views being identical; and,
 FIG. 3 is a top view of the bottle shown in FIG. 1.
 The broken lines in the drawings illustrate the portions of the bottle that form no part of the claim.
 The irregular circular lining applied to a portion of the bottle sidewall are intended to represent a contrasting appearance.

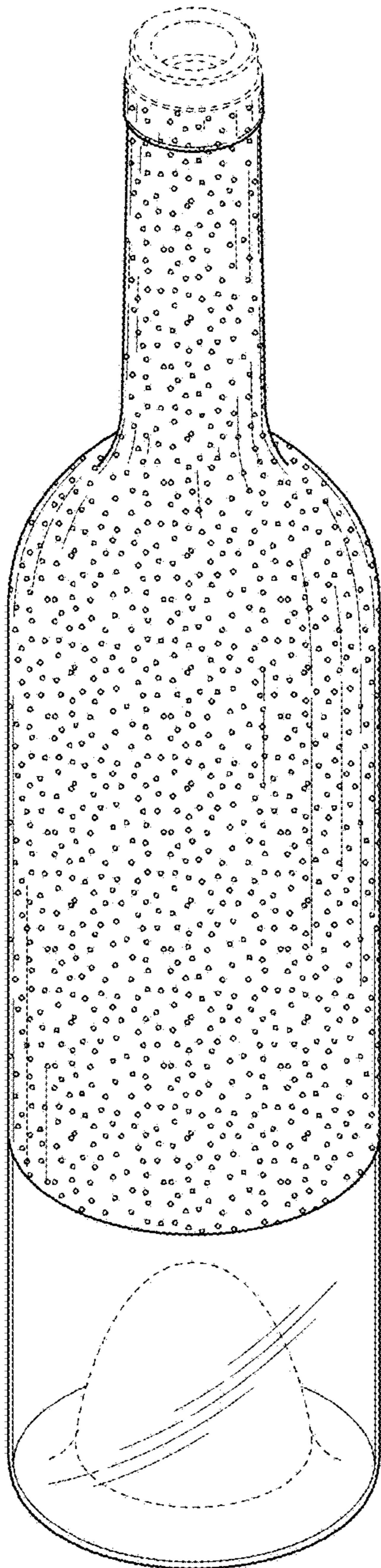

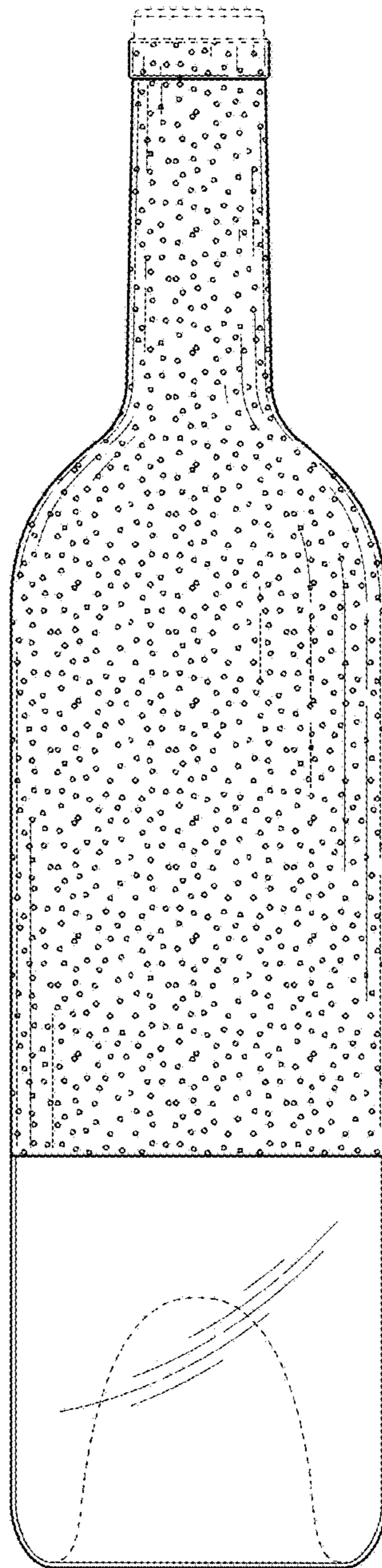

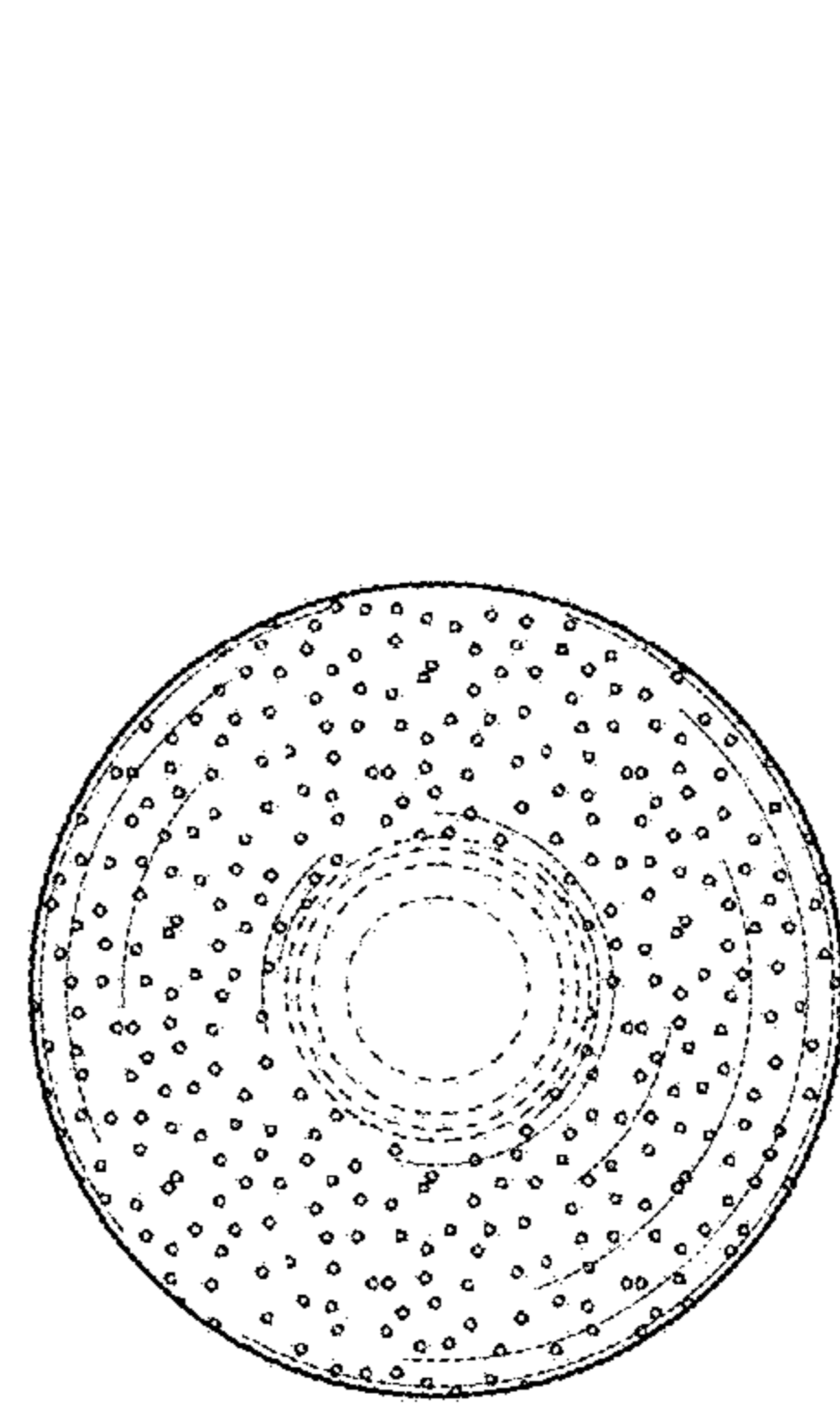
