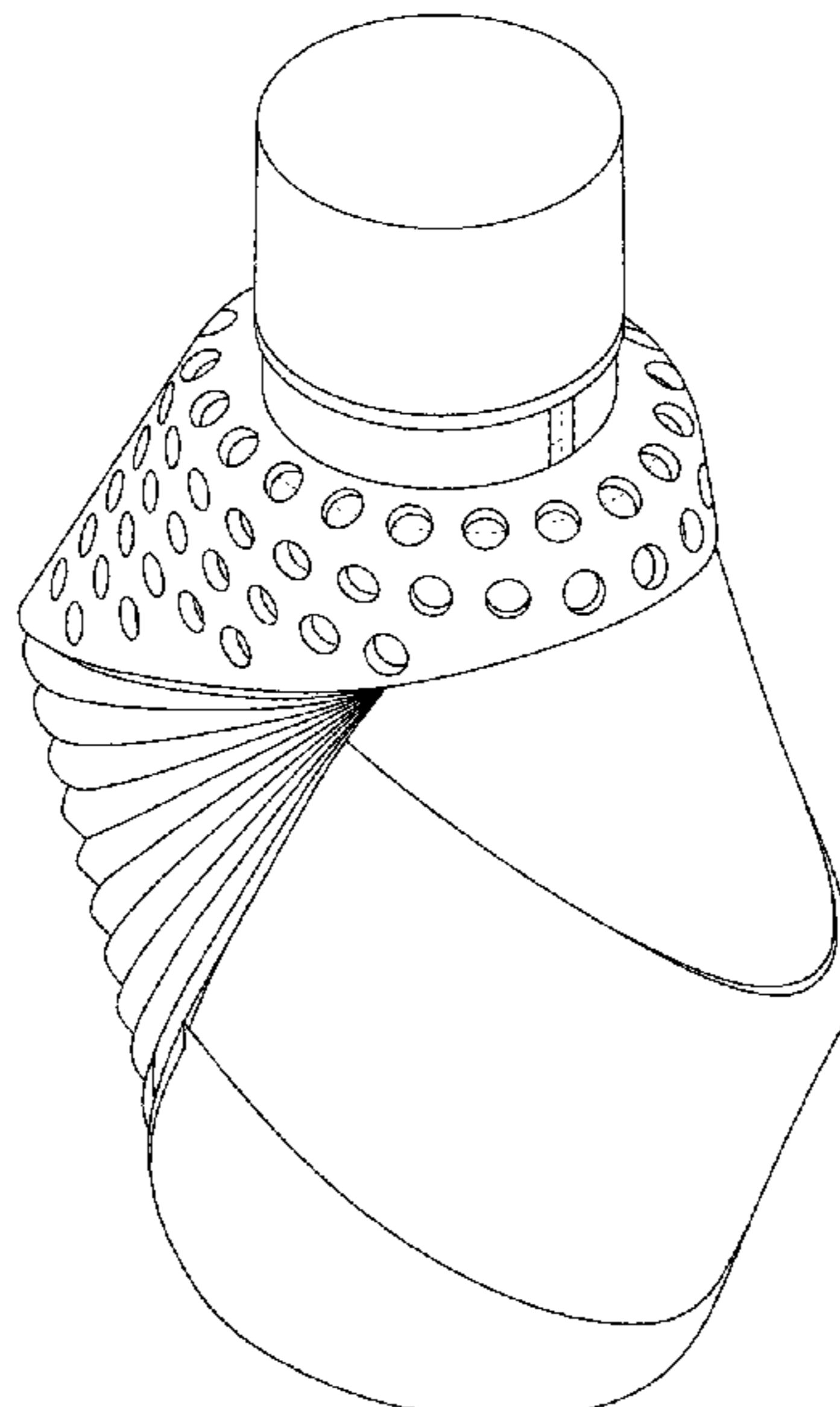

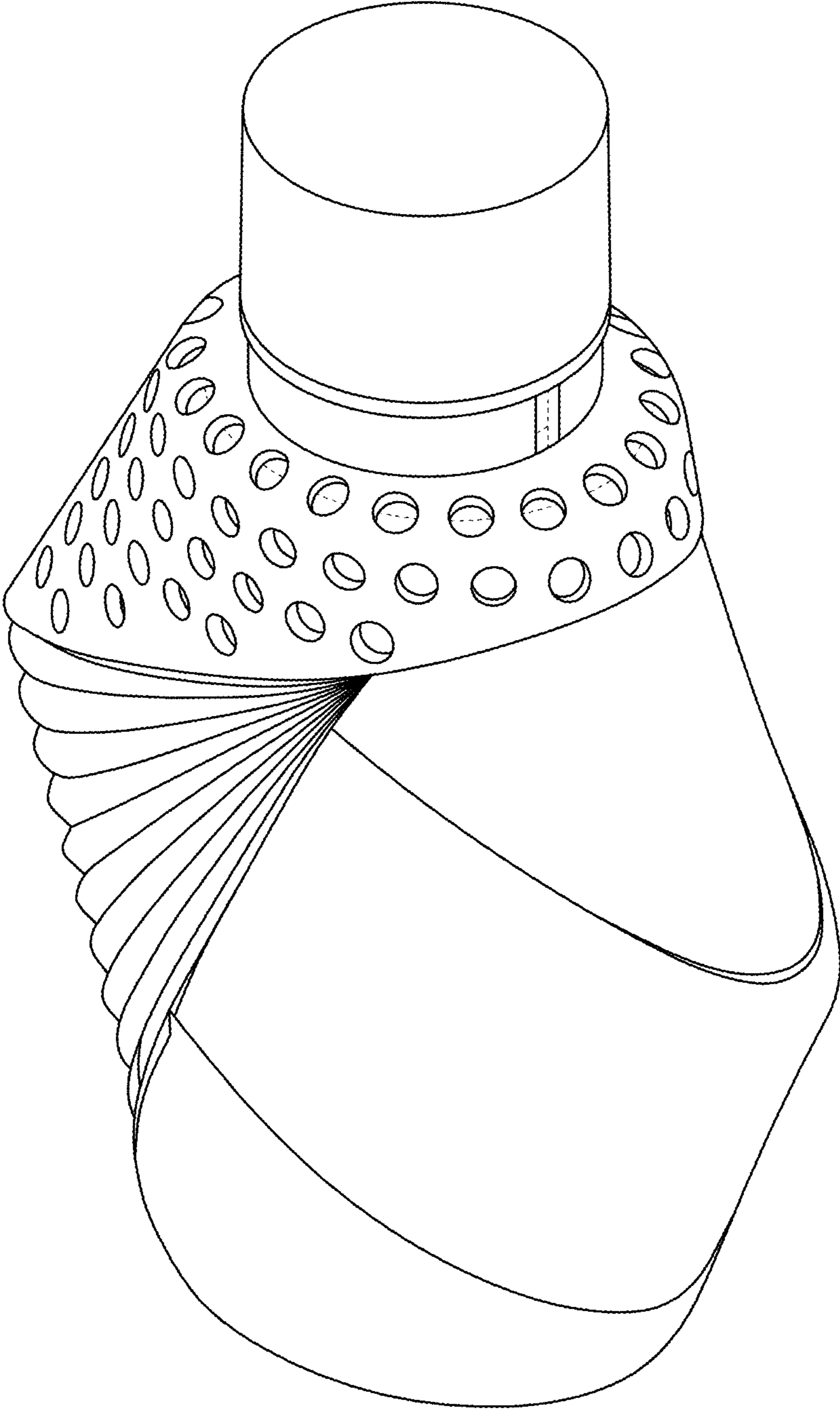

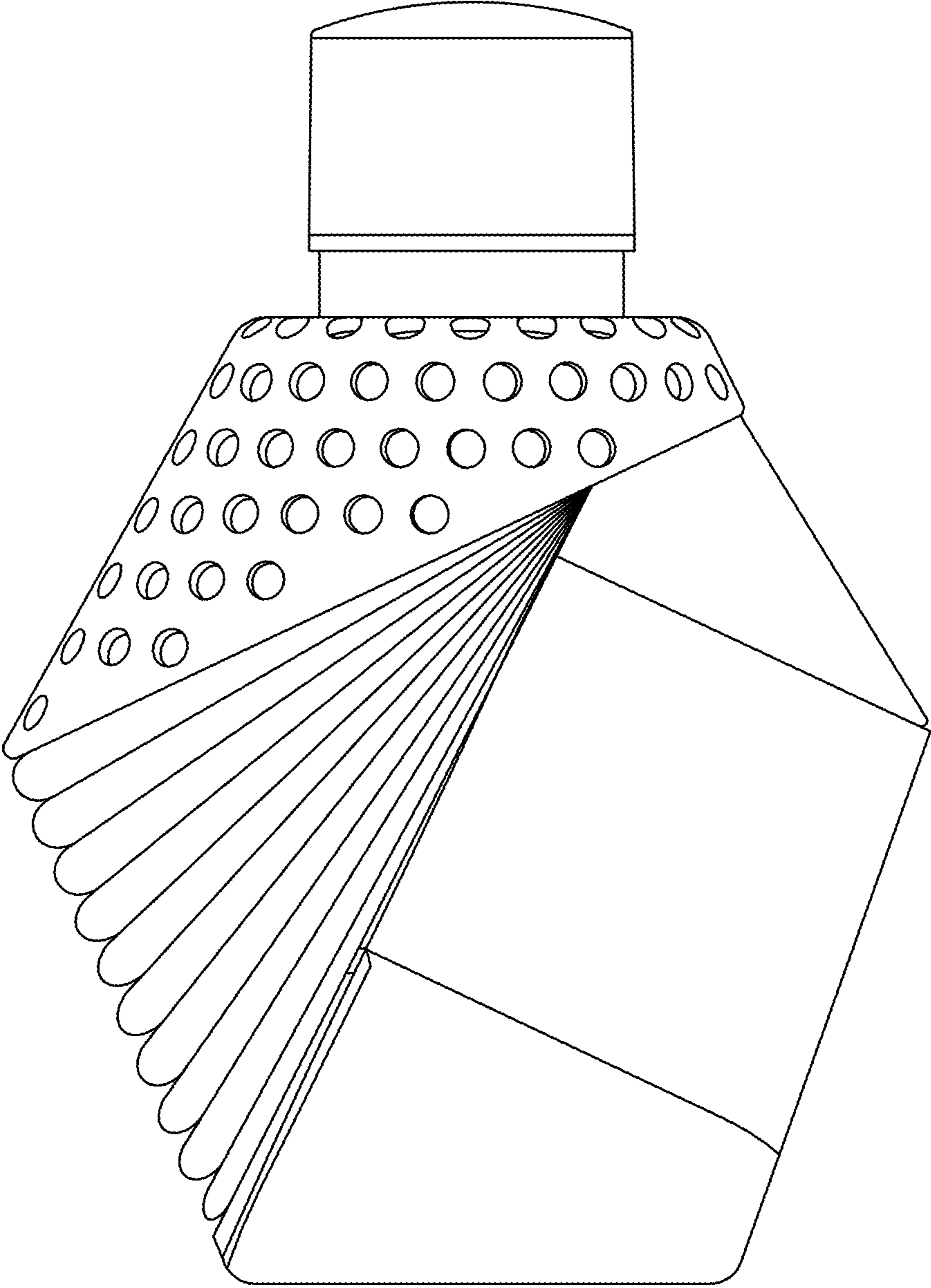
The broken lines depict portions of the perfume bottle that form no part of the claimed design.

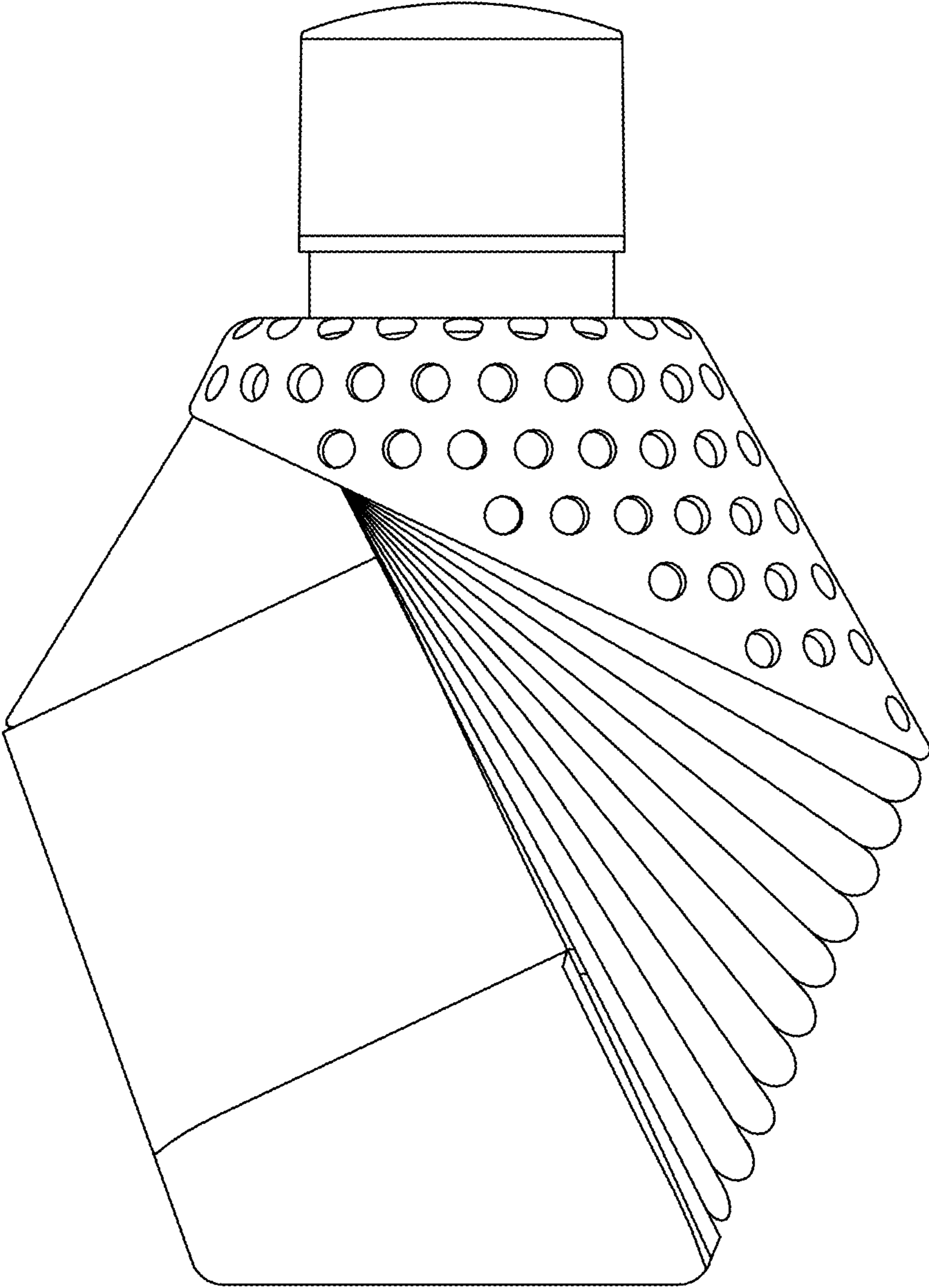




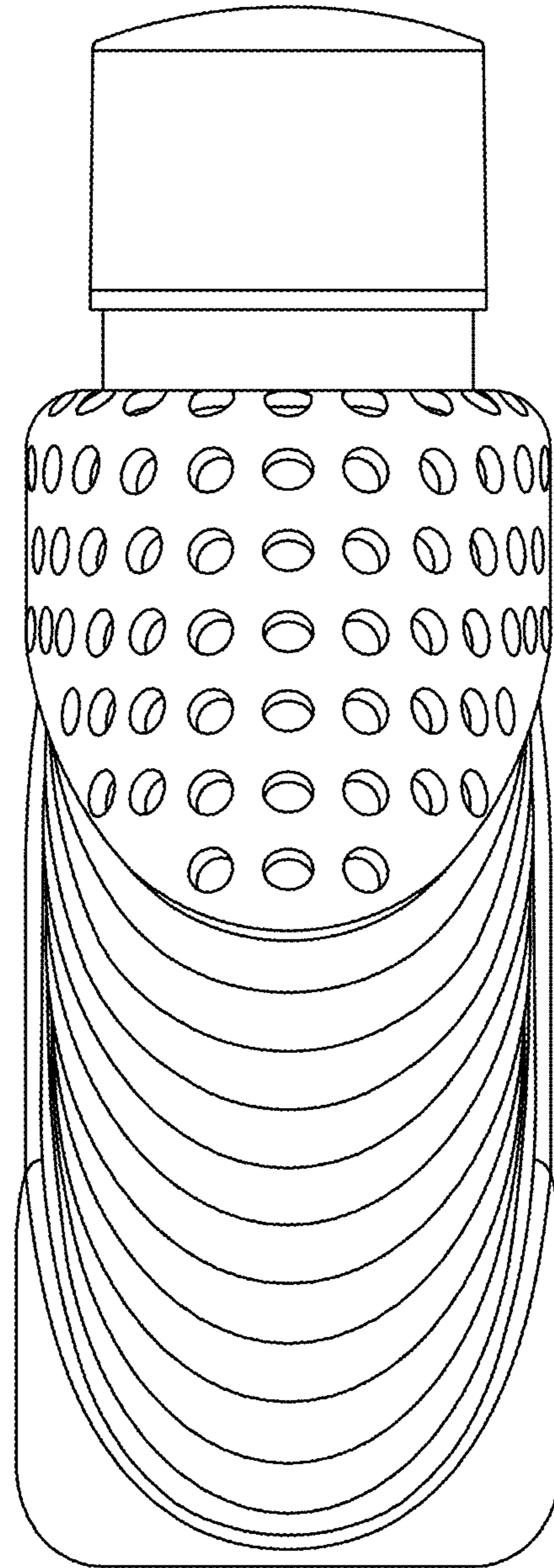

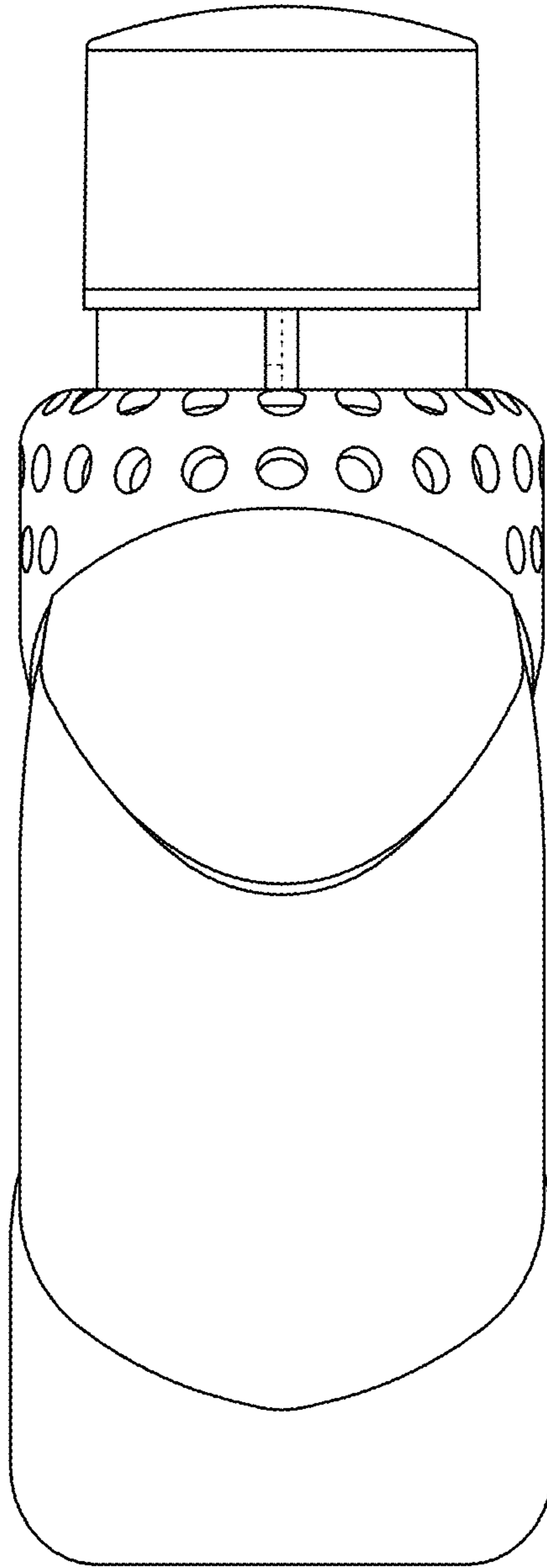

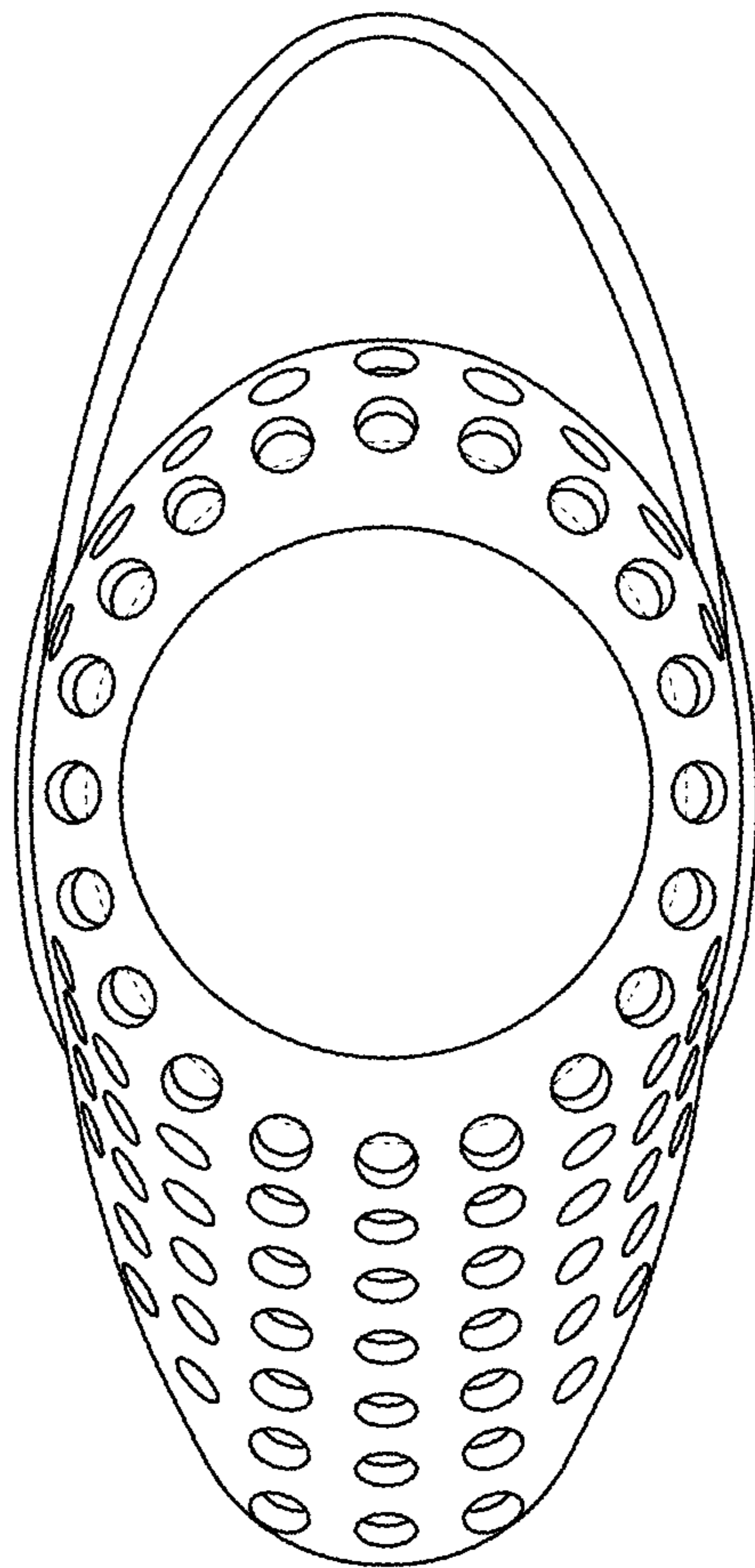

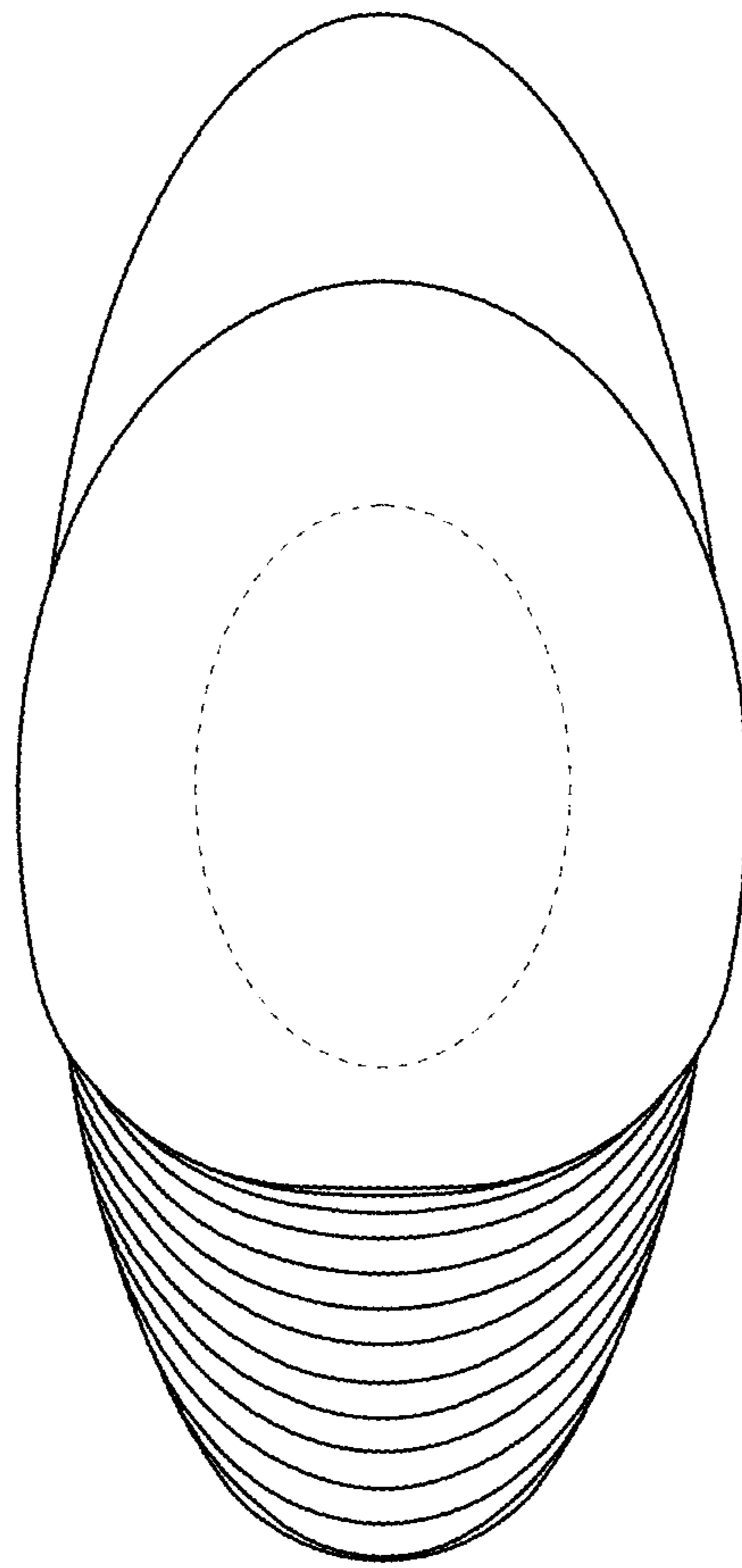
