DESCRIPTION

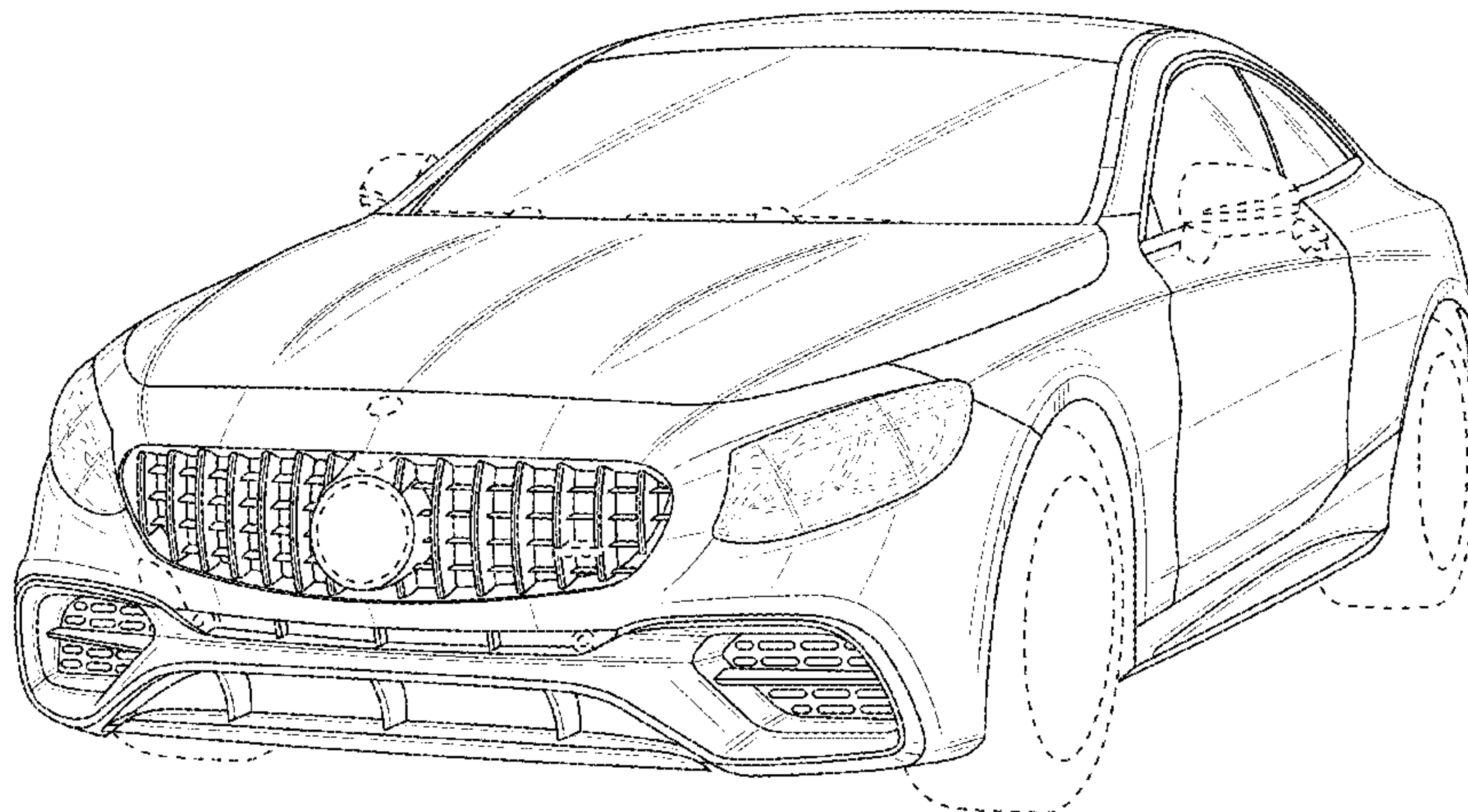
This application contains subject matter related to the following co-pending U.S. design patent applications:

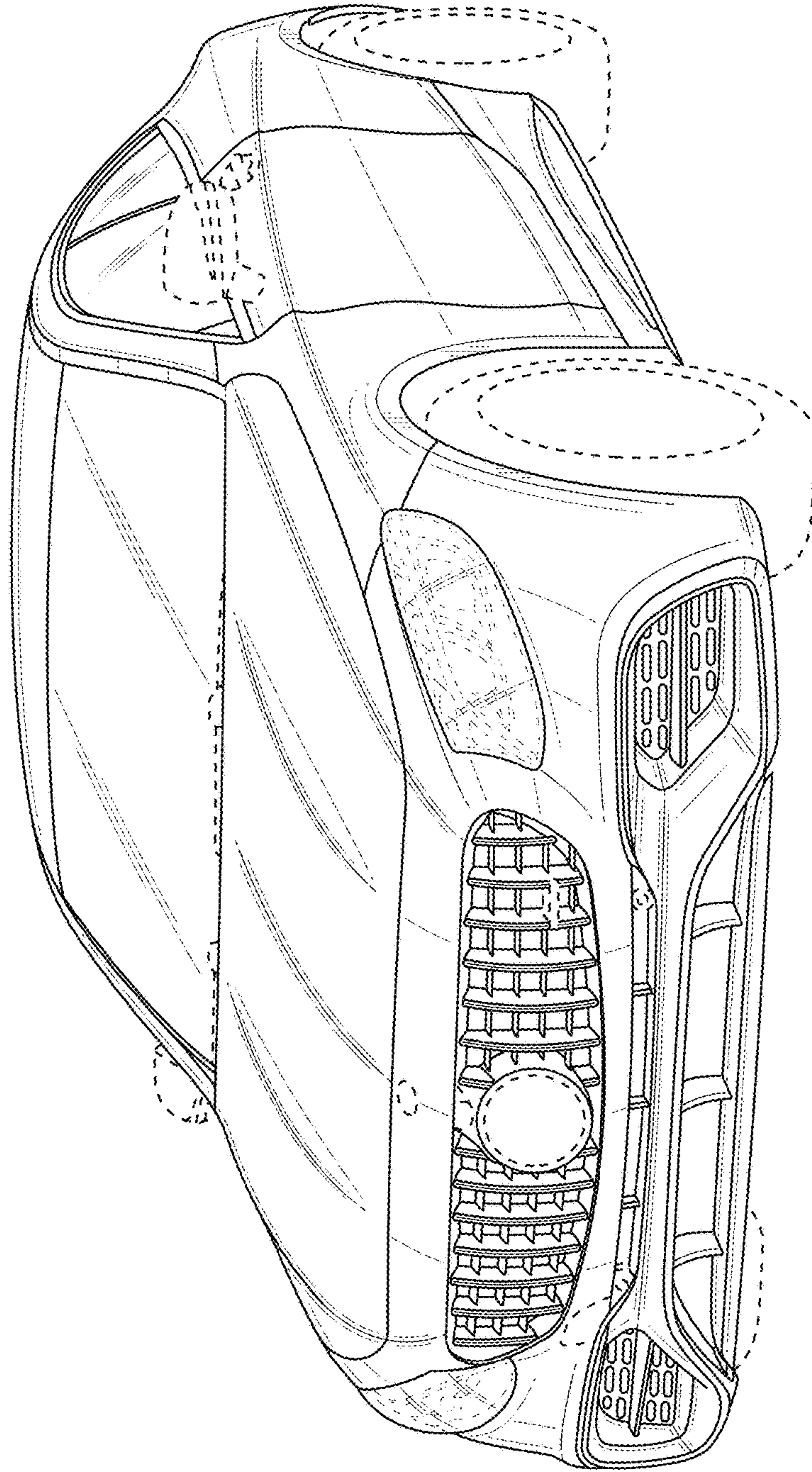

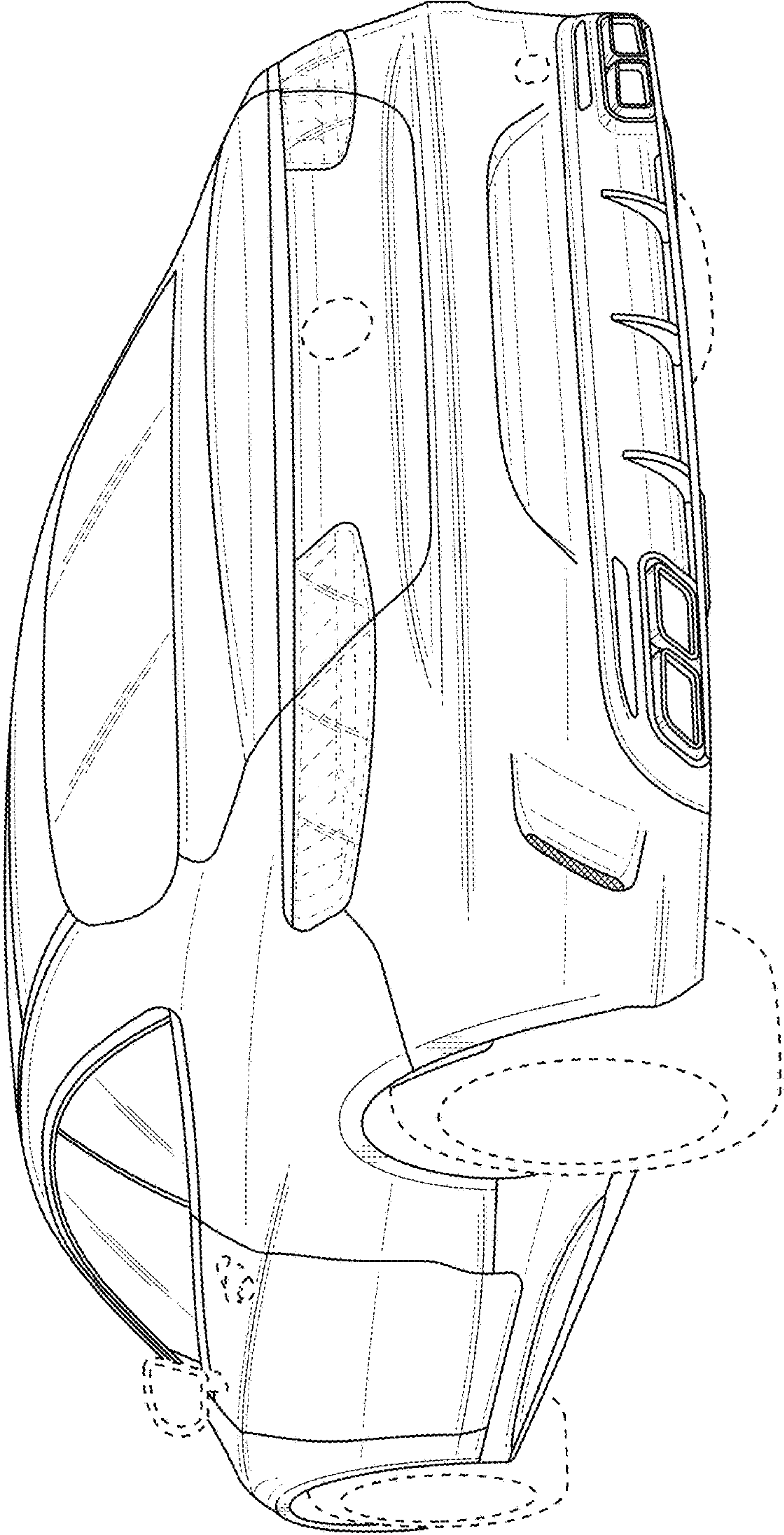

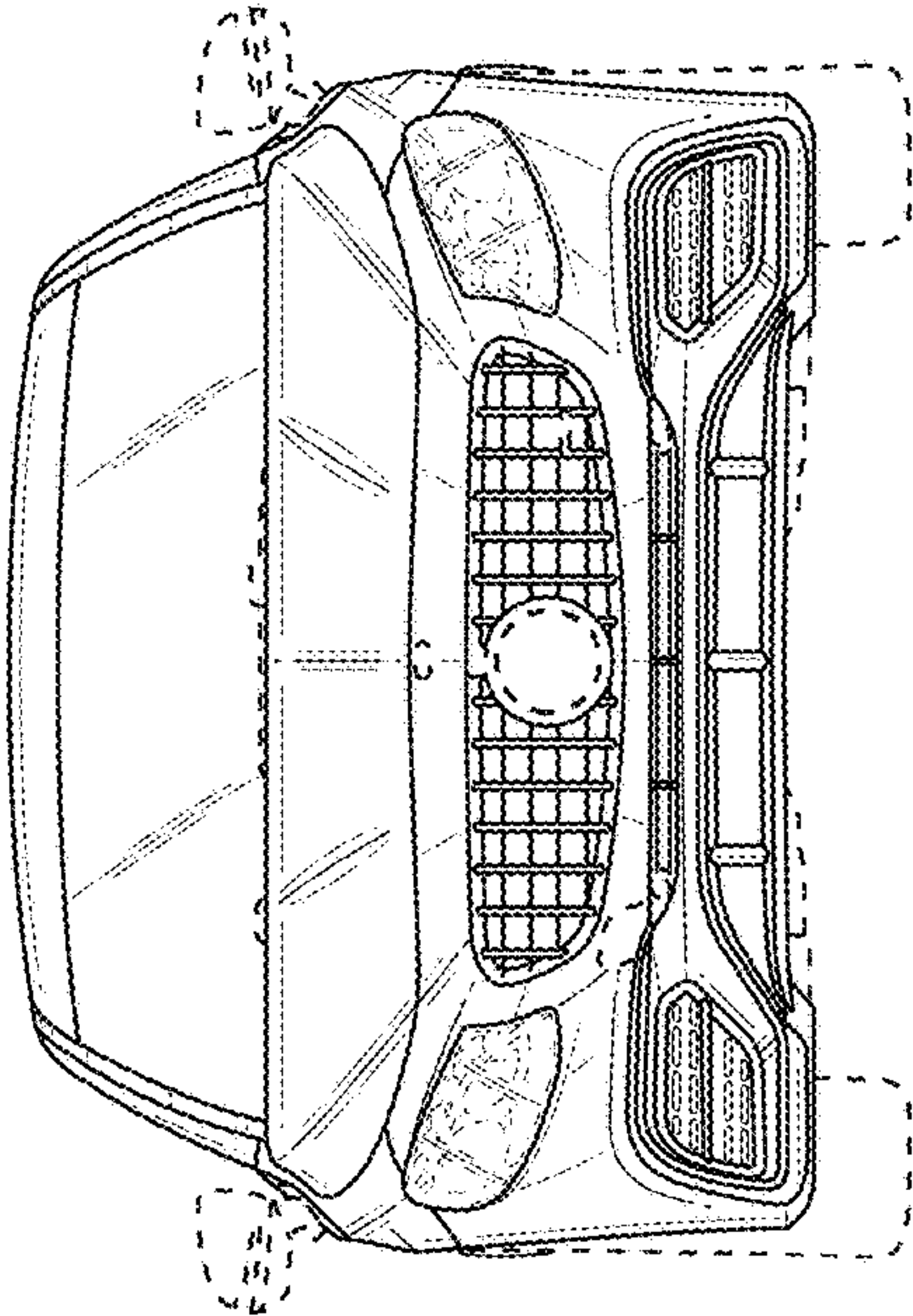

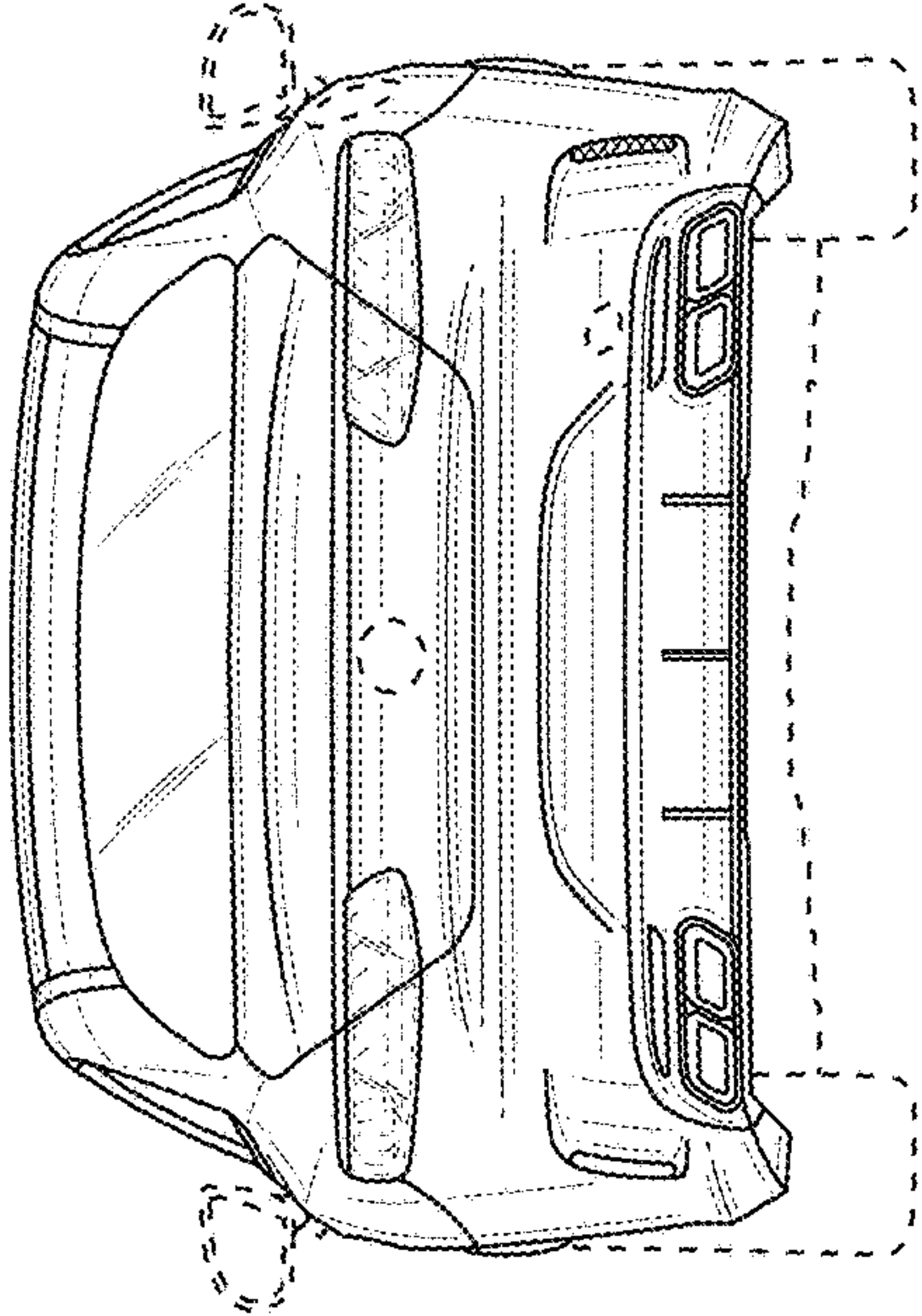

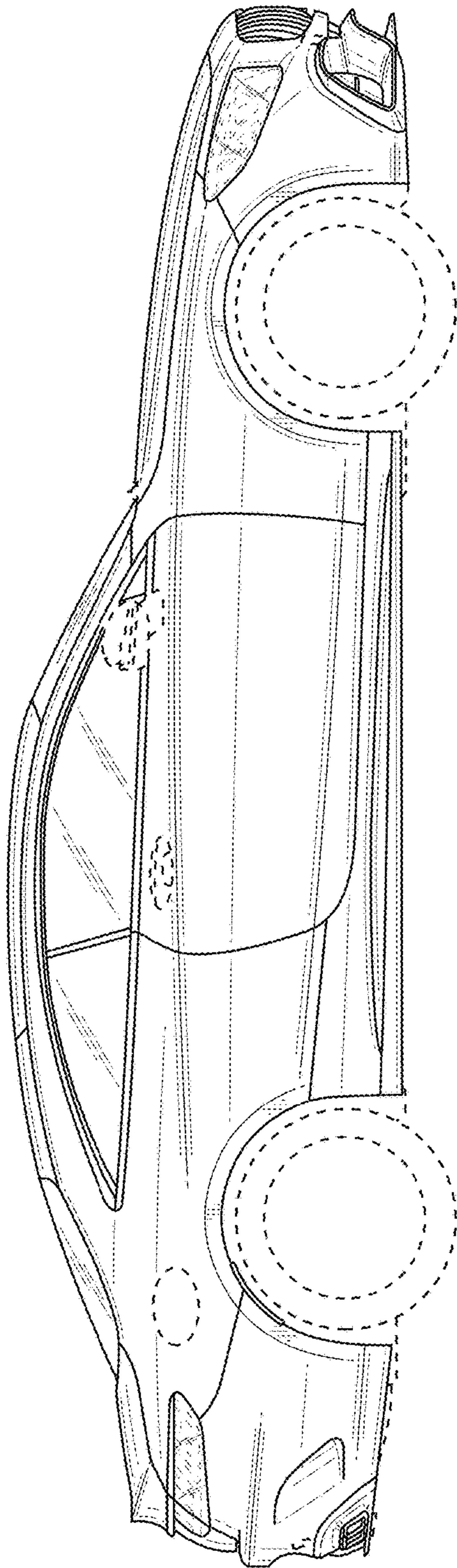

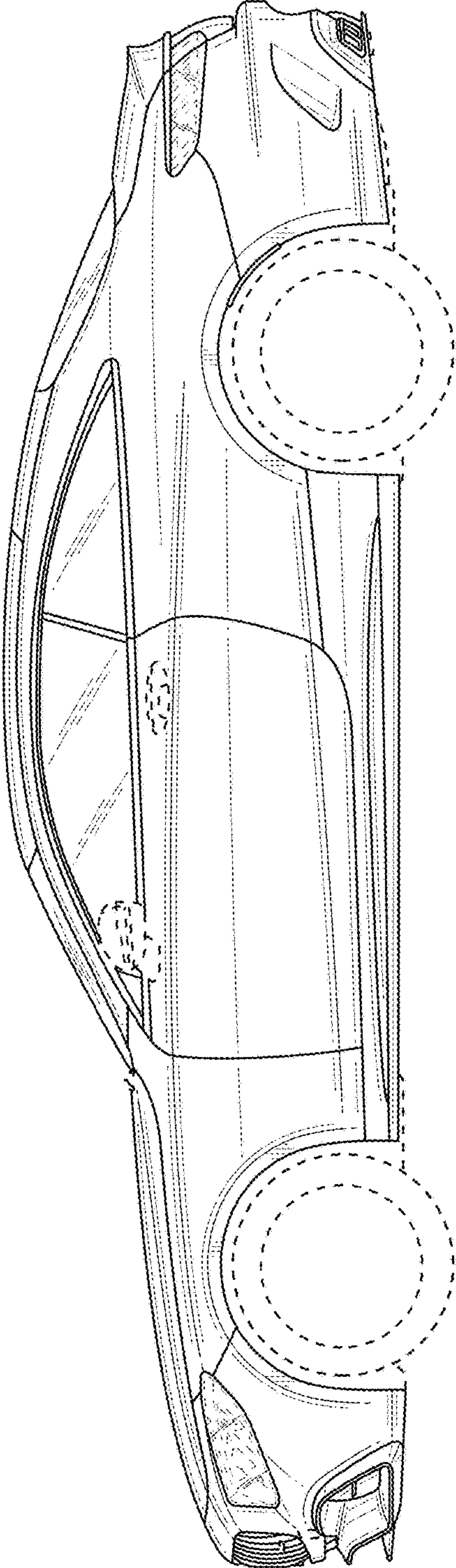

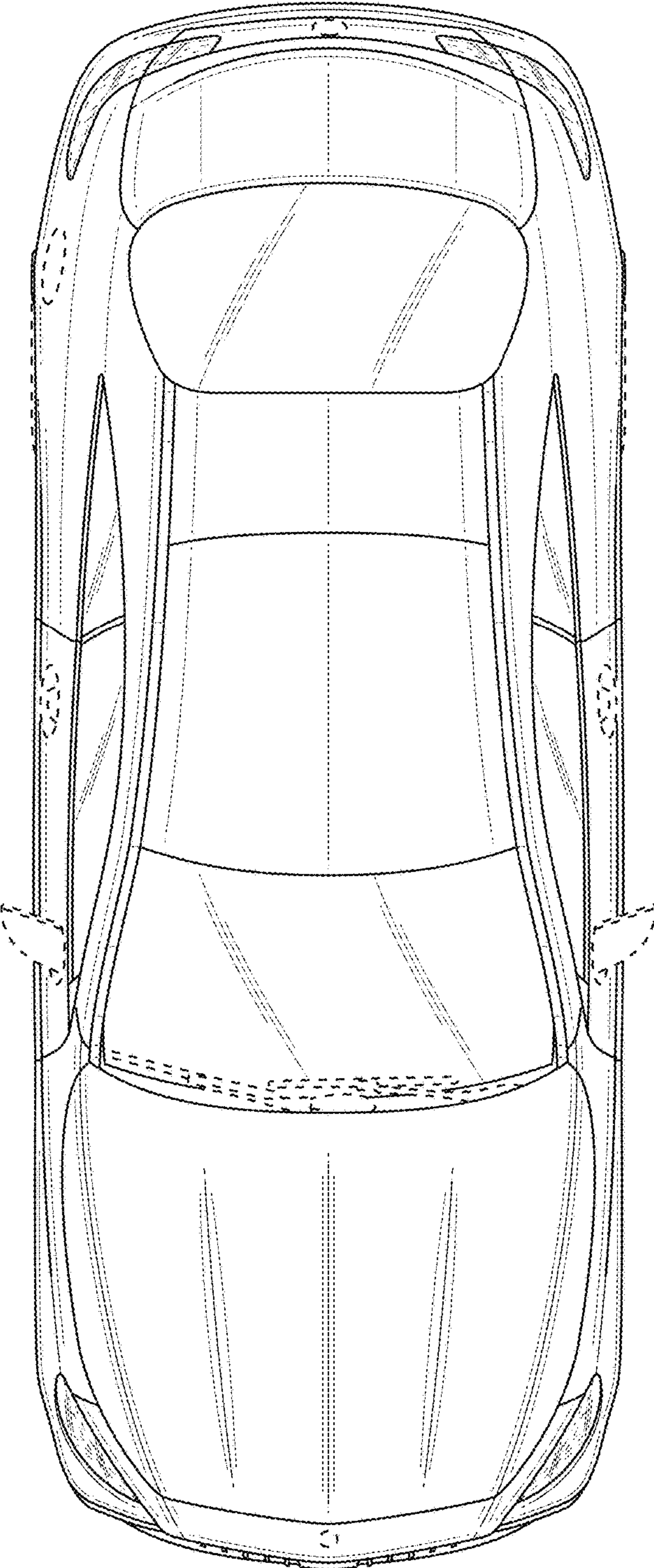
