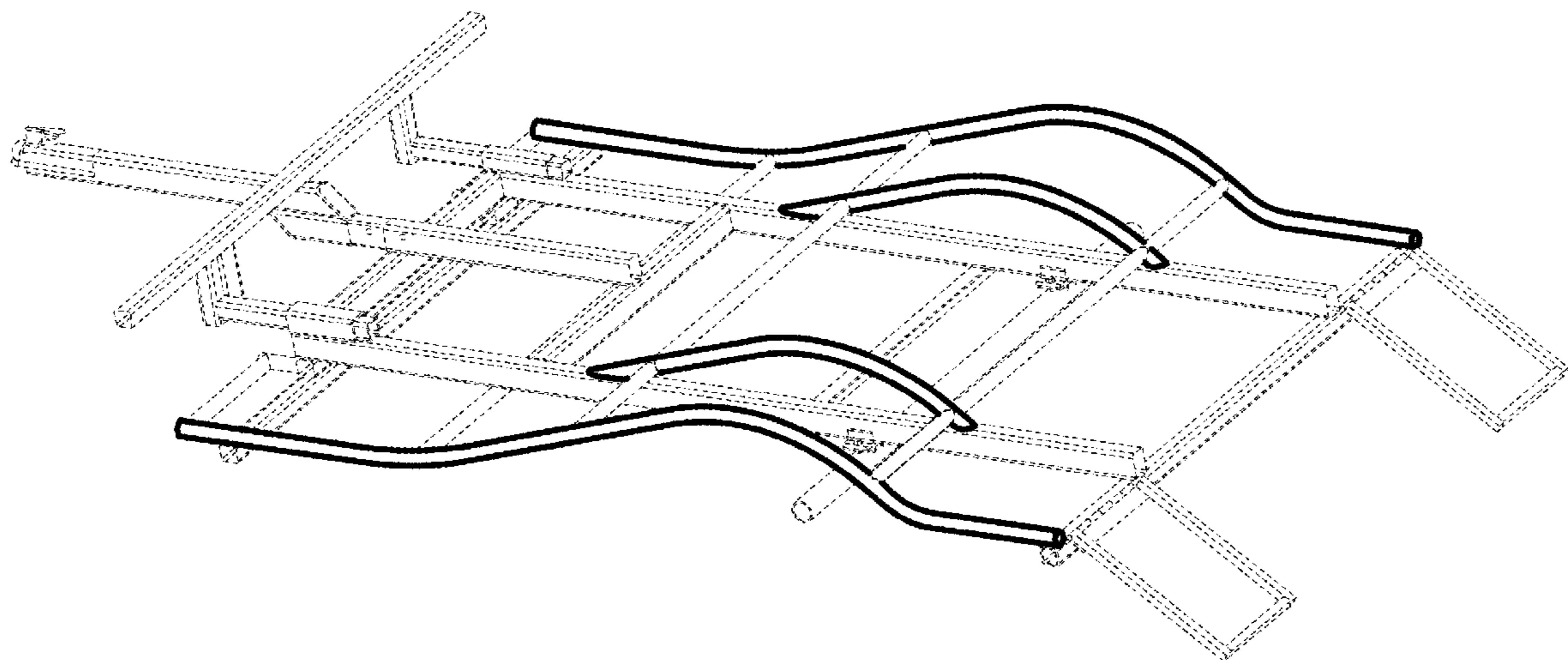
(57) **CLAIM**

The ornamental design for a trailer, as shown and described.

DESCRIPTION

FIG. 1 is a top right perspective view of a trailer, showing our new design in a state of use.
FIG. 2 is a top left isometric view of the design of FIG. 1, without the decking and wheels.
FIG. 3 is a left side view thereof.
FIG. 4 is a right side view thereof.
FIG. 5 is a top view thereof.
FIG. 6 is a bottom view thereof.
FIG. 7 is an enlarged front view thereof; and,
FIG. 8 is an enlarged rear view thereof.
The broken lines illustrate portions of the trailer that form no part of the claimed design.

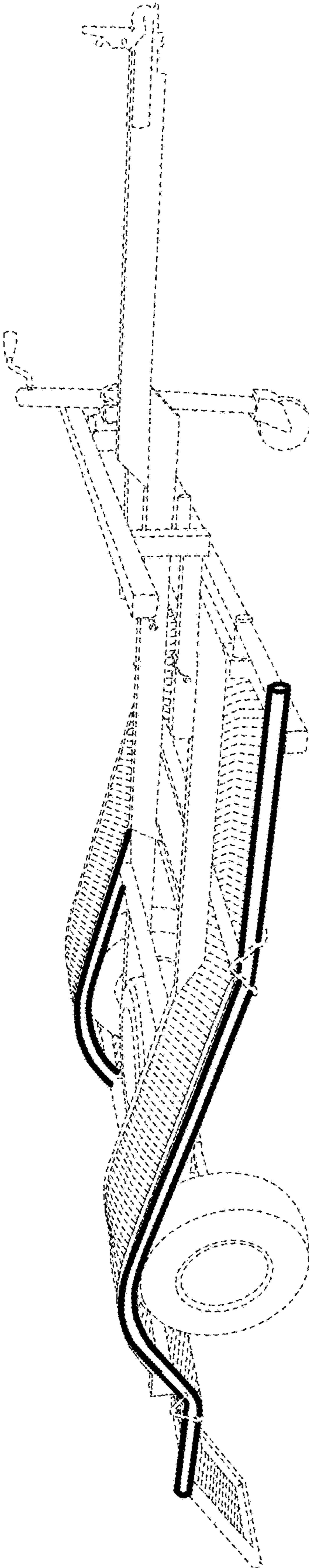

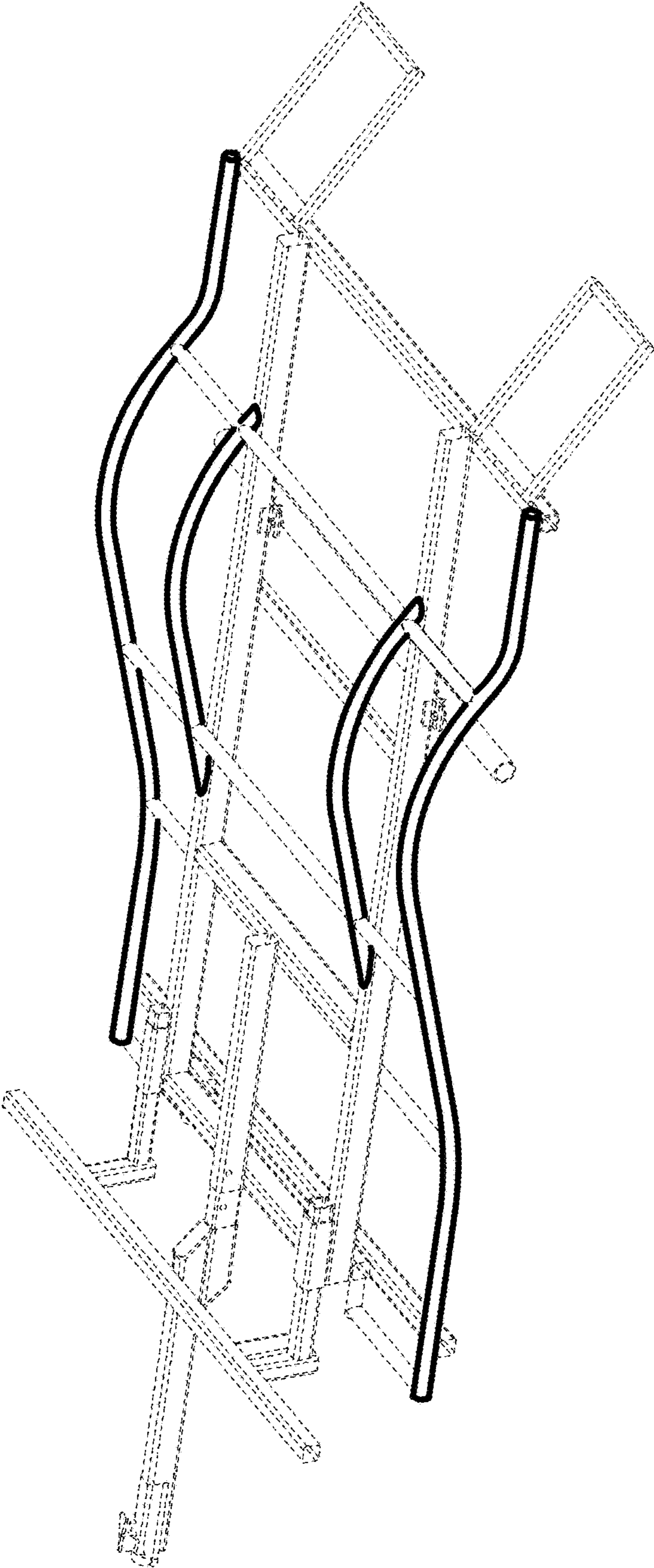

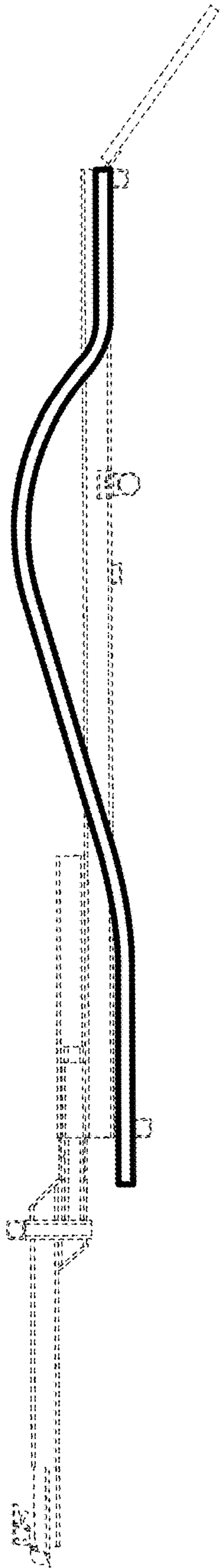

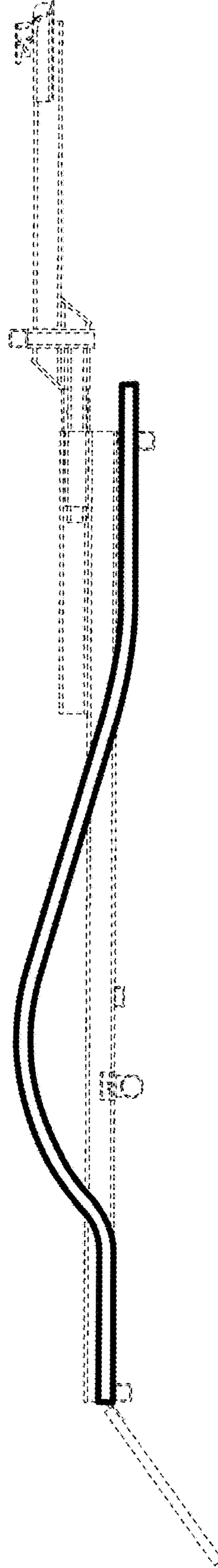

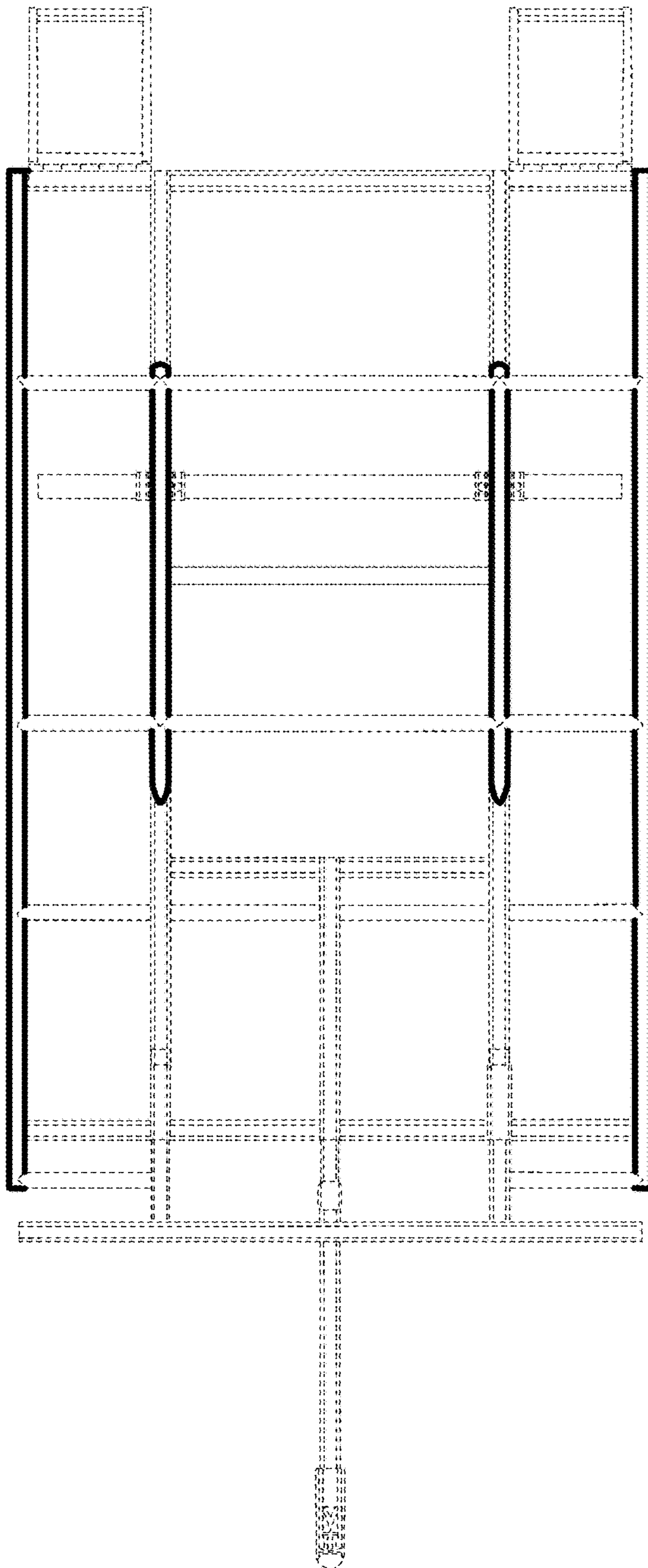

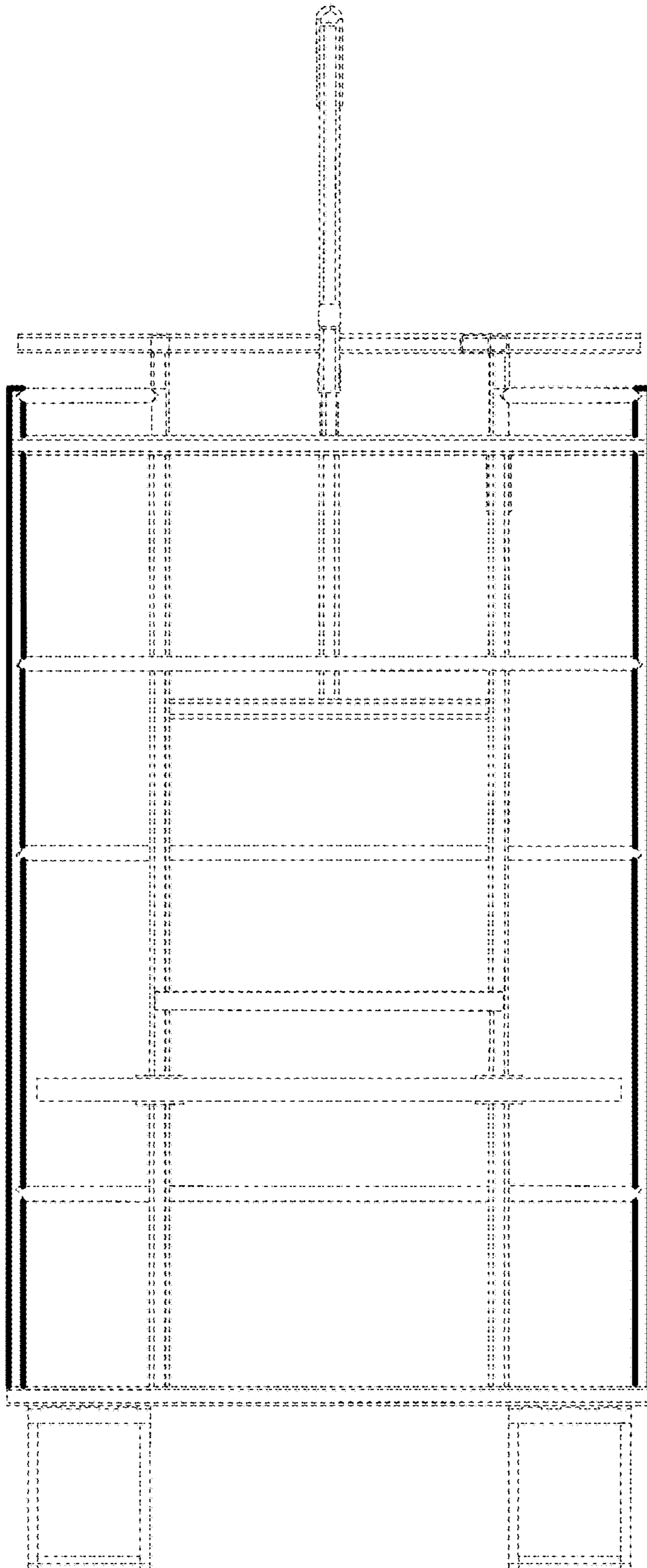

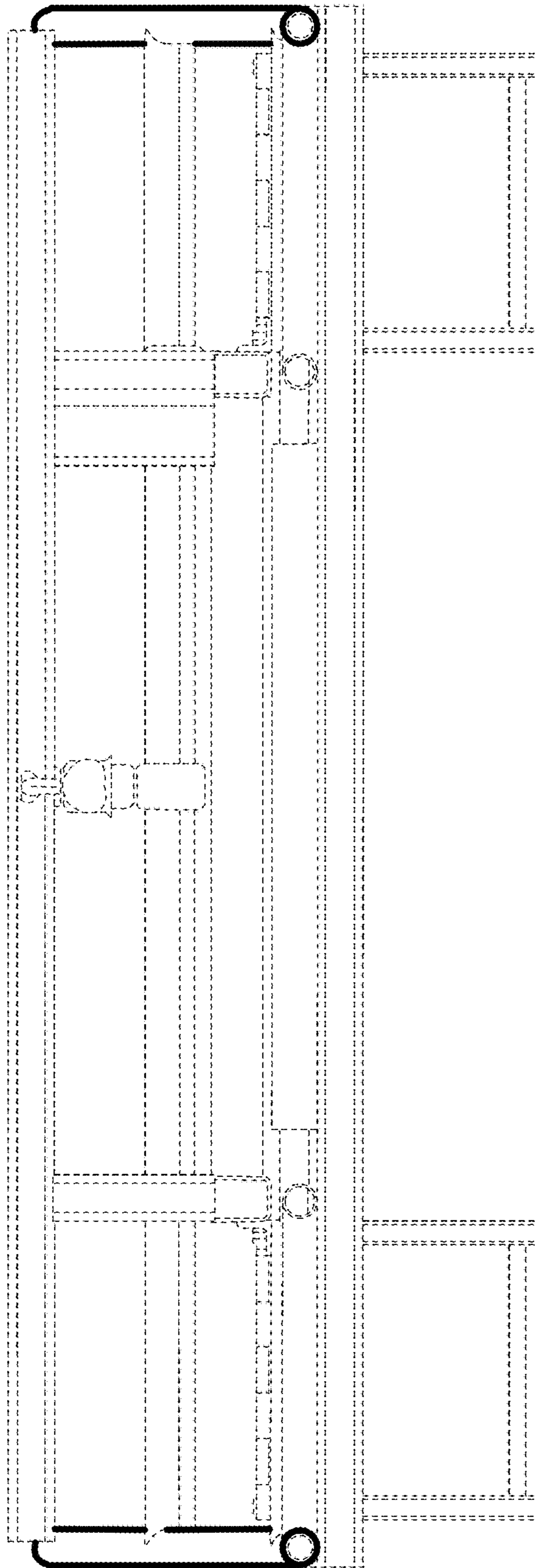

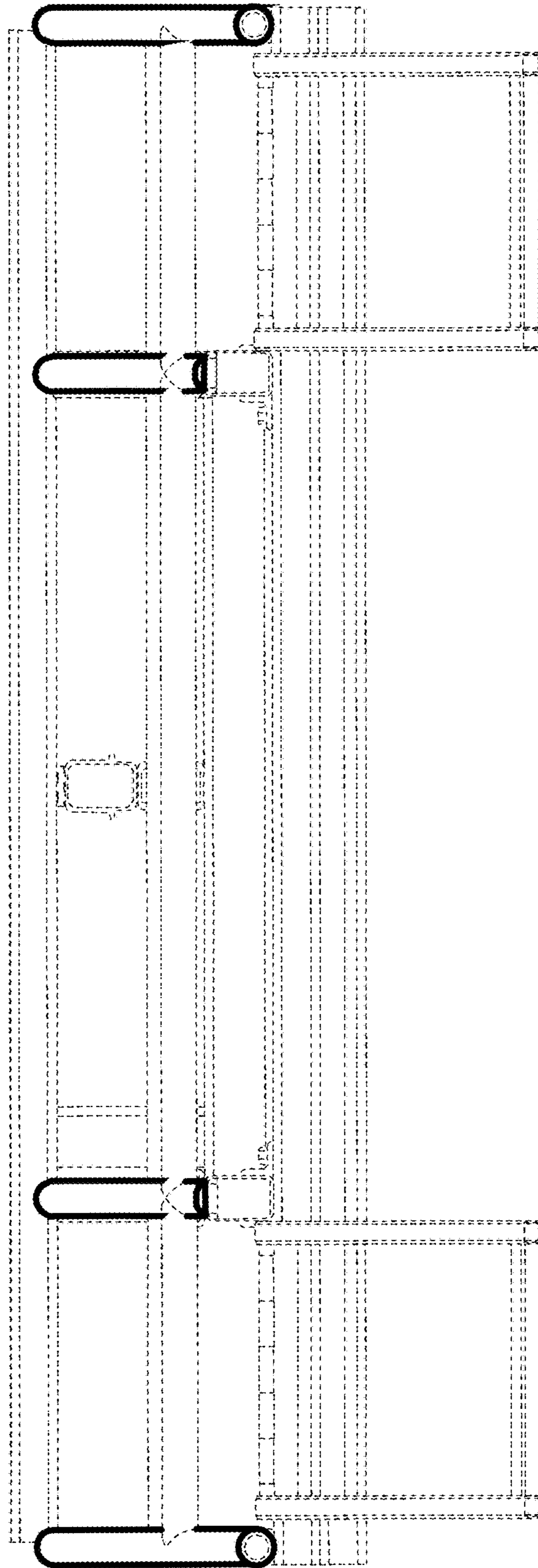
