**DESCRIPTION**

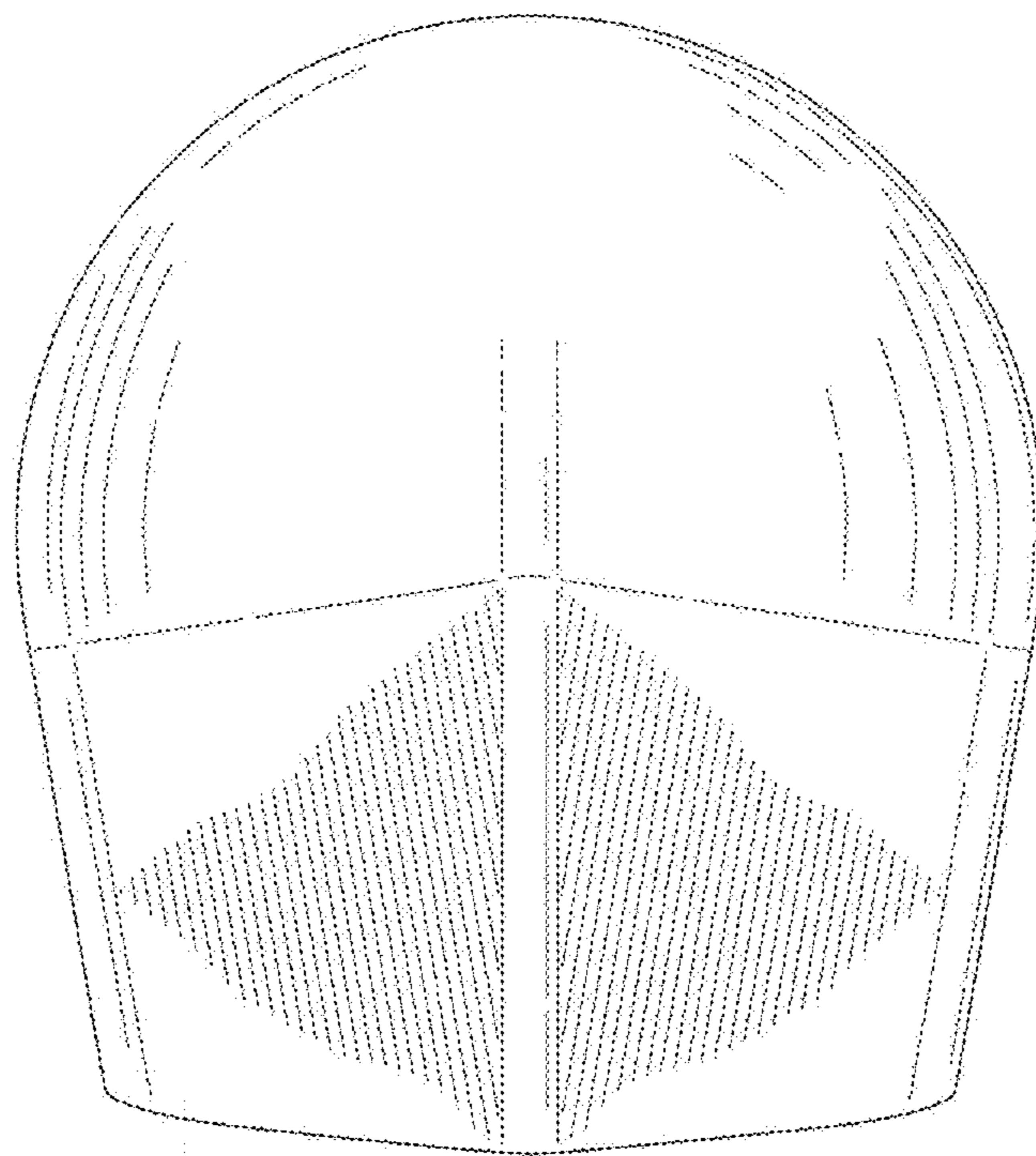
FIG. 1 is a front view of the design, according to a first embodiment thereof;

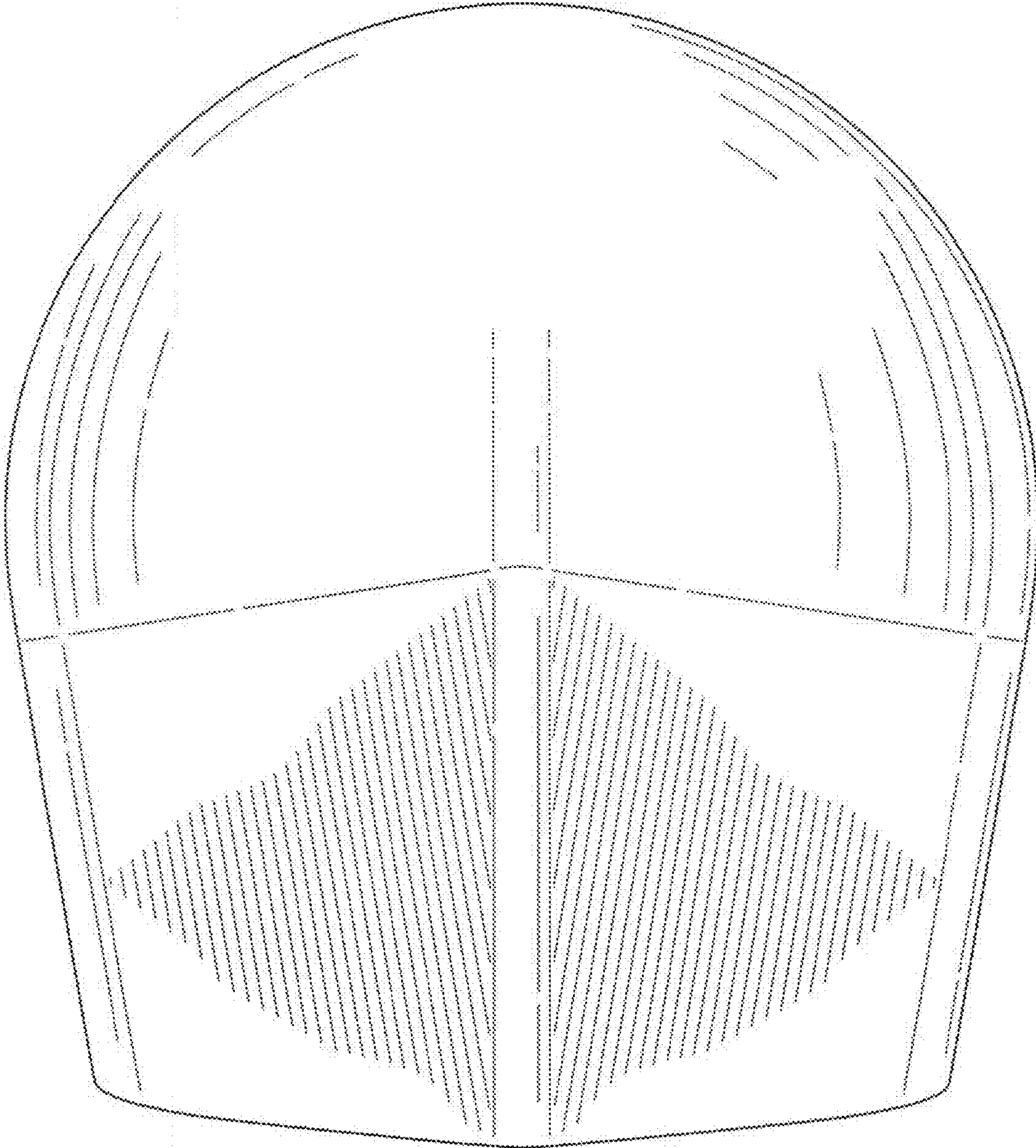

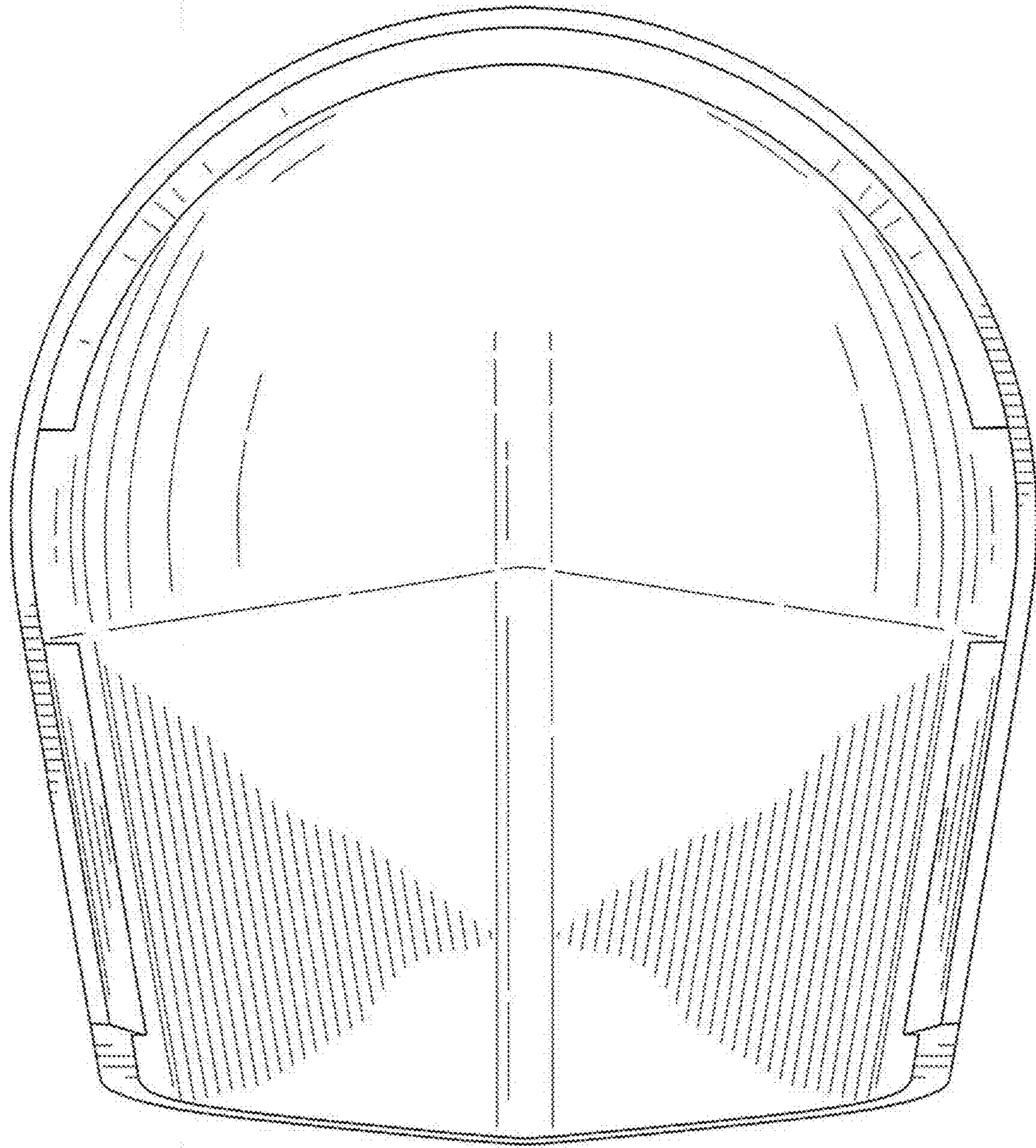

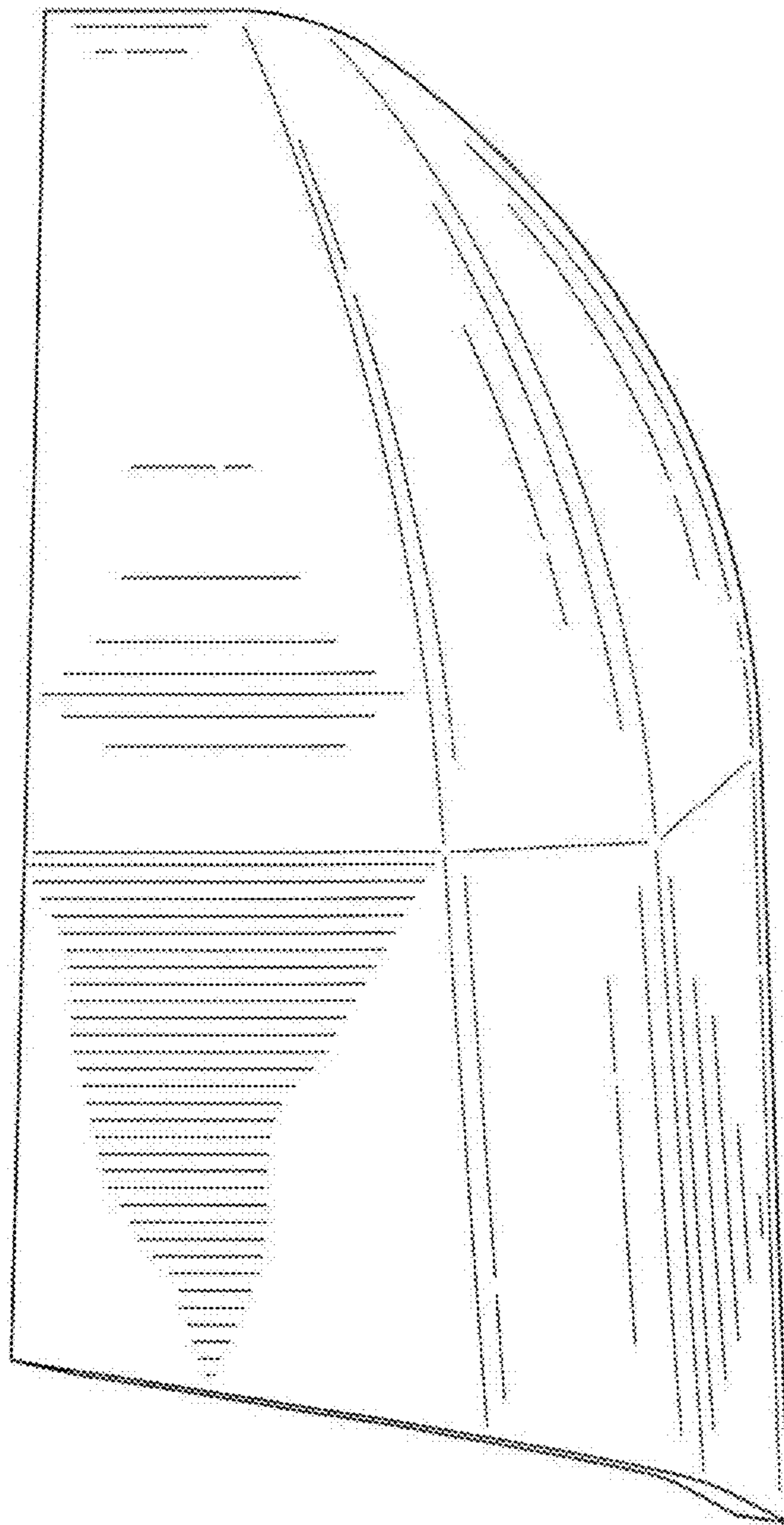

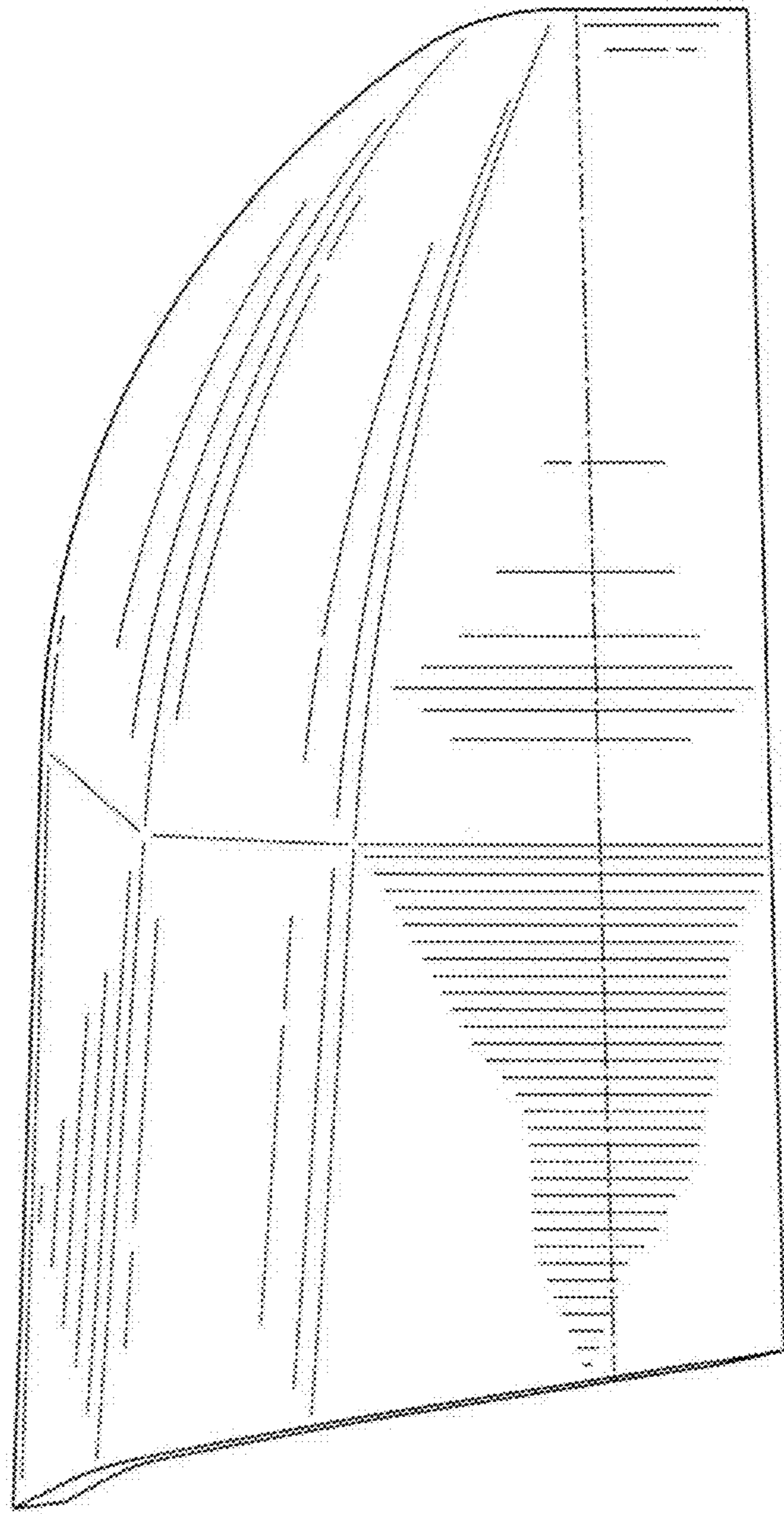

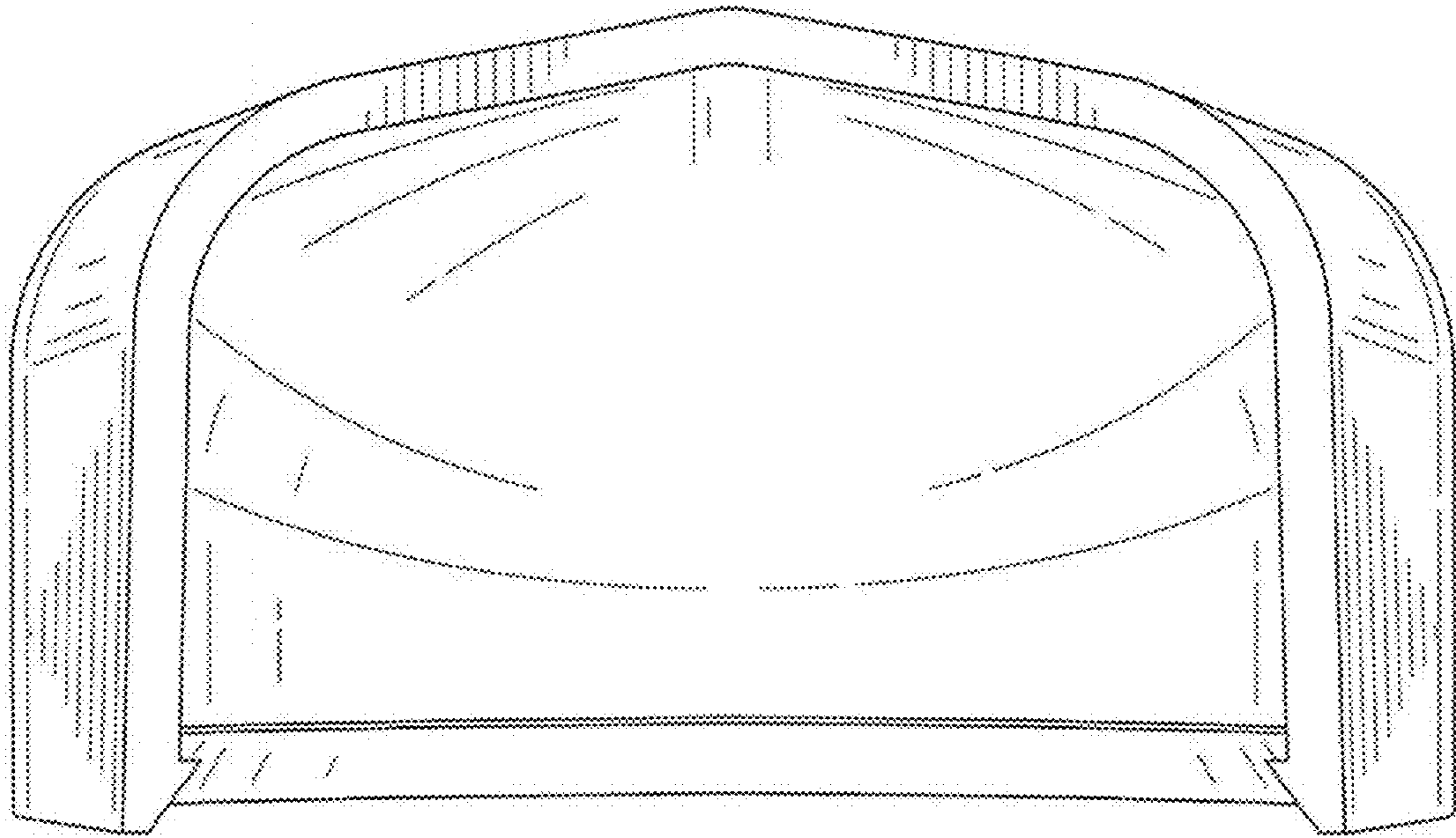

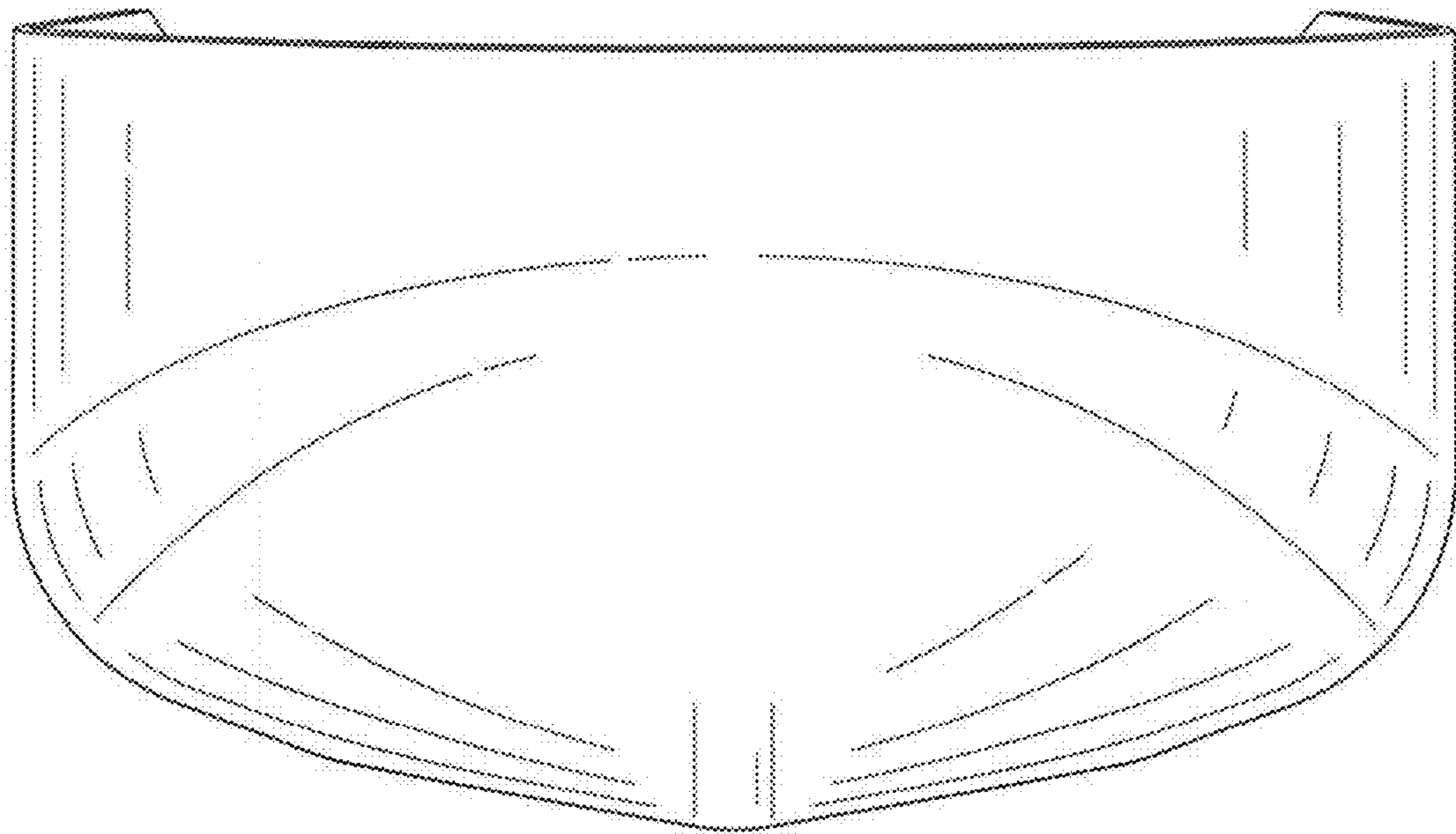

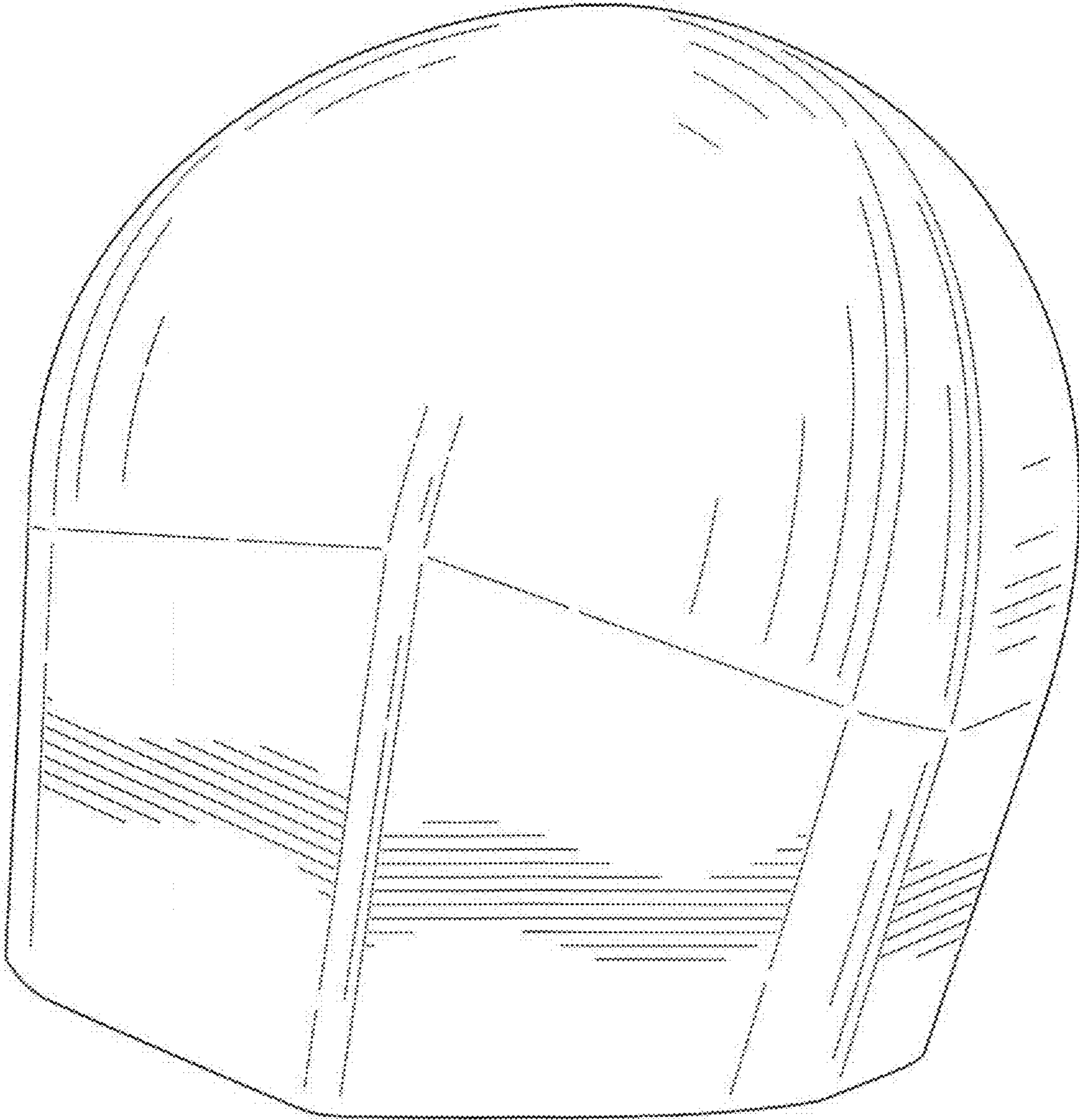

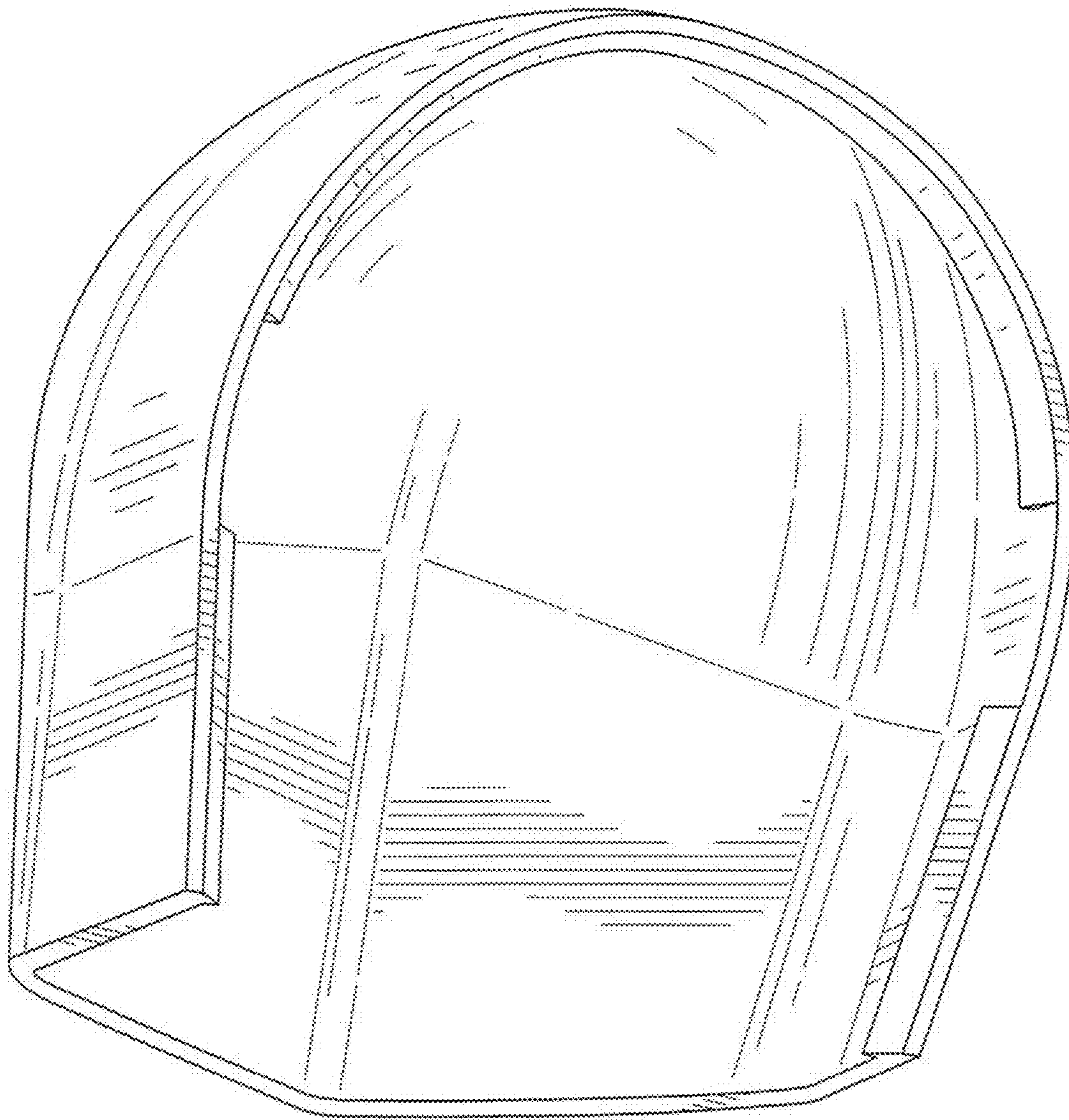

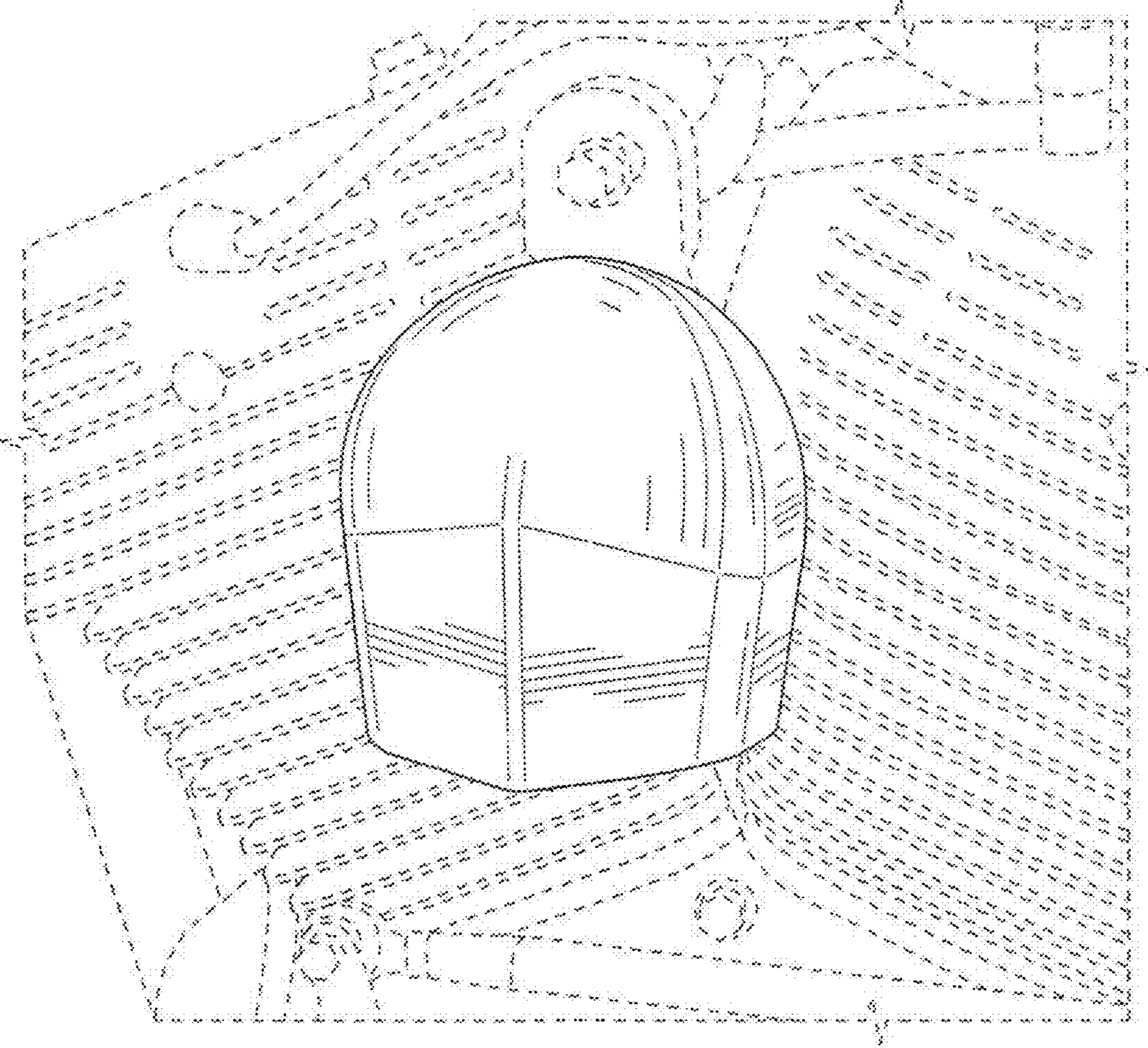
