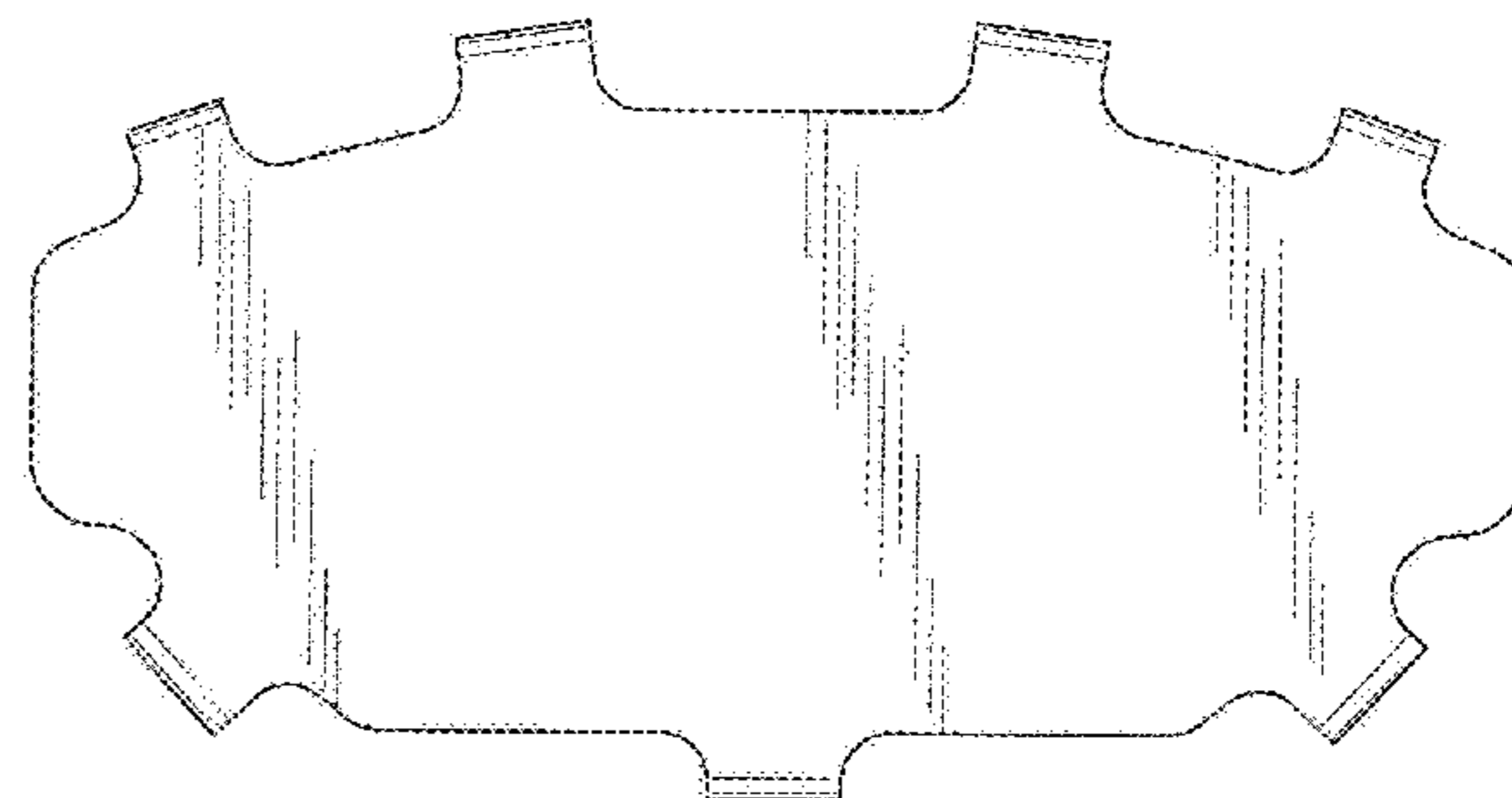
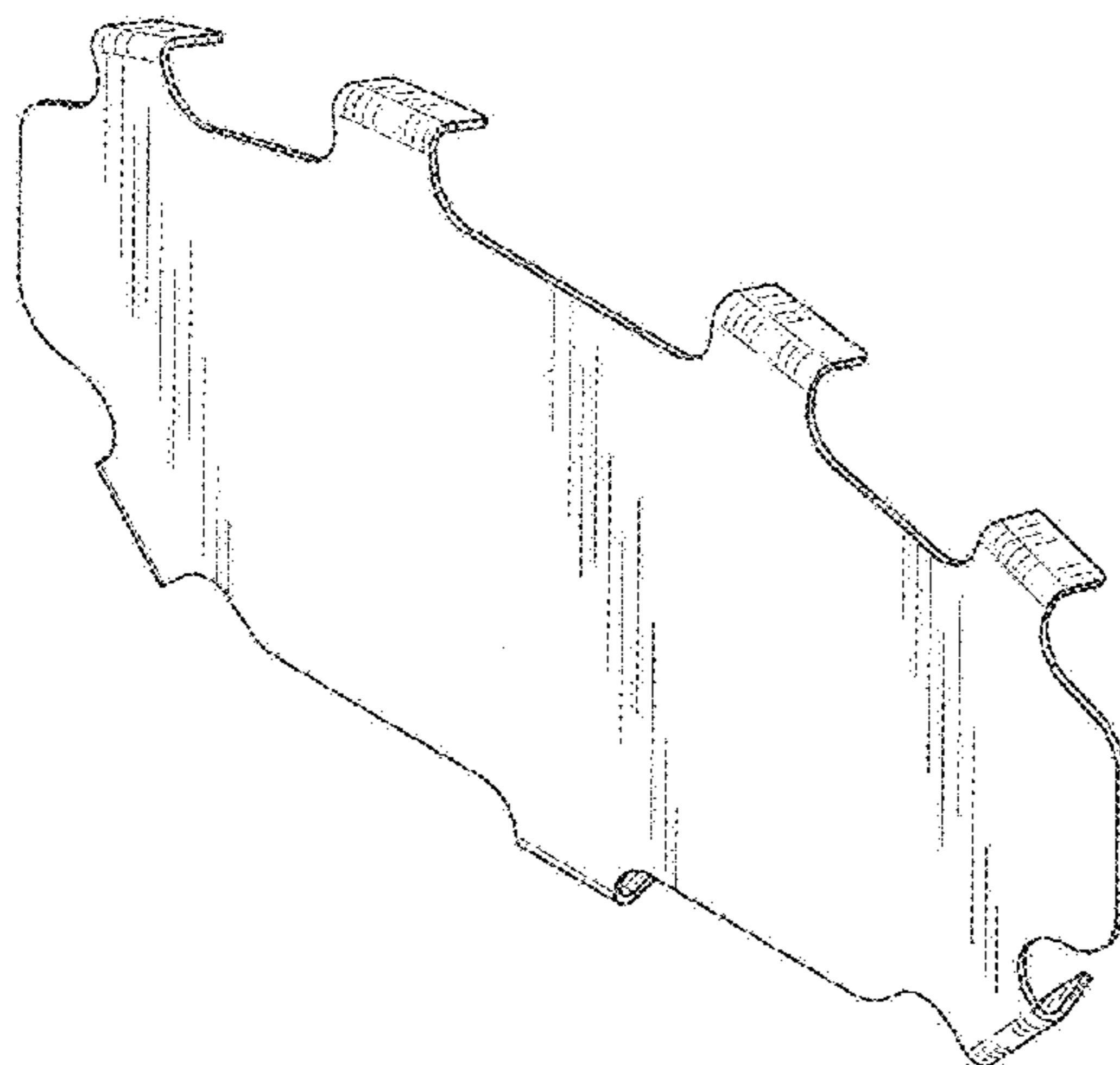
(57) **CLAIM**

I claim the ornamental design for a brake shim, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front of a brake shim in accordance with said Design;
FIG. 2 is a perspective view from the rear of the brake shim of FIG. 1;
FIG. 3 is a left side view of the brake shim of FIG. 1;
FIG. 4 is a front view of the brake shim of FIG. 1;
FIG. 5 is a right side view of the brake shim of FIG. 1,
FIG. 6 is a rear view of the brake shim of FIG. 1,
FIG. 7 is a top view of the brake shim of FIG. 1; and,
FIG. 8 is a bottom view of the brake shim of FIG. 1.

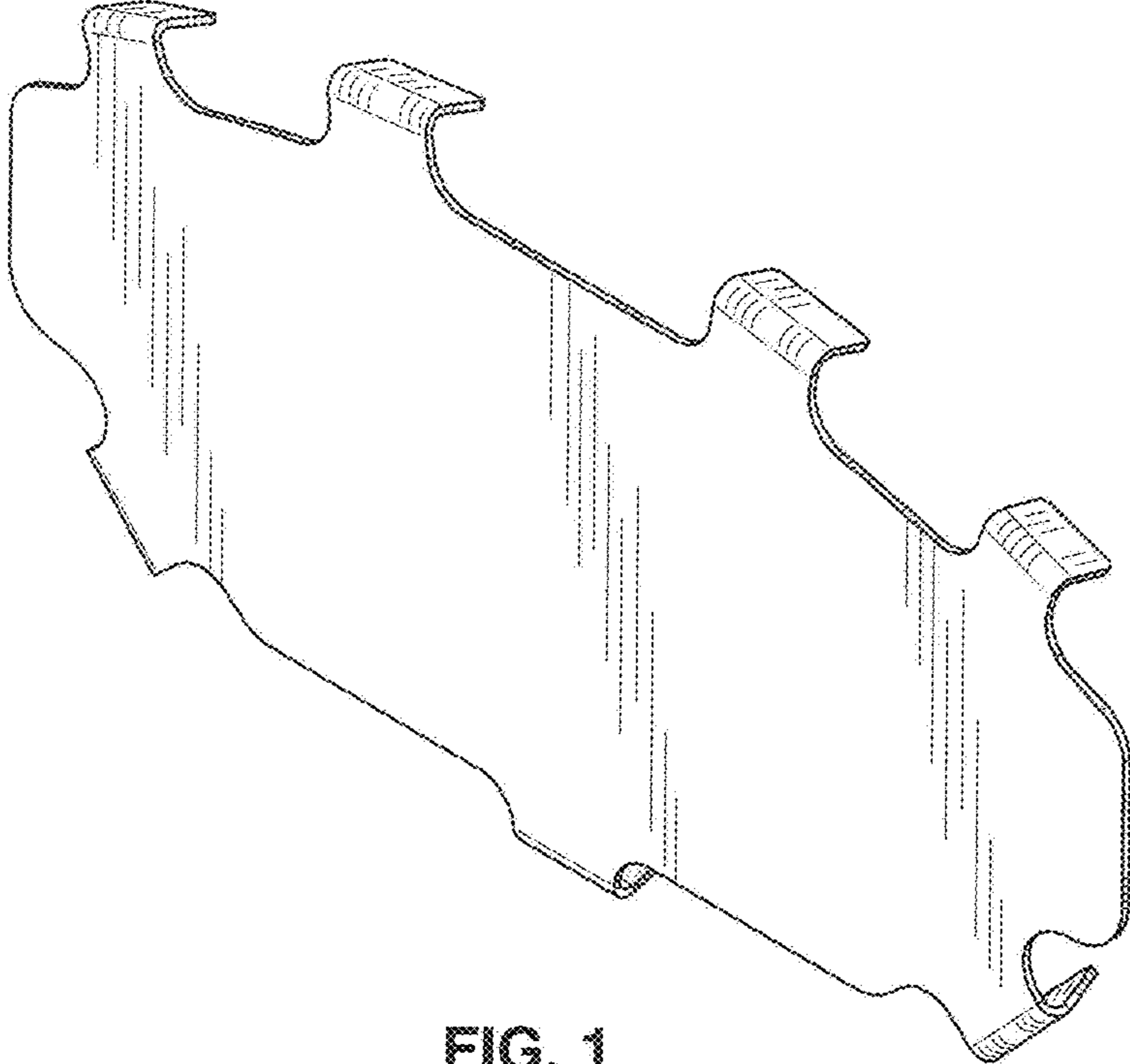

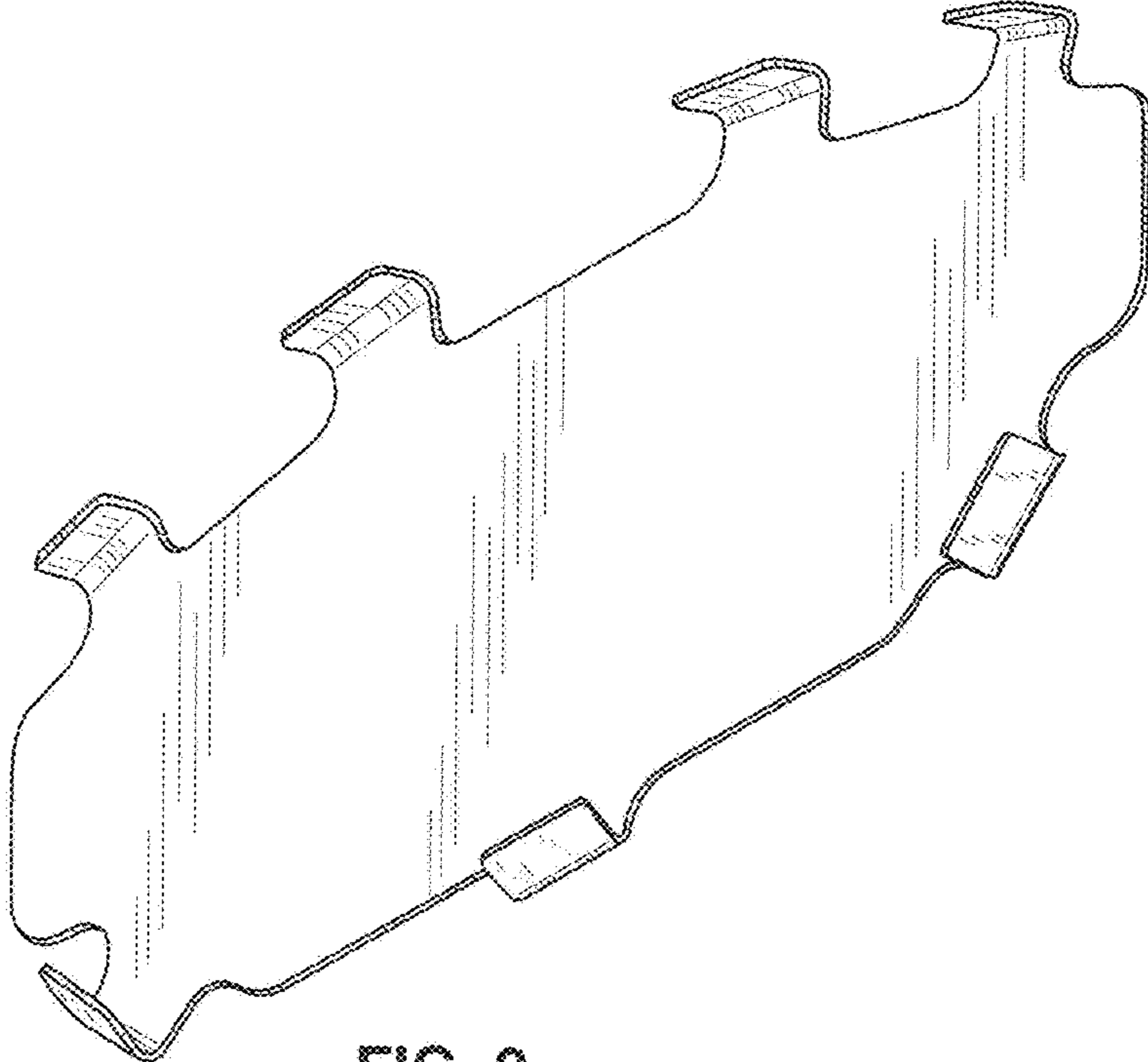

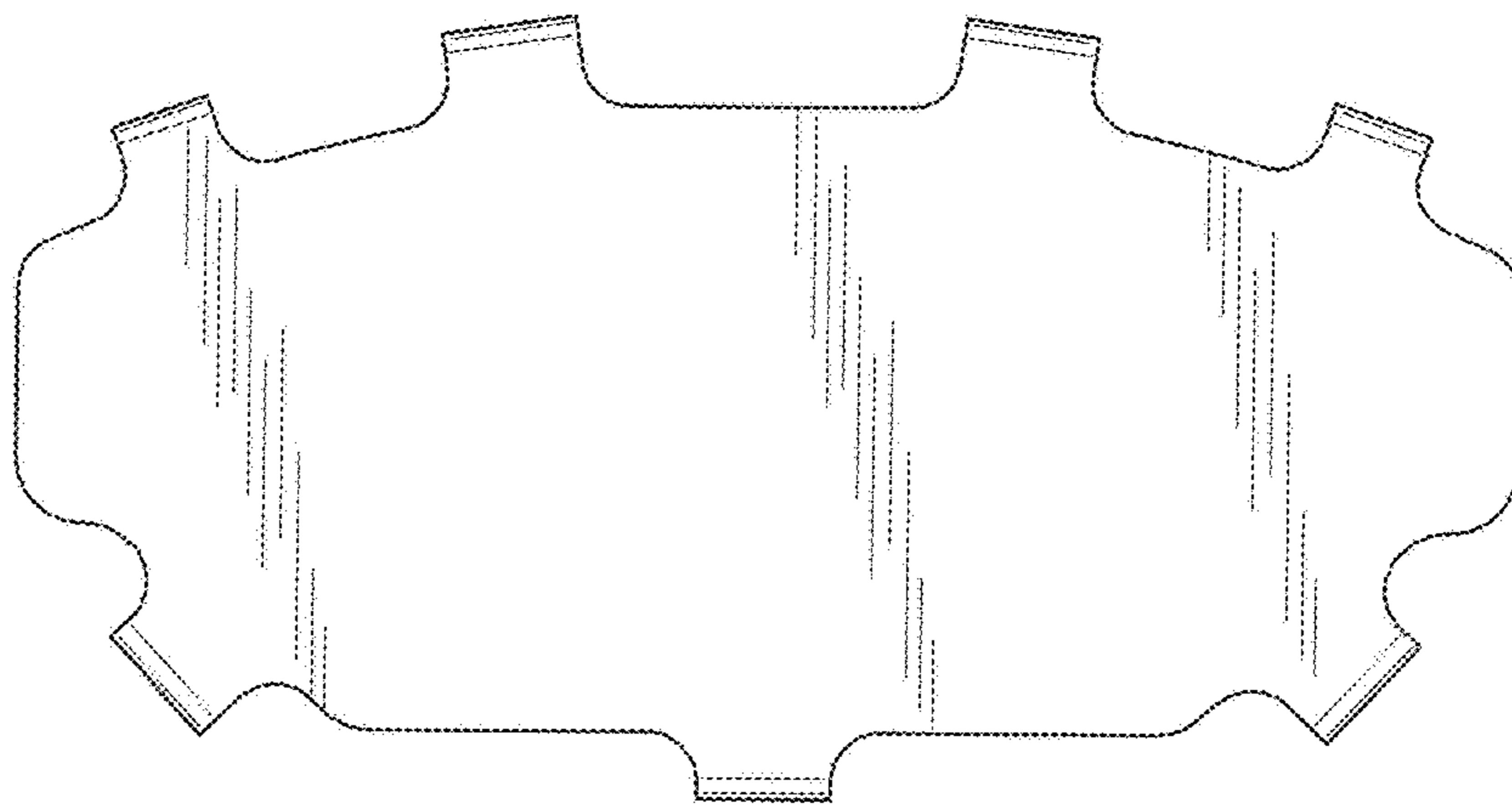

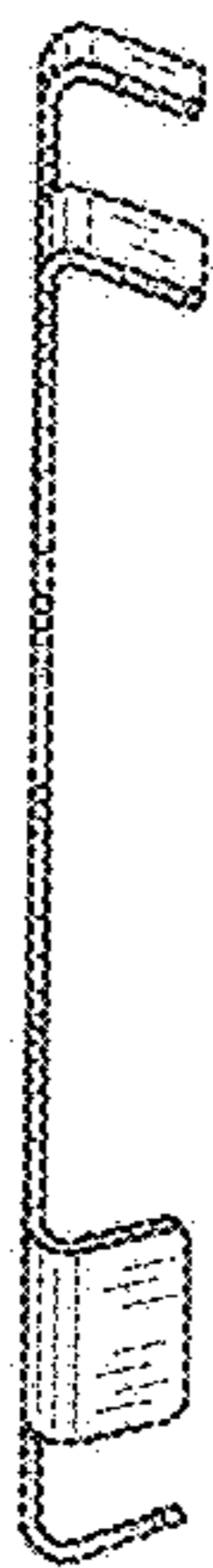

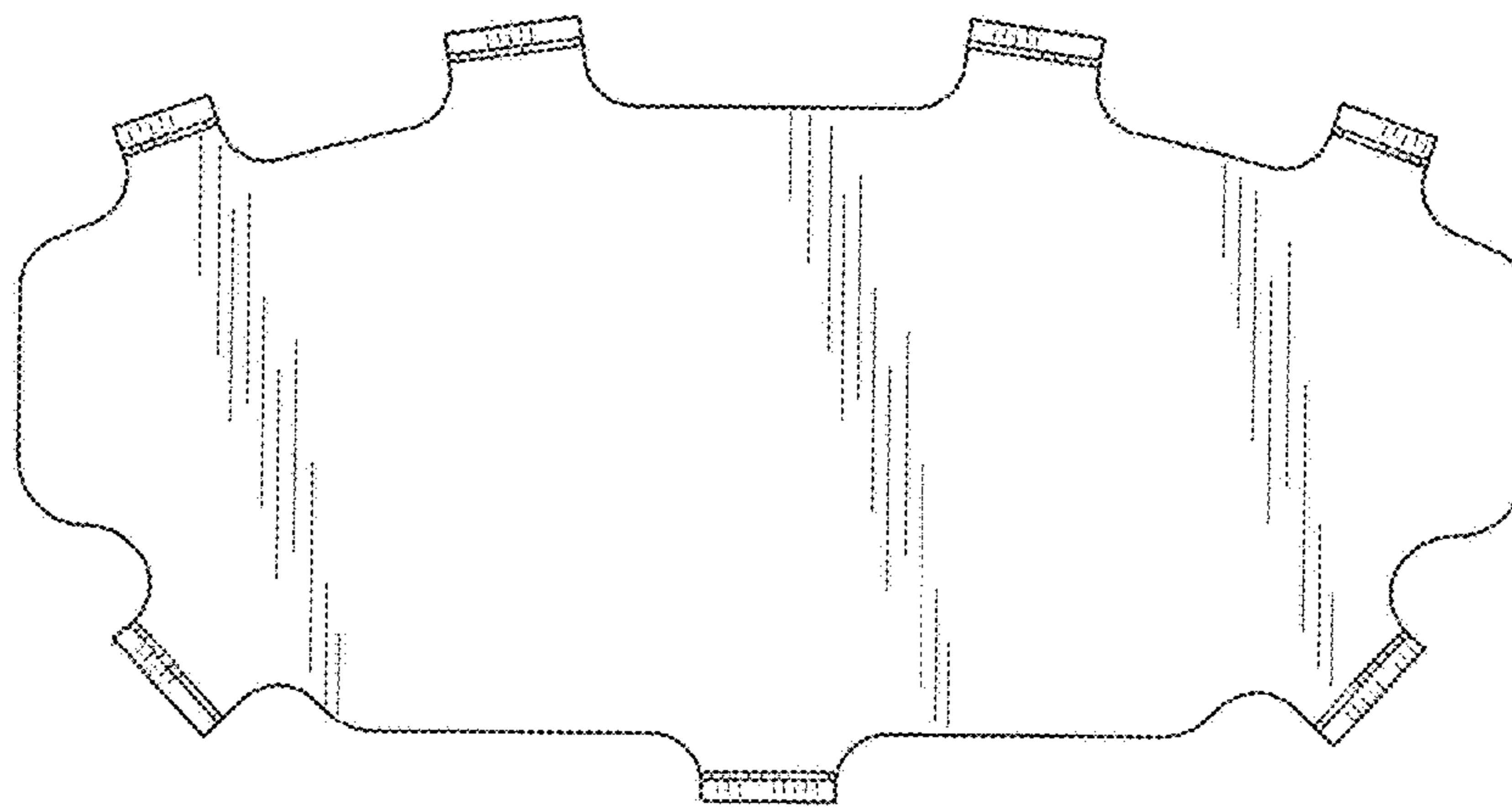

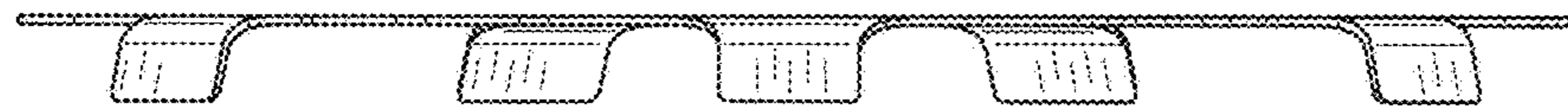
