The ornamental design for a wheel or wheel cover, as shown and described.

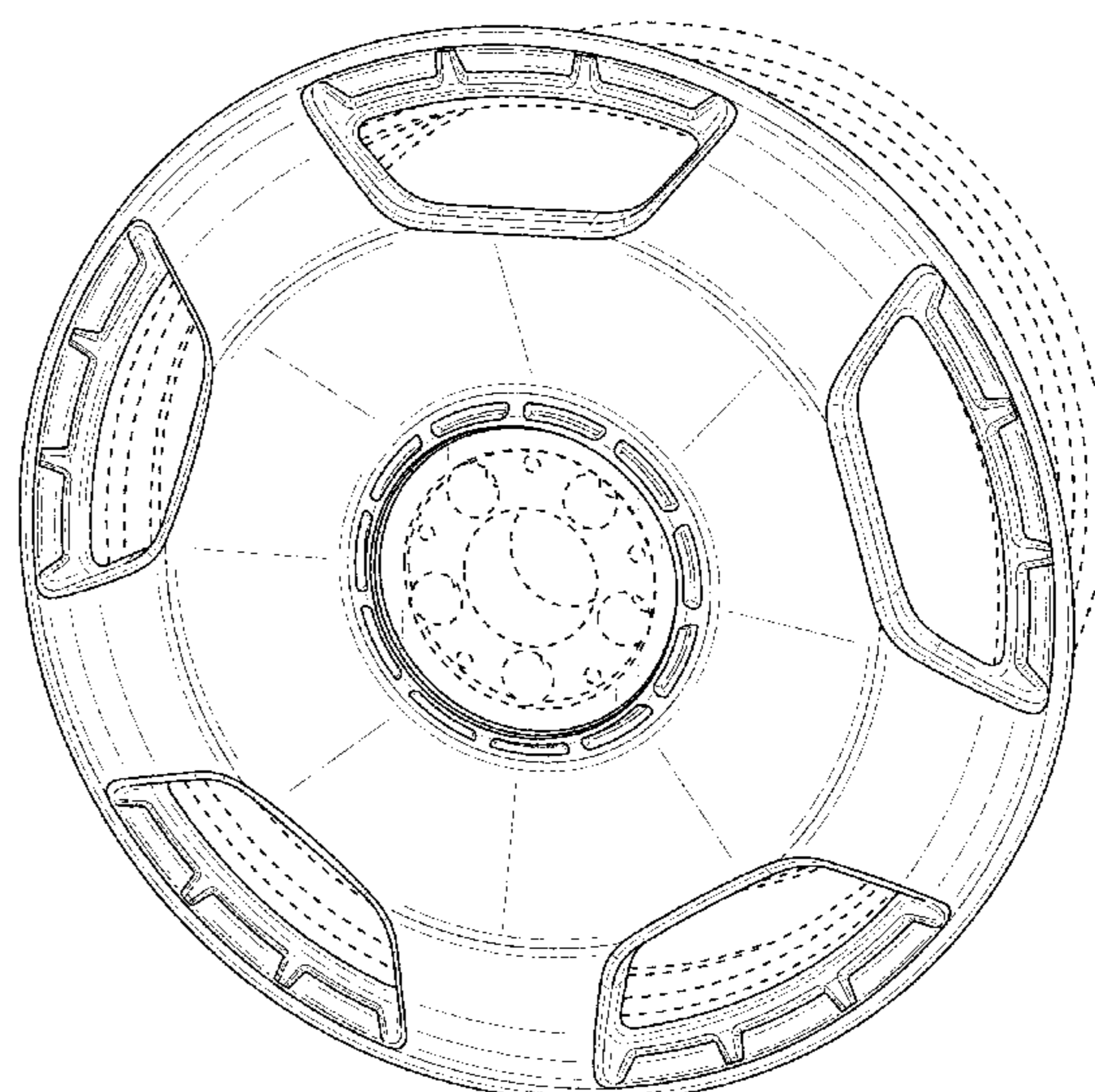
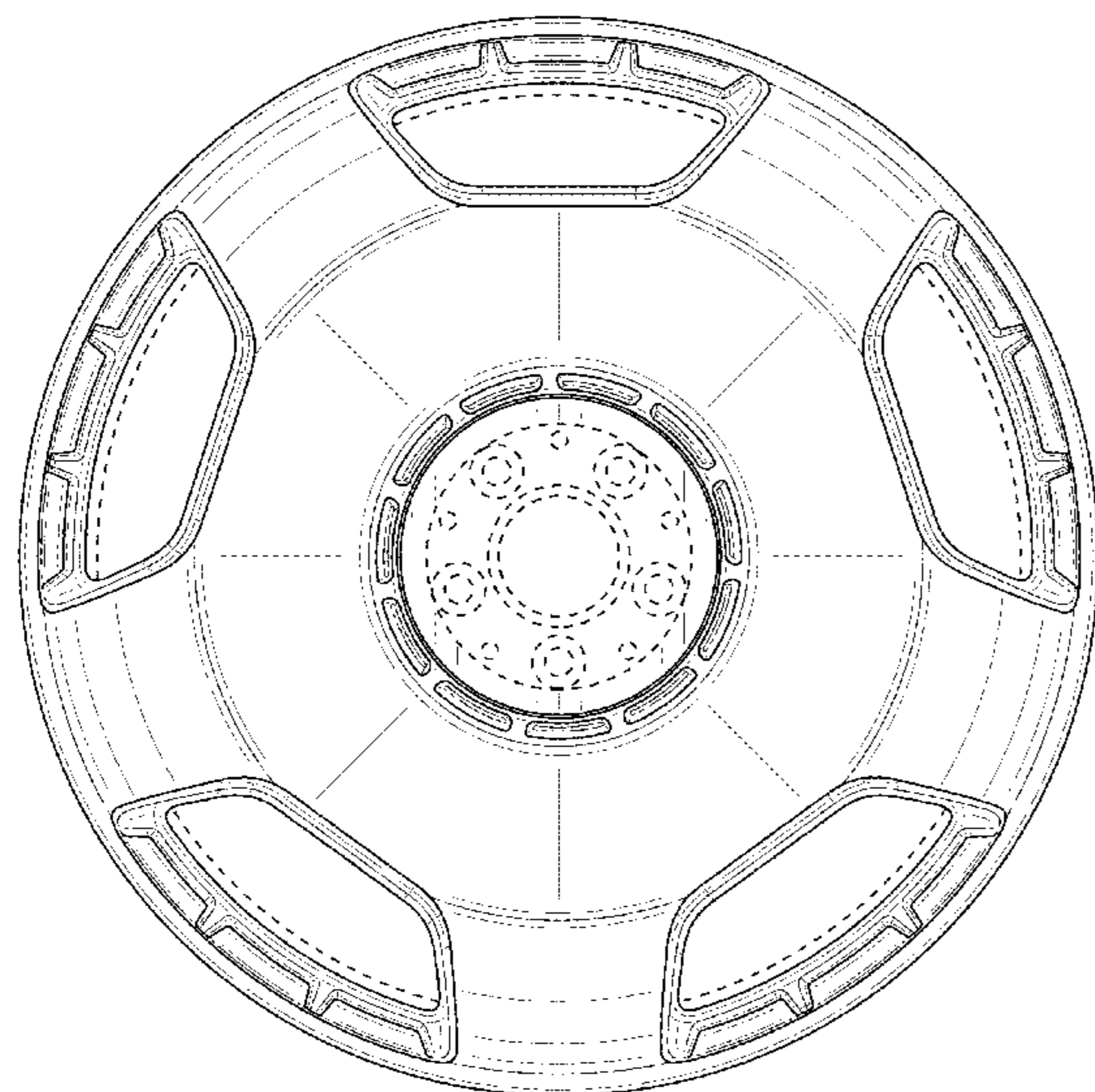
**DESCRIPTION**

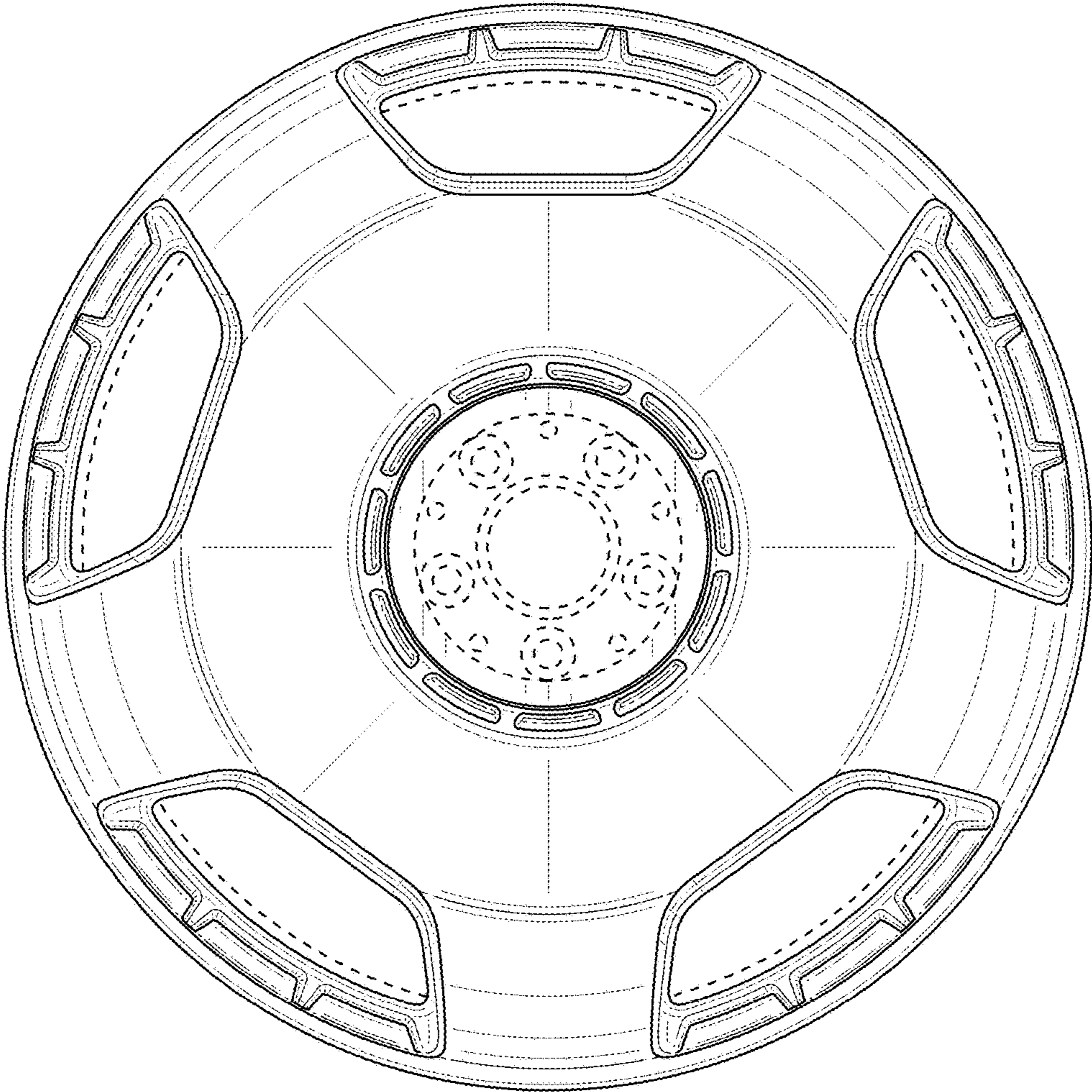
FIG. 1 is a front view of a wheel or wheel cover according to the design; and,

FIG. 2 is a perspective view thereof.

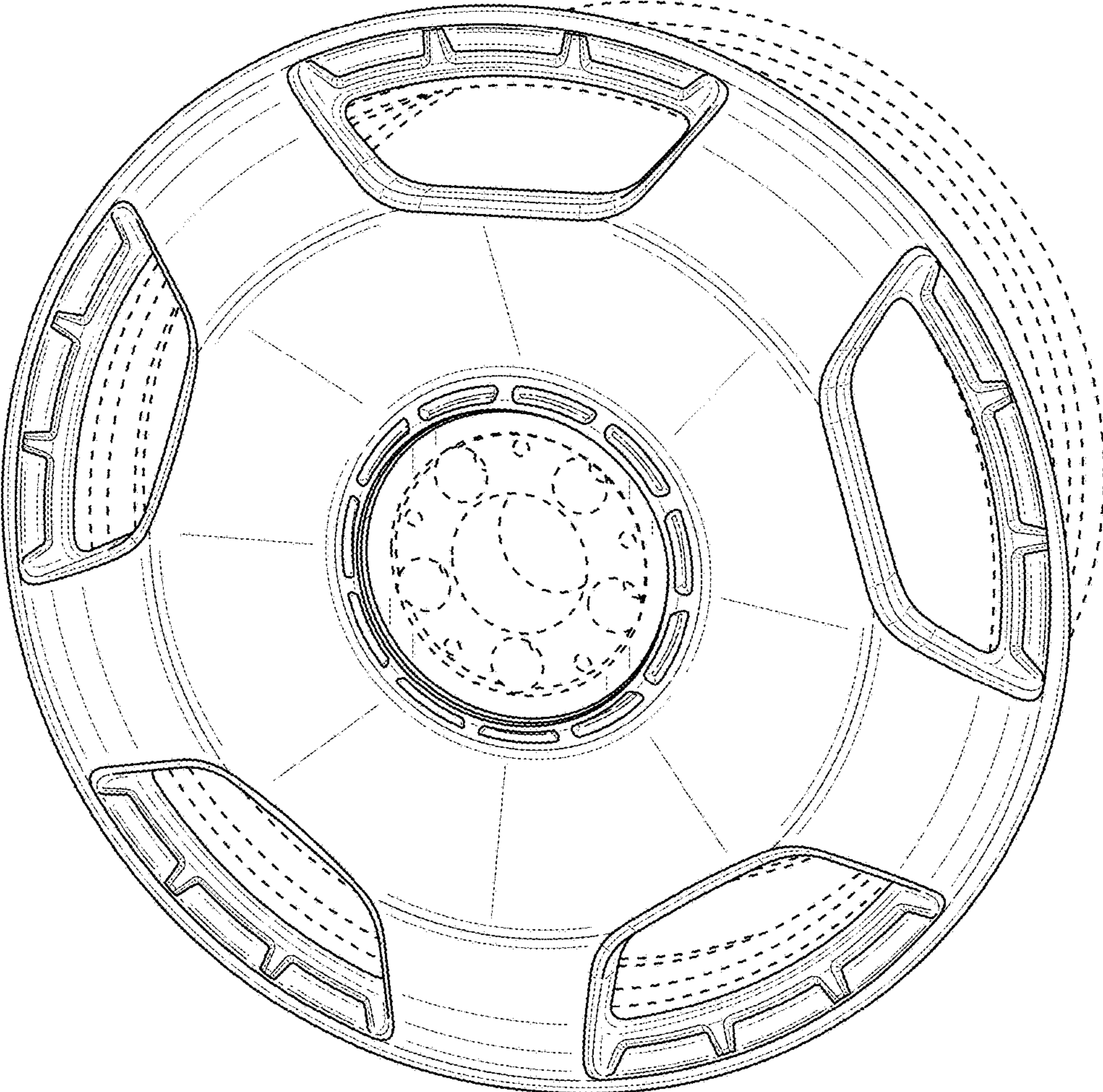
