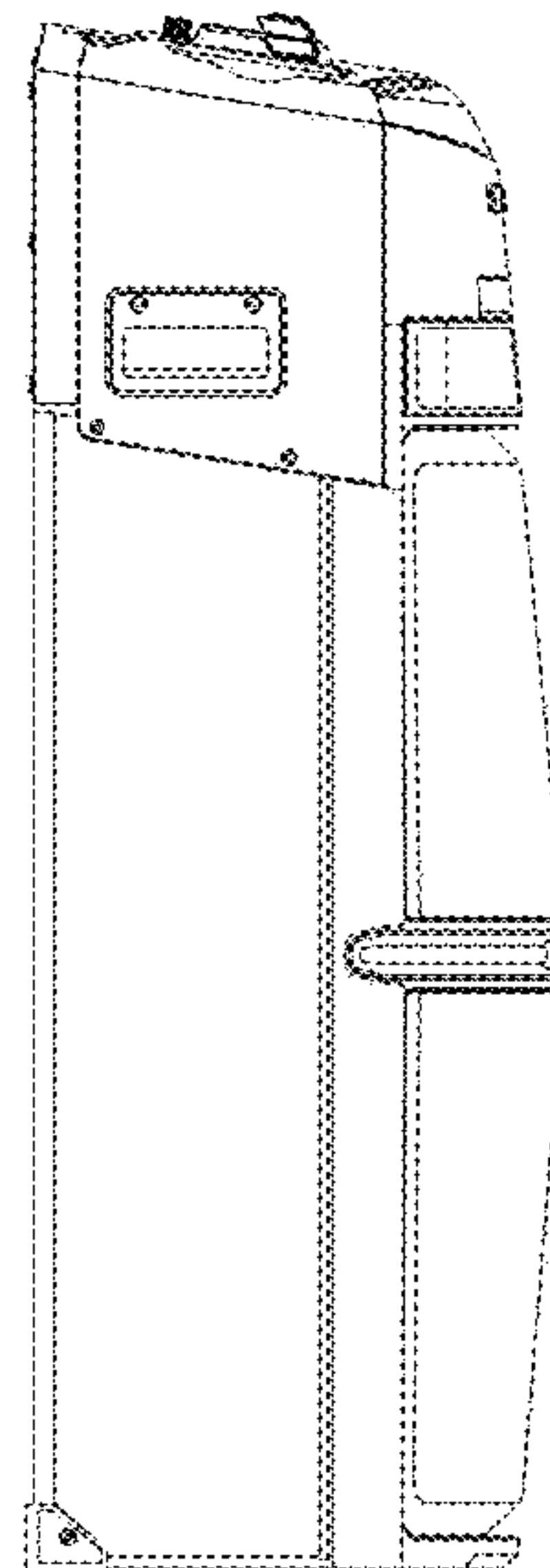
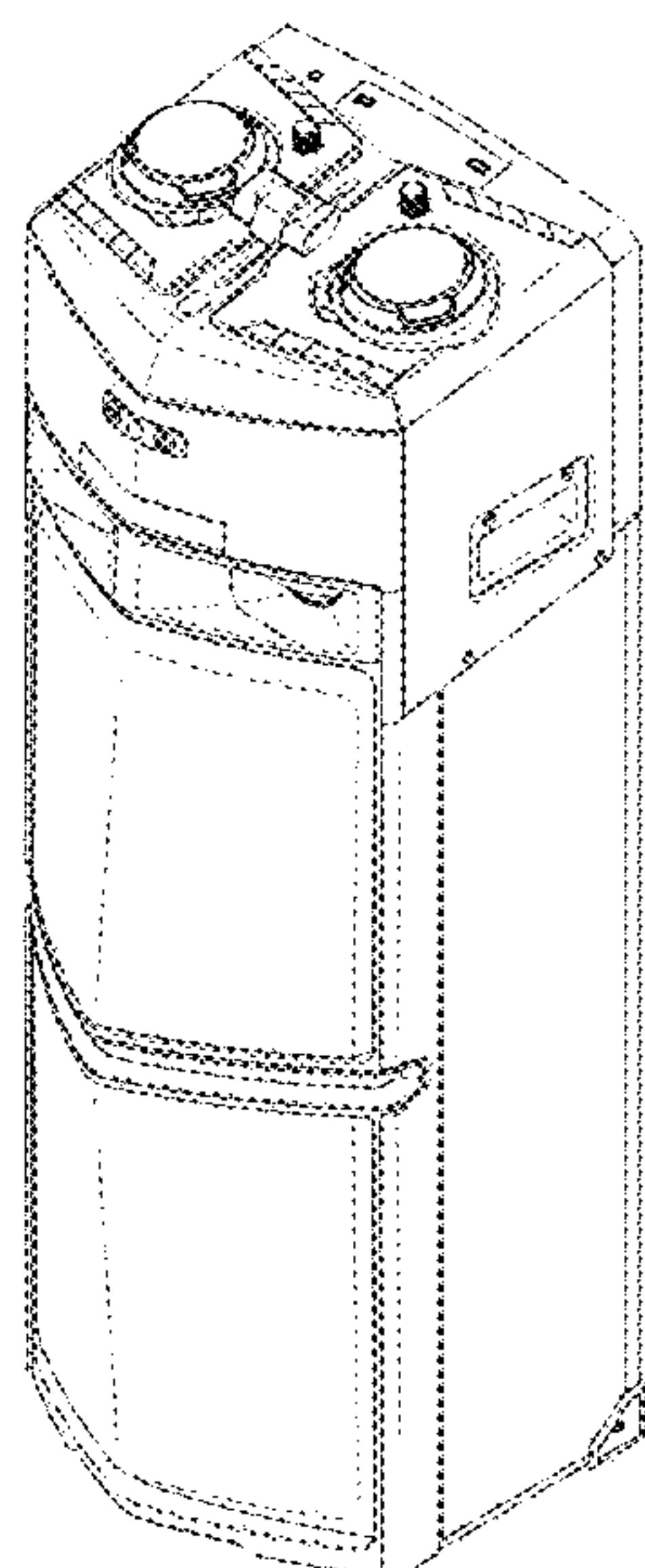

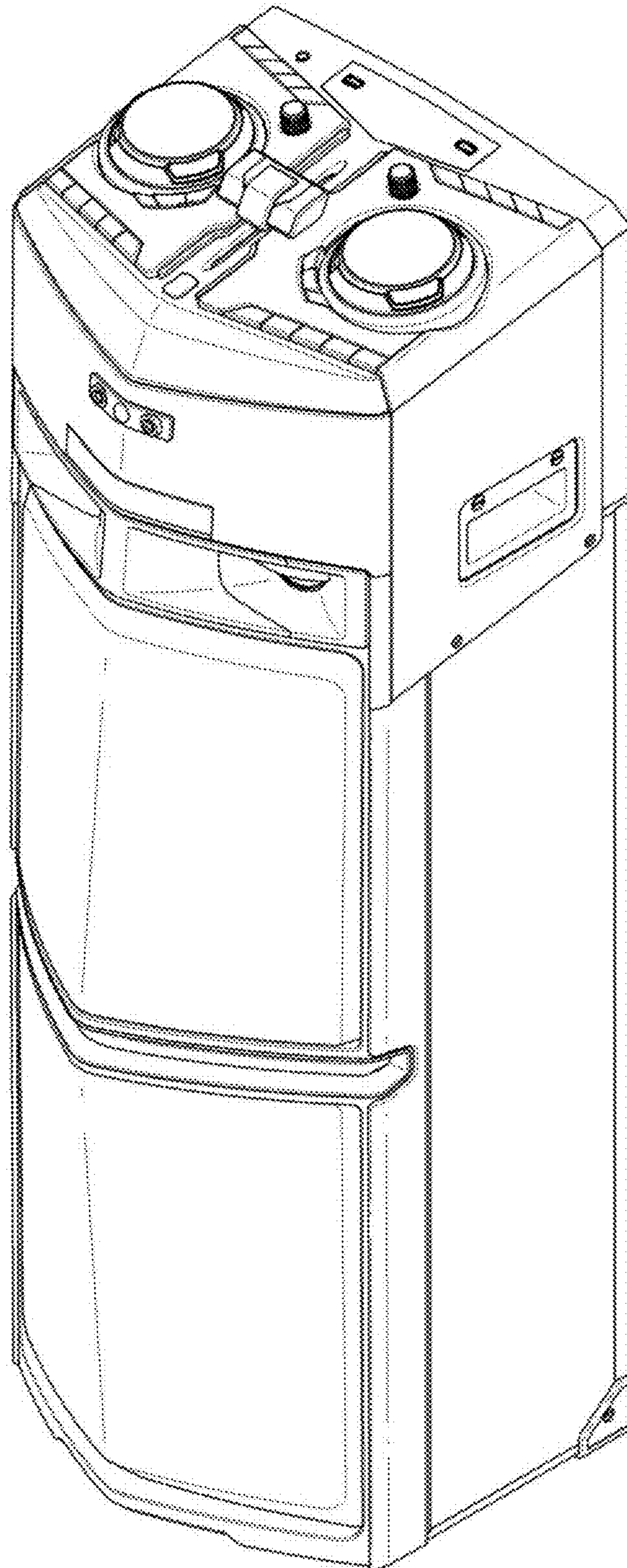

The present ornamental design is a combination of the shape and pattern of an audio player as shown and described; the broken lines indicate unclaimed portion of the article that form no part of the claimed design.

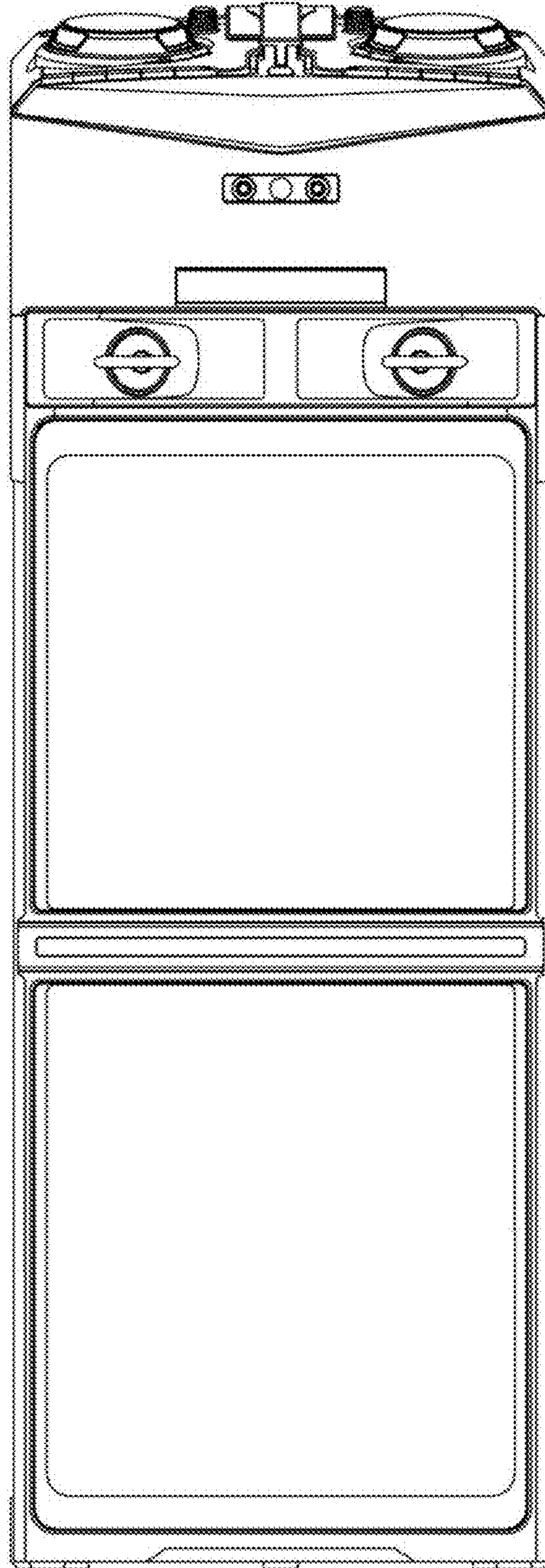

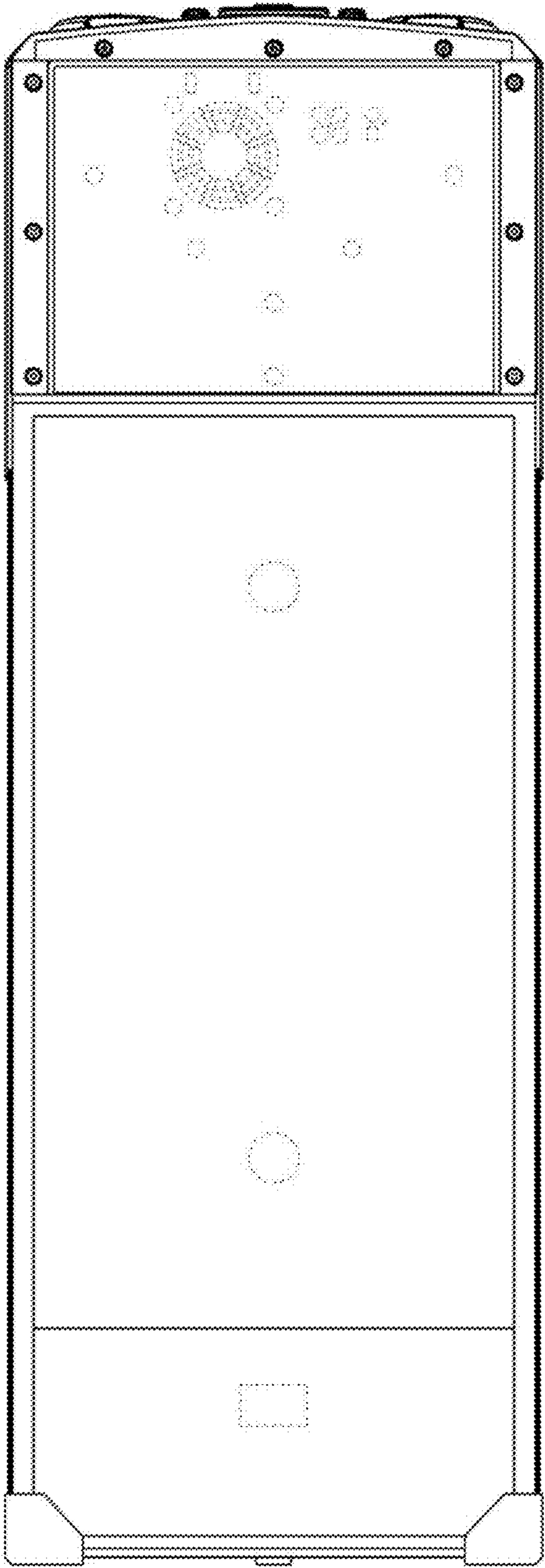

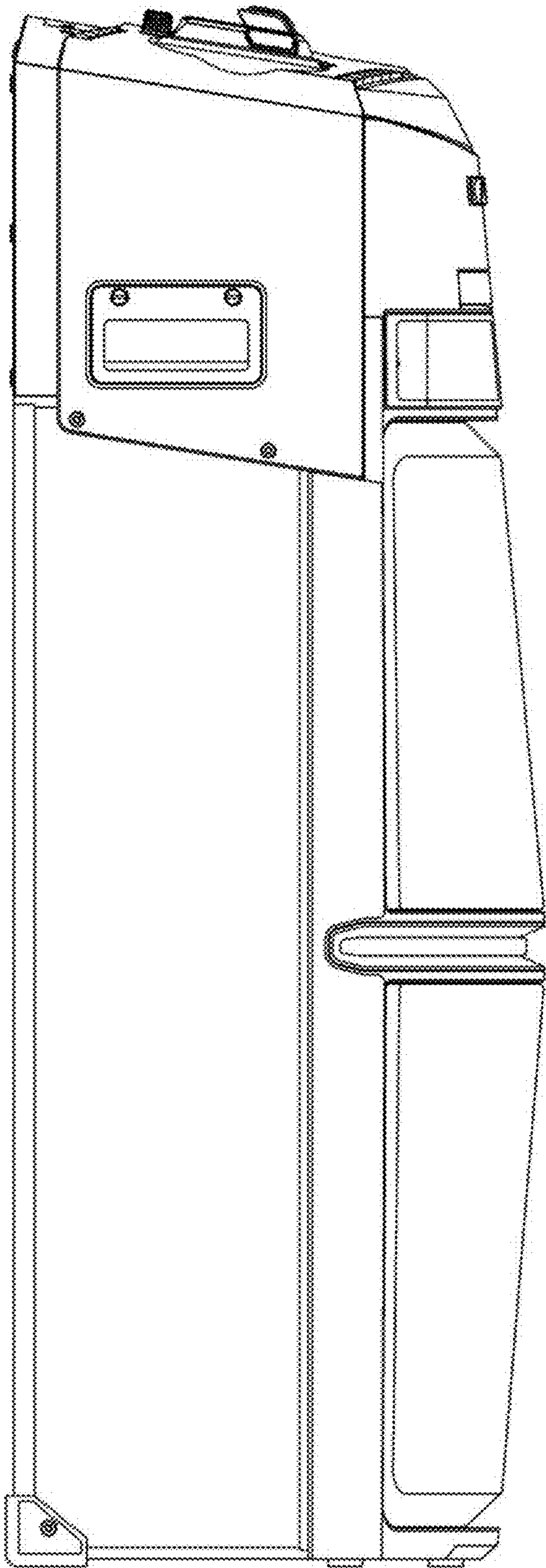

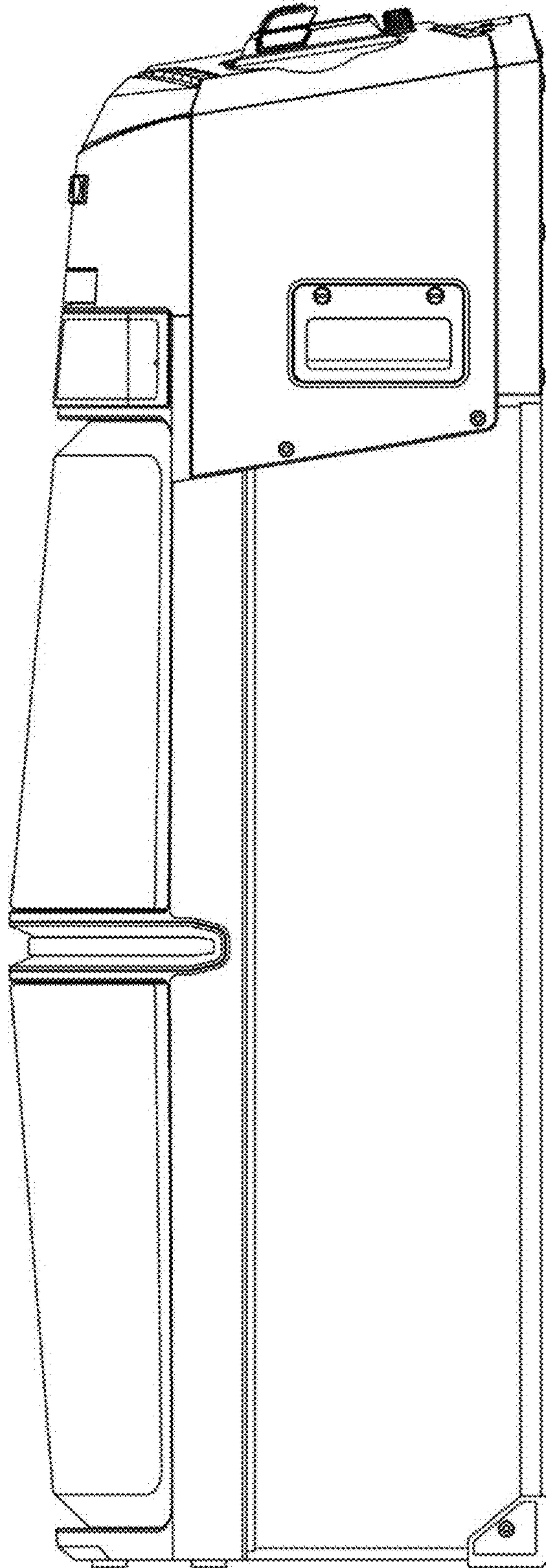

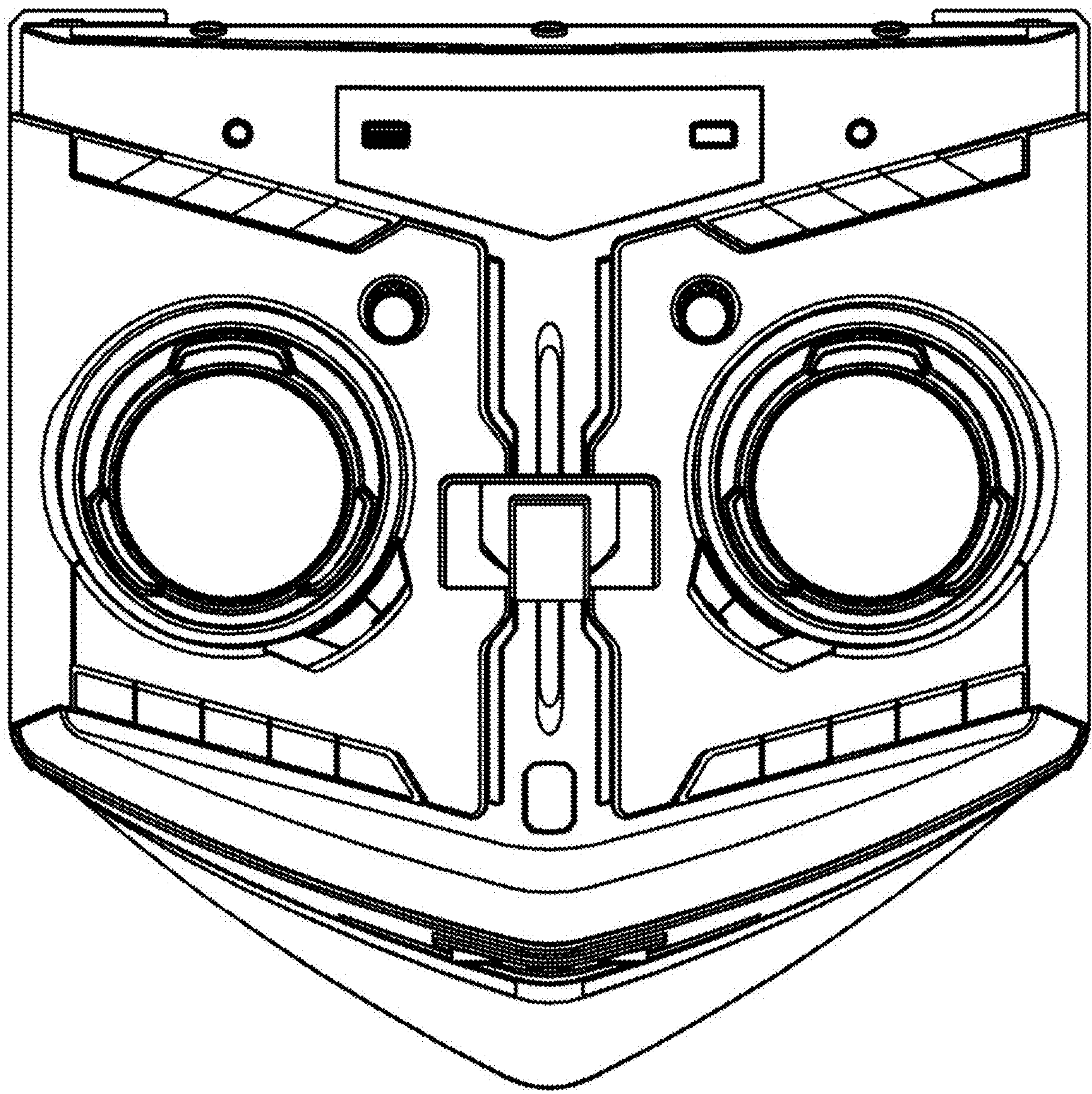
