The ornamental design for a port replicator, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, and right side perspective view of a port replicator showing our new design according to a first embodiment;

FIG. 13 is a front side elevational view thereof;

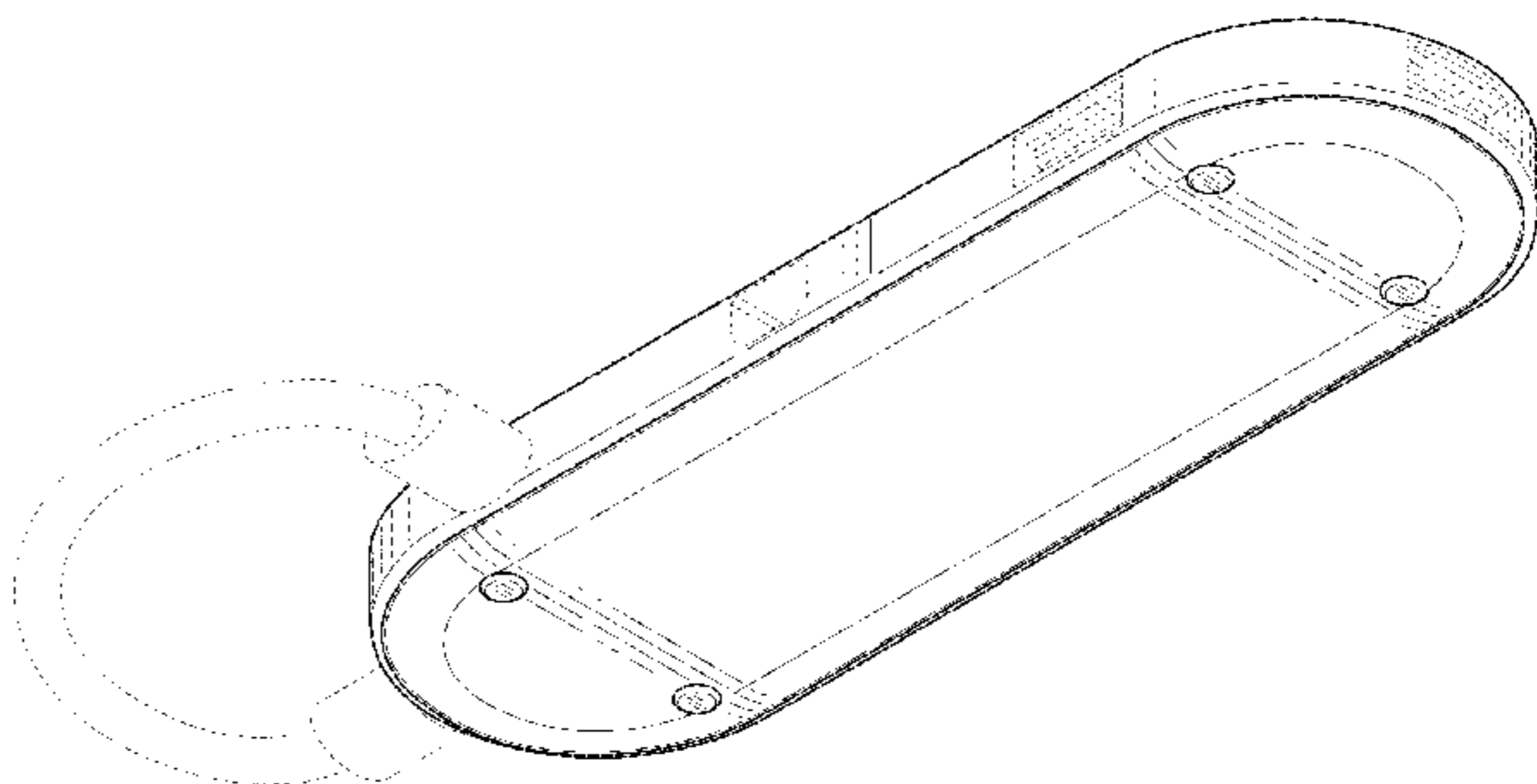
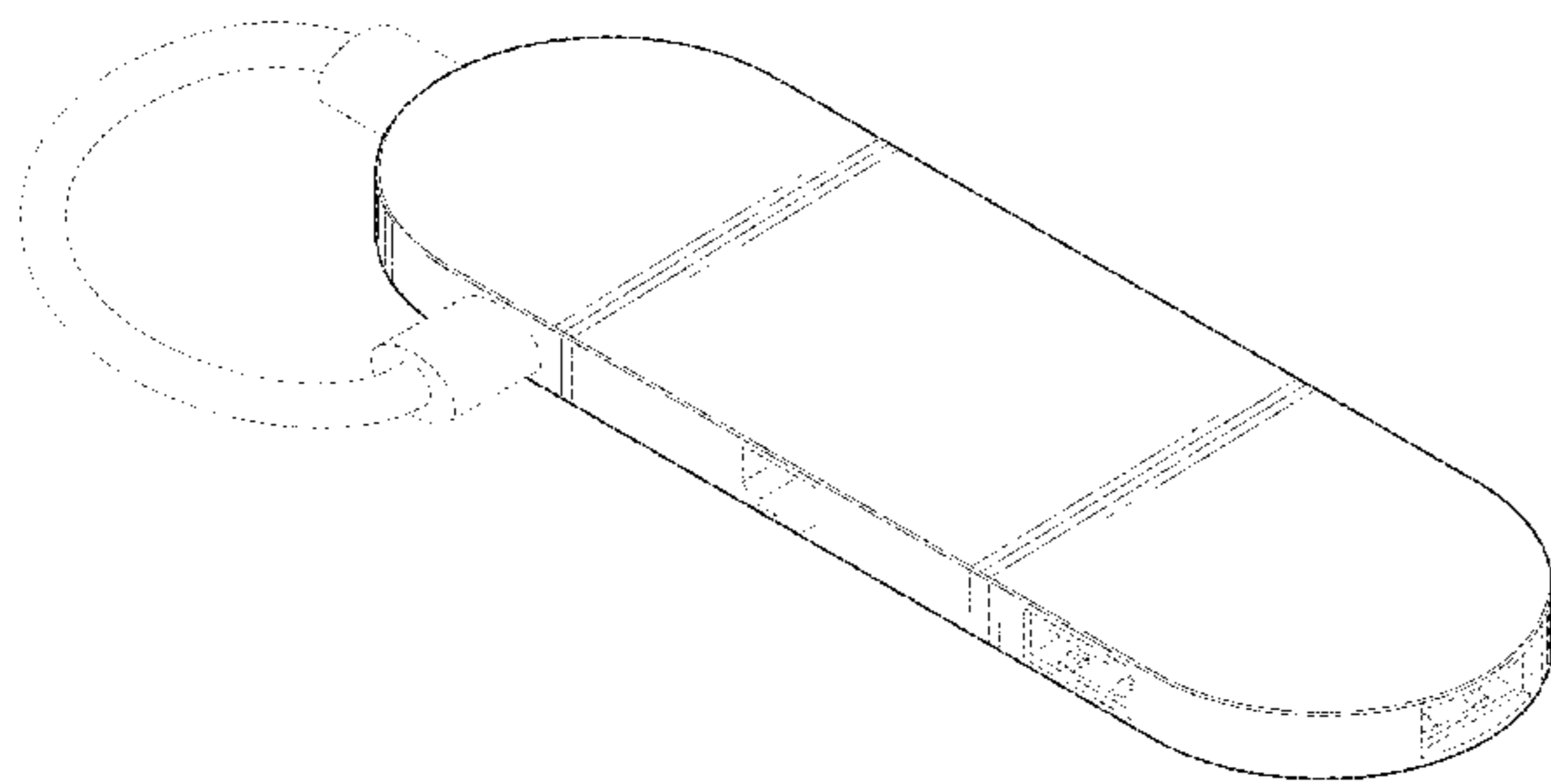
FIG. 14 is rear side elevational view thereof;

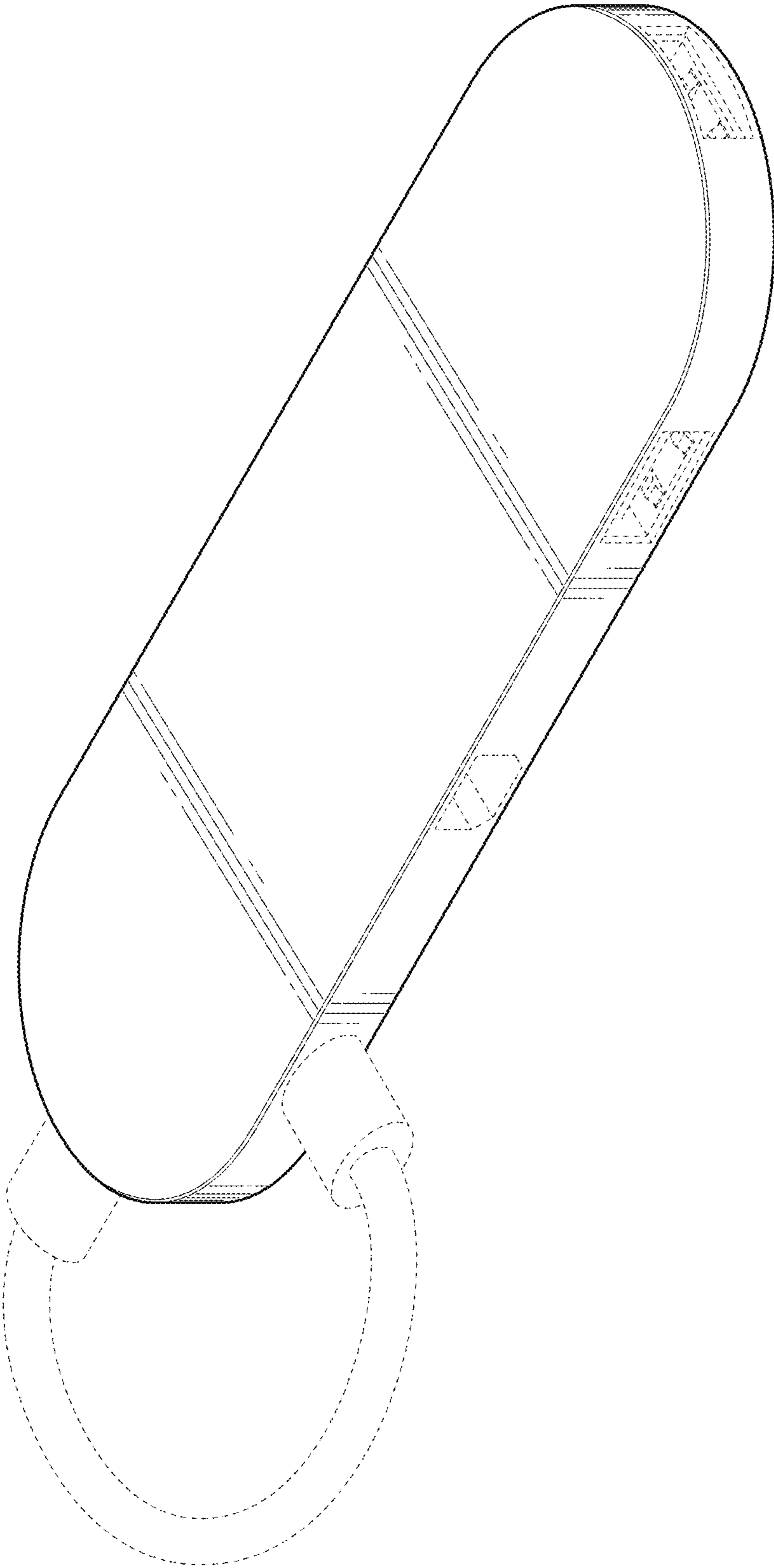

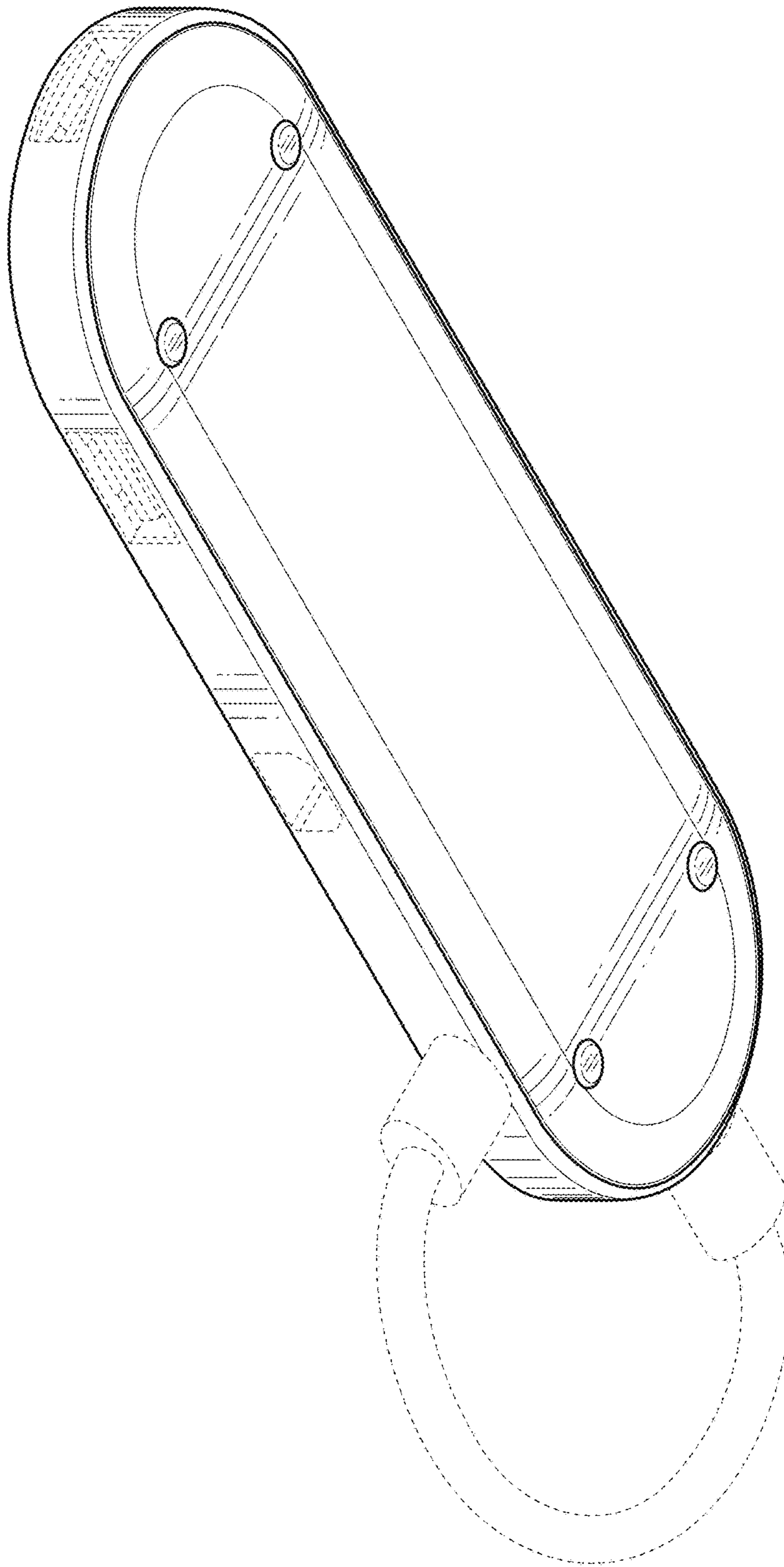

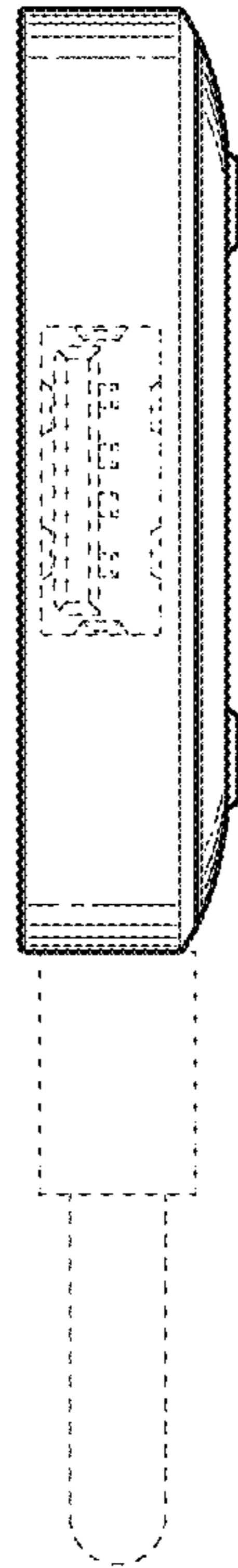

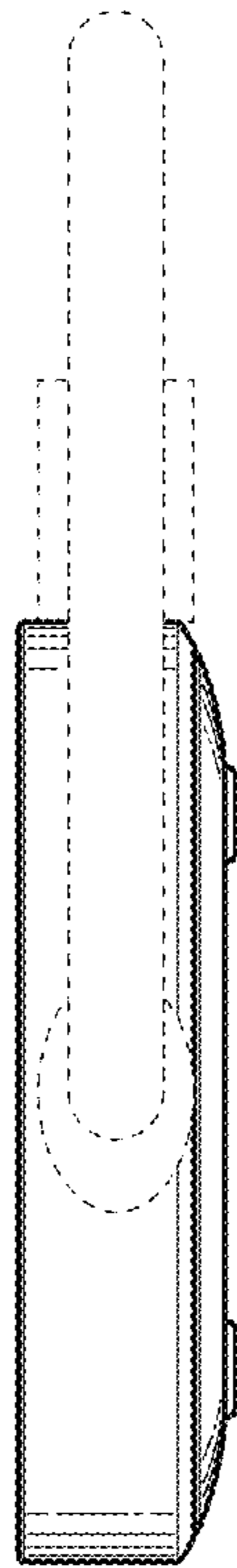

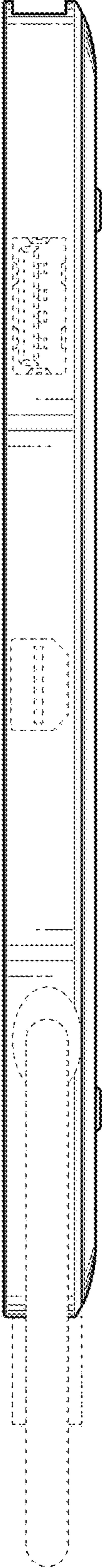

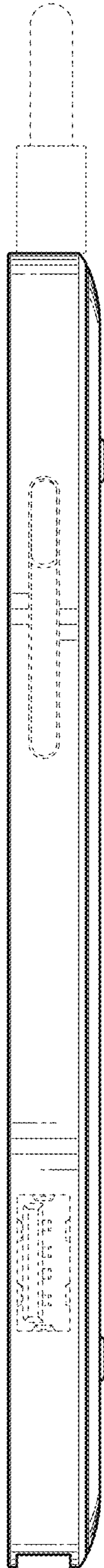

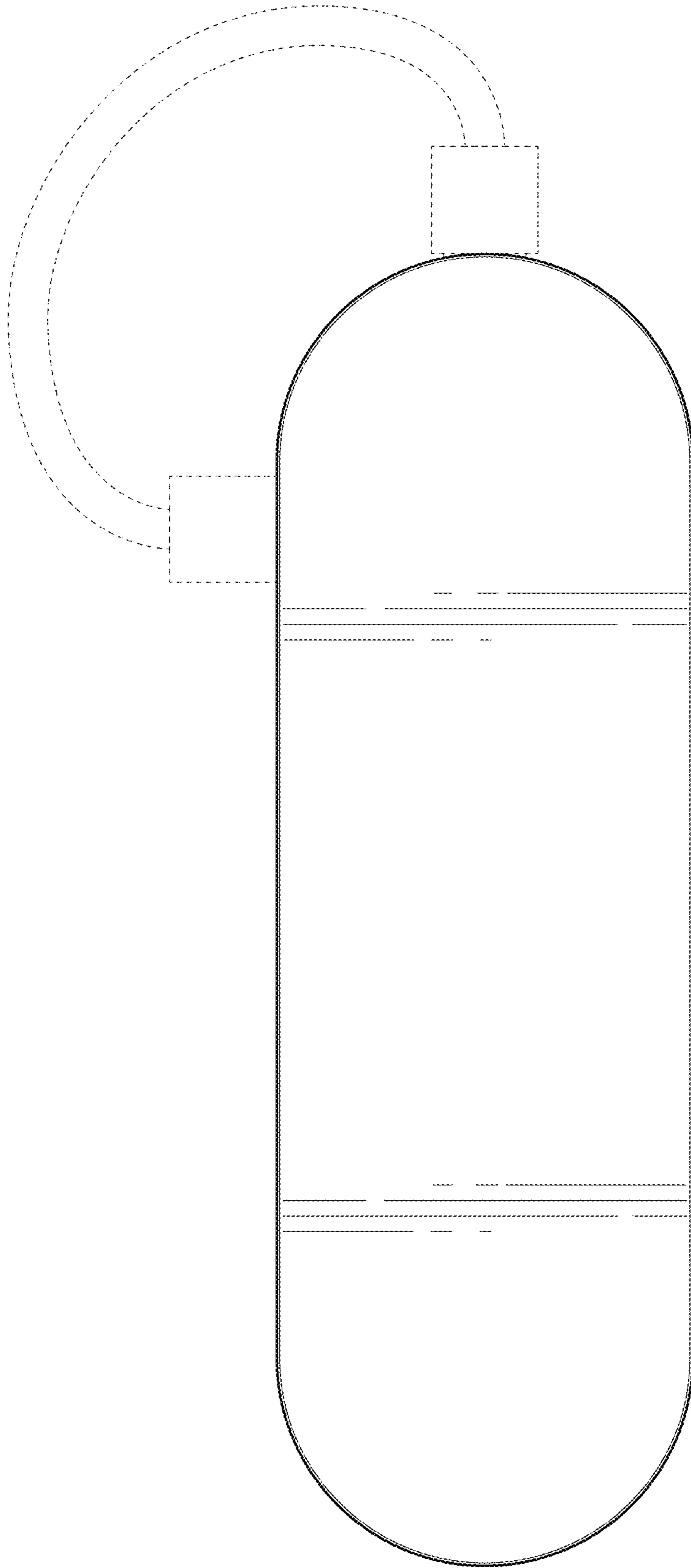

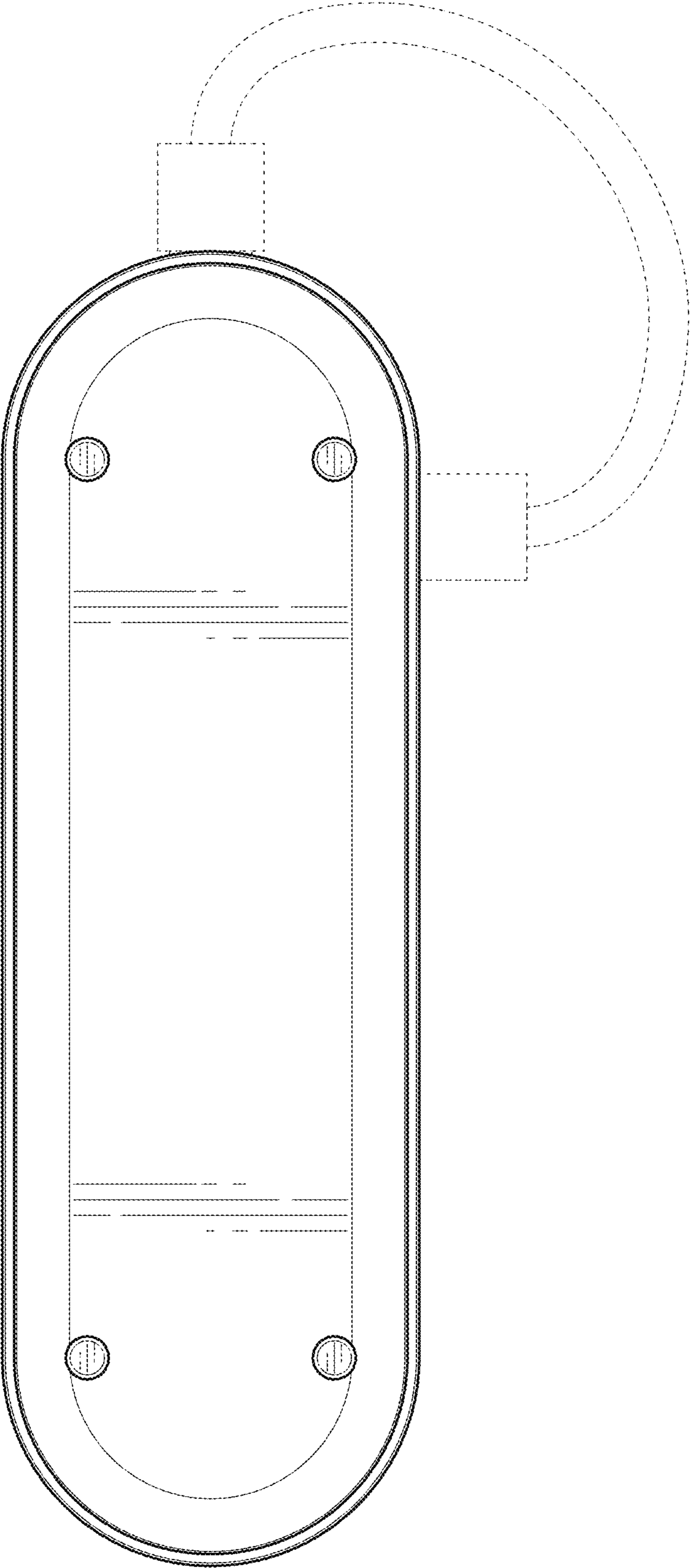

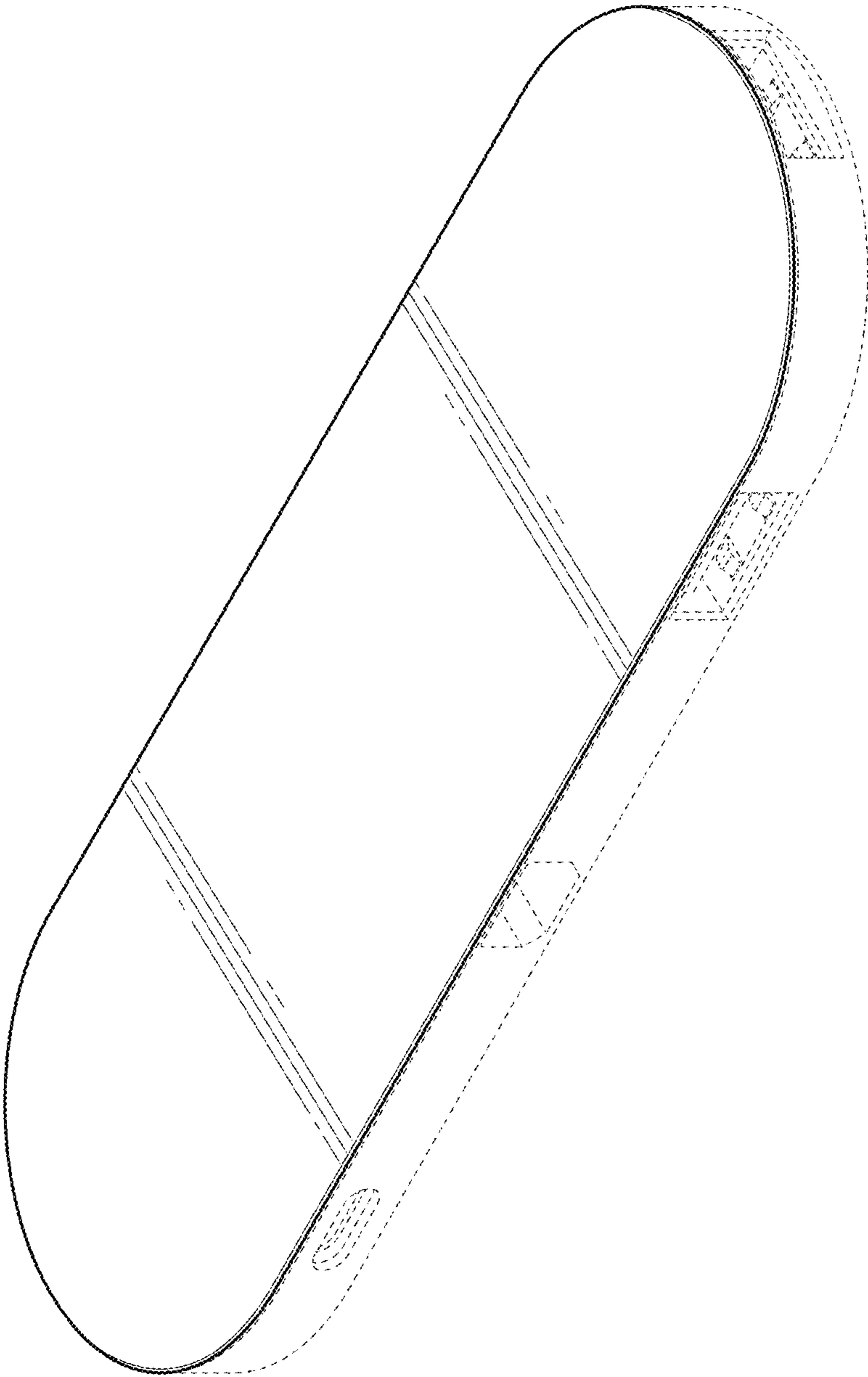

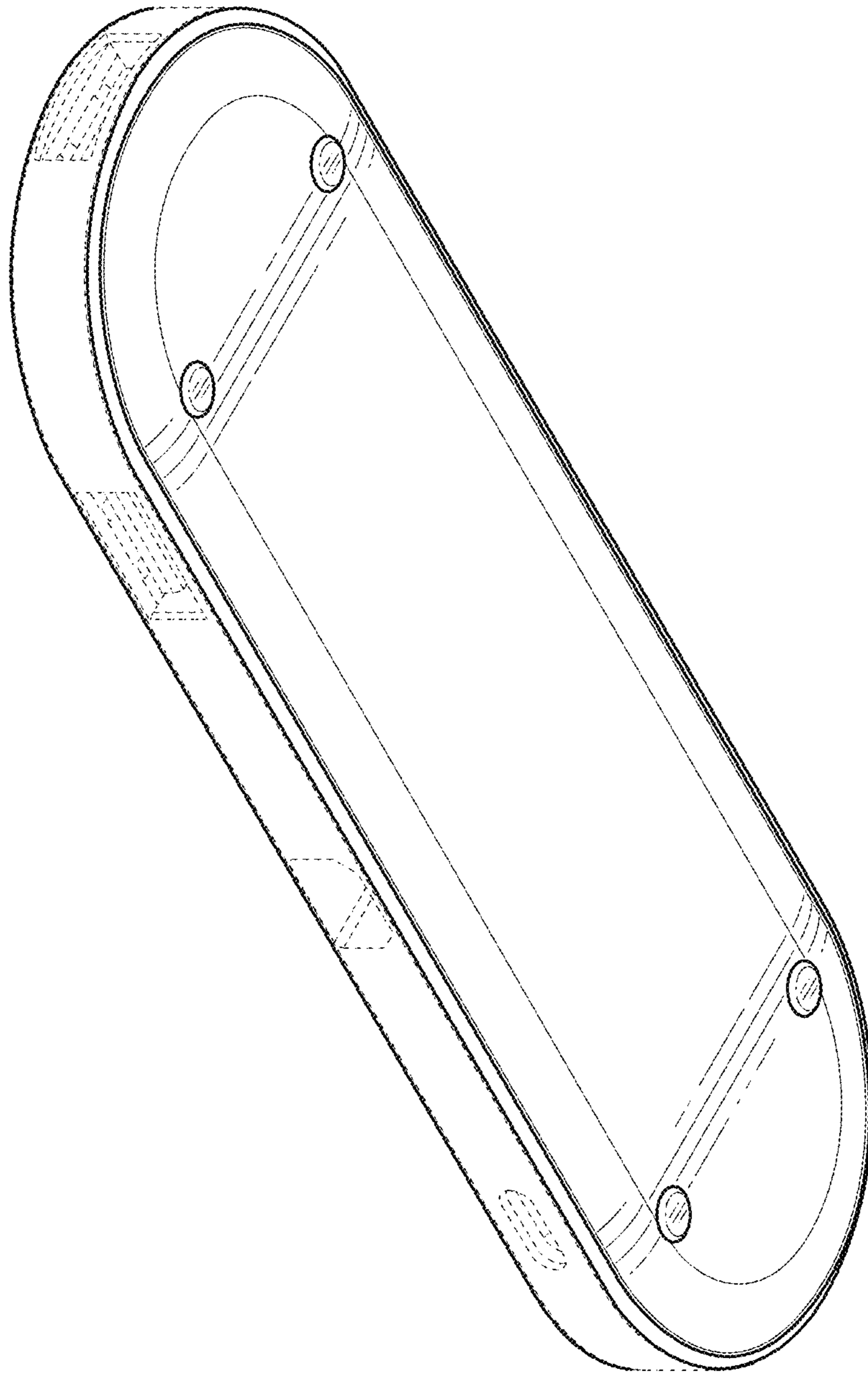

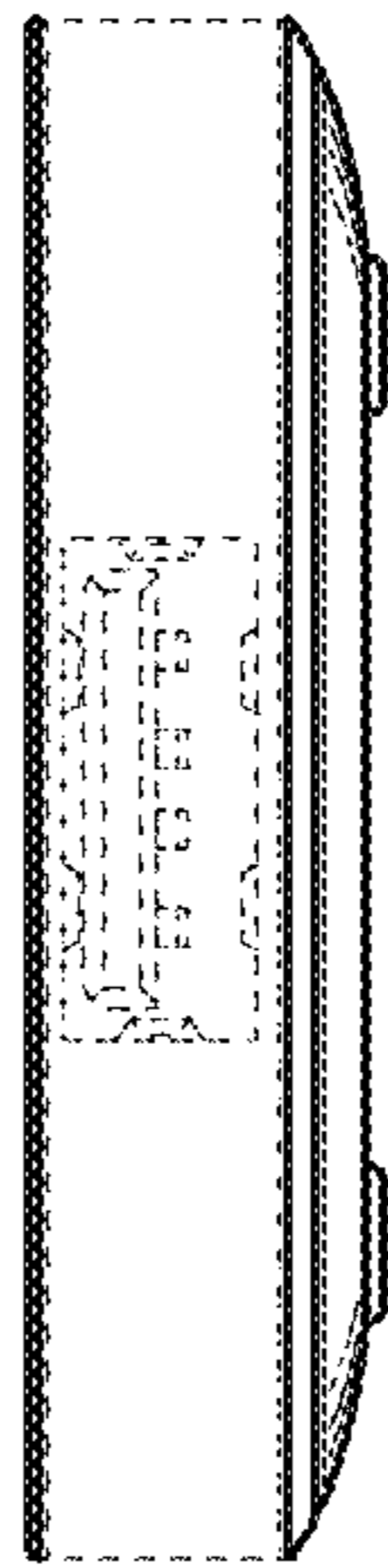

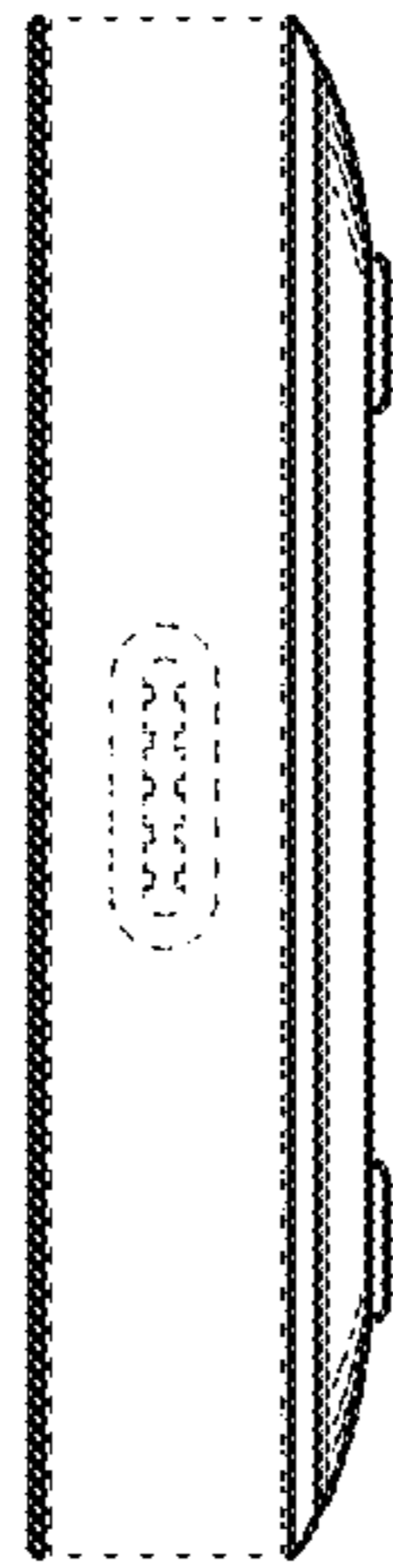

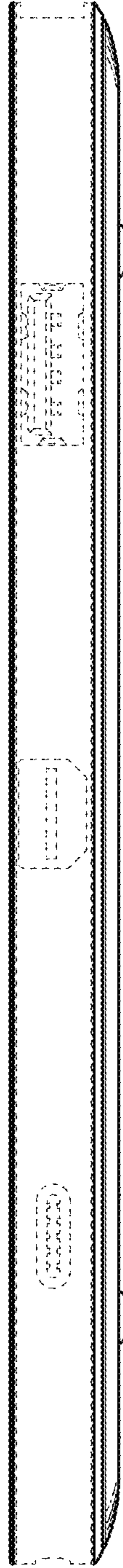

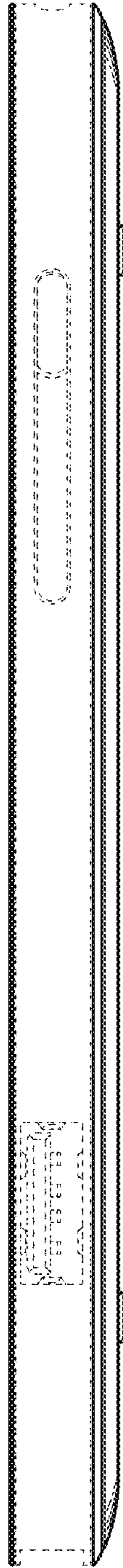

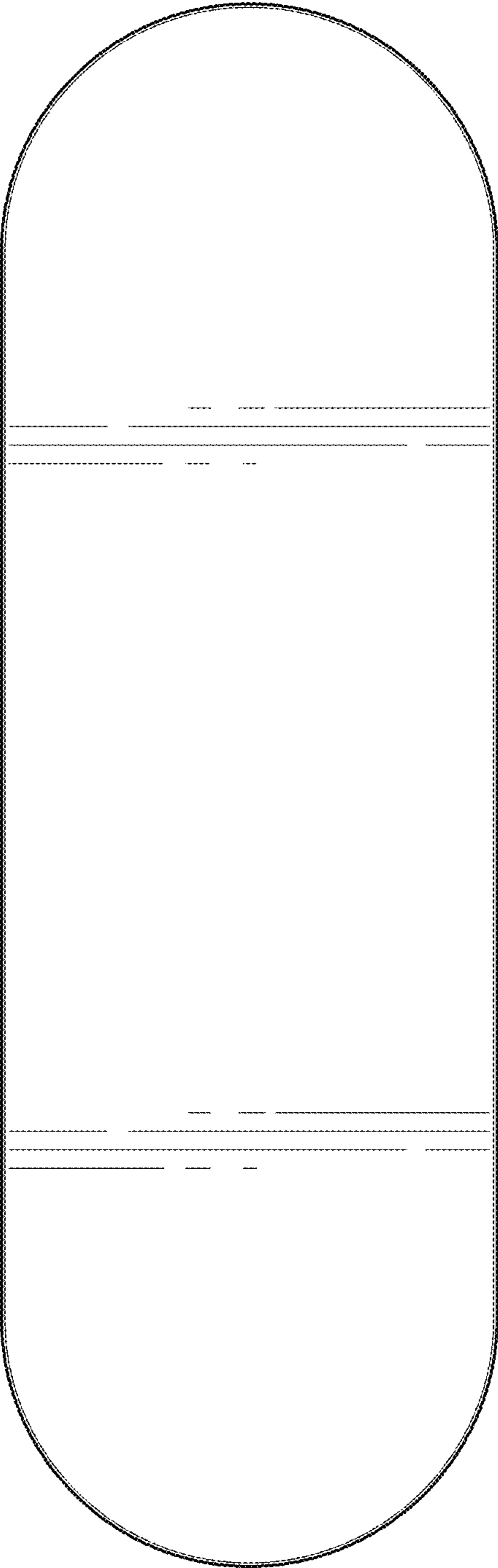

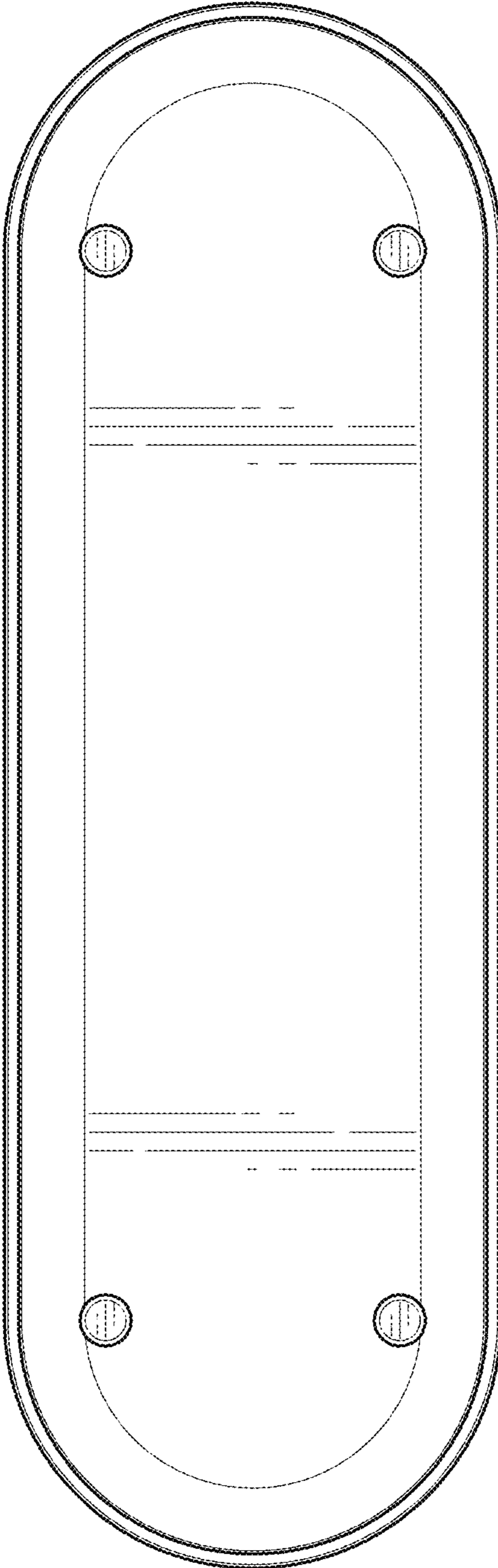
