The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

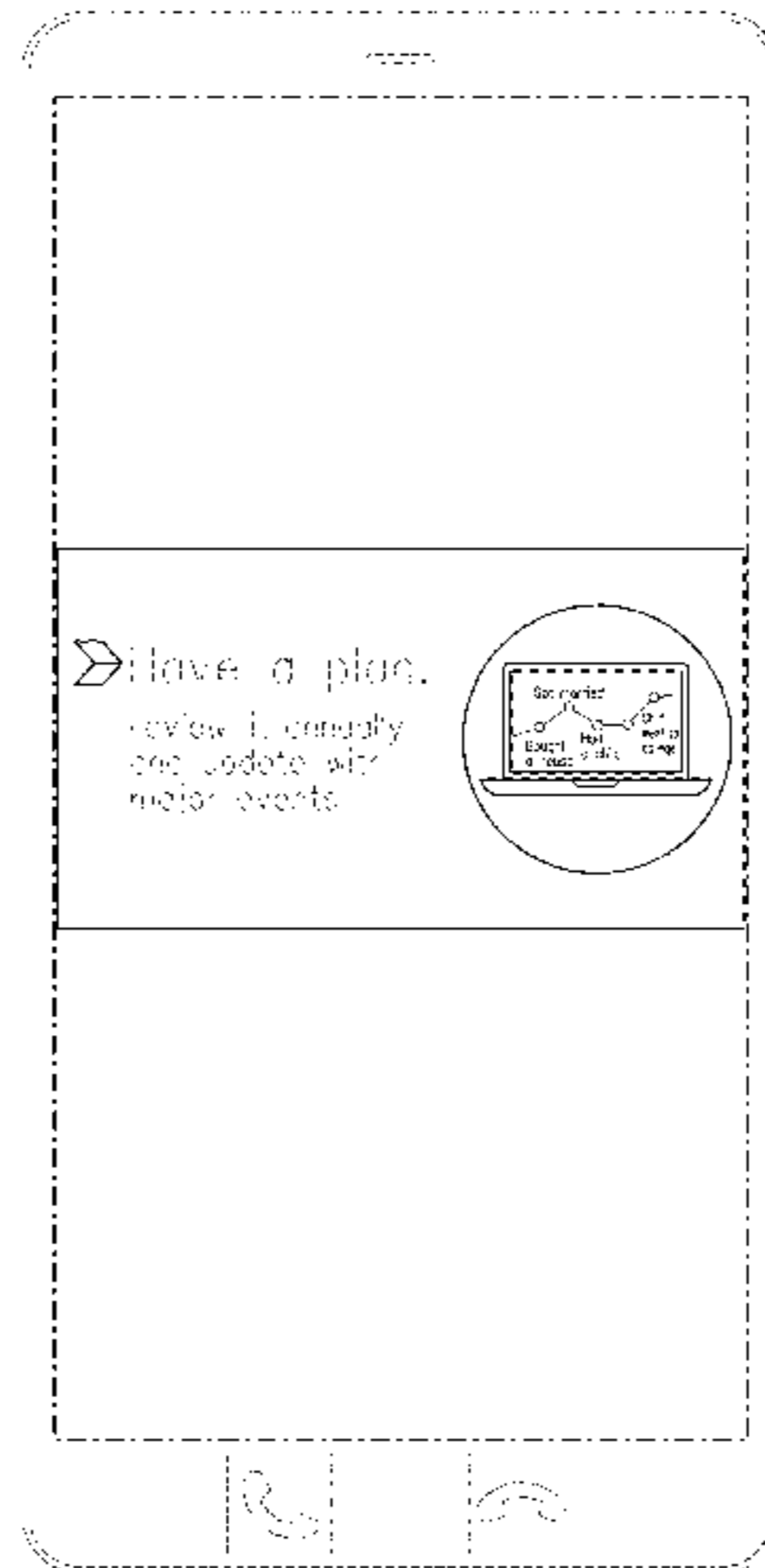
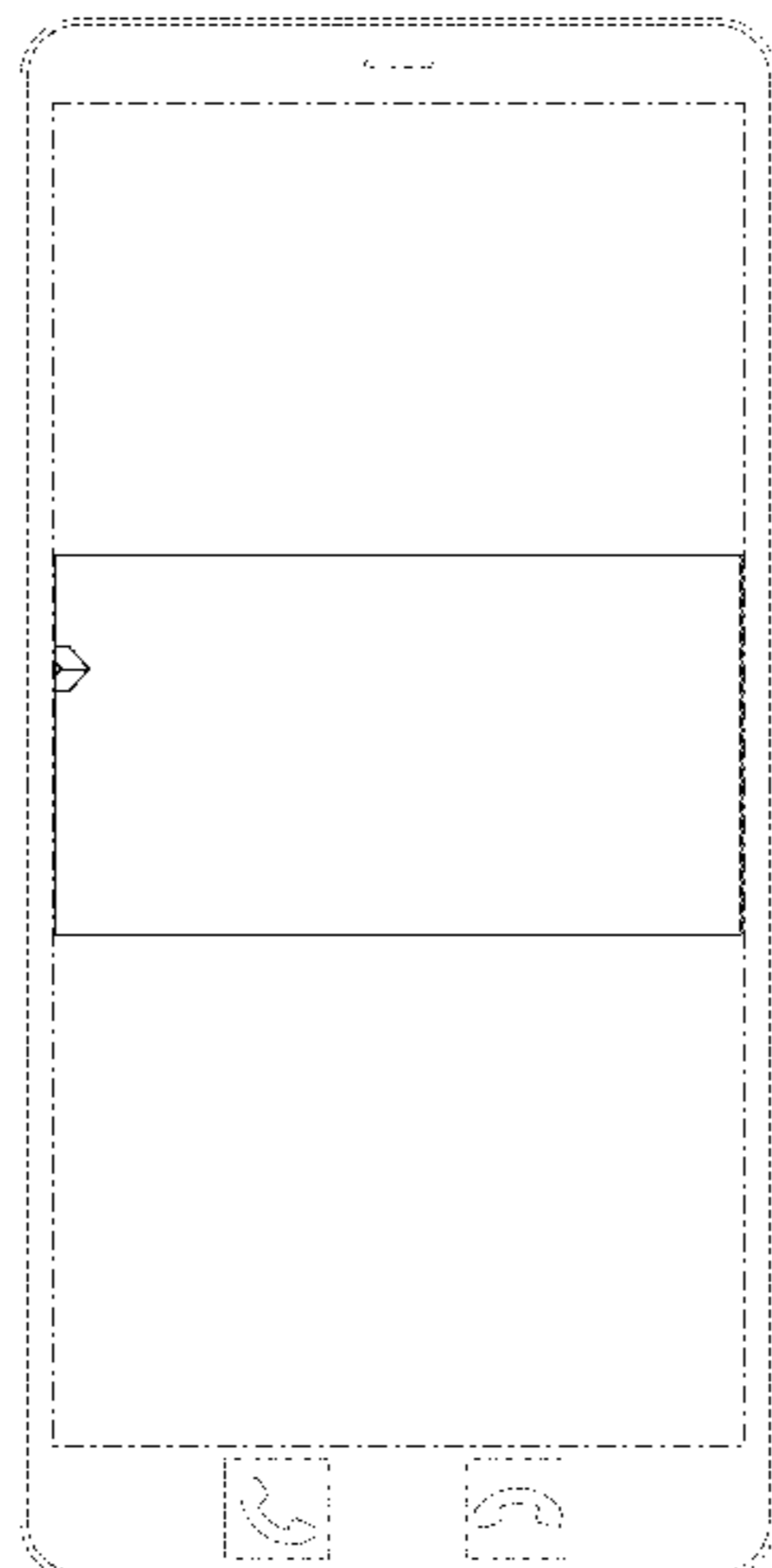
DESCRIPTION

FIG. 1 illustrates a front view of a display screen or portion thereof with animated graphical user interface (GUI) showing a first image in the sequence showing the new design; FIG. 2 illustrates a second image thereof; FIG. 3 illustrates a third image thereof; FIG. 4 illustrates a fourth image thereof; FIG. 5 illustrates a fifth image thereof; FIG. 6 illustrates a sixth image thereof; FIG. 7 illustrates a seventh image thereof; FIG. 8 illustrates an eighth image thereof; FIG. 9 illustrated a ninth image thereof; and, FIG. 10 illustrates a tenth image thereof.

The rectangular dot-dash broken-line perimeter illustrates a display screen. The dashed broken lines outside this perimeter illustrate portions of an electronic device. The dashed broken lines within the perimeter illustrate portions of a graphical user interface. The broken lines form no part of the claimed design.

The appearance of the animated images sequentially transitions between the images shown in FIG. 1-10. The process or period in which one image transitions to another forms no part of the claimed ornamental design.

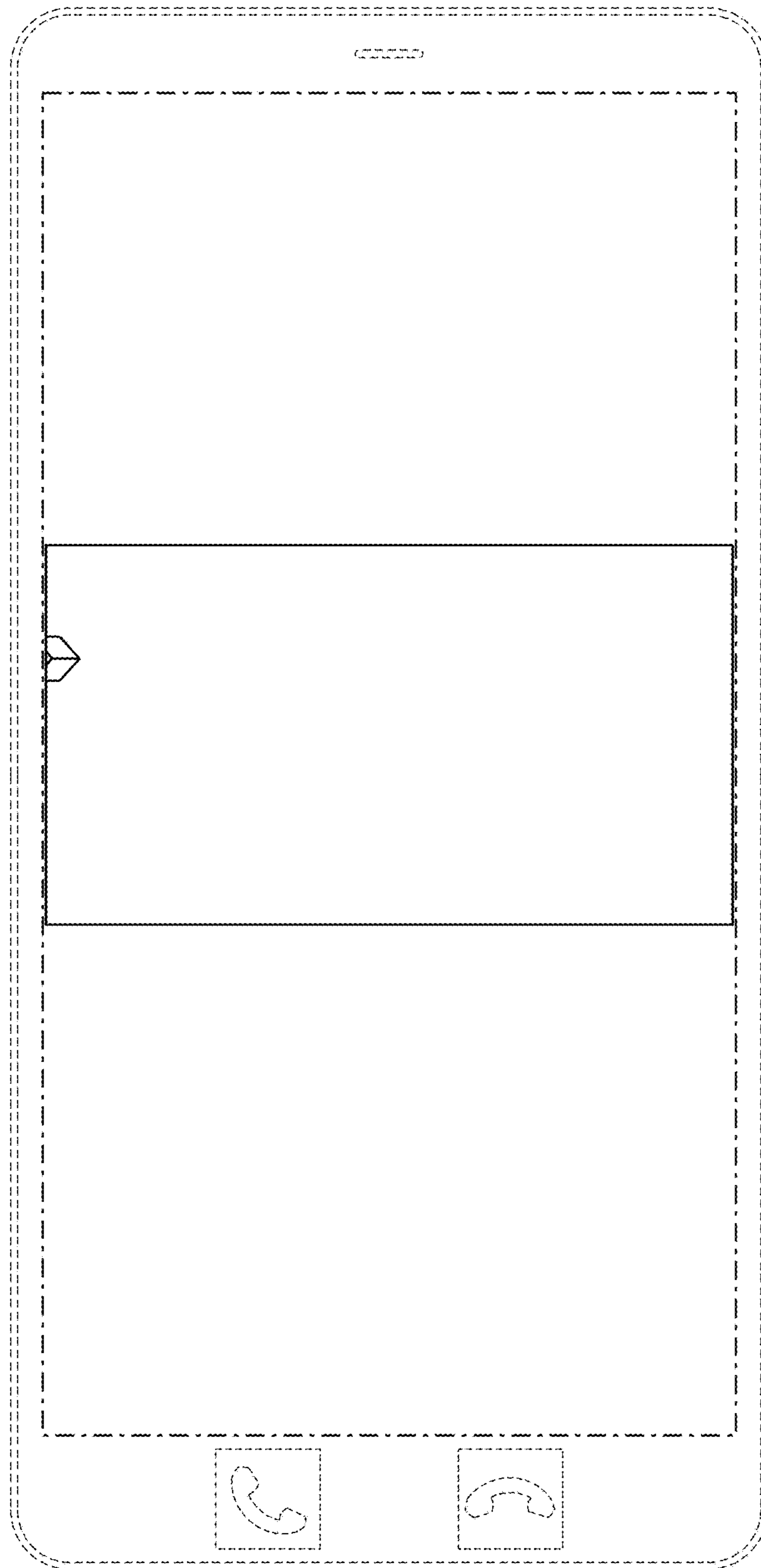

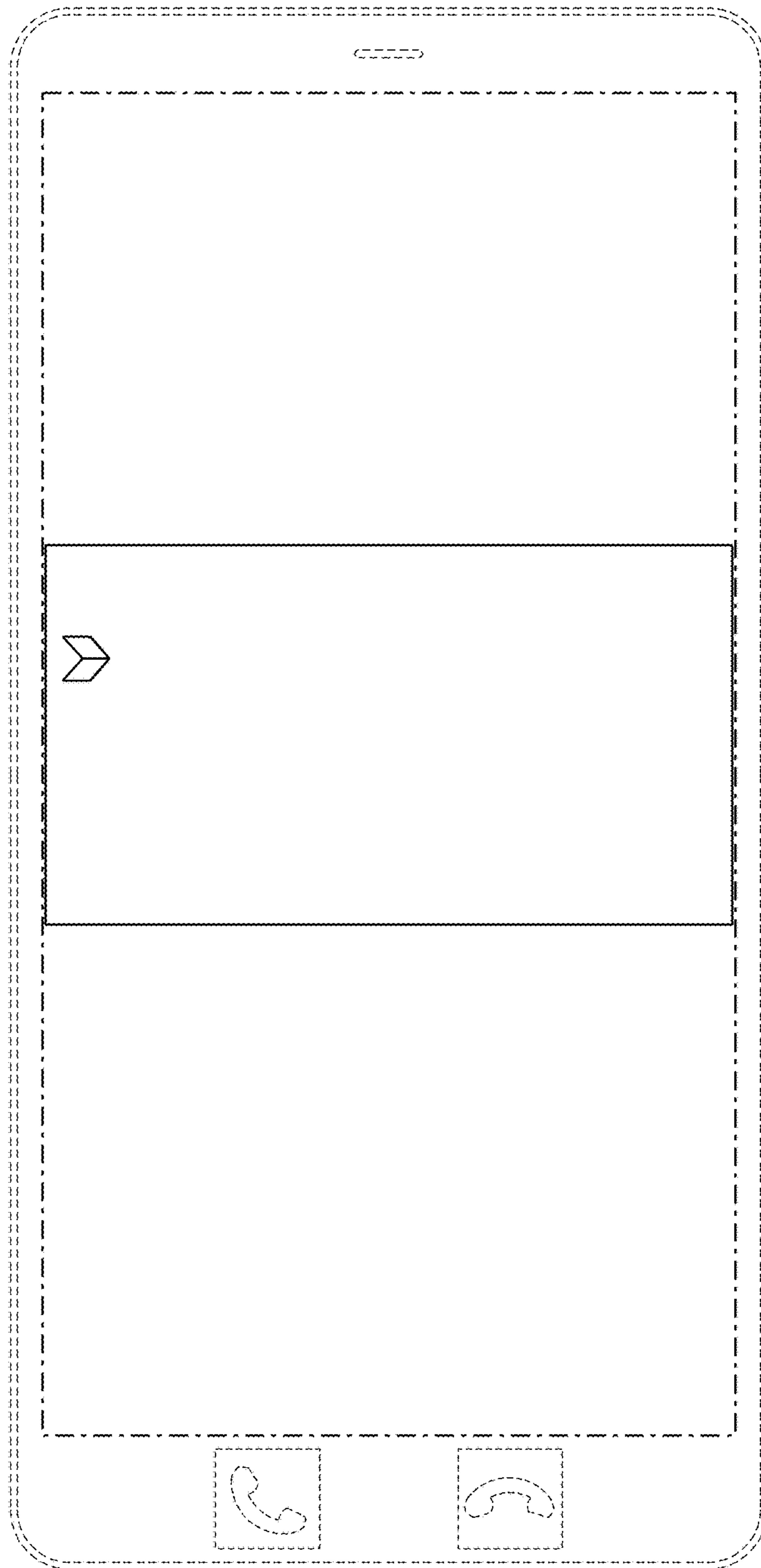

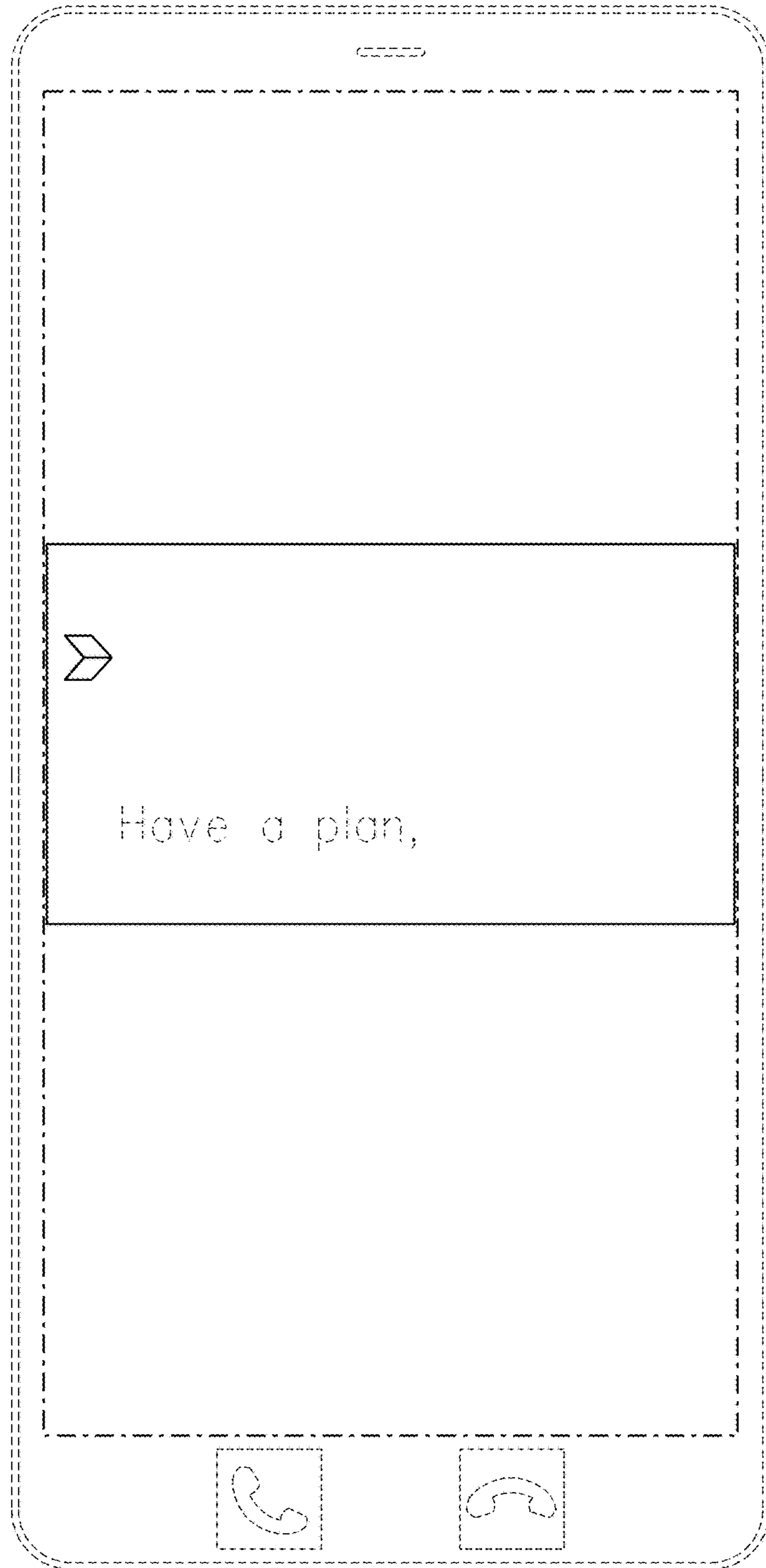

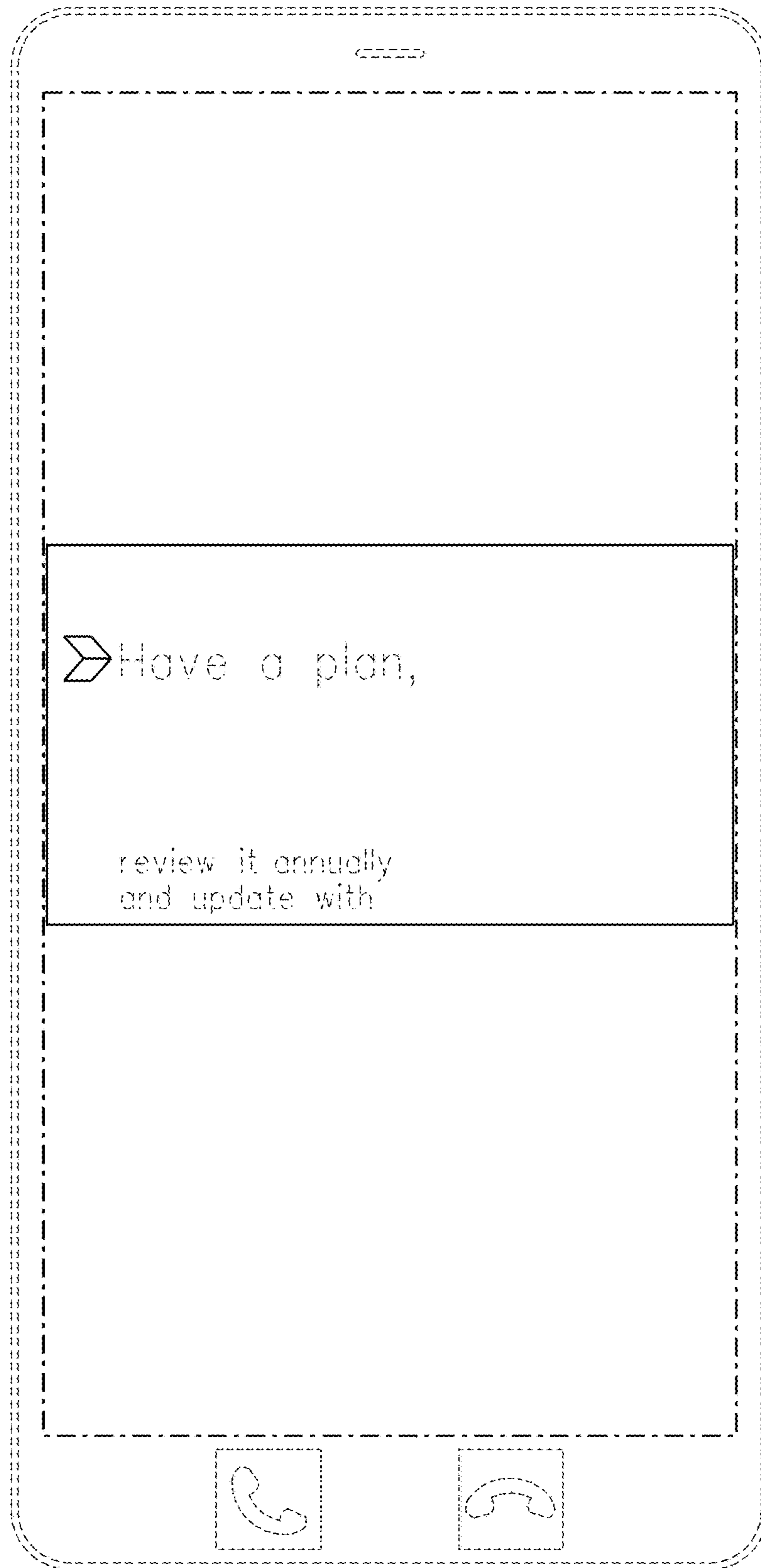

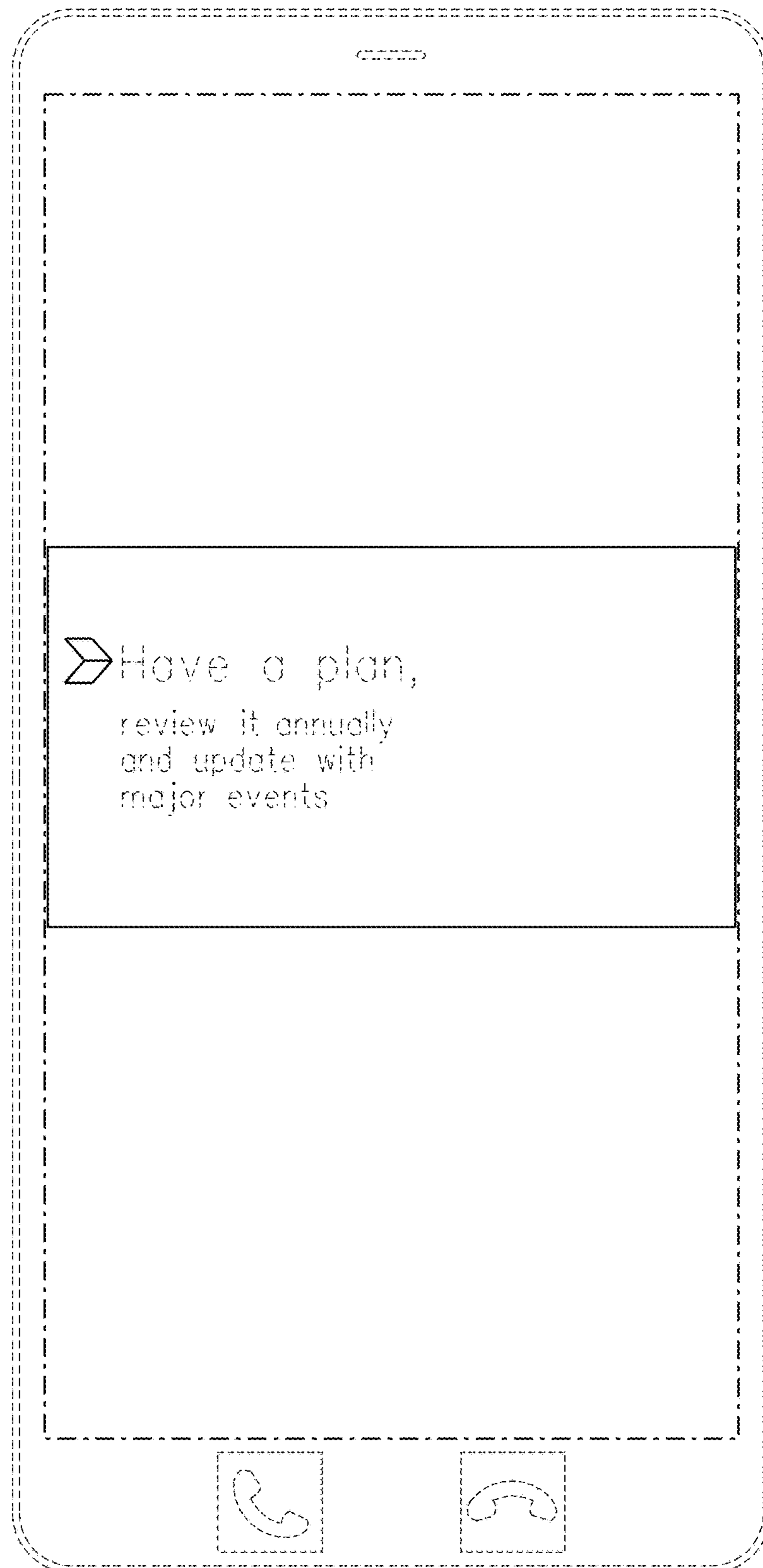

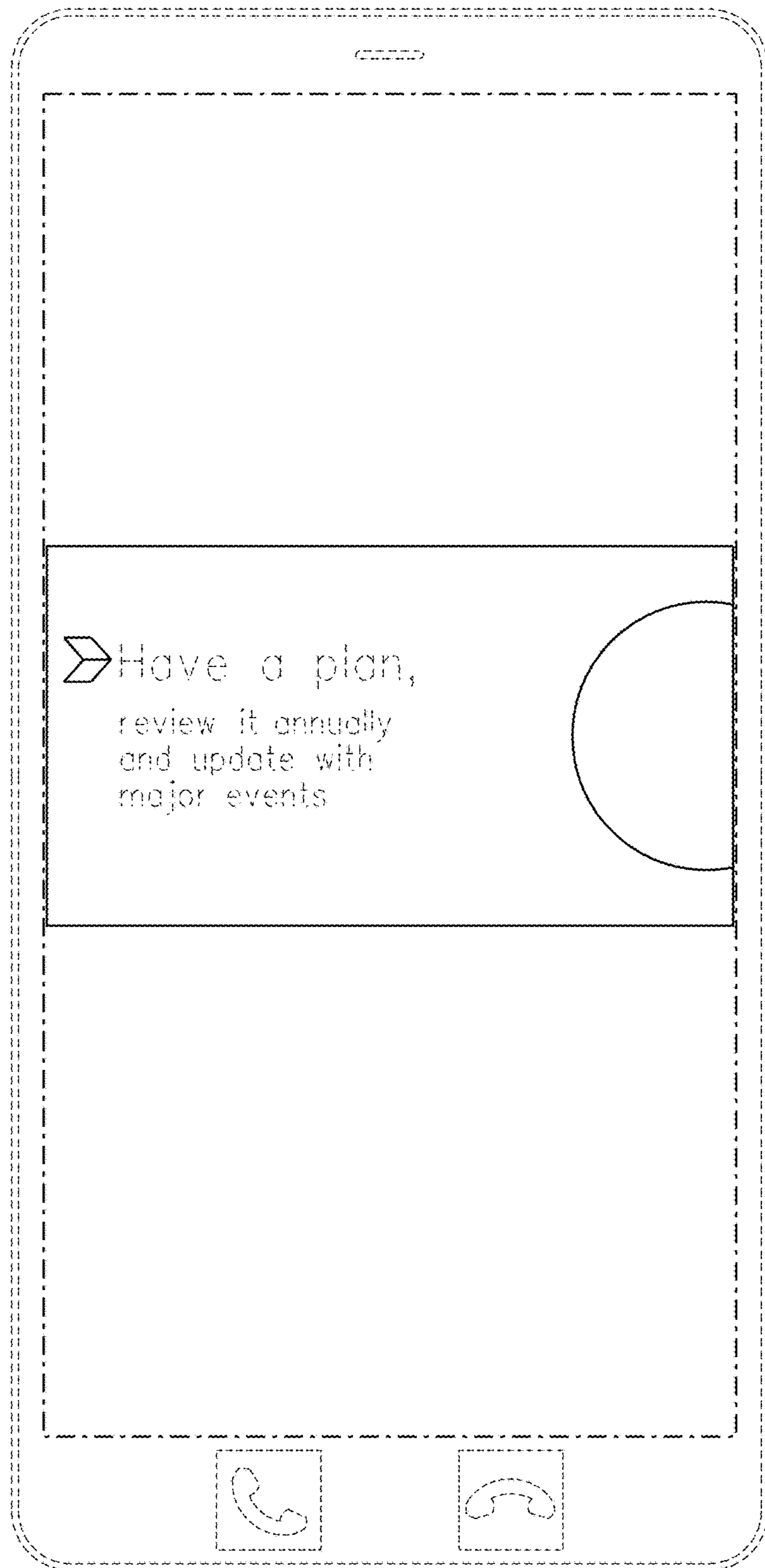

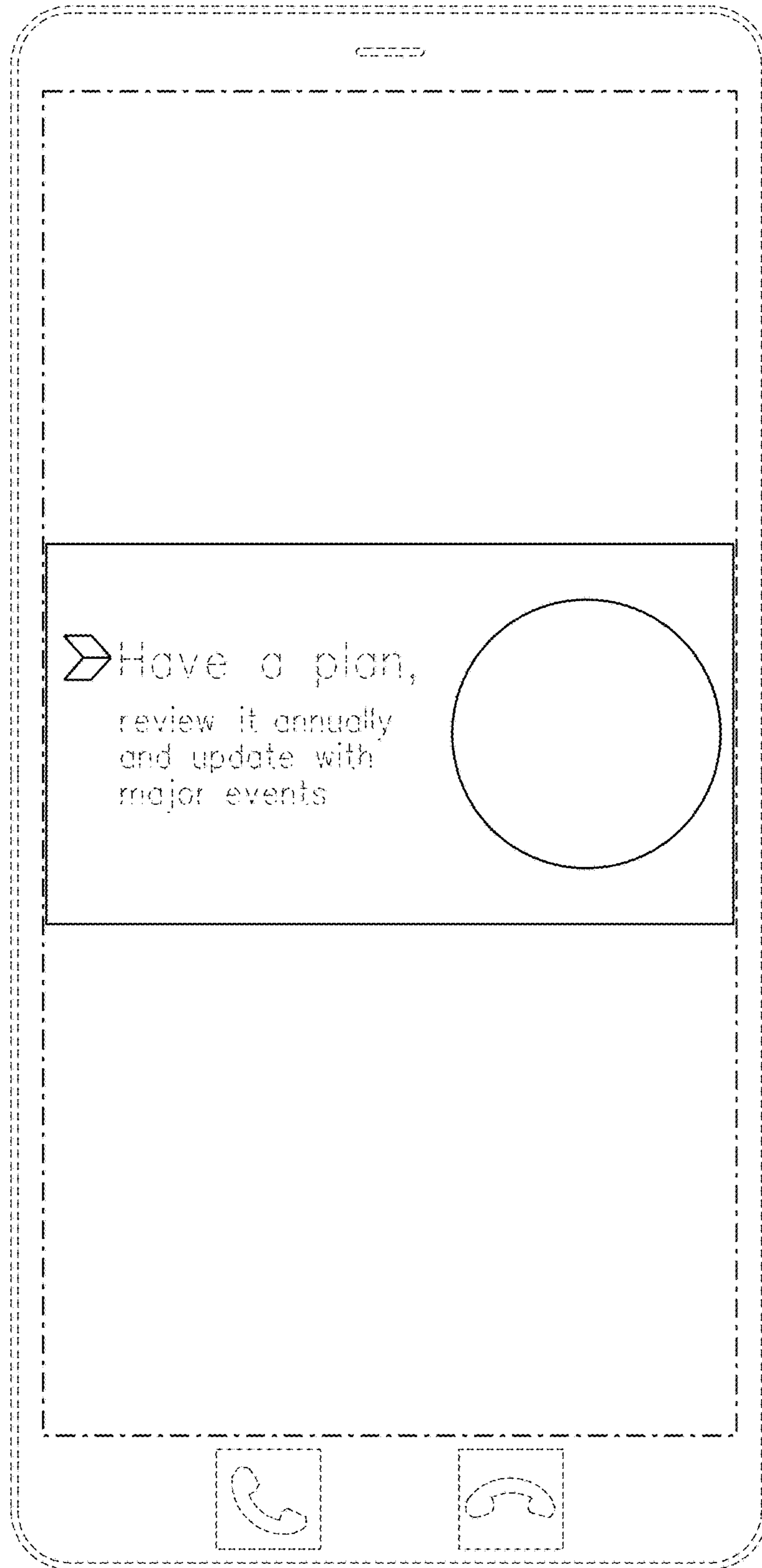

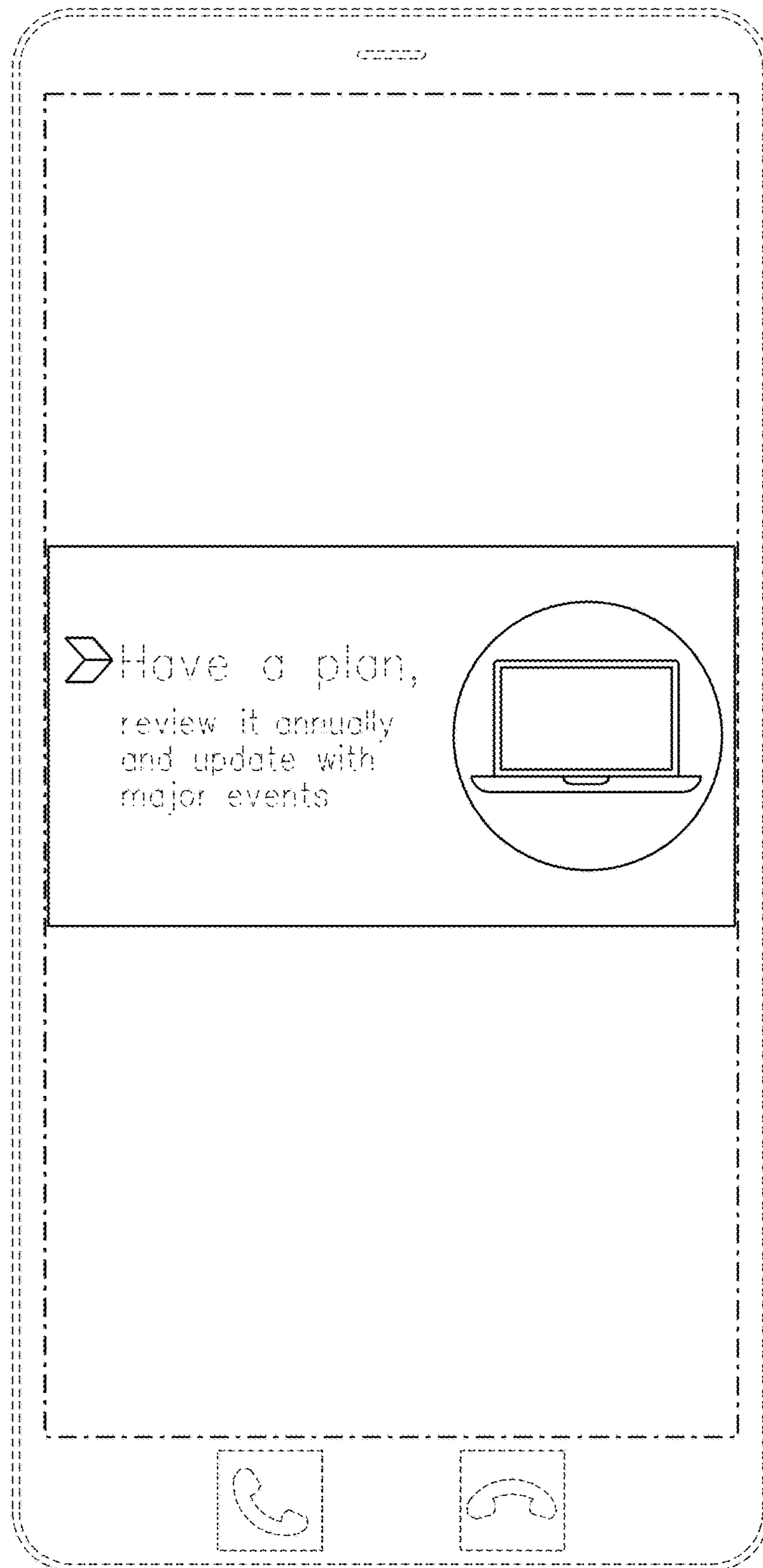

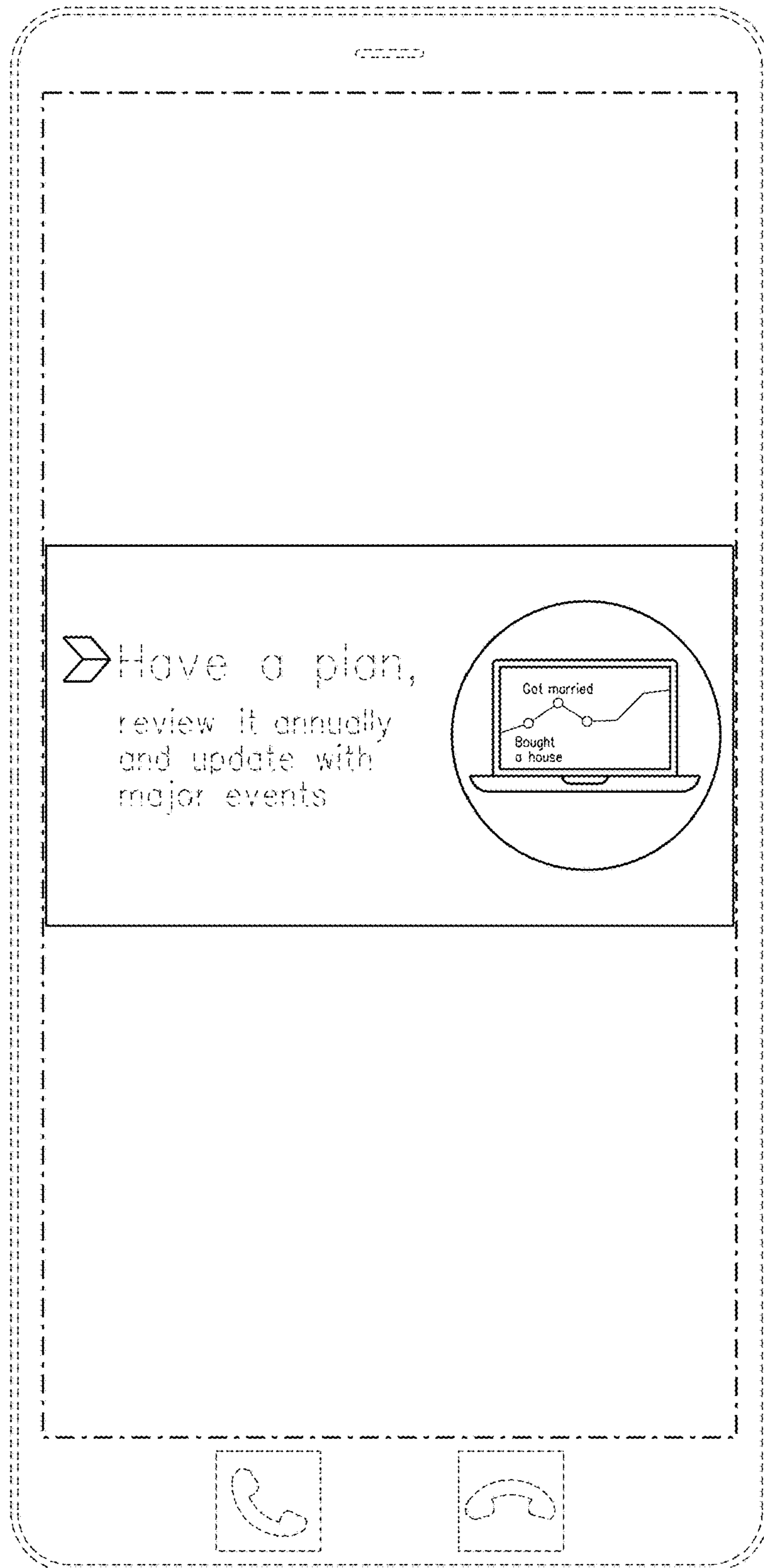

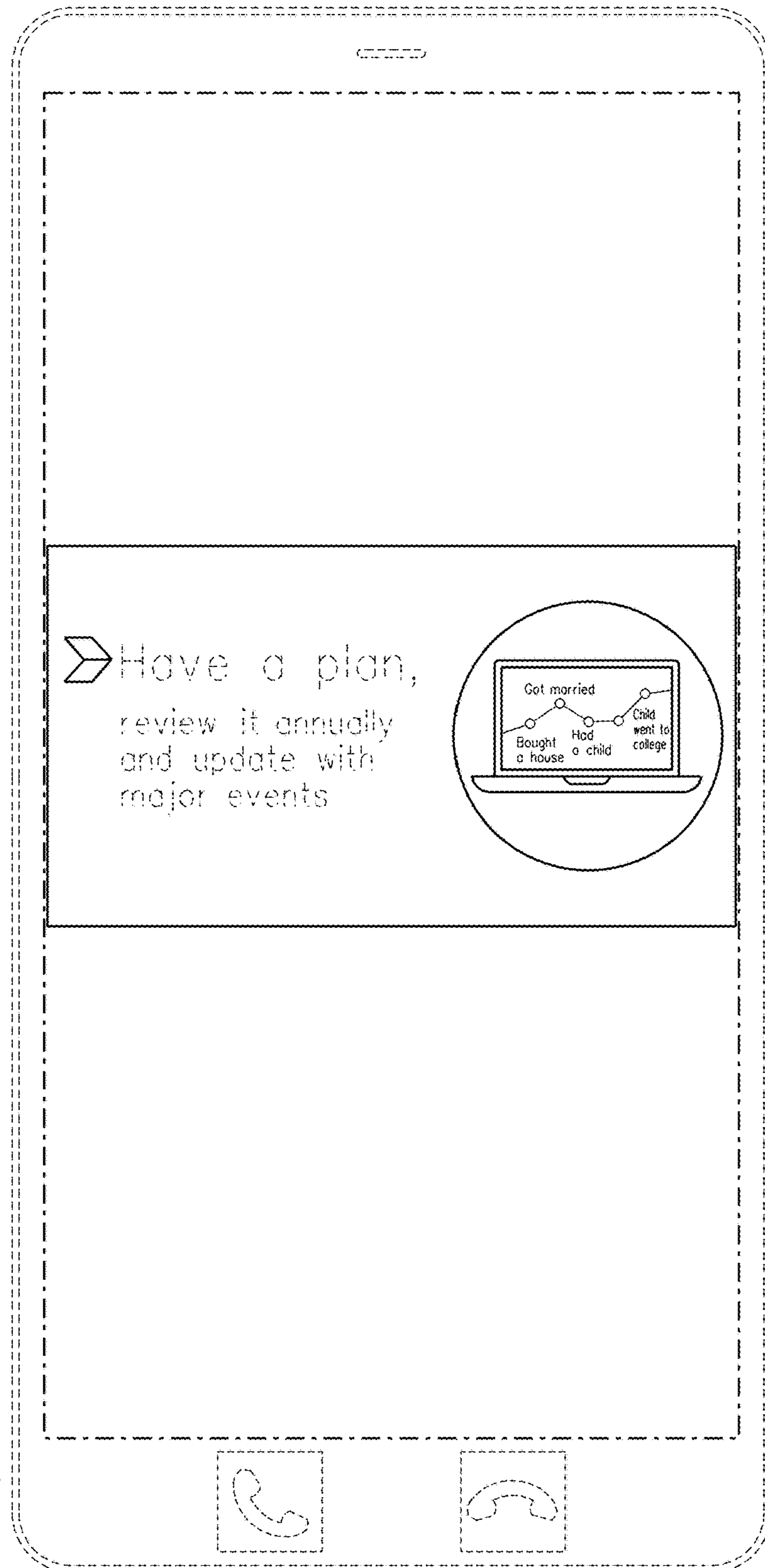
