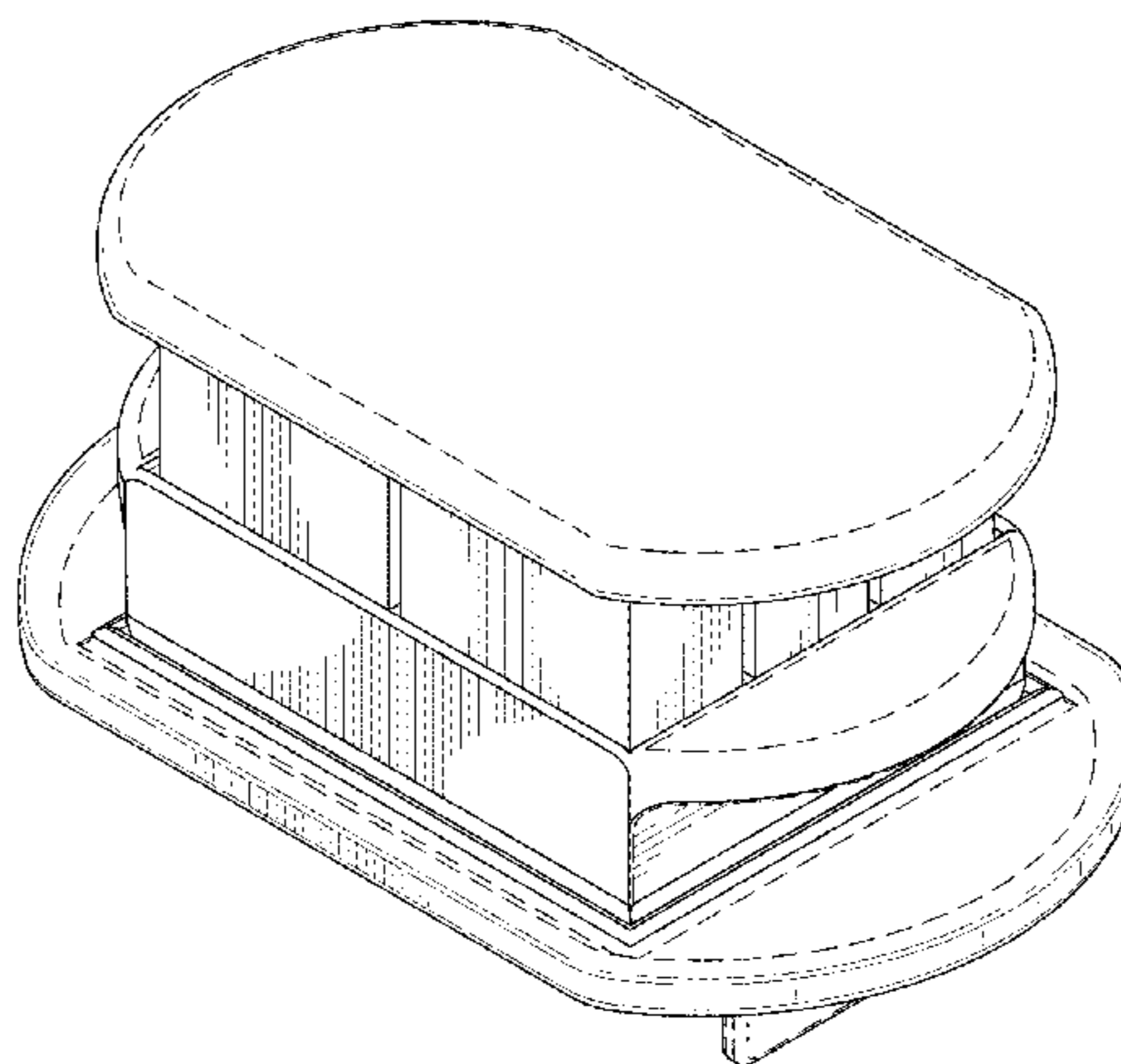
(57) **CLAIM**

The ornamental design for a brick maker, as shown and described.

DESCRIPTION

FIG. 1 is a top-front perspective view of a brick maker in an assembled position showing the new design; FIG. 2 is a side elevation view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a top-front perspective view of the brick maker, in an exploded view showing the base, the cutter and the plunger; FIG. 7 is a top-front perspective view of the base of the brick maker; FIG. 8 is a side elevation view thereof; FIG. 9 is a front elevation view thereof; FIG. 10 is a top plan view thereof; FIG. 11 is a bottom plan view thereof; FIG. 12 is a top-front perspective view of the cutter of the brick maker; FIG. 13 is a side elevation view thereof; FIG. 14 is a front elevation view thereof; FIG. 15 is a top plan view thereof; FIG. 16 is a bottom plan view thereof; FIG. 17 is a top front perspective view of the plunger of the brick maker; FIG. 18 is a bottom-front perspective view thereof; FIG. 19 is a side elevation view thereof; FIG. 20 is a front elevation view thereof; FIG. 21 is a top plan view thereof; and, FIG. 22 is a bottom plan view thereof. In FIGS. 1-22, broken lines indicate optional features of the brick maker that form no part of the claimed design.

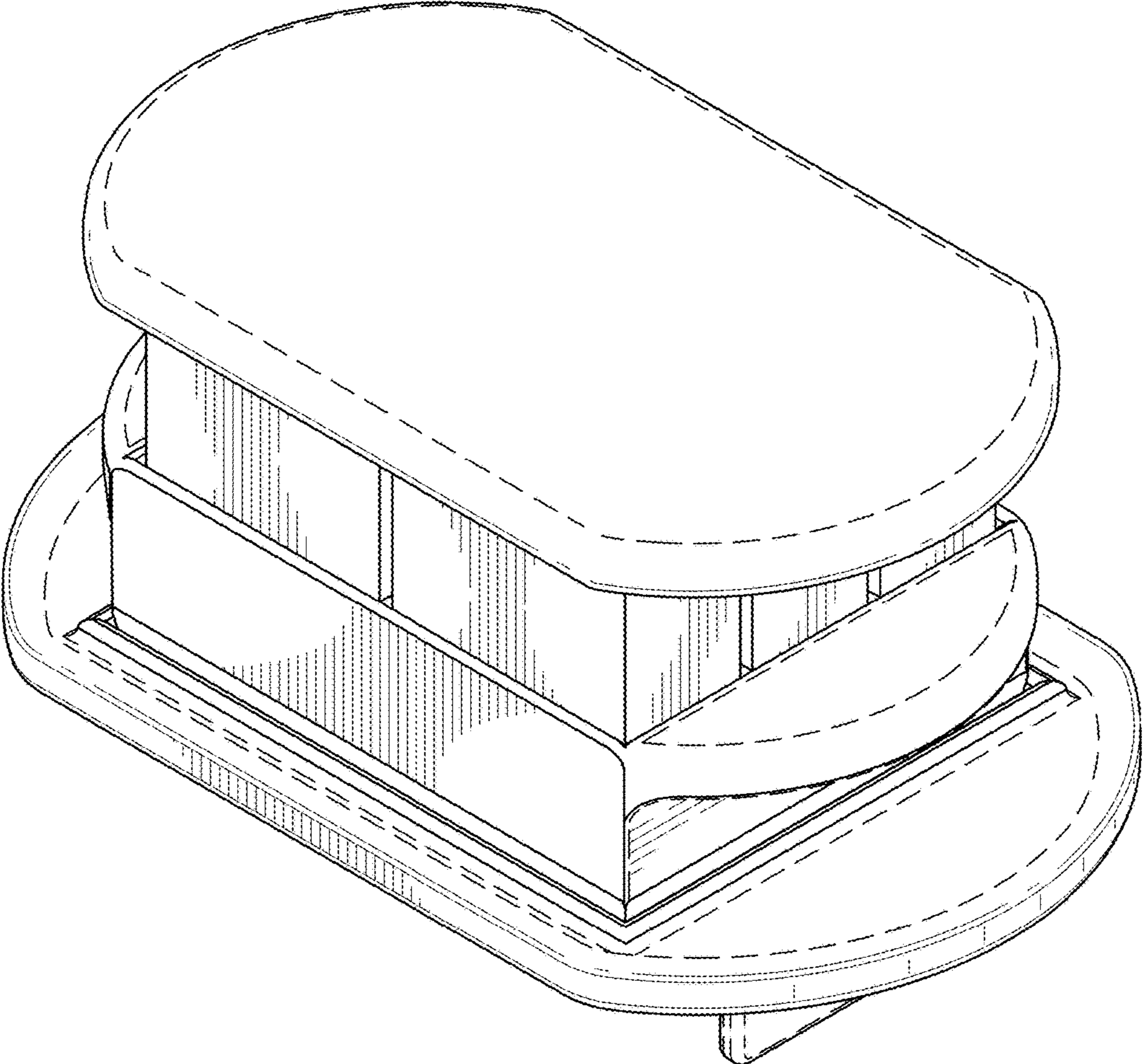

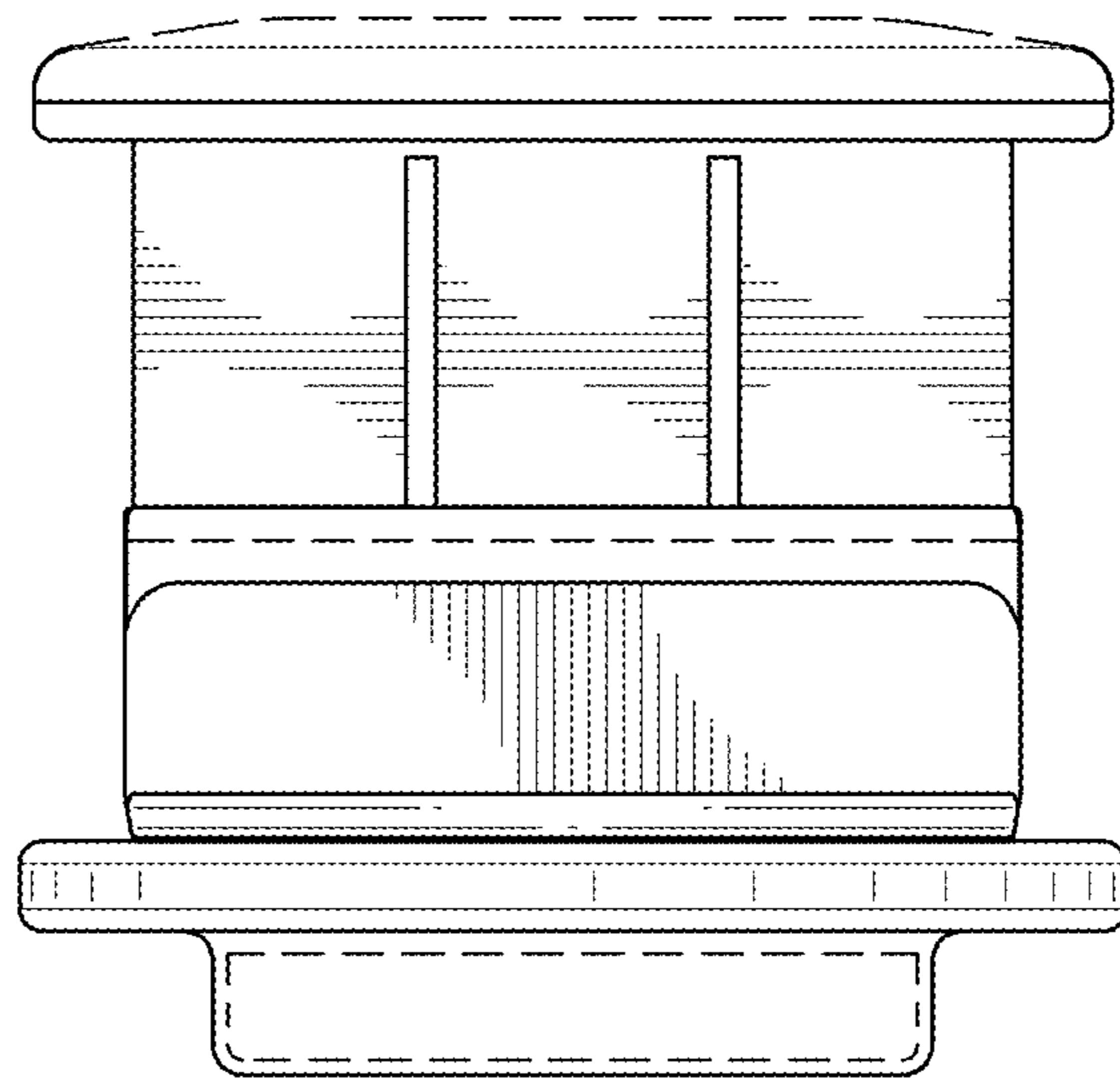

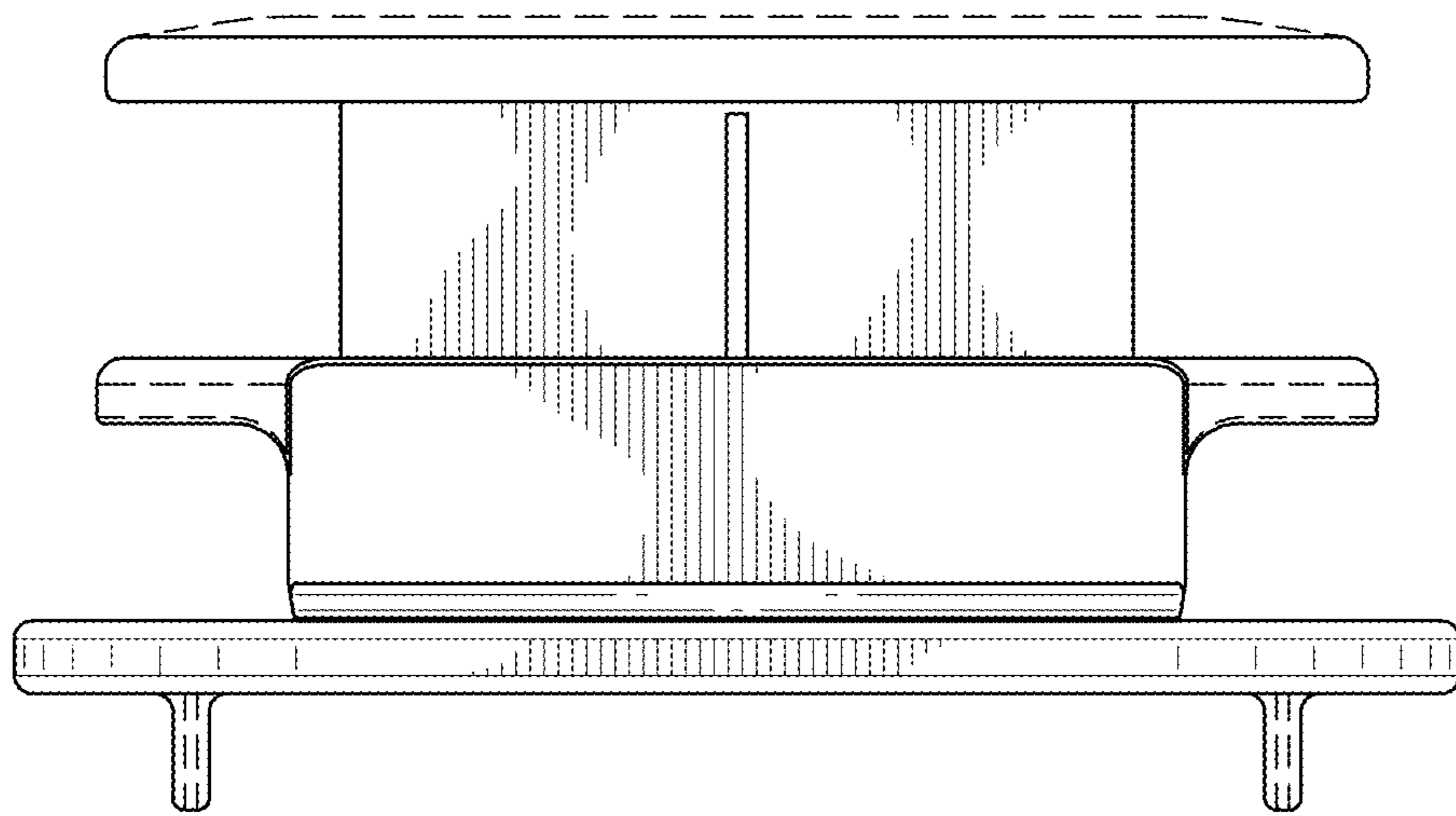

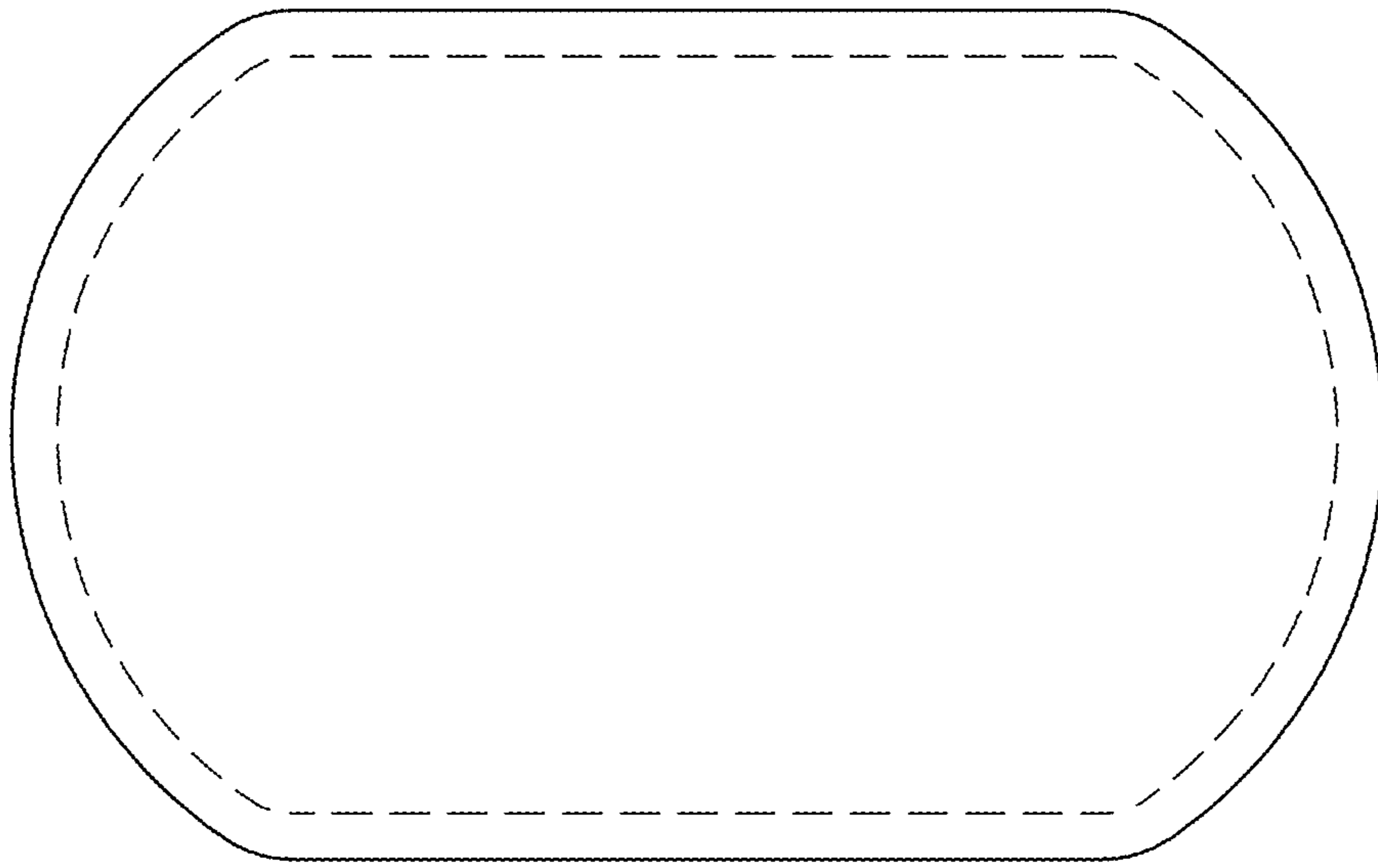

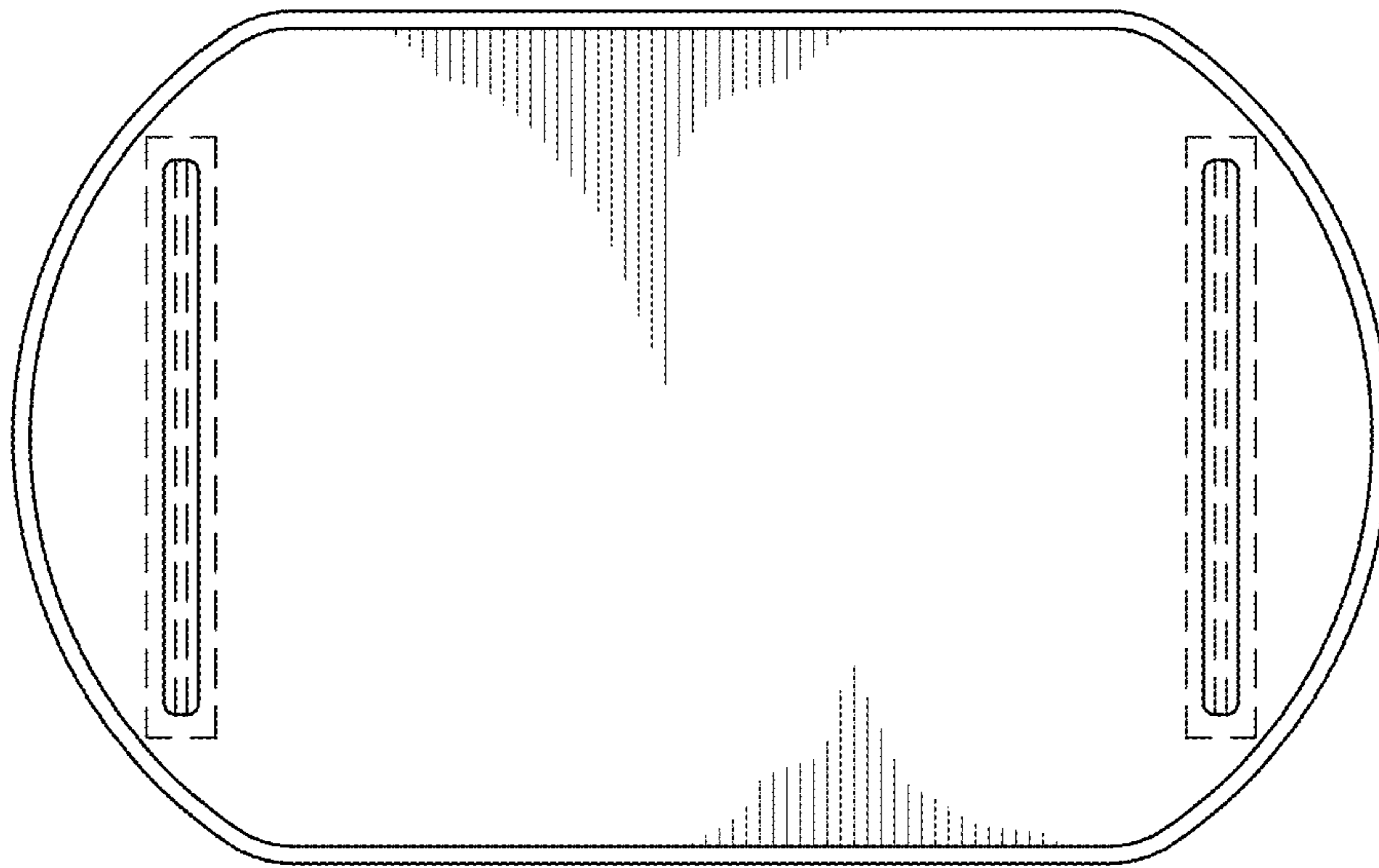

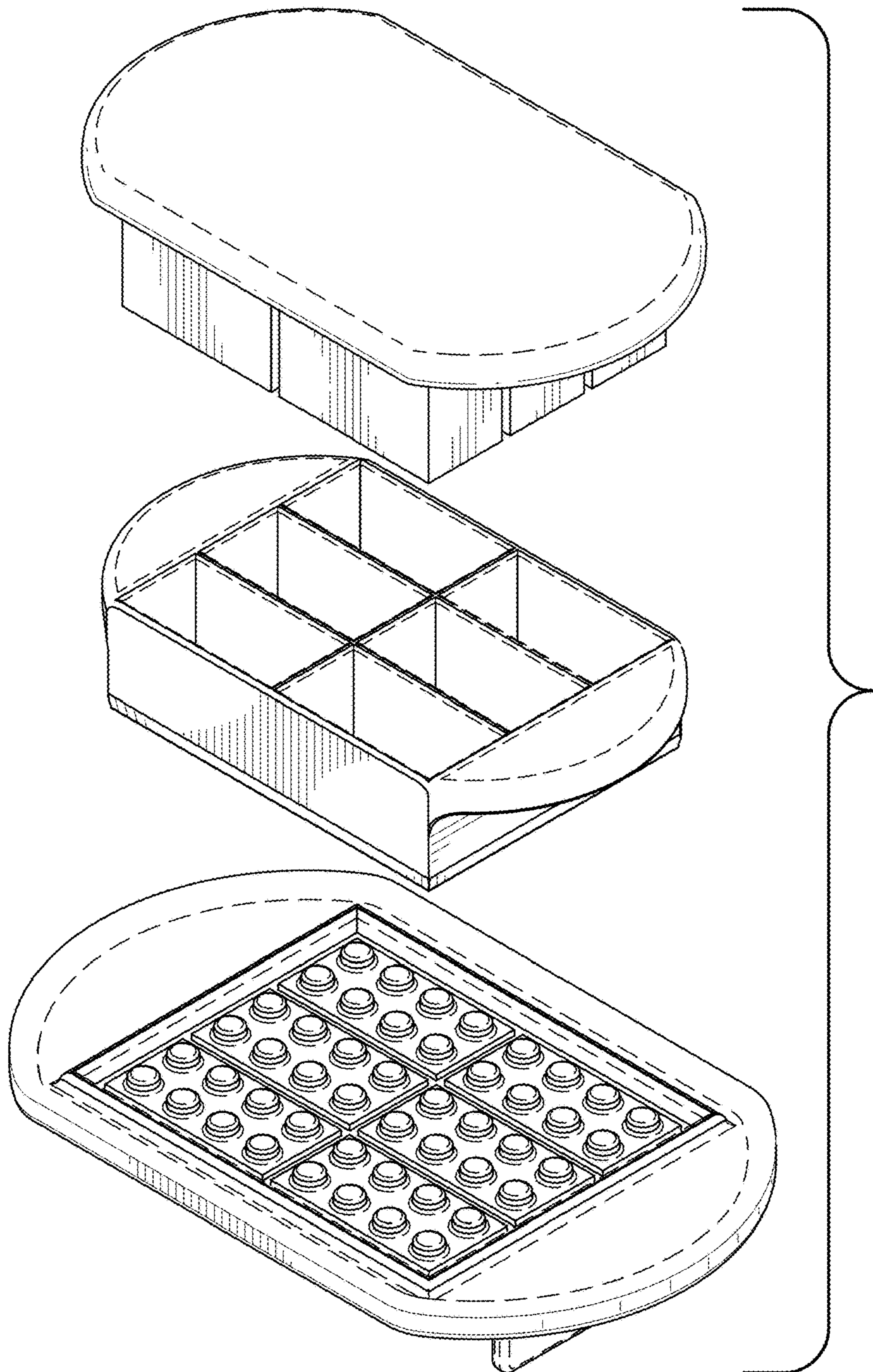

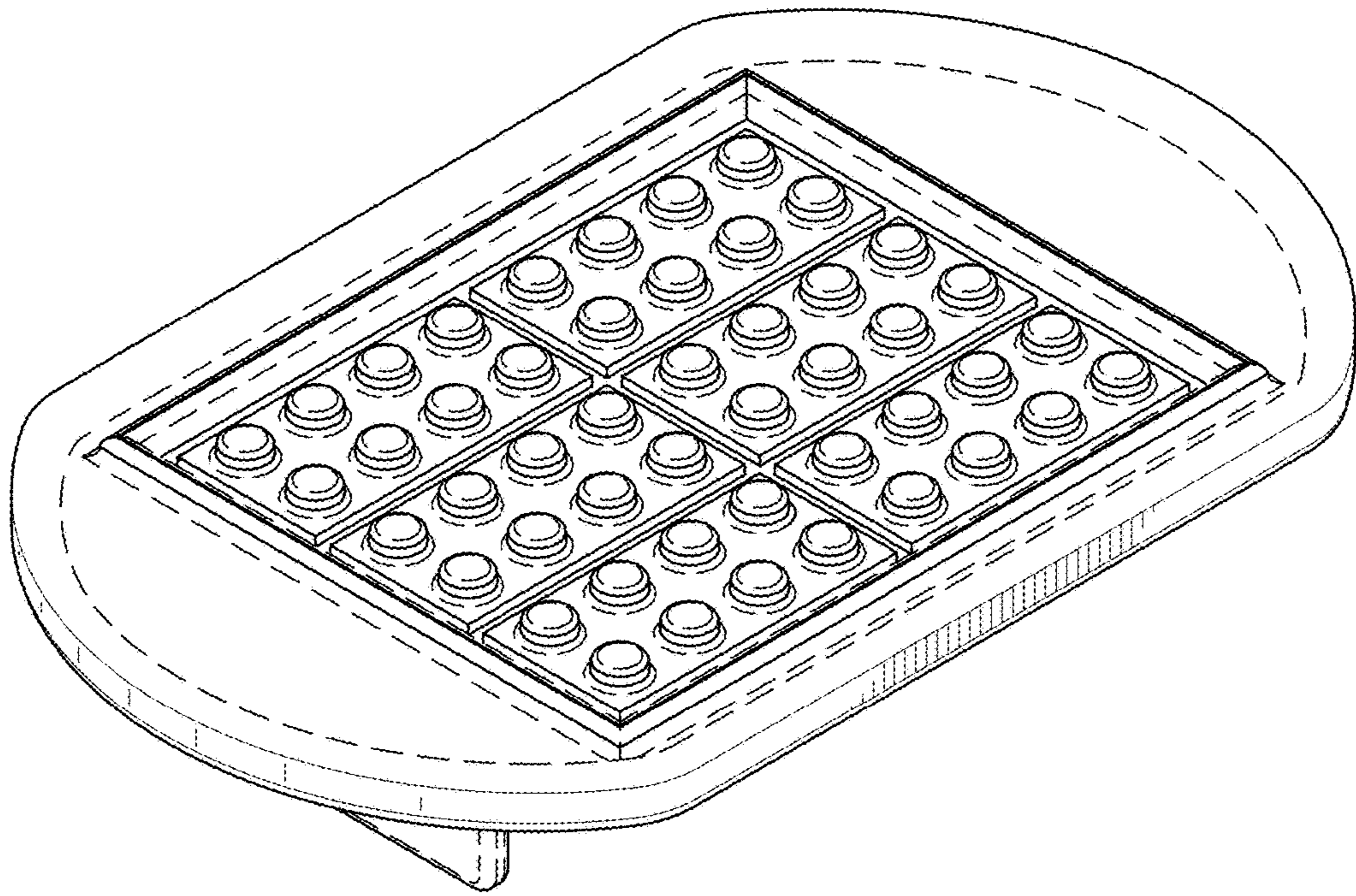

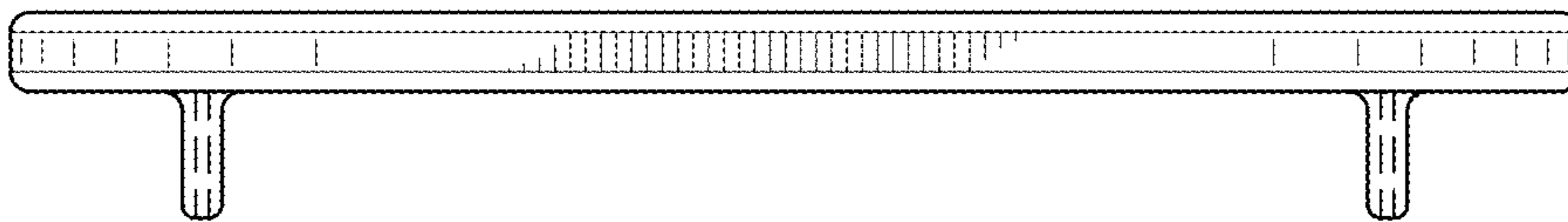

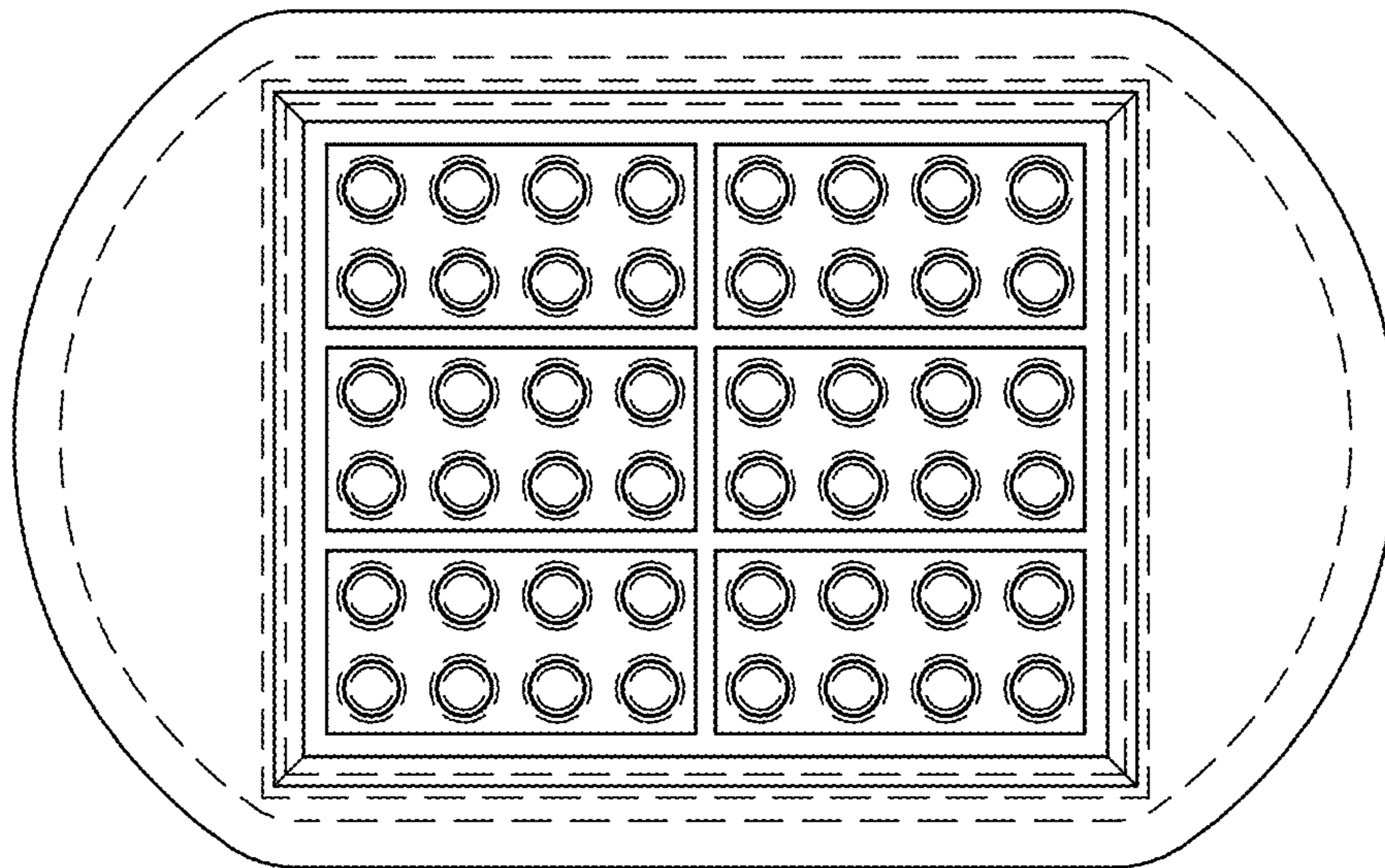

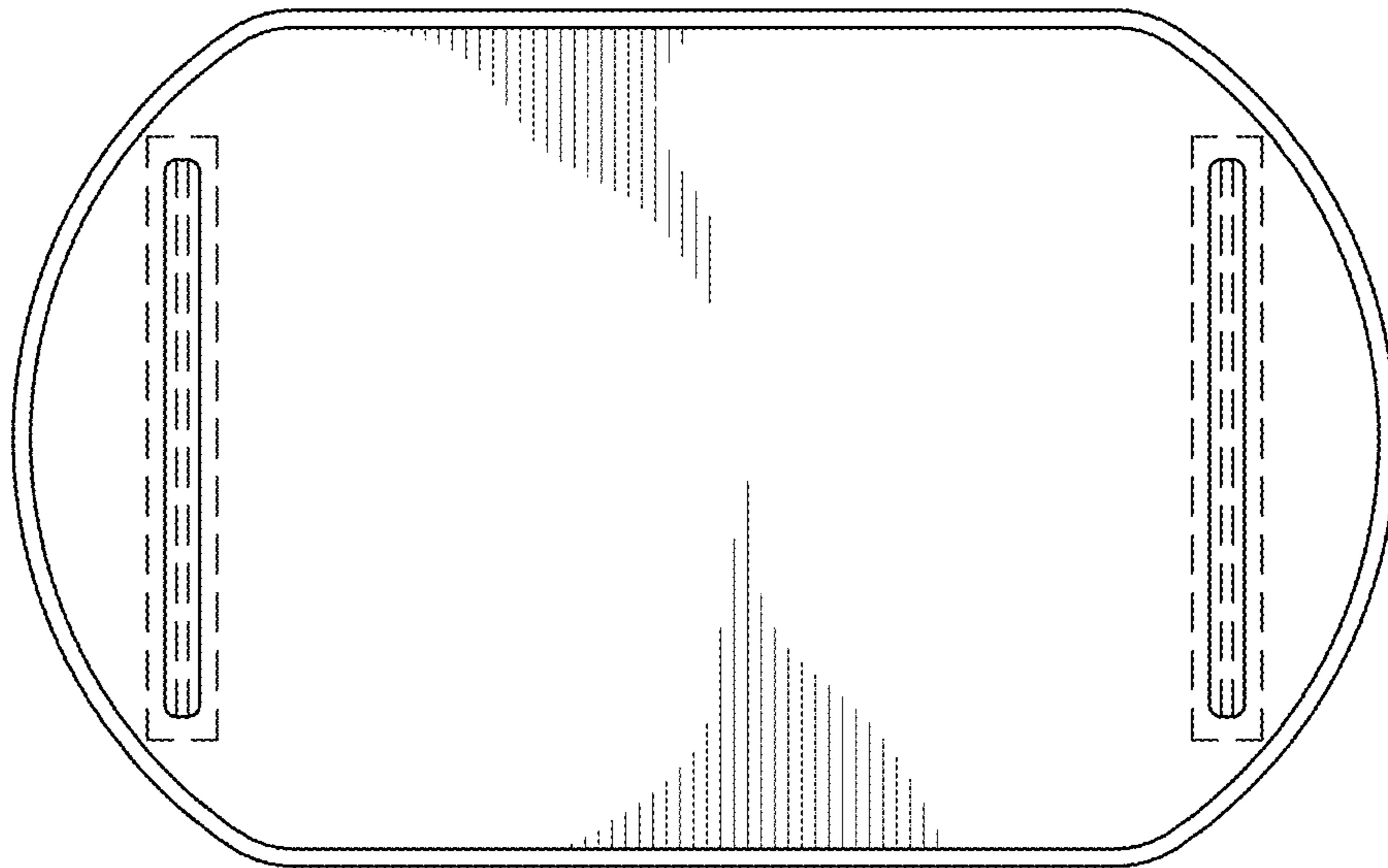

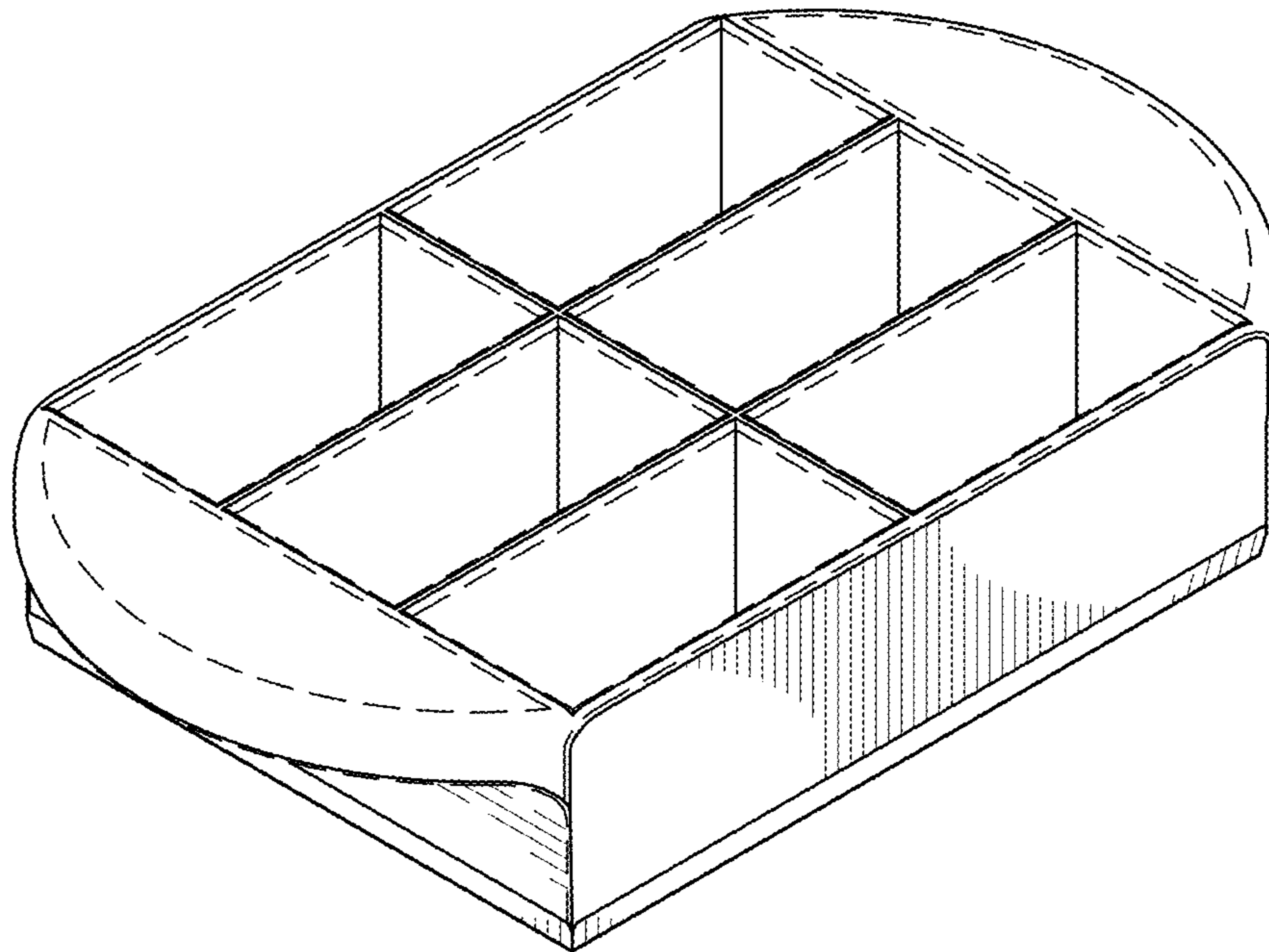

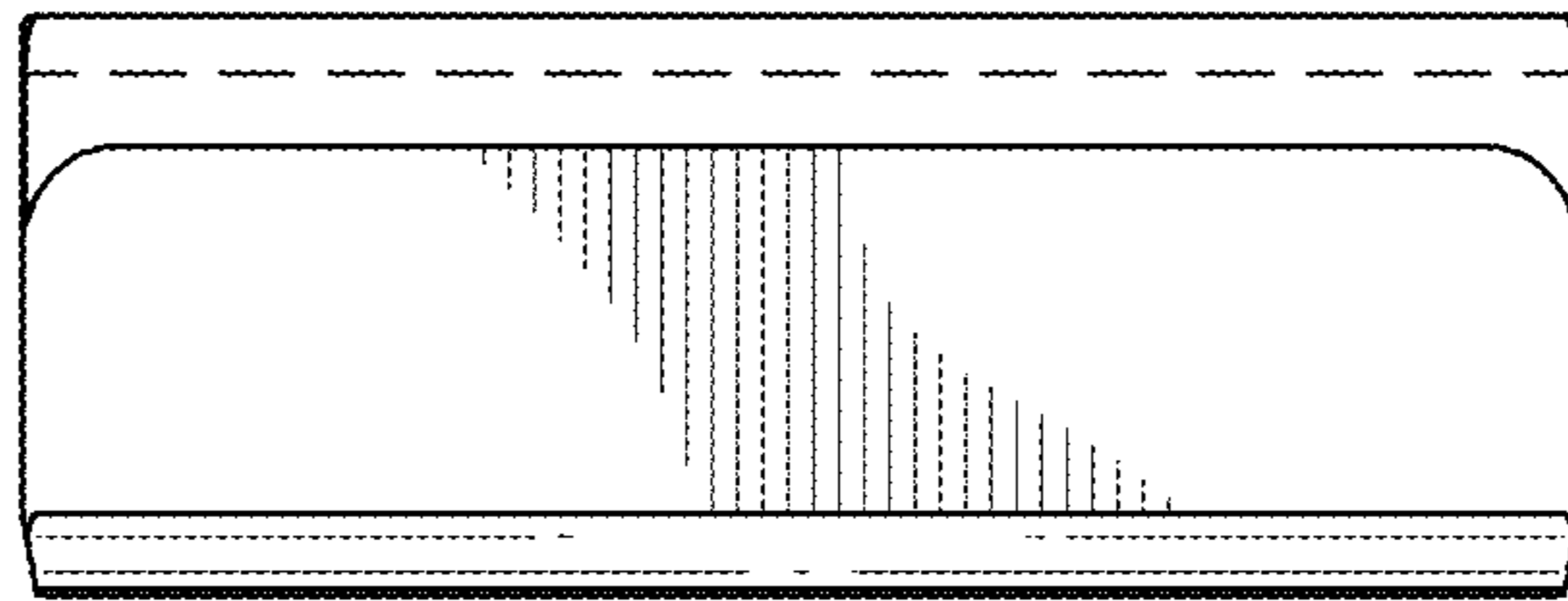

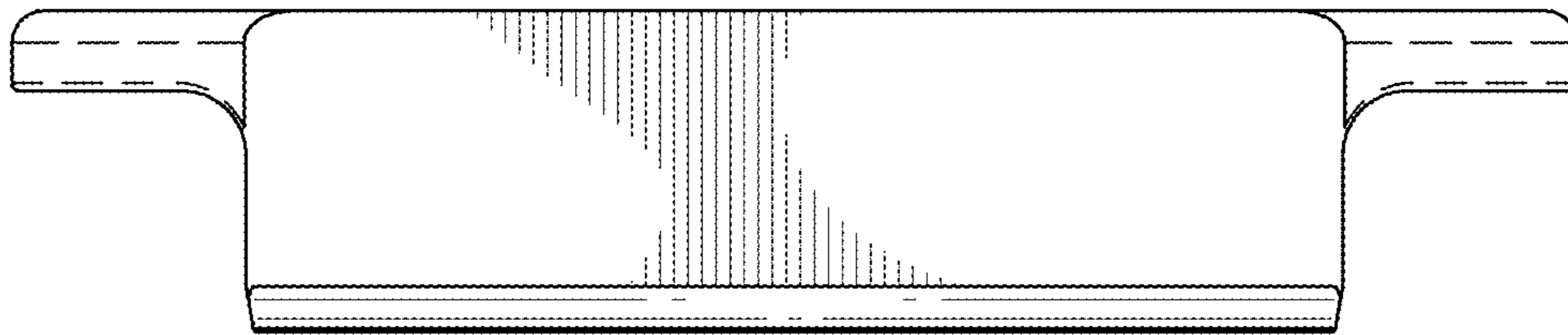

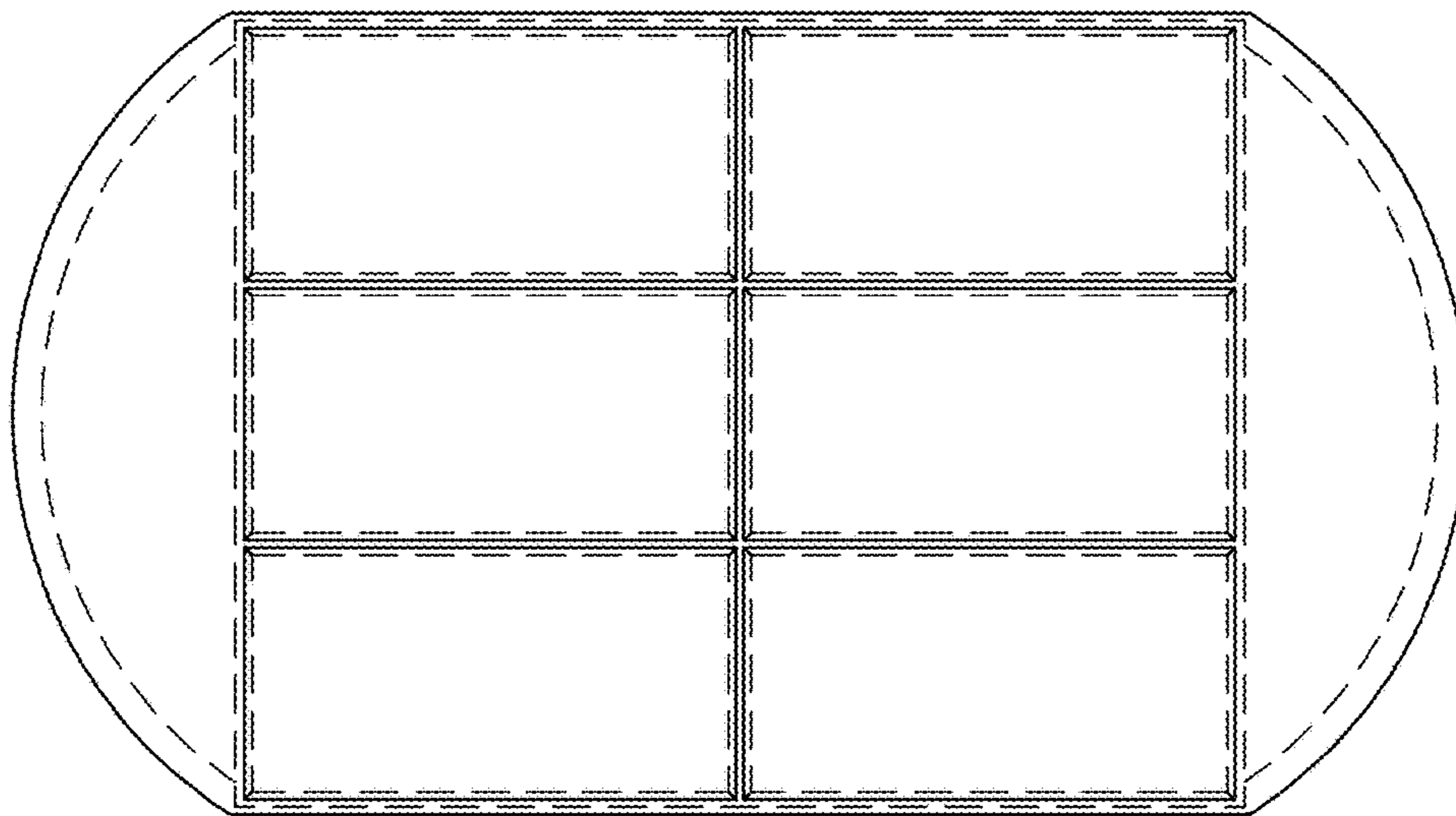

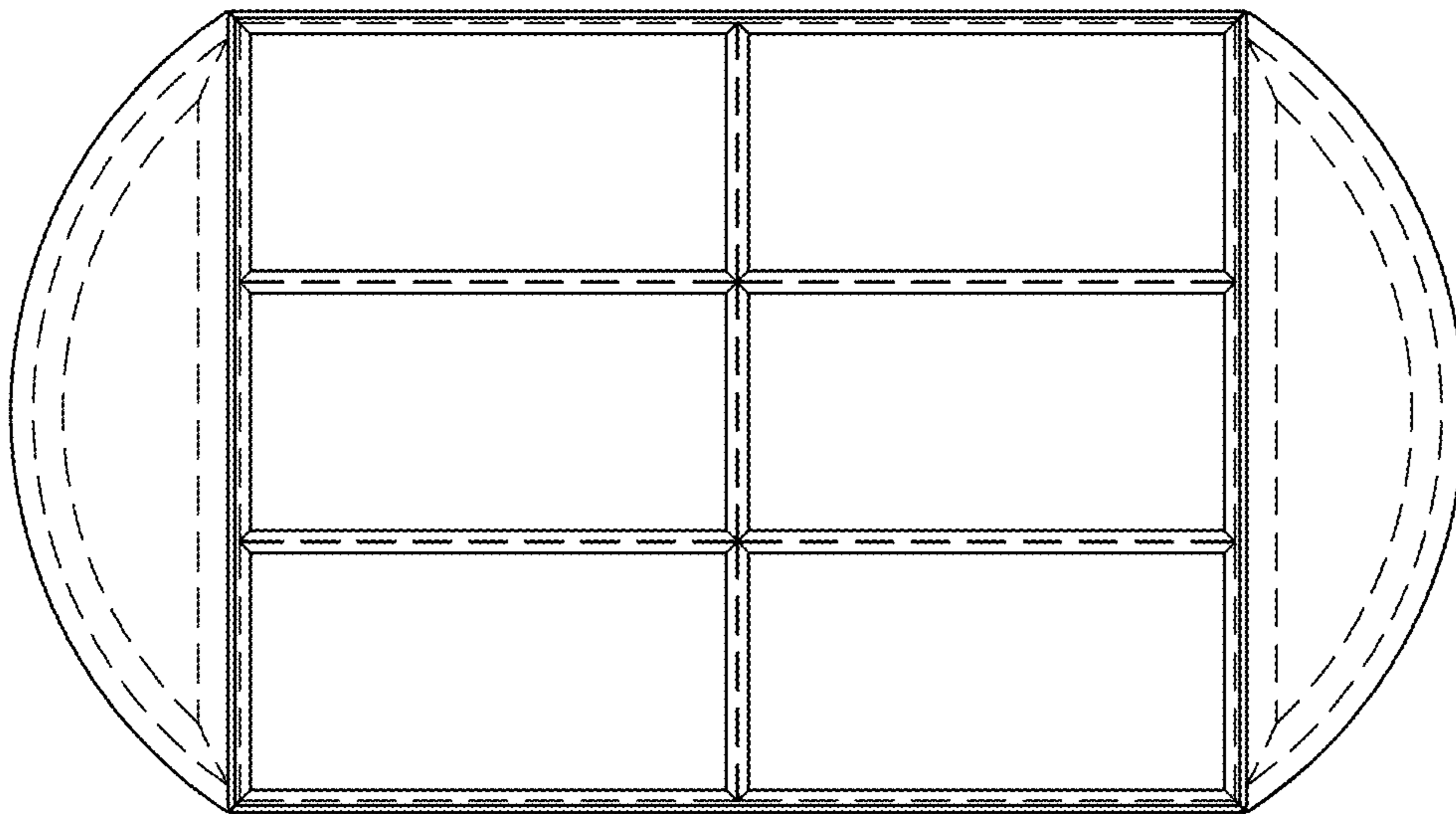

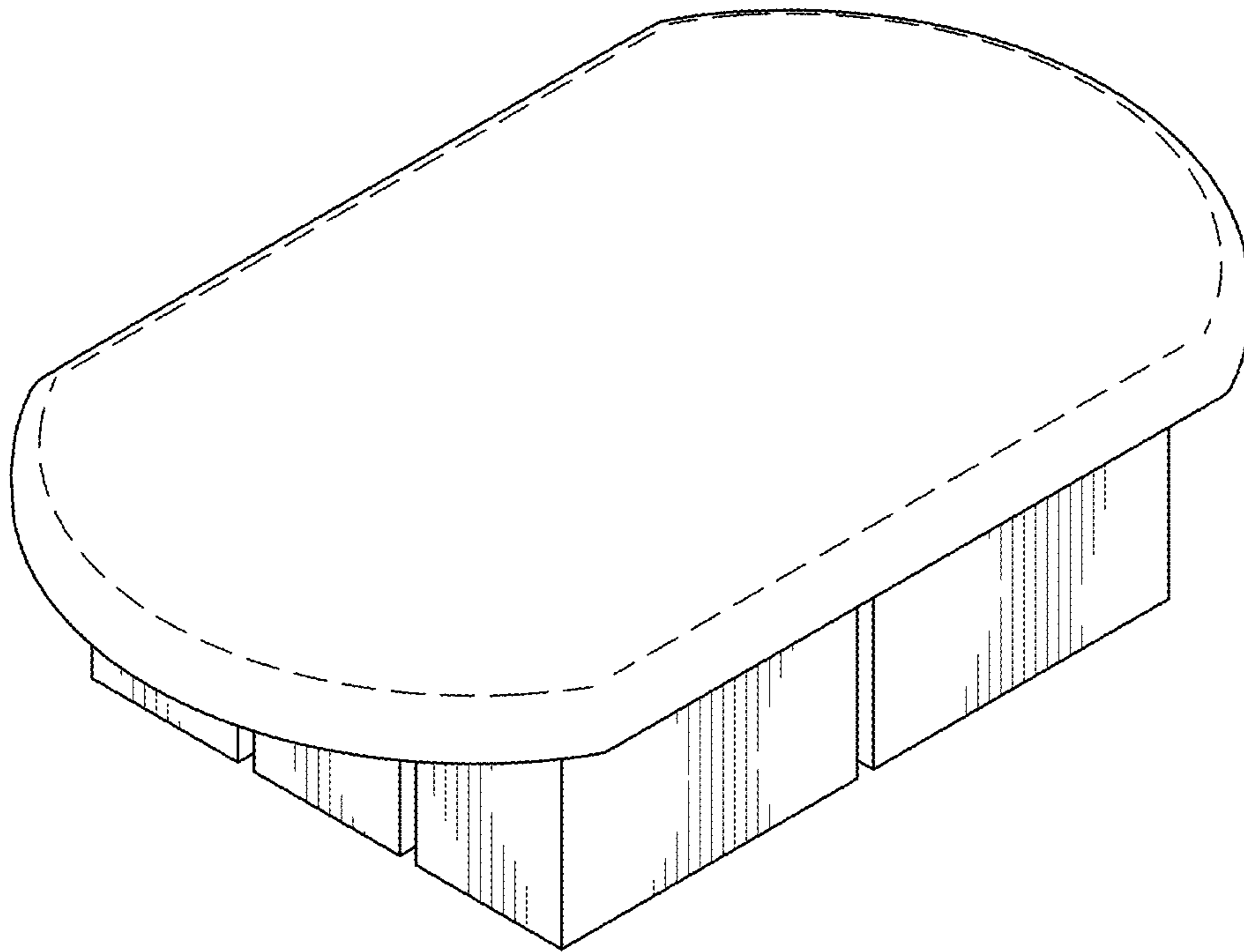

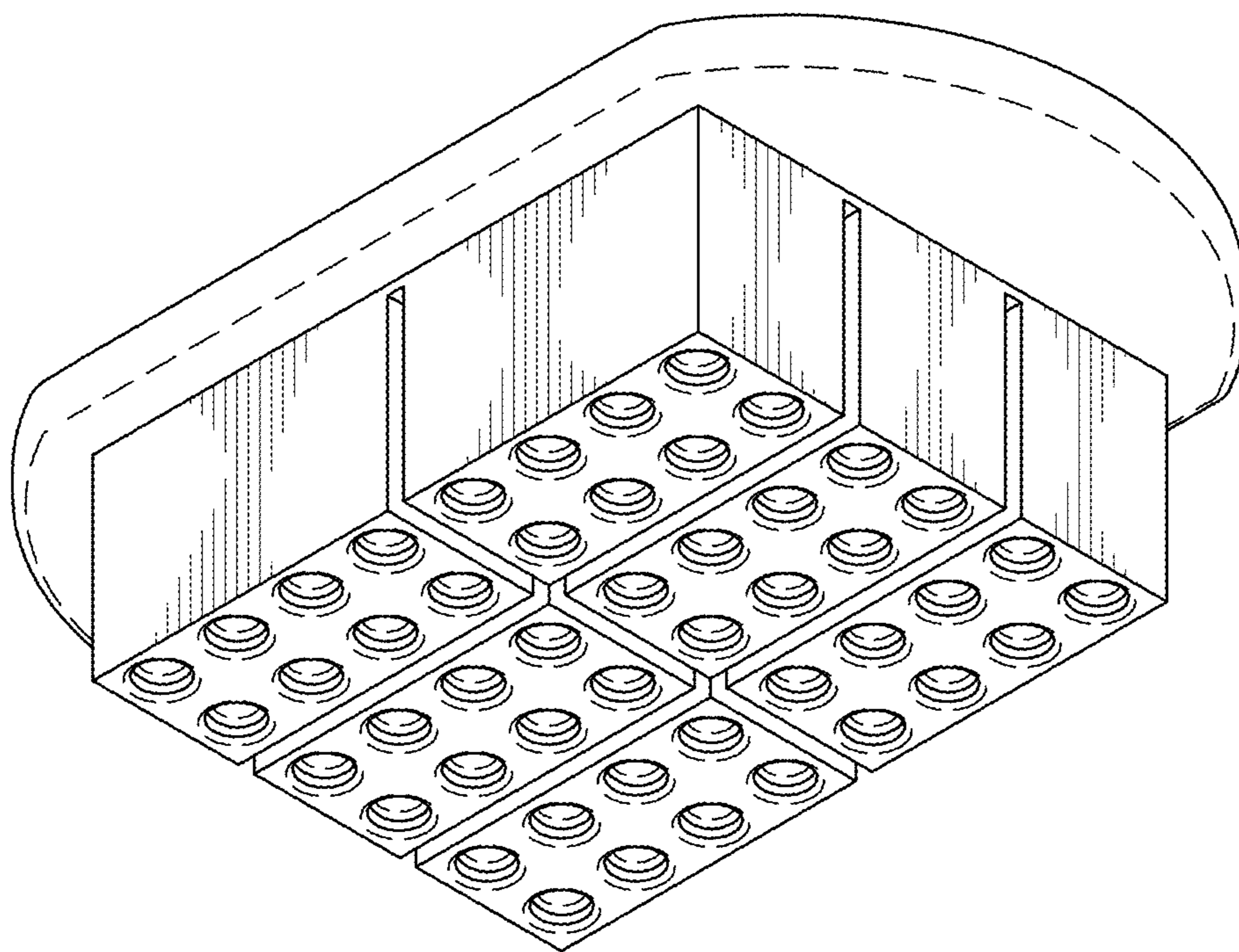

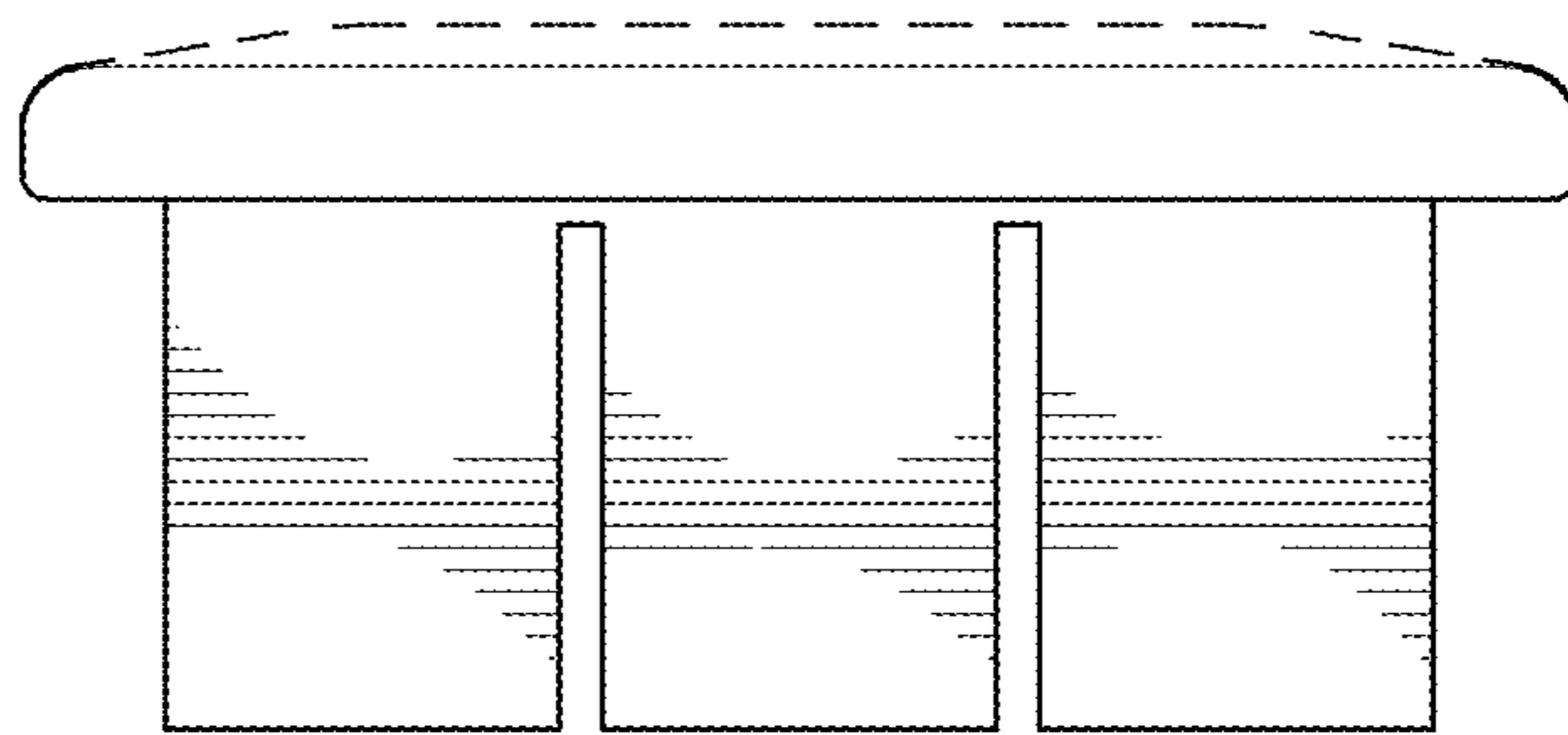

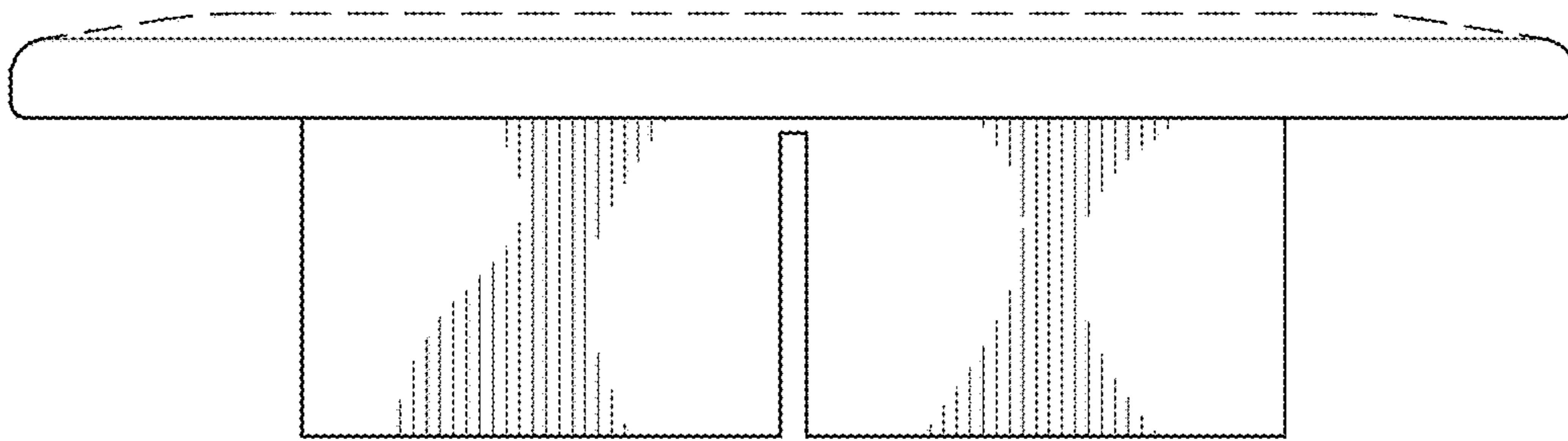

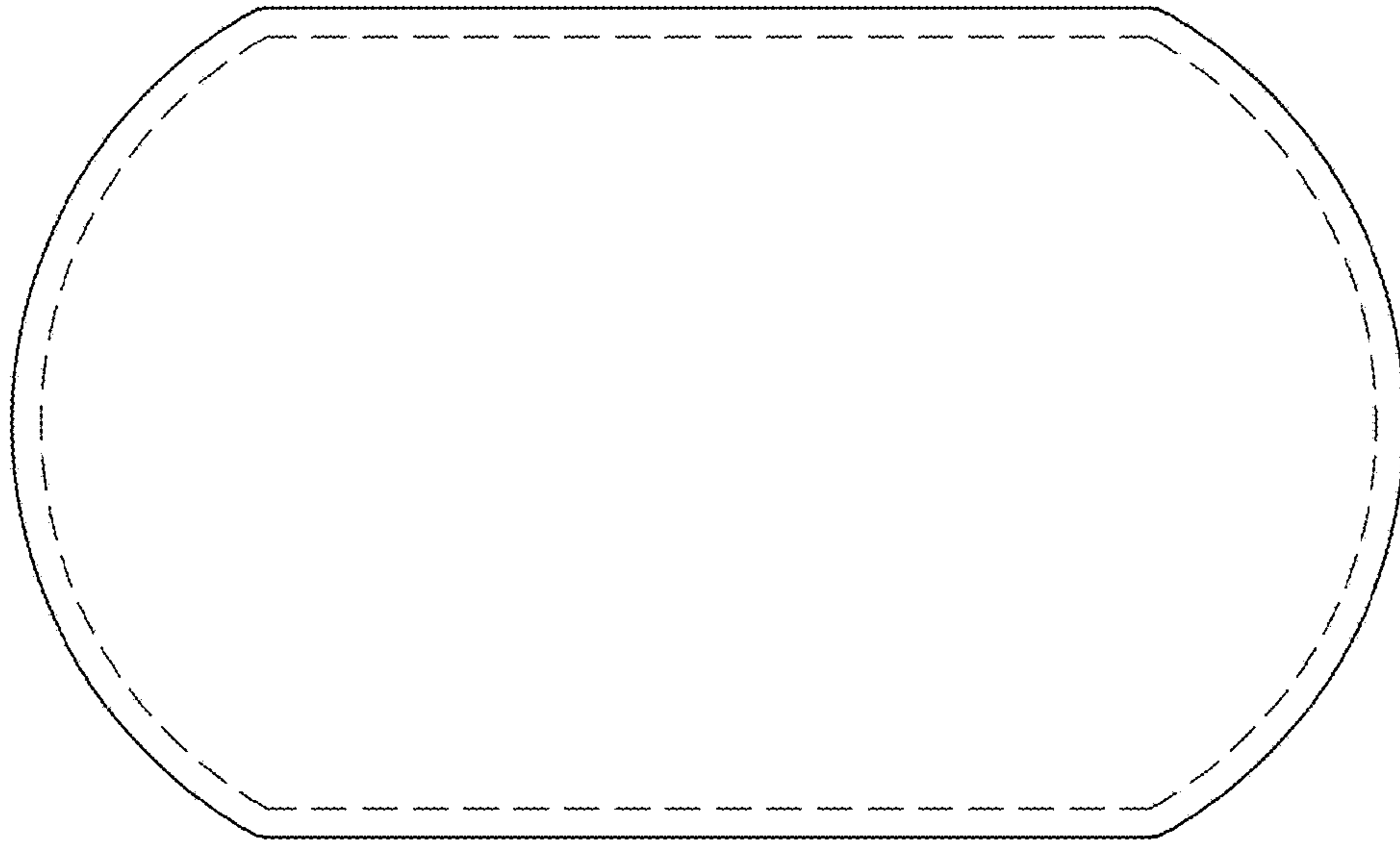

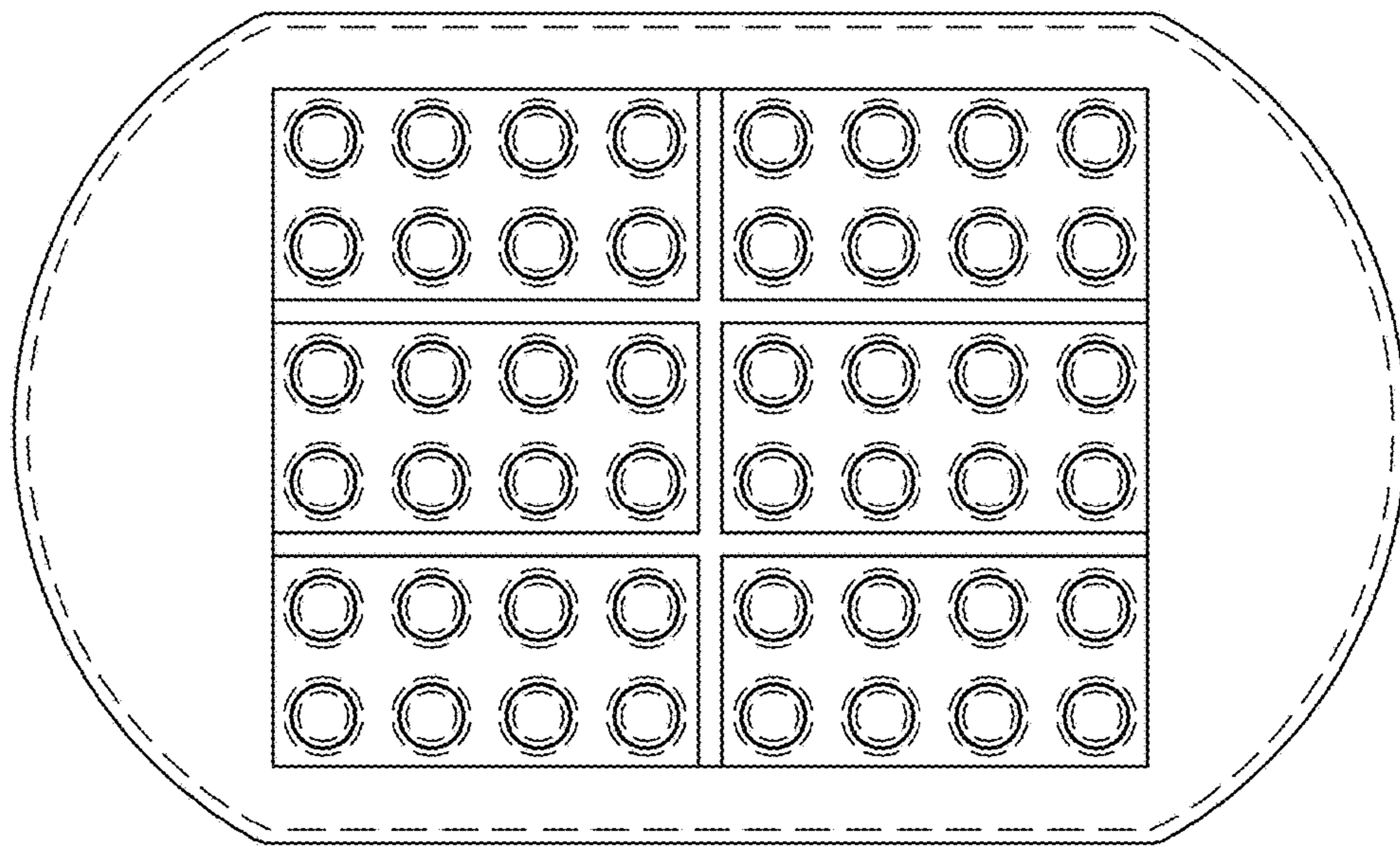
