1.3 is a right side view thereof;

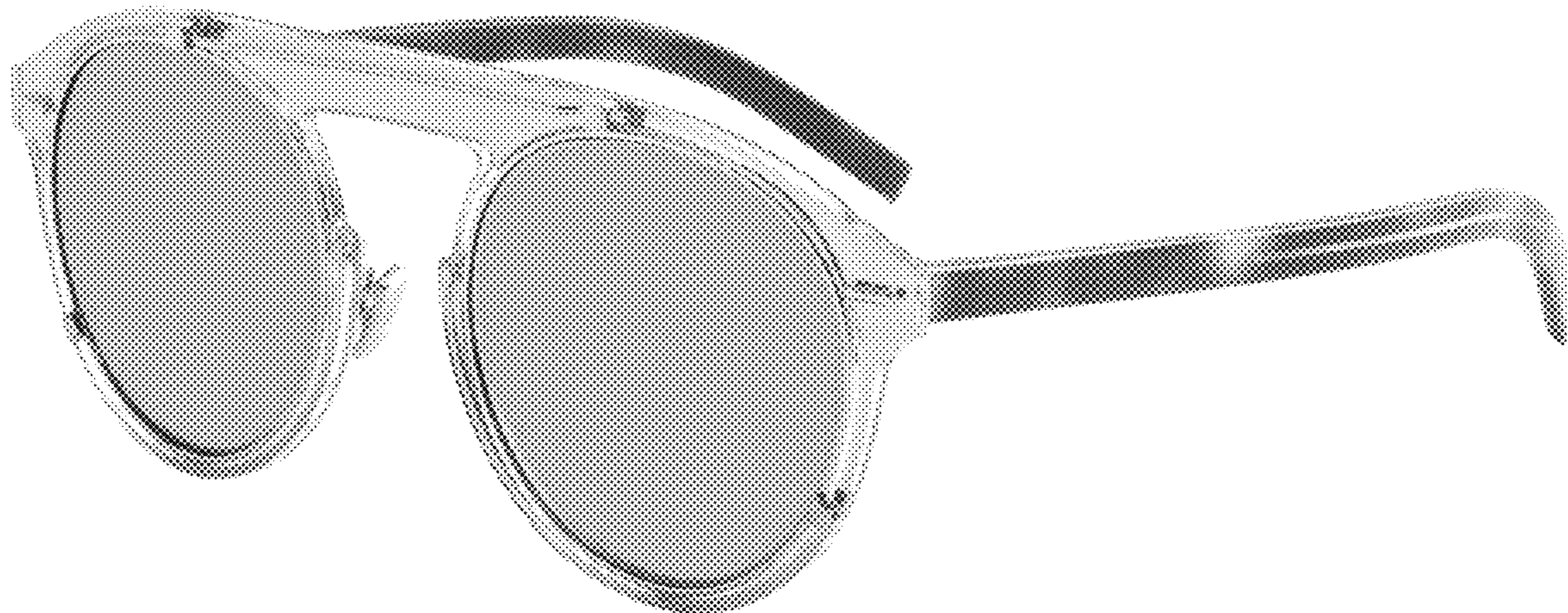
1.4 is a left side view thereof;

1.5 is bottom view thereof;

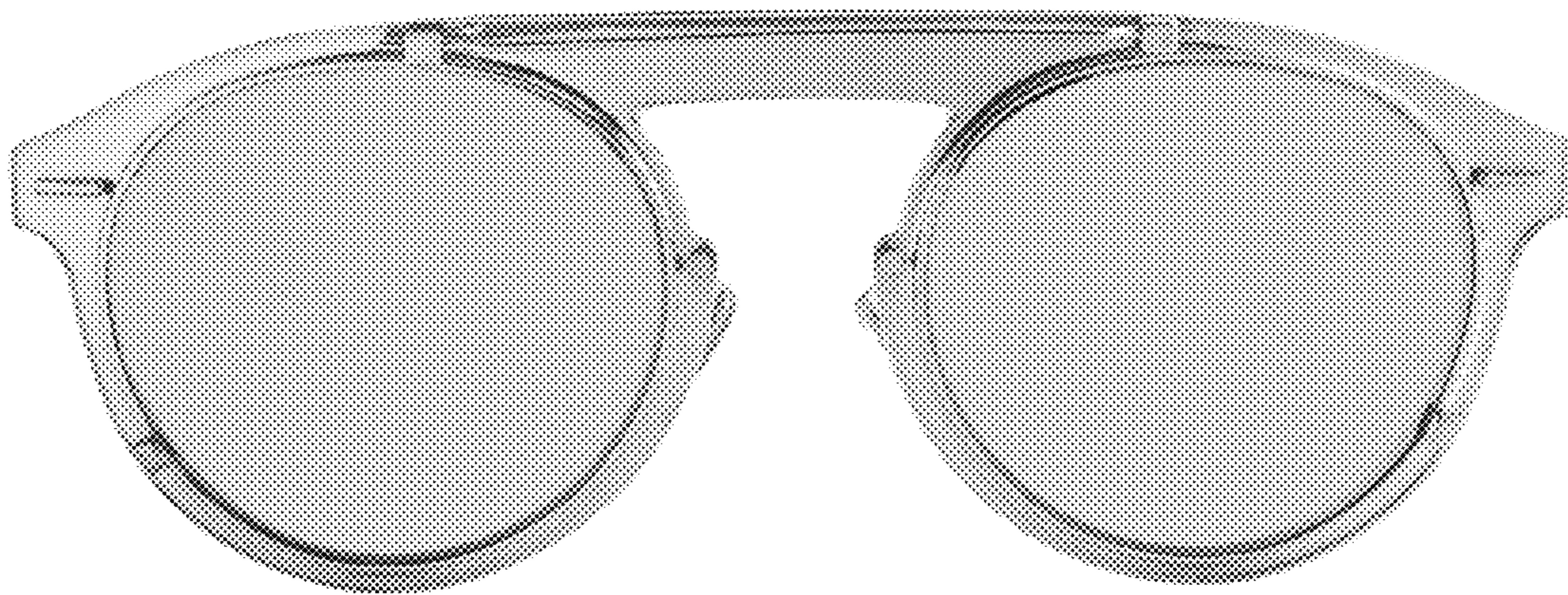
1.6 is a top view thereof; and

1.7 is a front perspective view.

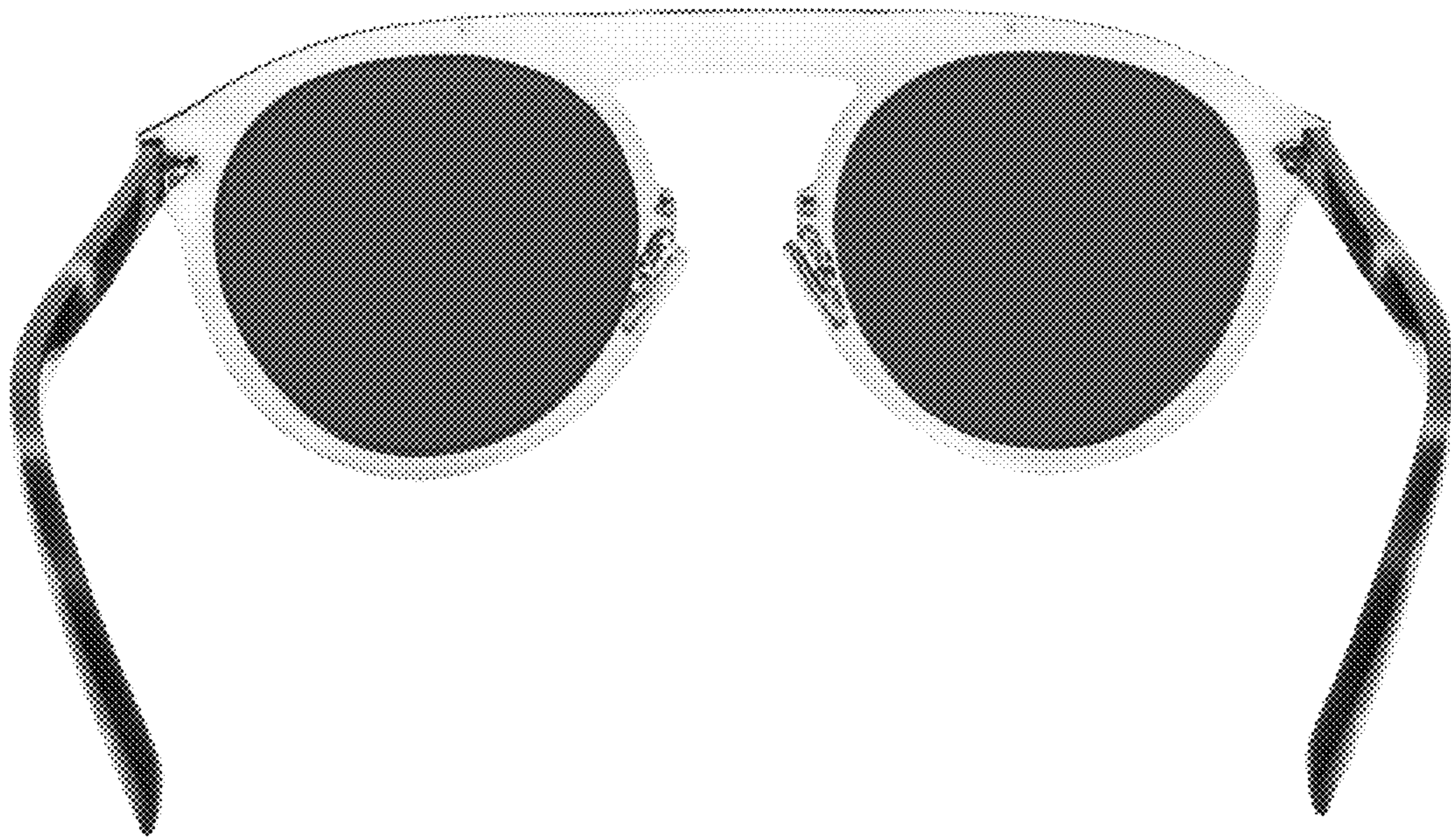

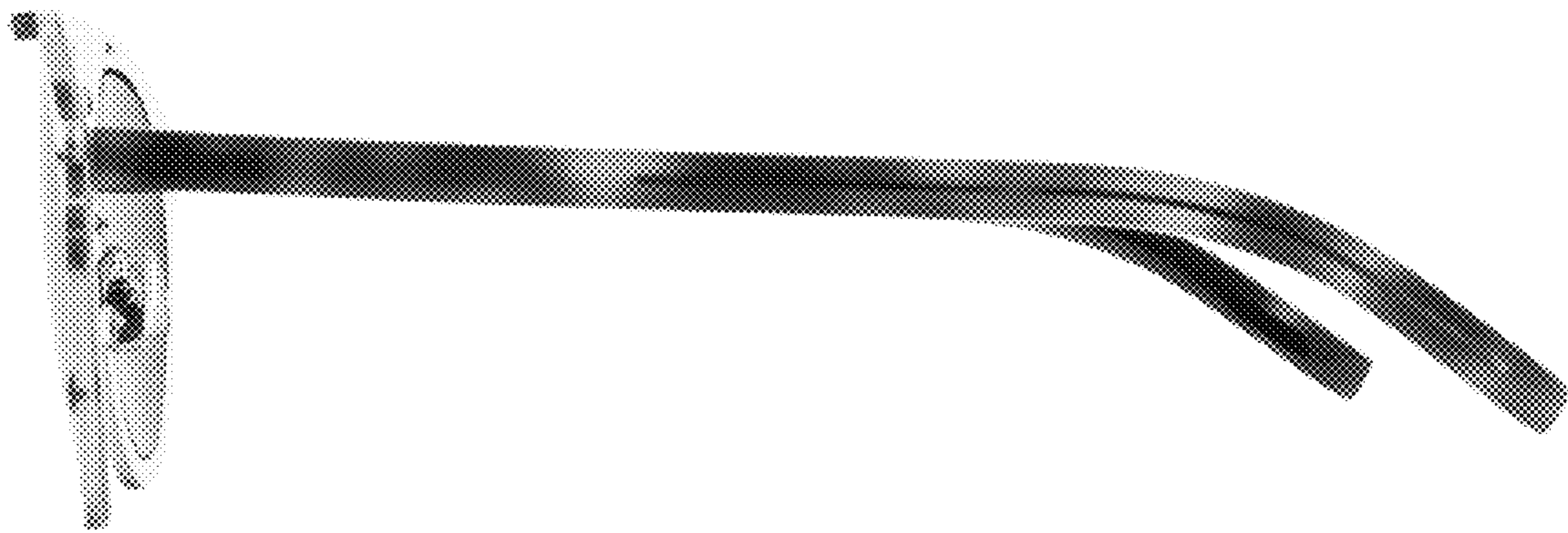

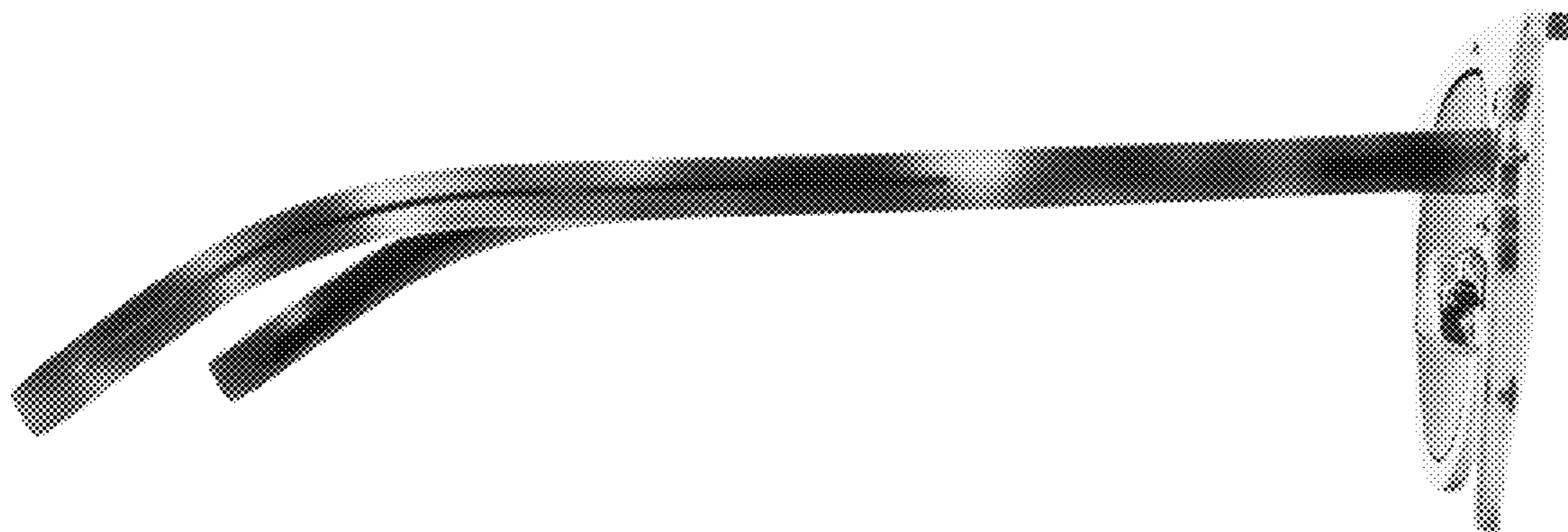
