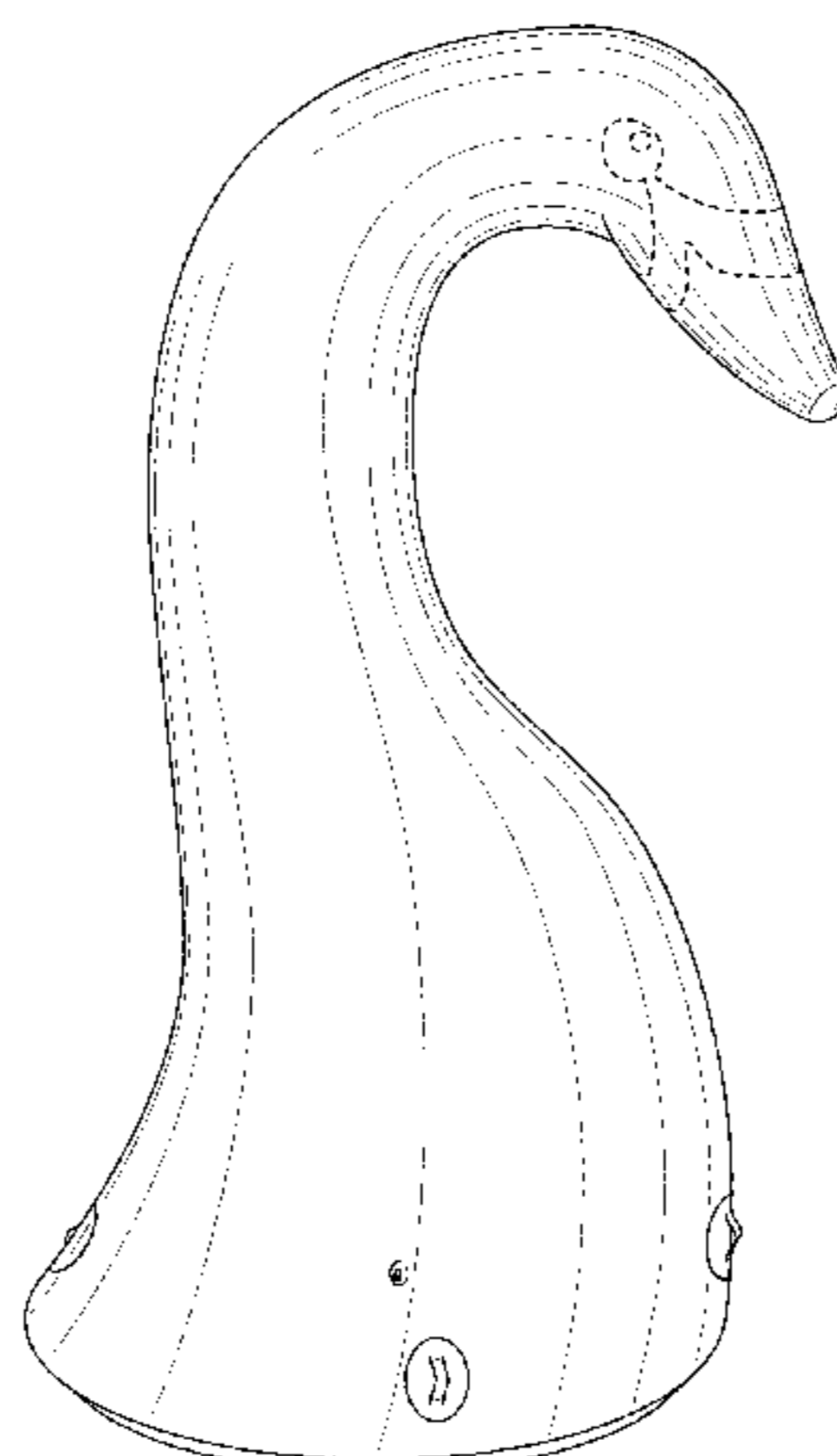
(57) **CLAIM**

The ornamental design for a model of an anatidae portion,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a model of an anatidae  
portion showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a top view thereof; and,  
FIG. 7 is a bottom view thereof.  
The broken lines in FIGS. 1, 2, and 4-6 illustrate portions of  
the model of an anatidae portion which form no part of the  
claimed design.

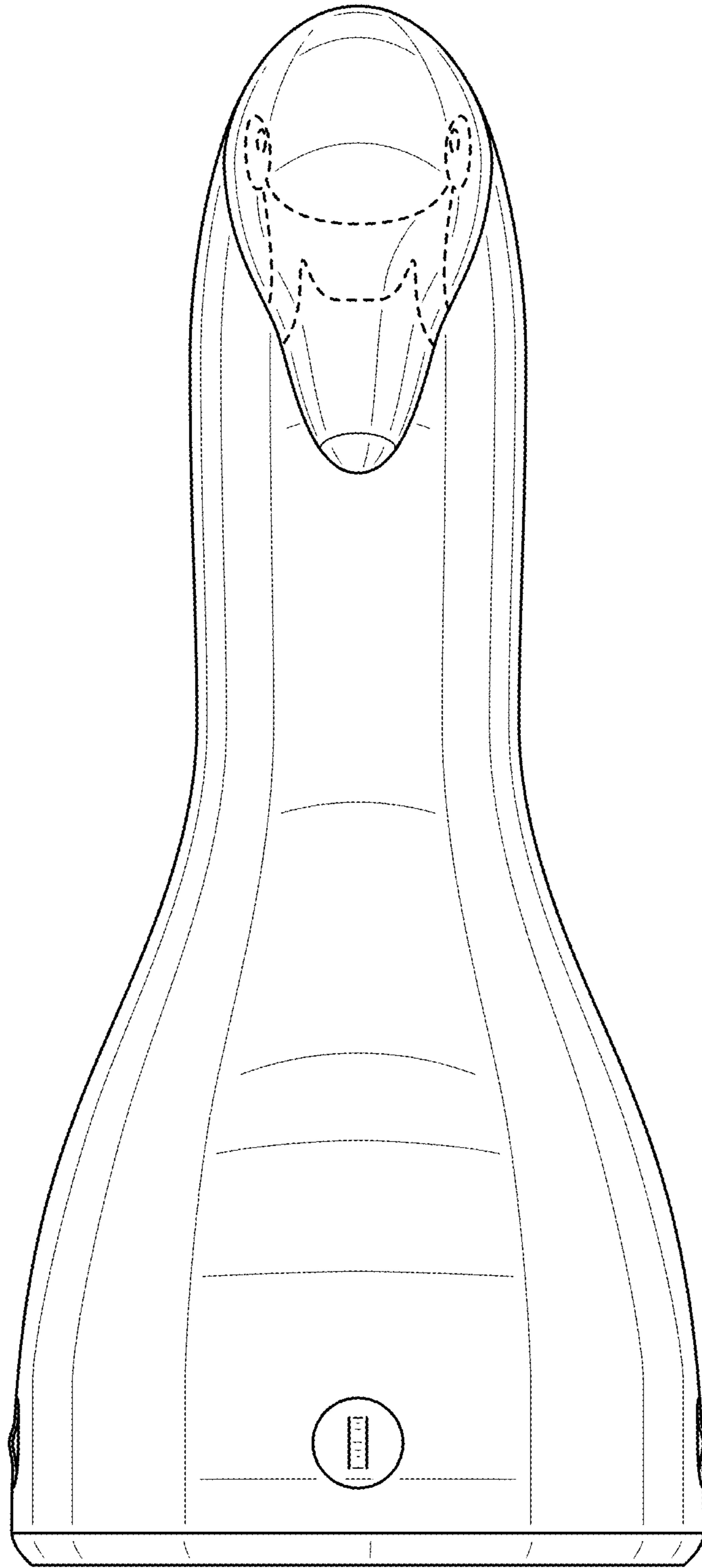

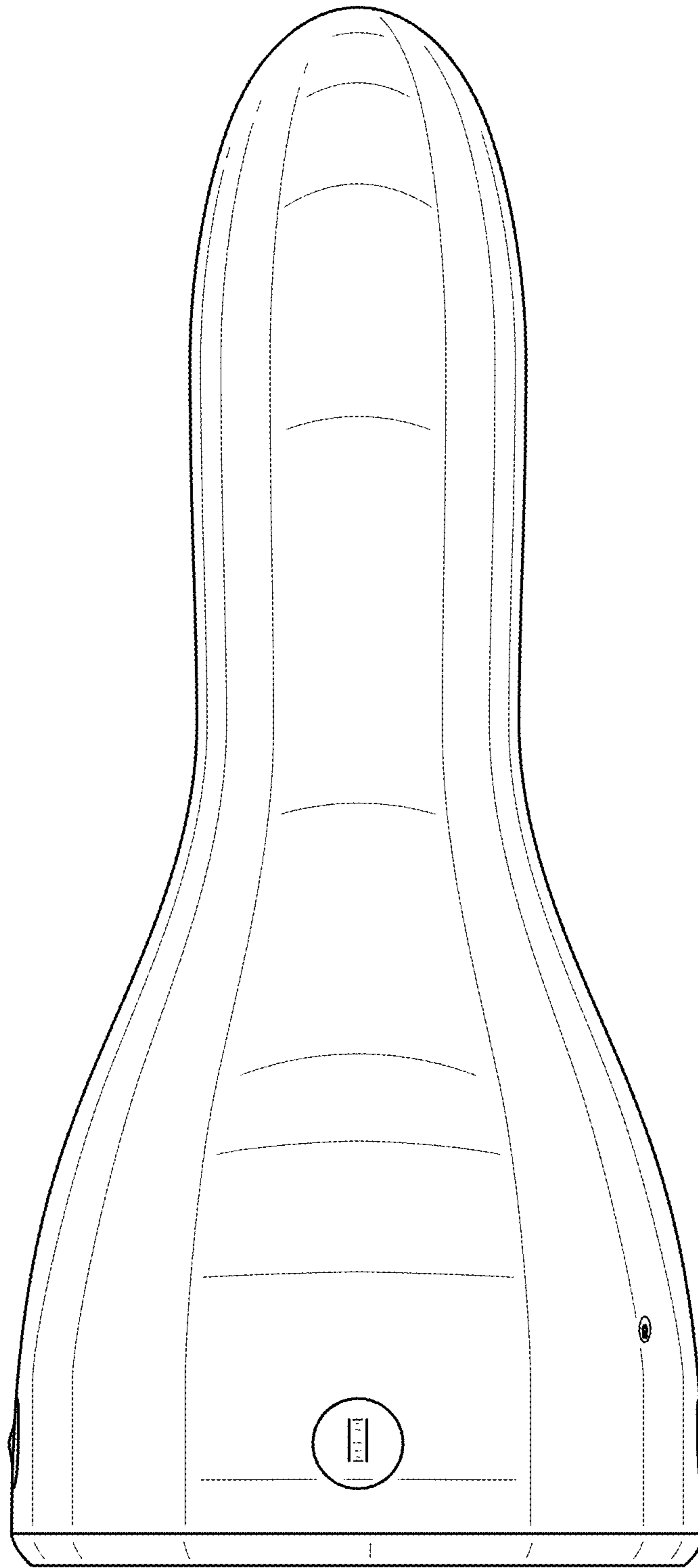

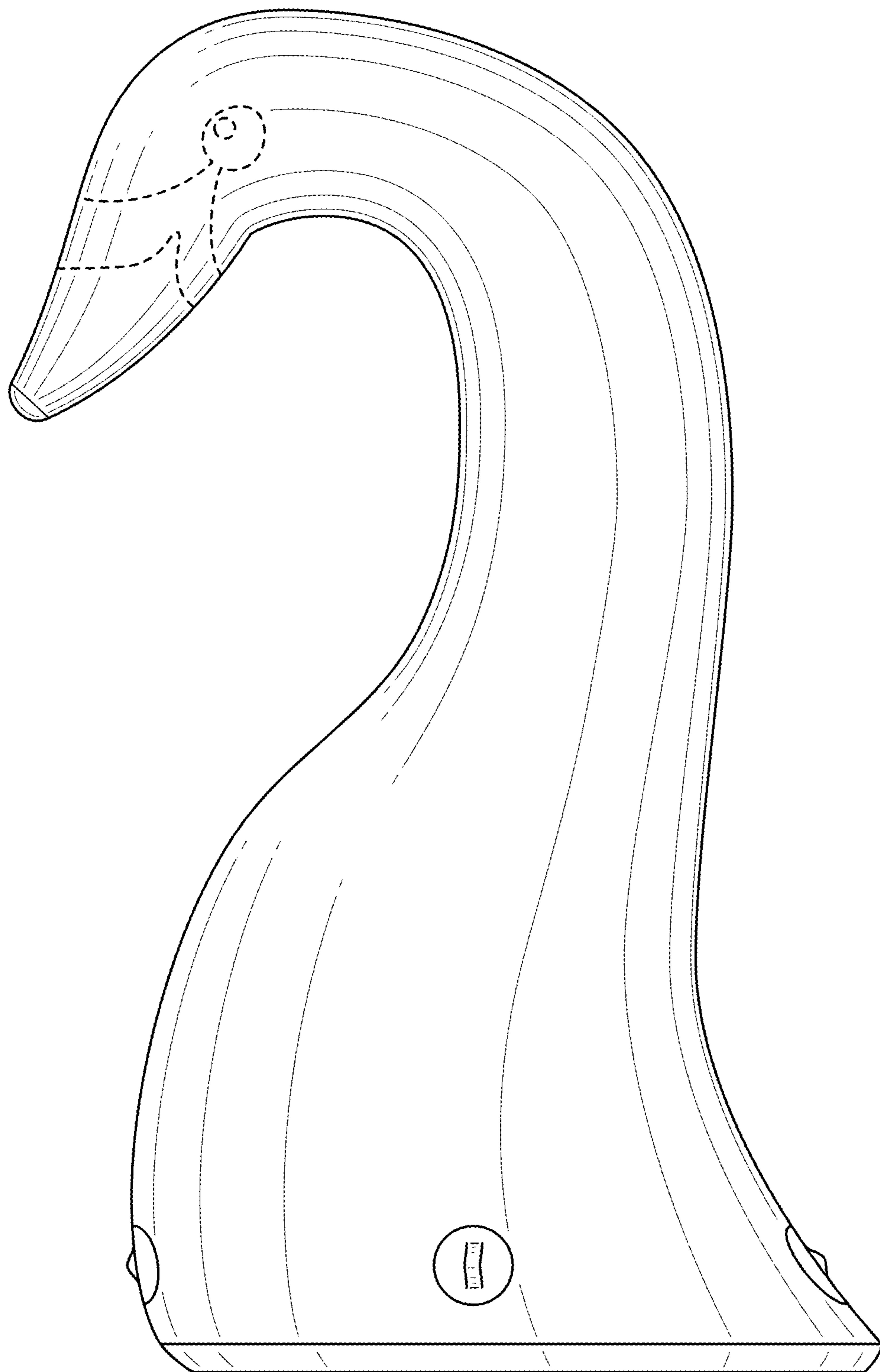

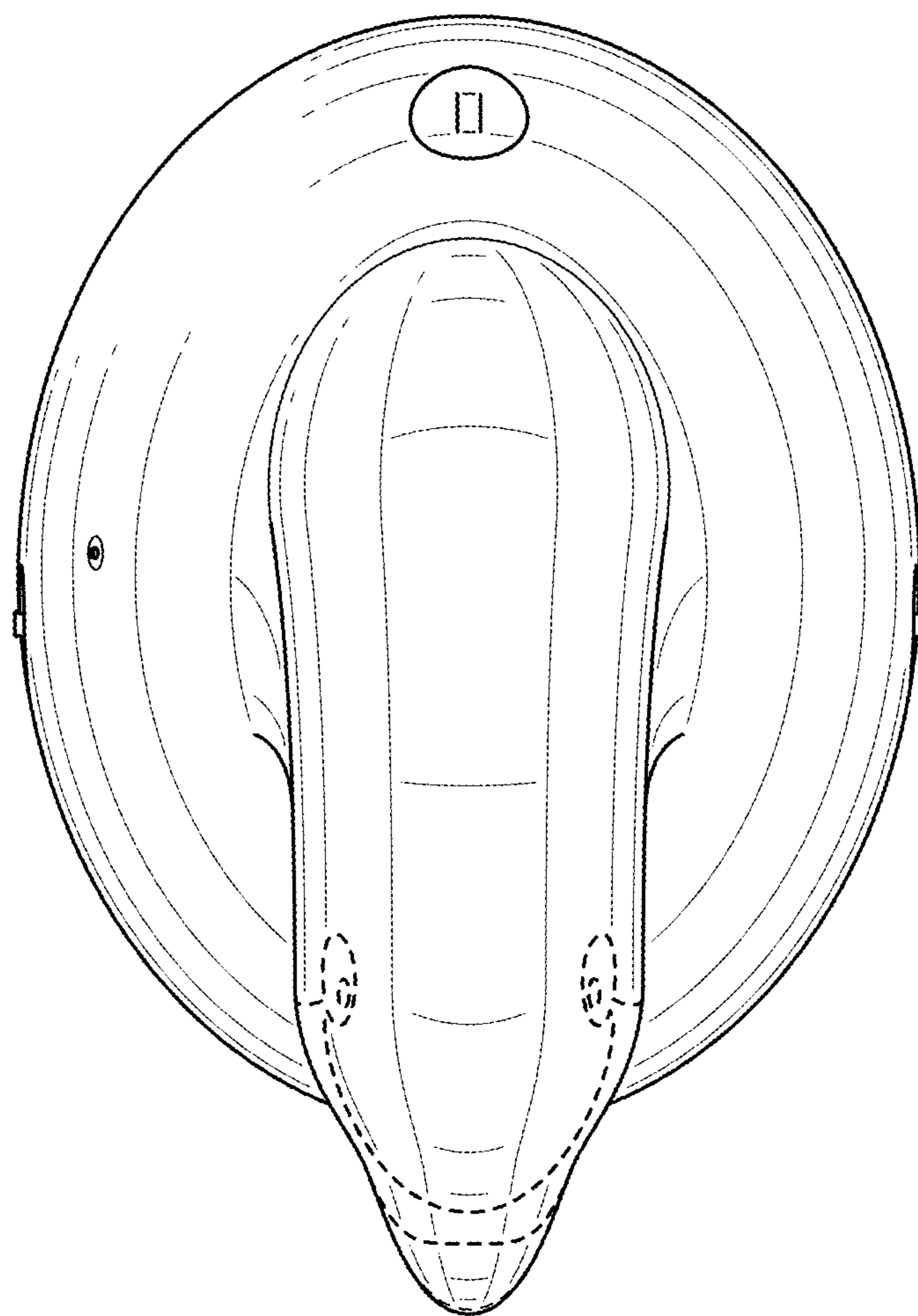

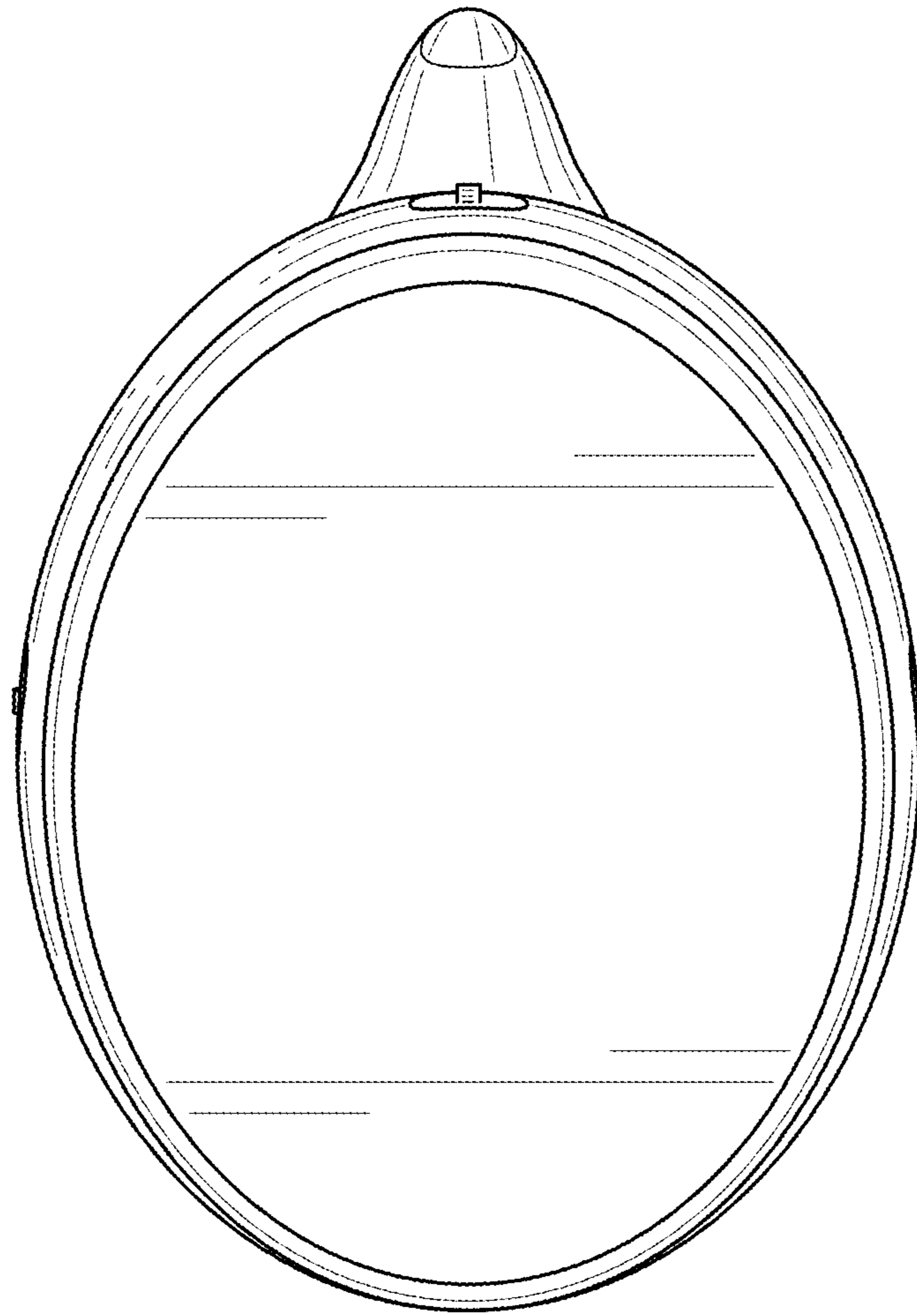
