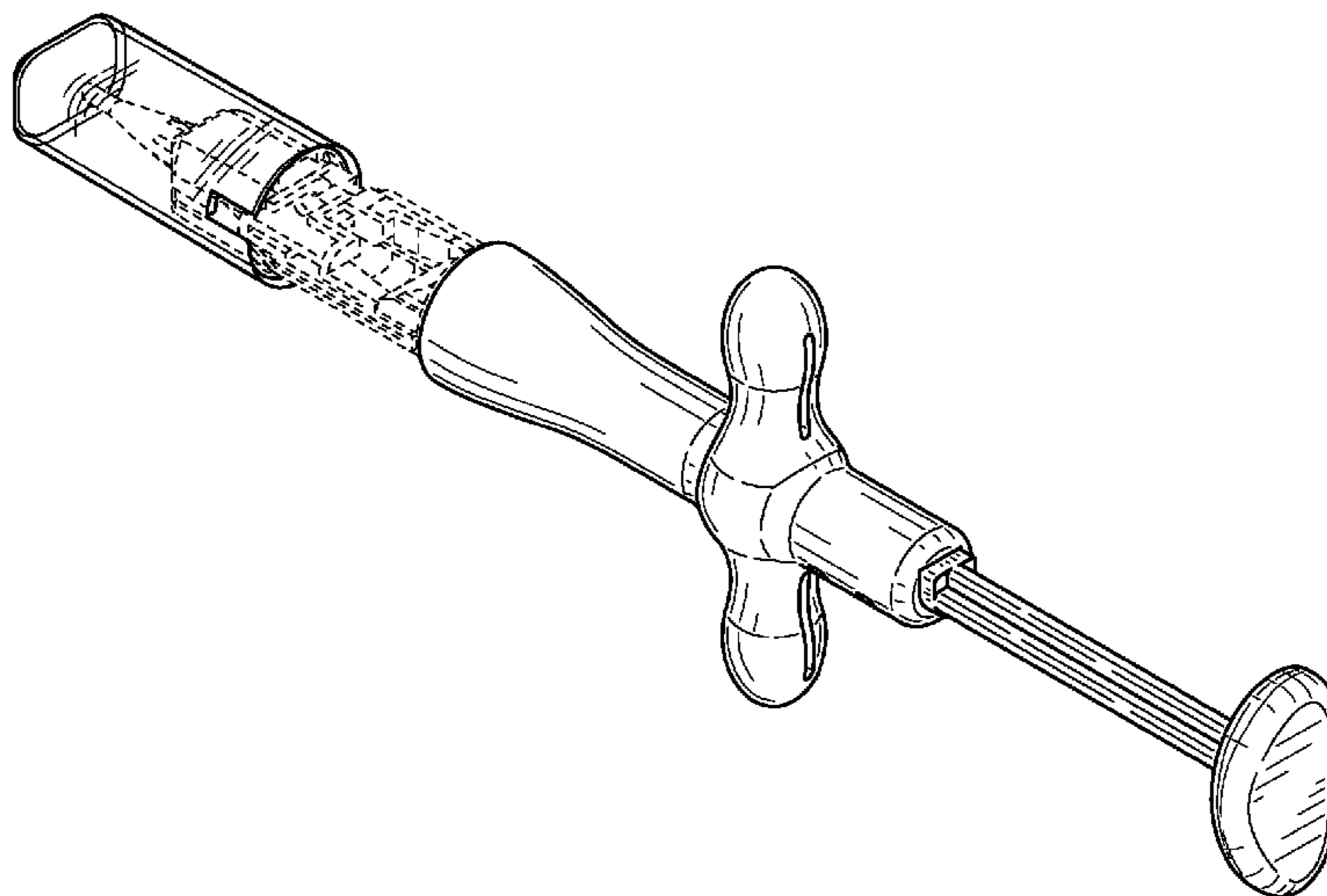
(57) **CLAIM**

The ornamental design for an intraocular lens injector set, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the intraocular lens injector set with a housing in a fully open position. FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view of the intraocular lens injector set with a housing in a fully-closed position. FIG. 9 is a front elevation view thereof; FIG. 10 is a rear elevation view thereof; FIG. 11 is a left side elevation view thereof; FIG. 12 is a right side elevation view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof. The features shown in broken lines in the Figures form no part of the claimed design.

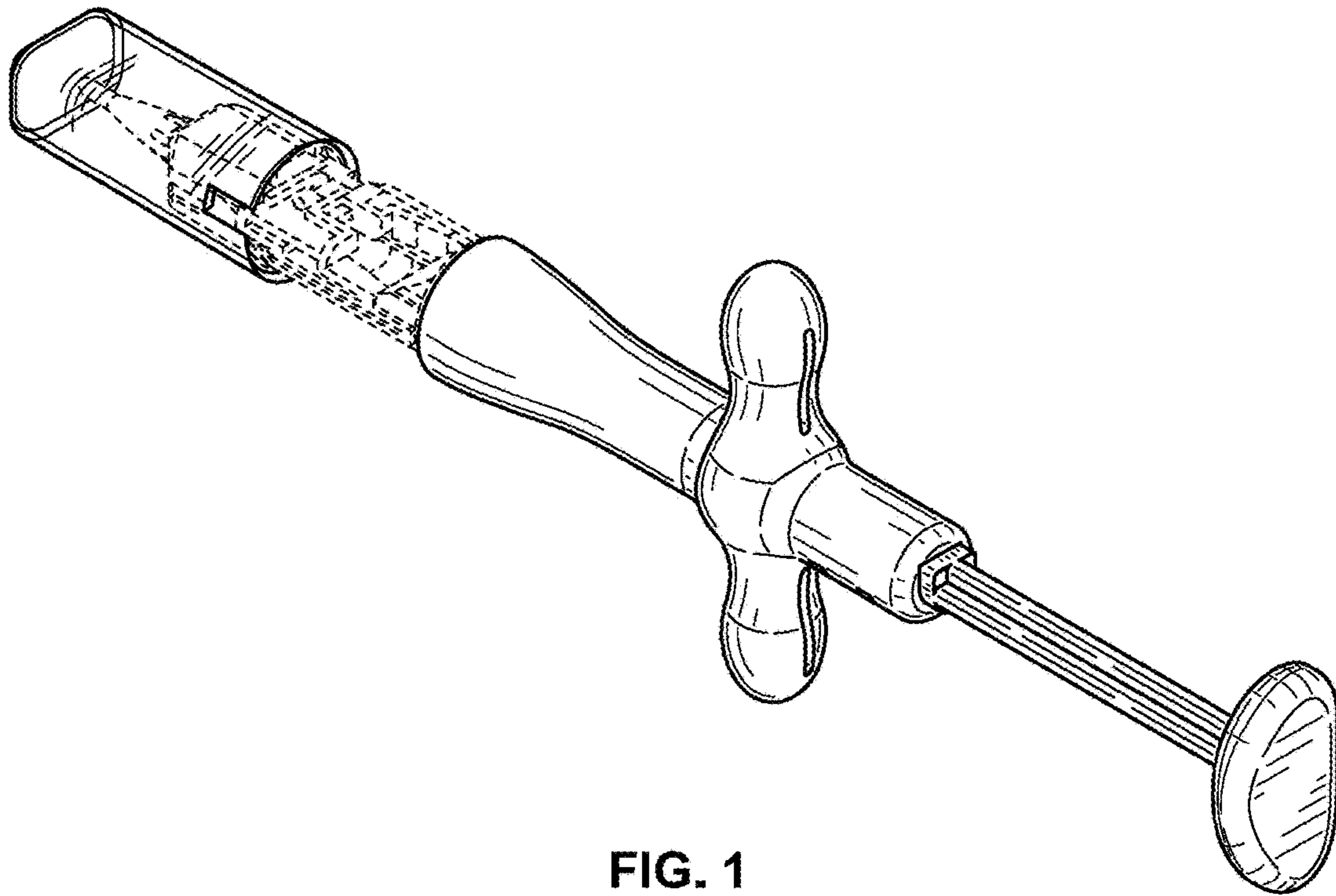

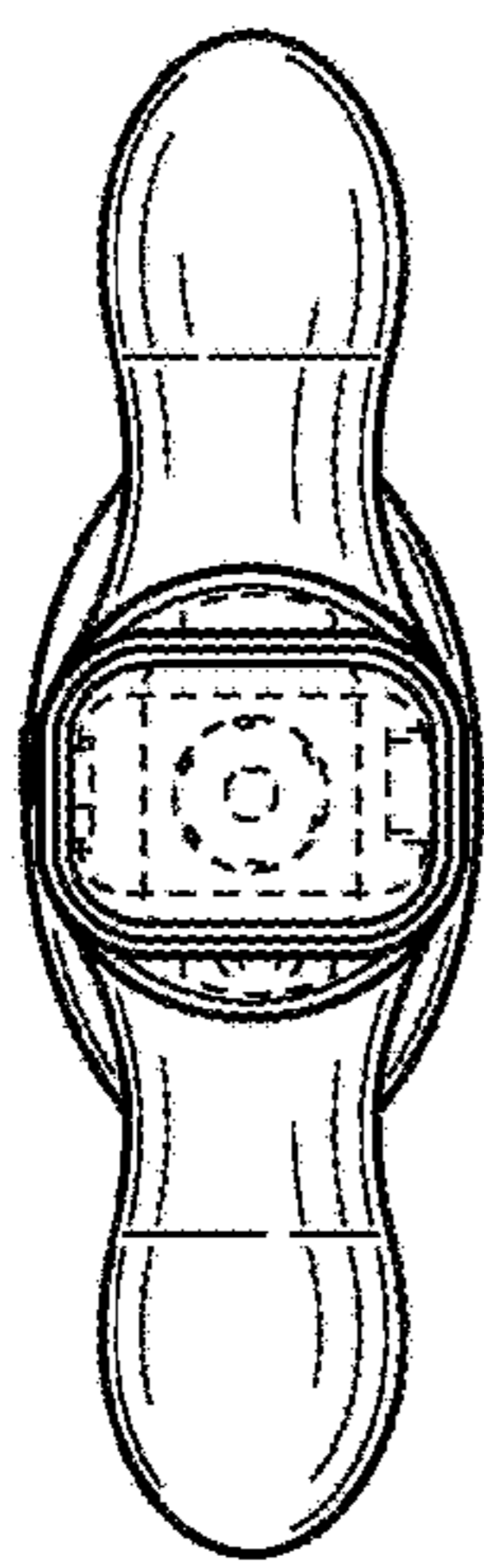

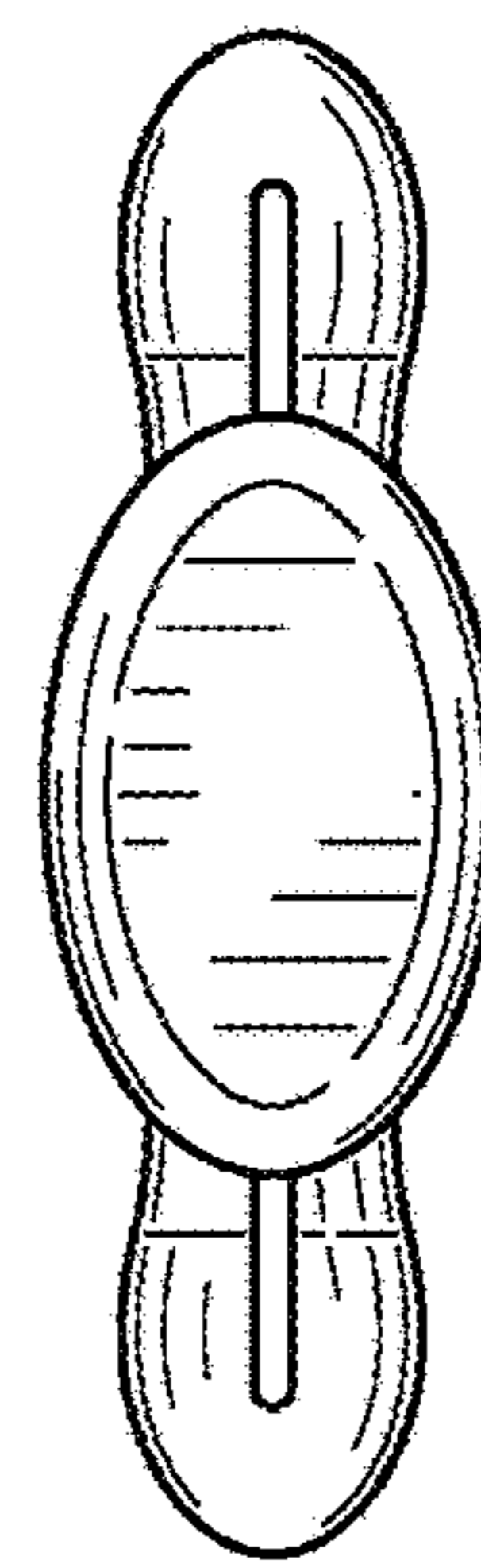
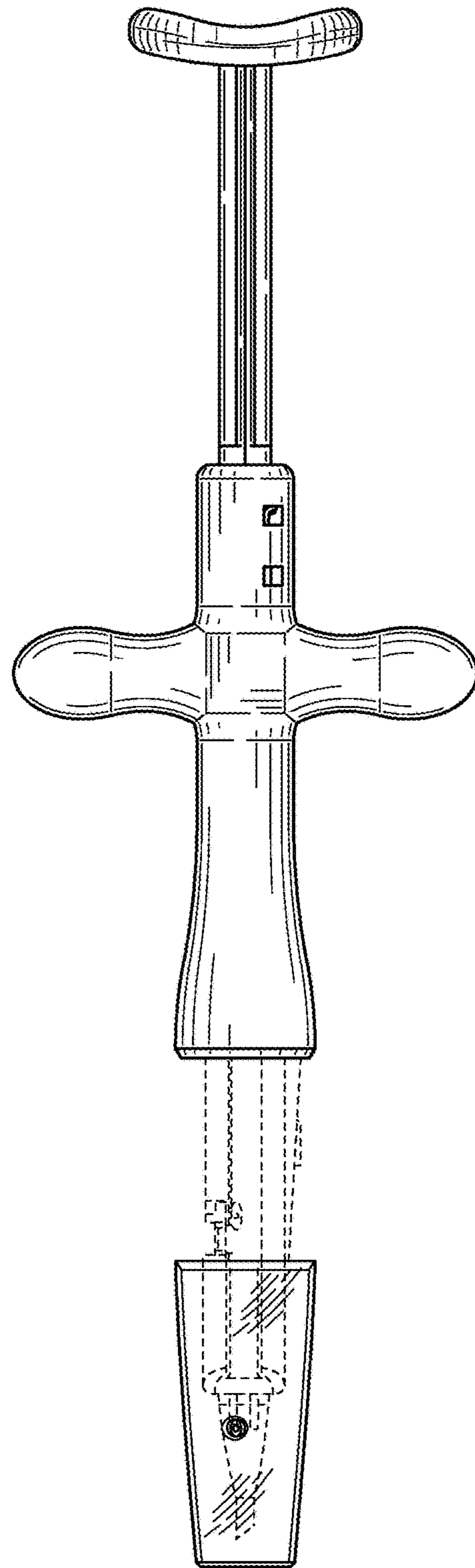
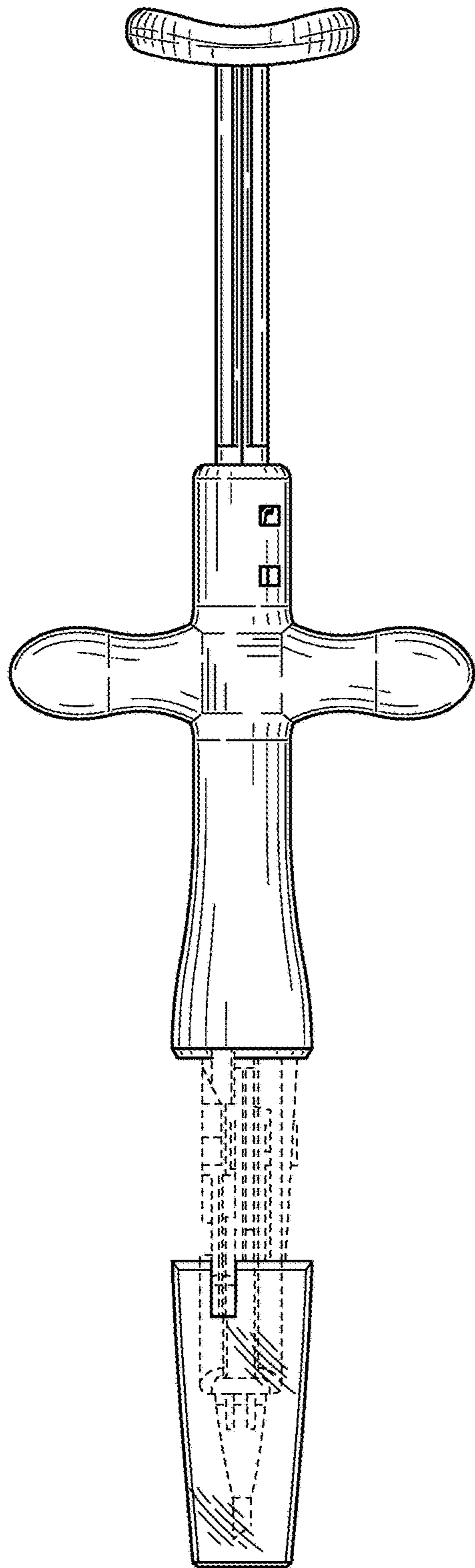

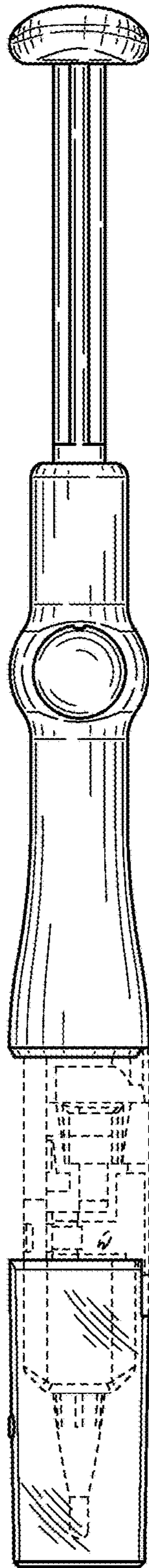

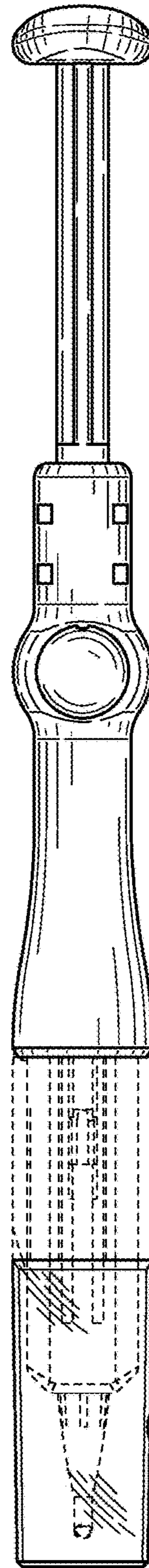

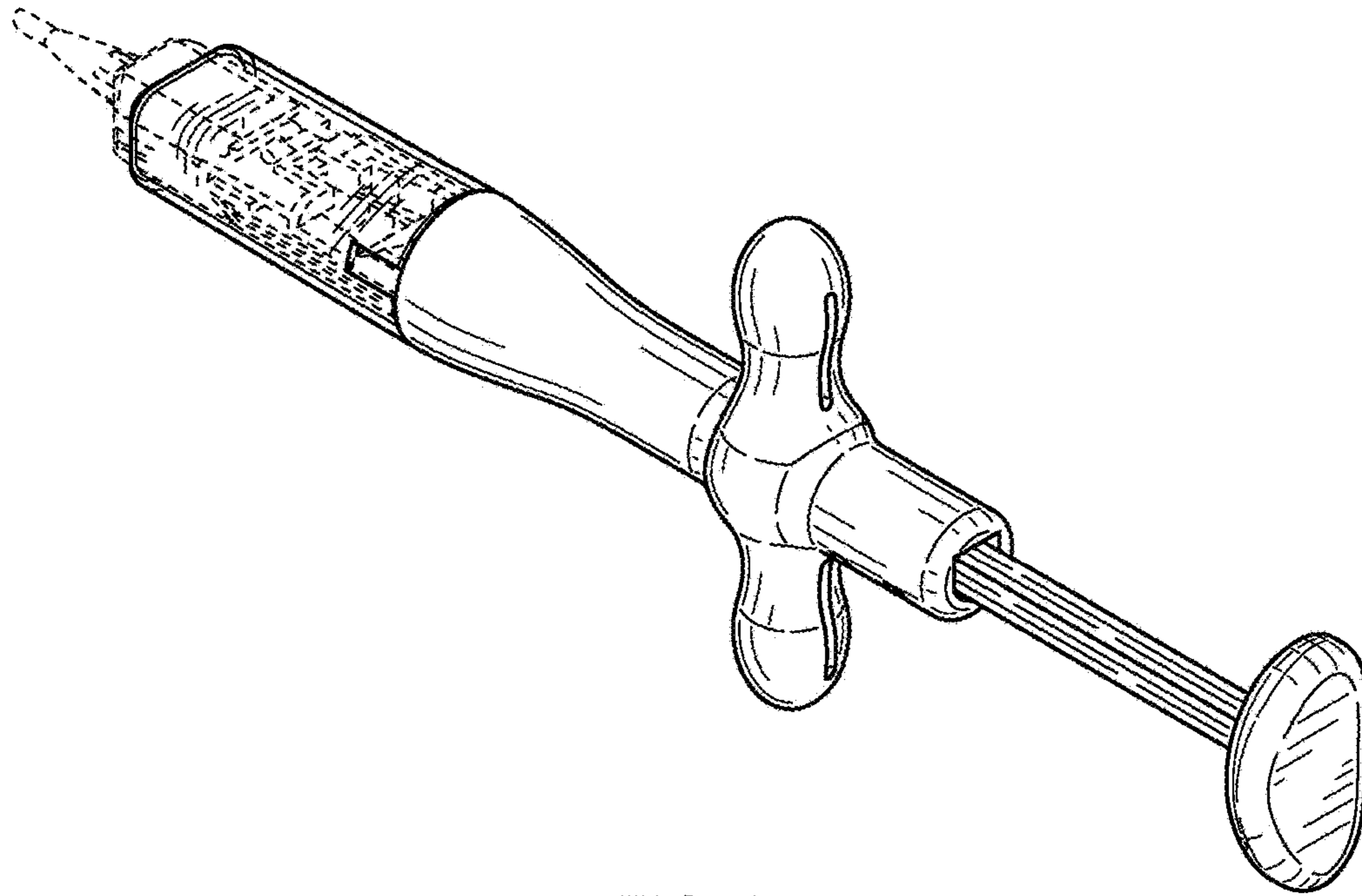

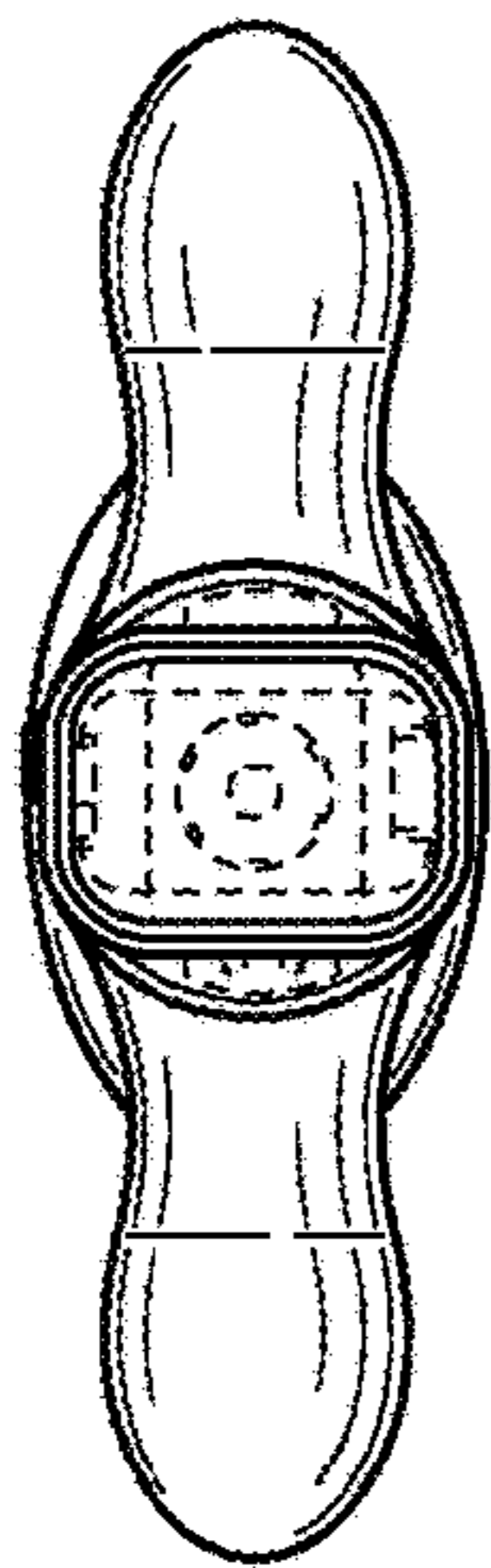

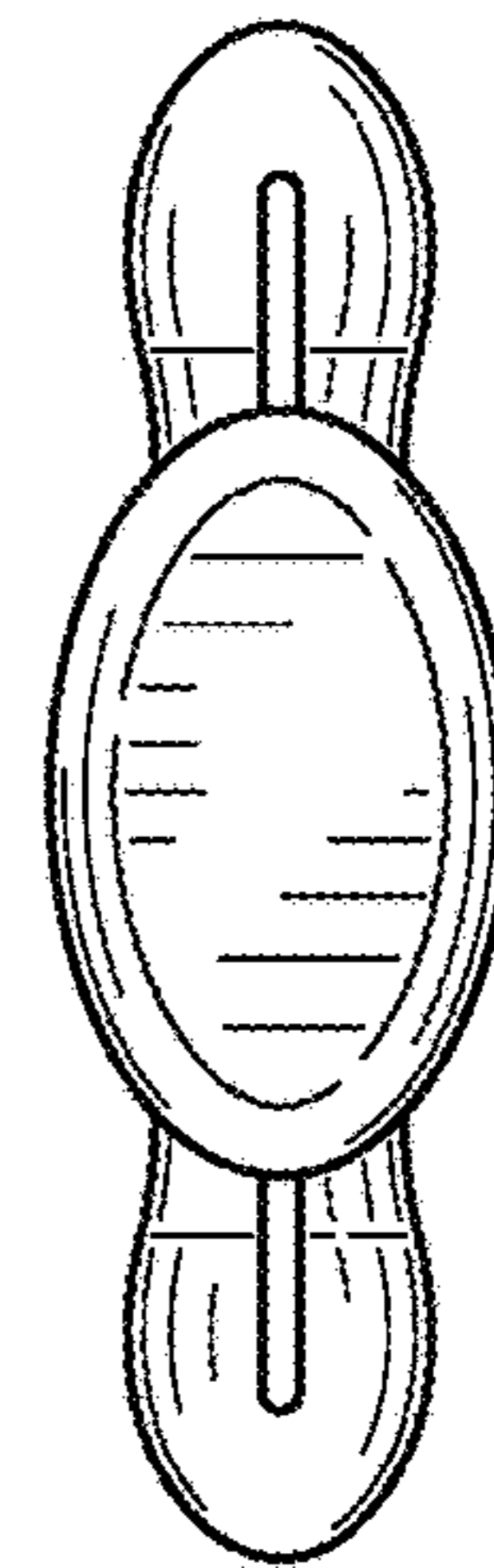

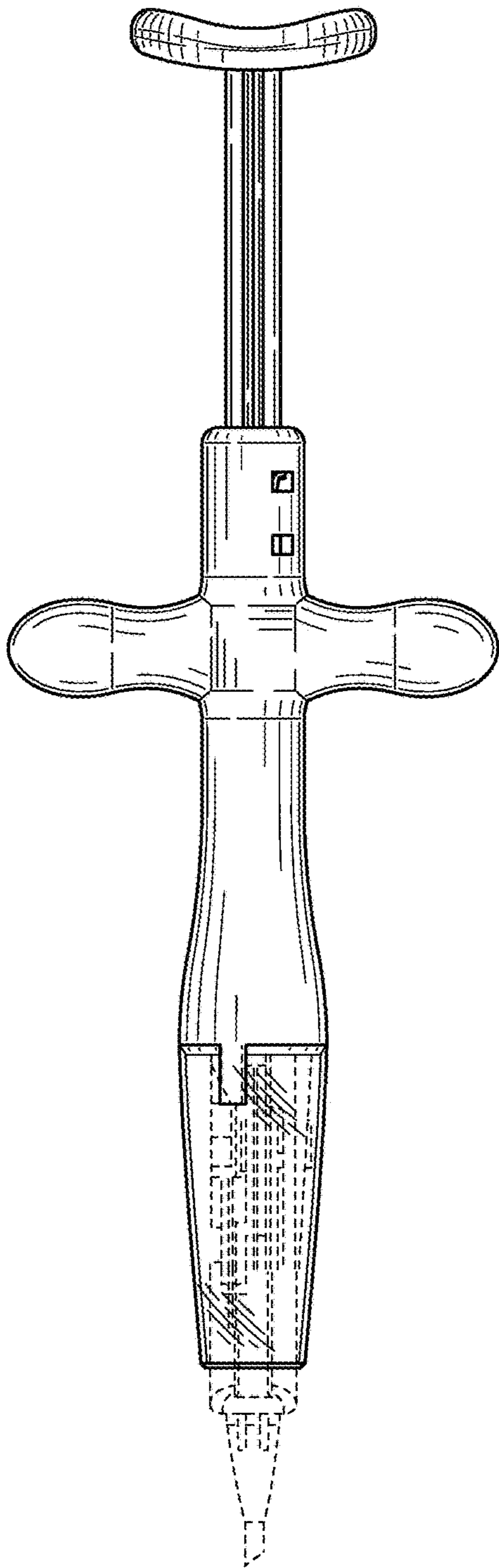

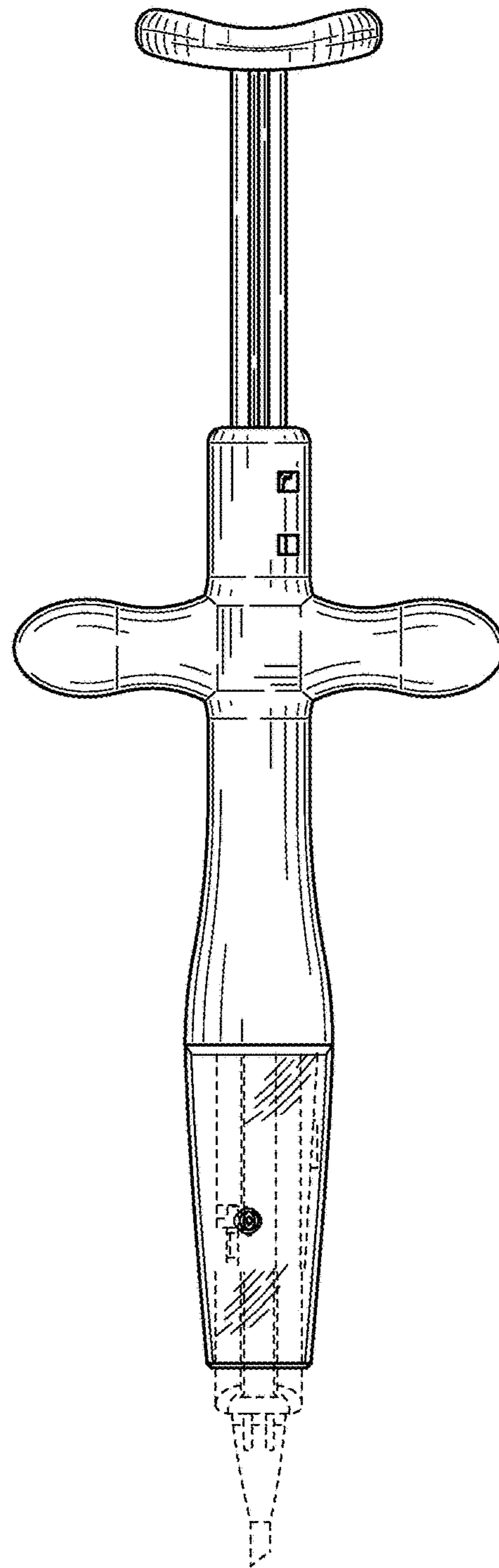

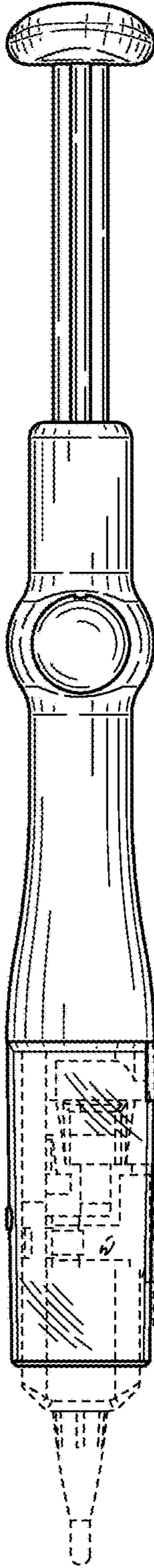

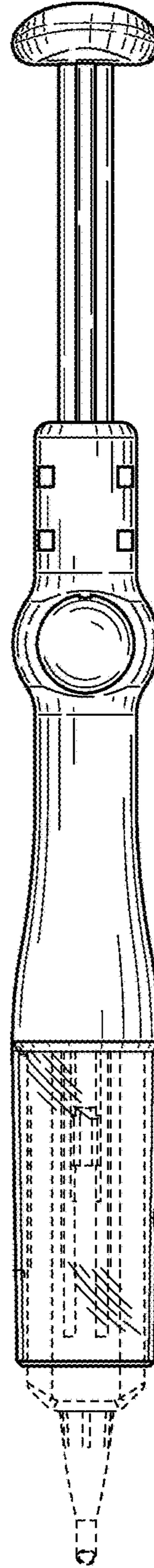
