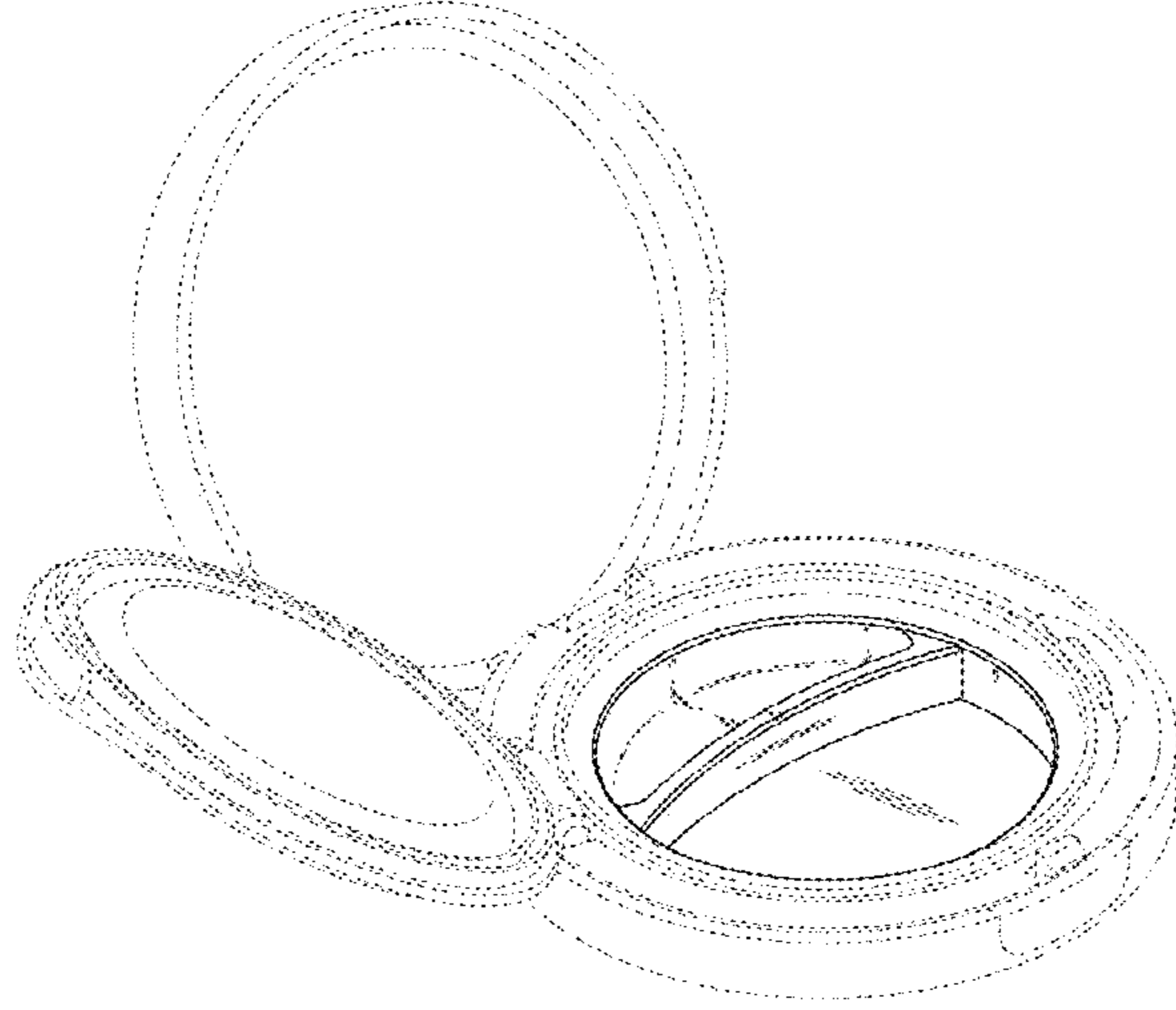
(57) **CLAIM**

We claim the ornamental design for a container for cosmetics, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a container for cosmetics, showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.
The broken lines shown in the drawings show portions of the container for cosmetics which form no part of the claimed design.

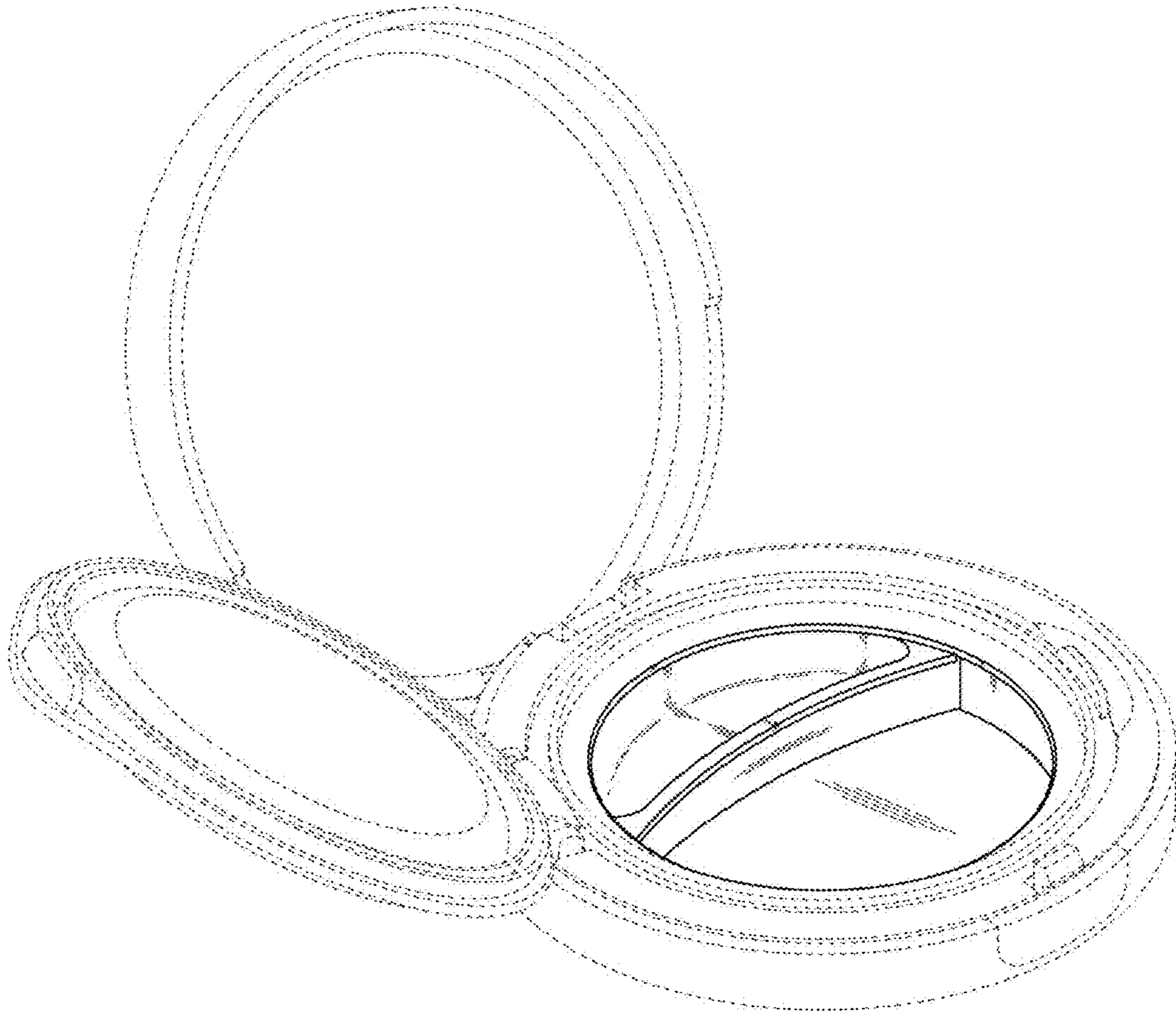

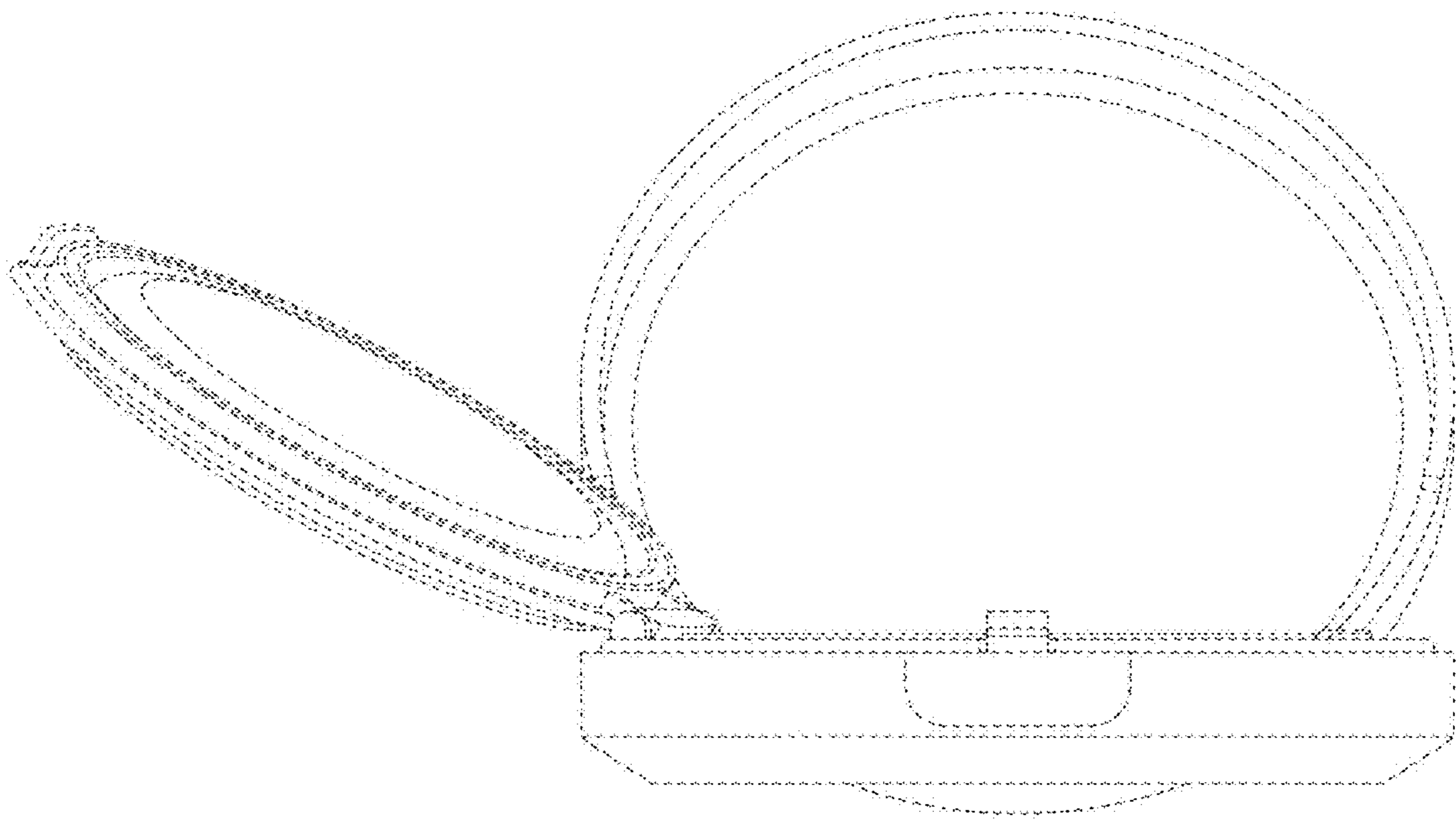

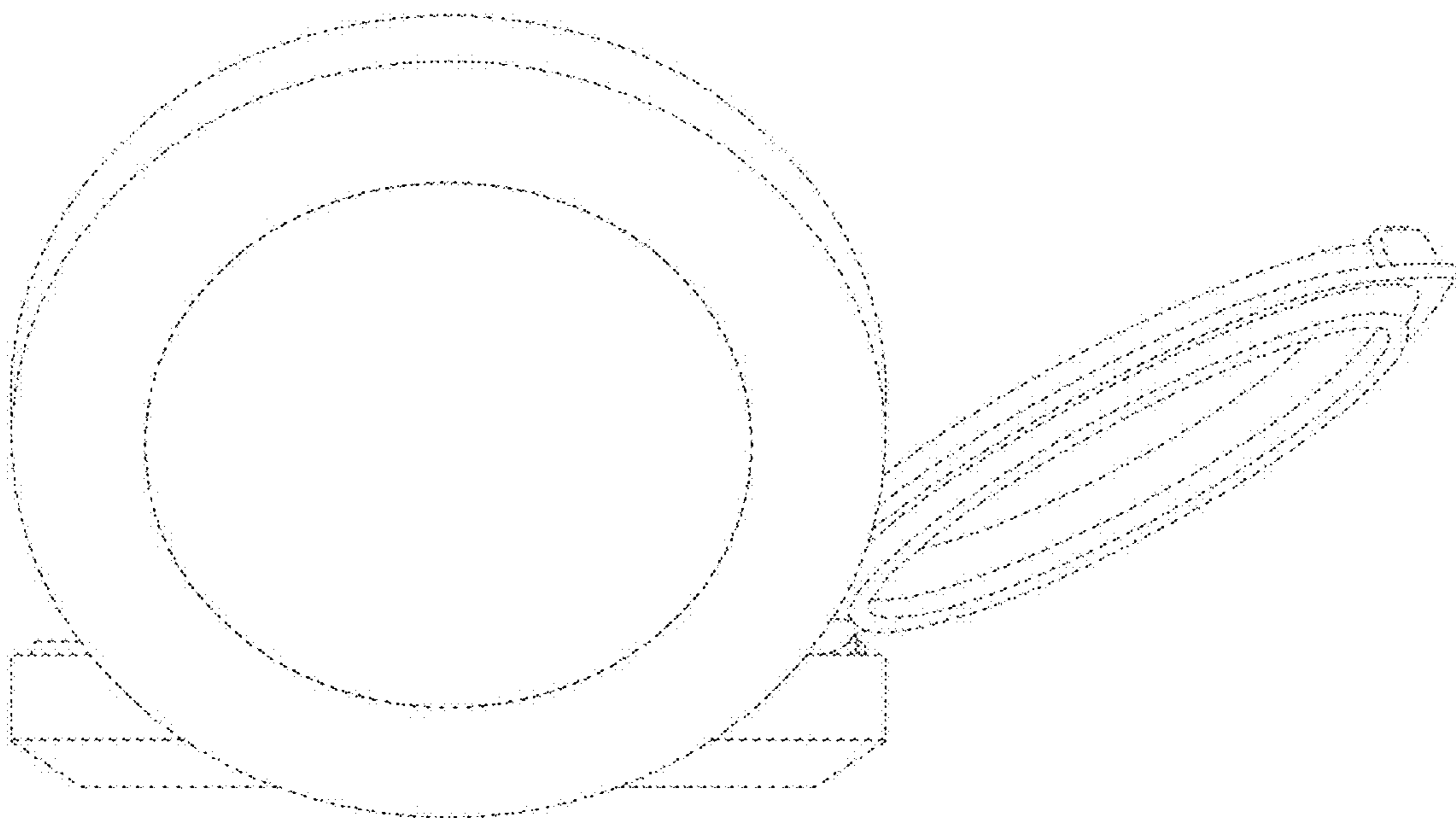

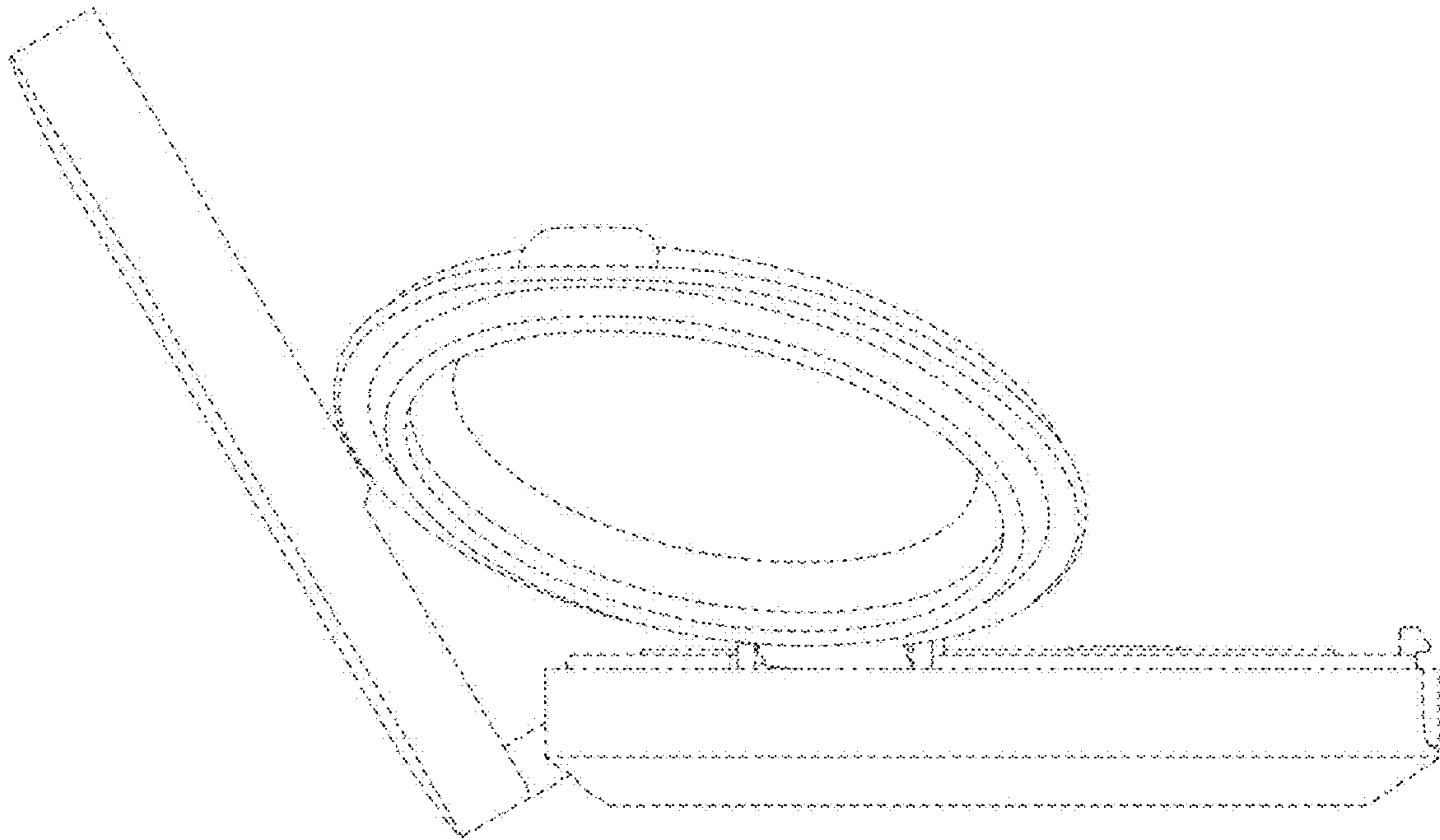

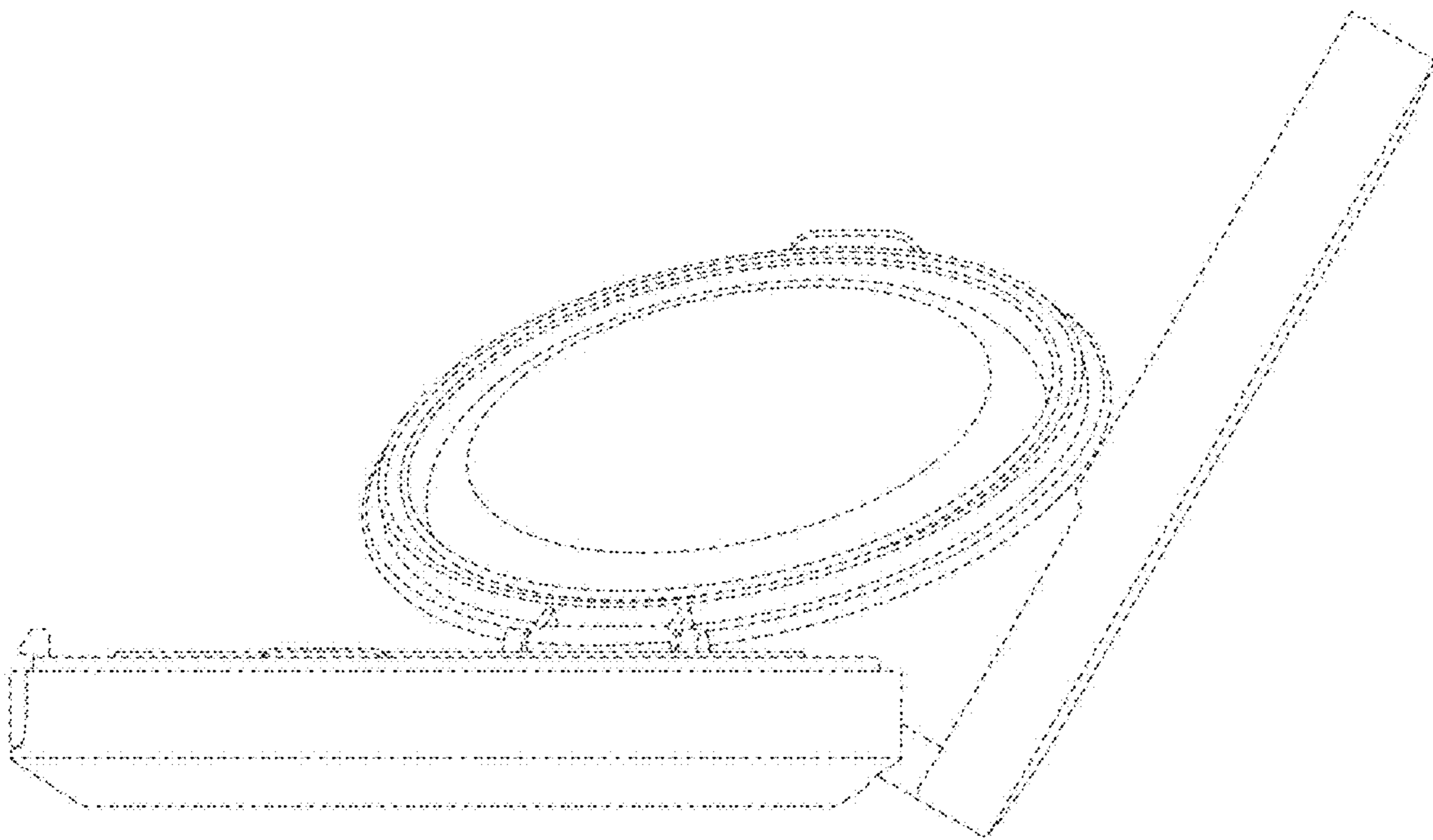

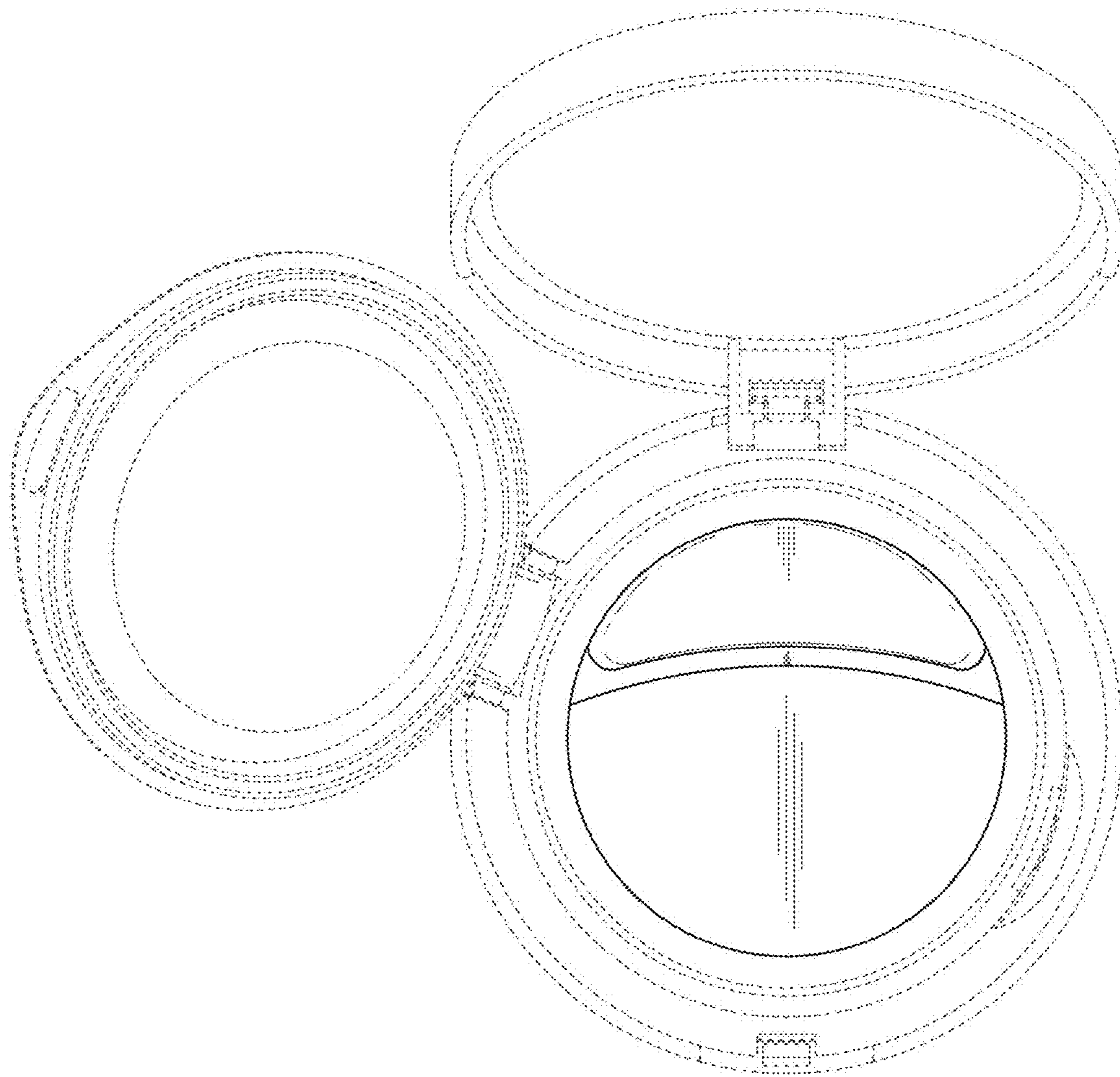

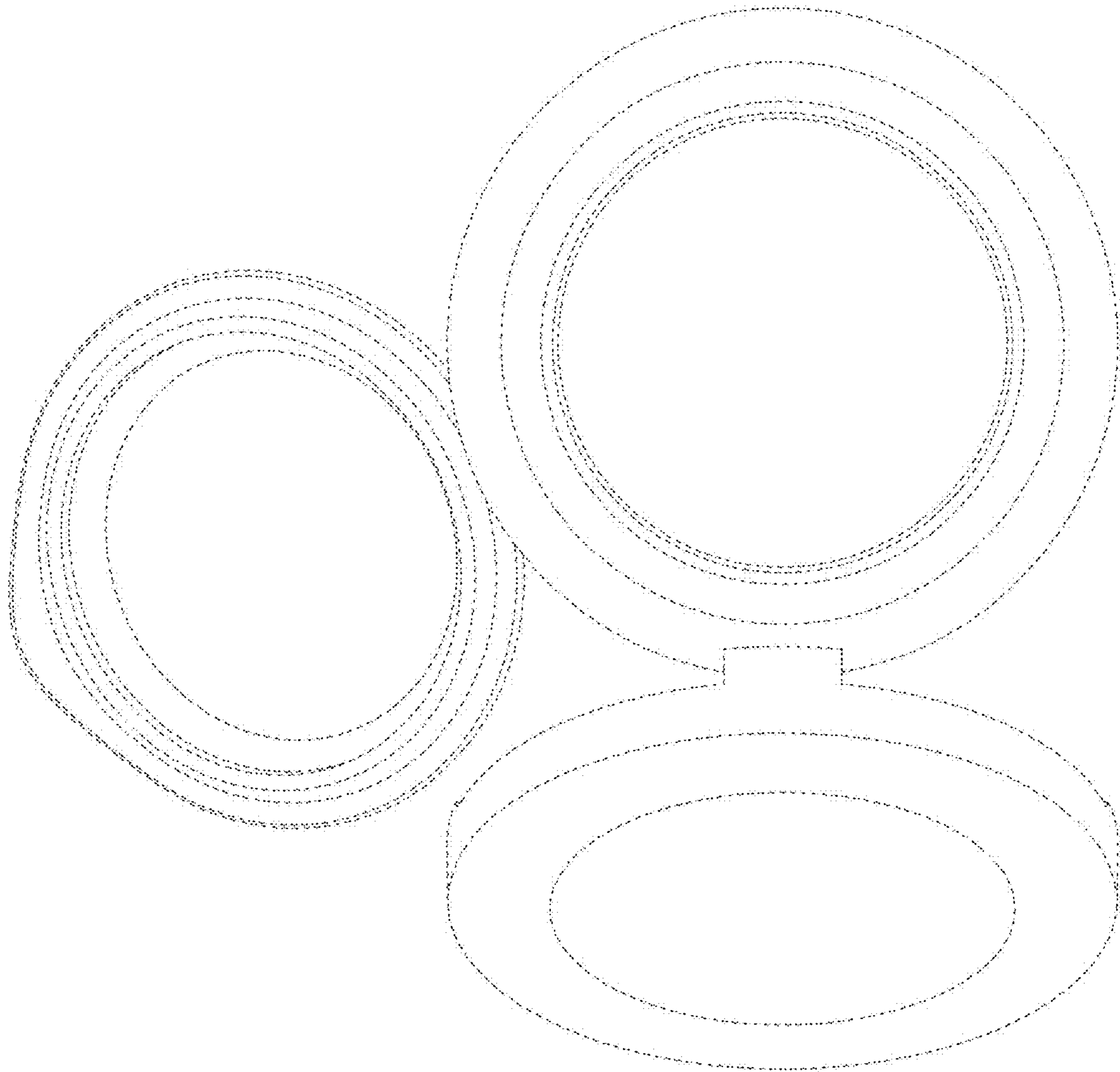
