(57) **CLAIM**

The ornamental design for a pet bed, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a pet bed showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a left-side elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a front elevational view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a top perspective view thereof, showing the fabric lifted in an alternate position; and,
FIG. 9 is a top perspective sectional view taken on line 9-9 on FIG. 1.

The evenly spaced broken lines shown in the figures represent stitching and form part of the claimed design. The dash-dot broken lines shown in the figures represent environmental subject matter and form no part of the claimed design.

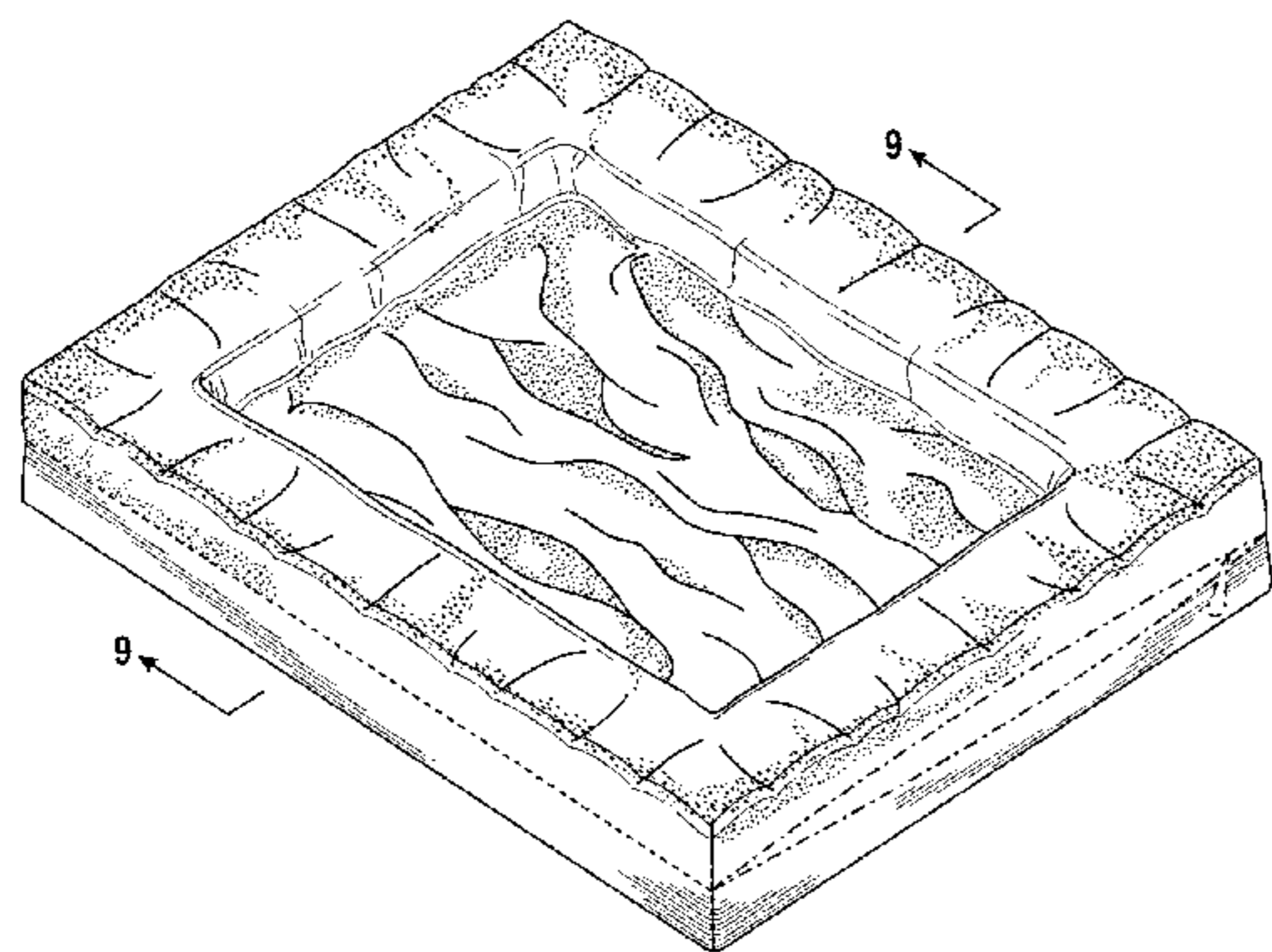
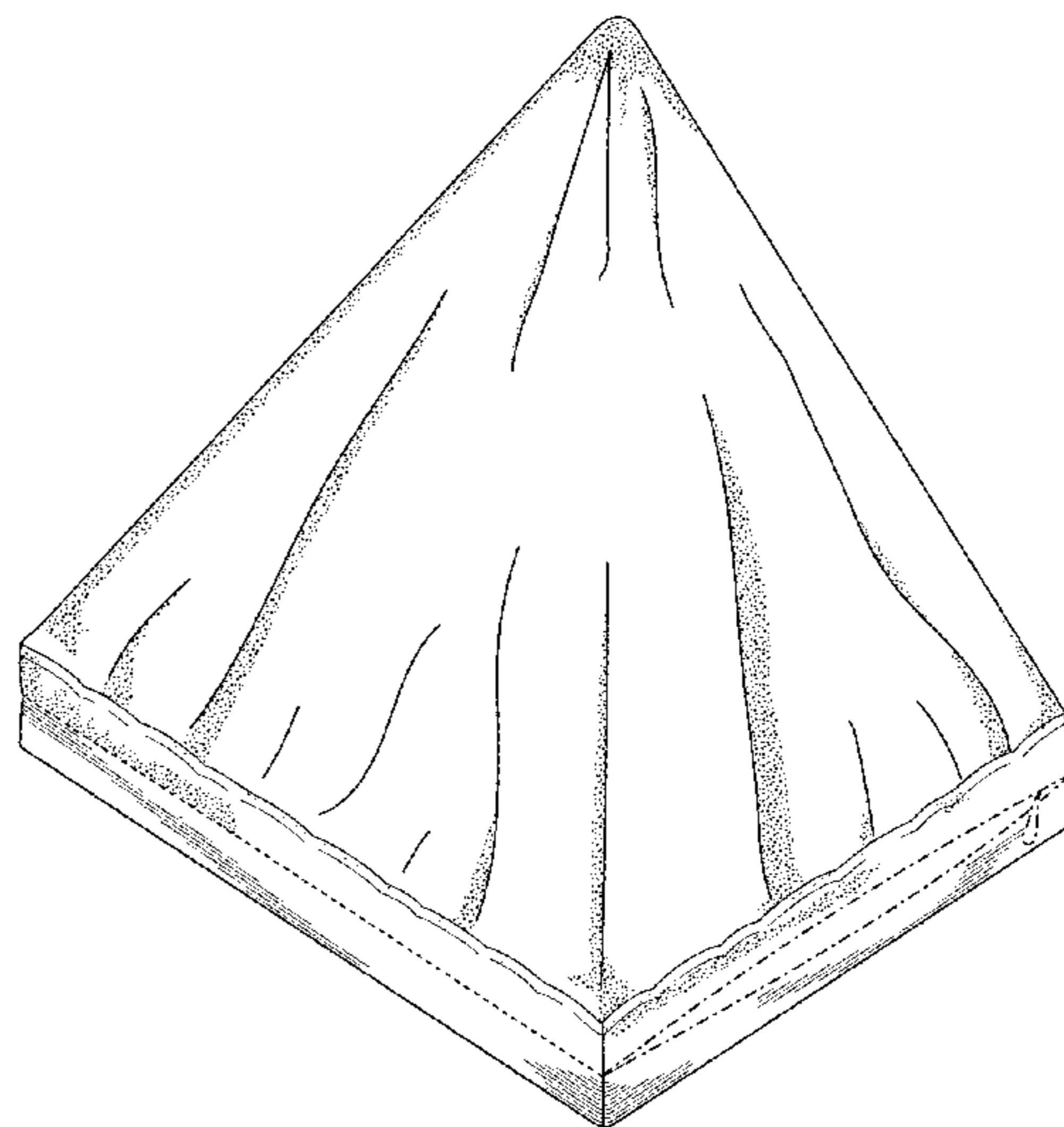

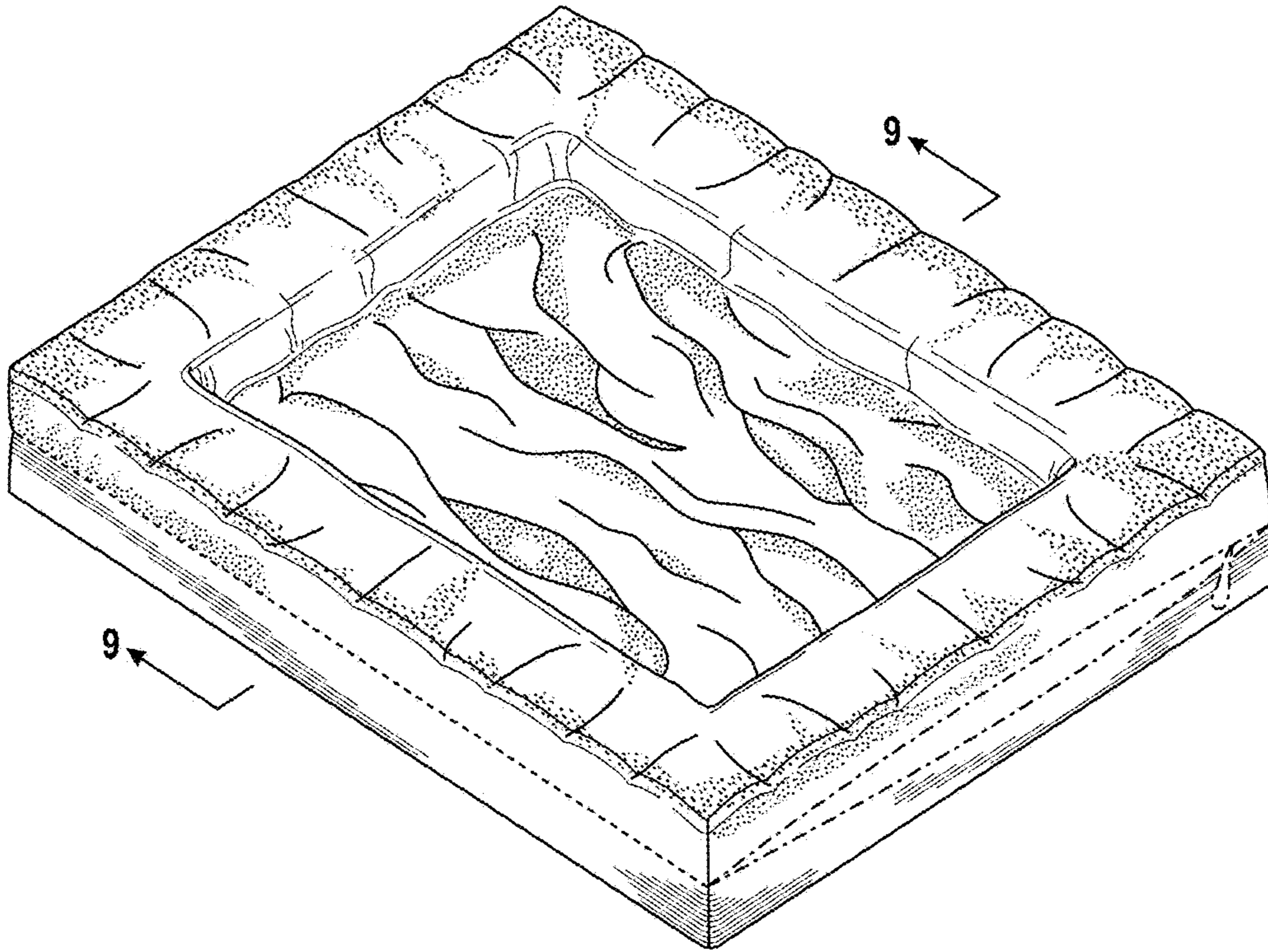

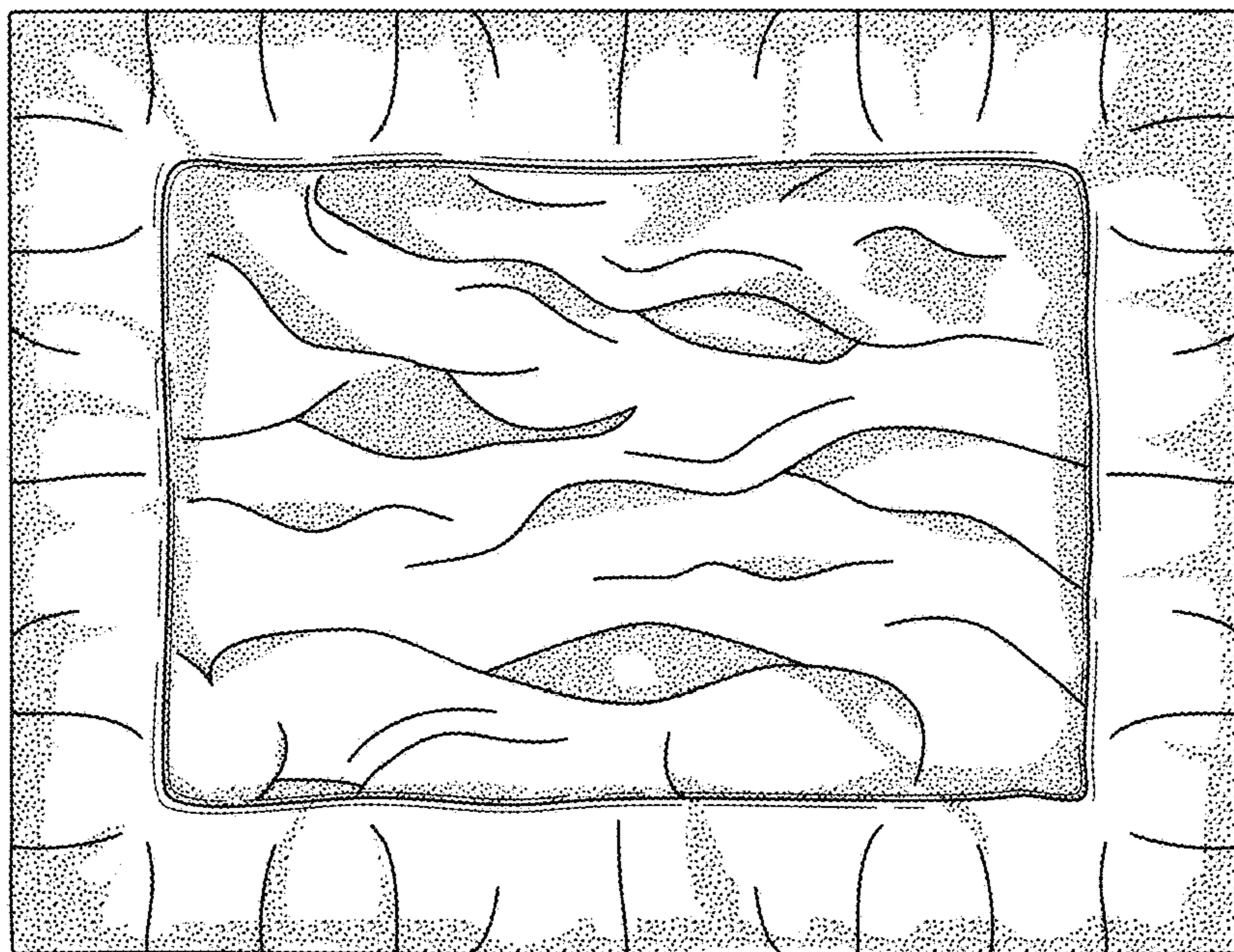

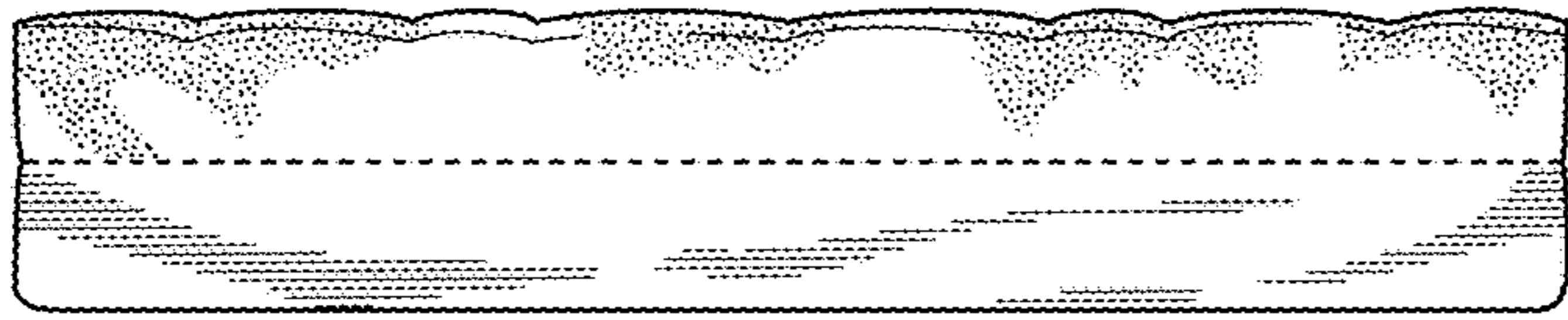

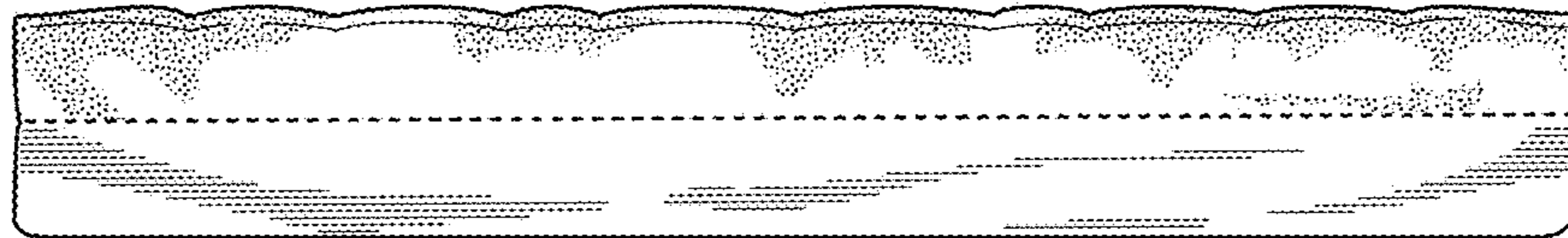

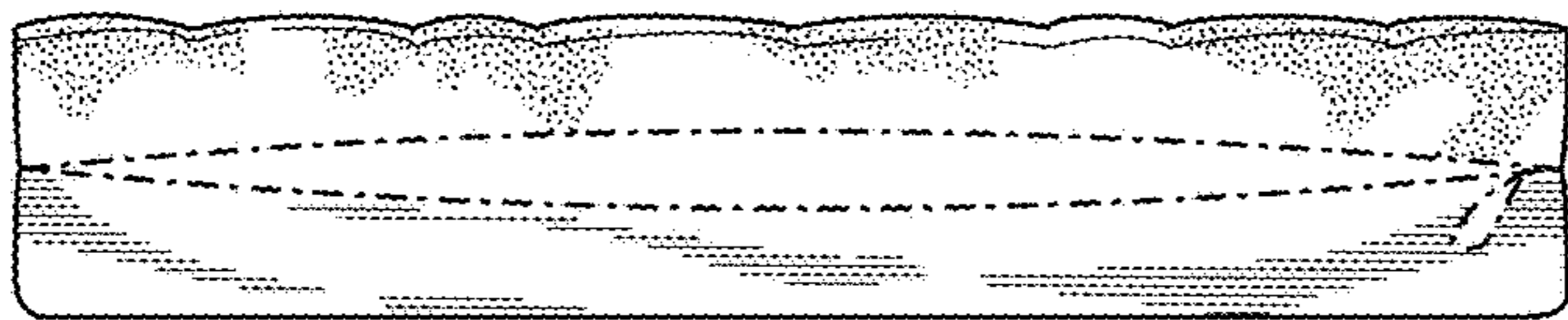

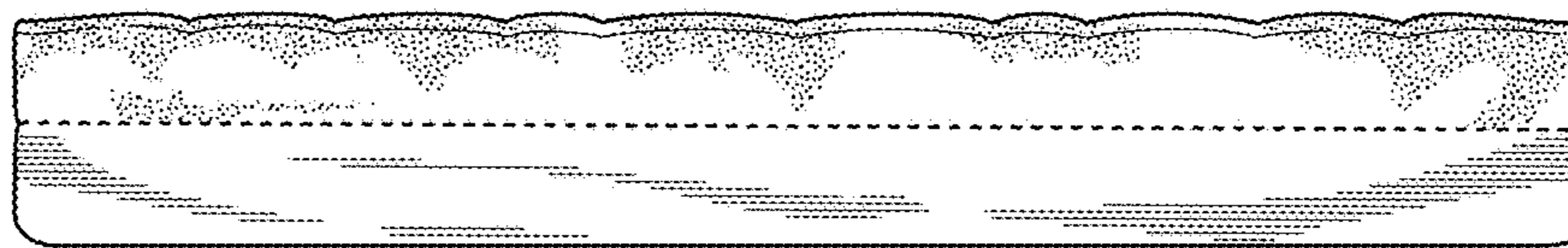

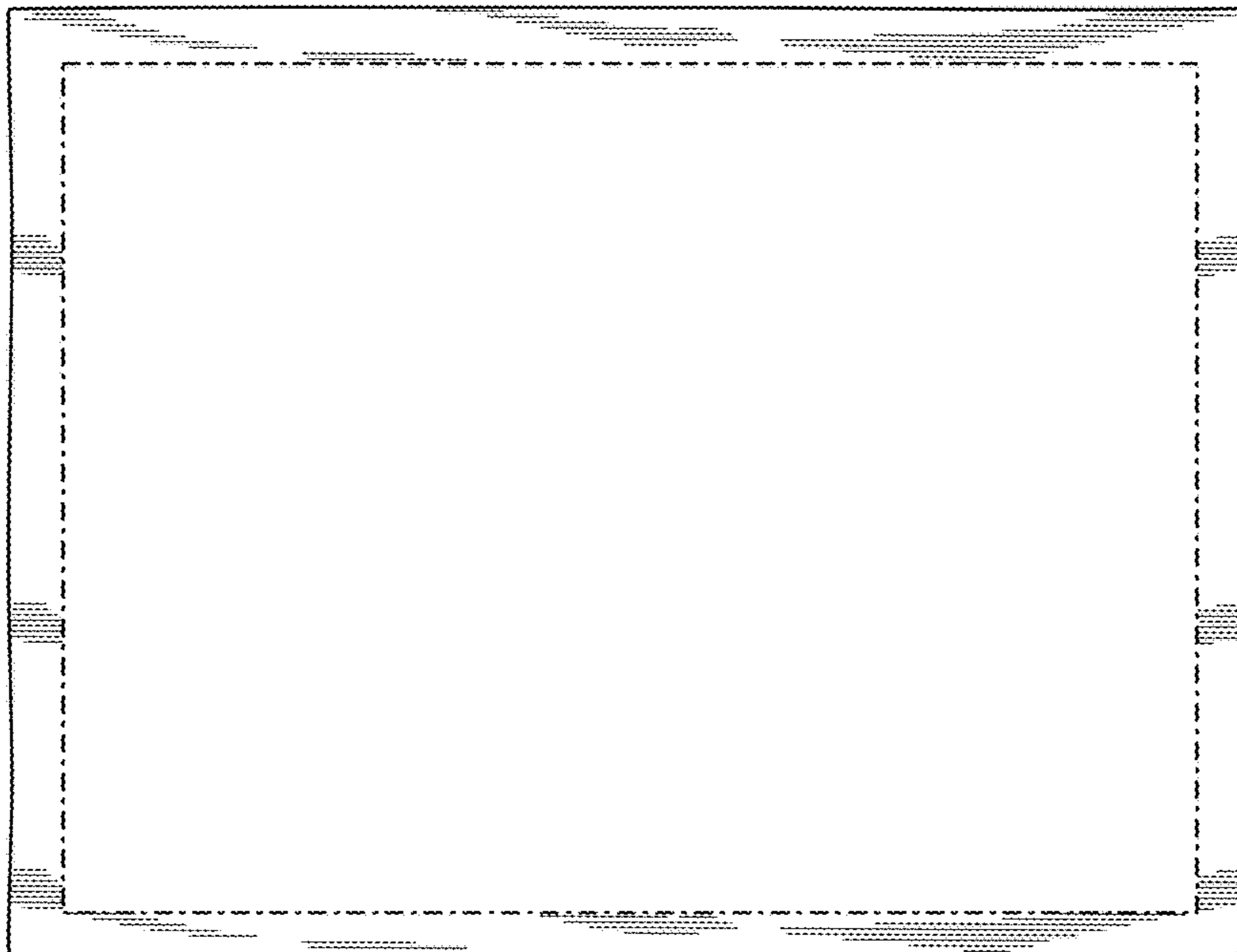

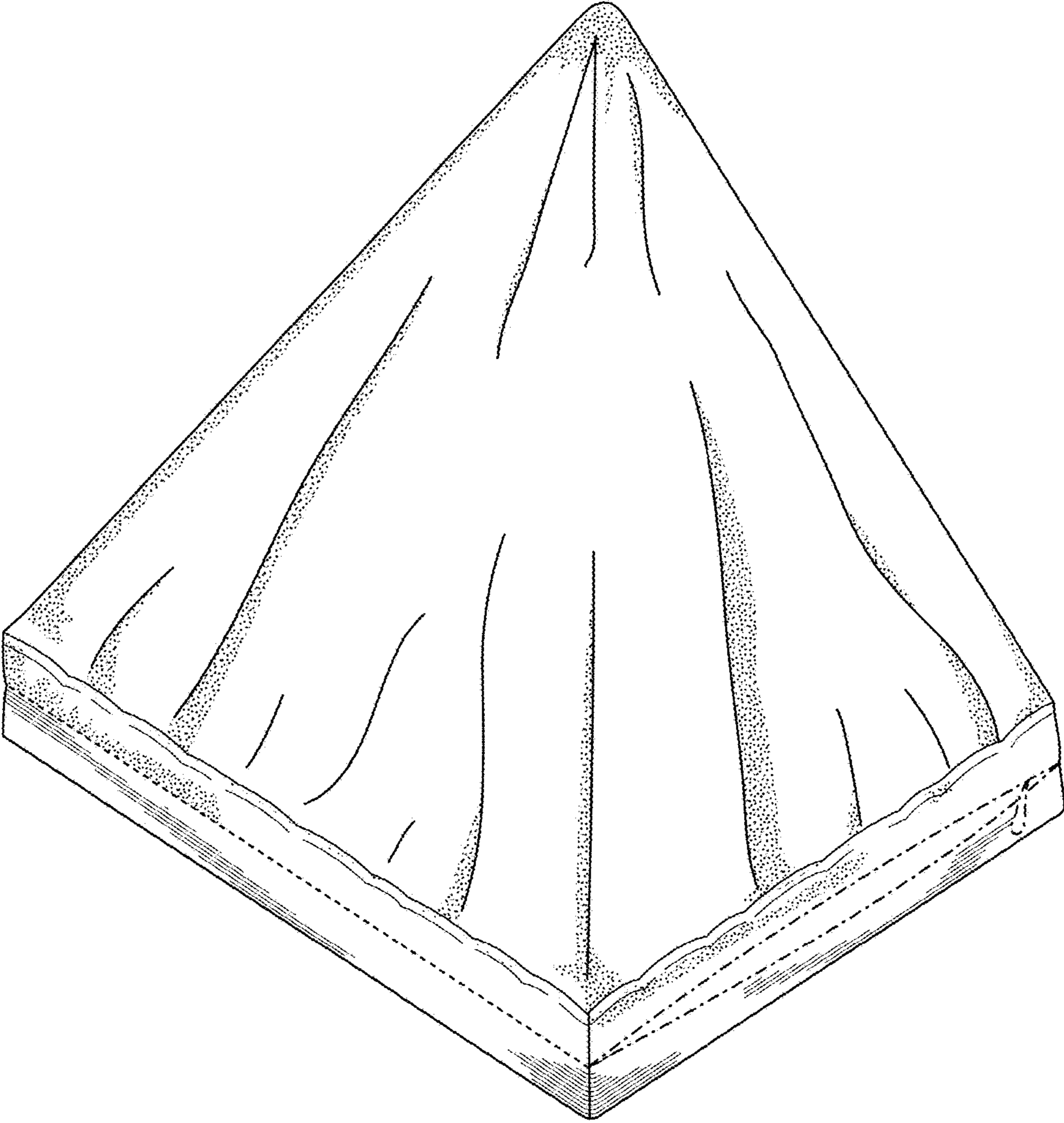

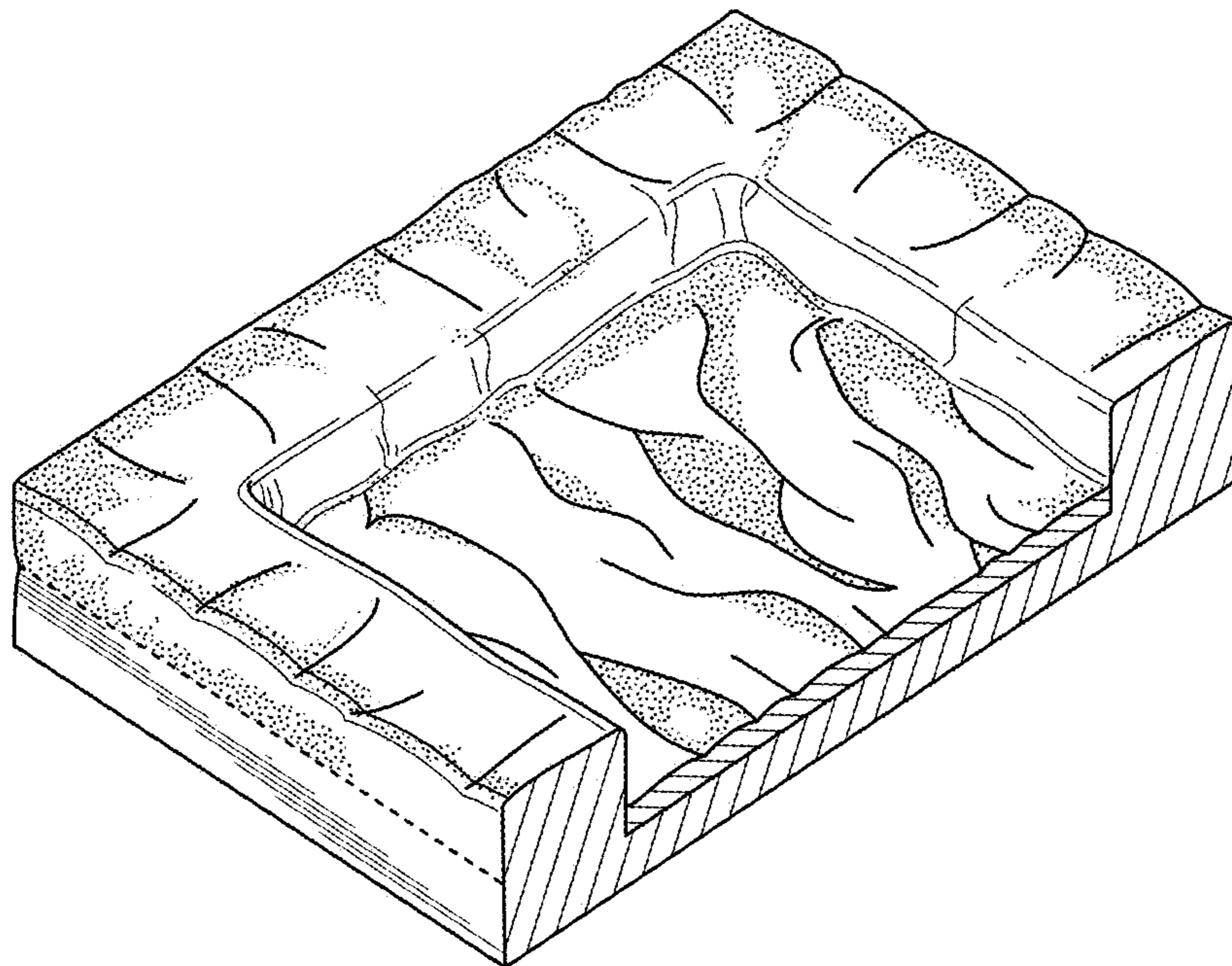
