The ornamental design for a jacket with scalloped shoulder regions, as shown and described.

**DESCRIPTION**

FIG. 12 is a right side view of the second embodiment thereof;

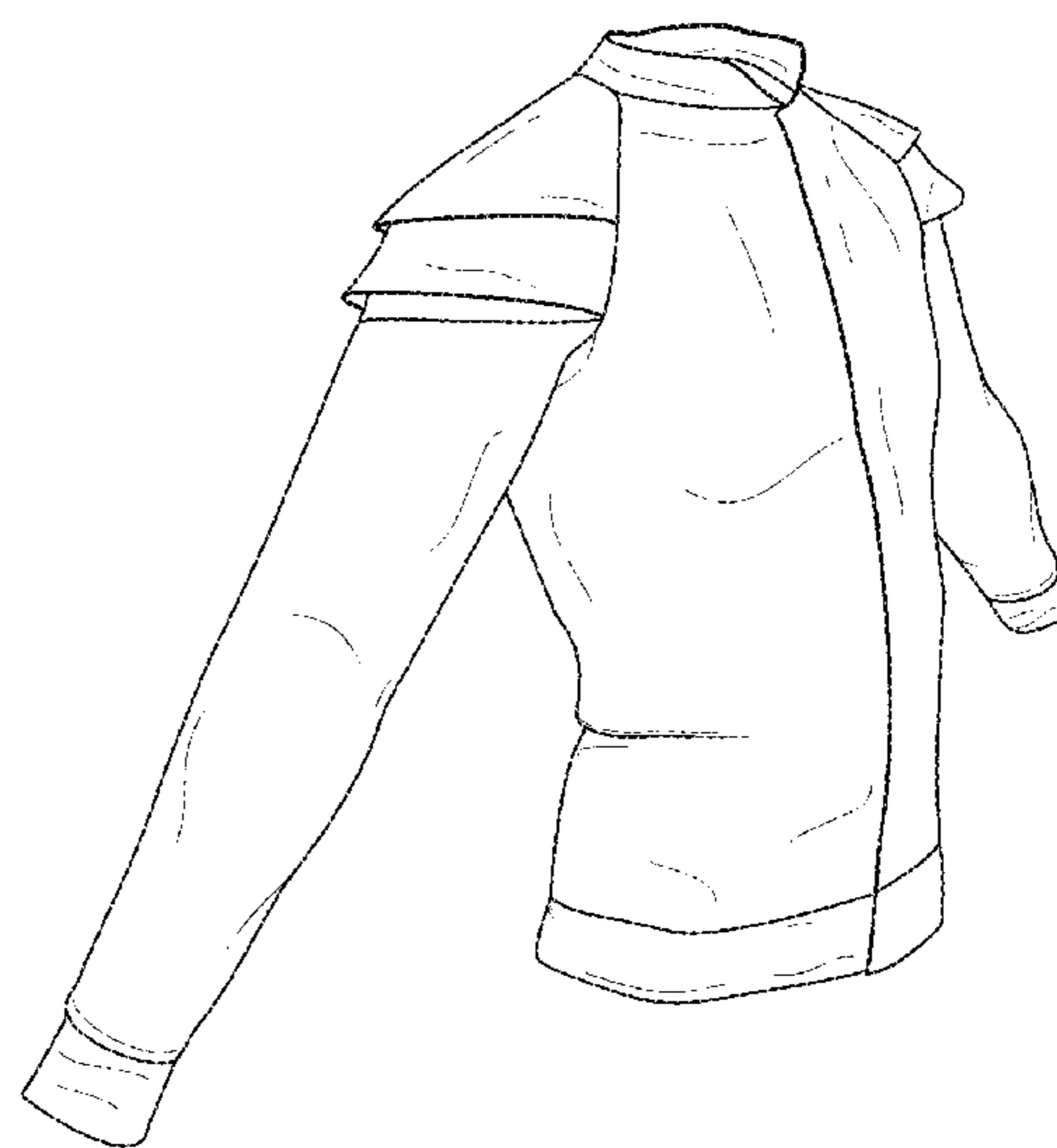
FIG. 13 is a left side view of the second embodiment thereof;

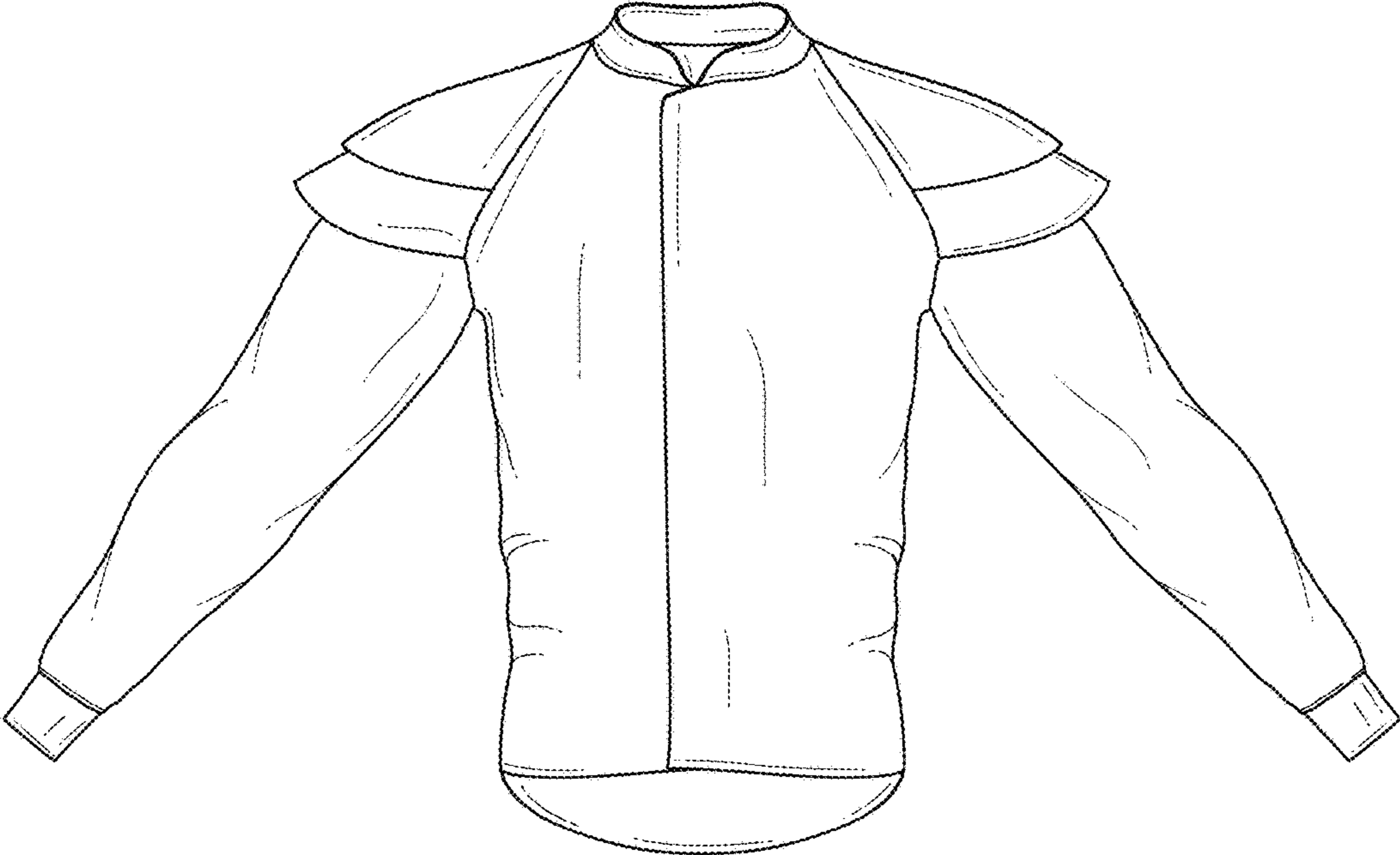

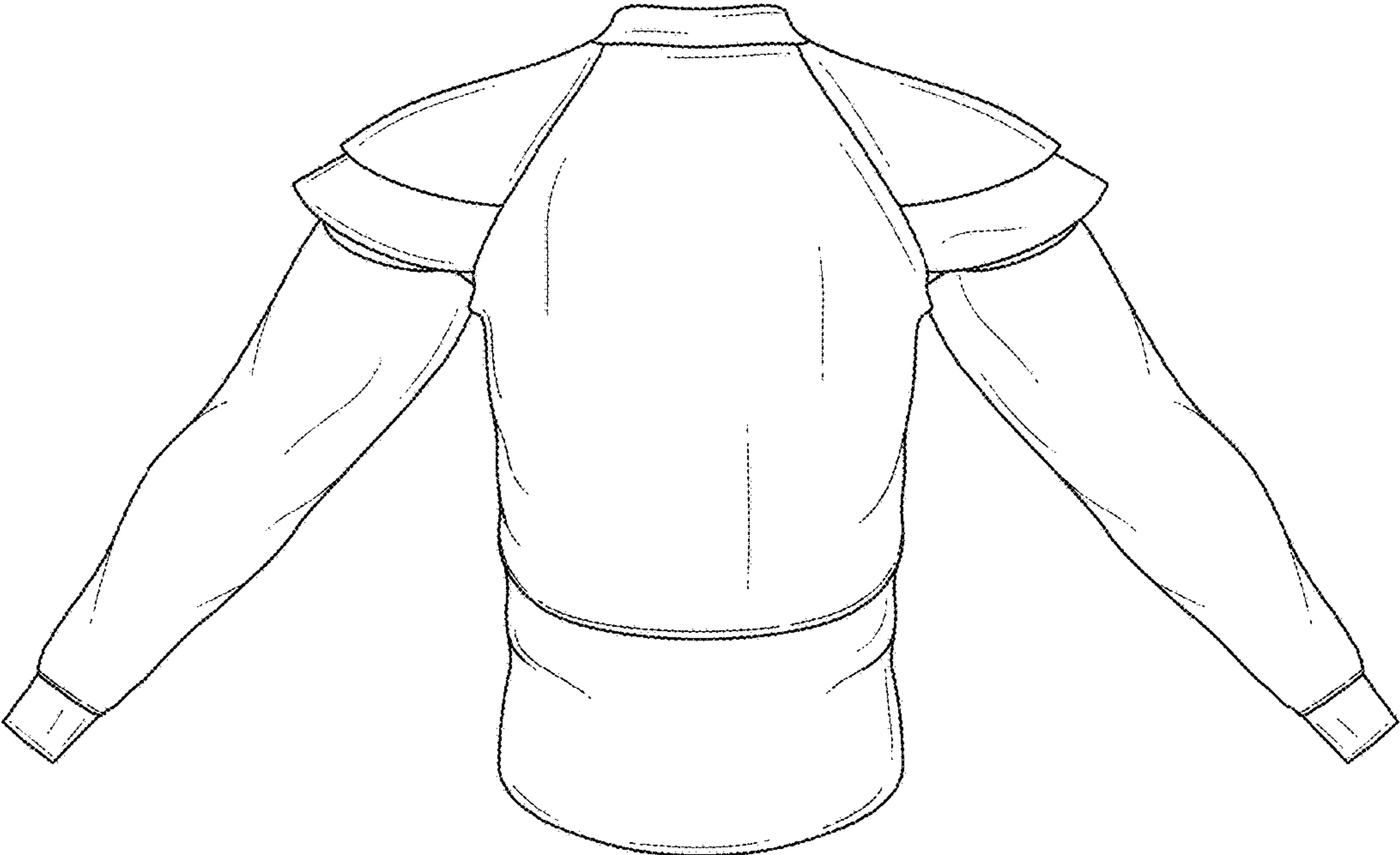

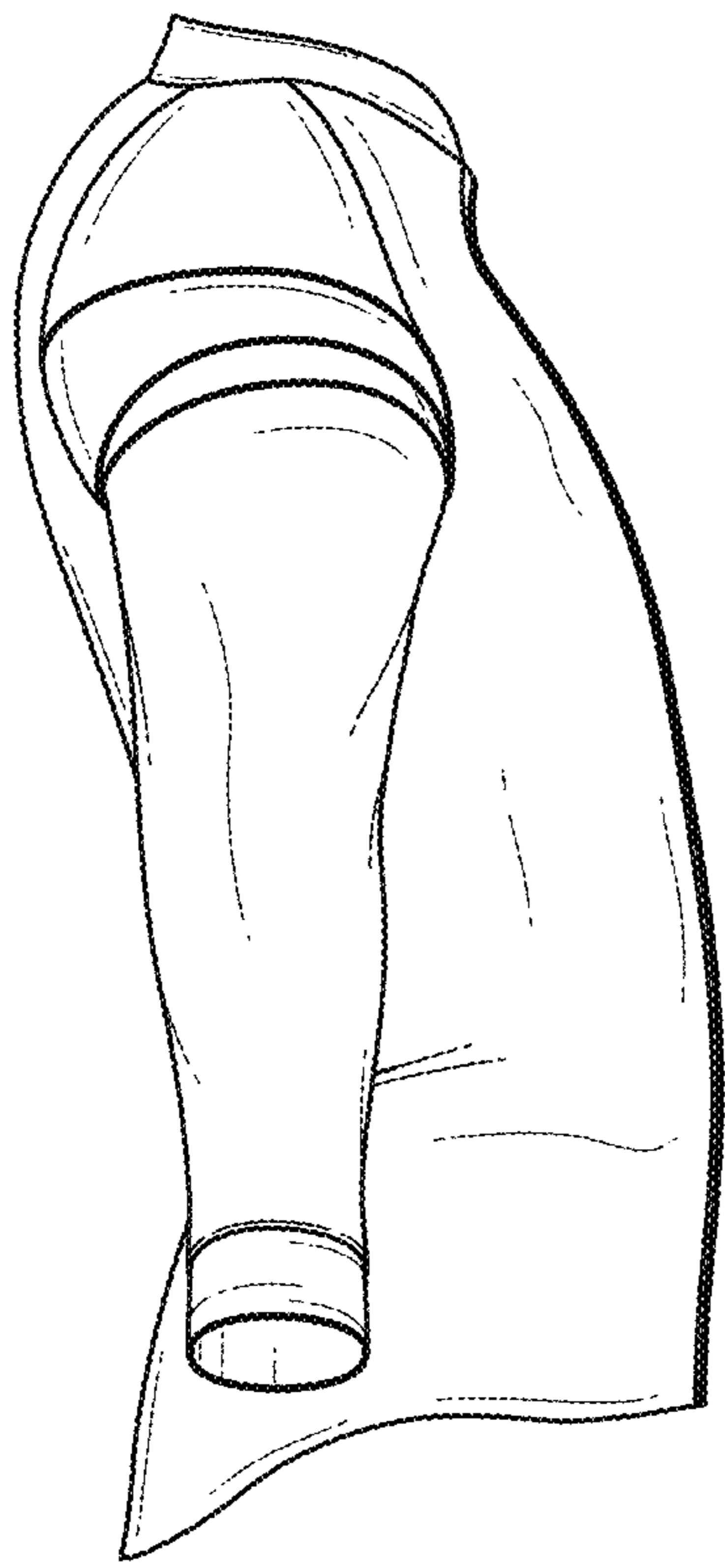

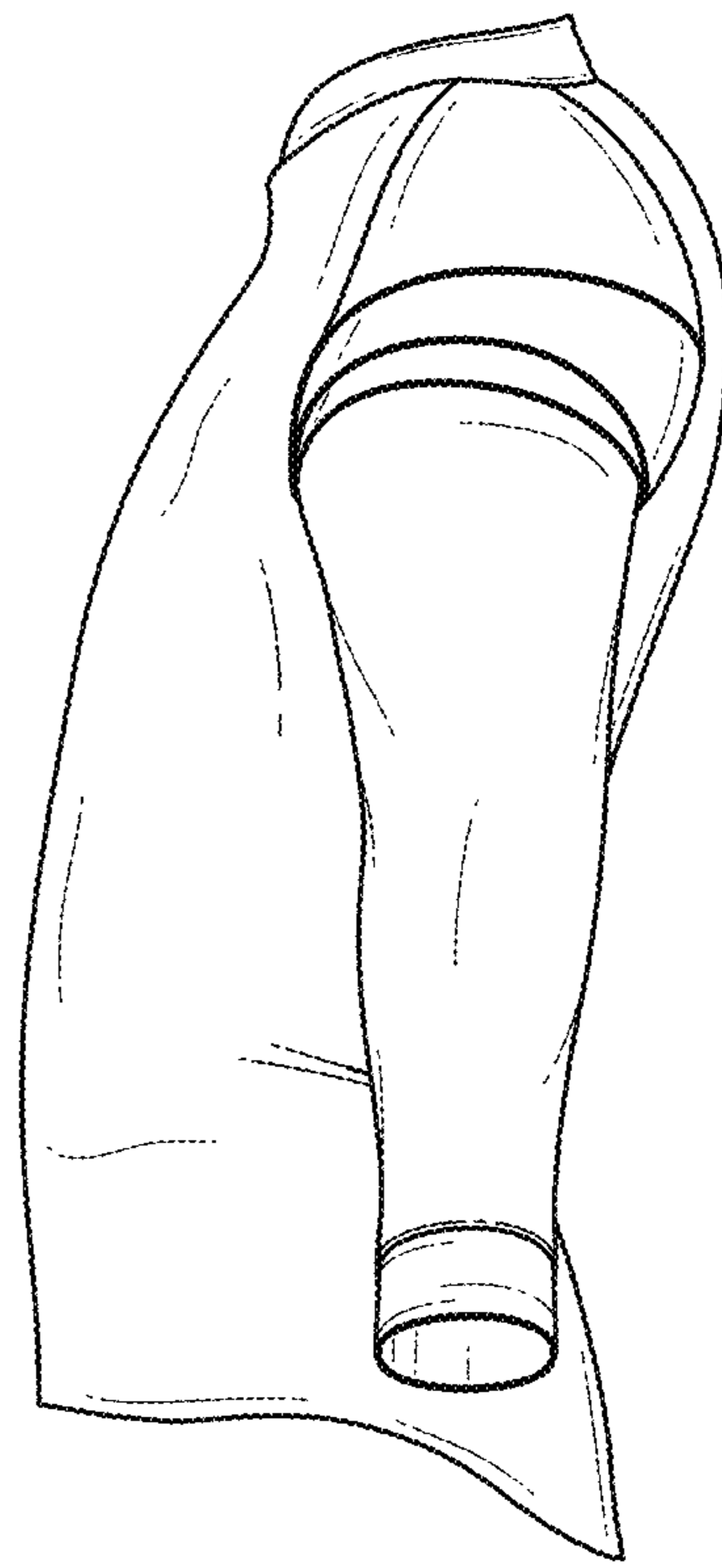

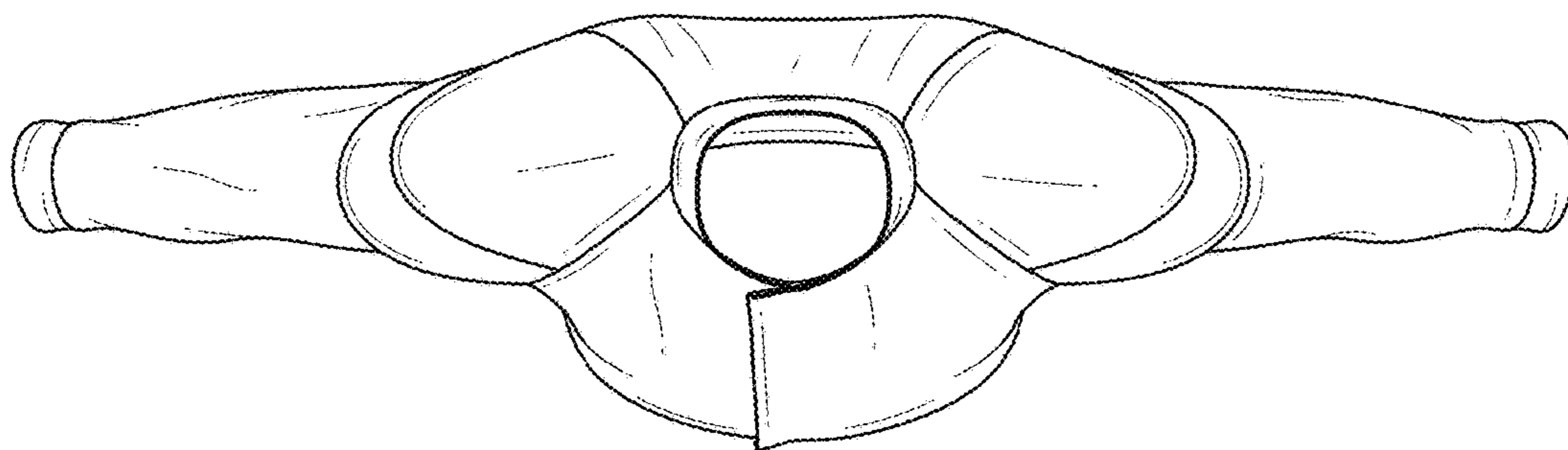

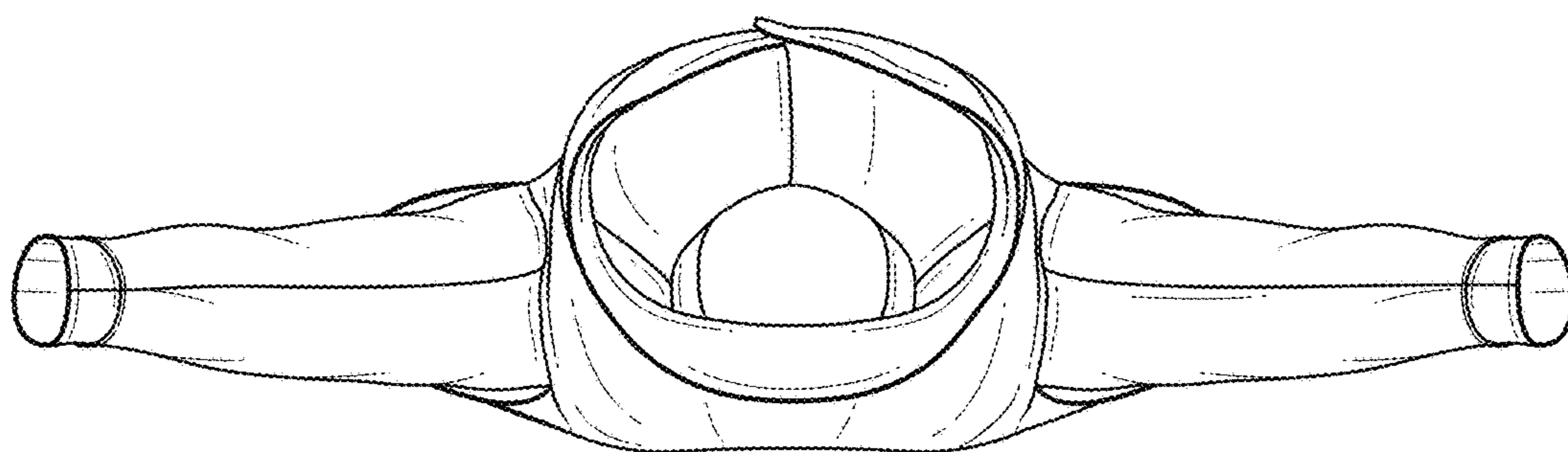

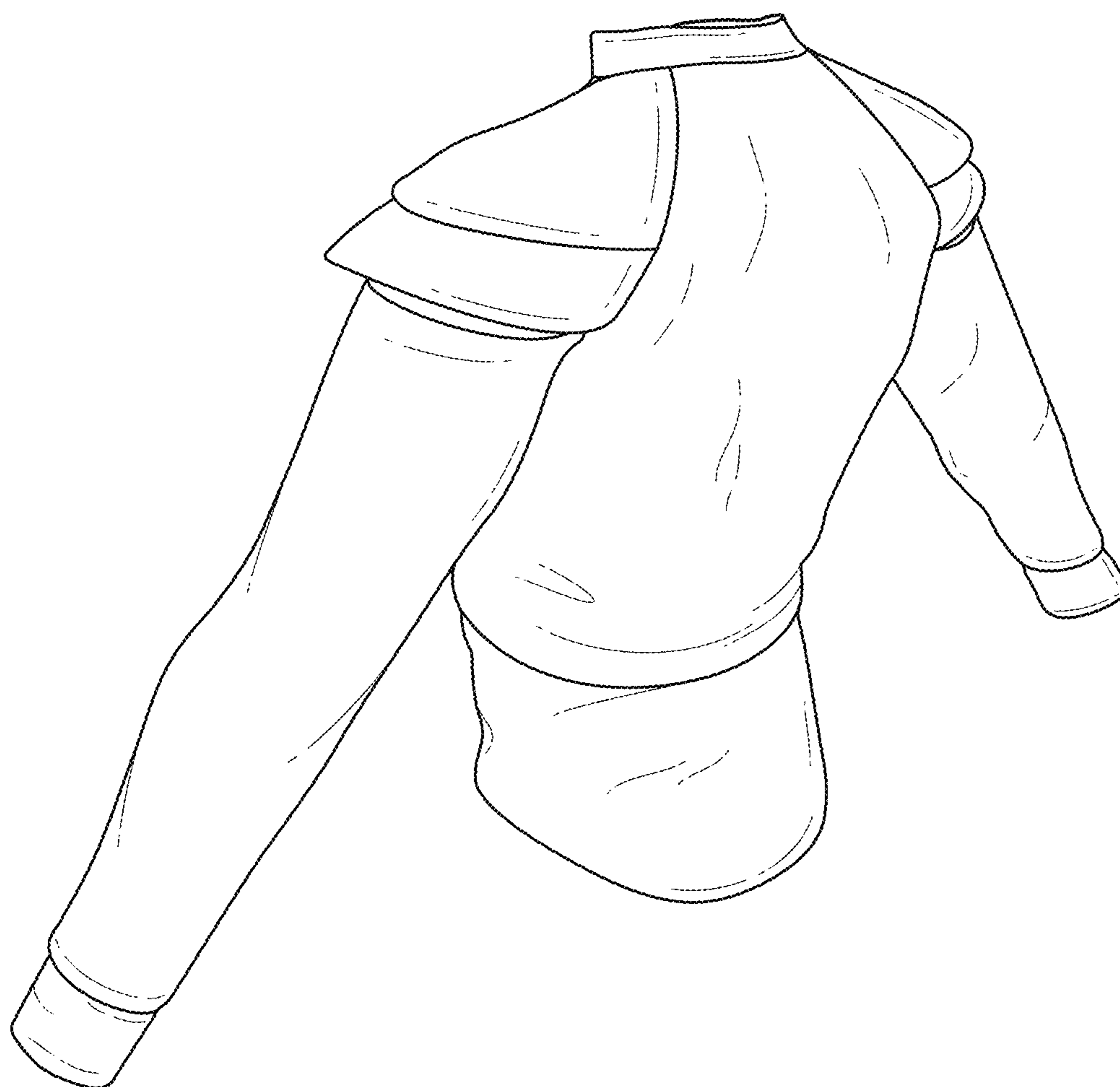

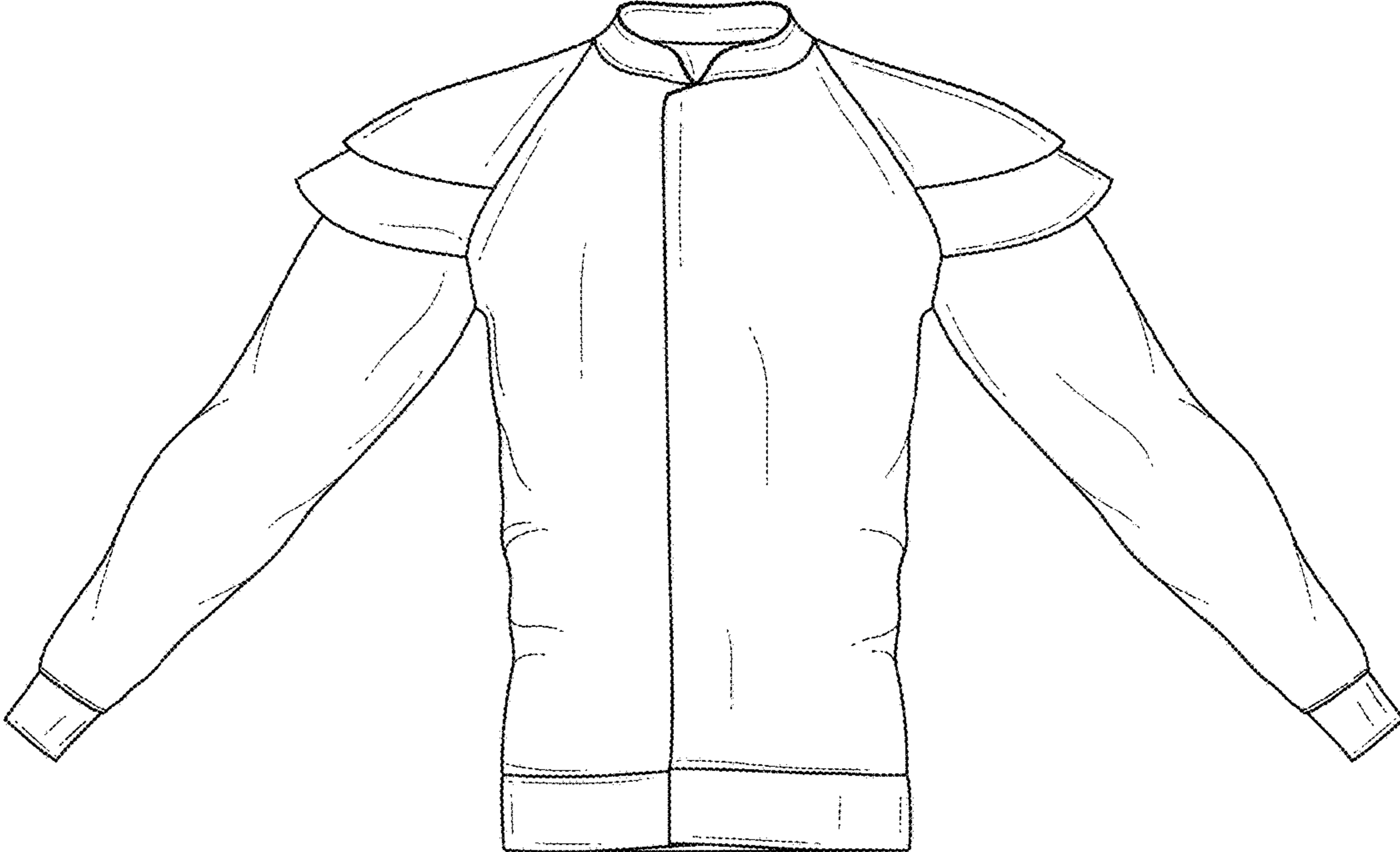

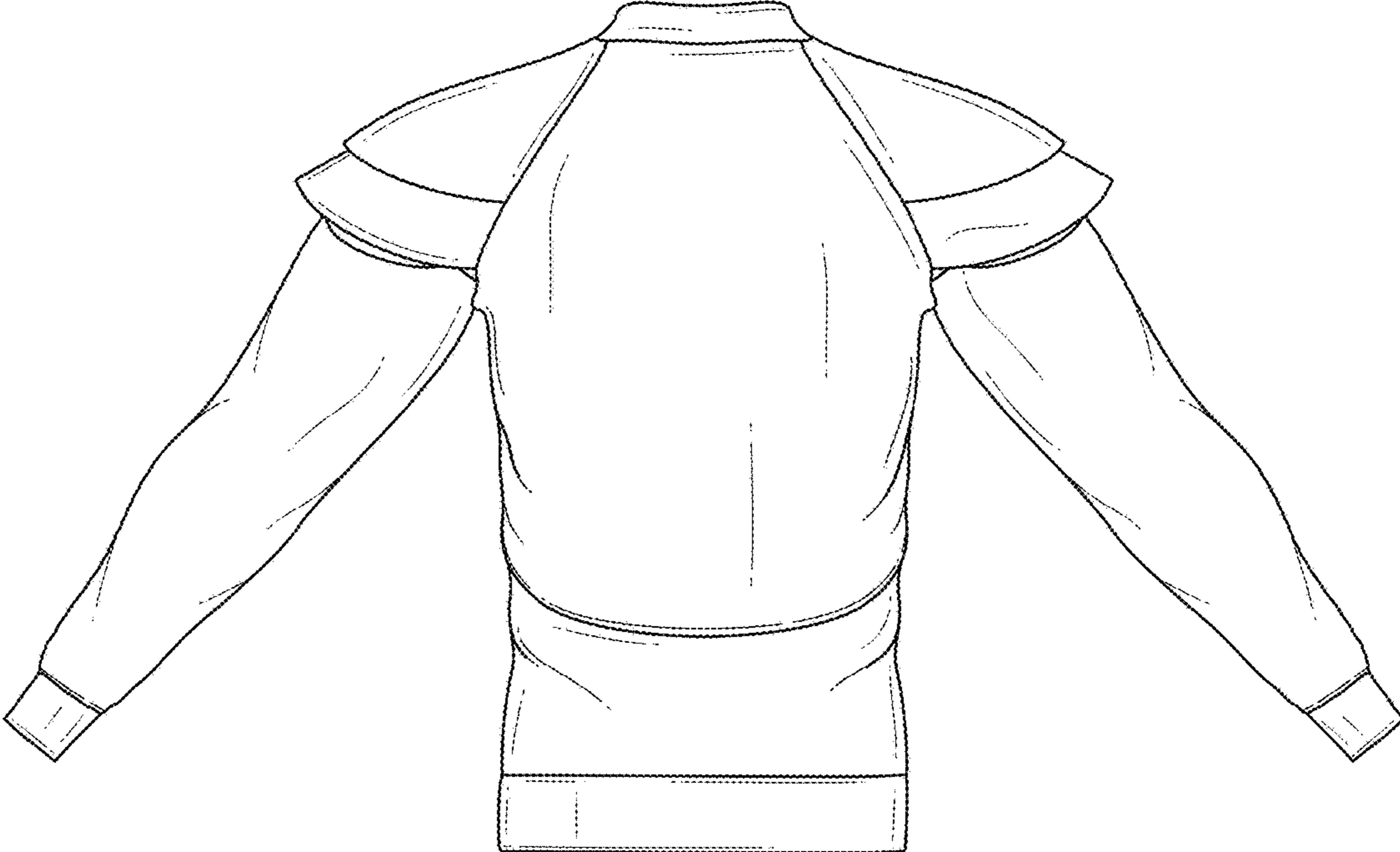

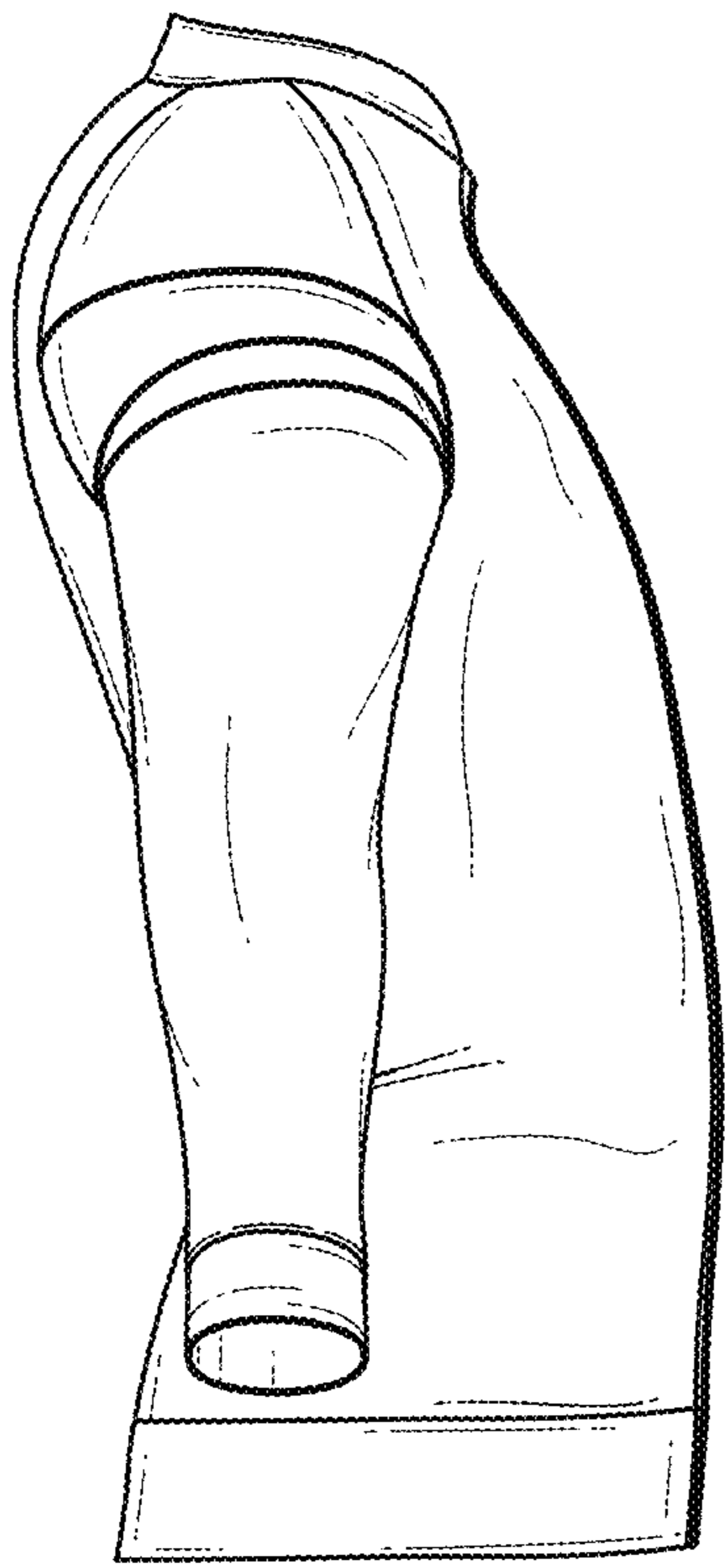

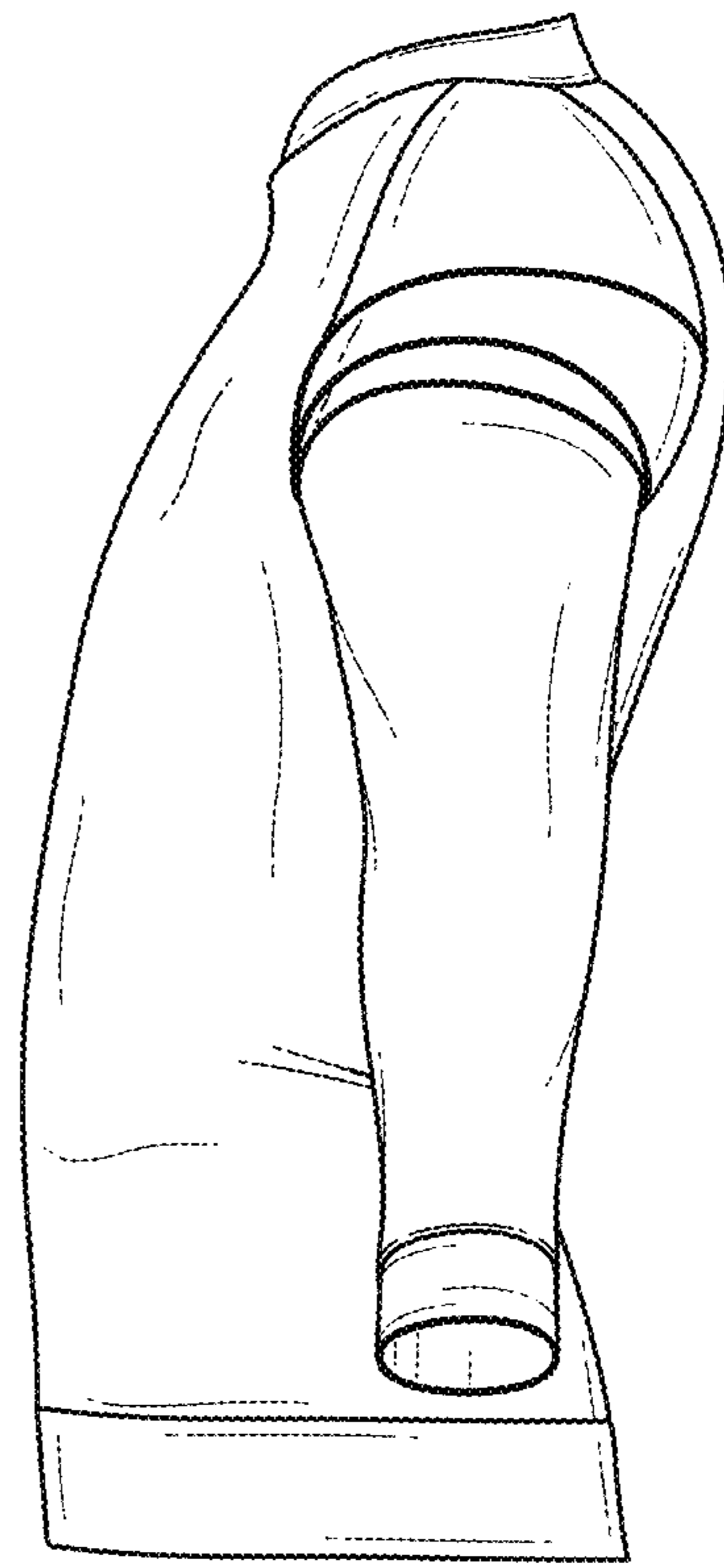

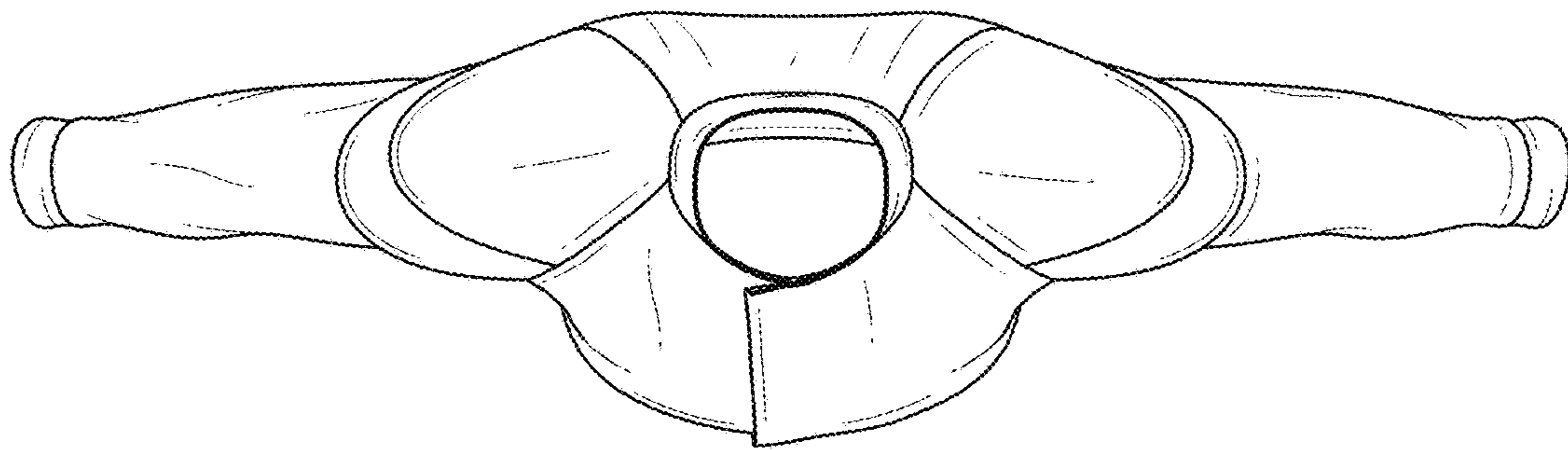

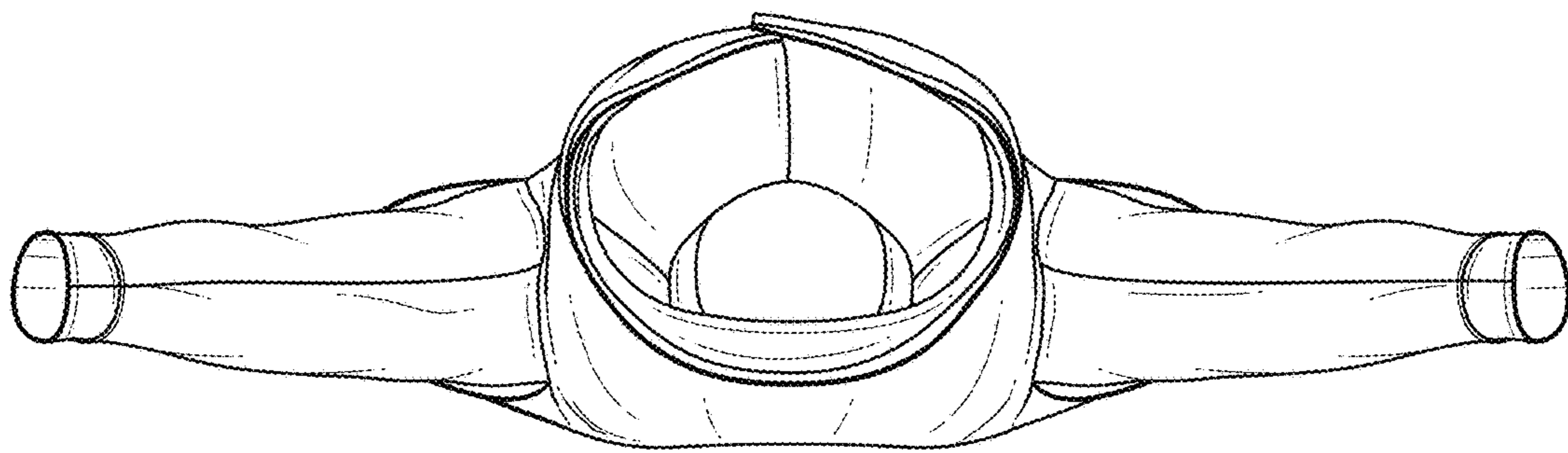

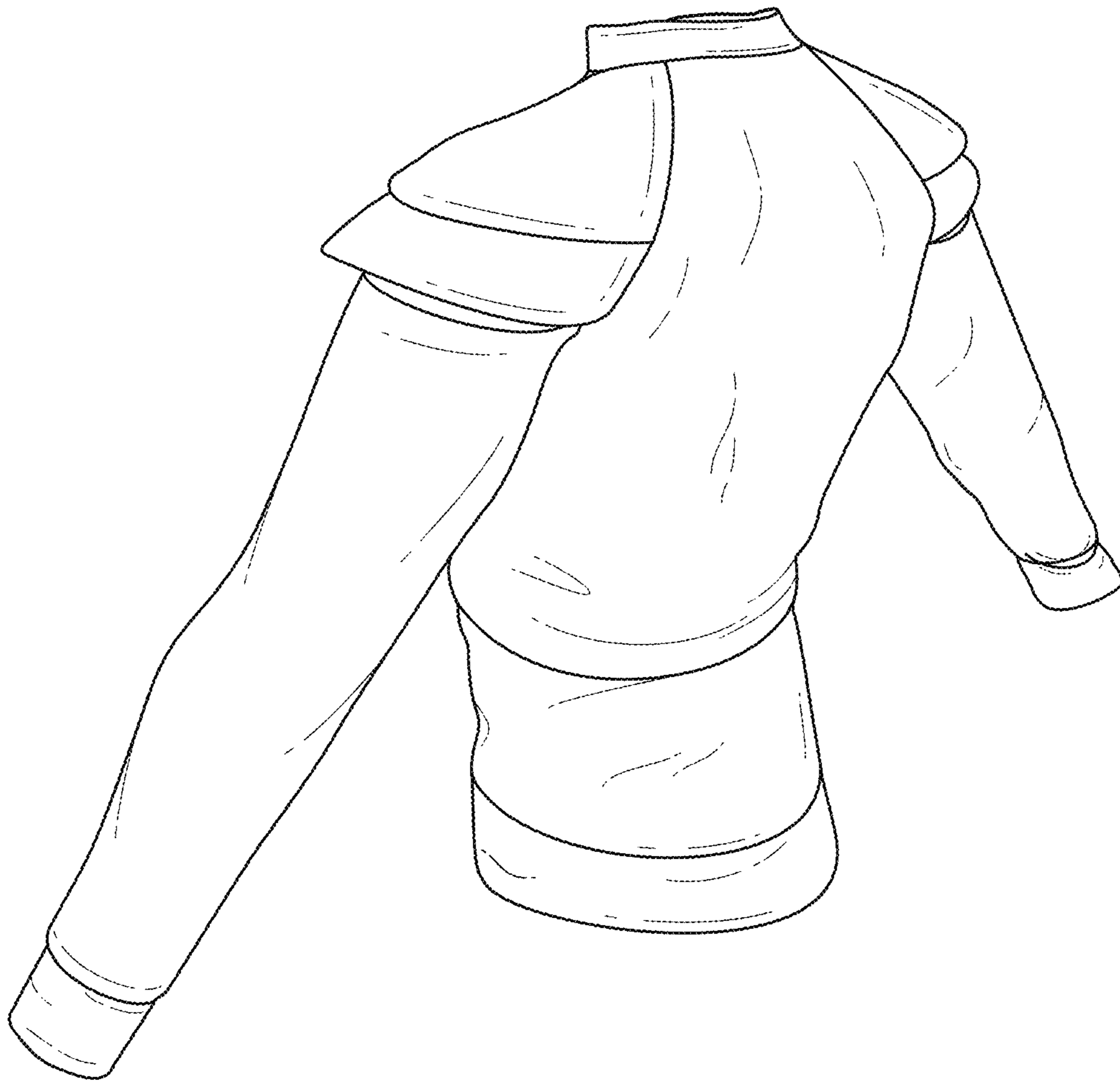
