The even-length broken lines shown in the drawings are directed to environment and form no part of the claimed design.

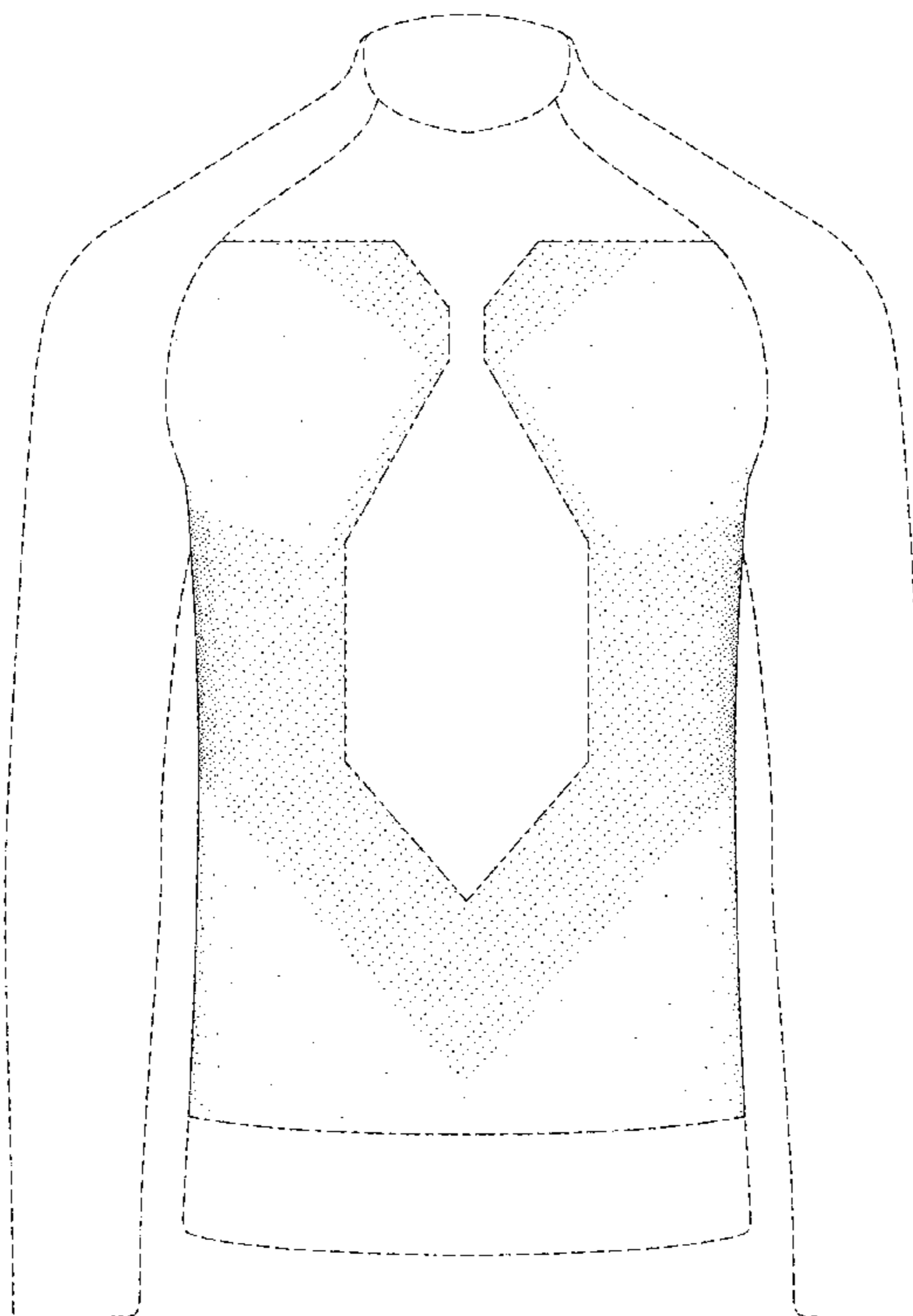

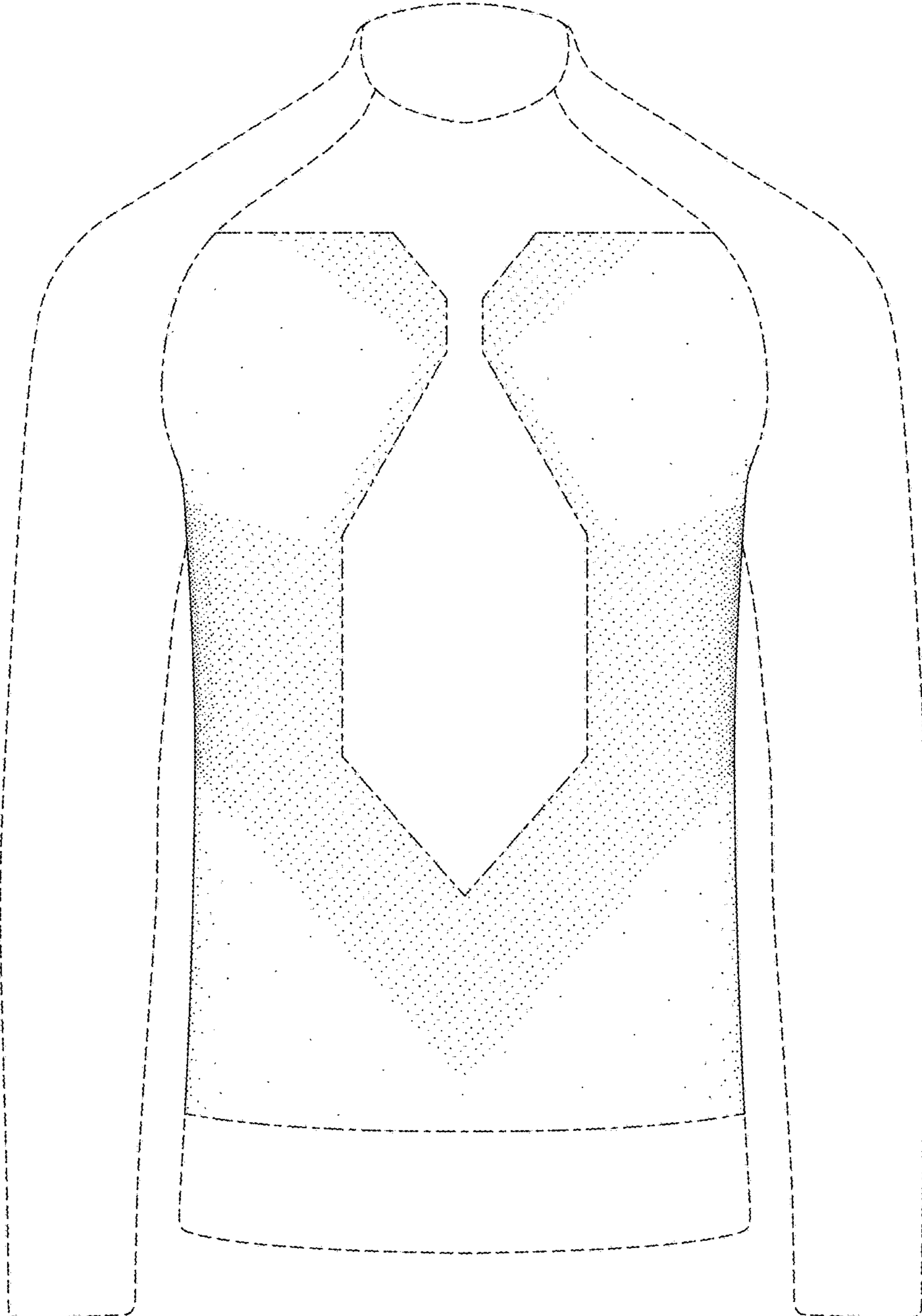

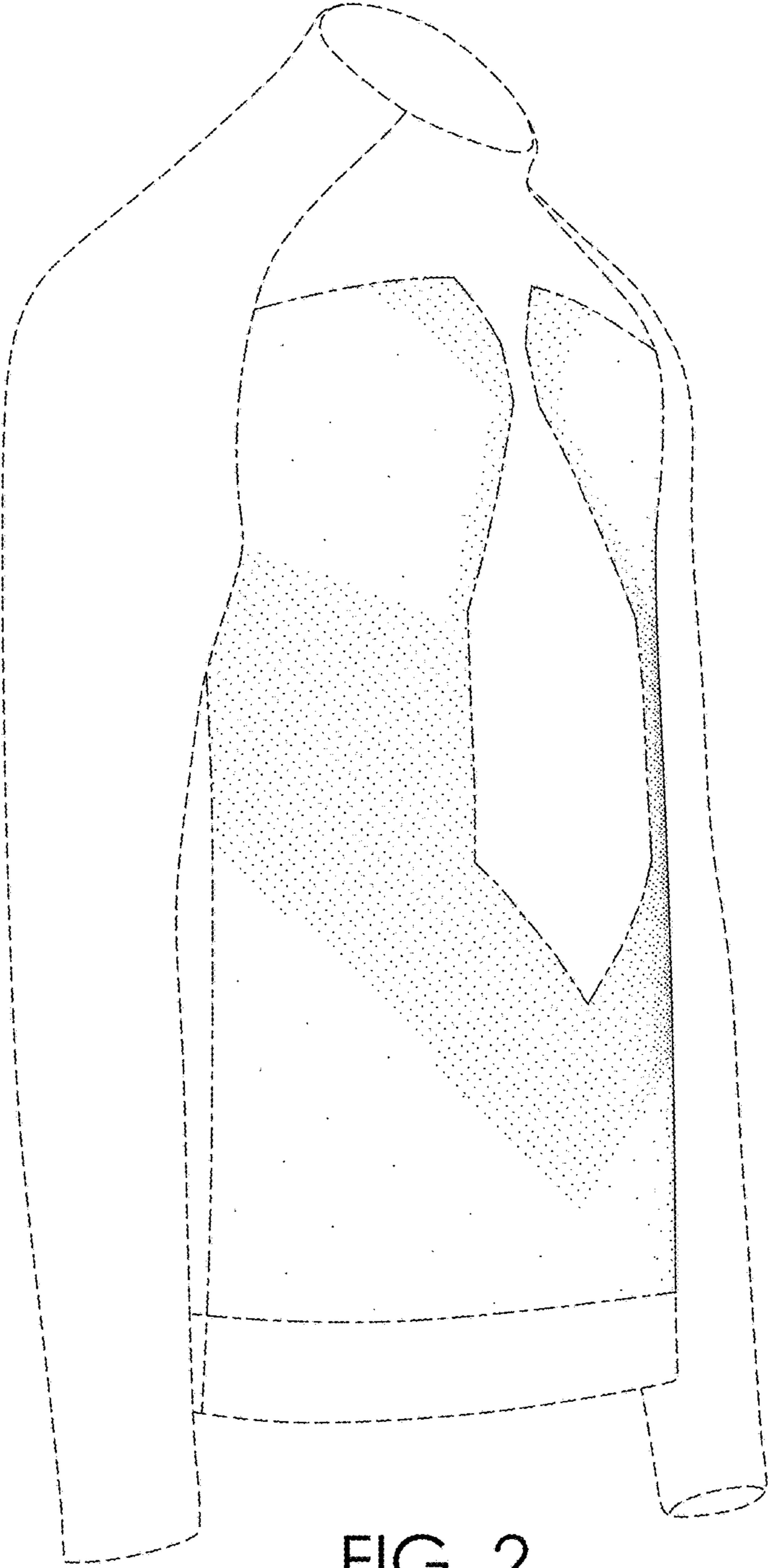

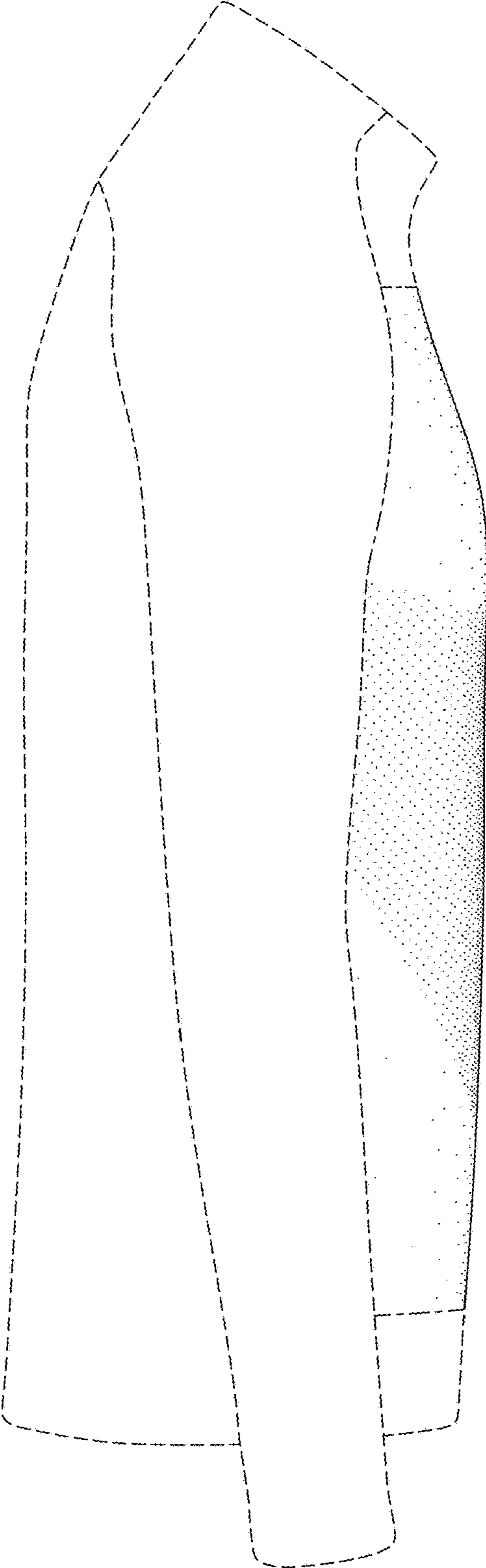

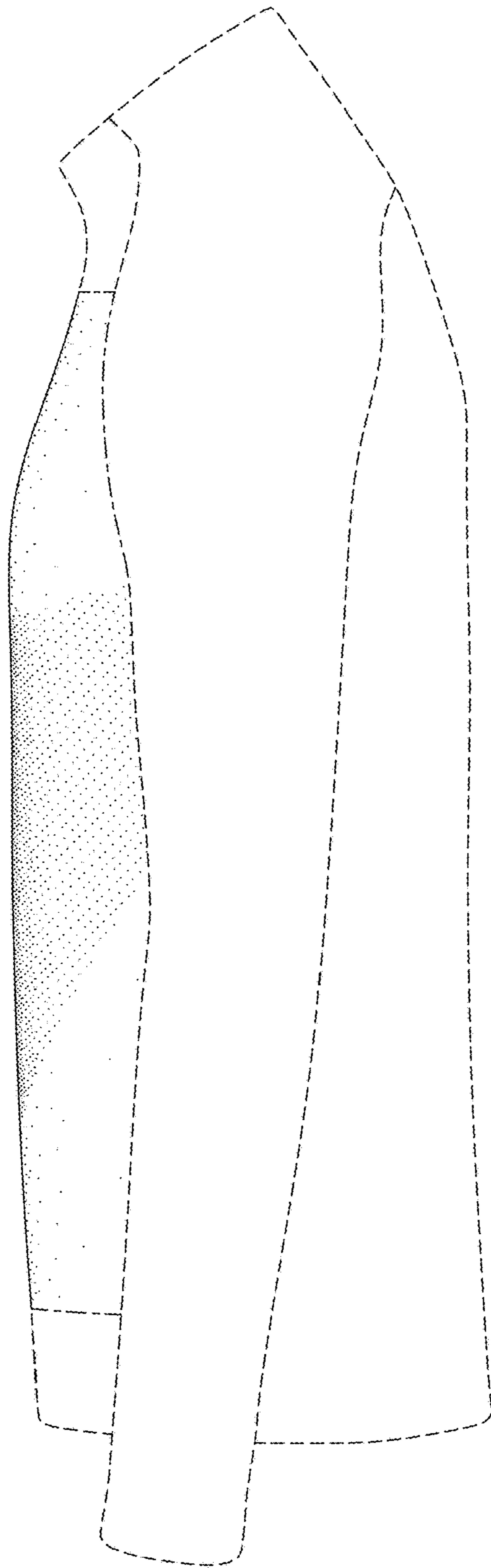
