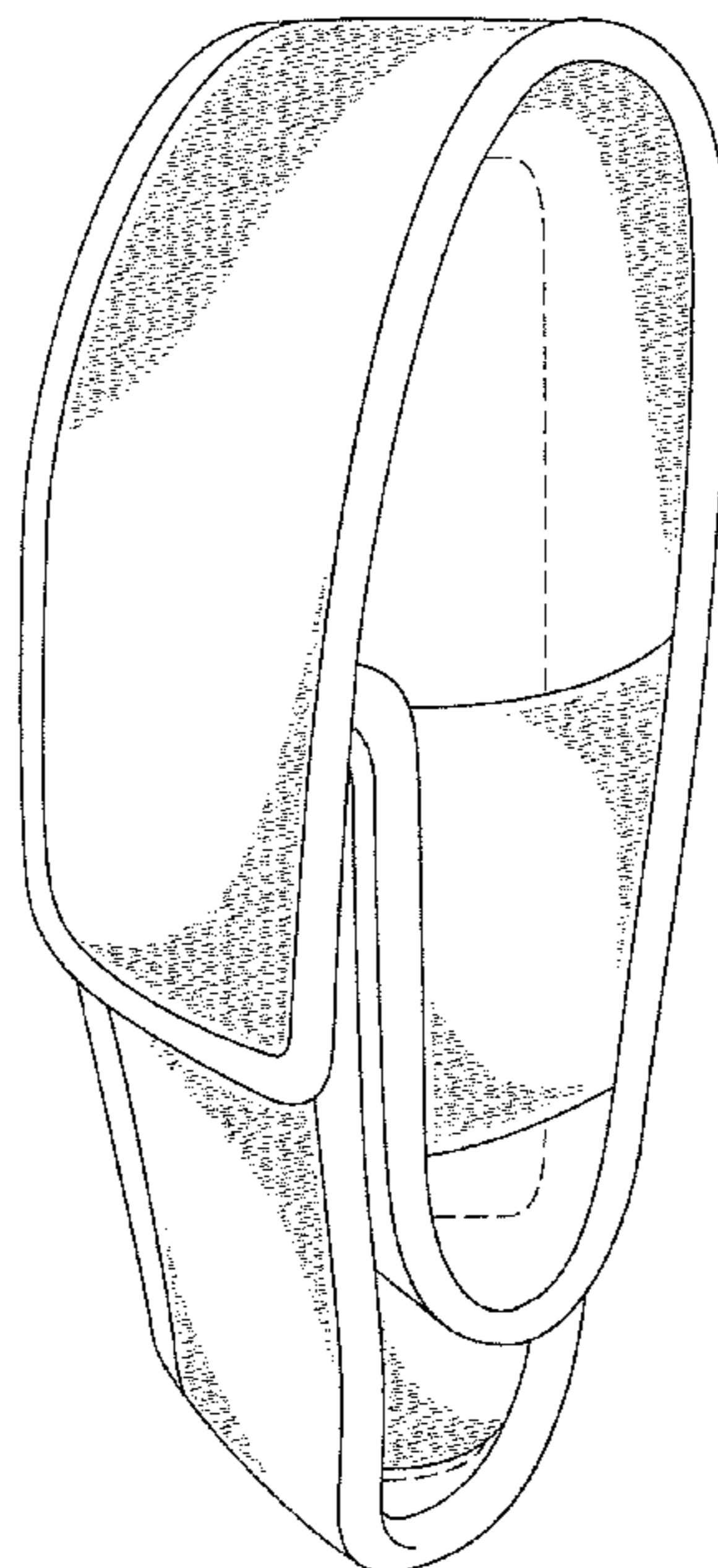
FIG. 1 is a front, right-side, perspective view of the holster for carrying cylindrical case and glove, with unclaimed subject matter shown in phantom;

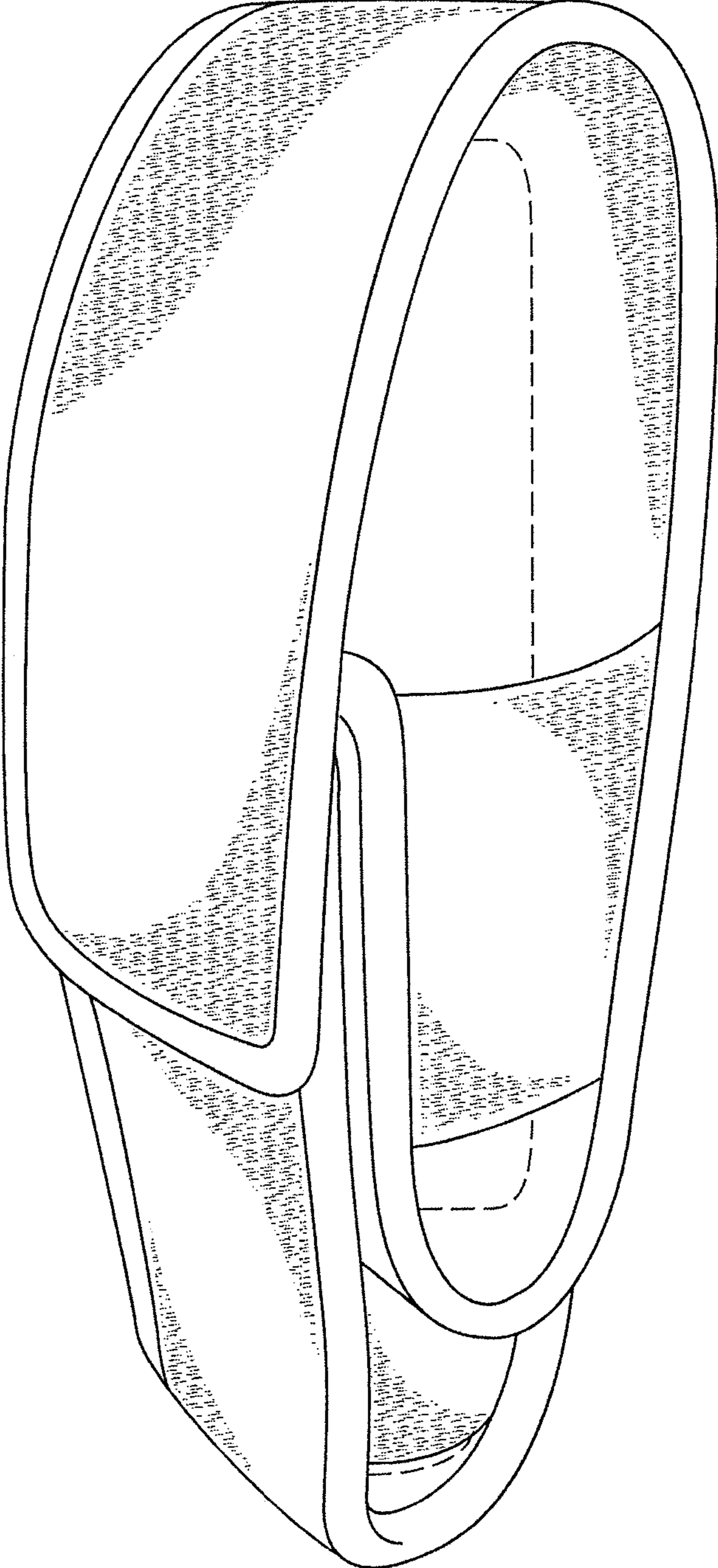

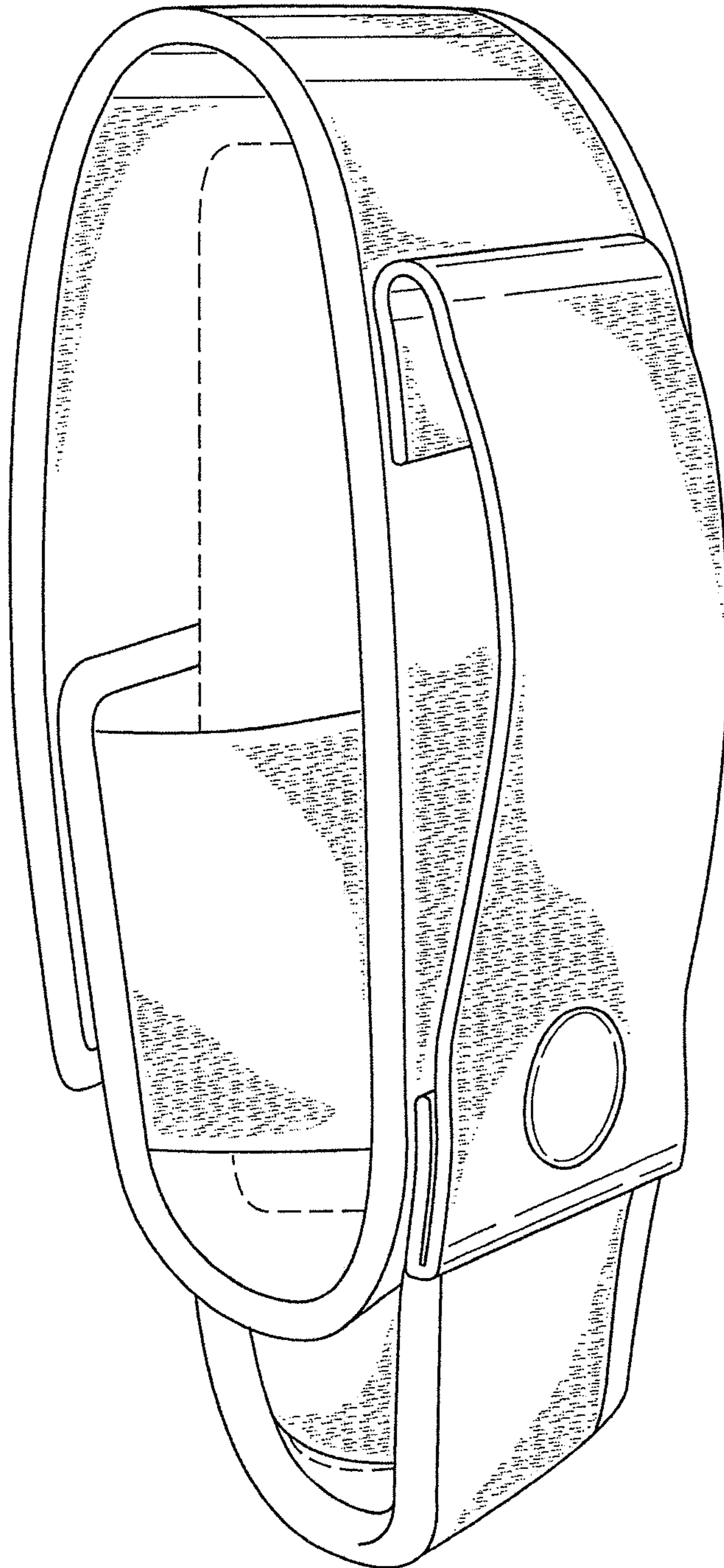

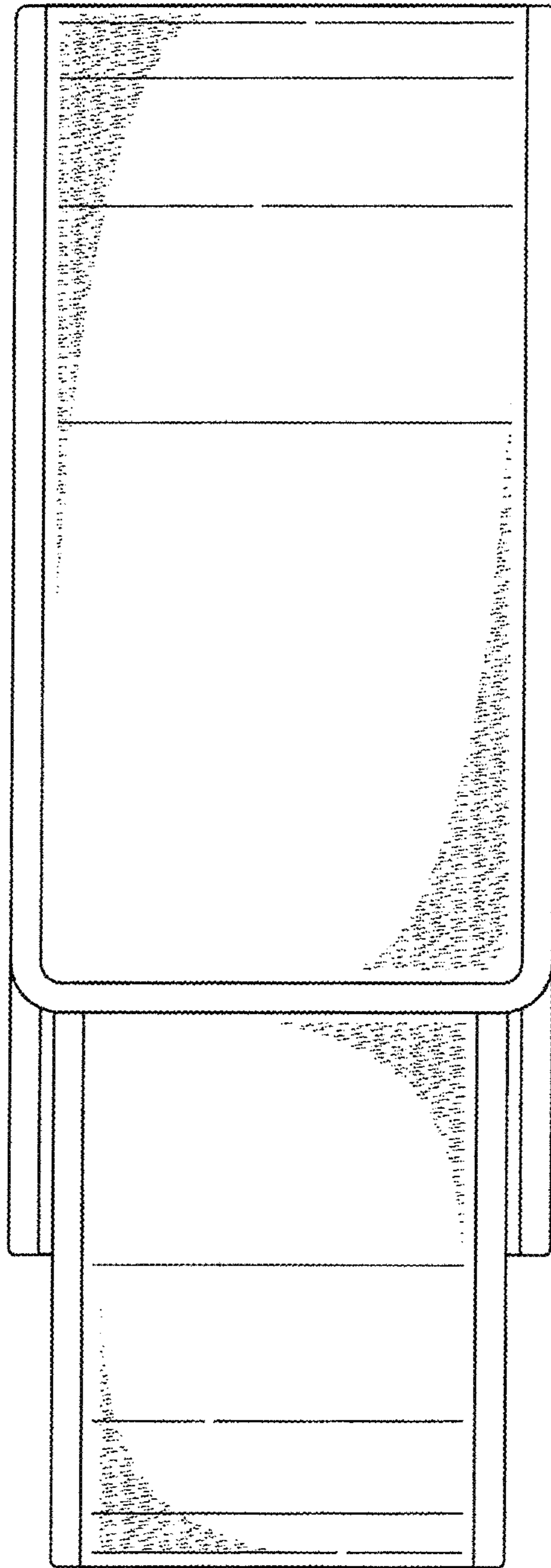

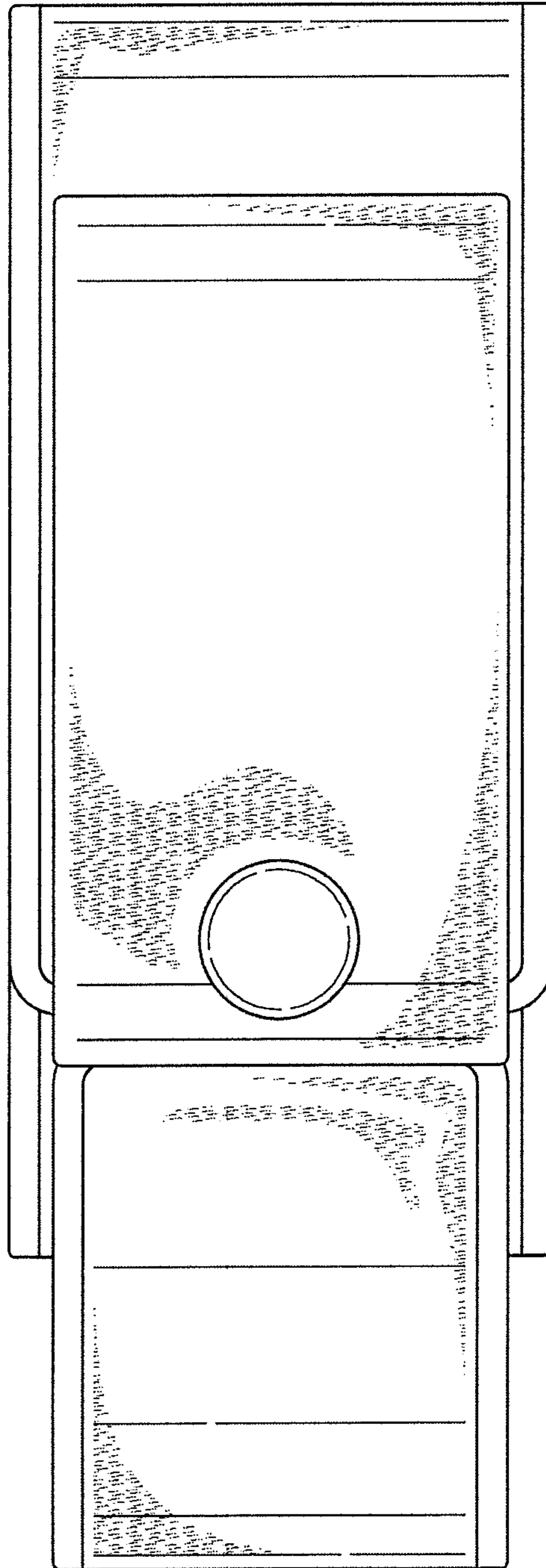

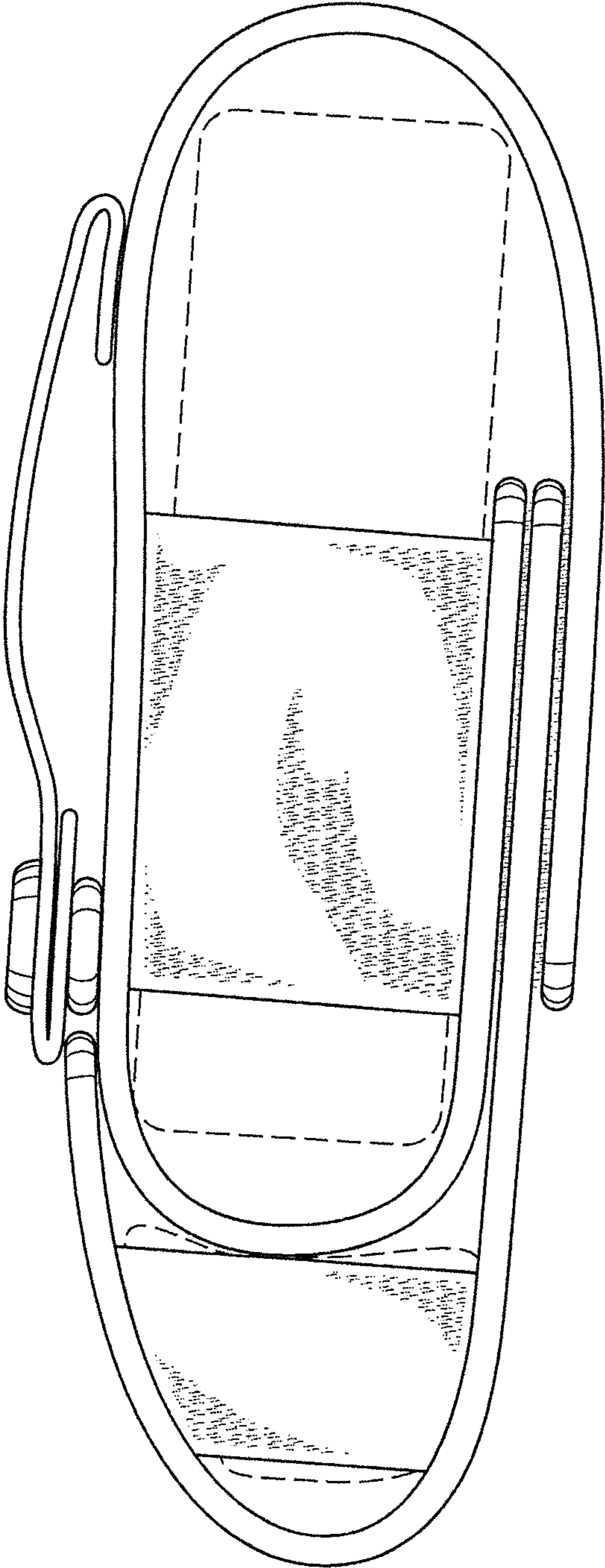

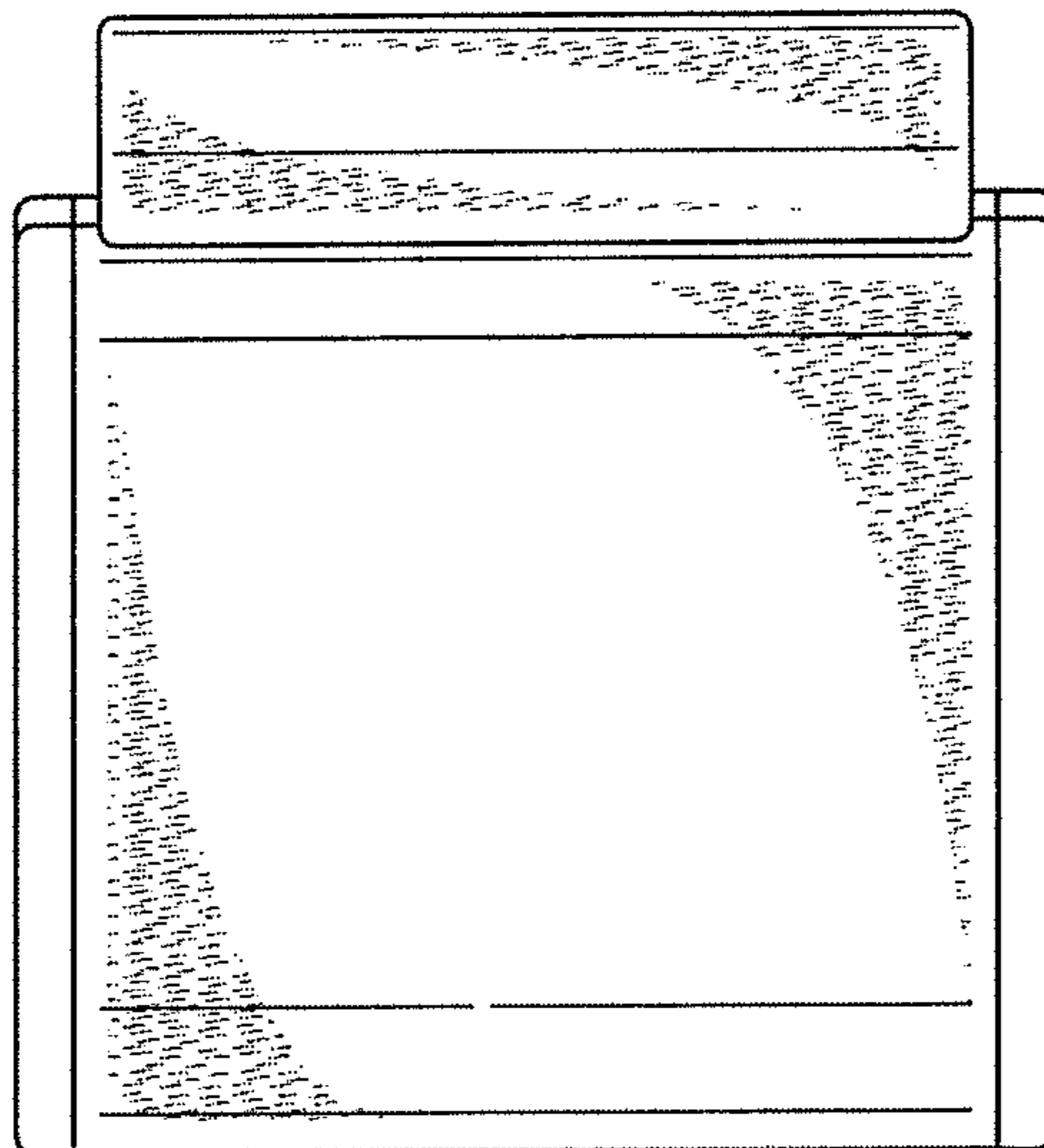

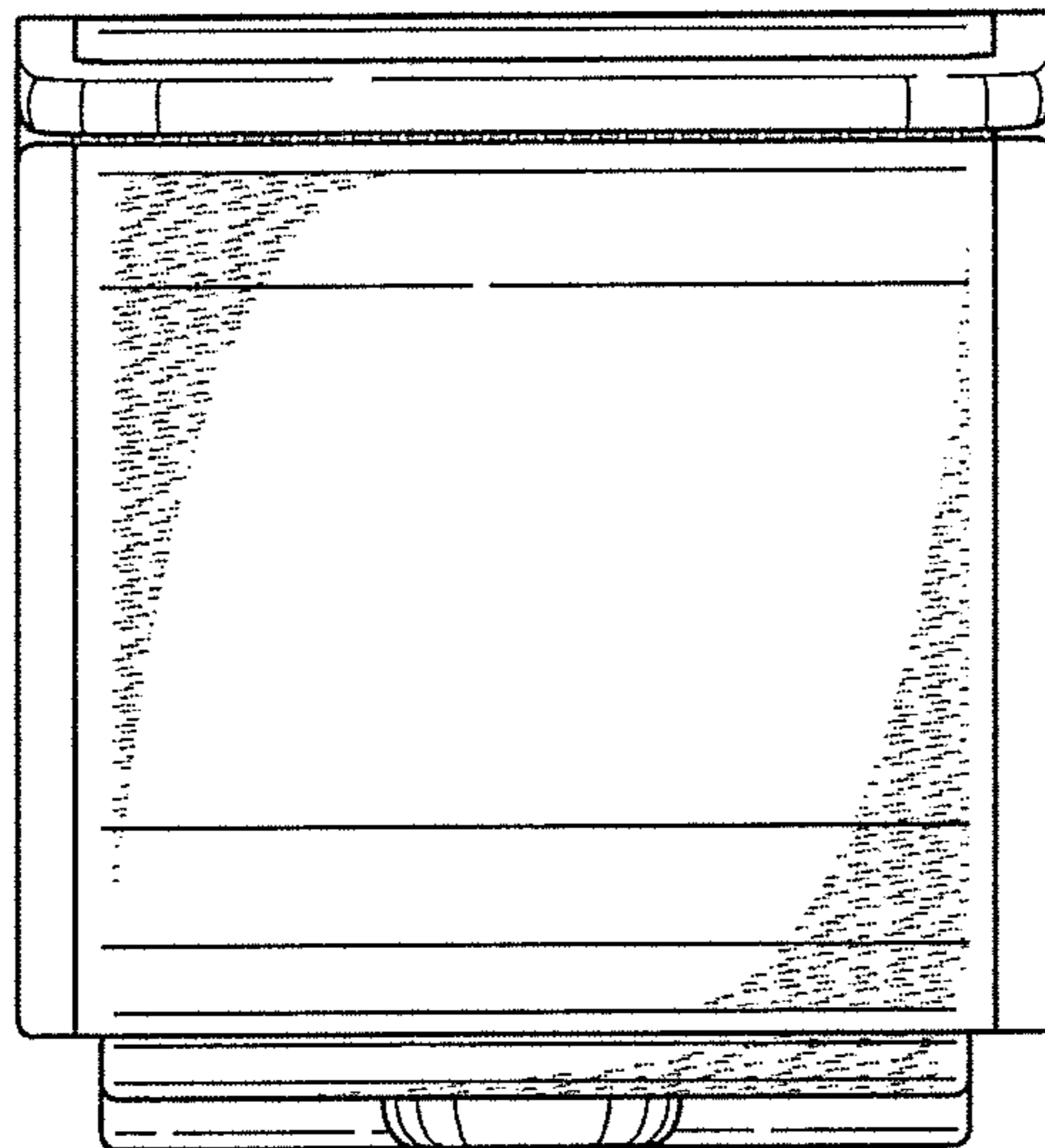
