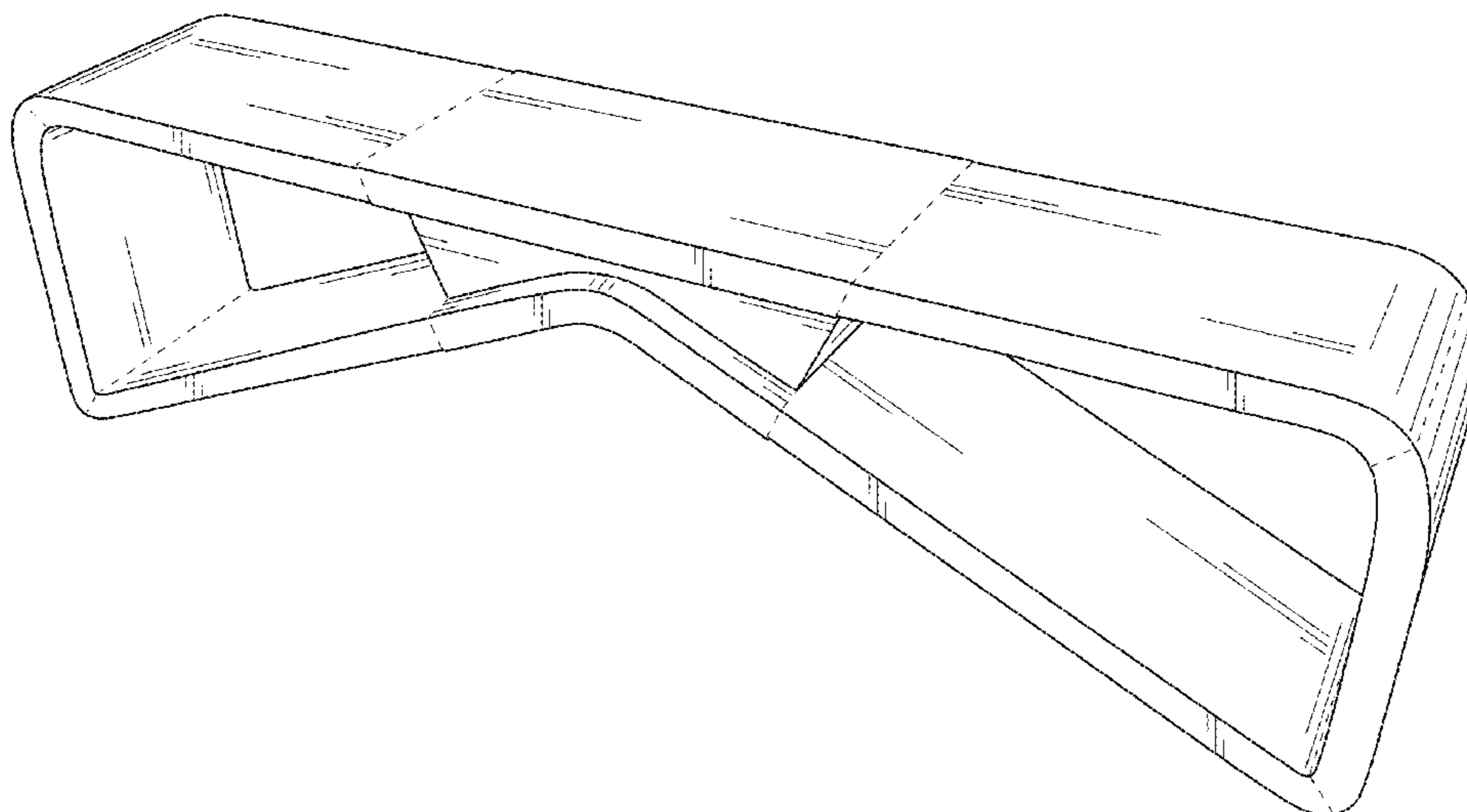
**CLAIM**

(57) The ornamental design for a bench, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the bench of the present design;  
FIG. 2 is a front elevation view thereof, the rear elevation view being identical thereto;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is bottom plan view thereof; and,  
FIG. 5 is a left side elevation view thereof, the right side elevation view being identical thereto.  
The broken lines designate certain edges of central portions of the bench that form no part of the claimed design.

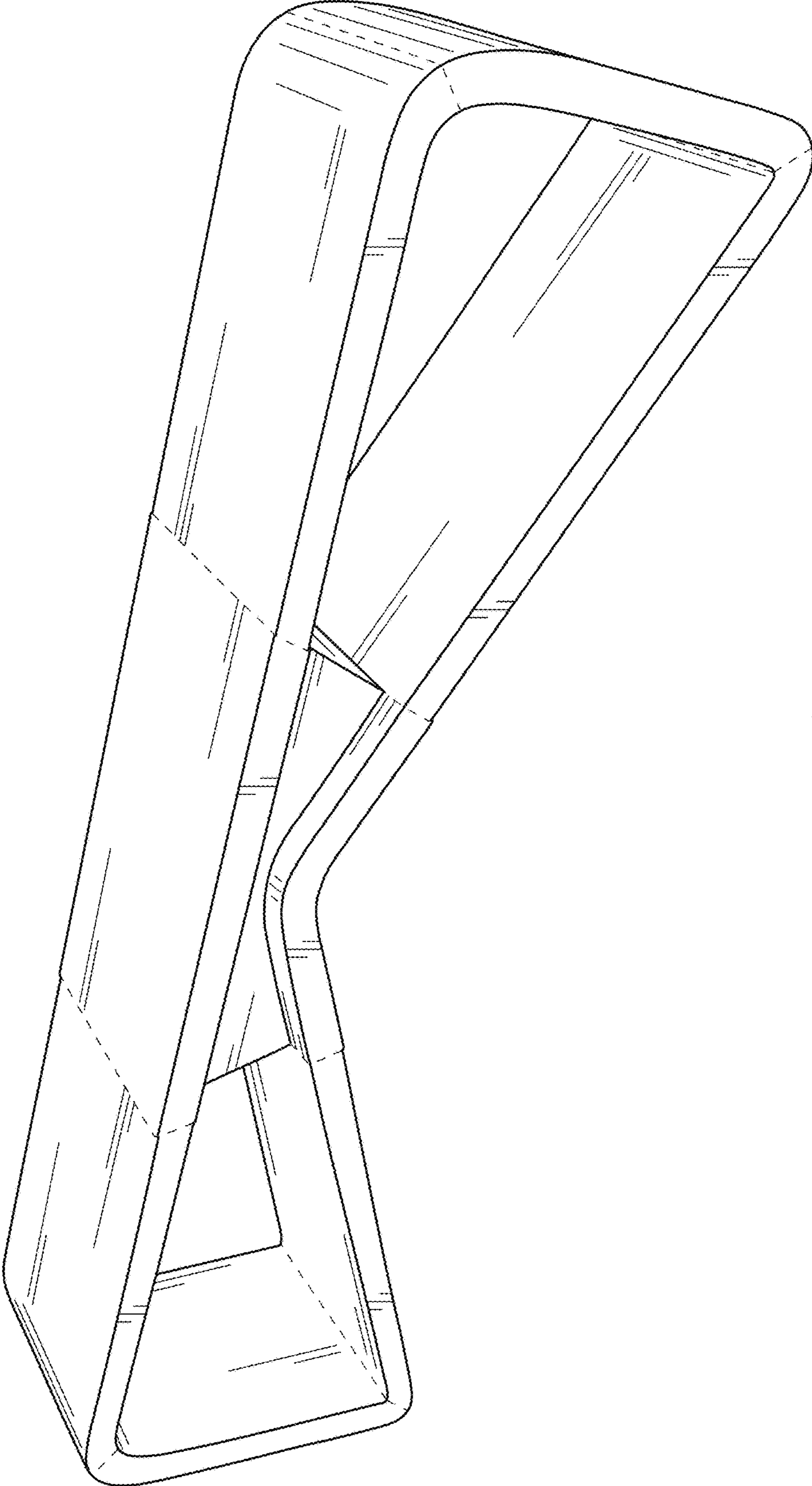

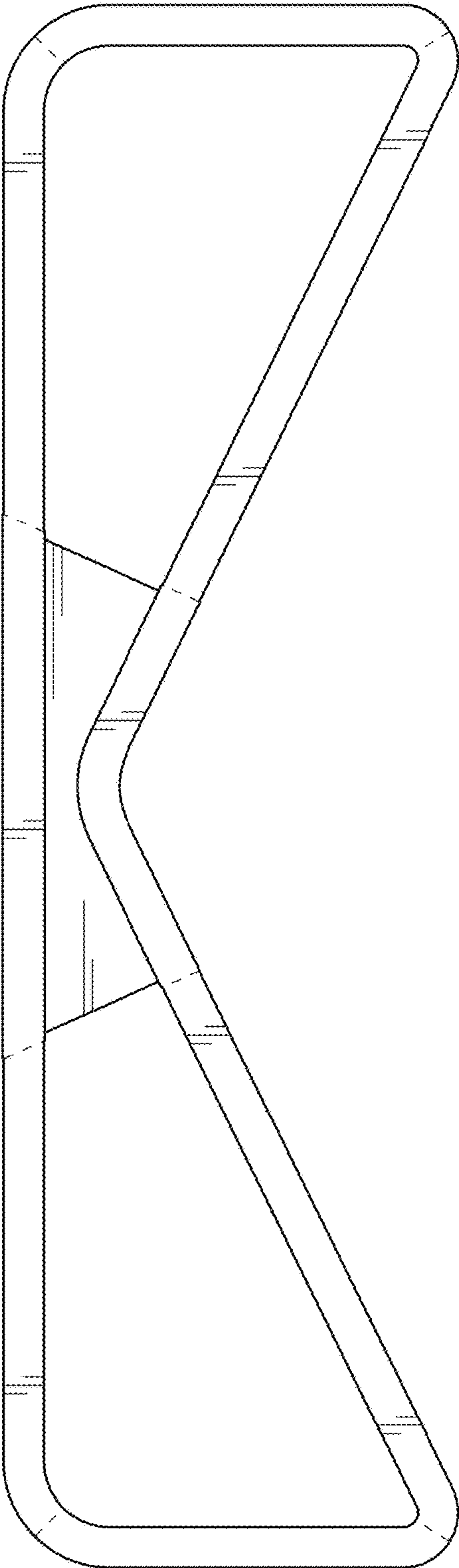

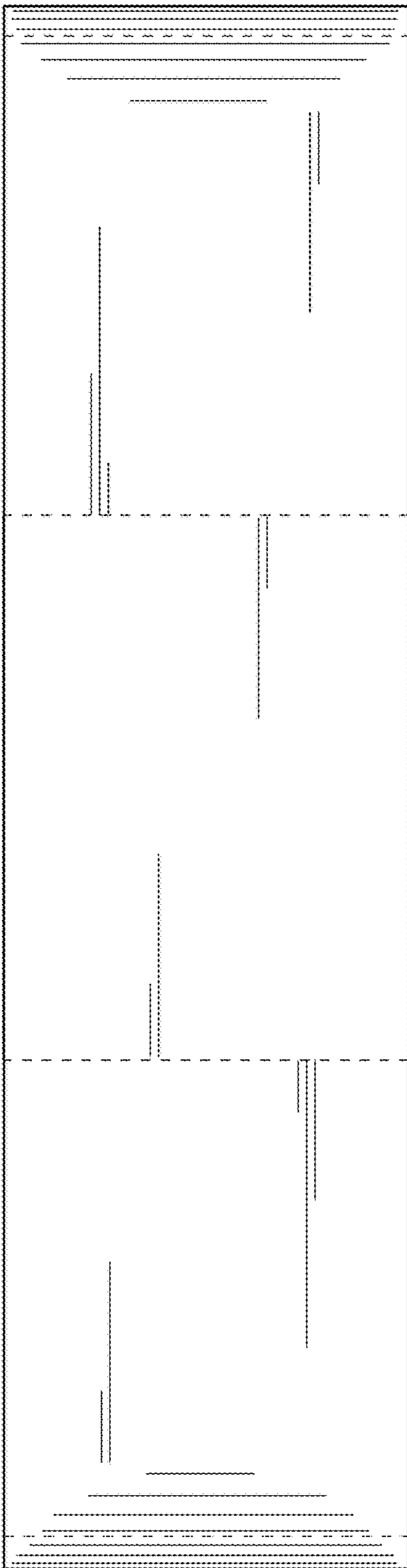

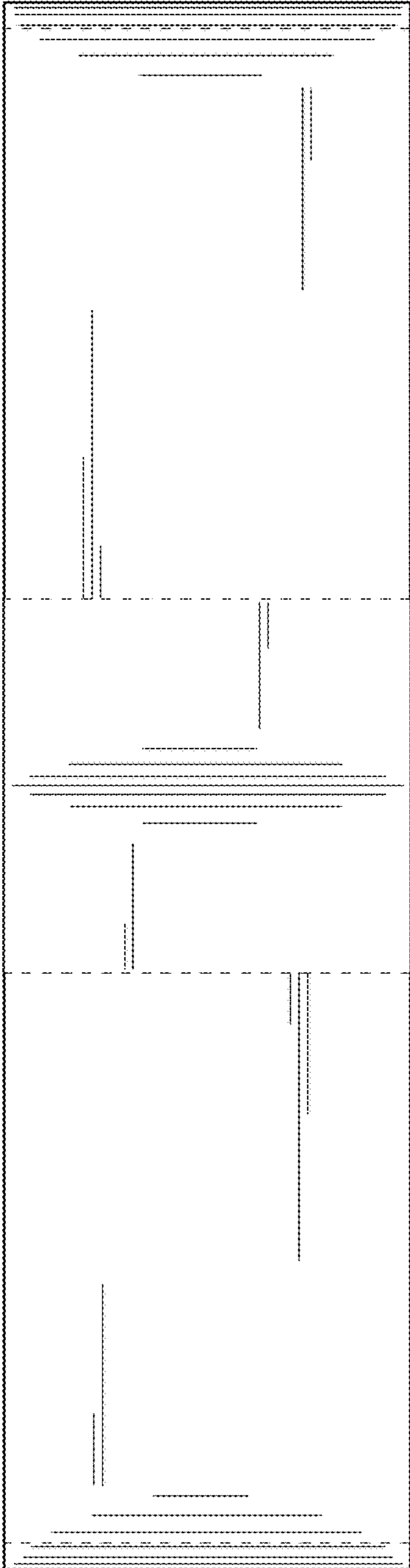

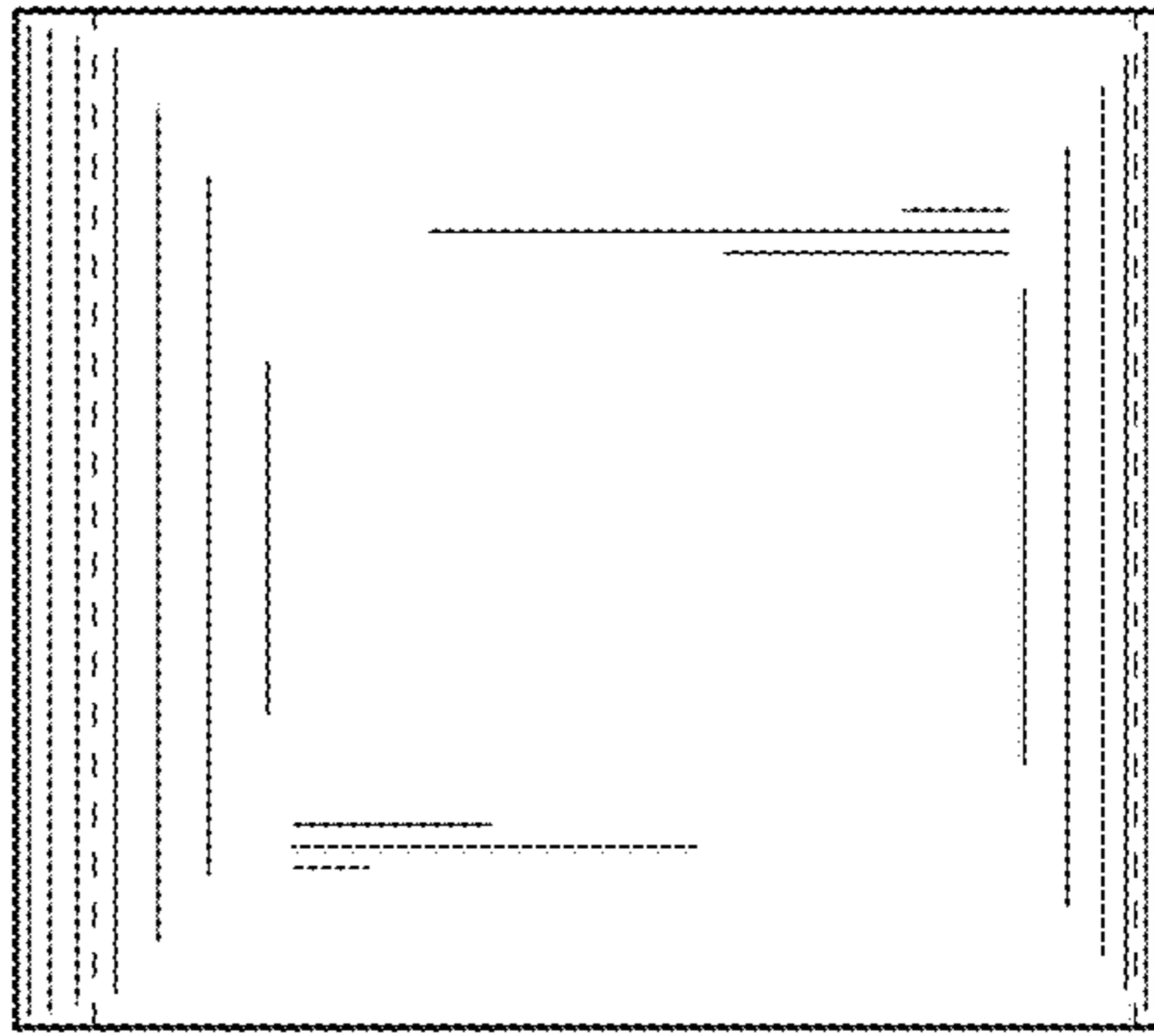
