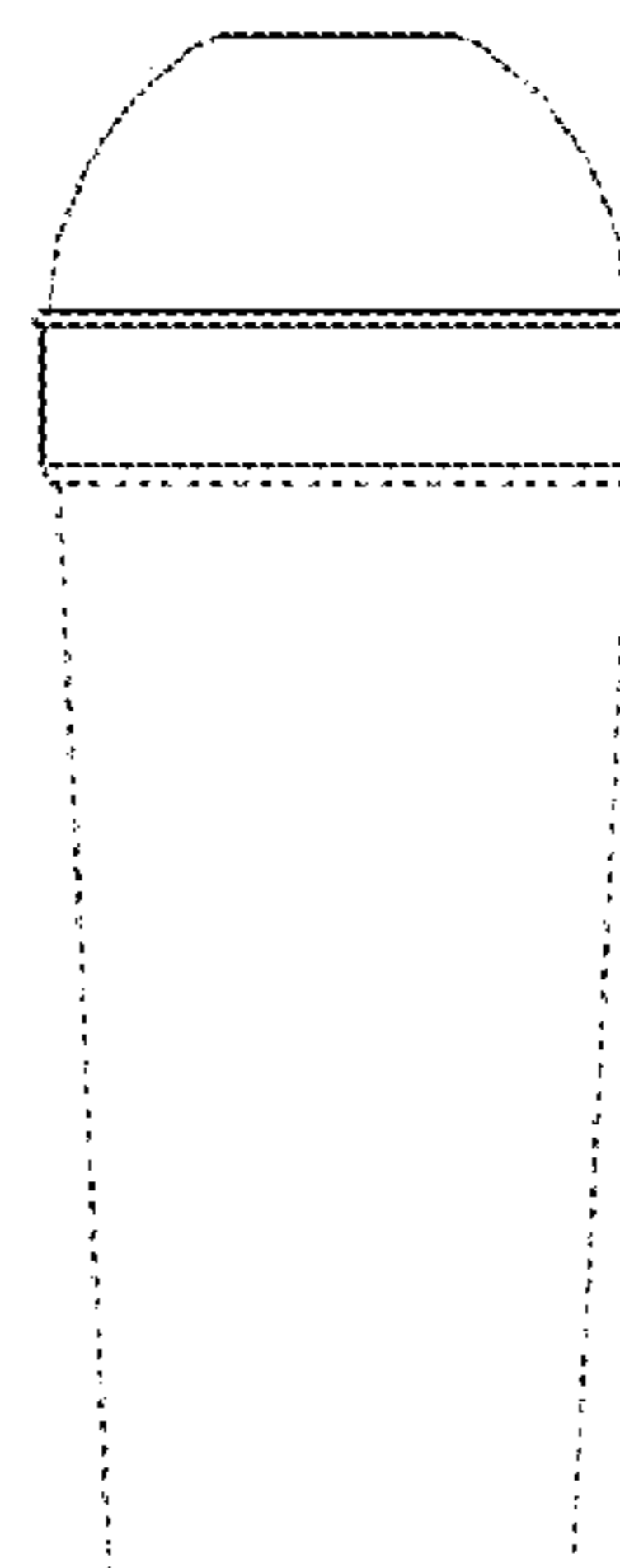
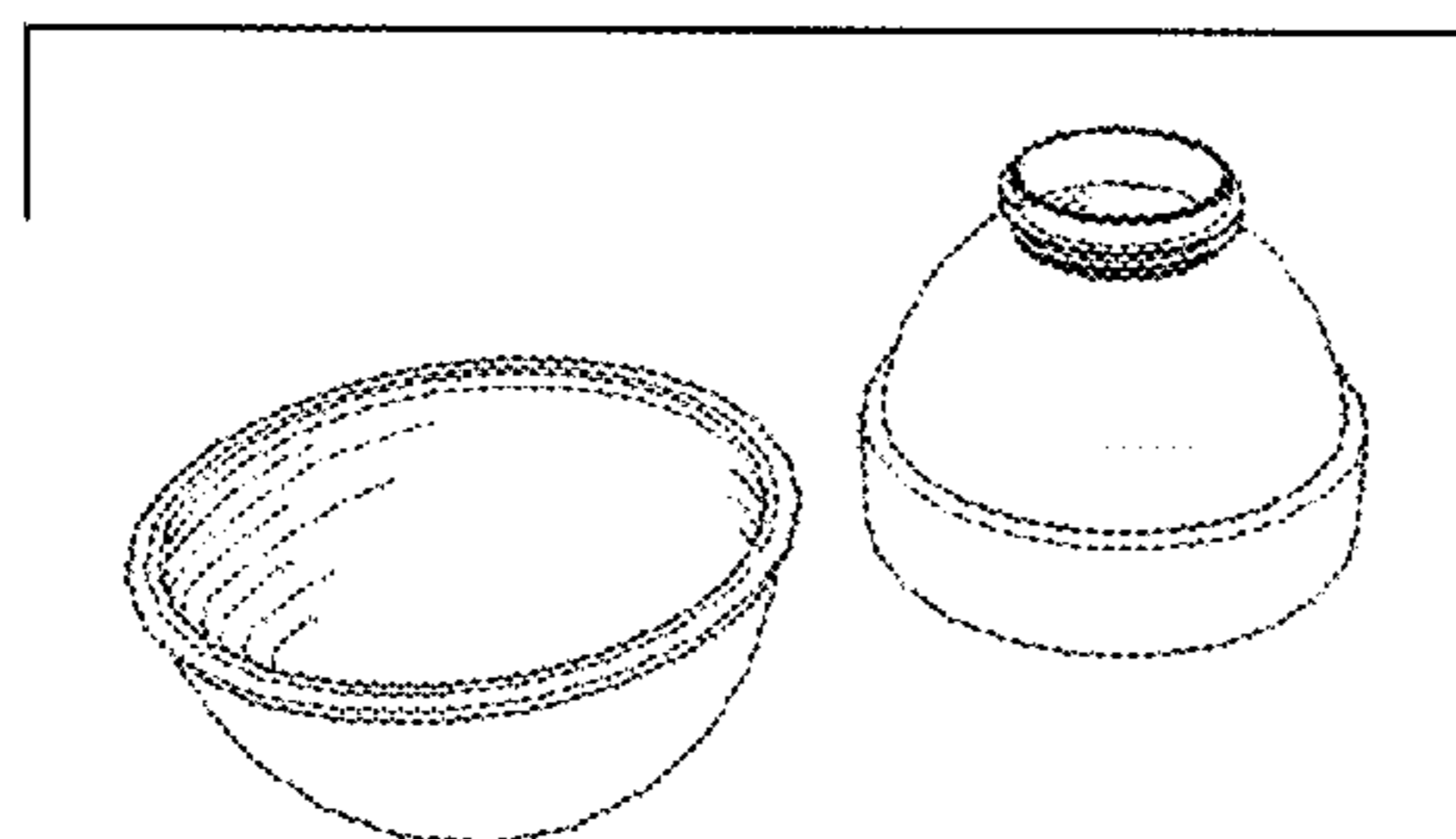
(57) **CLAIM**

The ornamental design for a combined beverage bottle lid with coconut shaped cup, as shown.

DESCRIPTION

FIG. 1 is an exploded top perspective view of a combined beverage bottle lid with coconut shaped cup showing my new design in two parts;
FIG. 2 is a top perspective view shown assembled;
FIG. 3 is a top perspective view, shown with the coconut shaped portion removed
FIG. 4 is a bottom perspective view thereof; and,
FIG. 5 is a front elevation view, shown assembled within in an environment of use.
The broken lines shown in FIG. 5 depict environmental subject matter that forms no part of the claimed design.

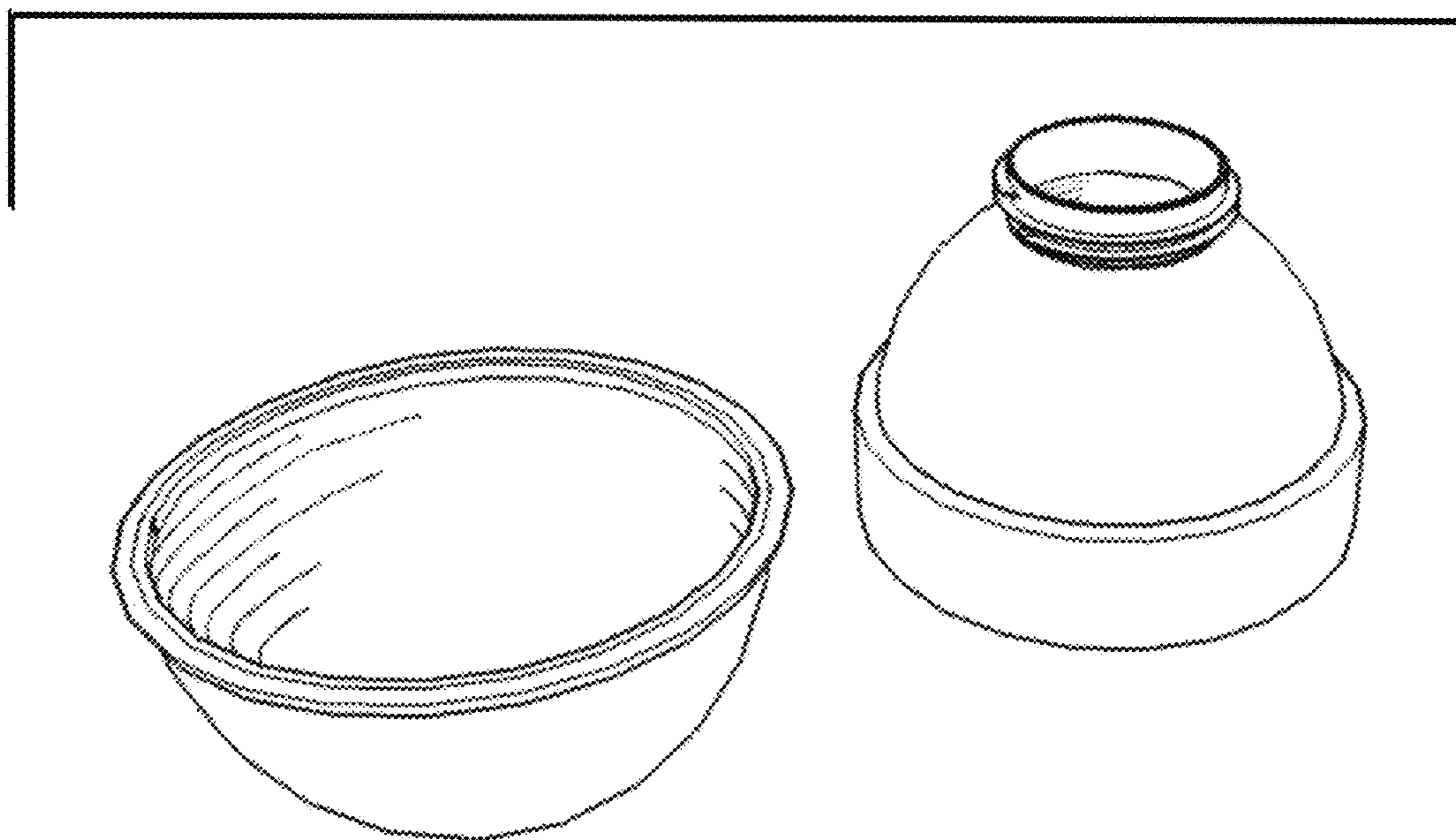

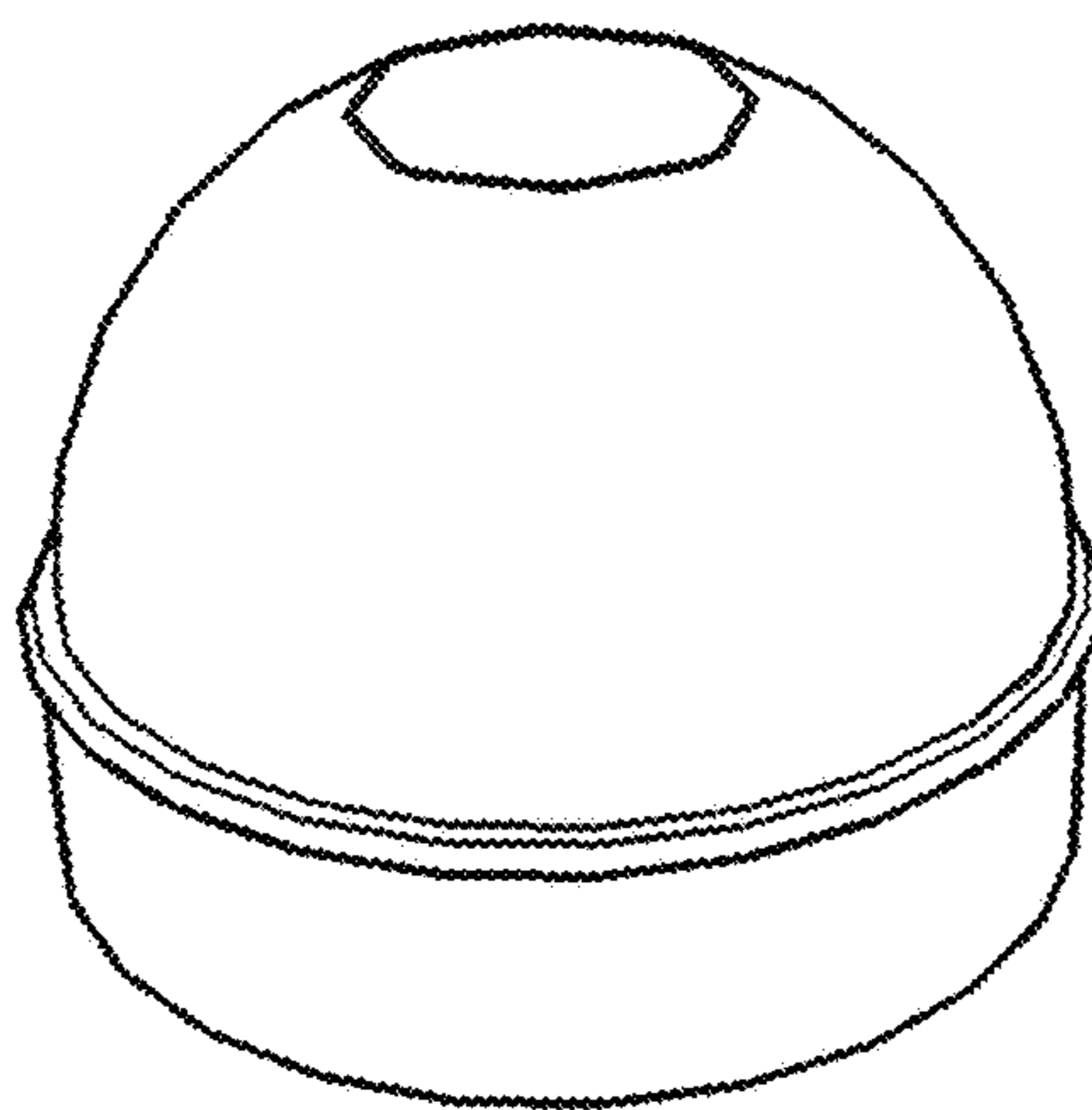

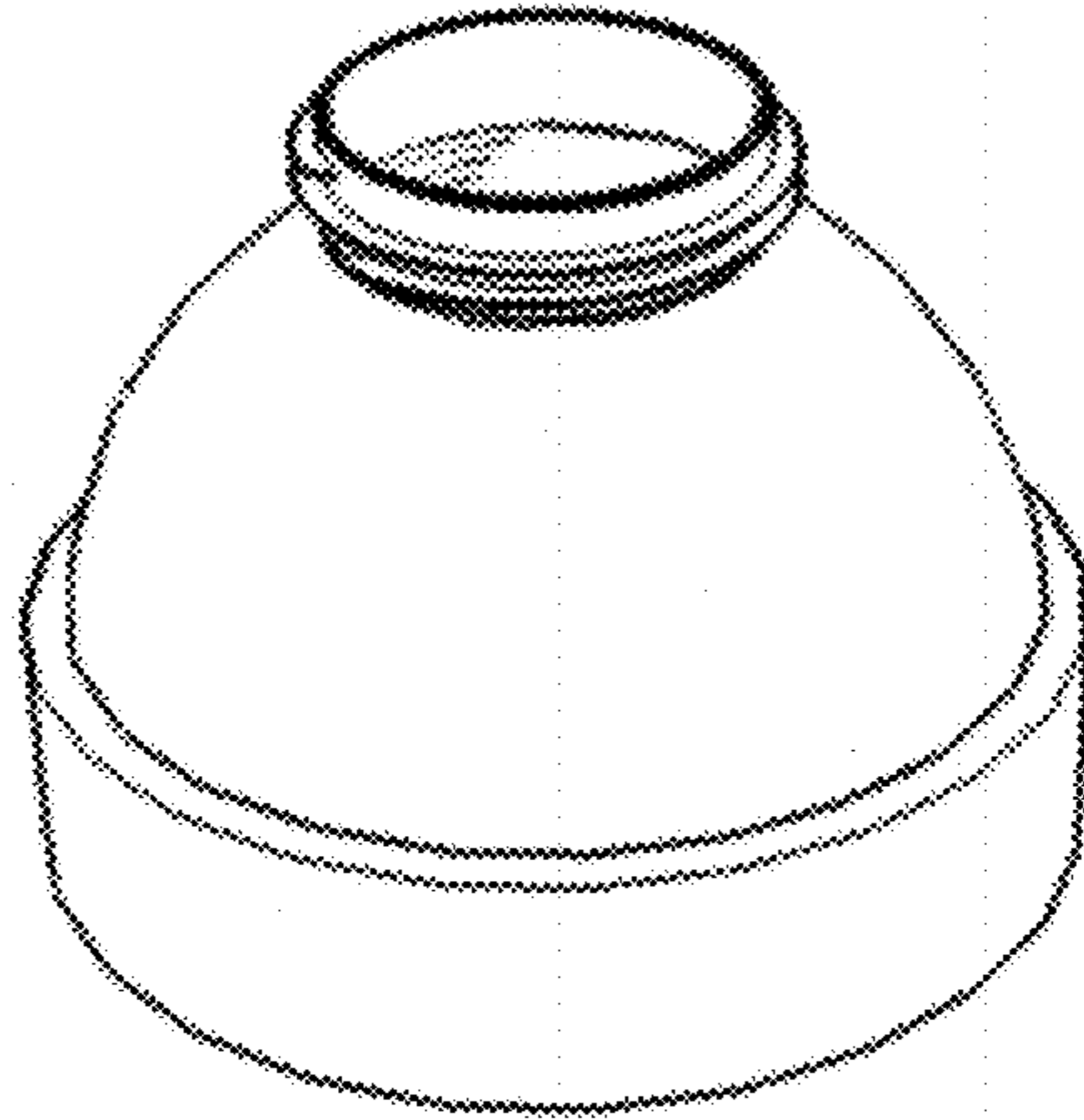

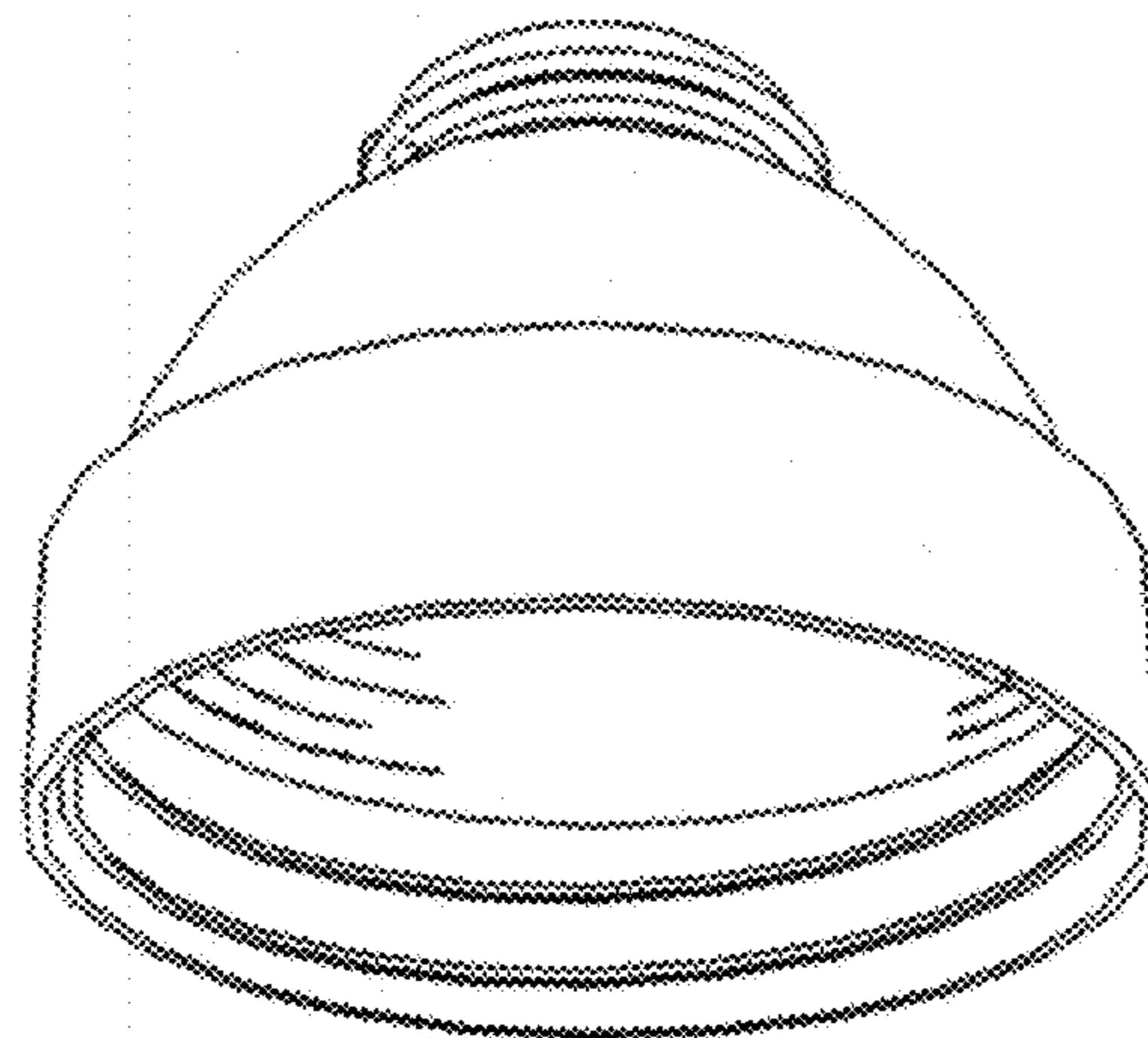
