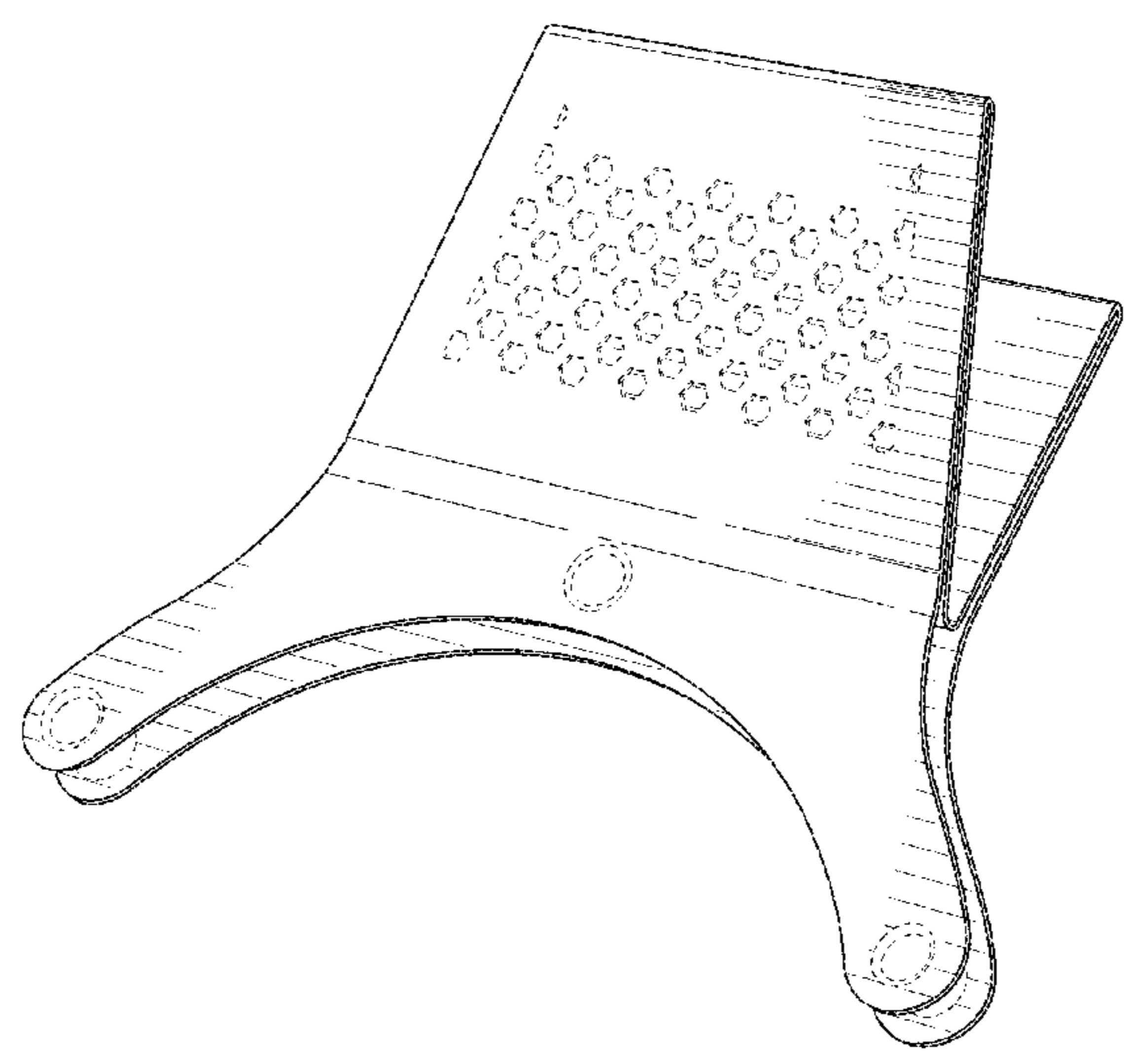
(57) **CLAIM**

The ornamental design for a food frying clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective from above of a food frying clip showing my new design;  
FIG. 2 is a front view of the food frying clip;  
FIG. 3 is a right side view of the food frying clip;  
FIG. 4 is a left side view of the food frying clip;  
FIG. 5 is a rear view of the food frying clip;  
FIG. 6 is a top view of the food frying clip;  
FIG. 7 is a bottom view of the food frying clip; and,  
FIG. 8 is a perspective view showing the food frying clip in an open position.  
The shade lines in the Figures show contour and not surface ornamentation.  
The broken lines illustrate portions of the food frying clip that form no part of the claimed design.

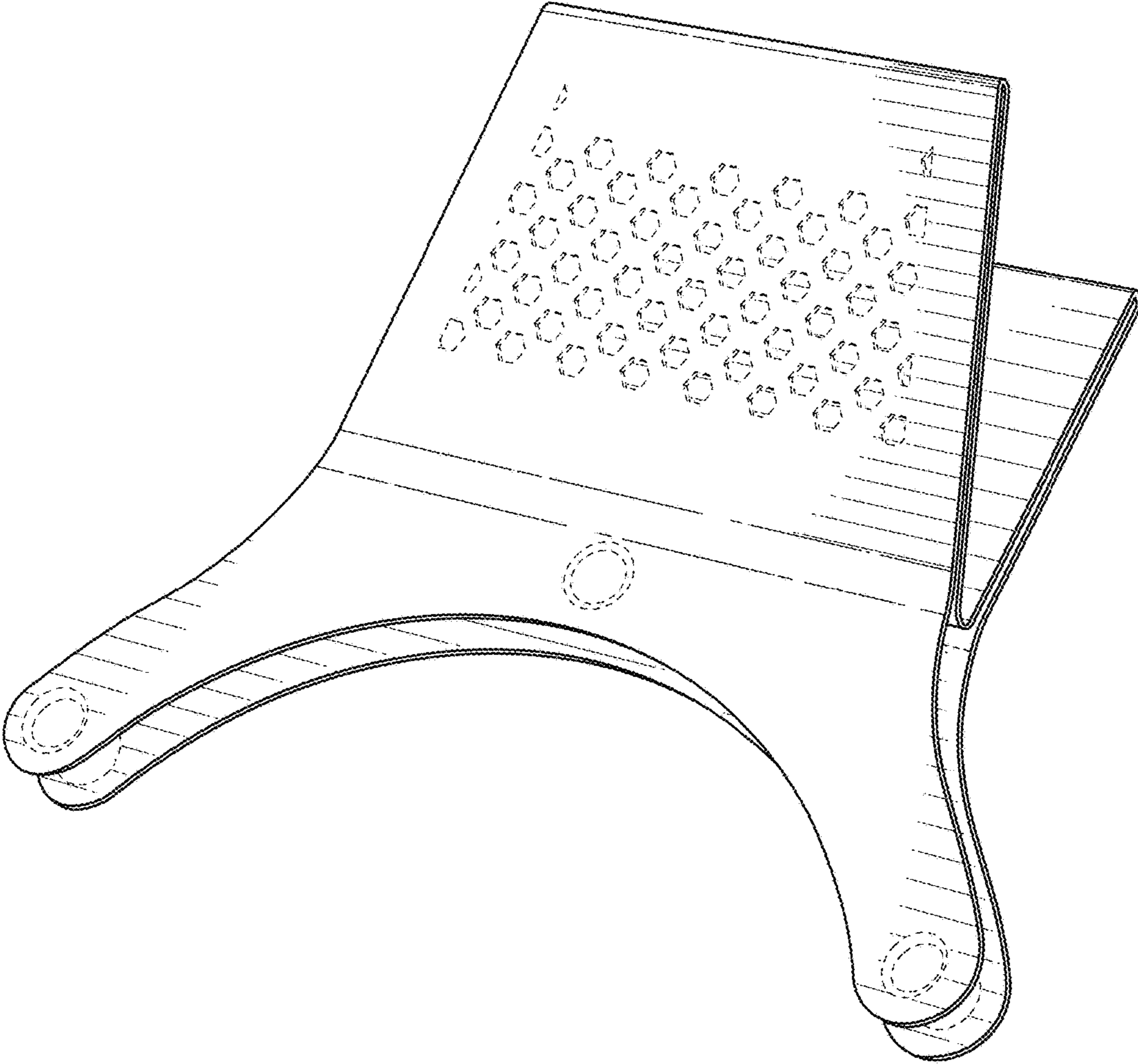

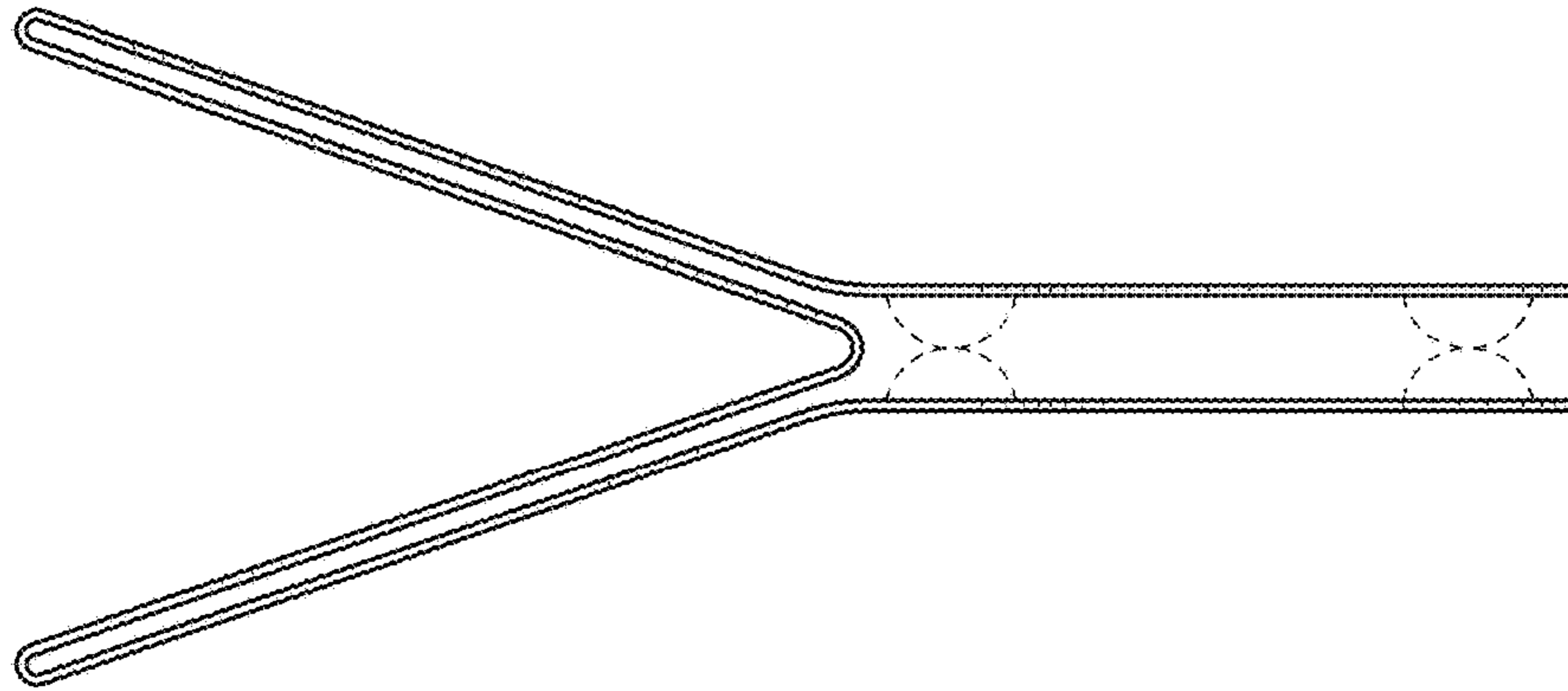

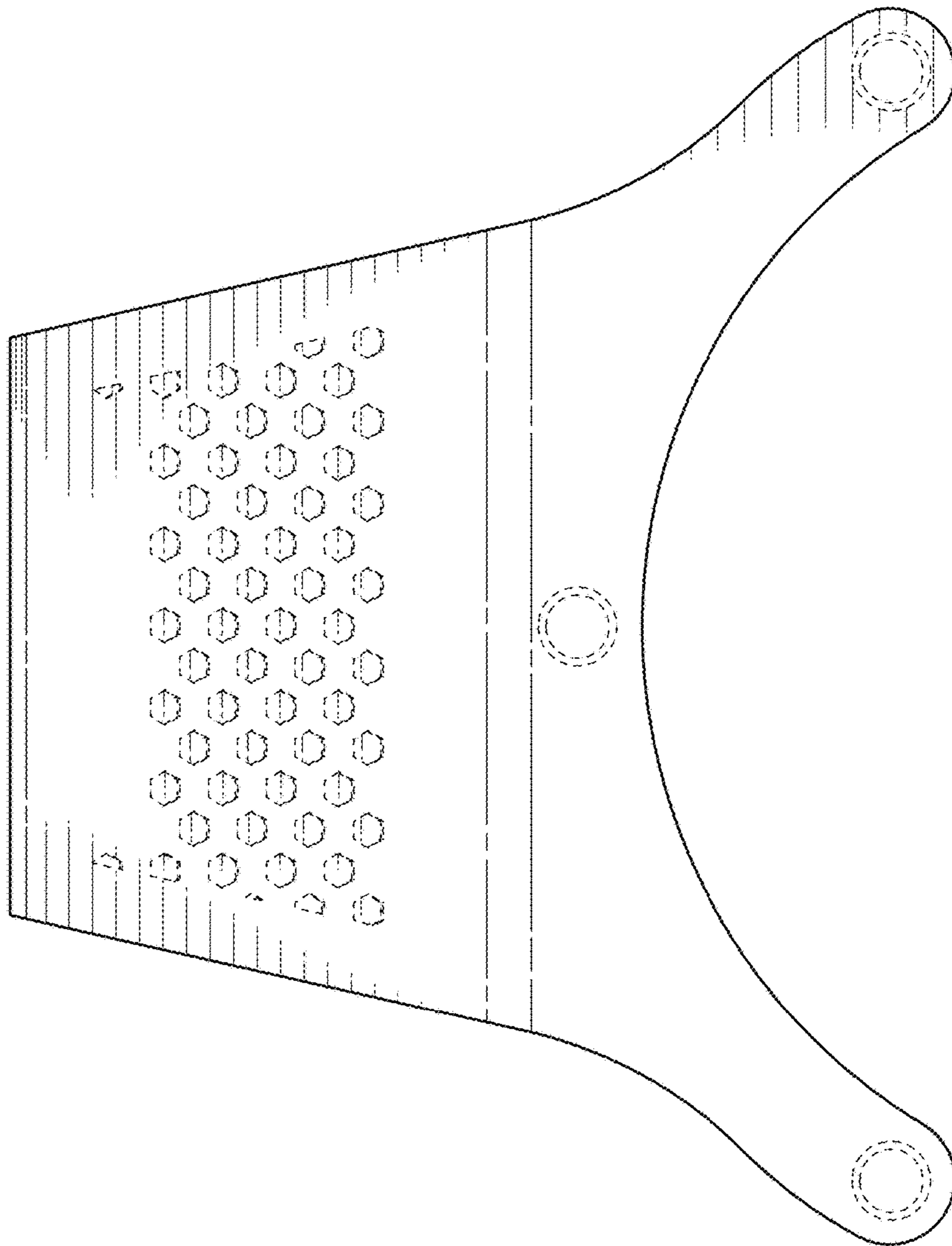

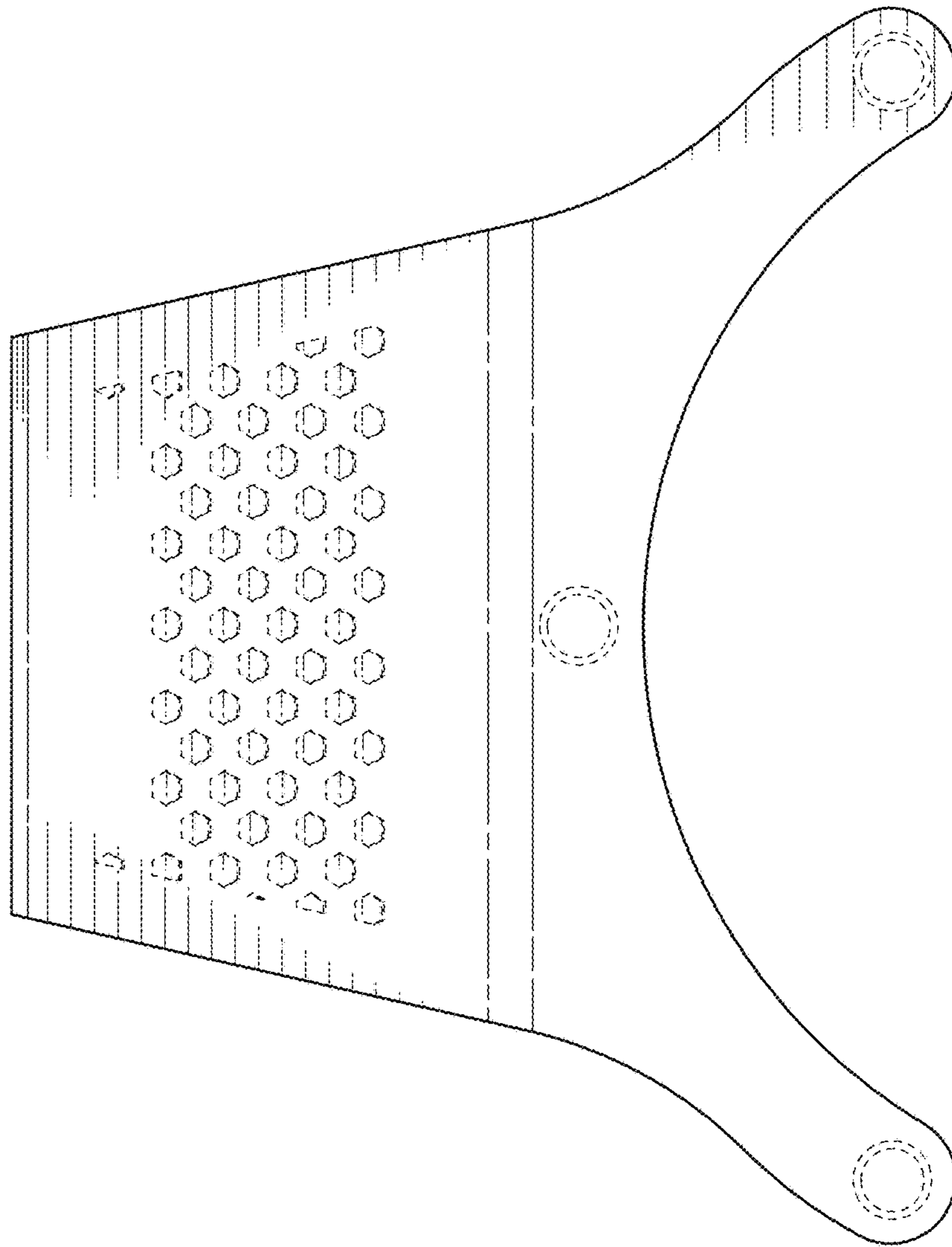

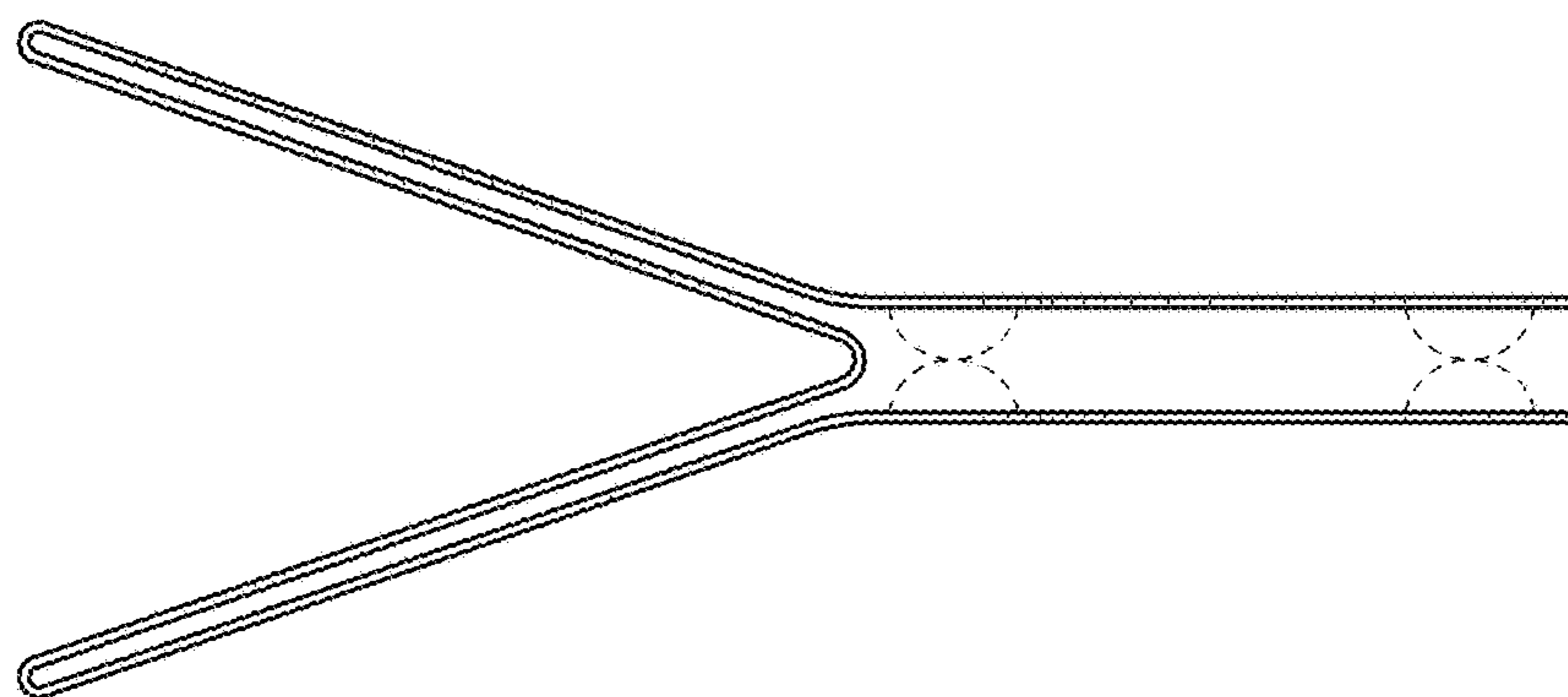

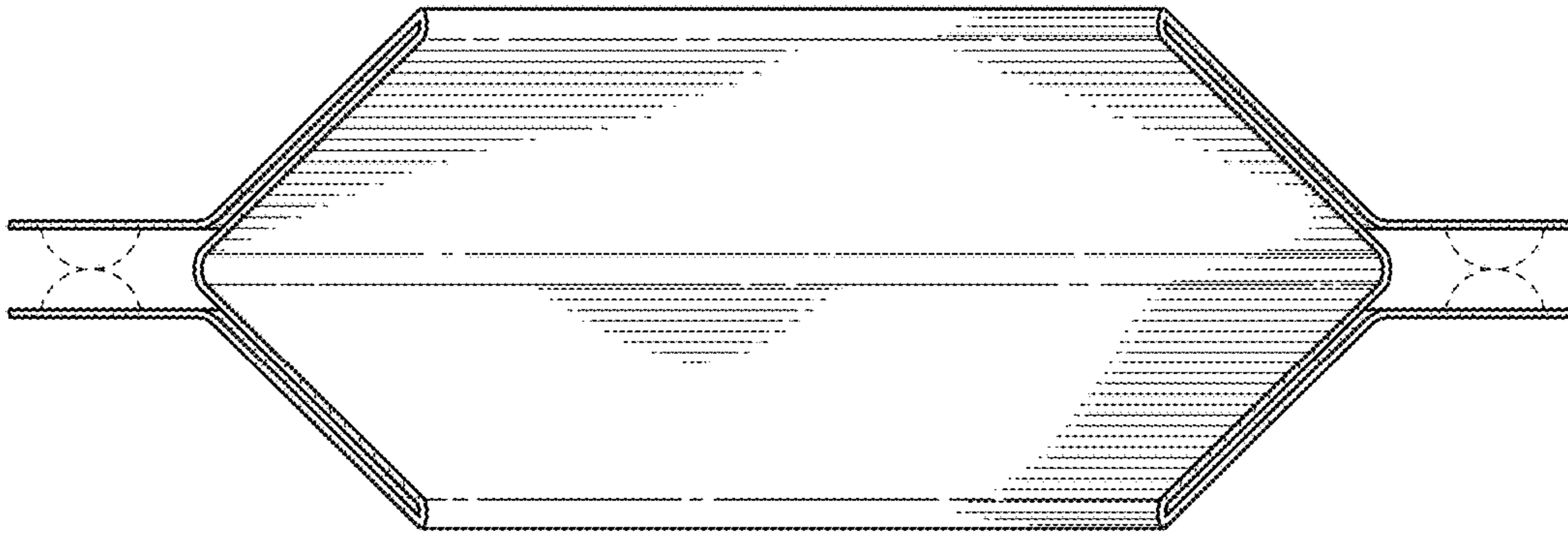

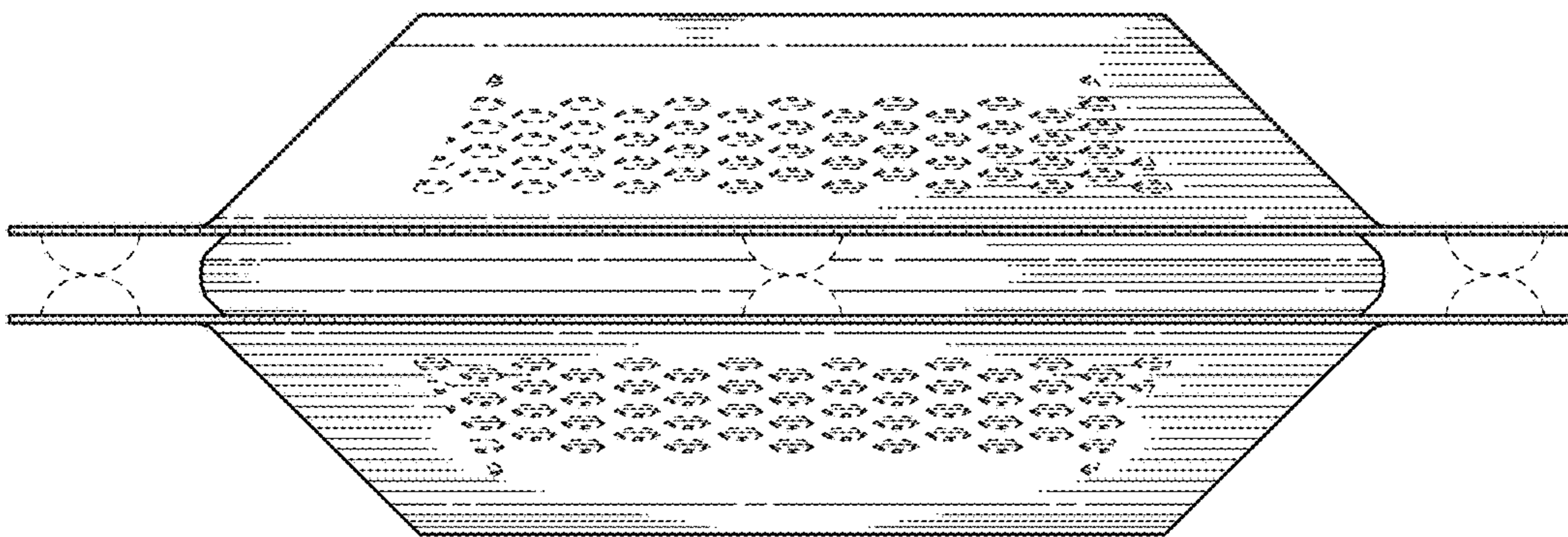

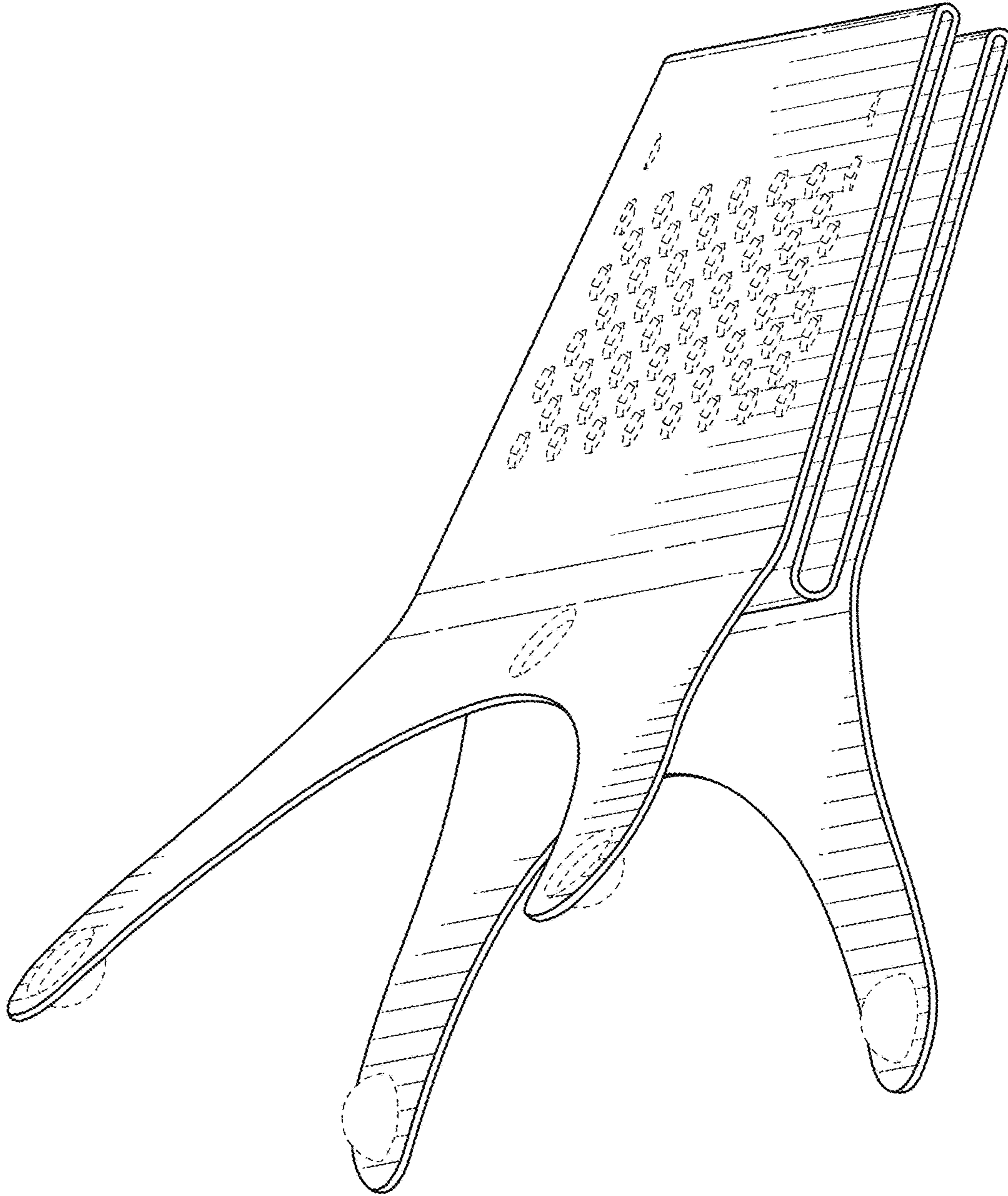
