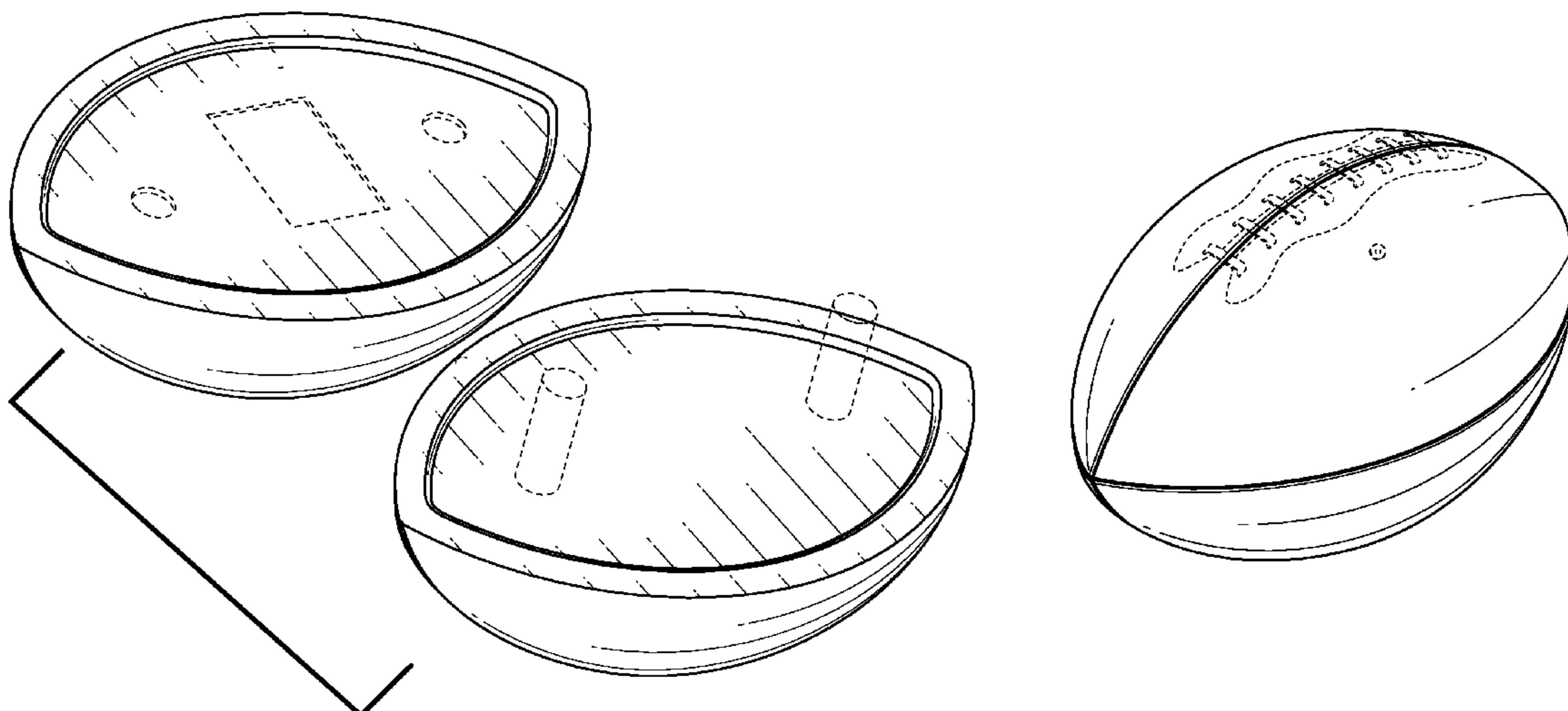
(57) **CLAIM**

I claim the ornamental design for “bottle opener,” as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle opener shown in an open position;
FIG. 2 is a front view thereof;

FIG. 5 is a top view thereof;

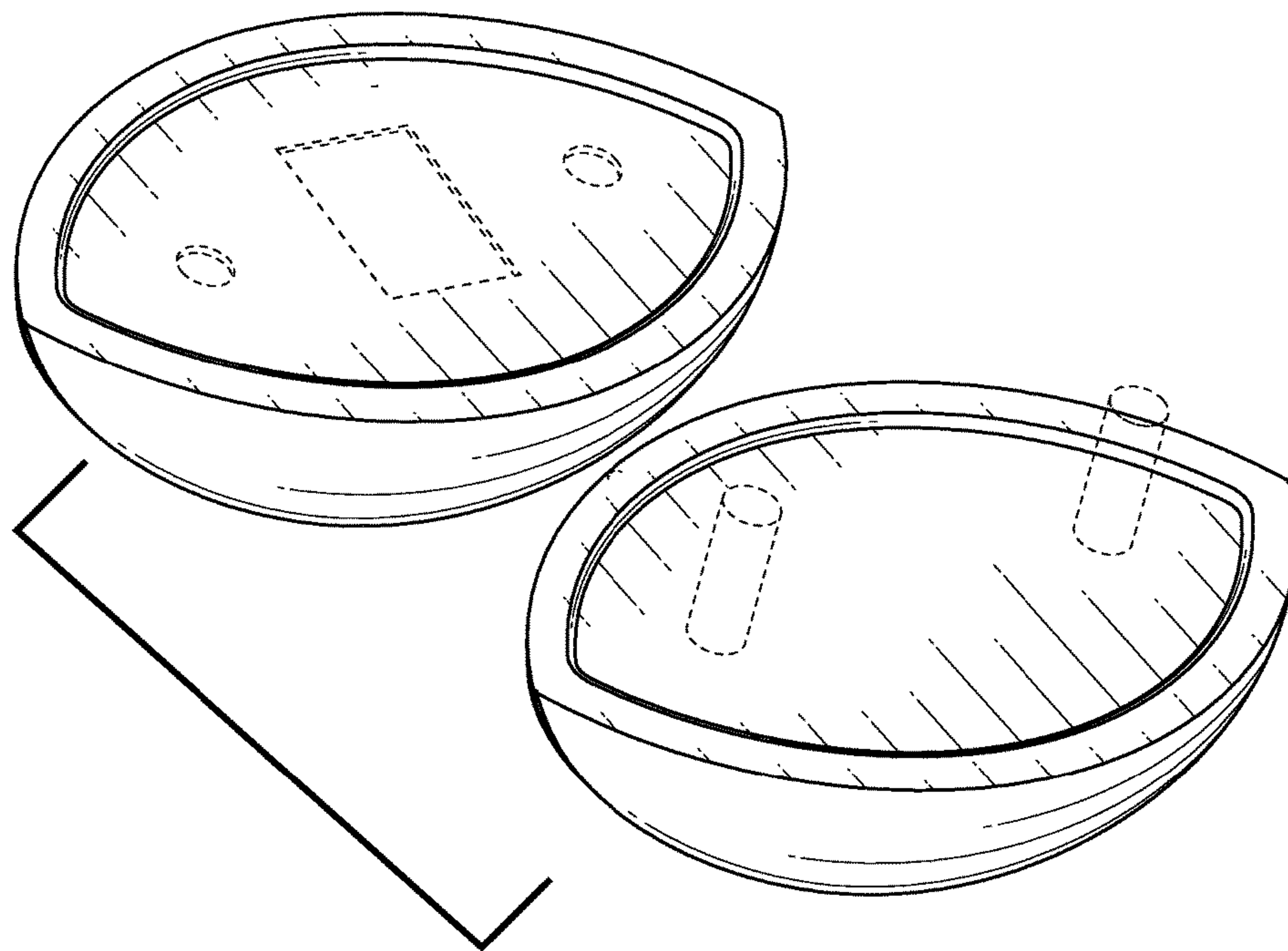

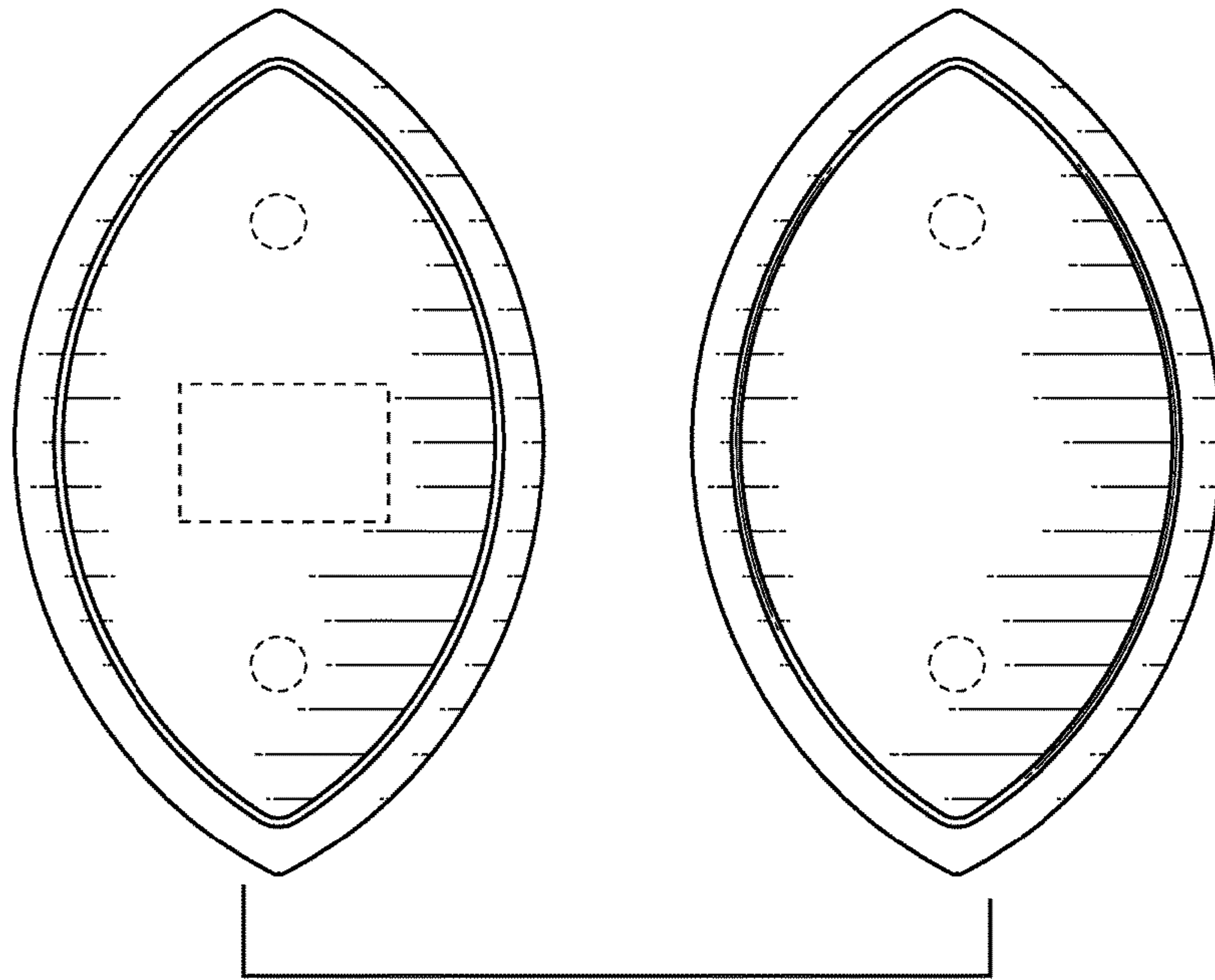

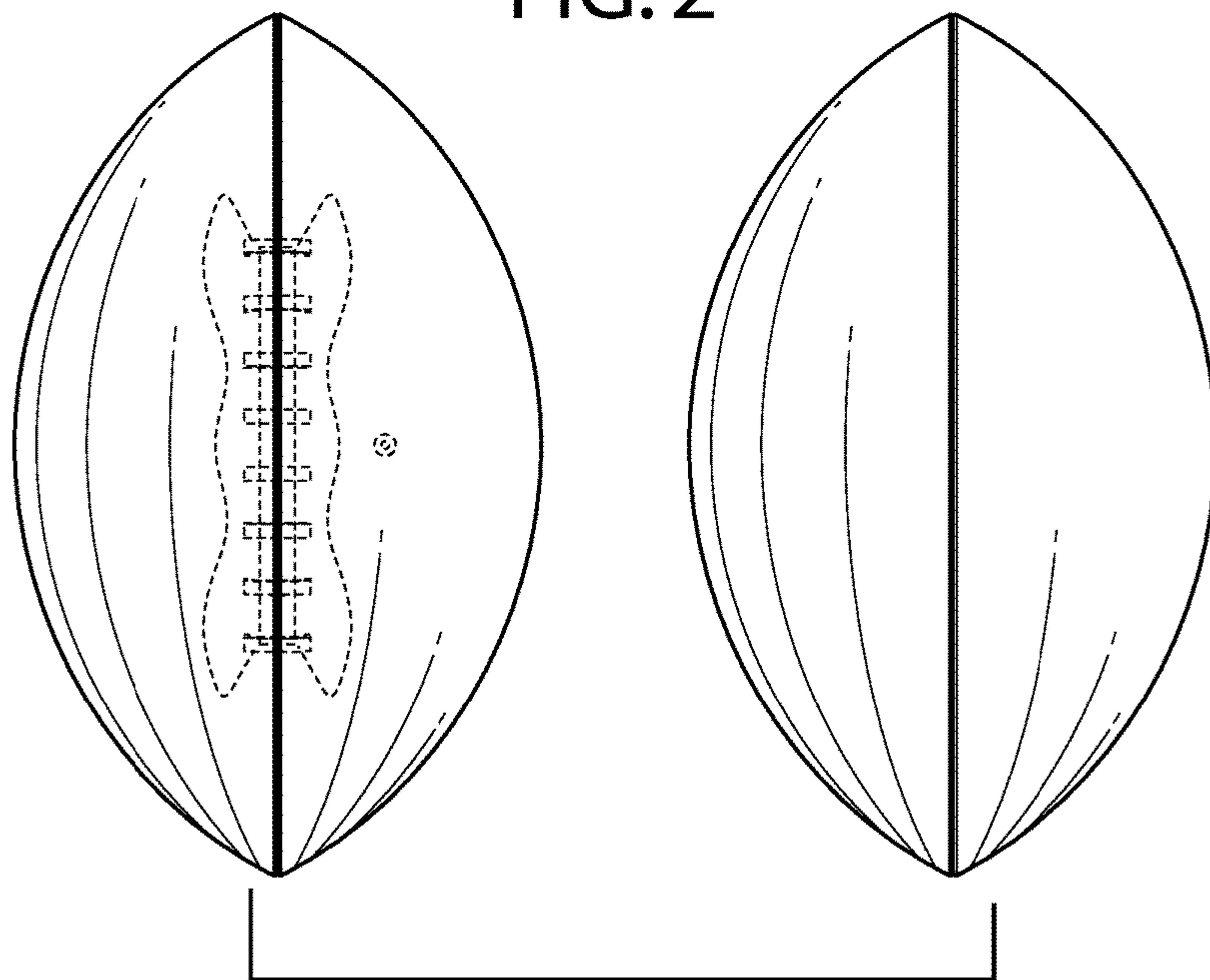

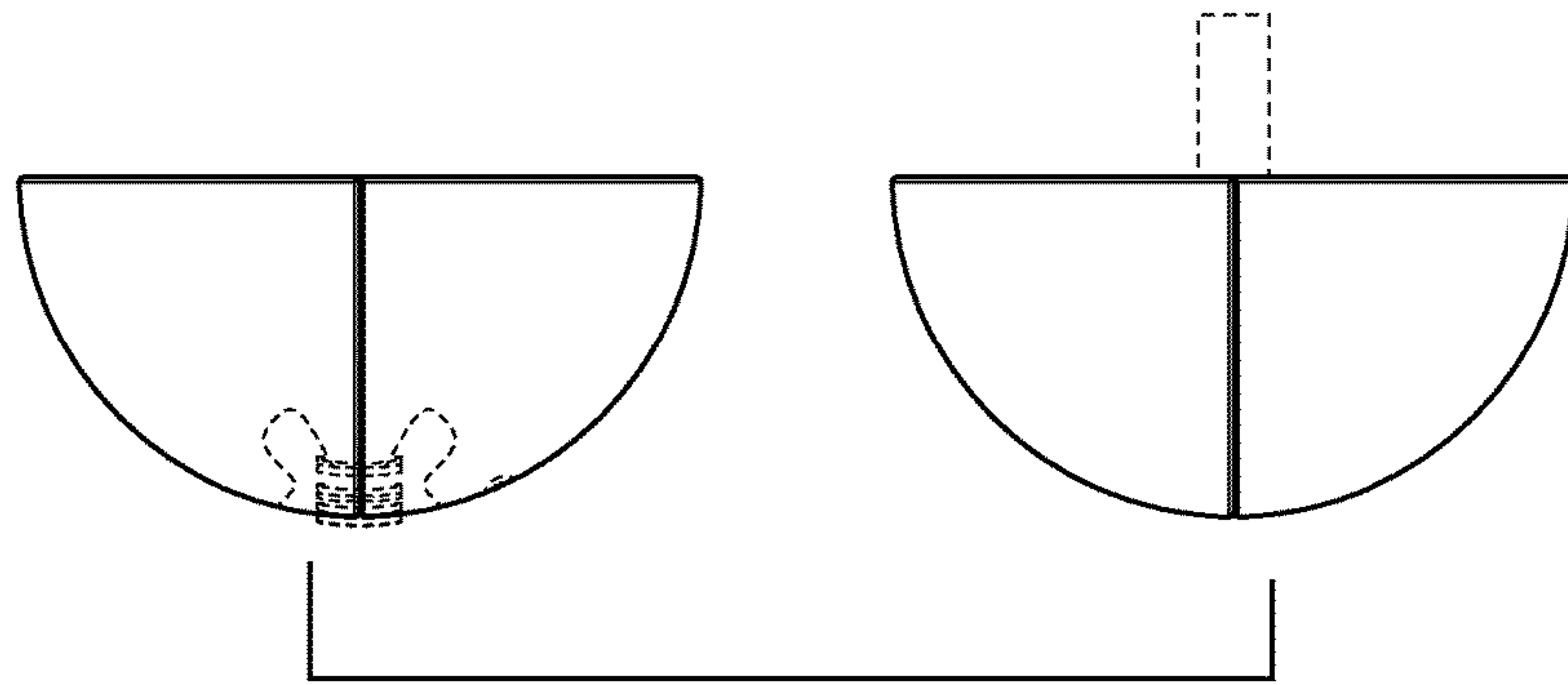

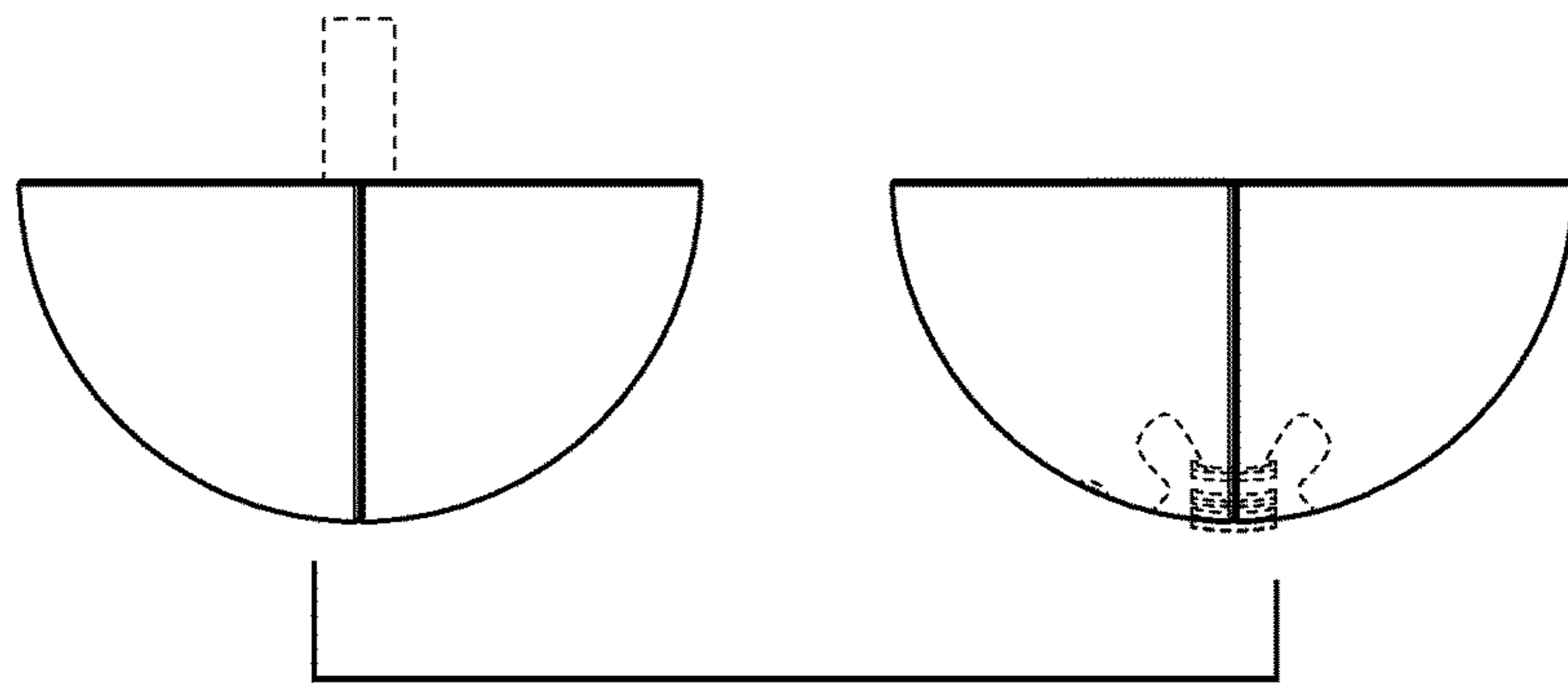

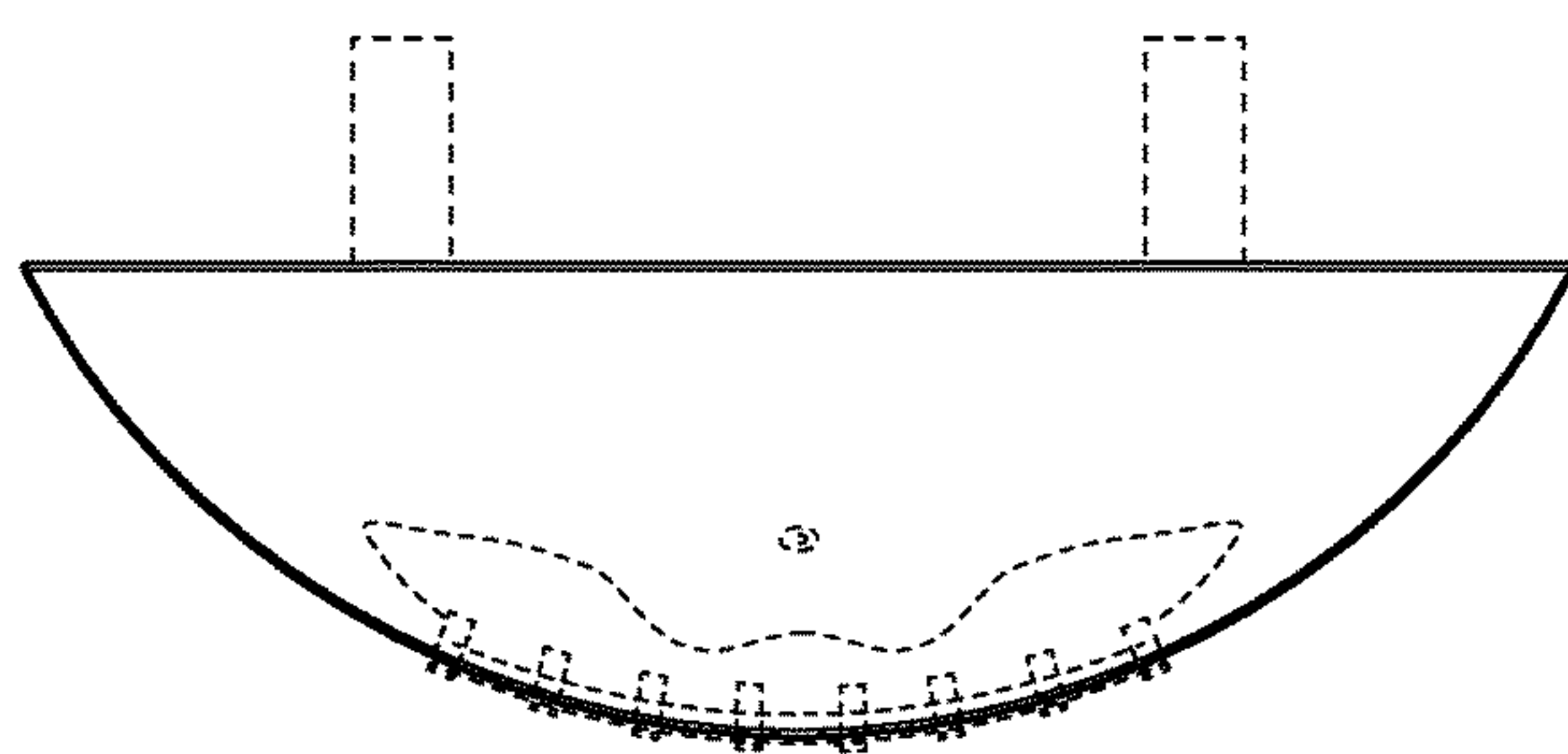

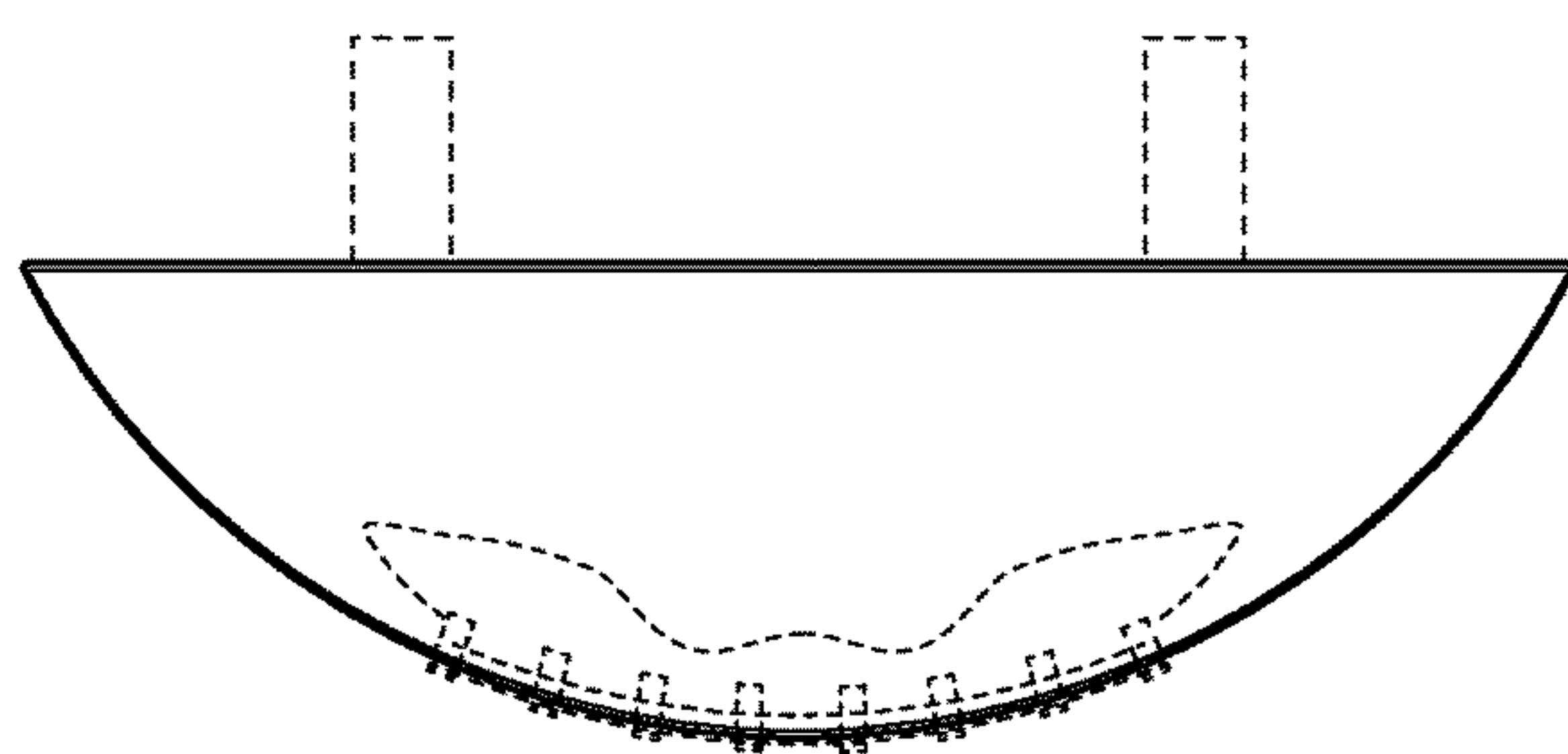

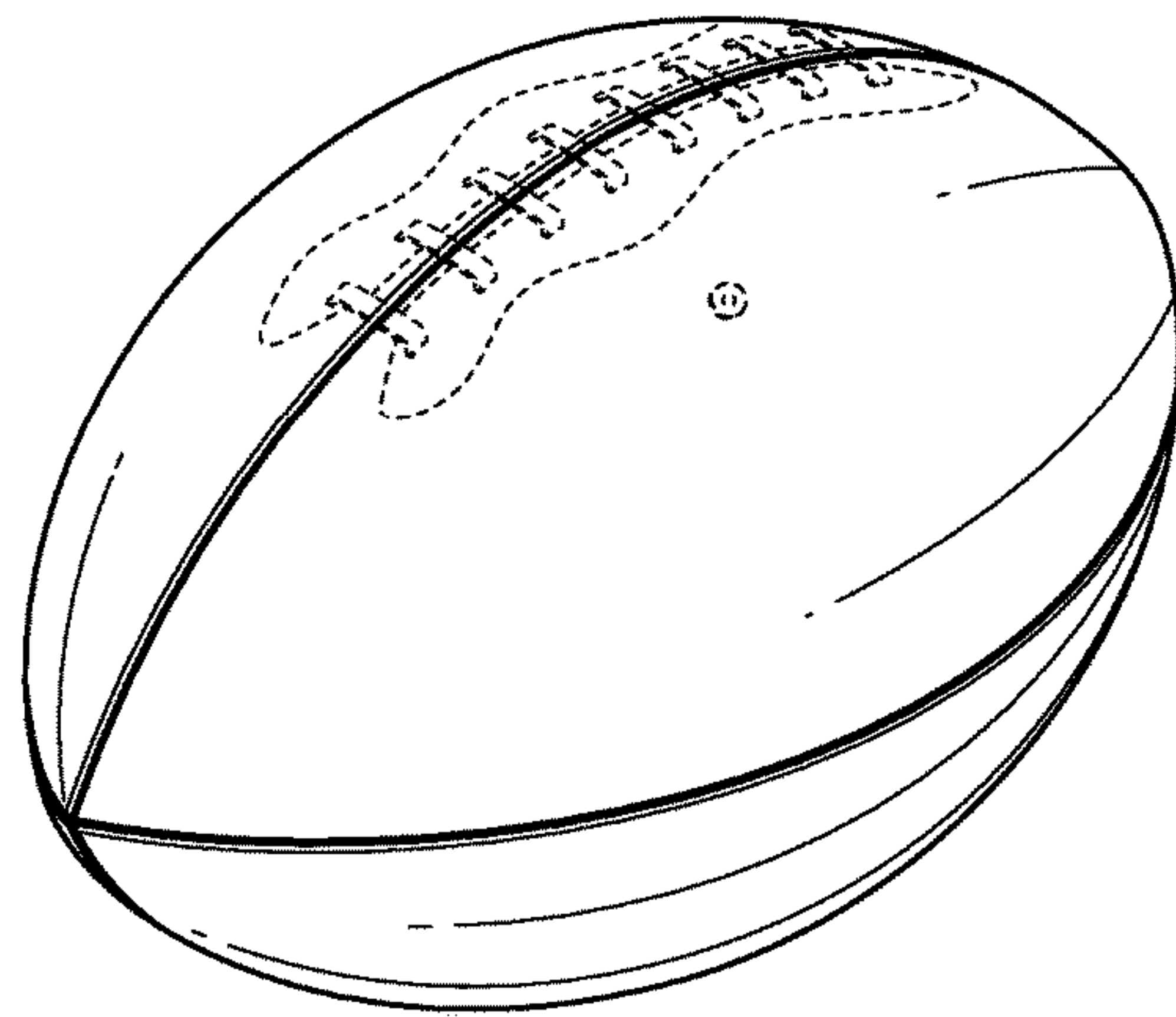
