We claim the ornamental design for a hammer, as shown and described.

DESCRIPTION

FIG. 4 is a front view of the hammer of FIG. 1.

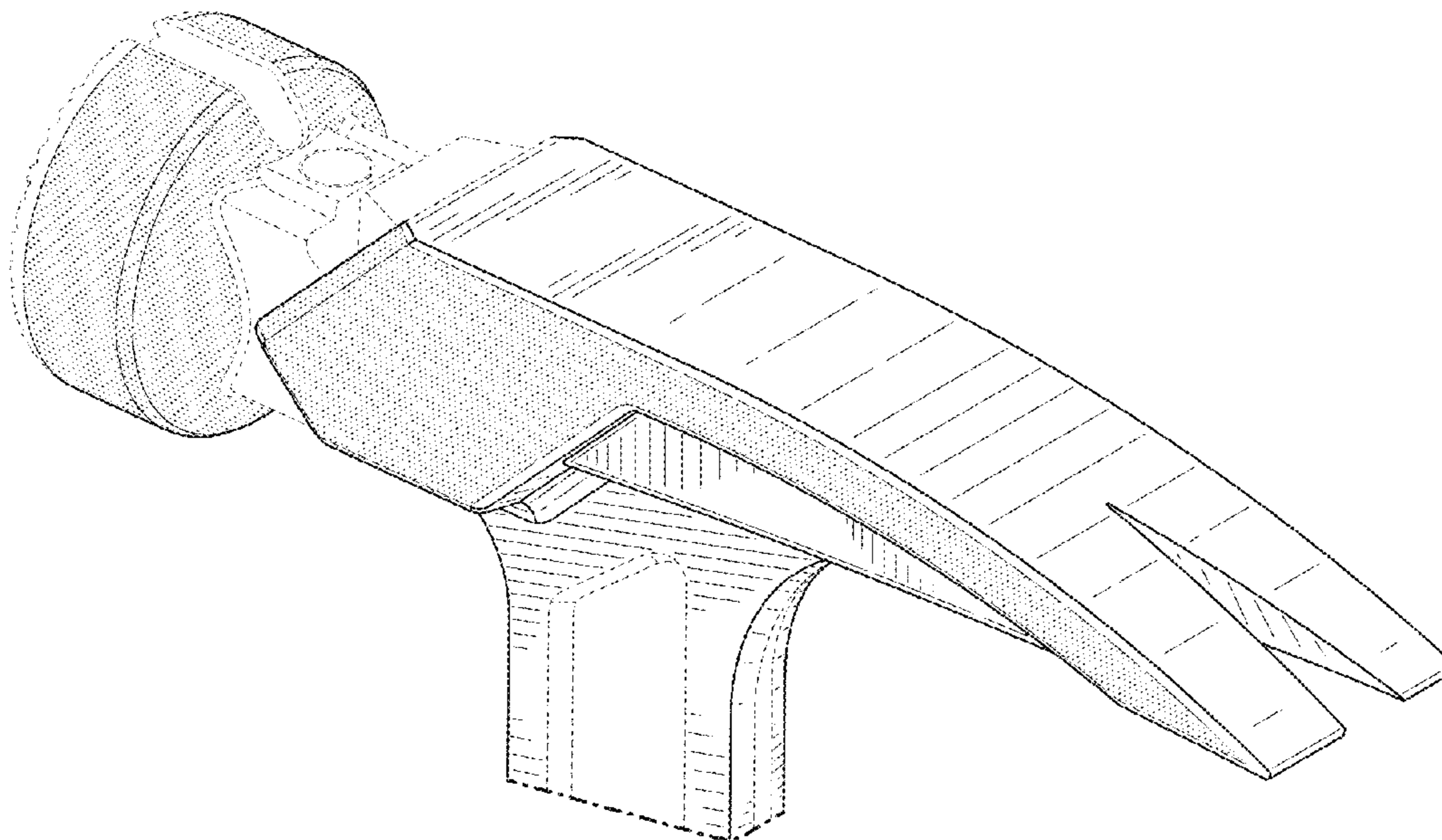
FIG. 5 is a rear view of the hammer of FIG. 1.

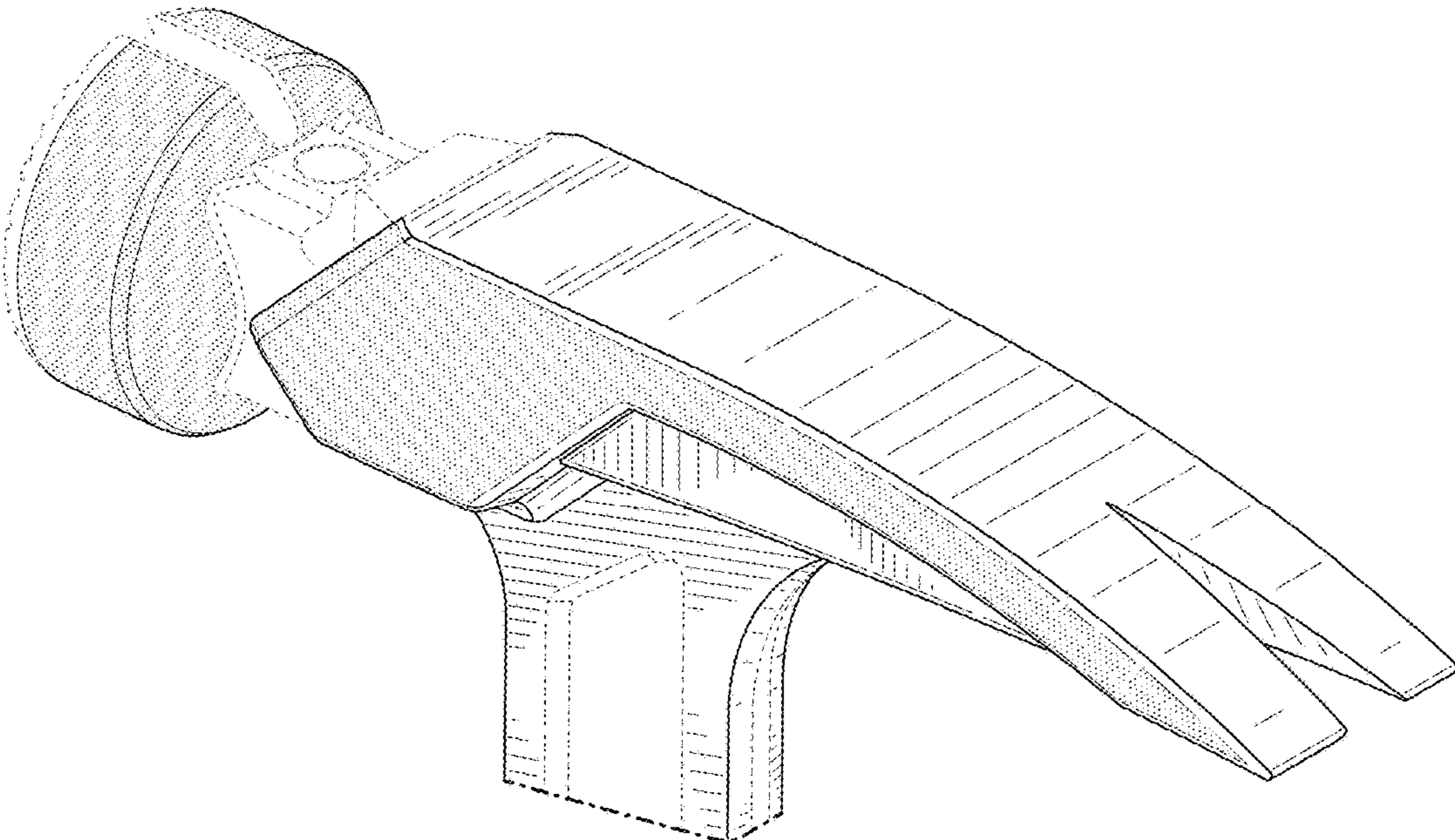

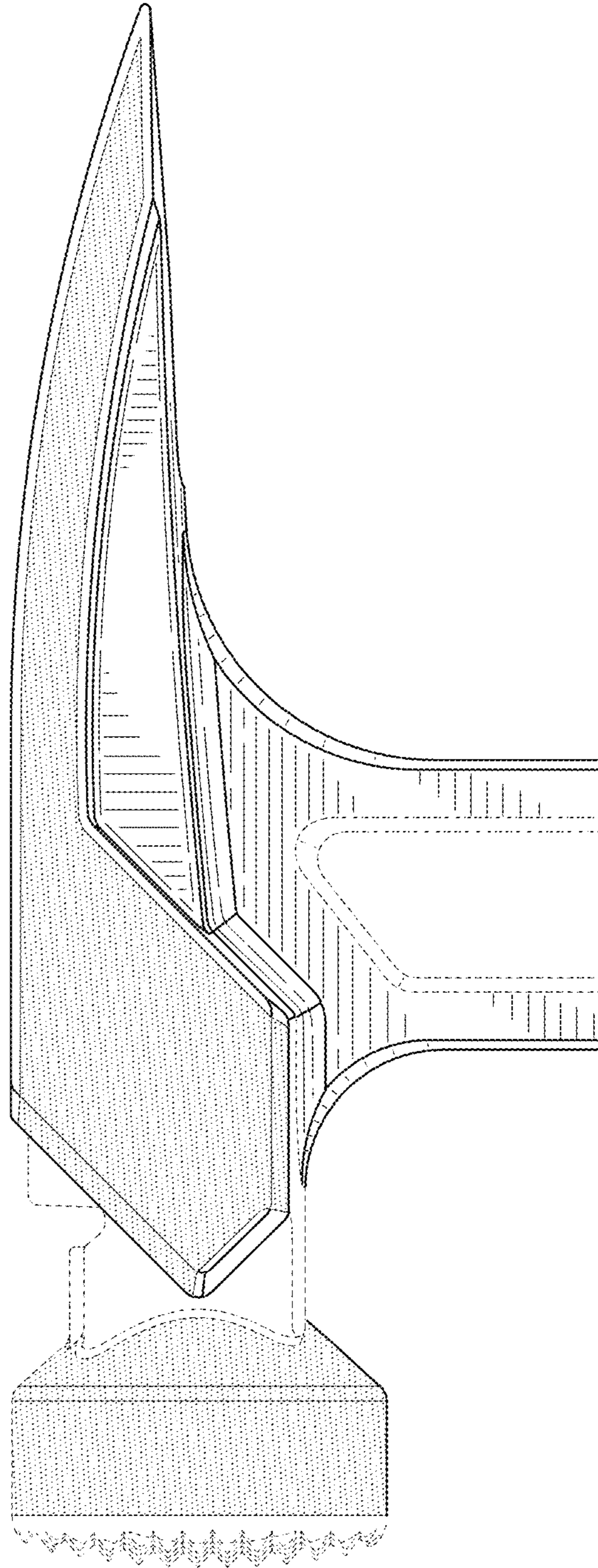

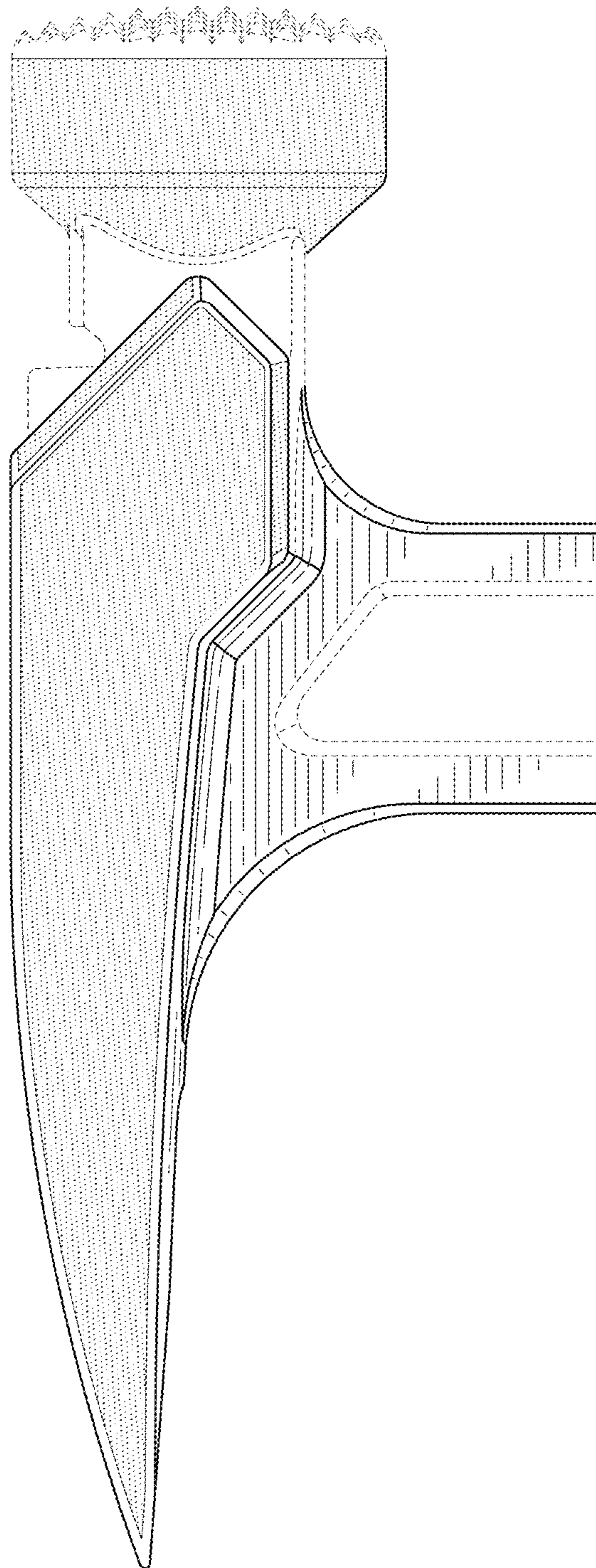

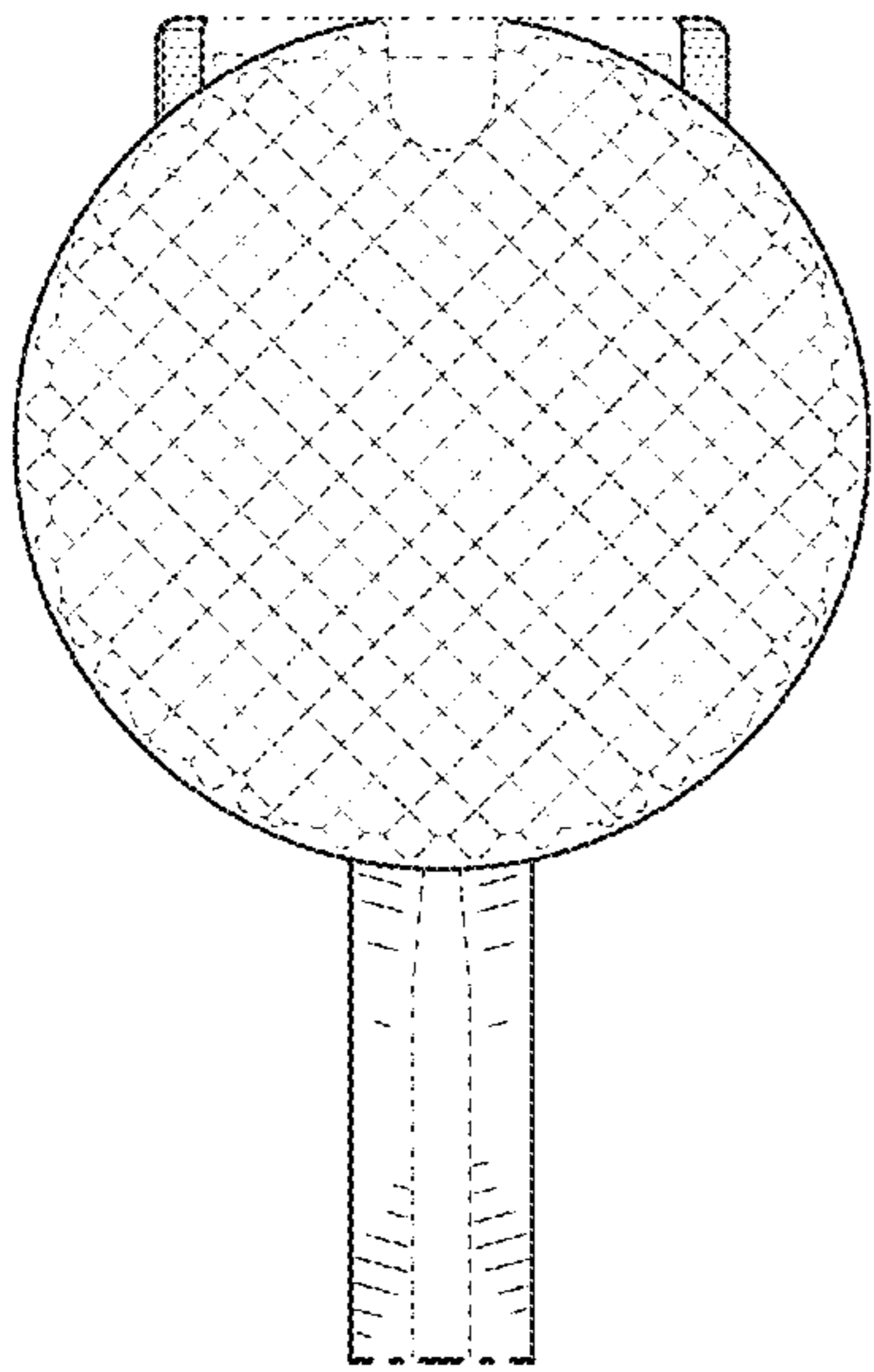

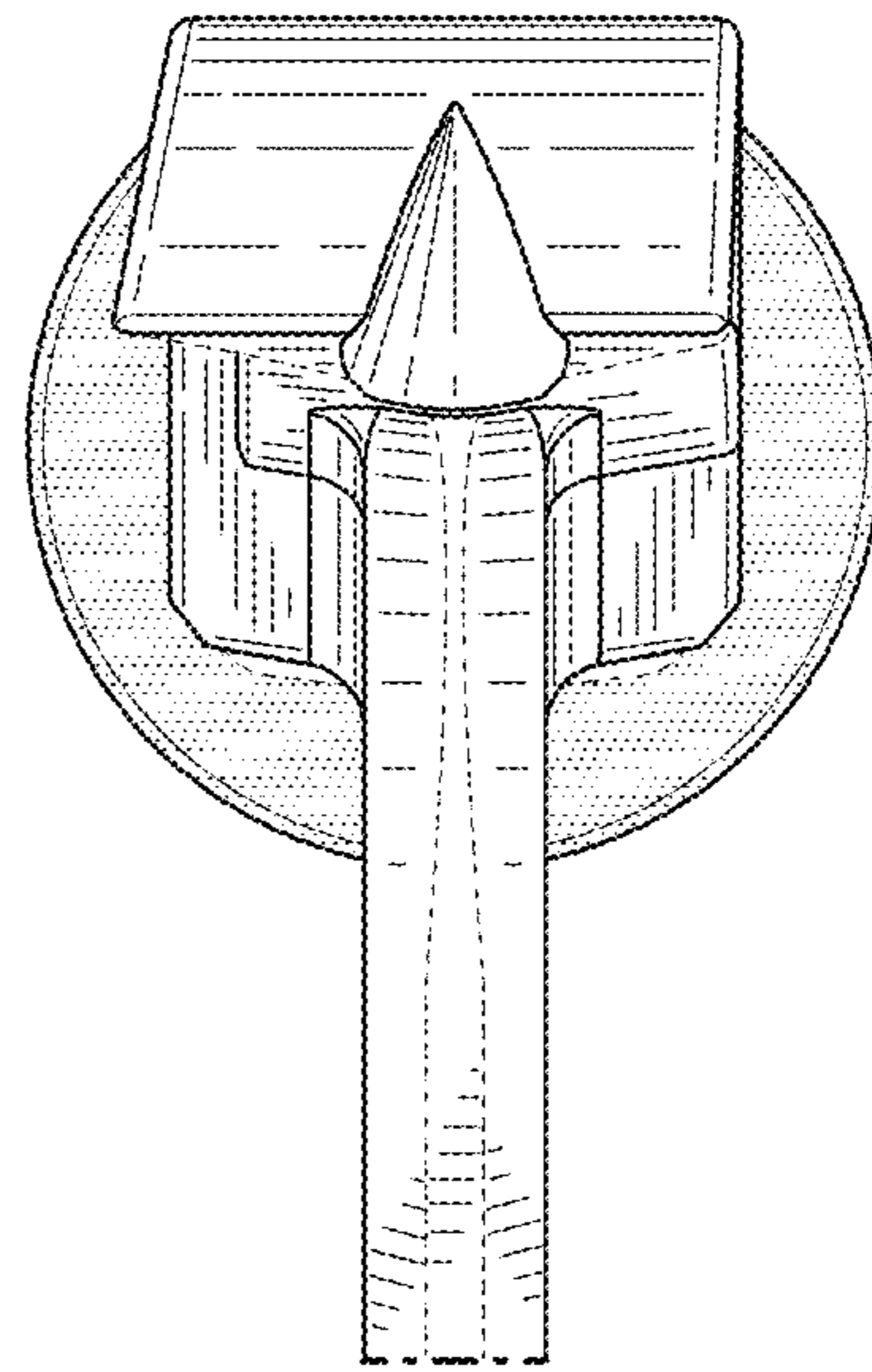

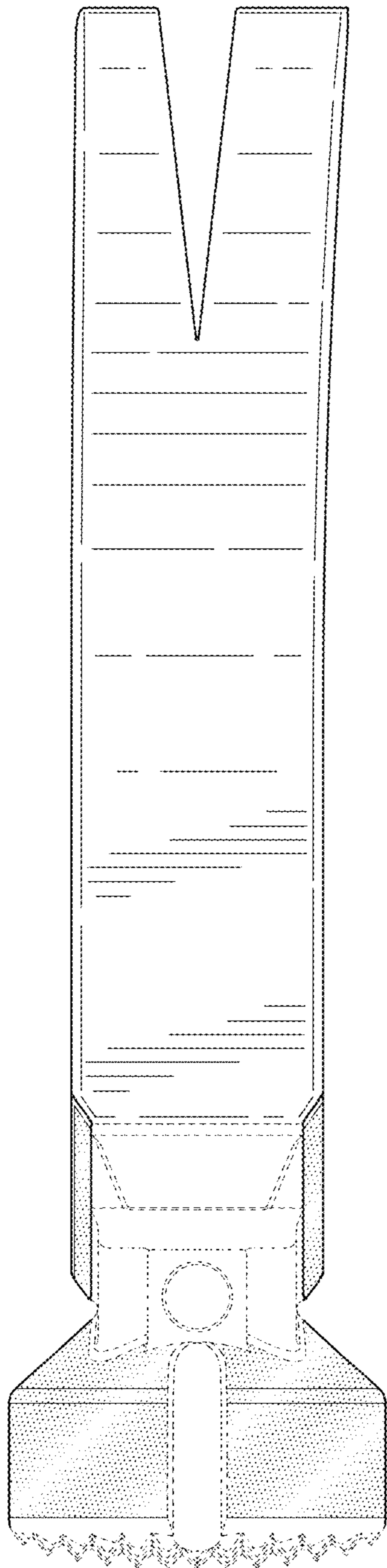

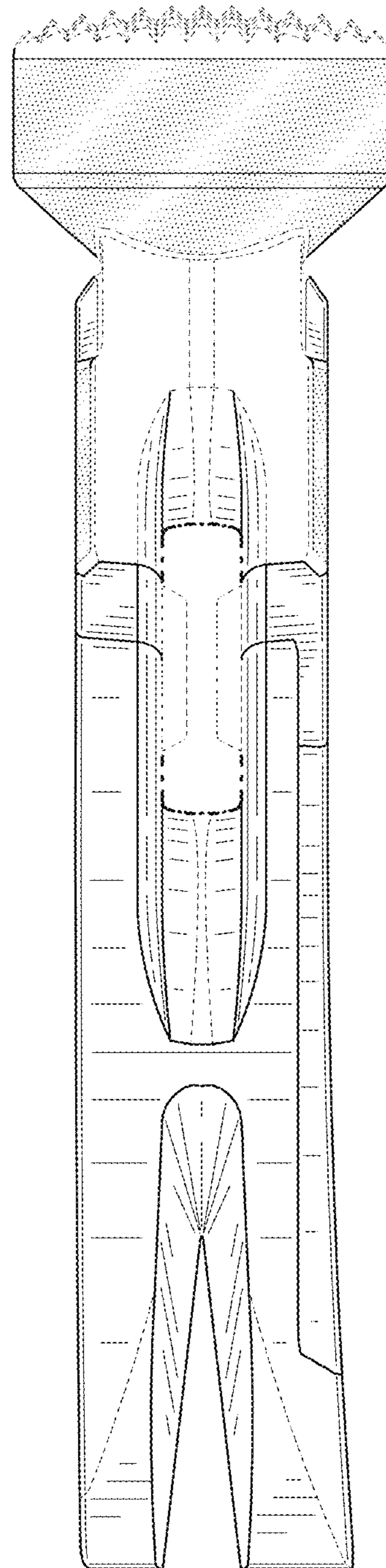
