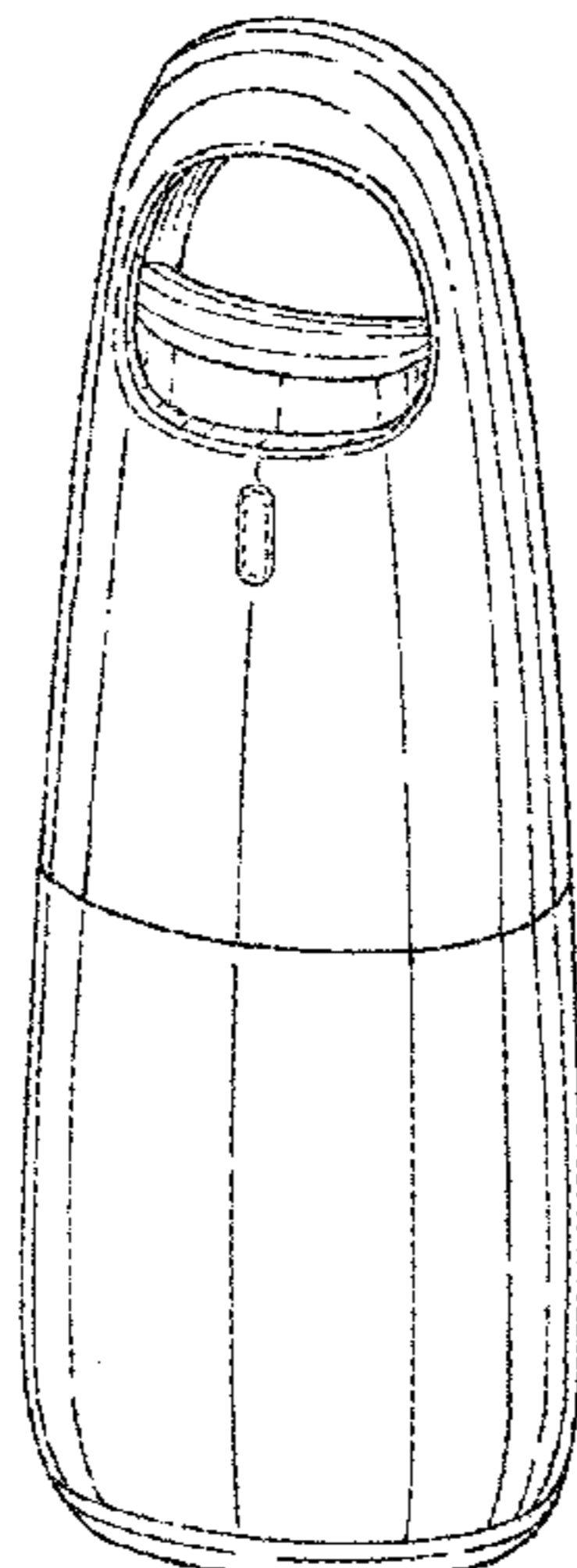
(57) **CLAIM**

The ornamental design for a sprayer, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a sprayer in accordance with the new design;
 FIG. 2 is a front perspective elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a left side isometric view thereof; the right side isometric view being a mirror image thereof;
 FIG. 5 is a bottom plan view thereof; and,
 FIG. 6 is a top perspective view thereof.
 The broken lines shown in FIGS. 1, 2, and 6 illustrate portions of the sprayer that form no part of the claimed design.

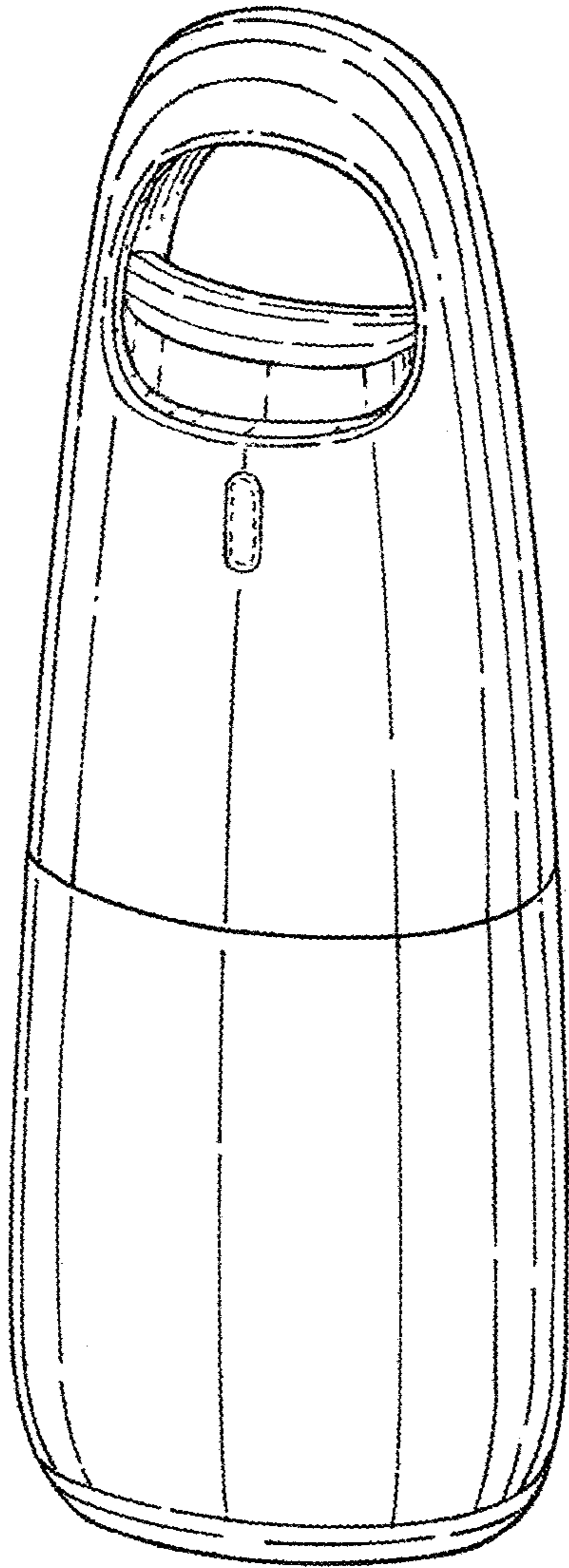

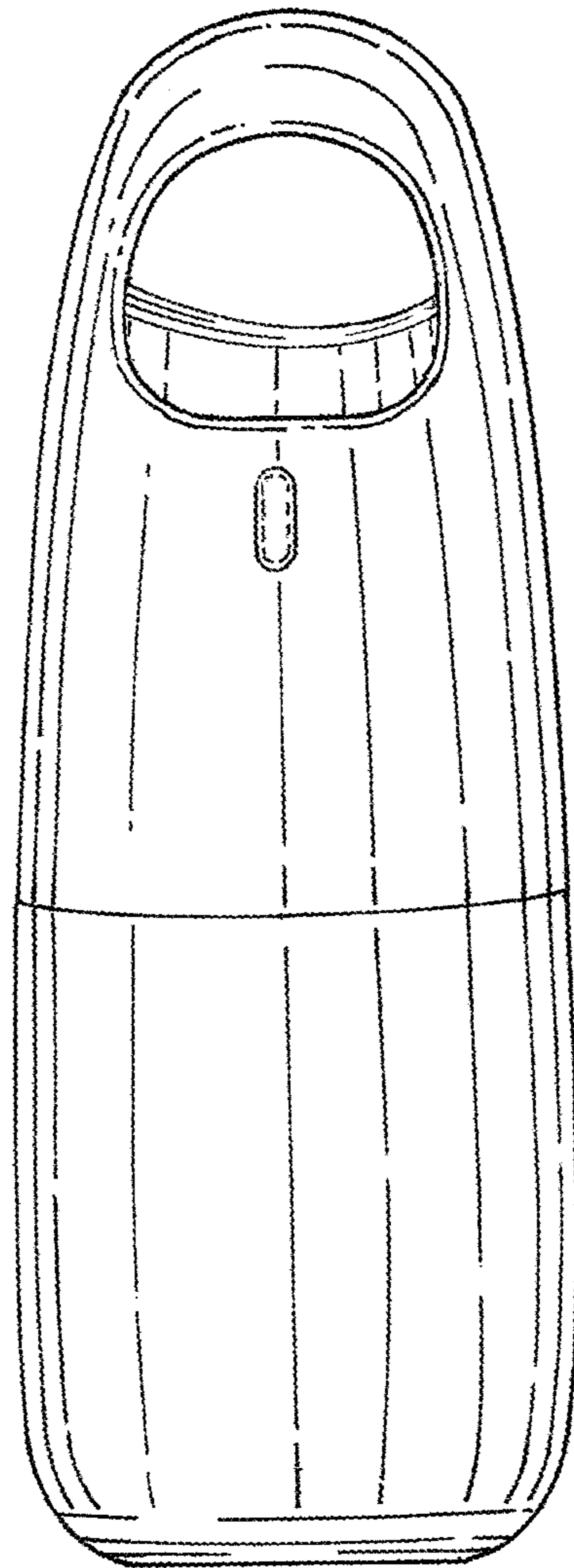

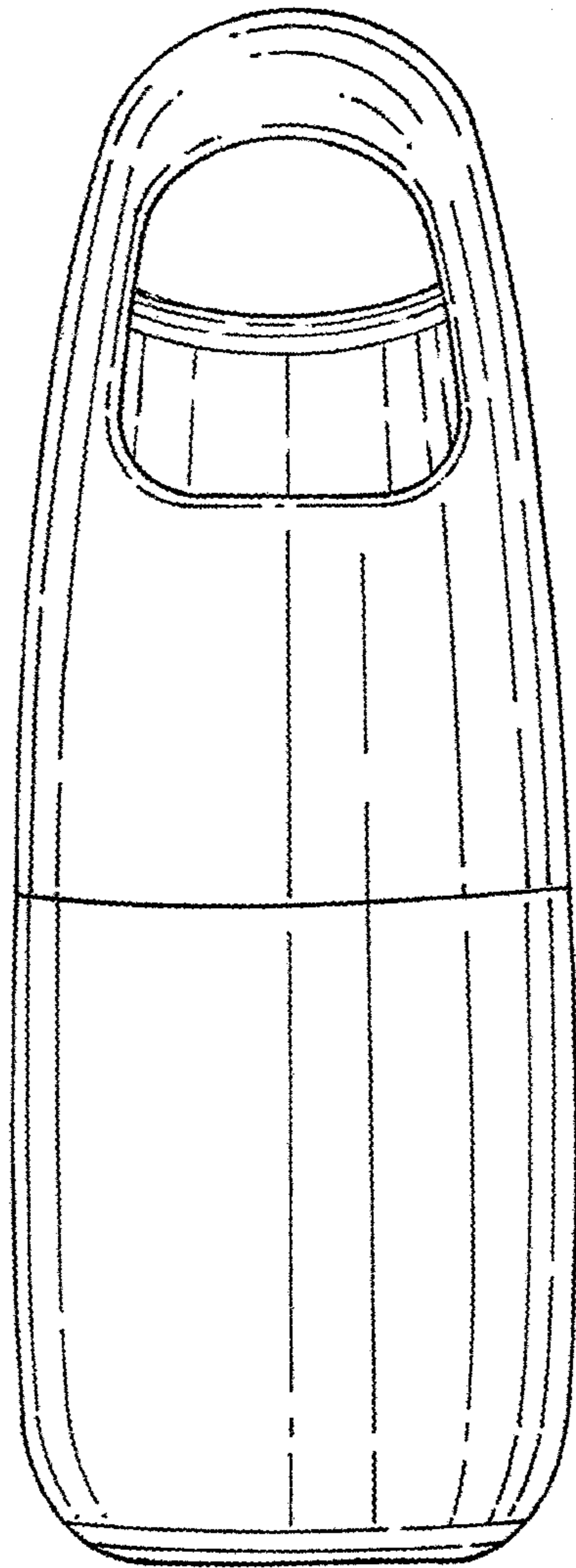

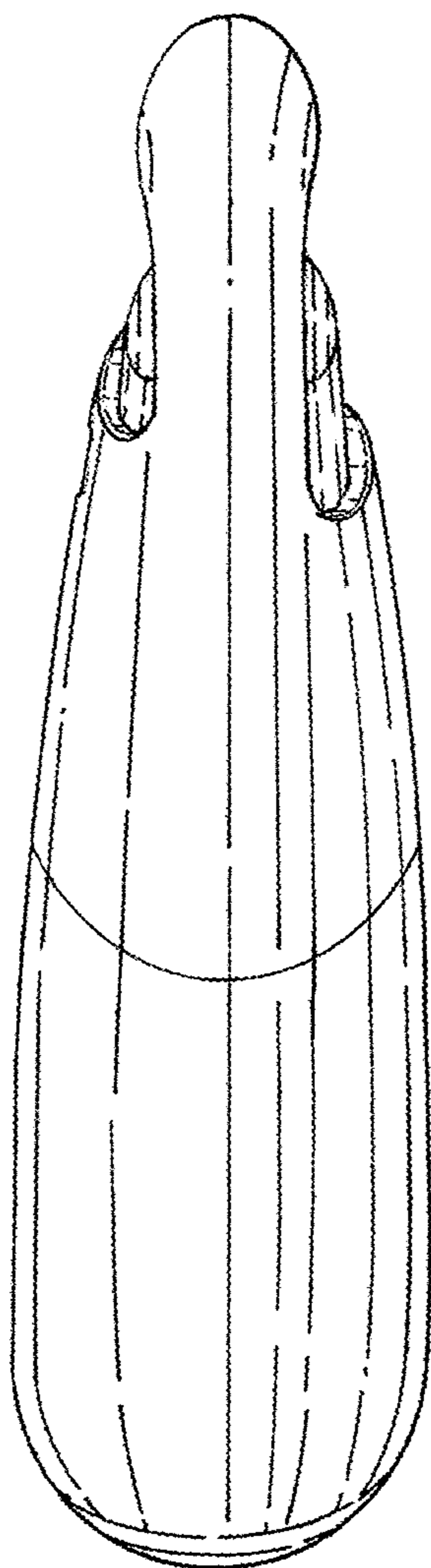

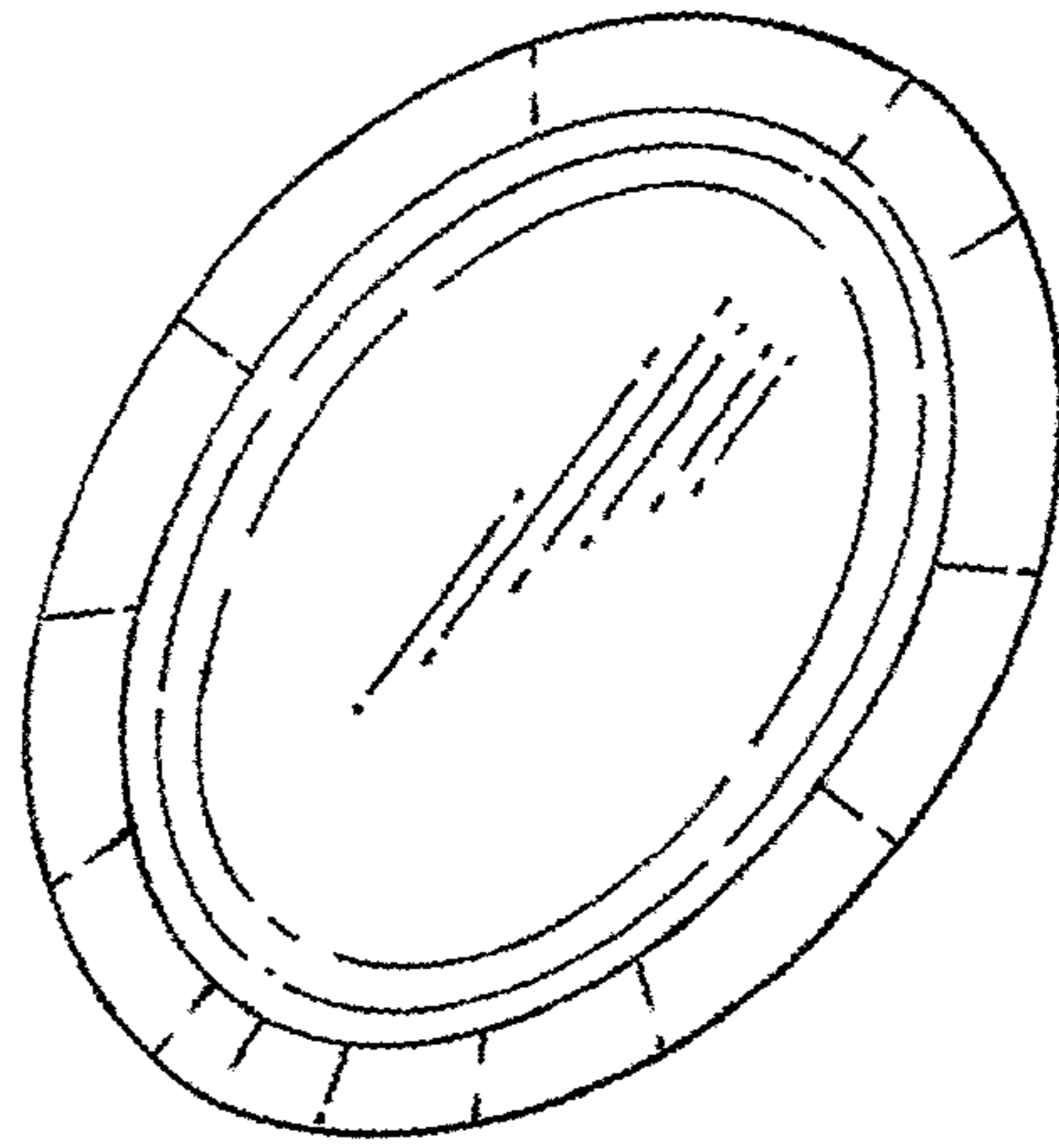

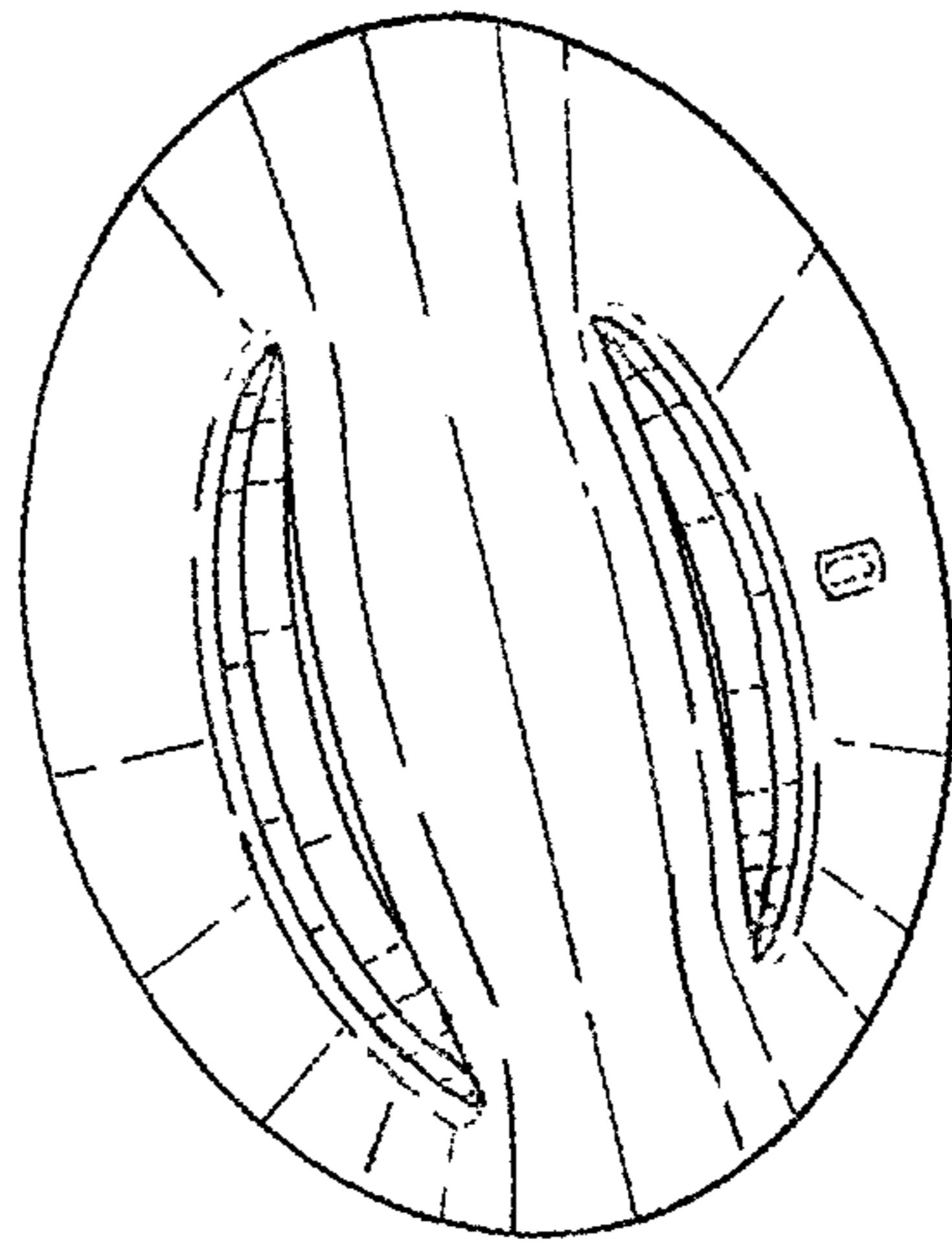
