The ornamental design for a snap fastener assembly, as shown and described.

**DESCRIPTION**

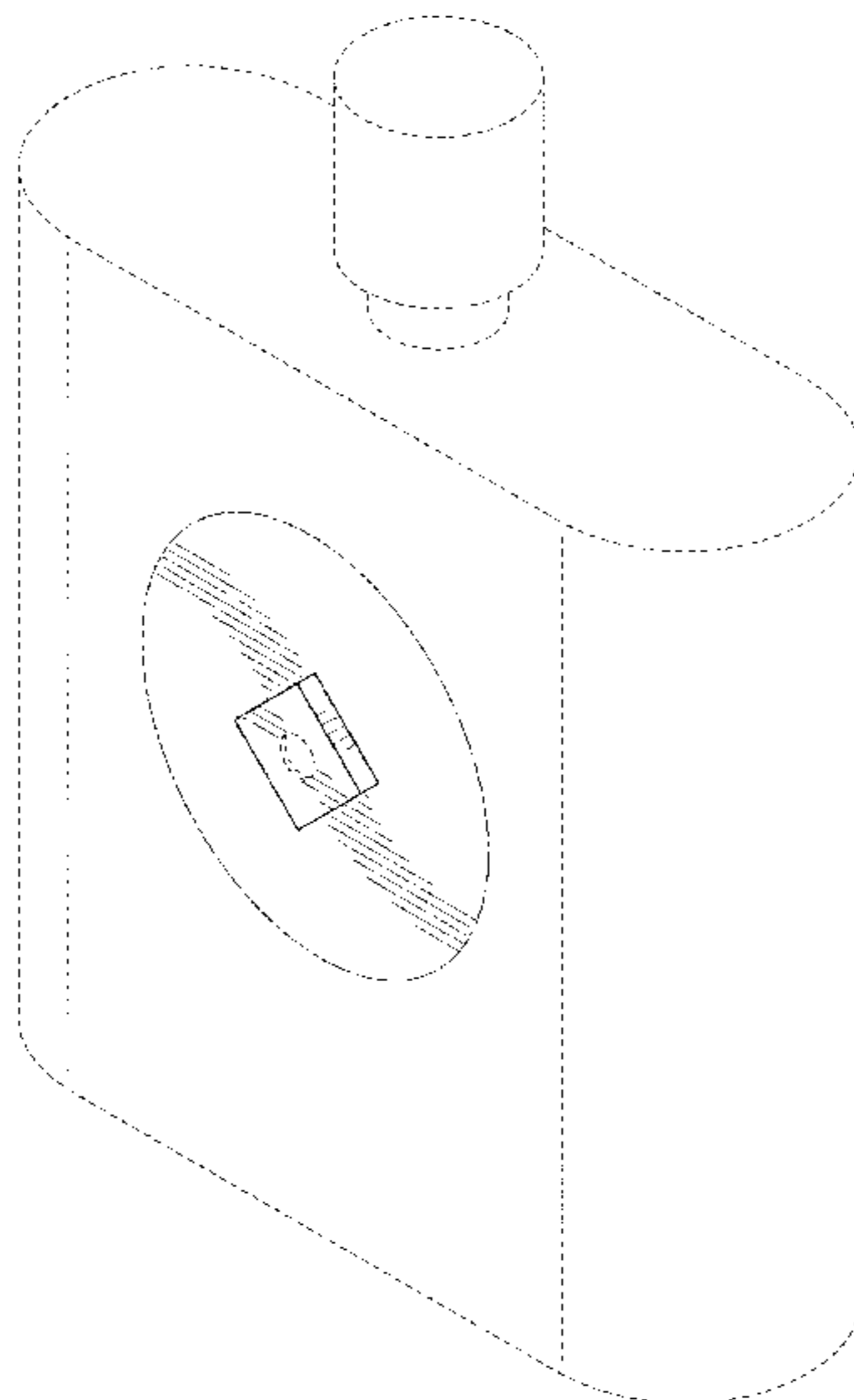
FIG. 1 is a perspective view of a female piece of a snap fastener assembly;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a right side elevation view thereof, the left side elevation view being symmetrical thereto;  
FIG. 6 is a cross-sectional view thereof, taken along 6-6 of FIG. 2;  
FIG. 7 is a perspective view of a male piece of the snap fastener assembly;  
FIG. 8 is top plan view thereof, the bottom plan view being omitted as it does not include any claimed features;  
FIG. 9 is a rear elevation view thereof;  
FIG. 10 is a top plan view thereof, the bottom plan view being mirror symmetrical thereto; and,  
FIG. 11 is a cross-sectional view thereof, showing the male piece mated with the female piece.  
The short dash-short dash lines in the figures illustrate portions of the snap fastener assembly that form no part of the claimed design. The long dash-short dash lines indicate a surface boundary of the snap fastener assembly.

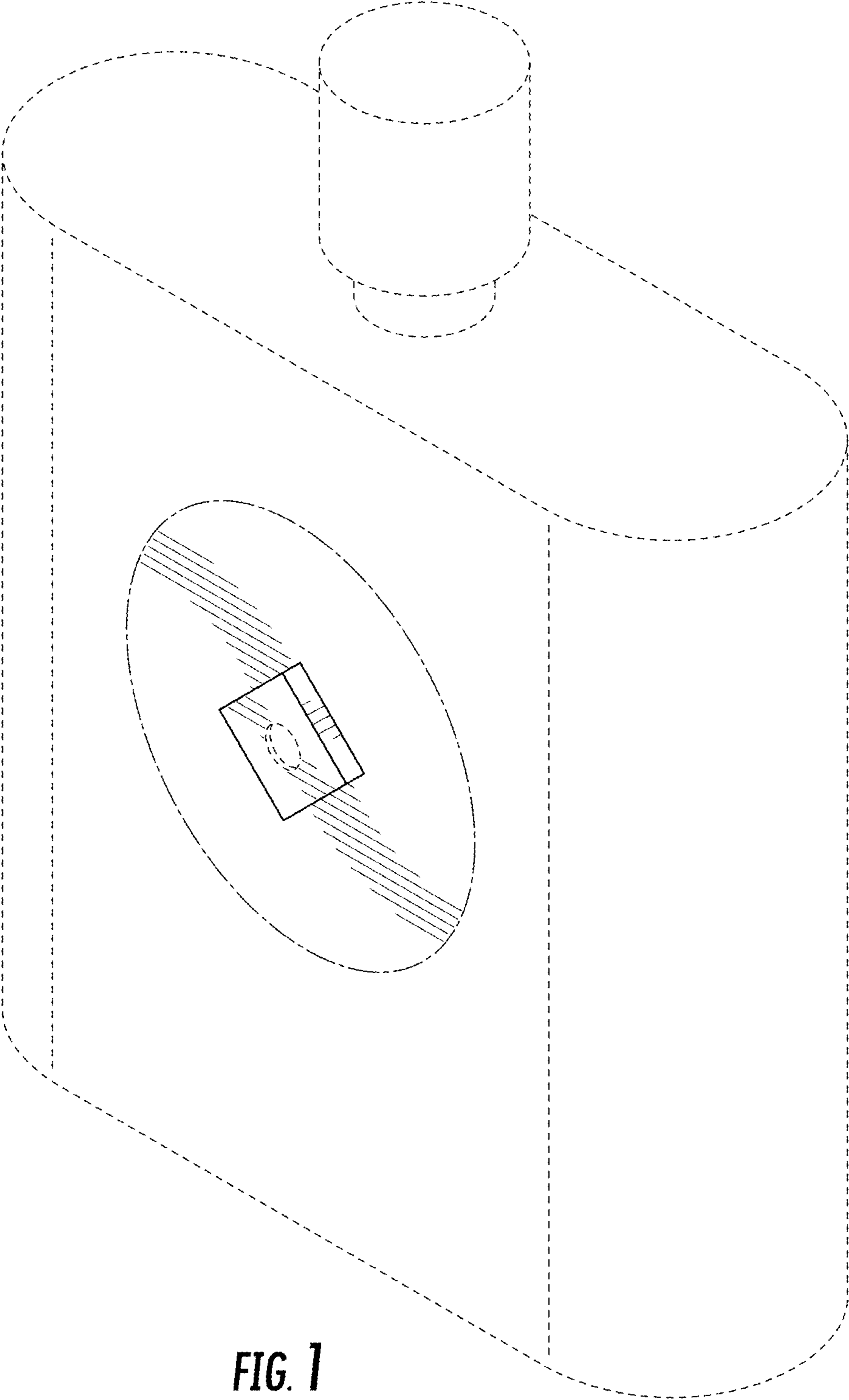

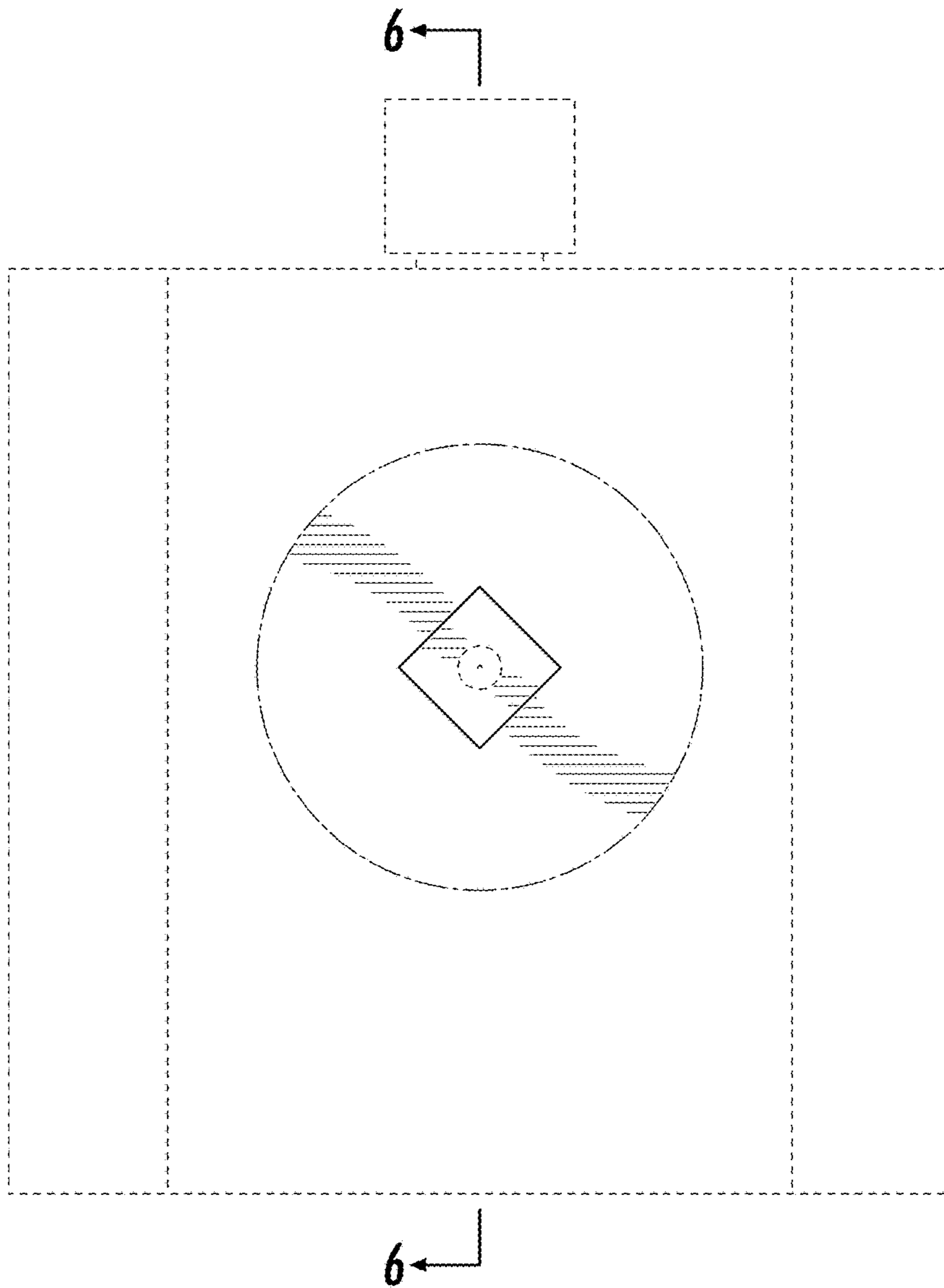
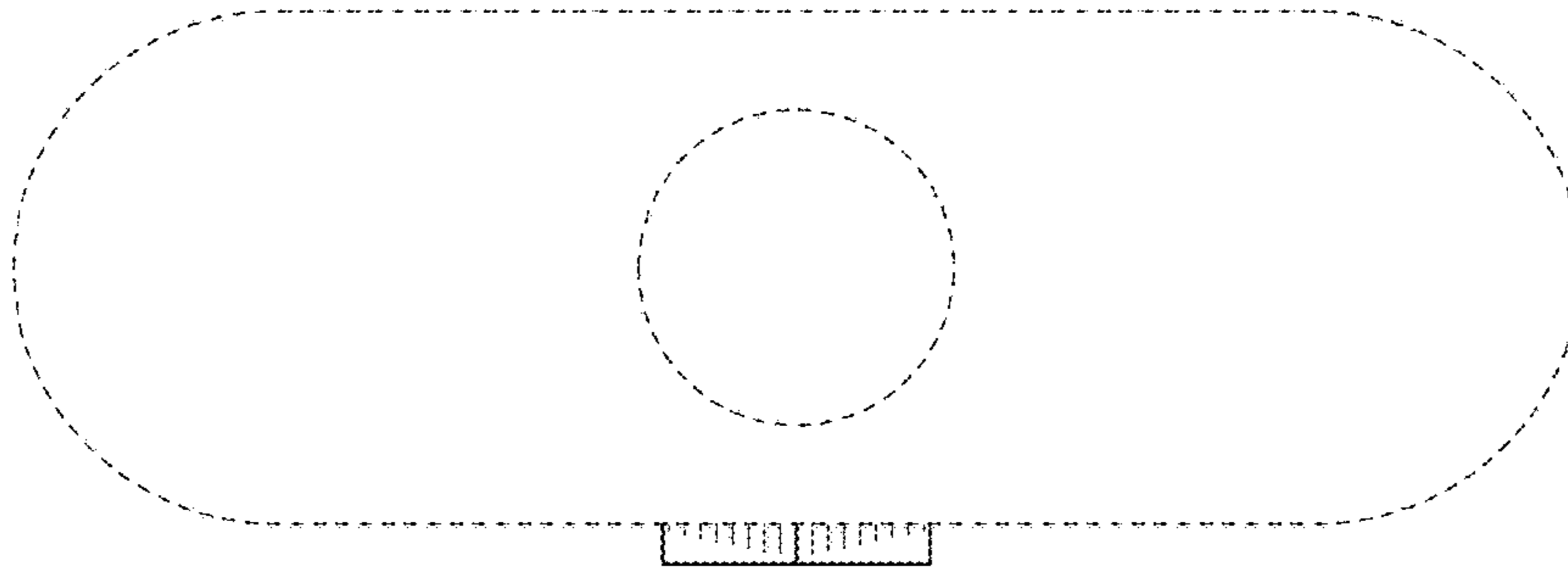
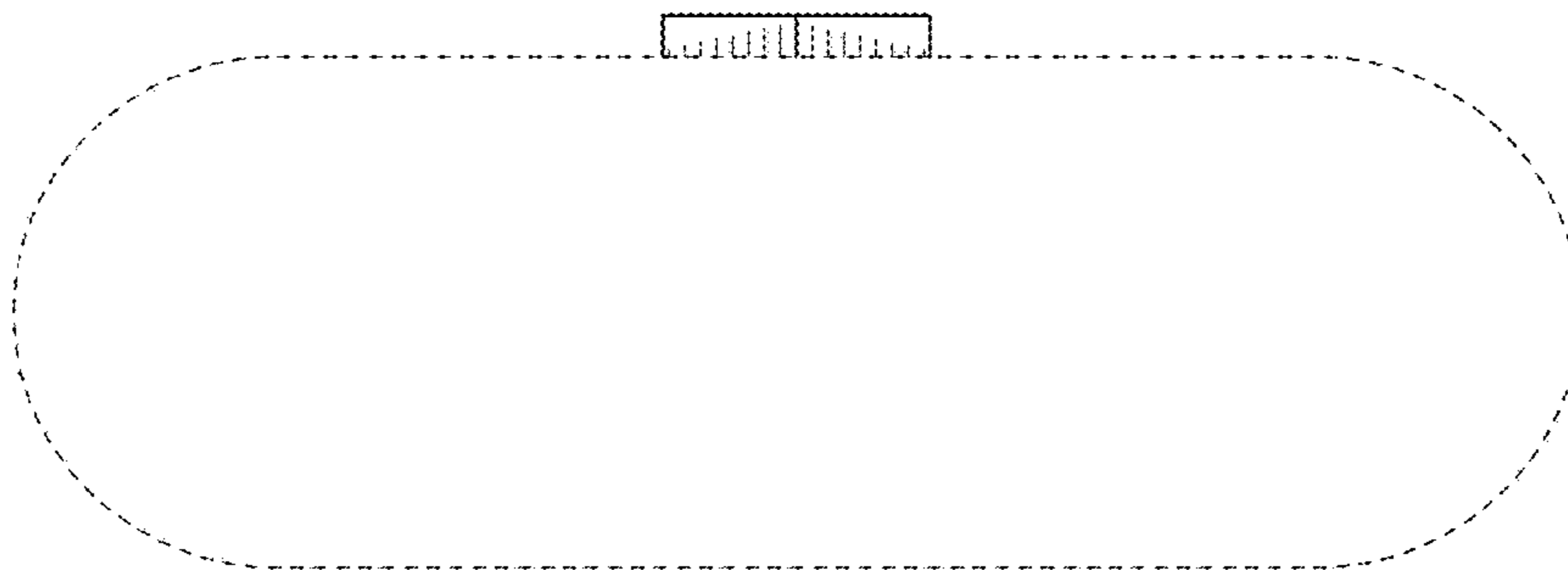

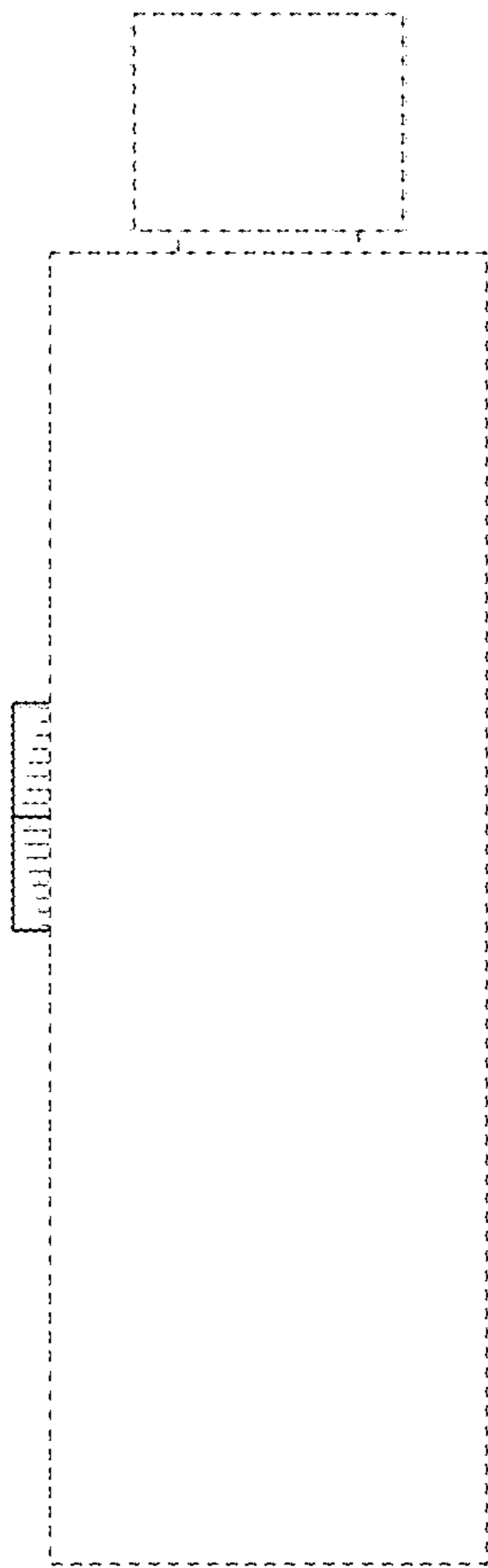

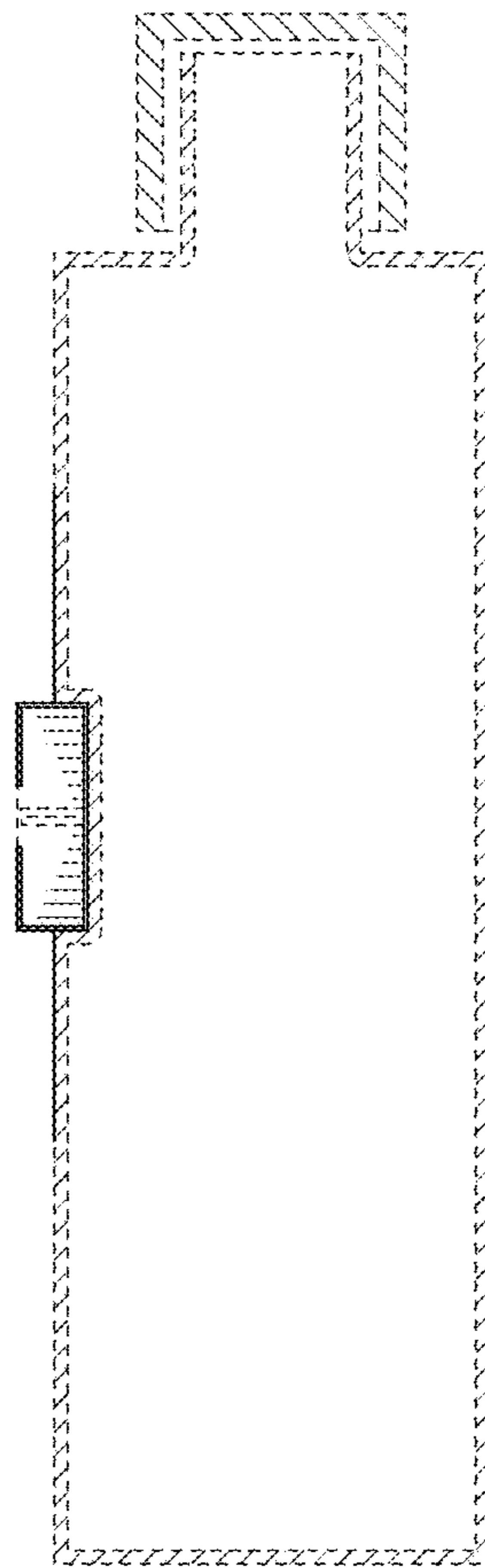

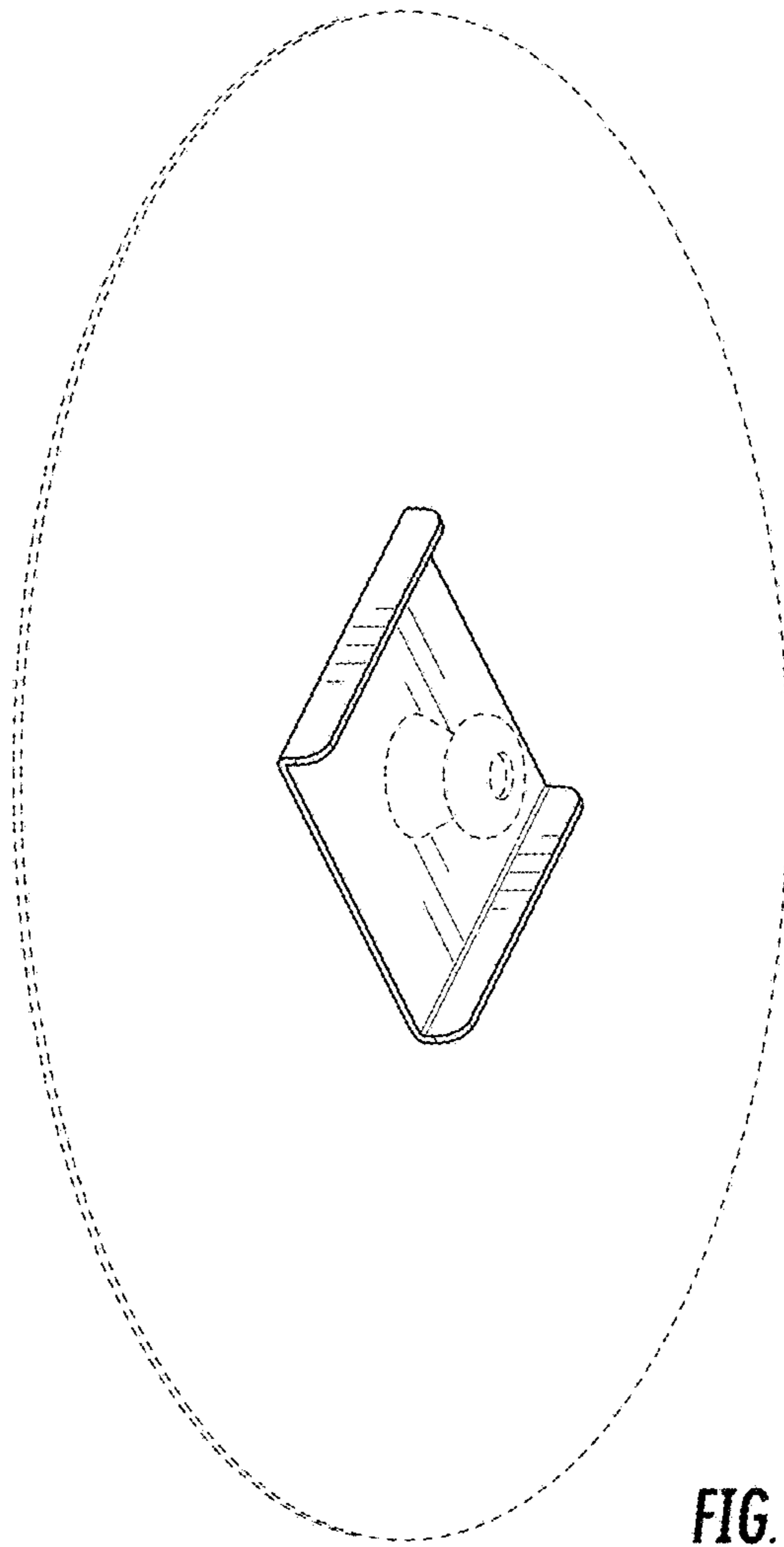

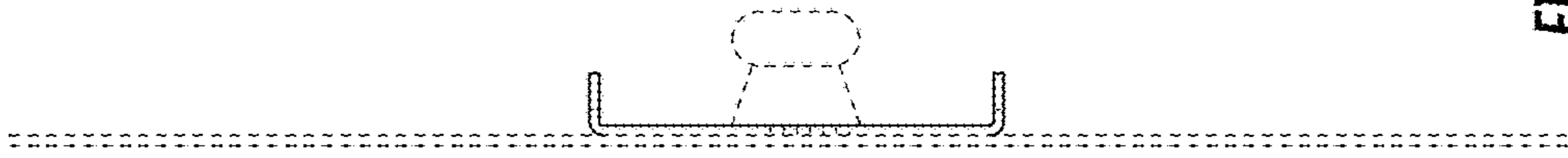

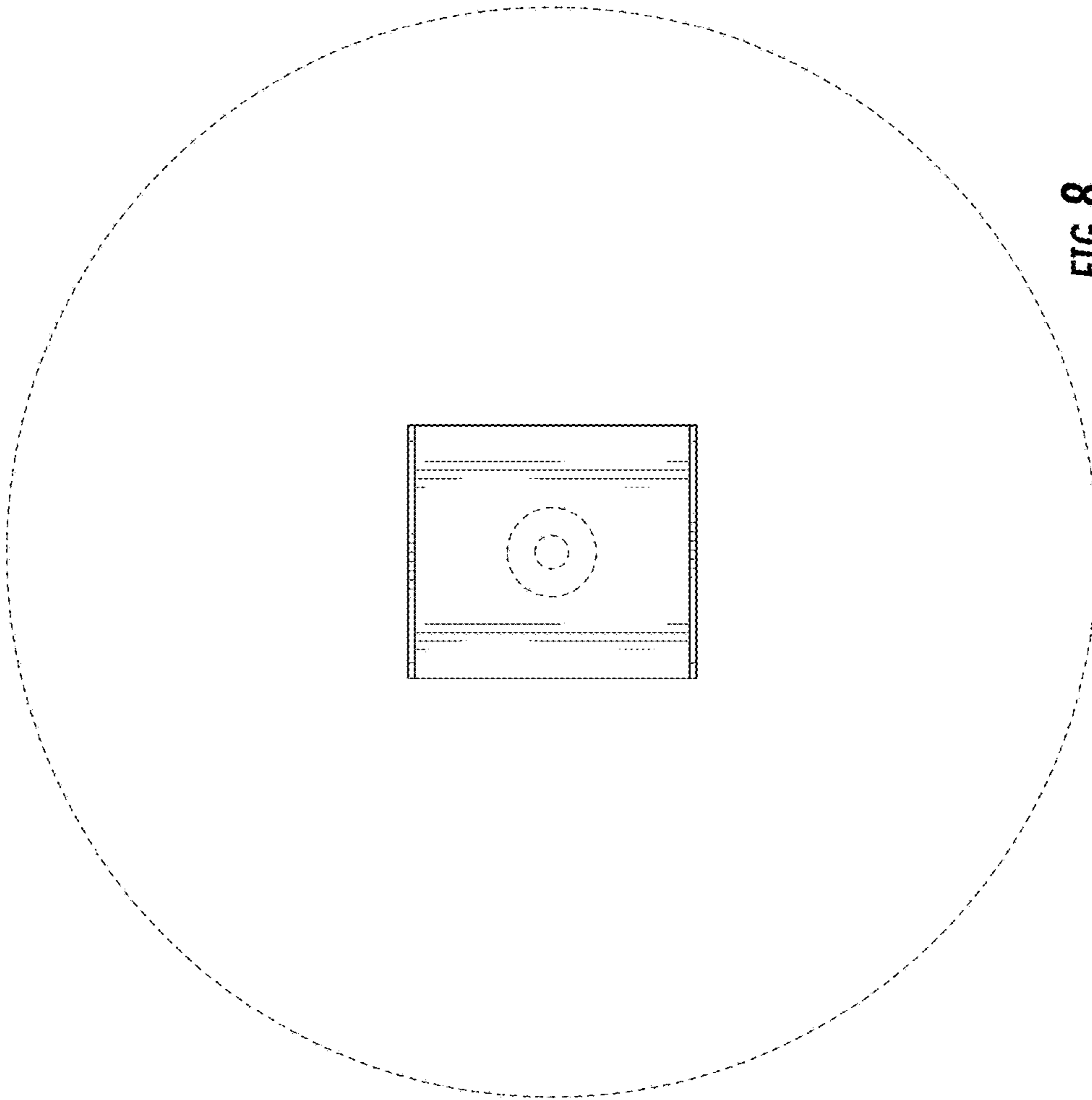
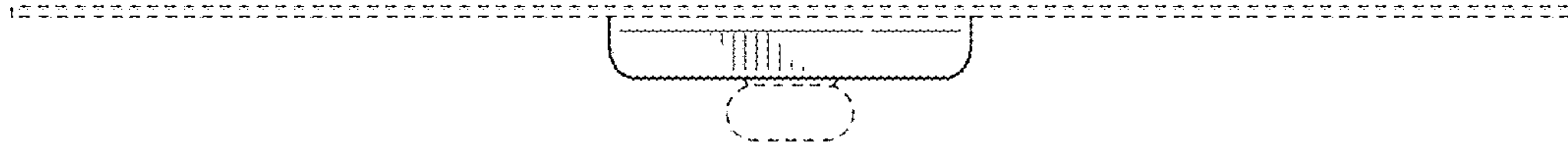
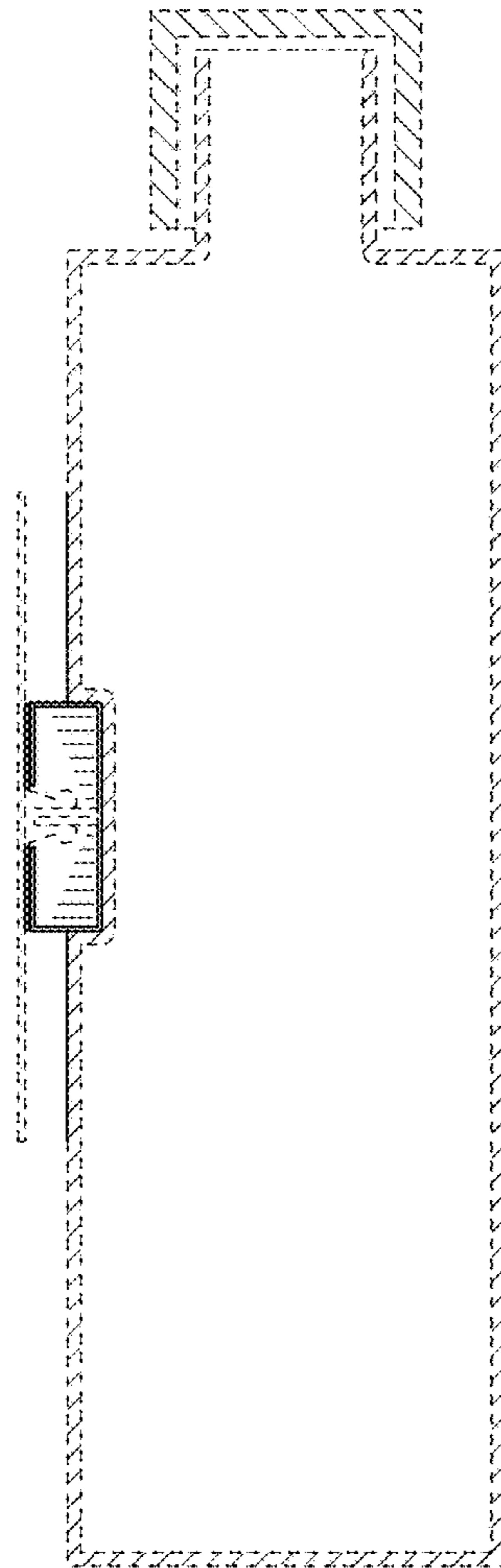
