(57) **CLAIM**

We claim the ornamental design for a loudspeaker cabinet, as shown and described in the figures.

**DESCRIPTION**

FIG. 1 is a perspective view of a loudspeaker cabinet, embodying aspects of the invention.

FIG. 2 is a second perspective view of the loudspeaker cabinet shown in FIG. 1.

FIG. 3 is a third perspective view of the loudspeaker cabinet shown in FIG. 1.

FIG. 4 is a fourth perspective view of the loudspeaker cabinet shown in FIG. 1.

FIG. 5 is a front view of the loudspeaker cabinet shown in FIG. 1.

FIG. 6 is a rear view of the loudspeaker cabinet shown in FIG. 1.

FIG. 7 is a left side view of the loudspeaker cabinet shown in FIG. 1.

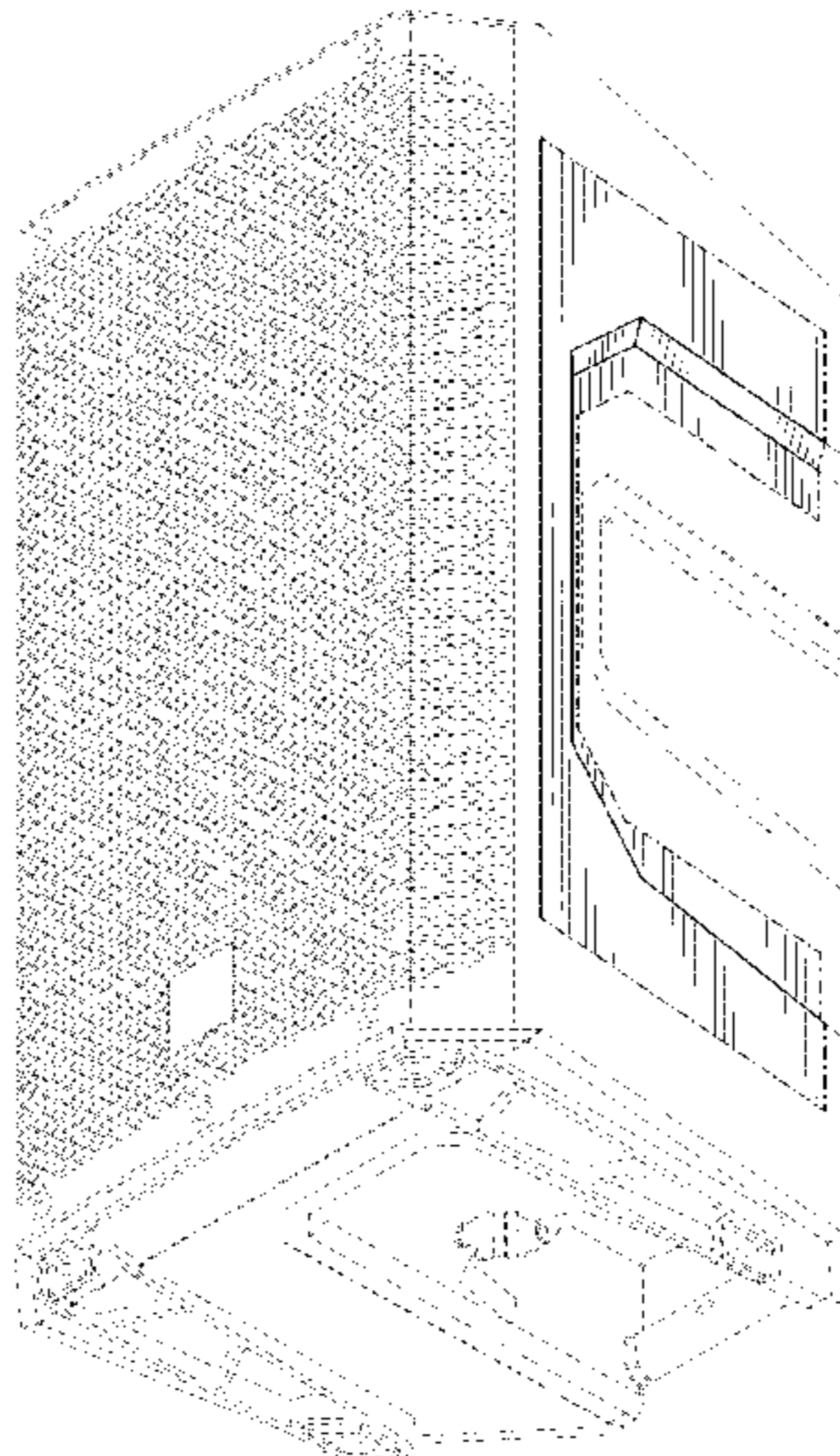
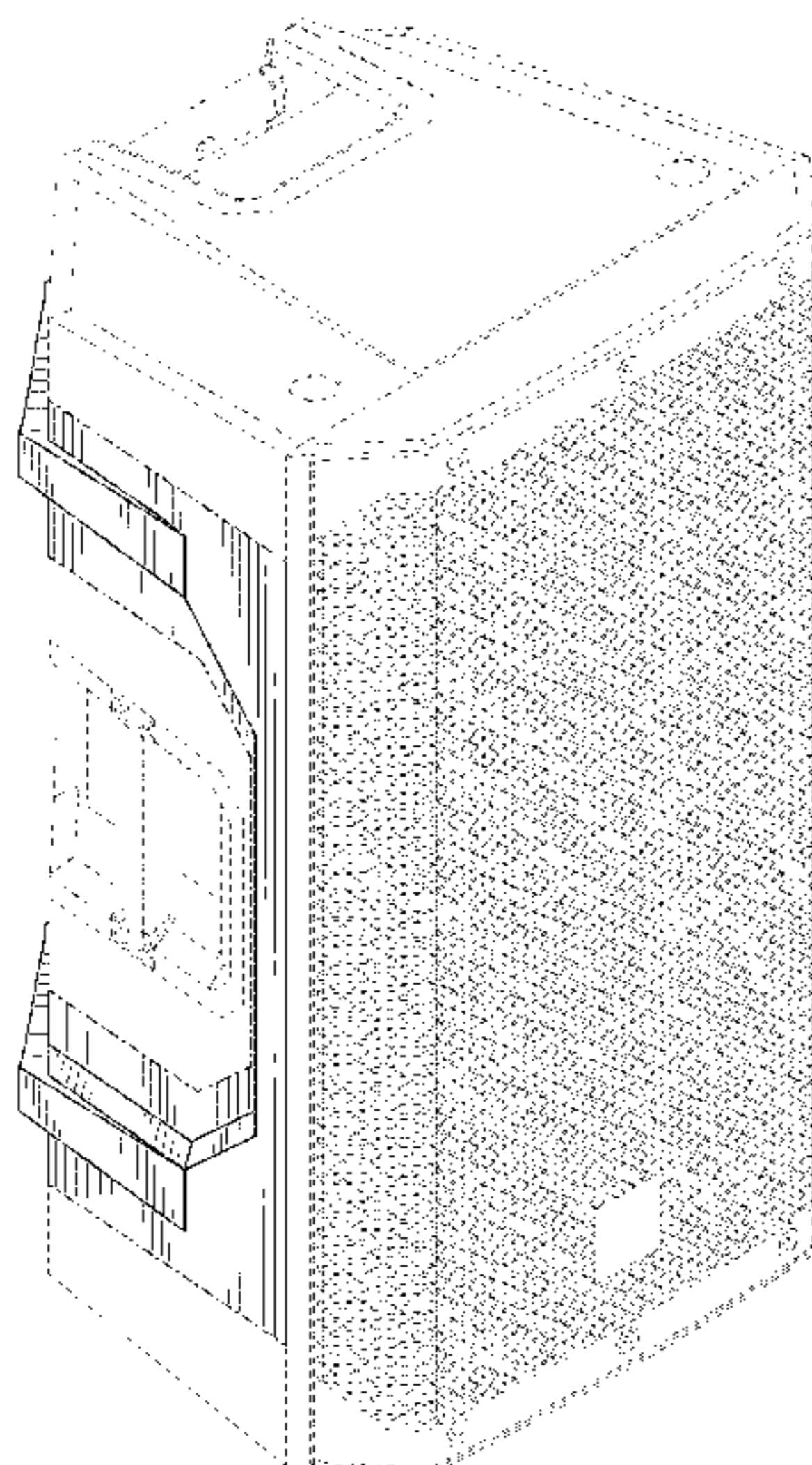
FIG. 8 is a right side view of the loudspeaker cabinet shown in FIG. 1.

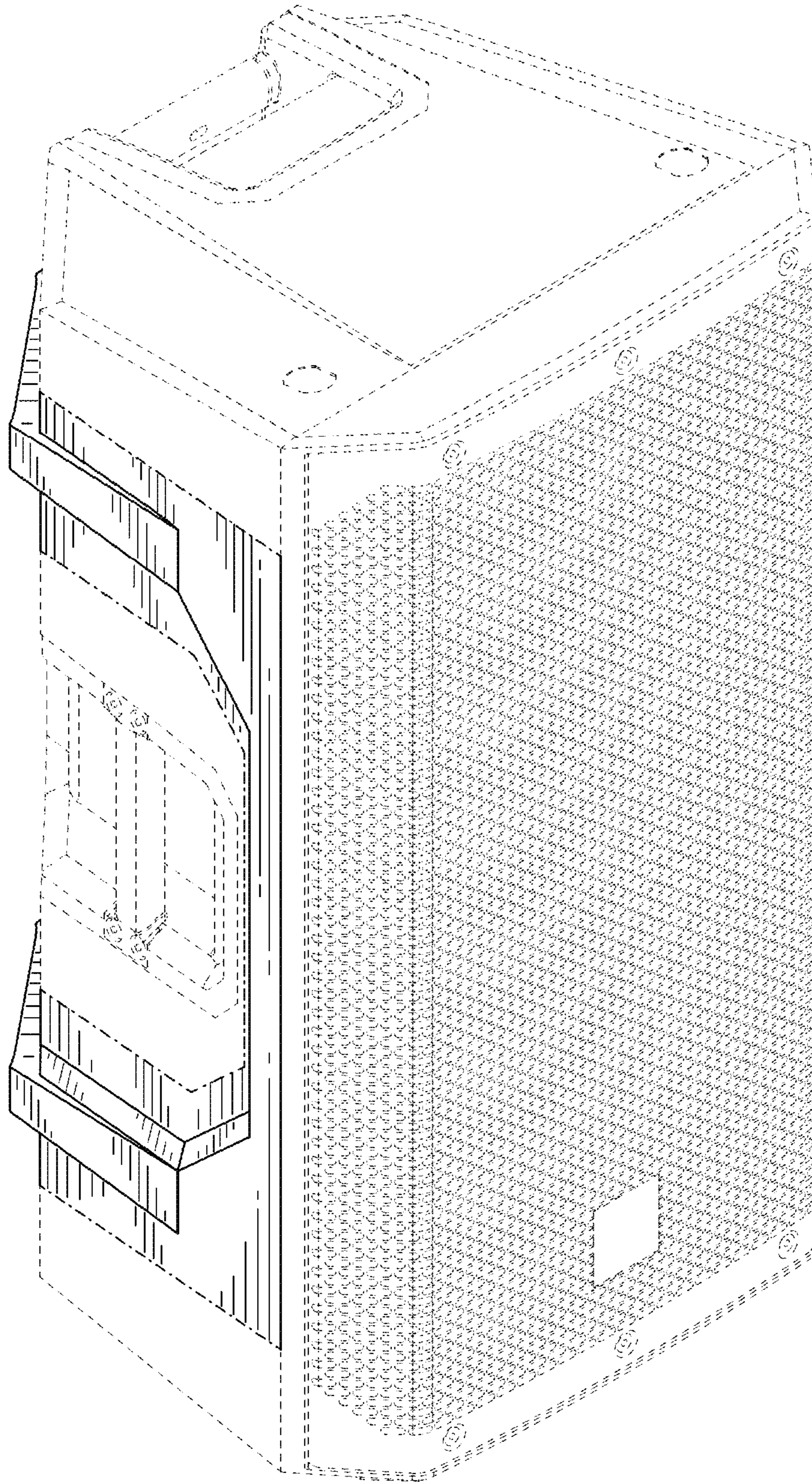

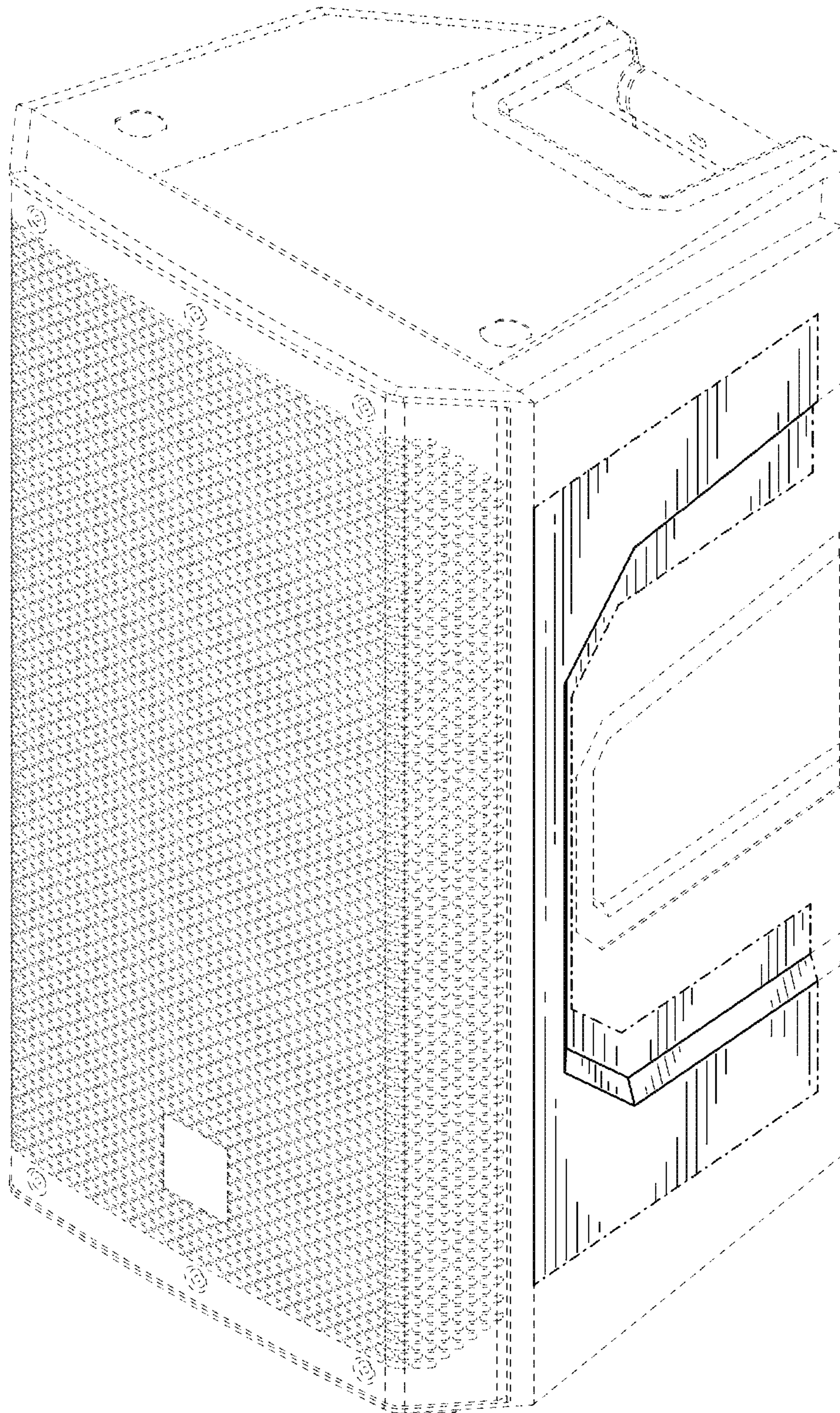

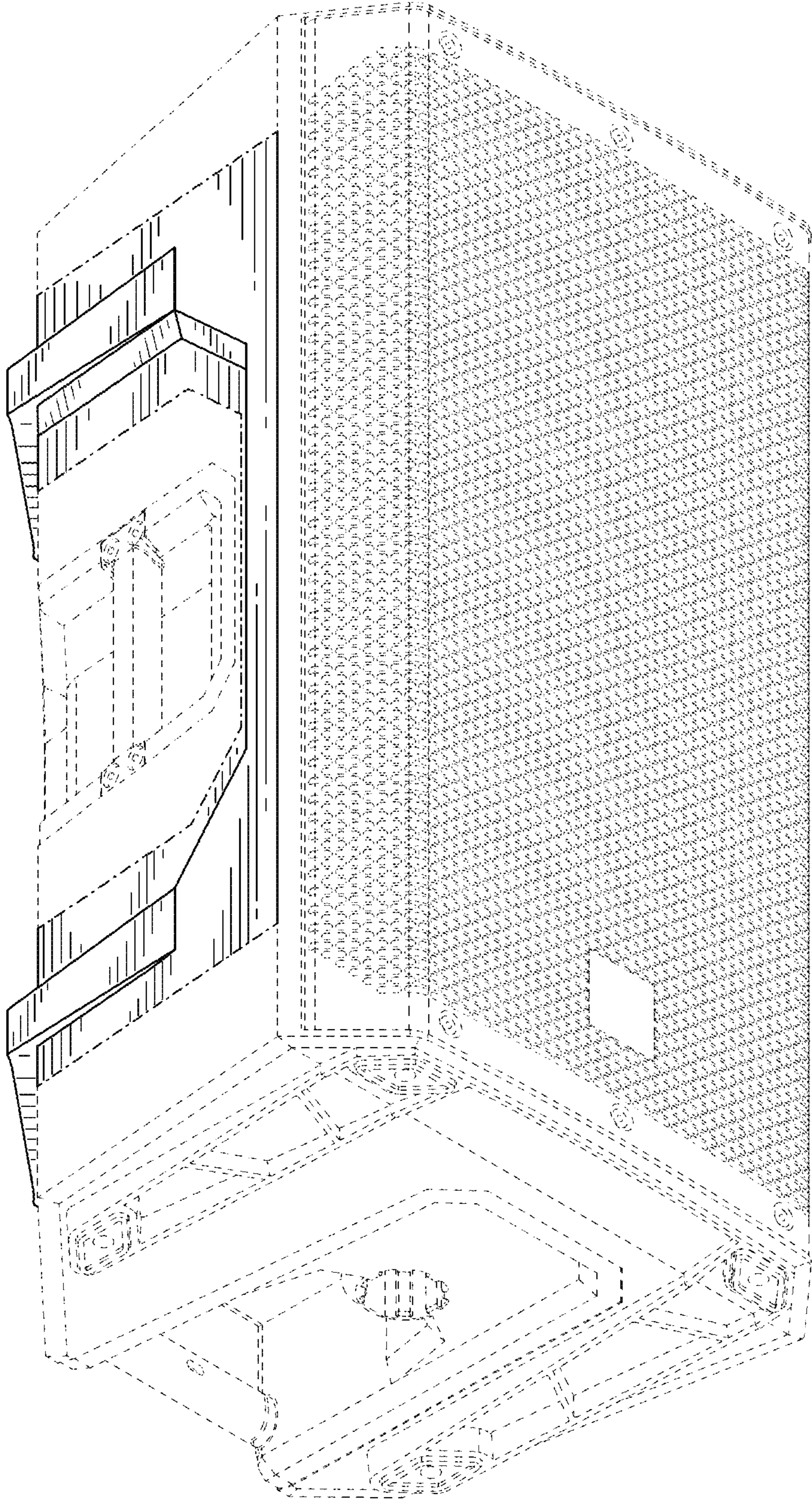

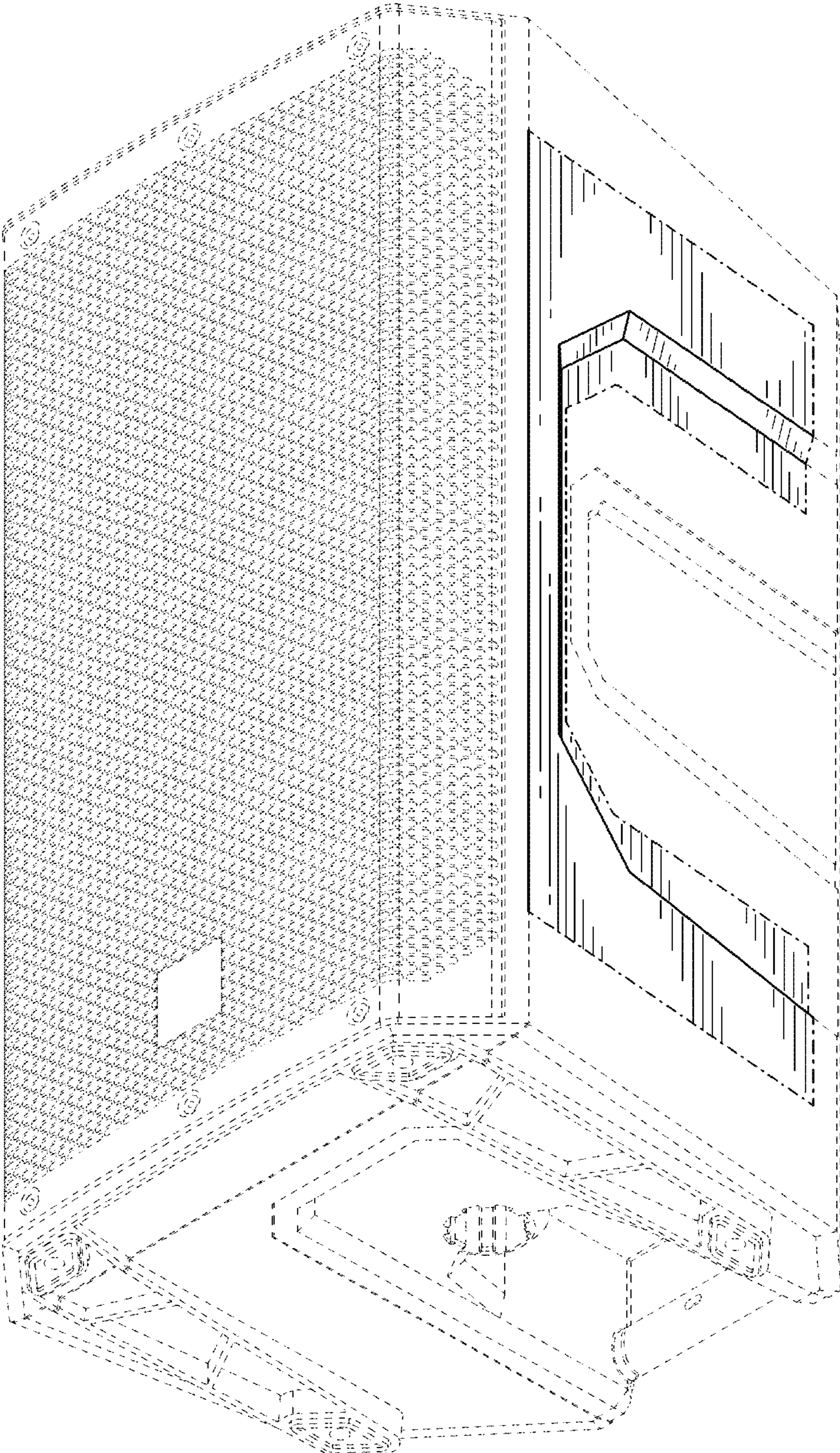

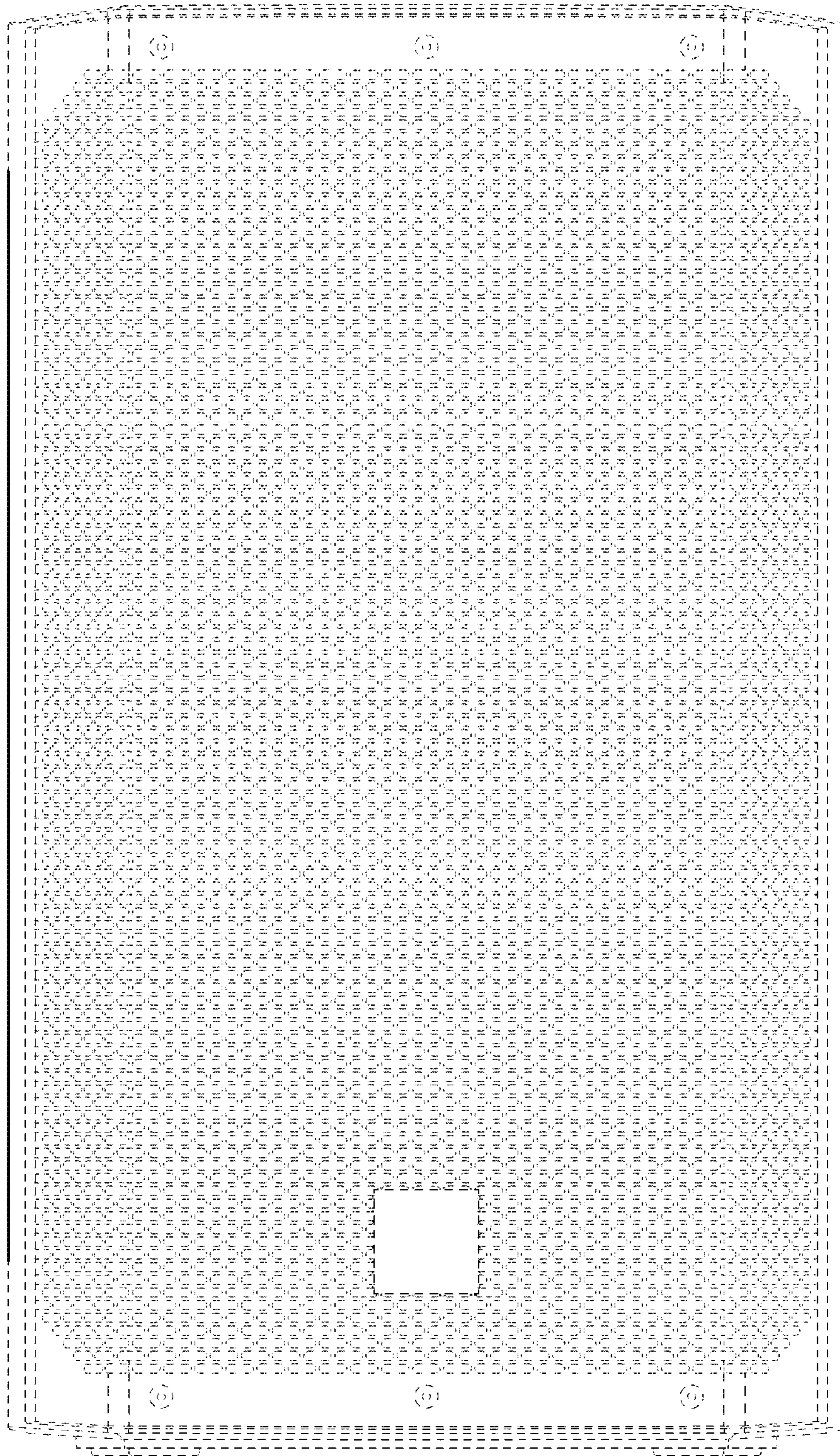

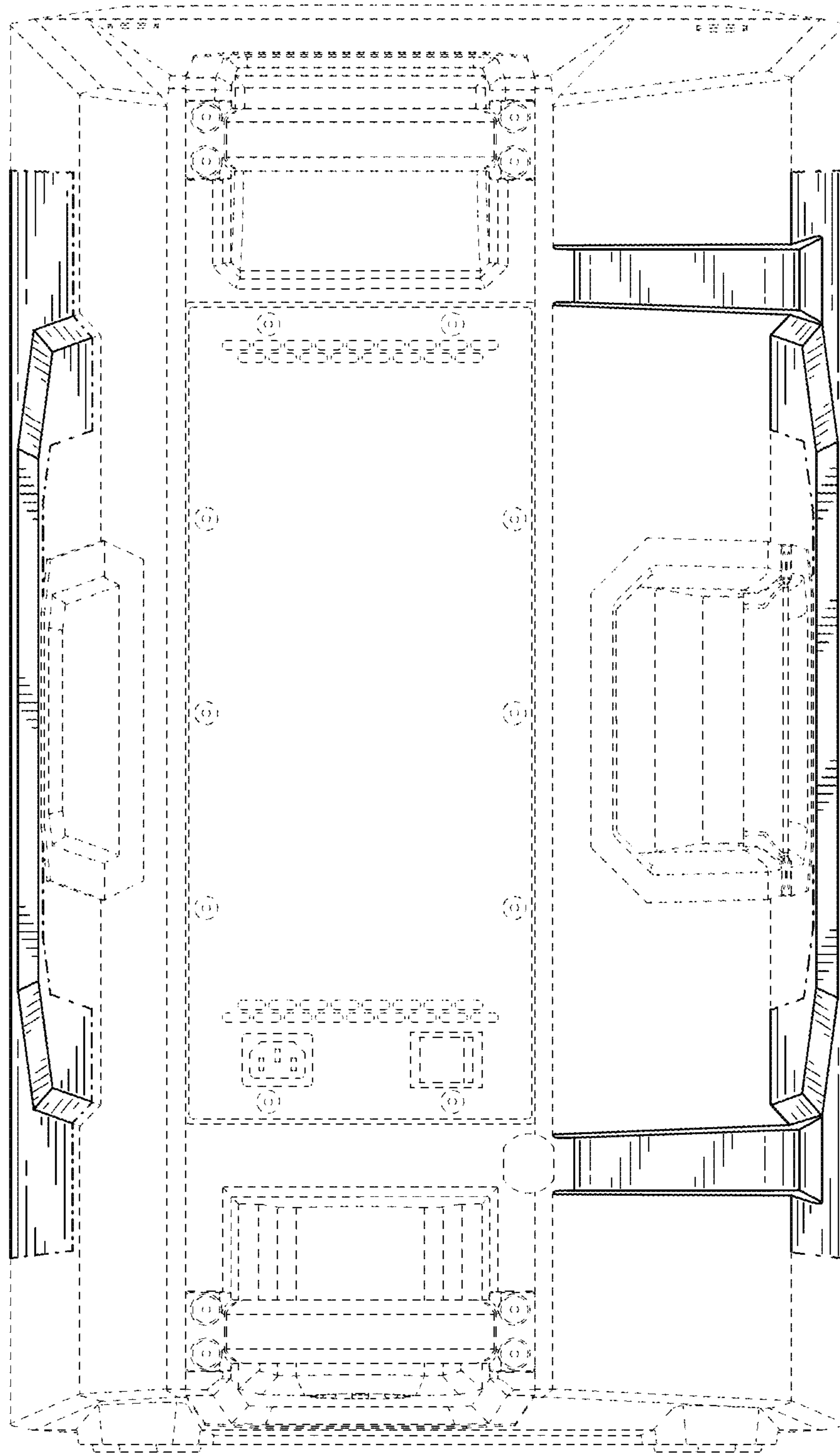

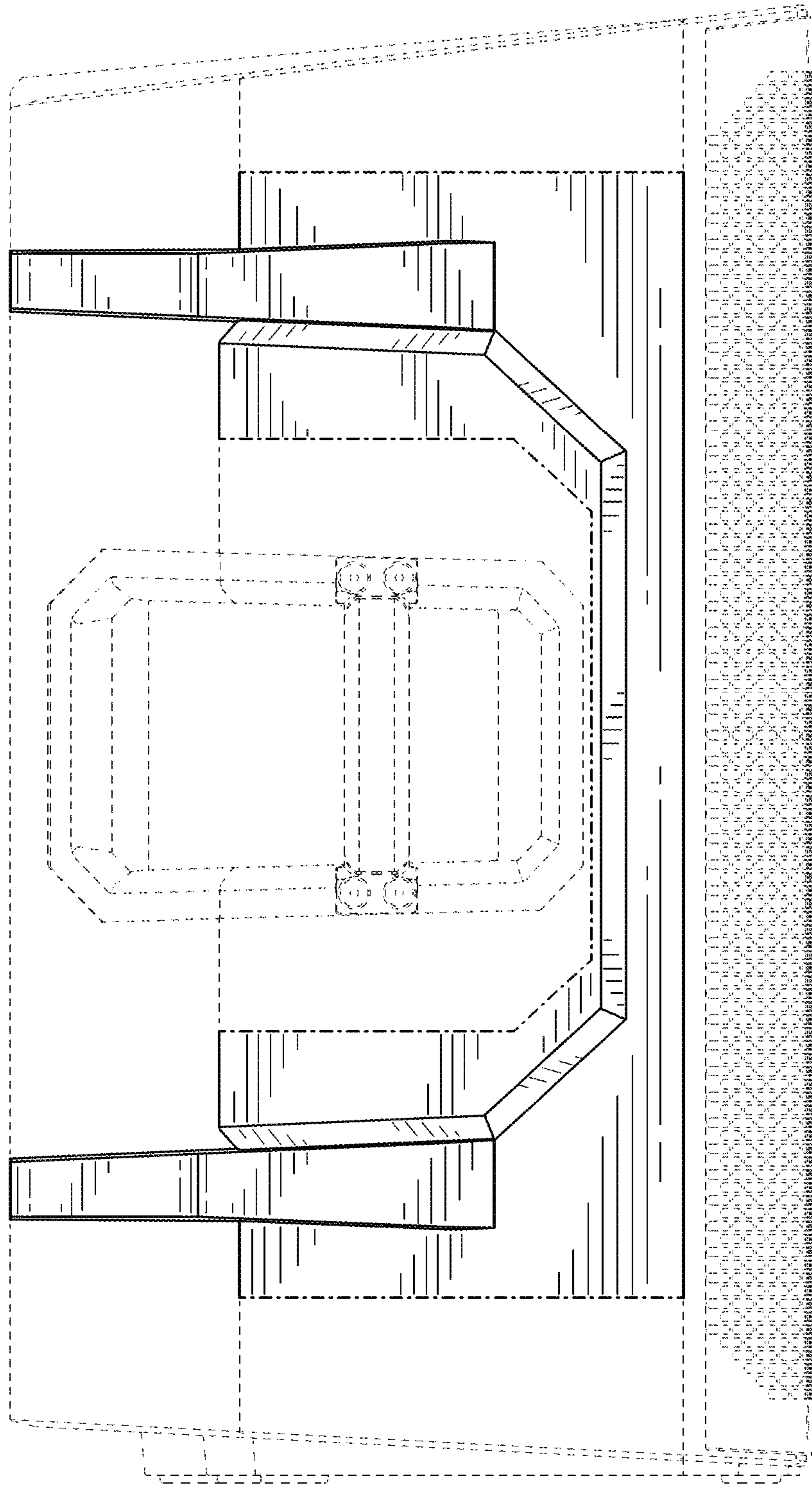

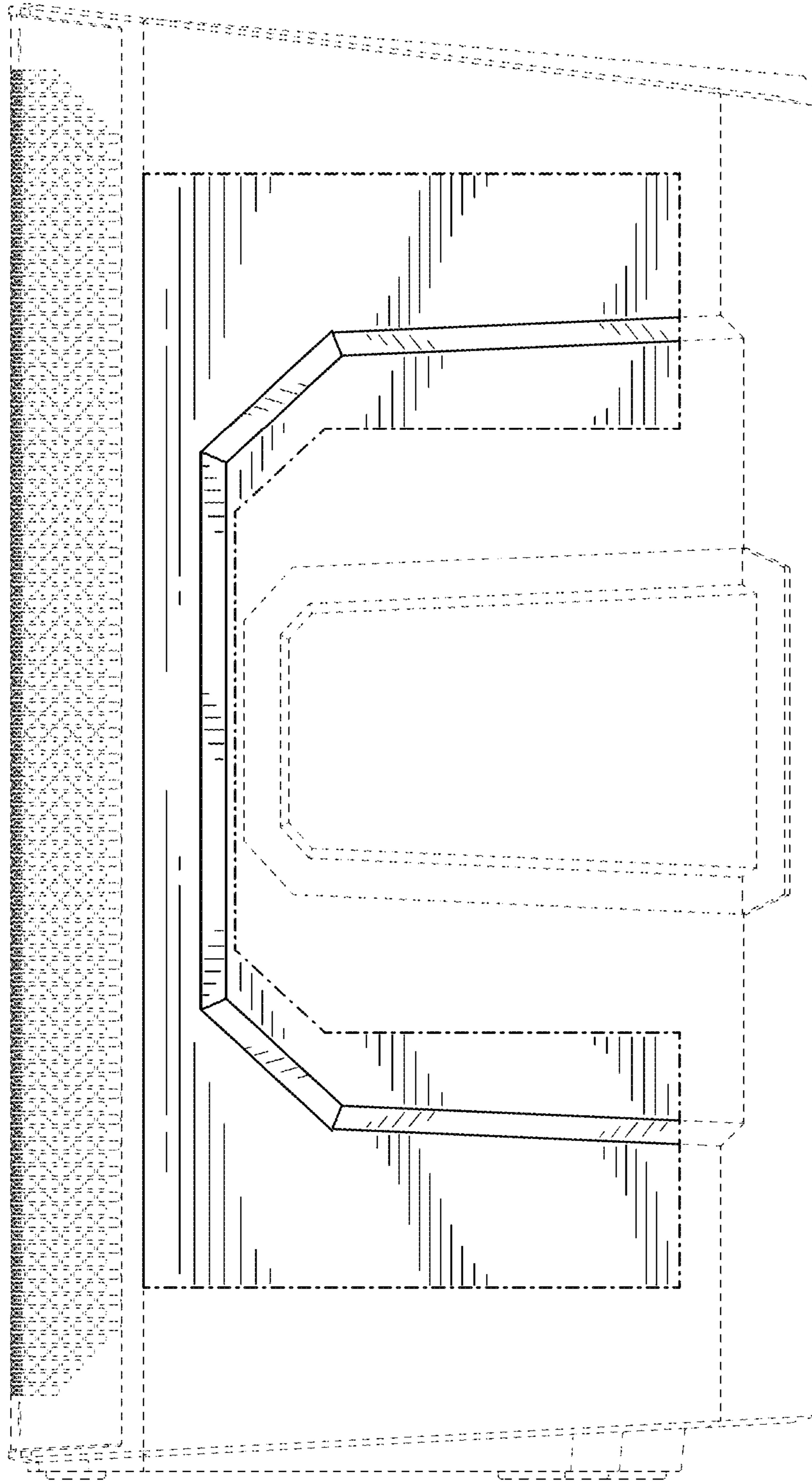

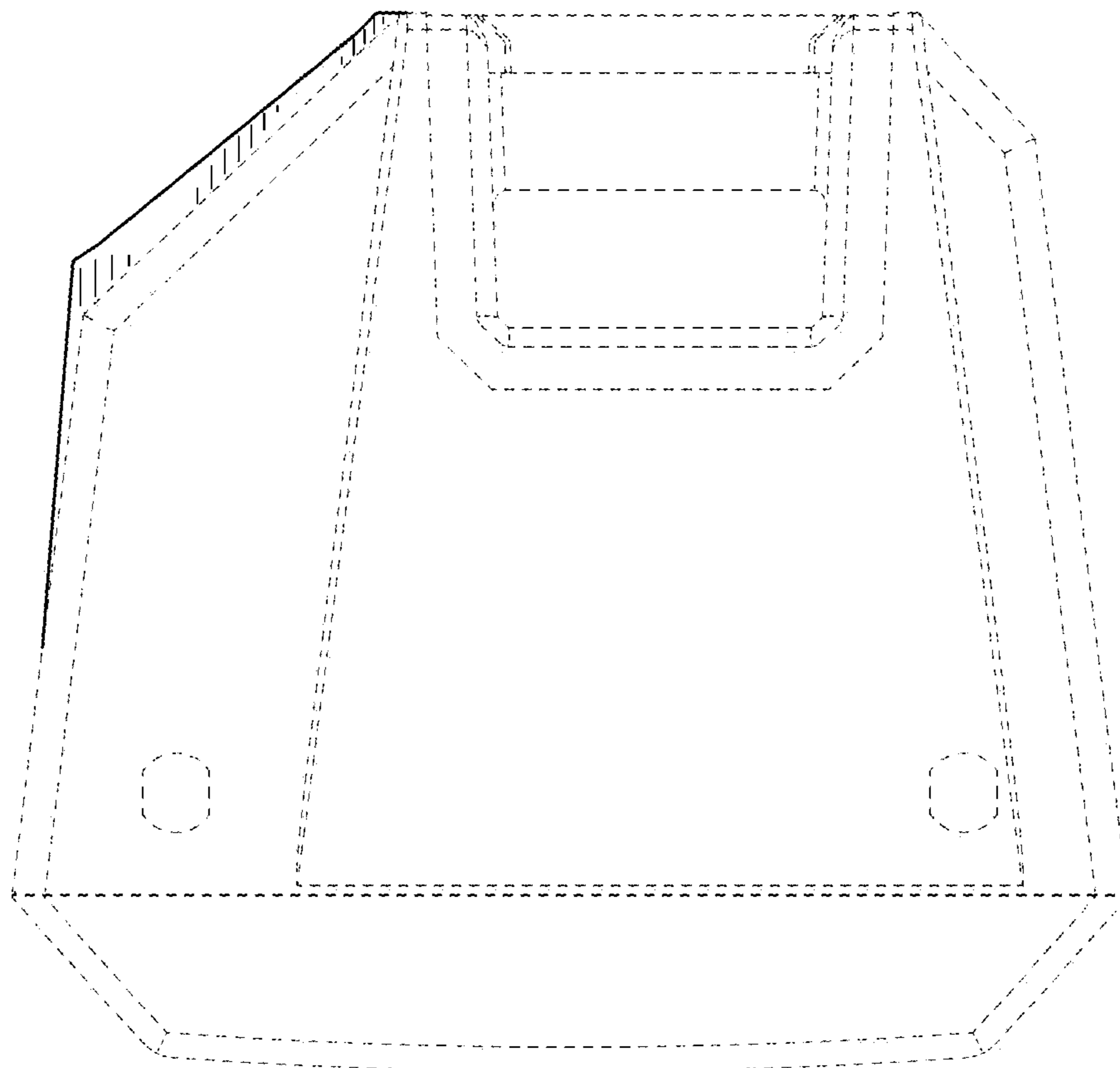




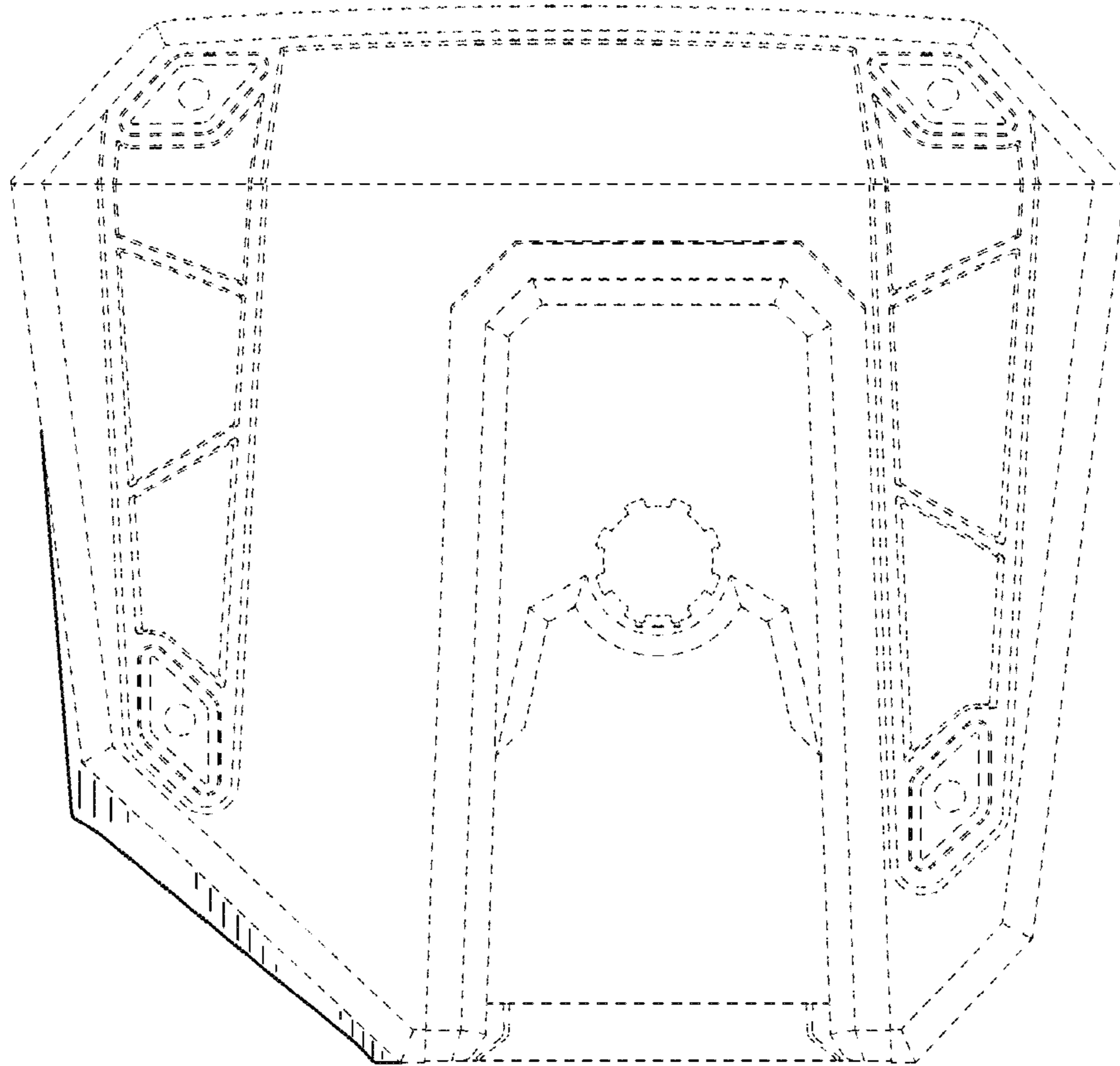
