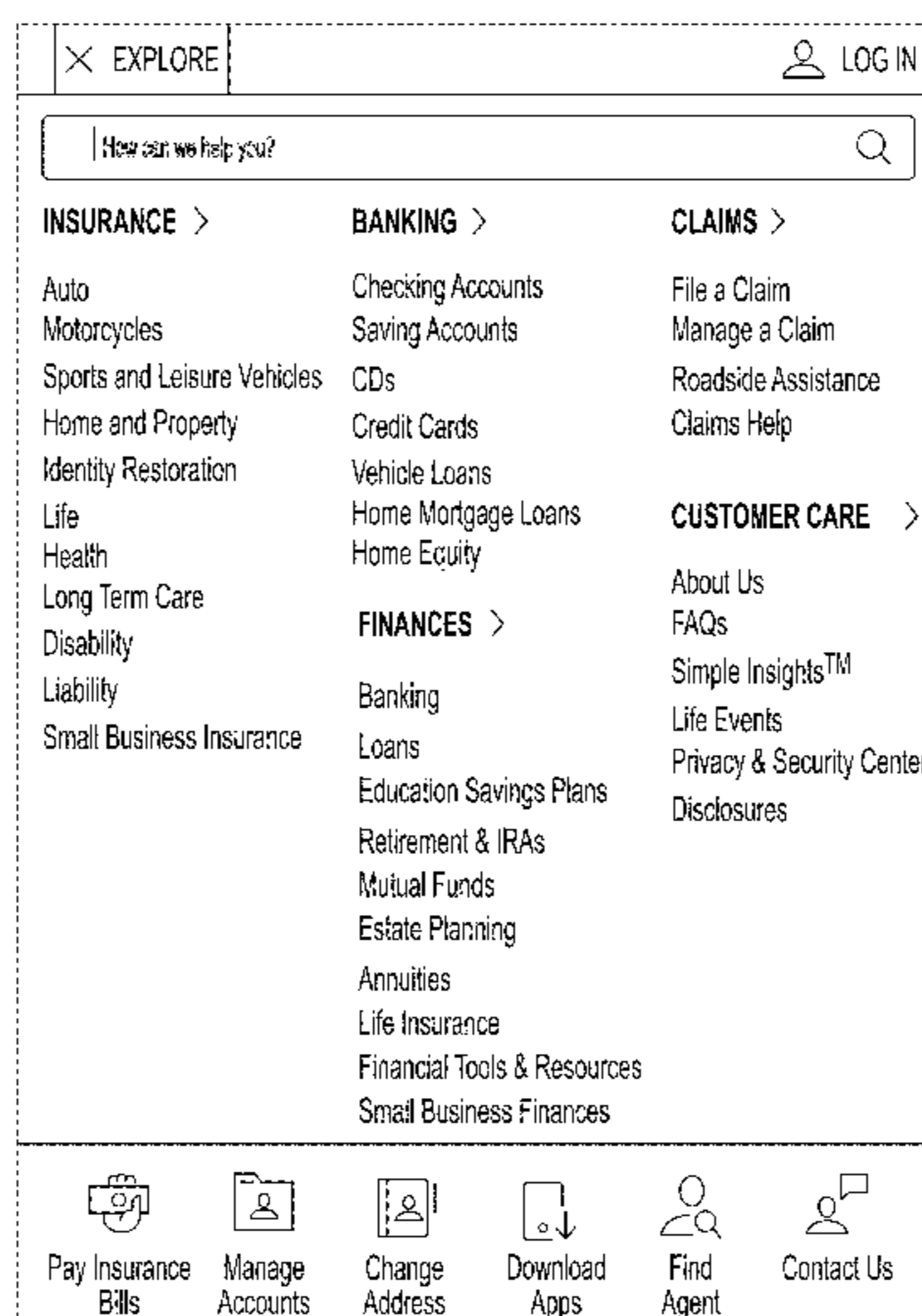
The ornamental design for a display screen with a graphical user interface for compressed insurance exploration menu, as shown and described.


