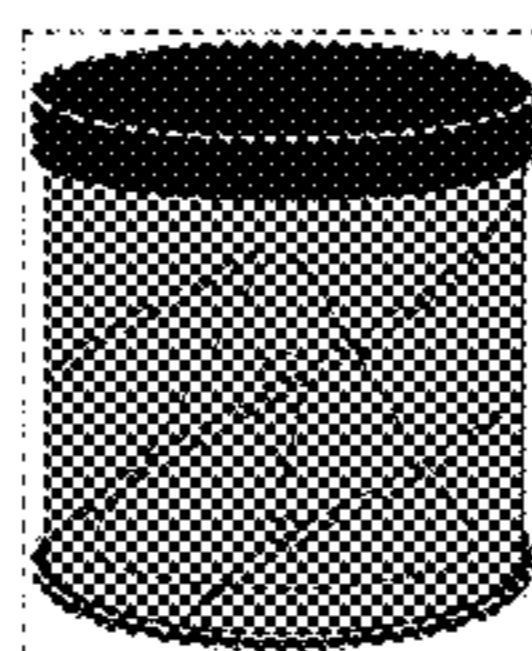
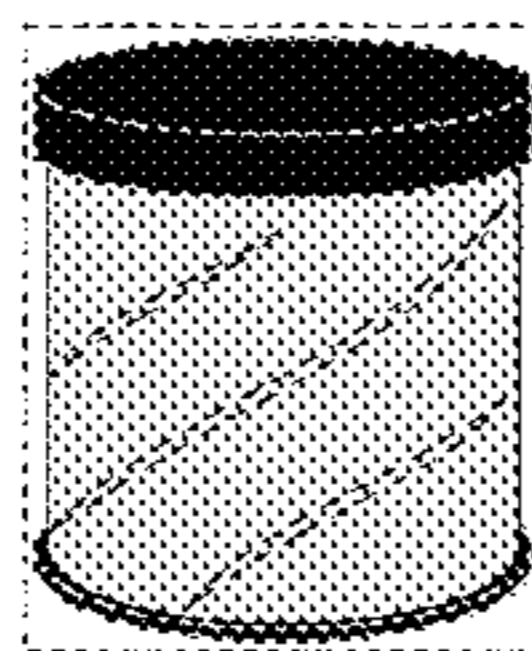
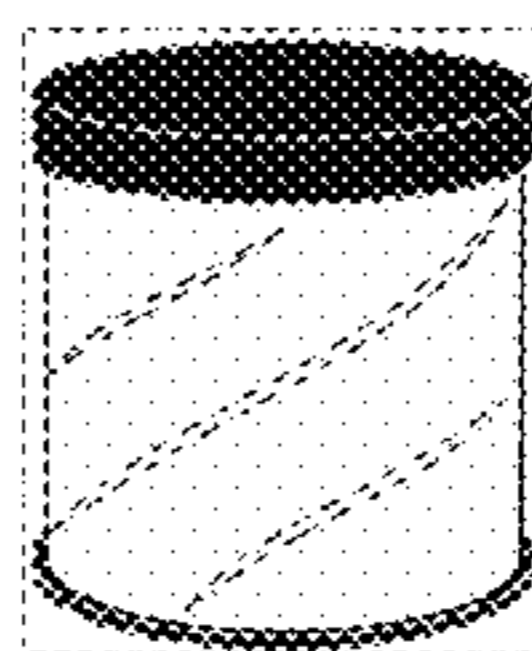
FIG. 1 shows a first image of a display screen or portion thereof with graphical user interface set showing our new design; and,

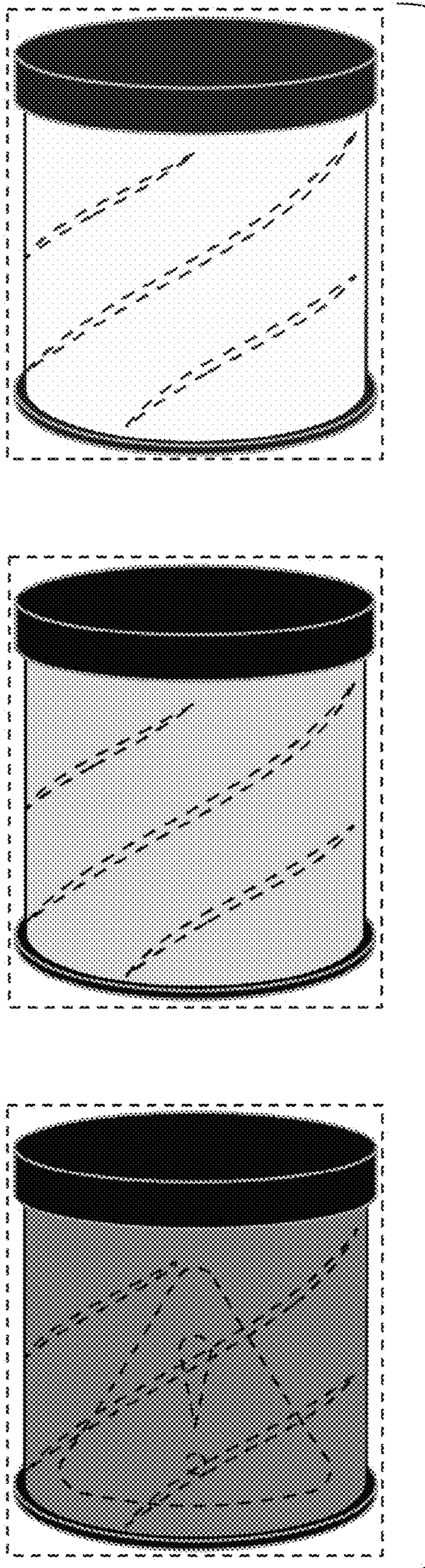

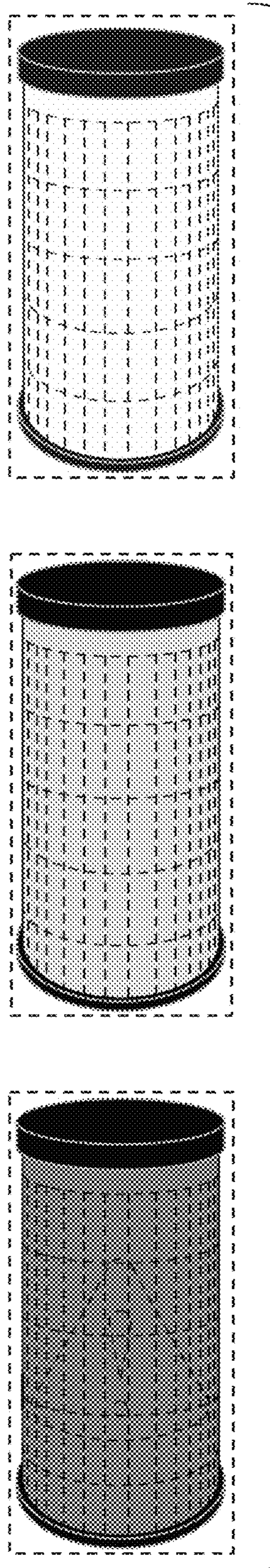
