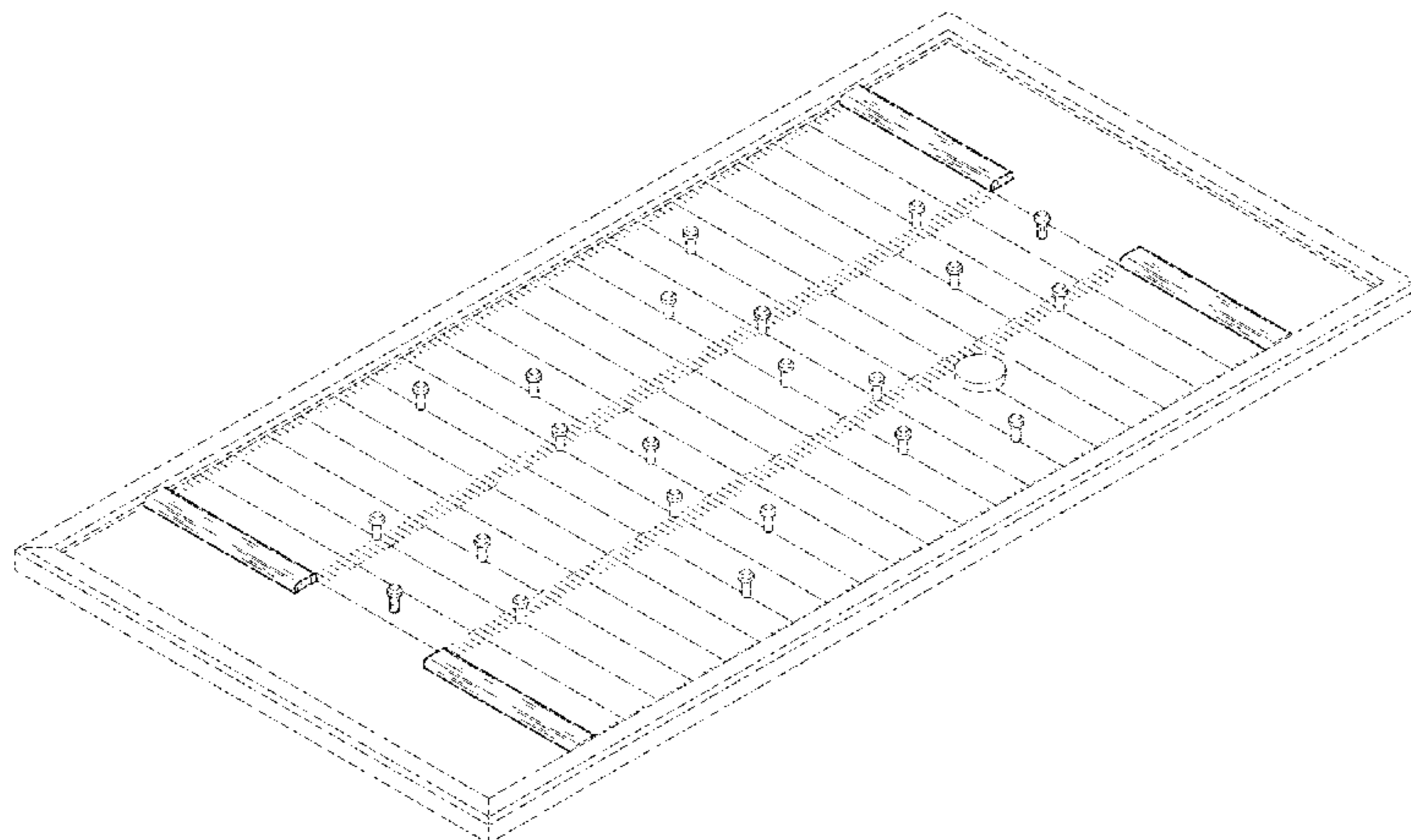
(57) **CLAIM**

The ornamental design for a sport simulation game board, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a sport simulation game board. FIG. 2 is a bottom plan view of the sport simulation game board of FIG. 1. FIG. 3 is a front view of the sport simulation game board of FIG. 1. FIG. 4 is a back view of the sport simulation game board of FIG. 1. FIG. 5 is a left side view of the sport simulation game board of FIG. 1. FIG. 6 is a right side view of the sport simulation game board of FIG. 1; and, FIG. 7 is an isometric view of the sport simulation game board of FIG. 1. 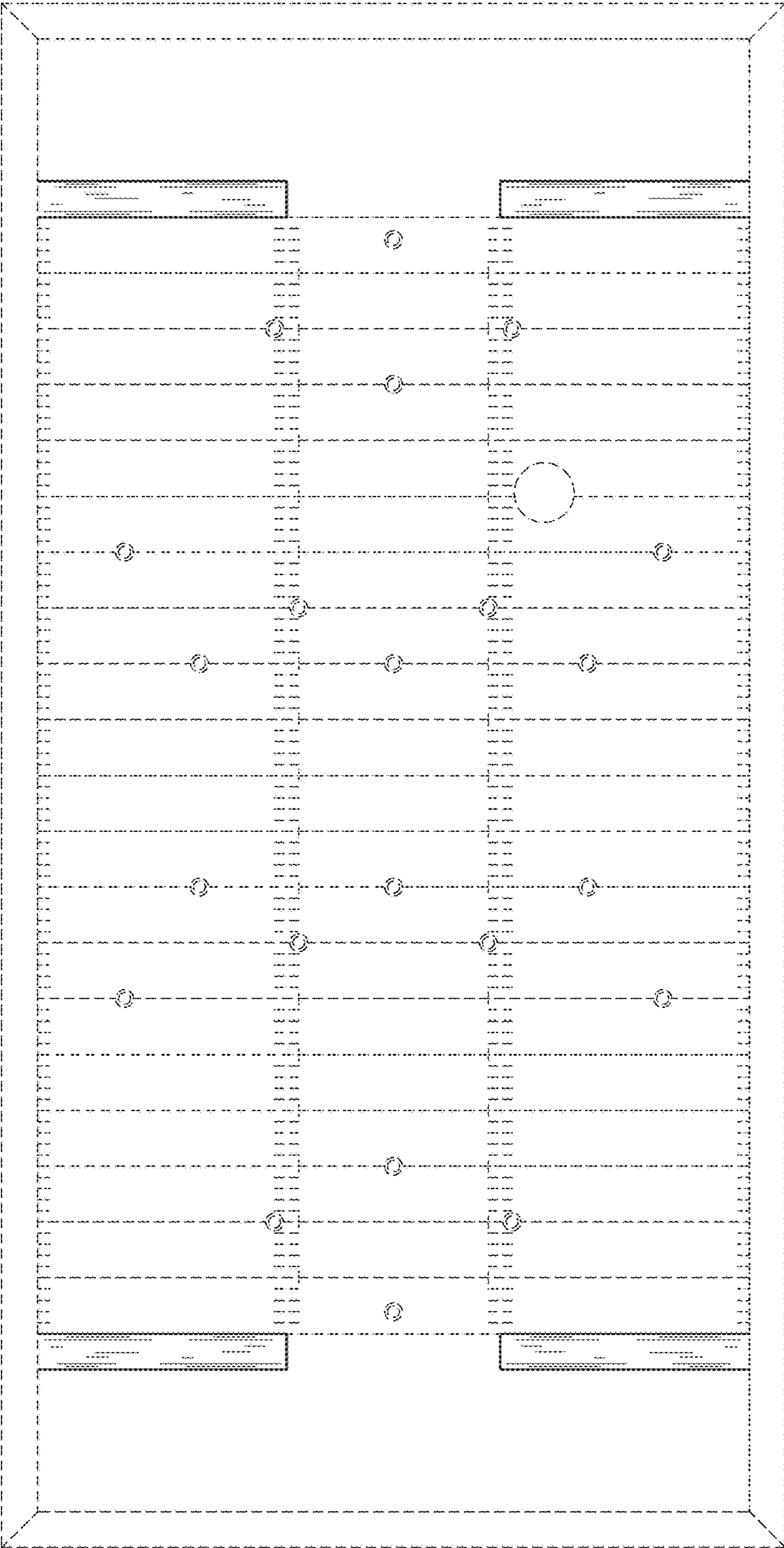

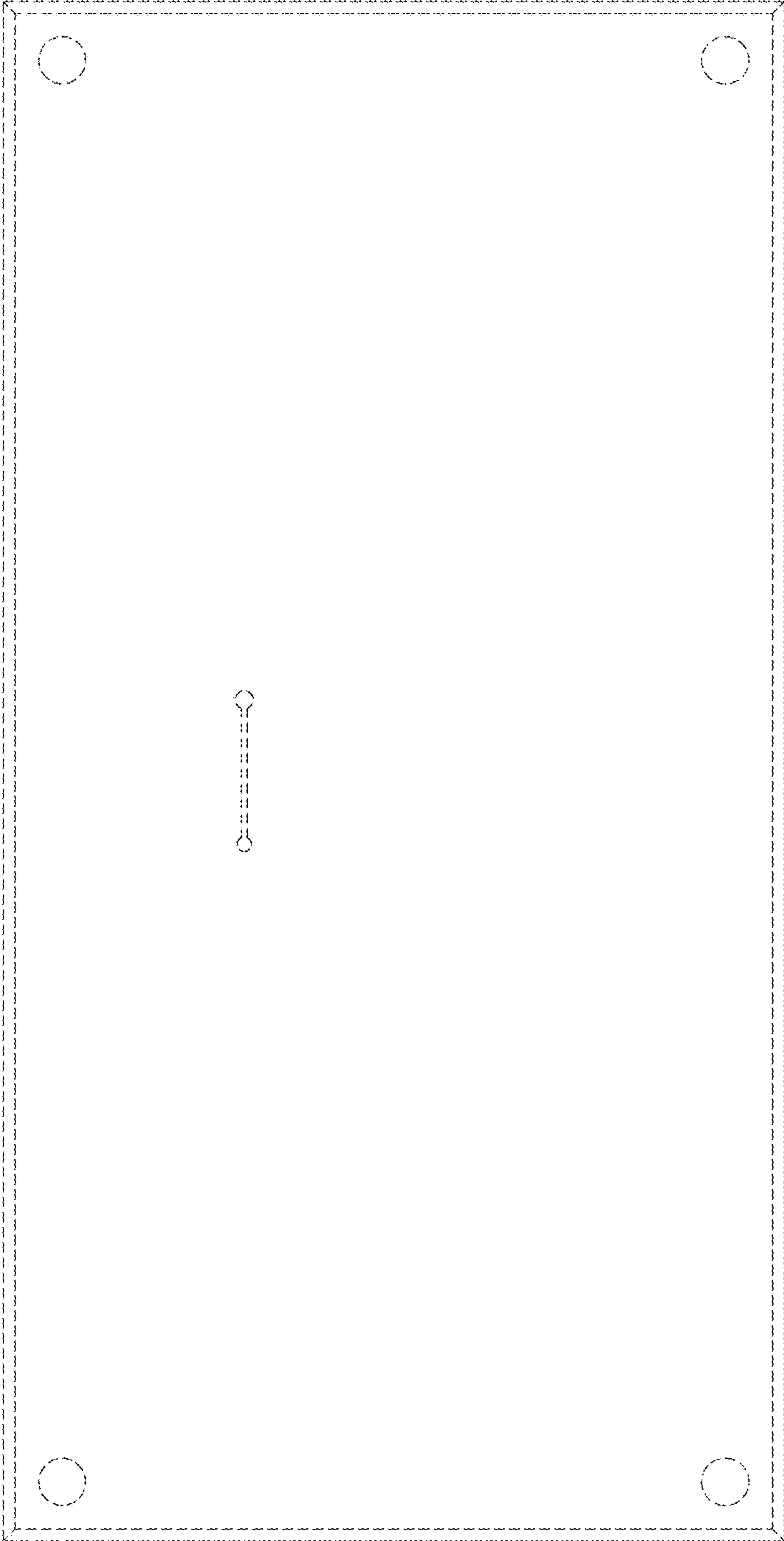

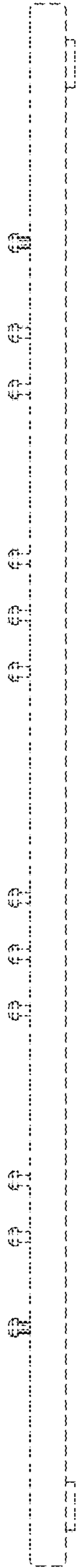

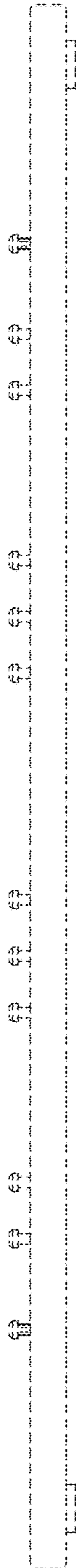

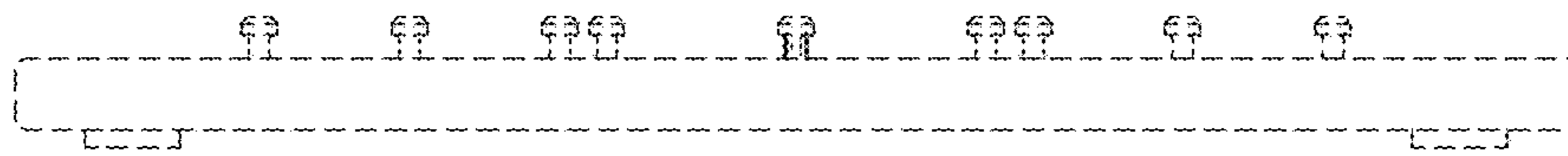

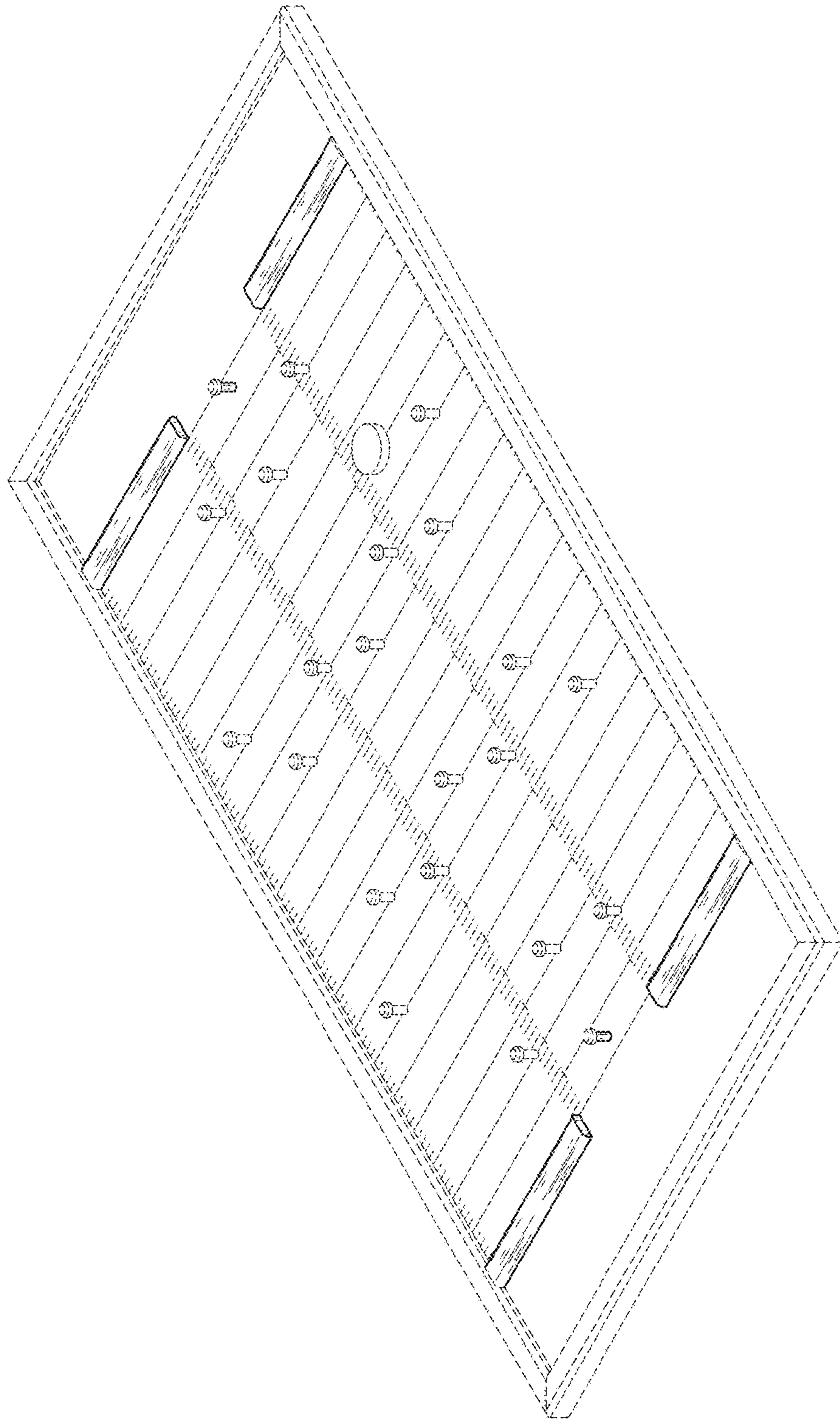
