(57) **CLAIM**

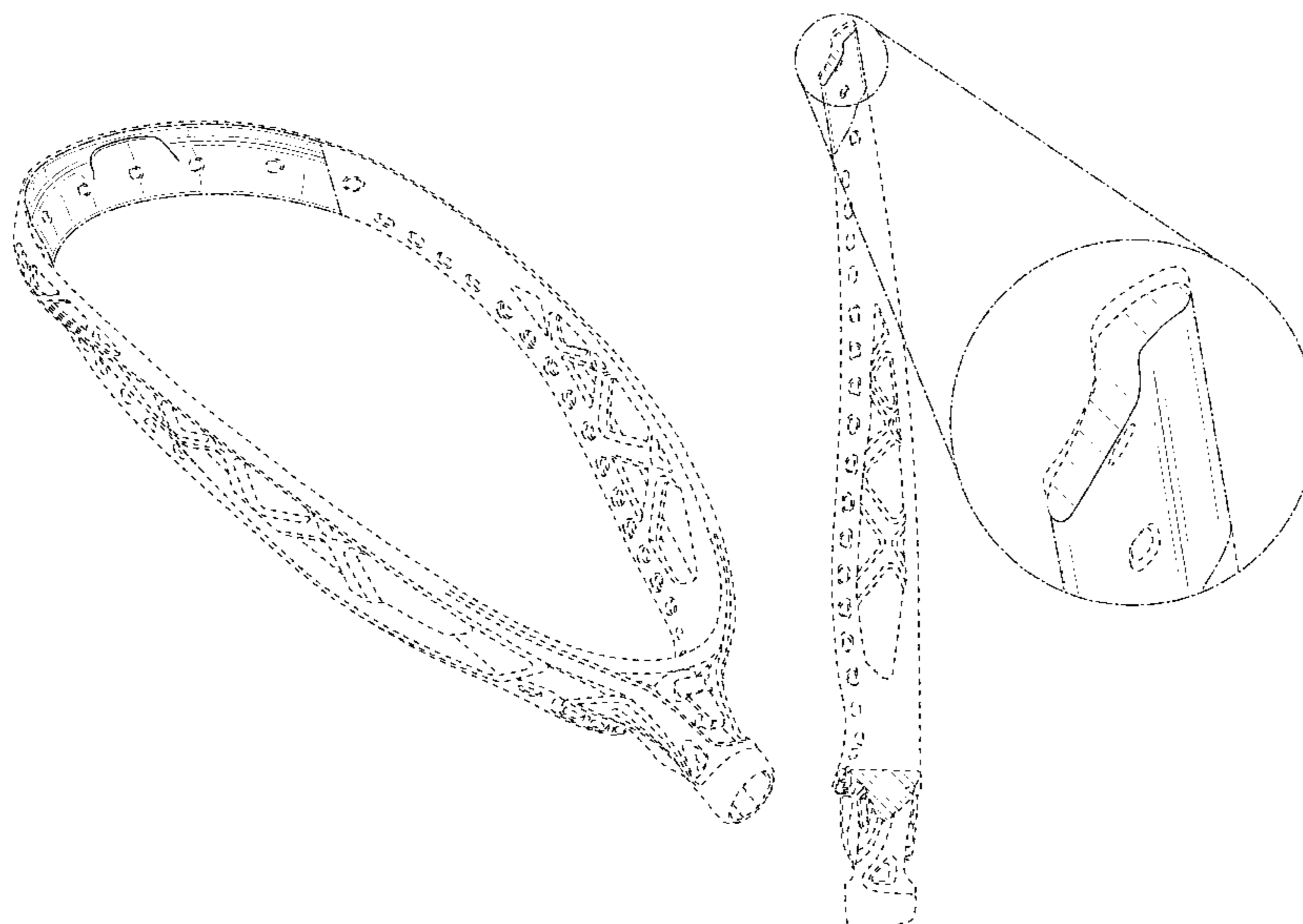
The ornamental design for a lacrosse head, as shown and described.

DESCRIPTION

FIG. 1 is a top isometric perspective view of a lacrosse head showing the new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a cross-sectional view thereof, taken along line 8-8 of FIG. 2;
 FIG. 9 is a cross-sectional view thereof, taken along line 9-9 of FIG. 2;
 FIG. 10 is a cross-sectional view thereof, taken along line 10-10 of FIG. 2;
 FIG. 11 is a cross-sectional view thereof, taken along line 11-11 of FIG. 2;
 FIG. 12 is a cross-sectional view thereof, taken along line 12-12 of FIG. 2;

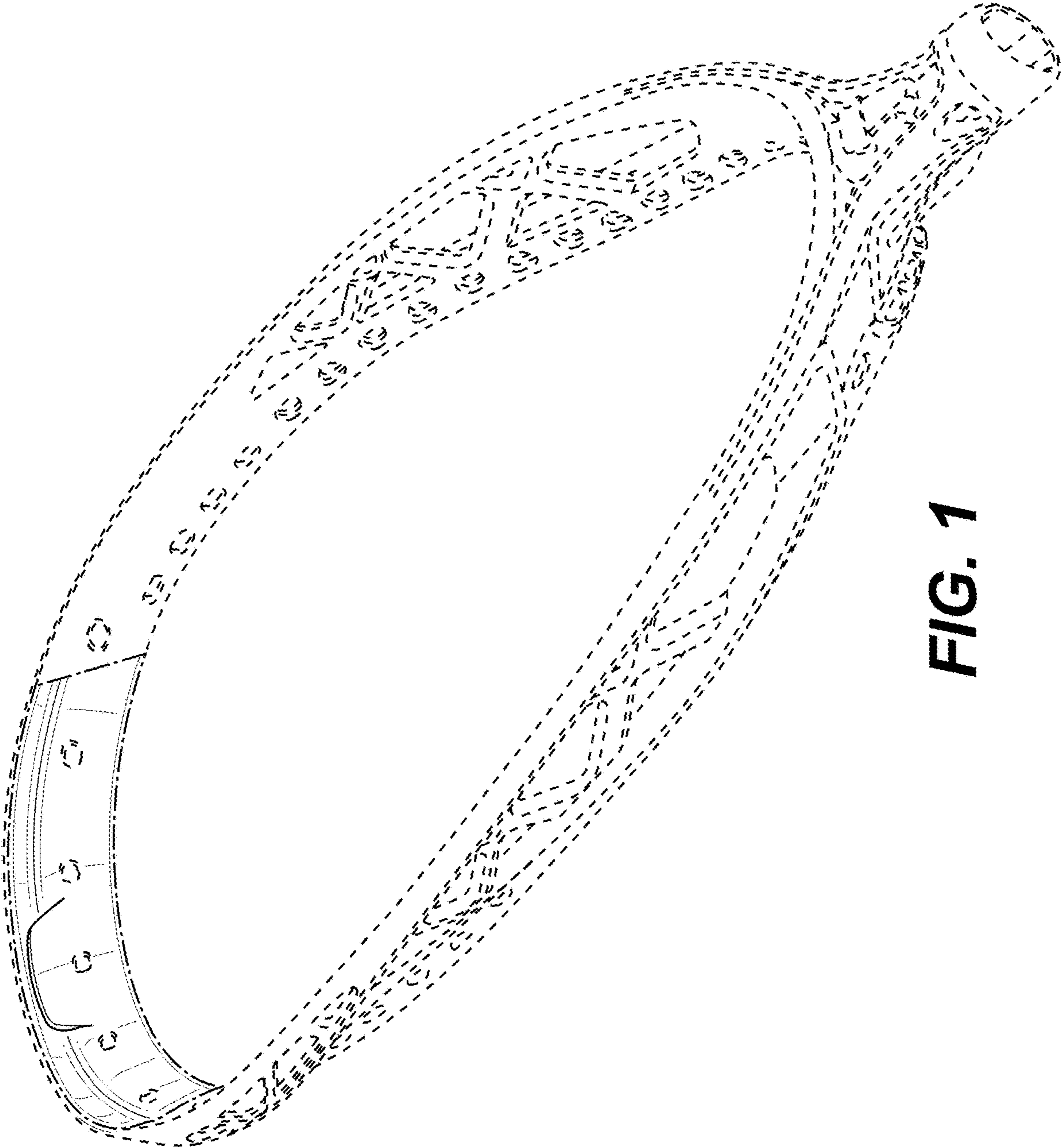

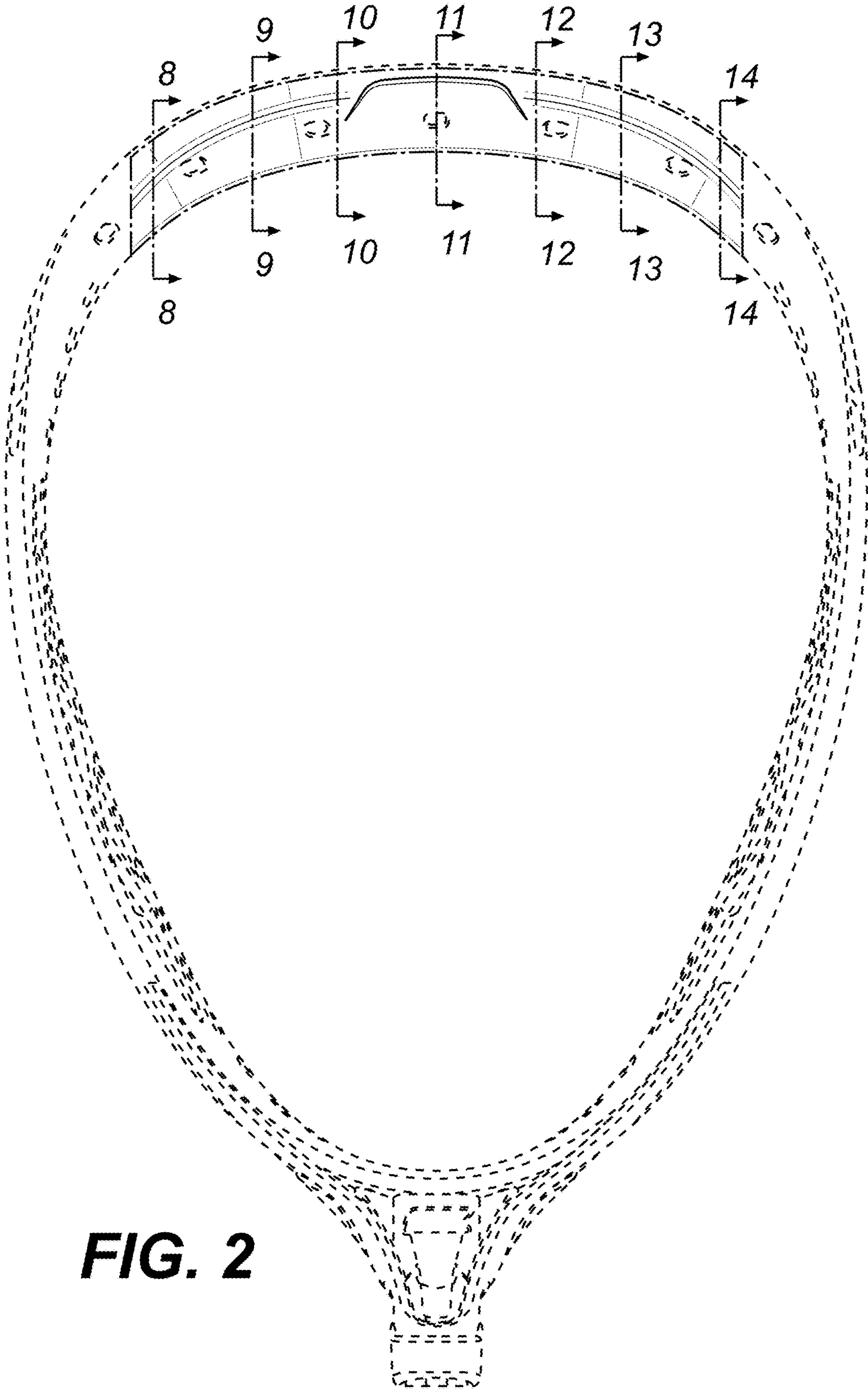

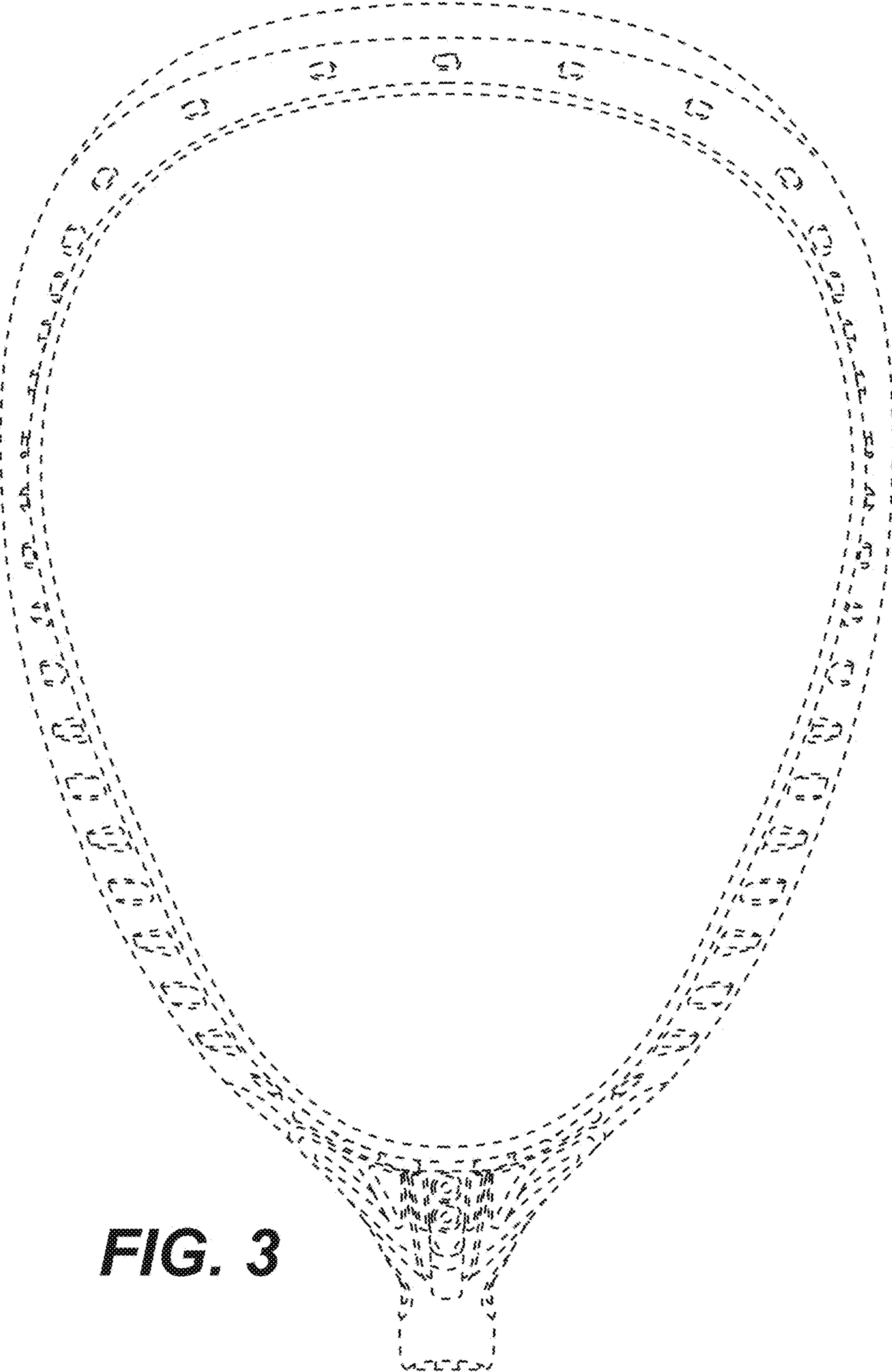

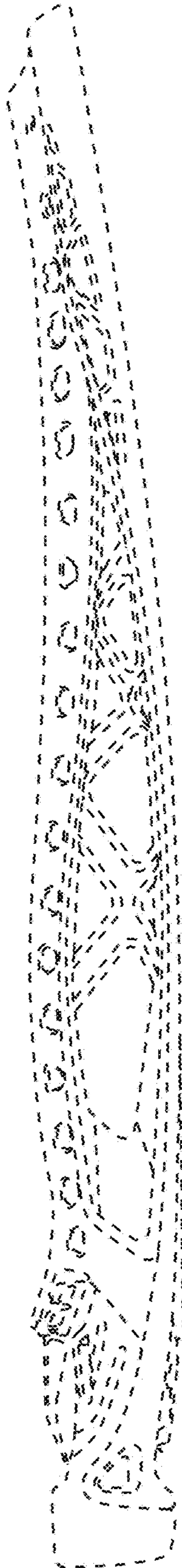

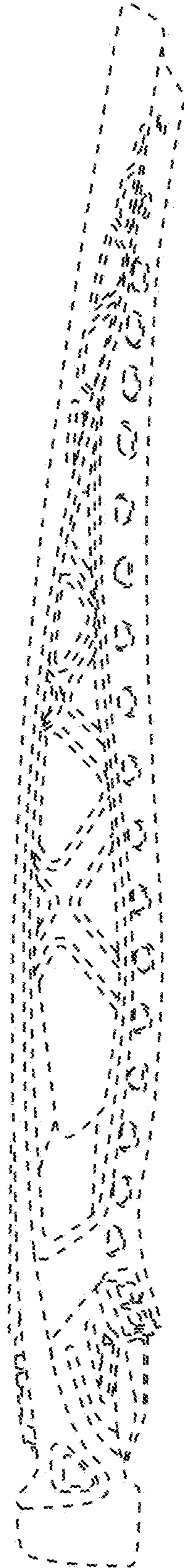

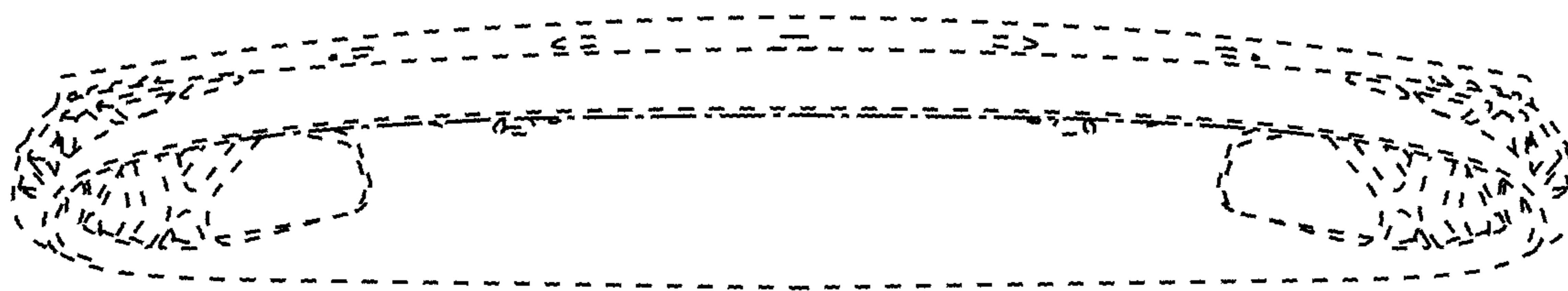

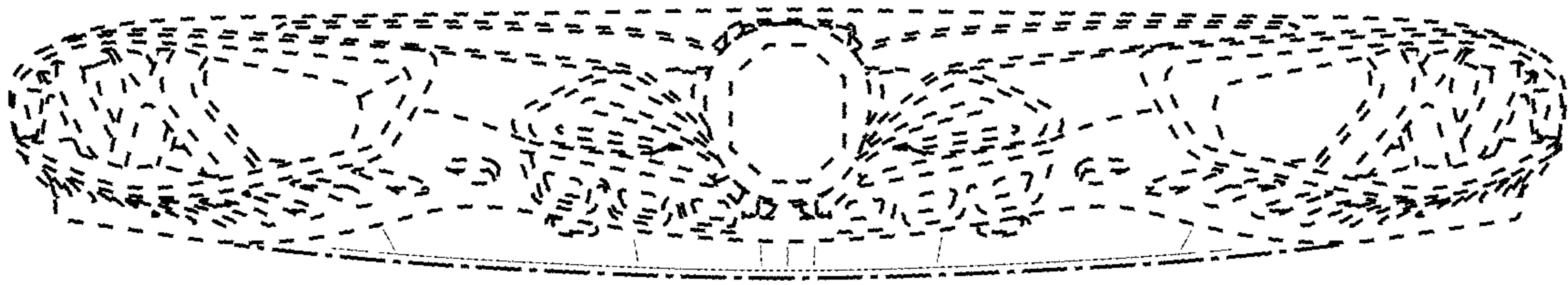

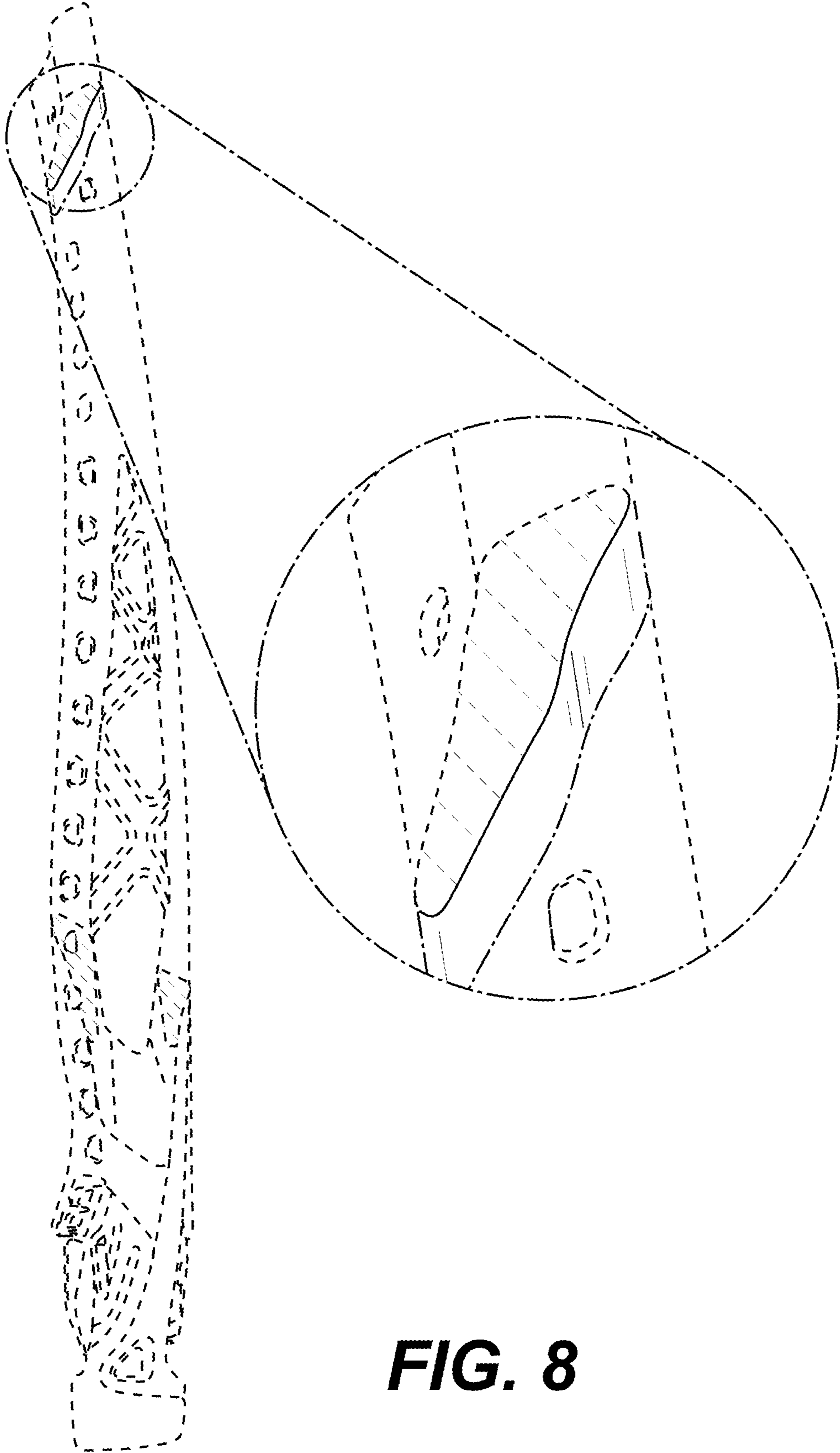

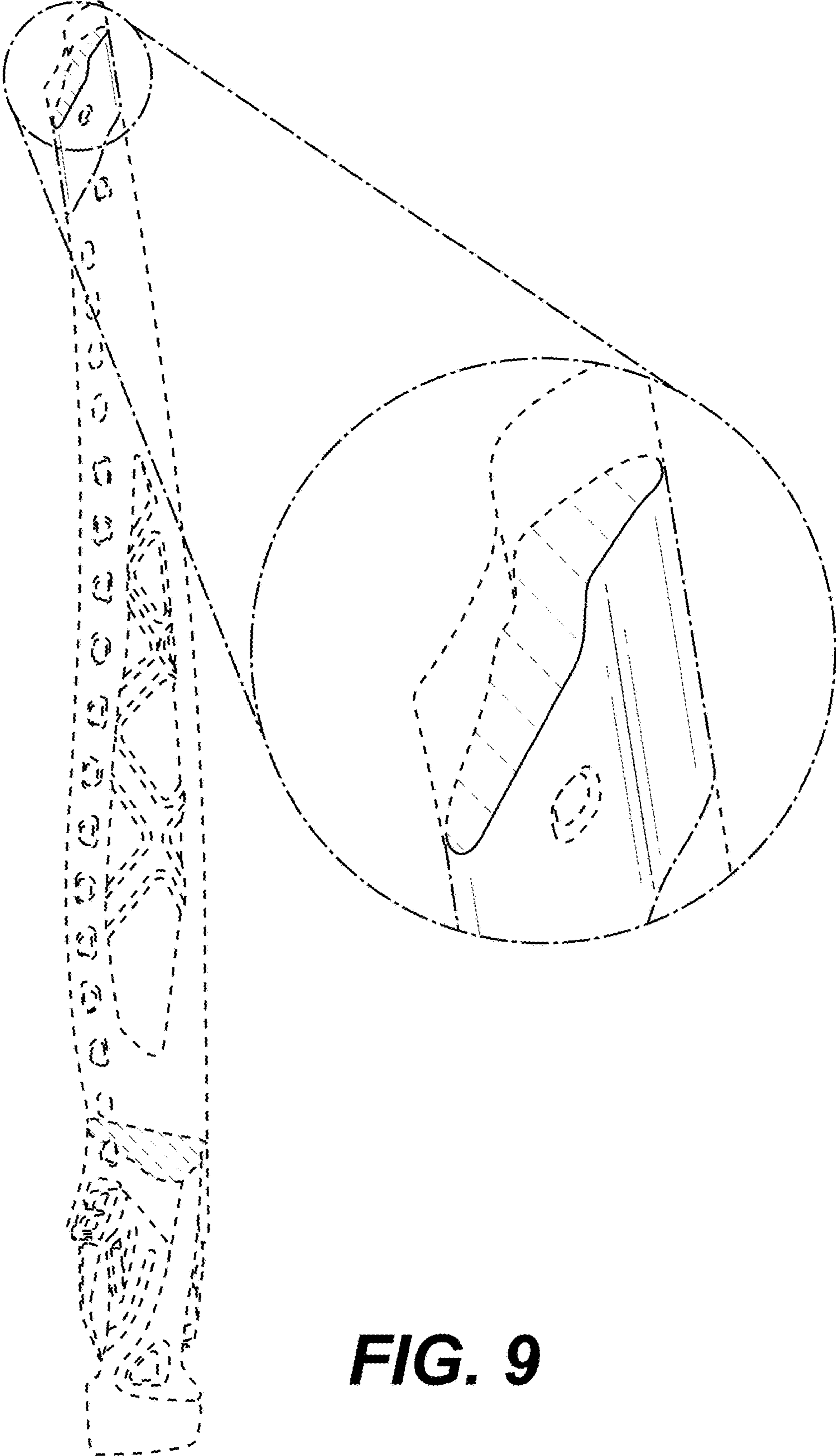

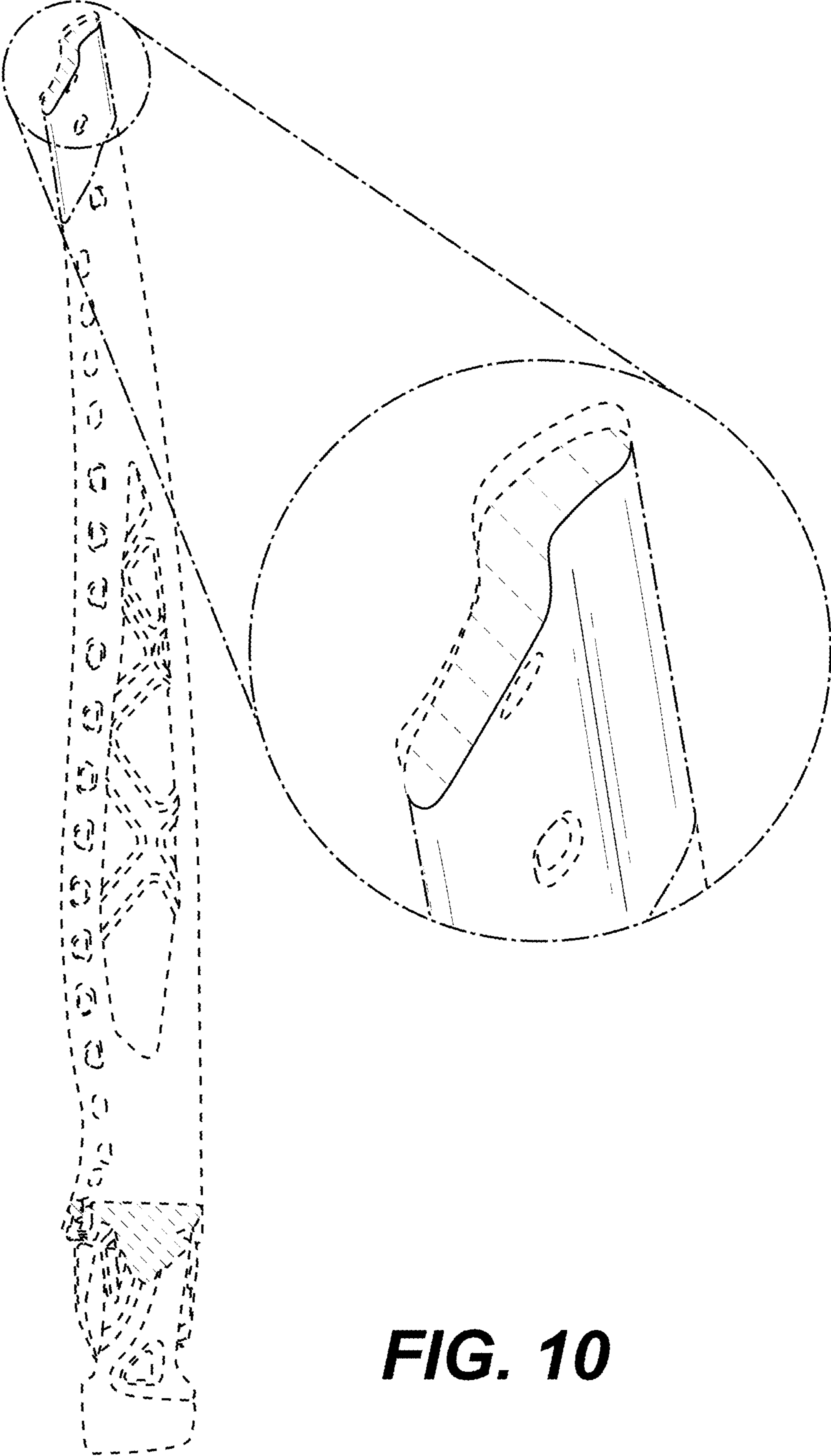

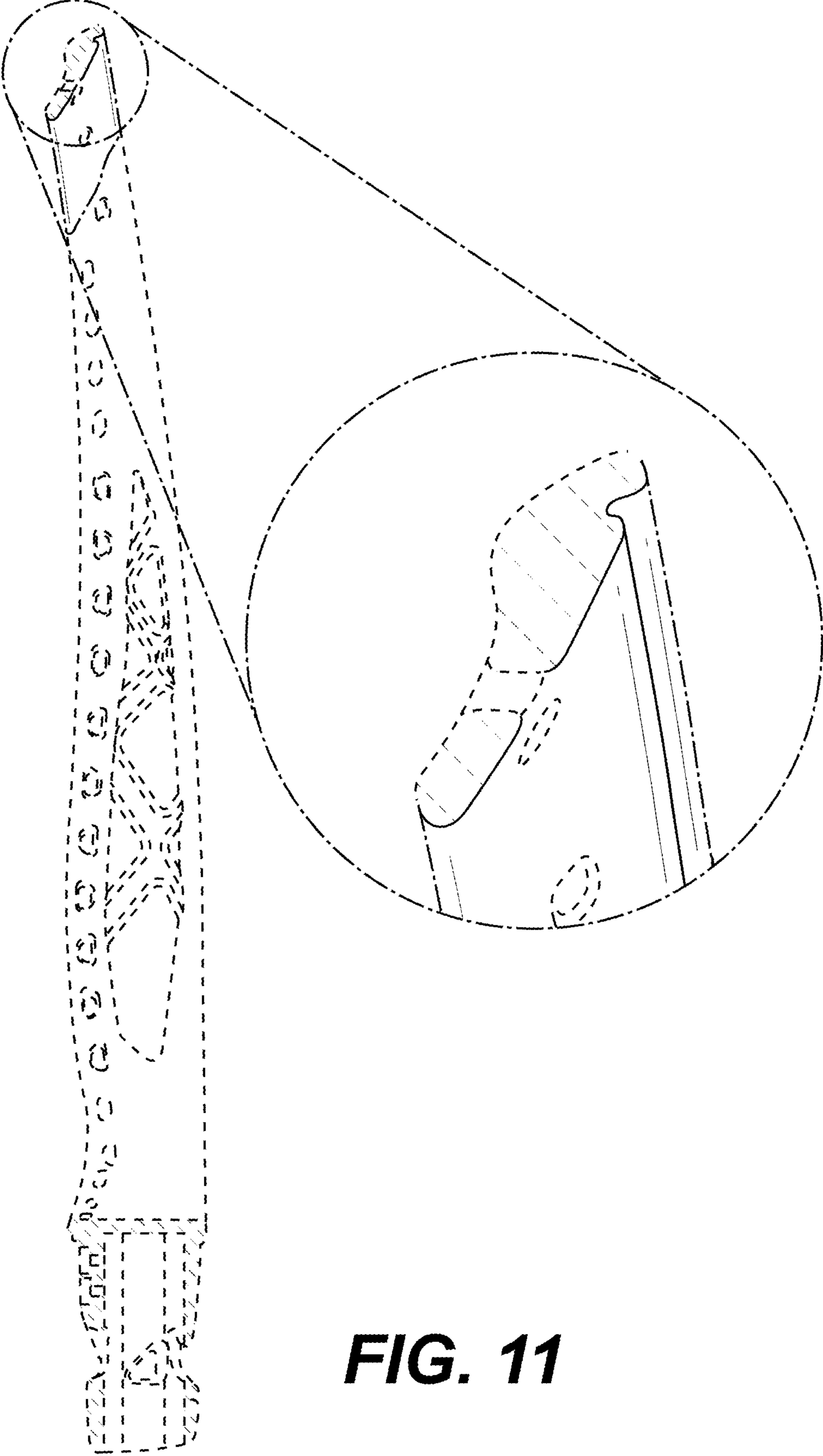

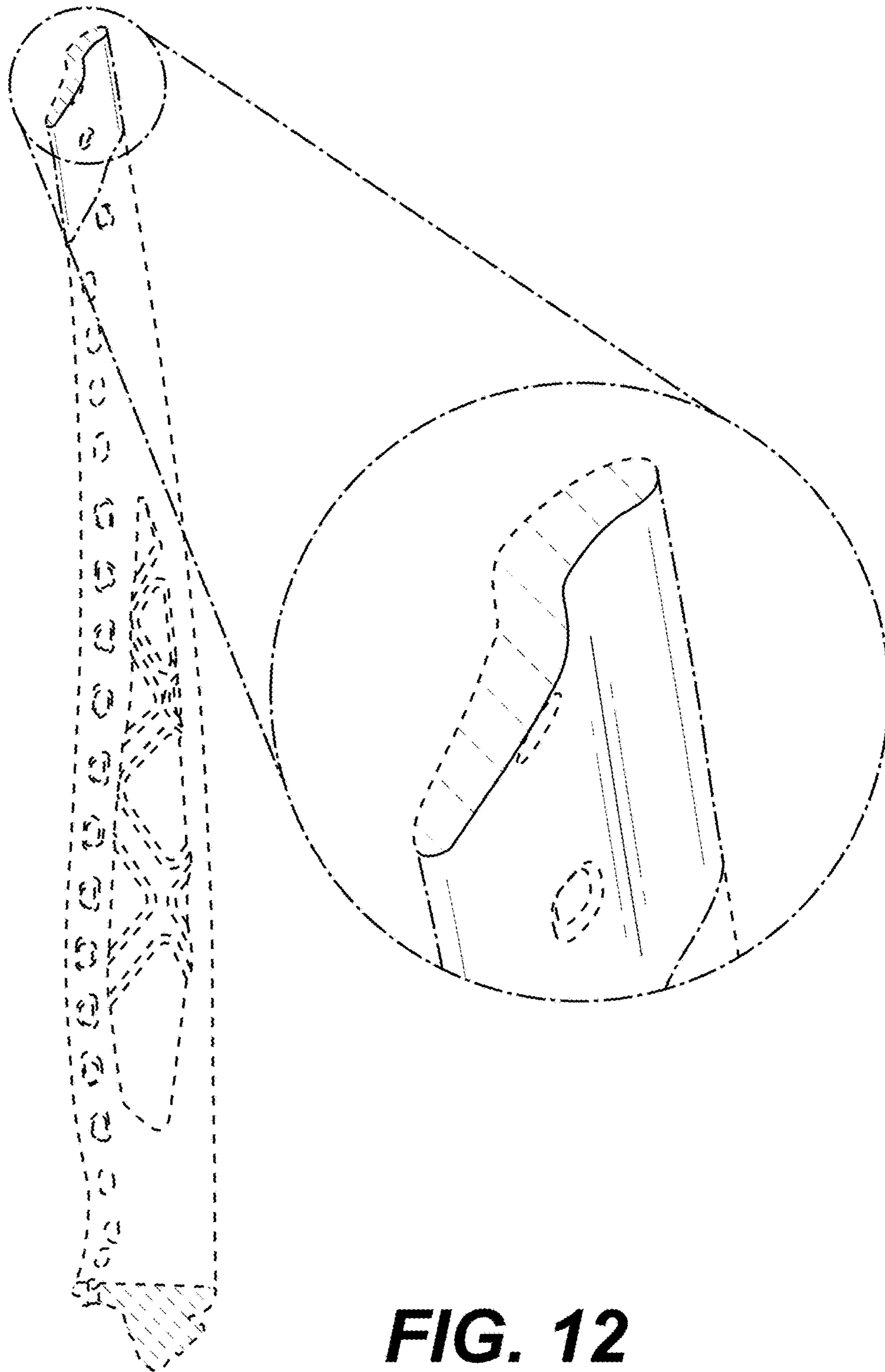

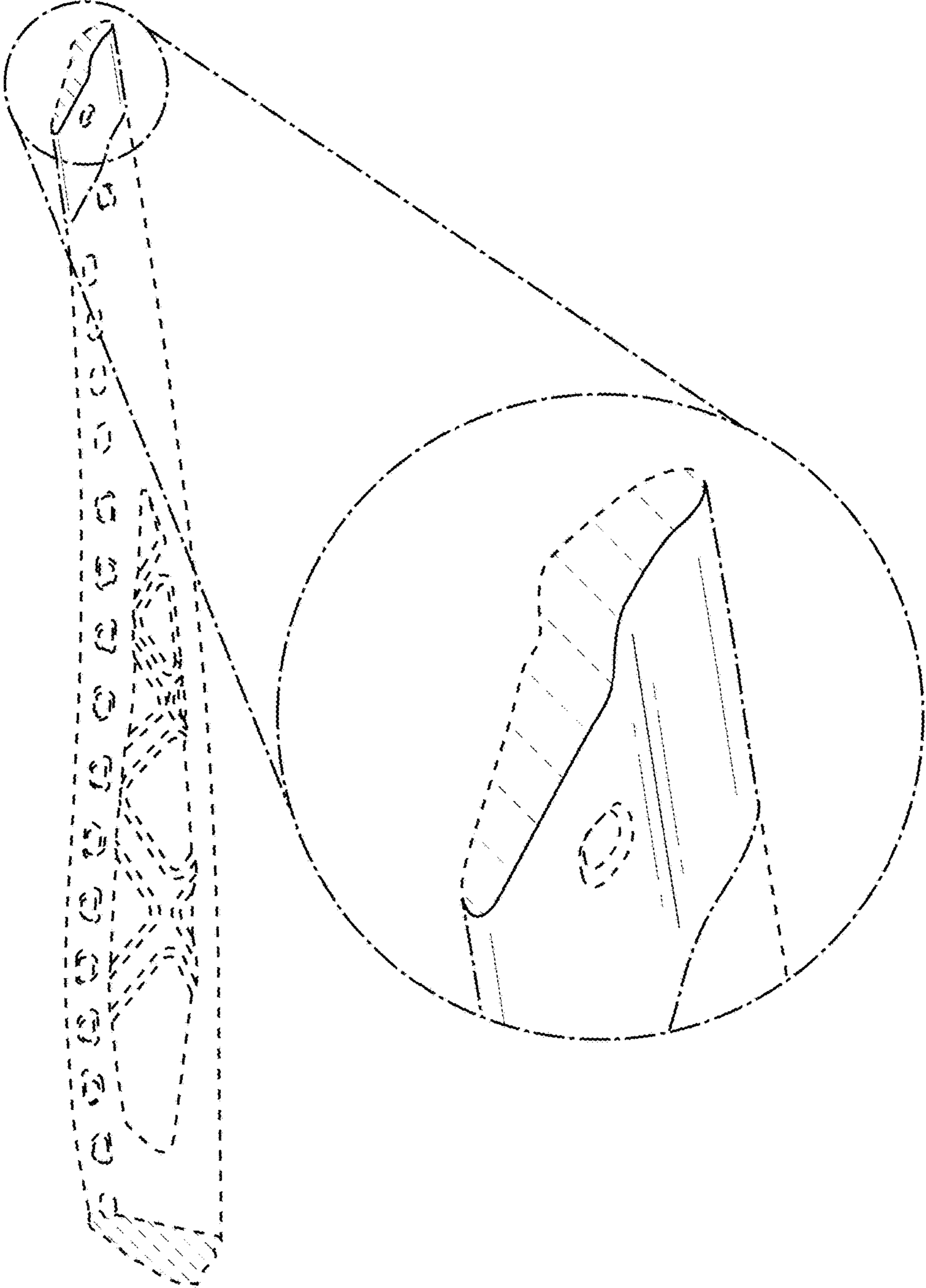

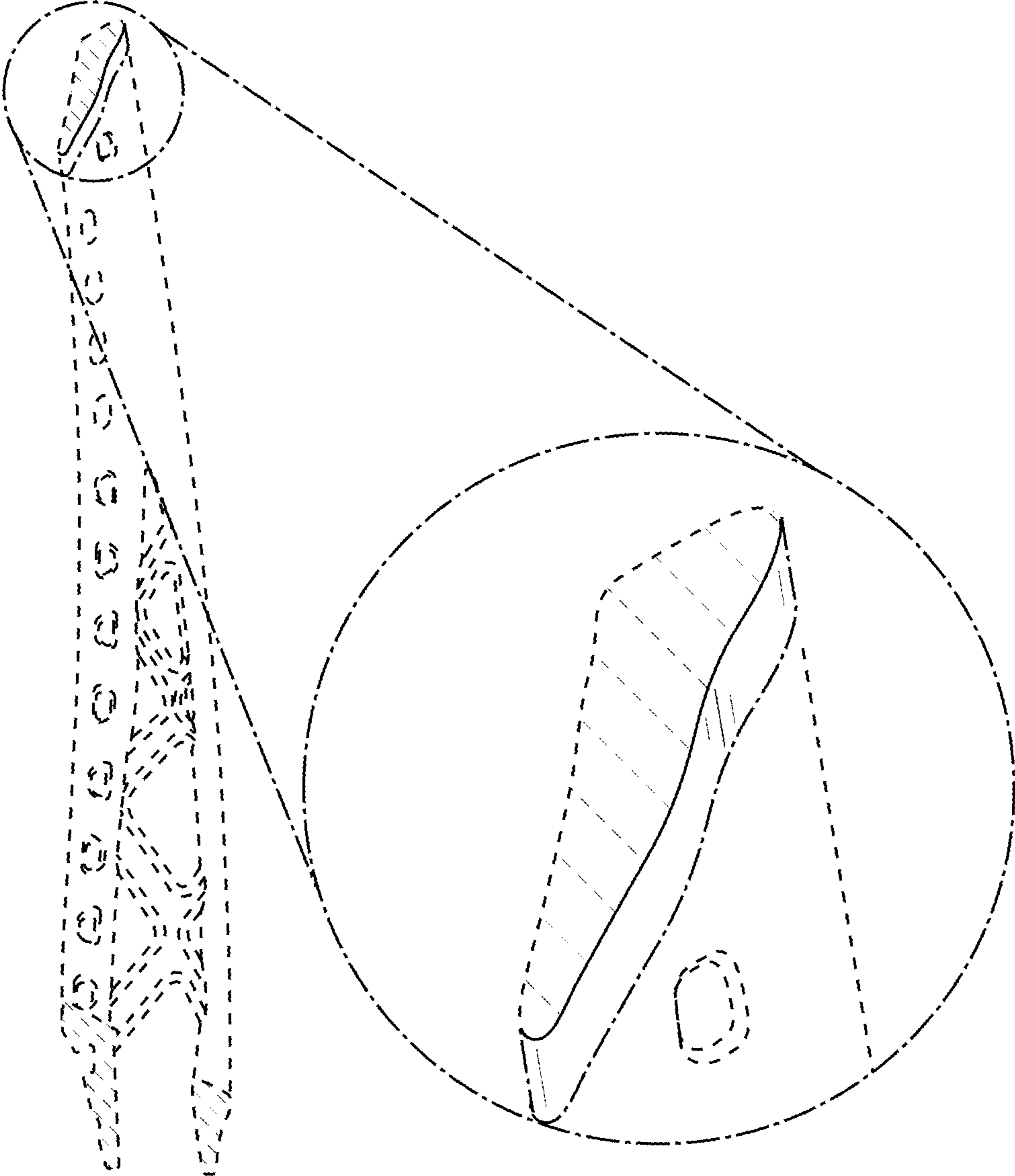
