(57) **CLAIM**

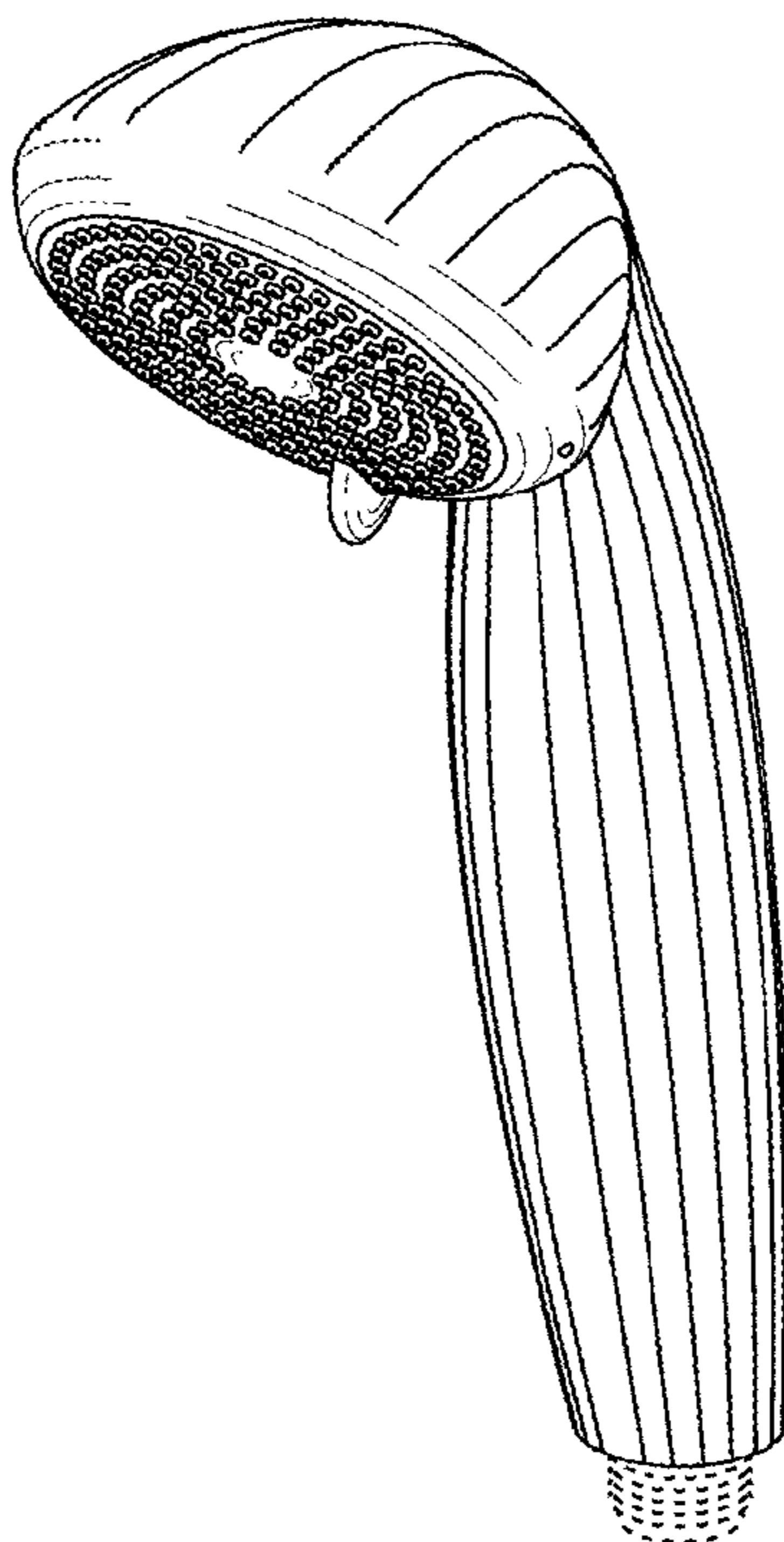
The ornamental design for shower head, as shown and described.

DESCRIPTION

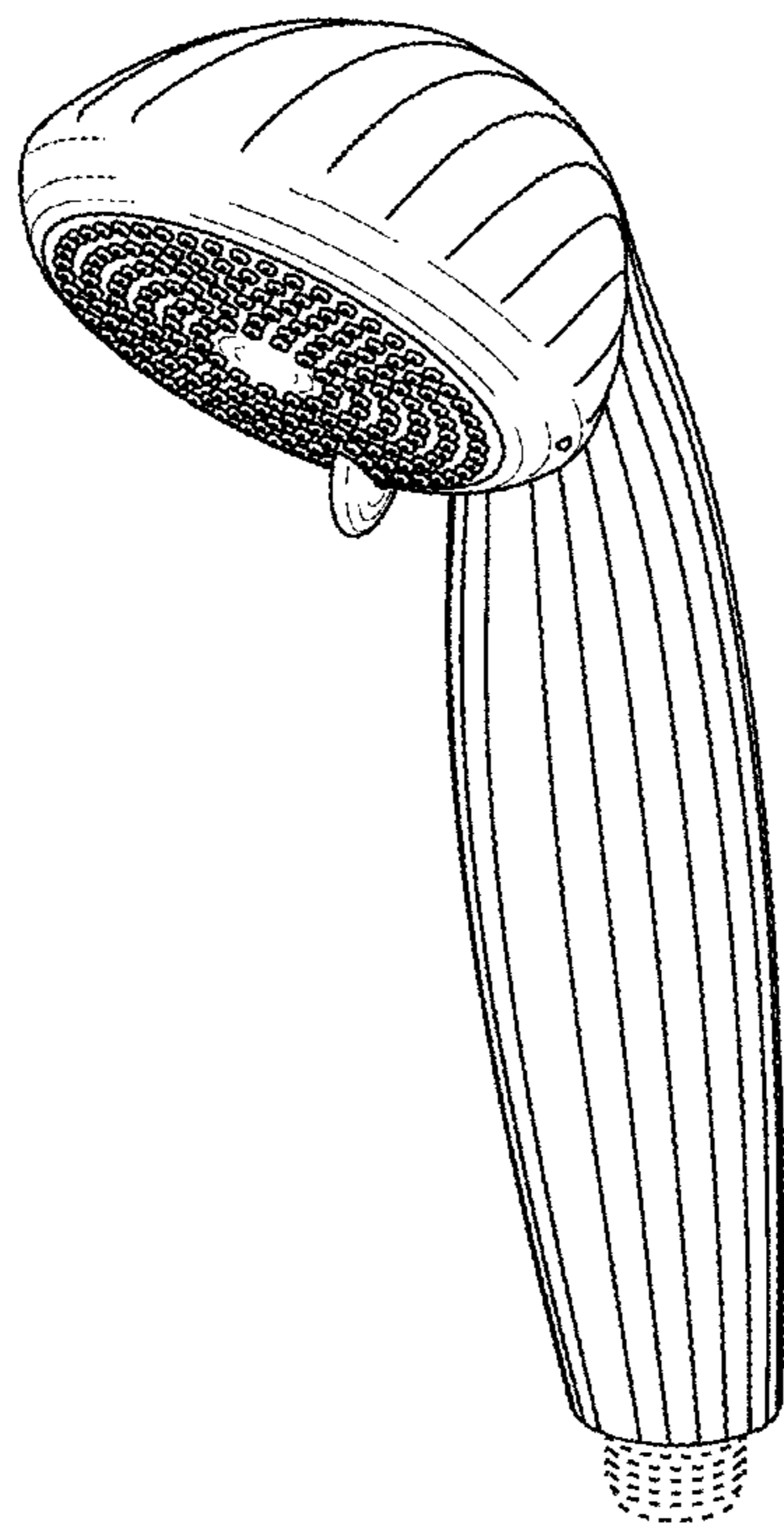

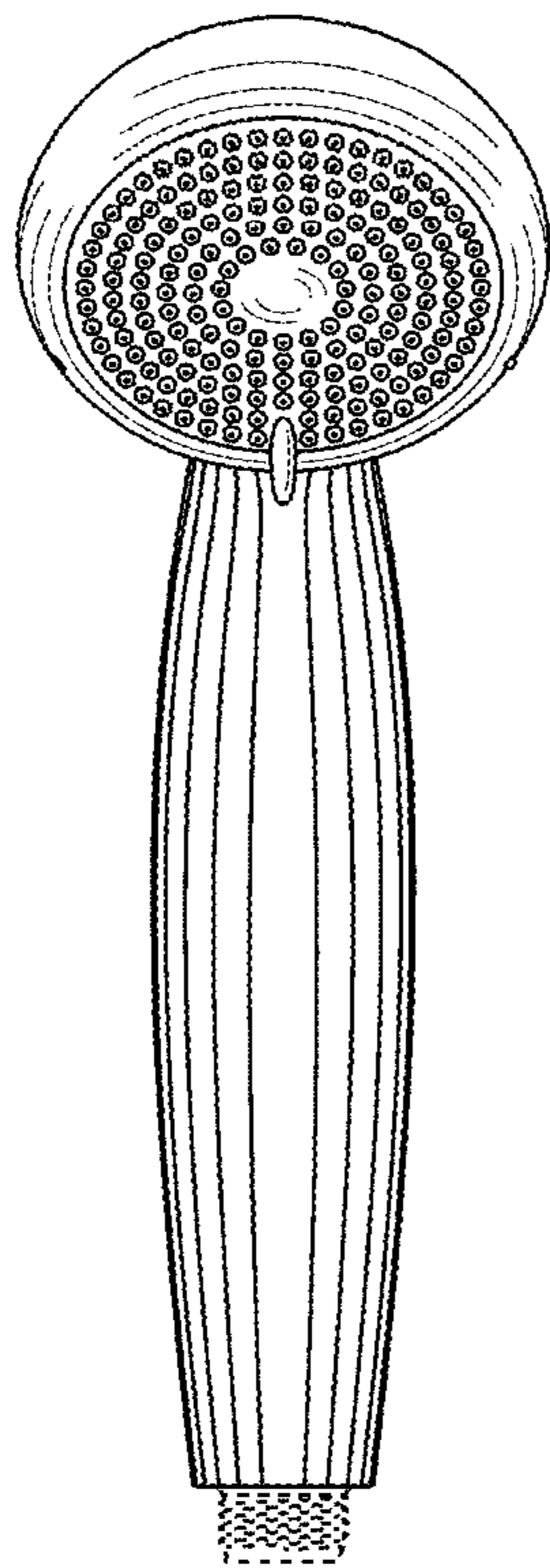

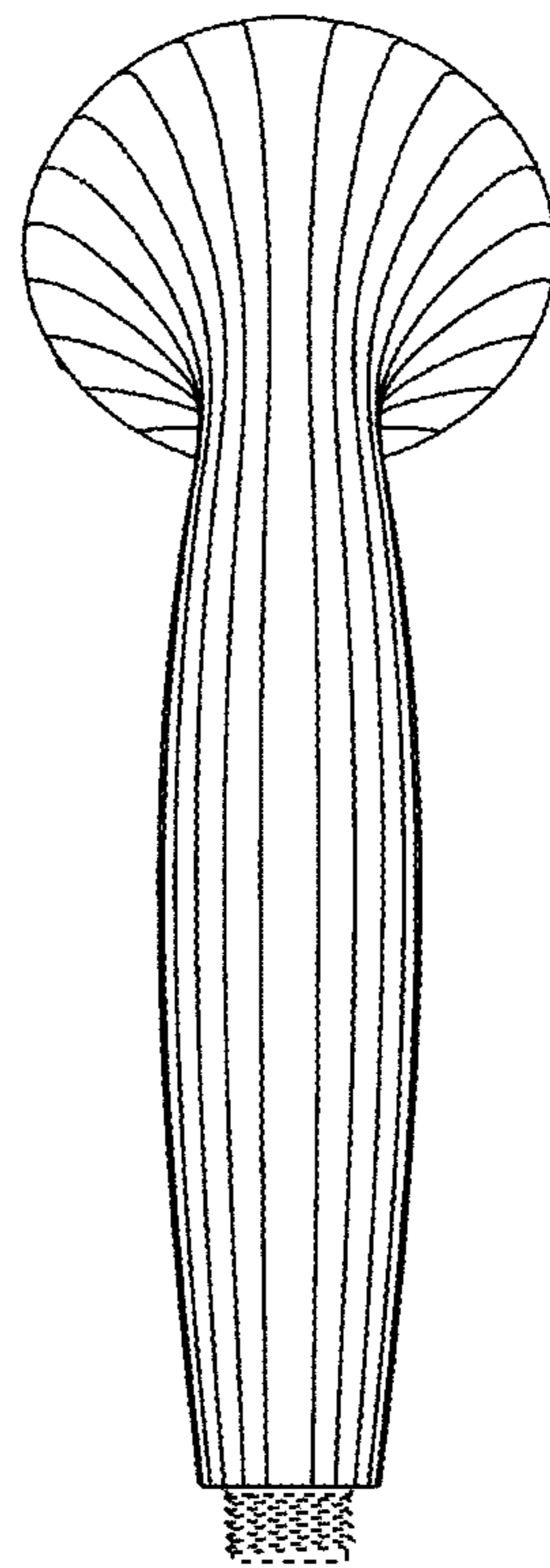

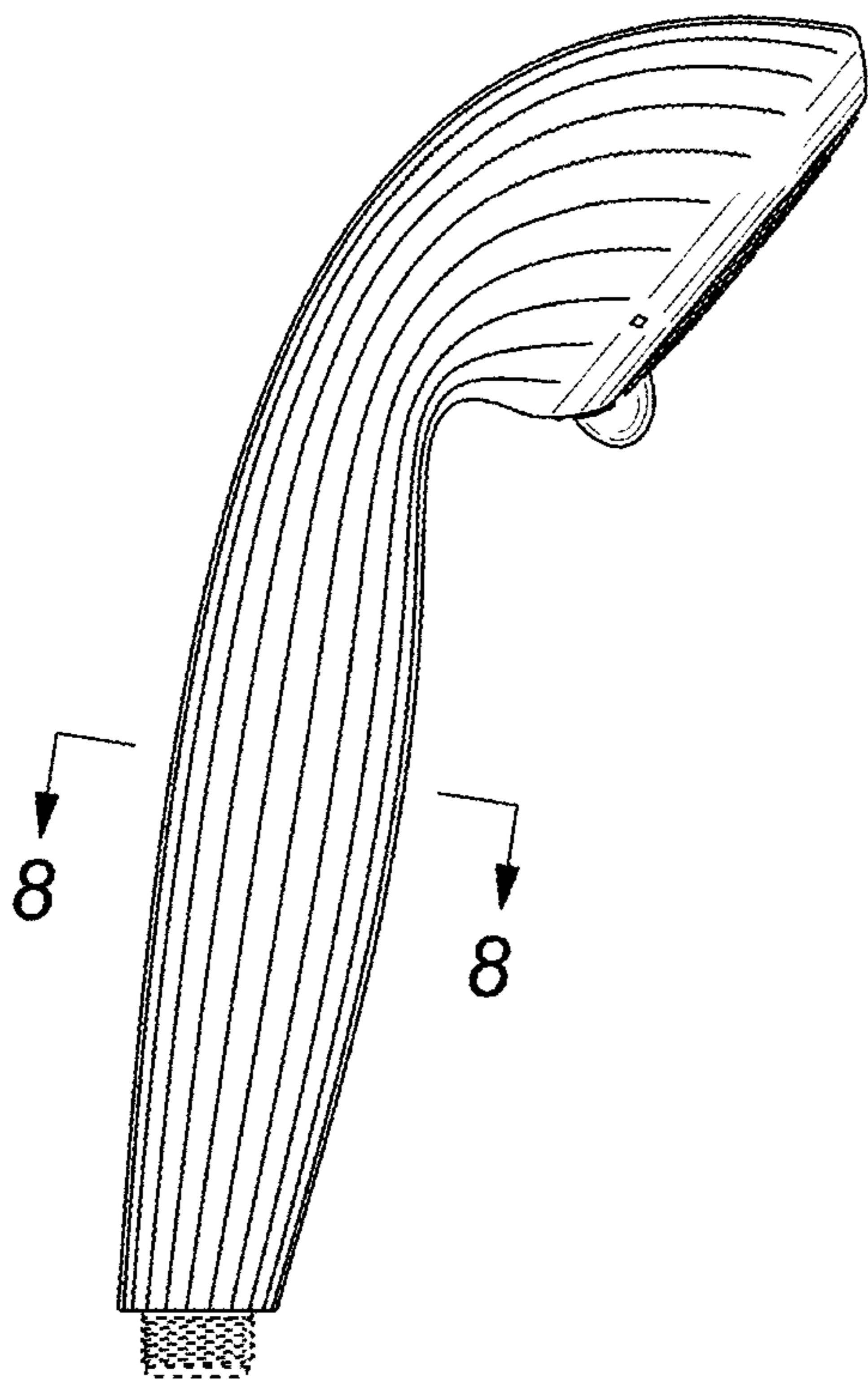

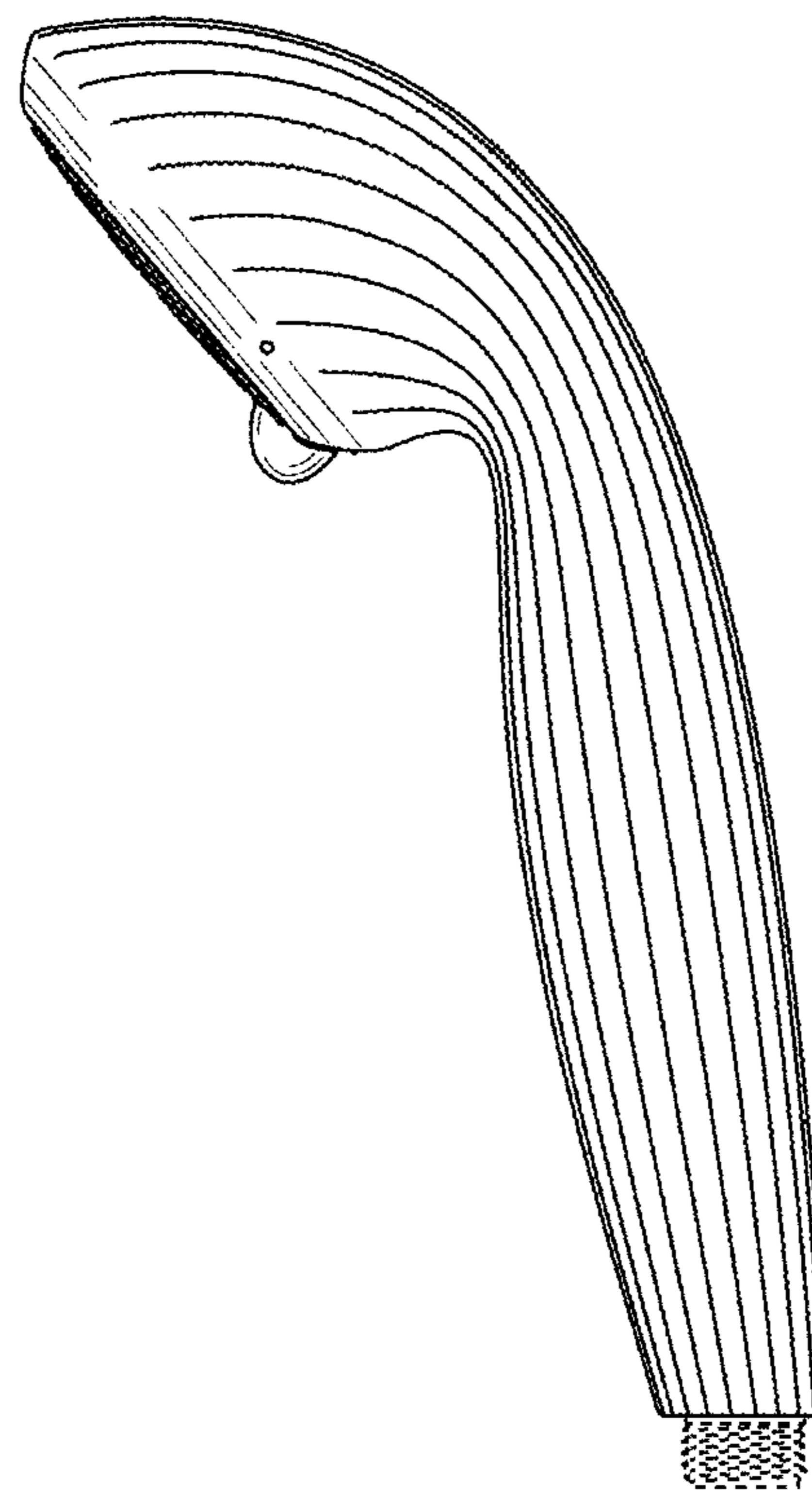

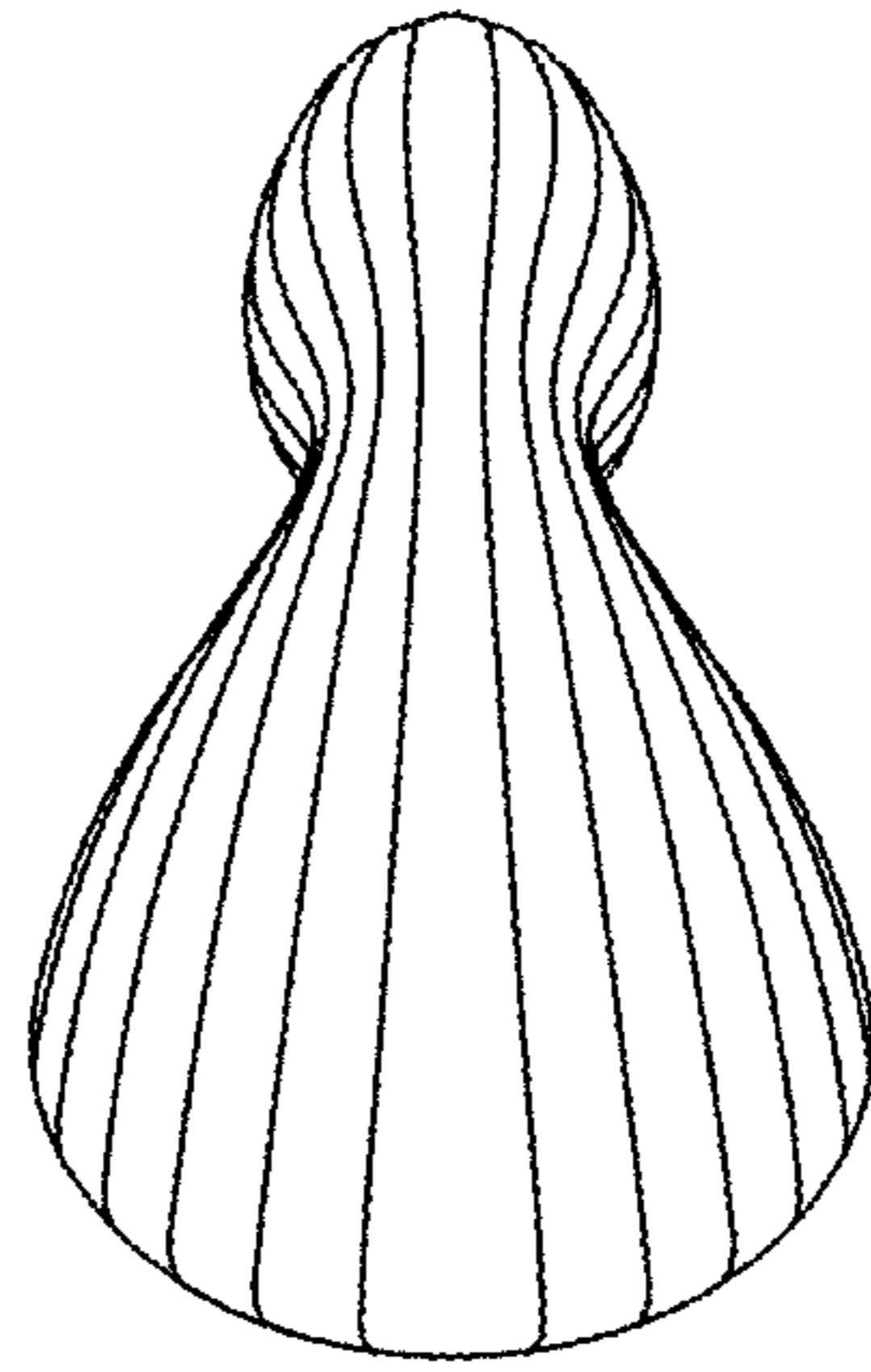

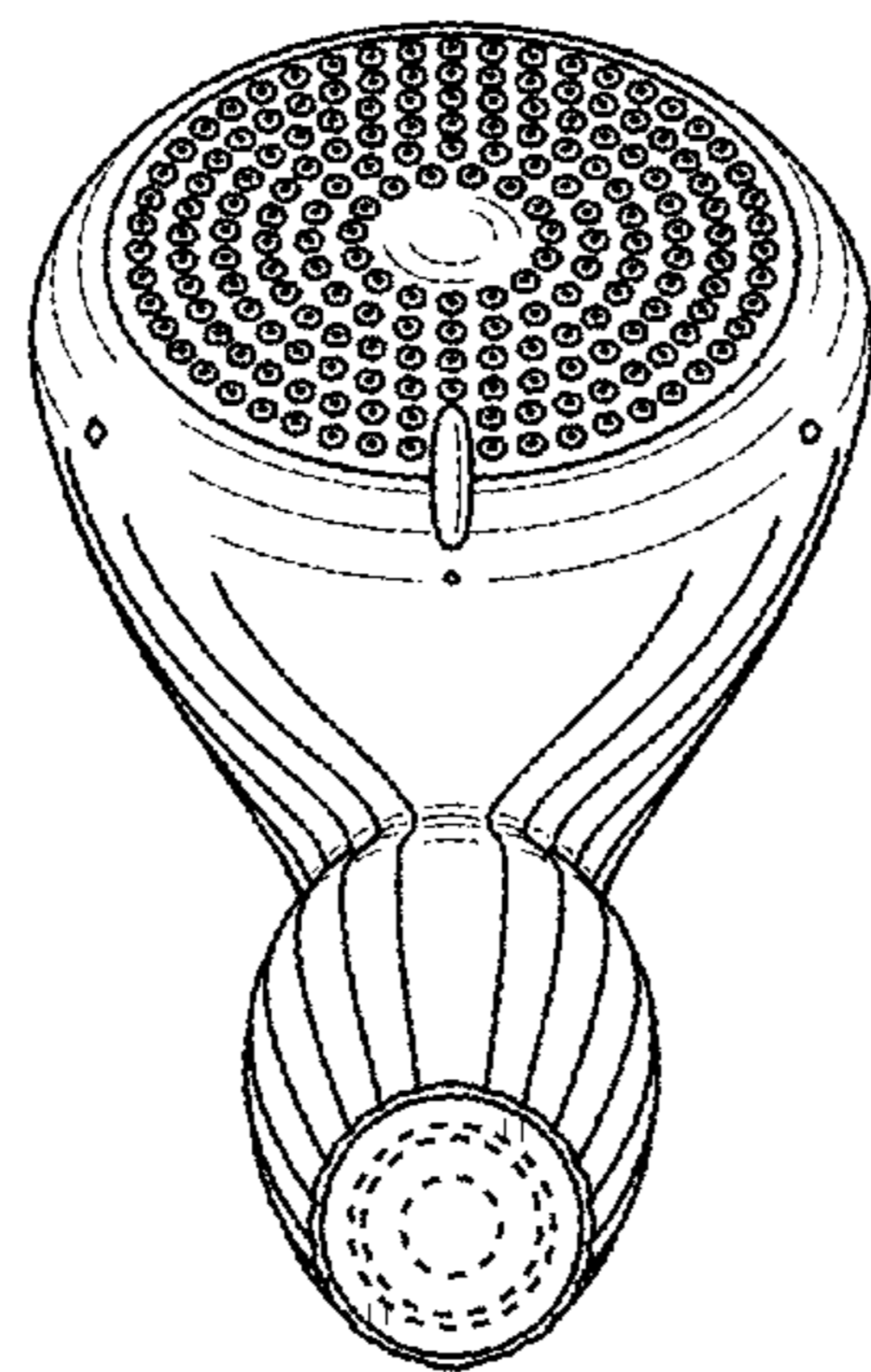

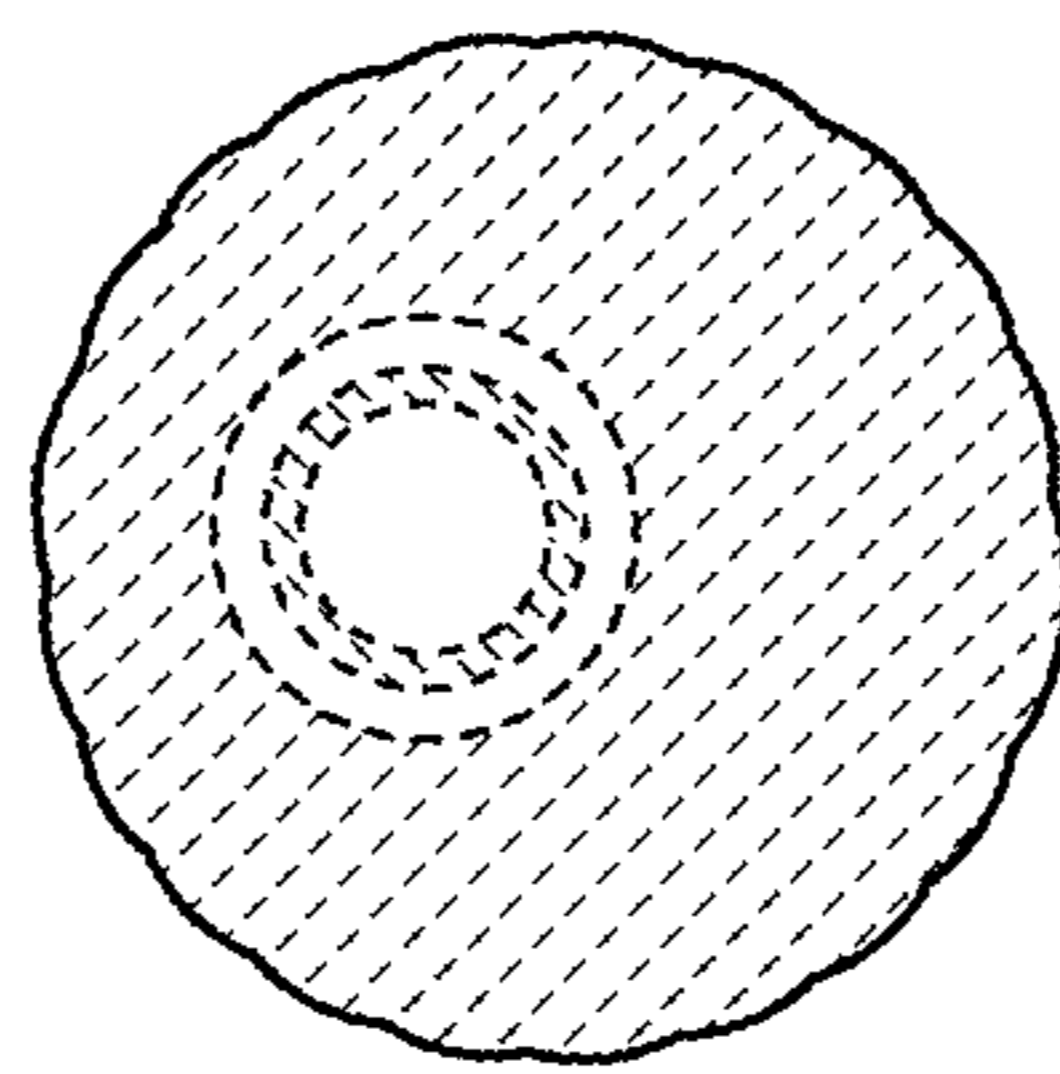
