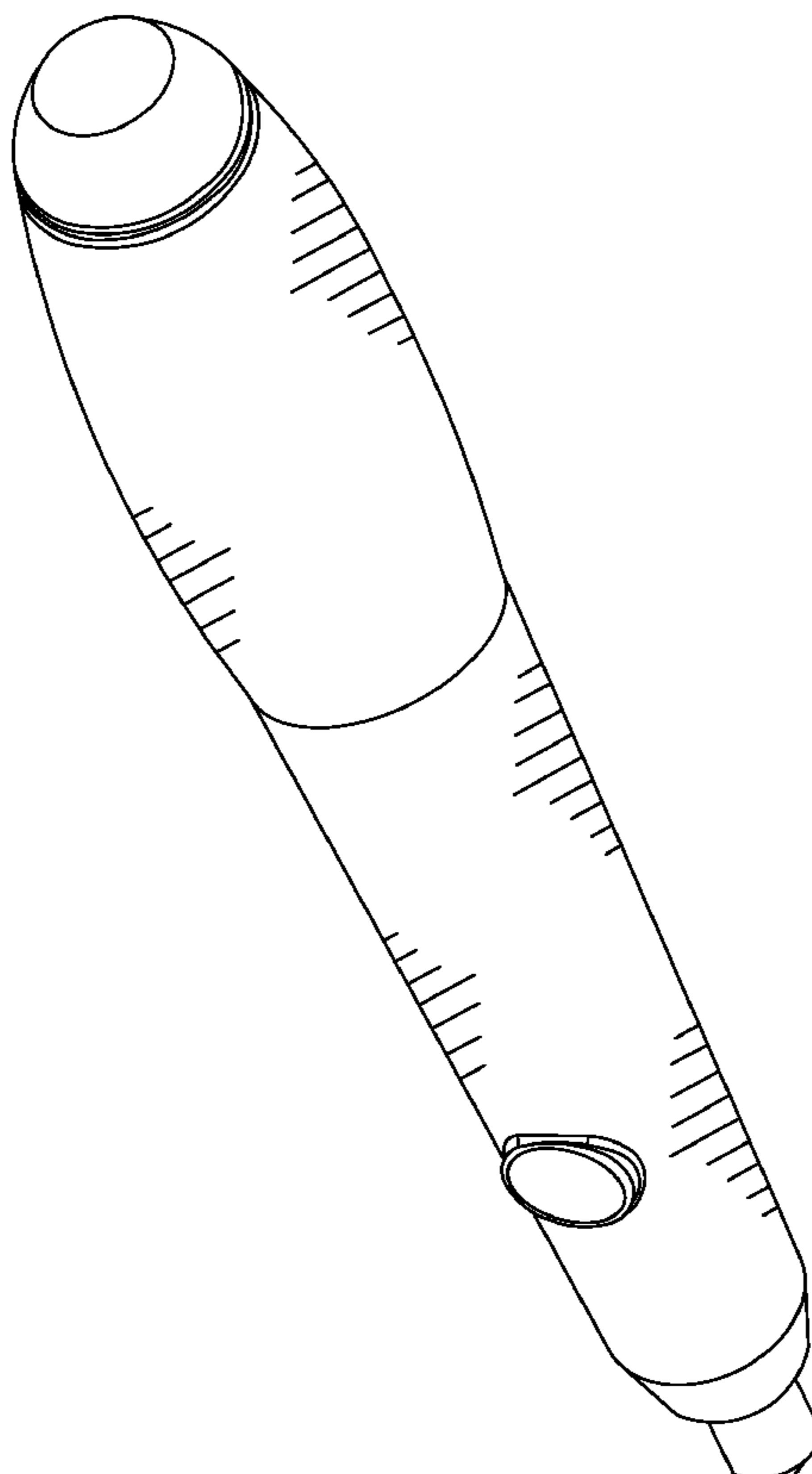
(57) **CLAIM**

DESCRIPTION

pigment detector pen showing my new design;

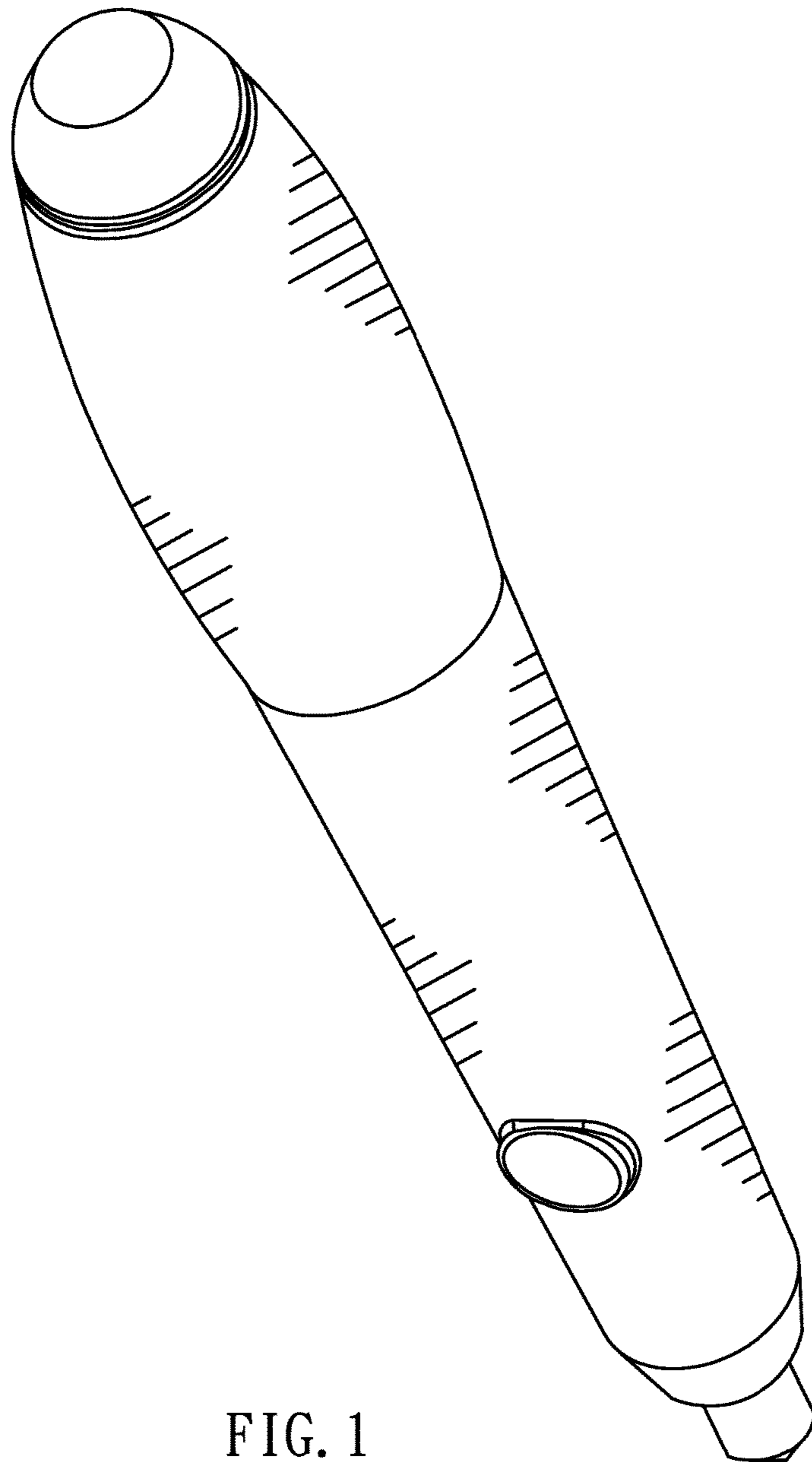

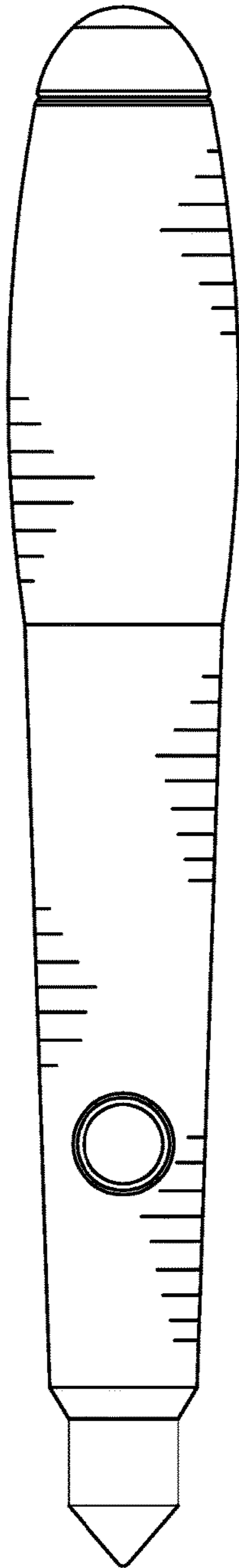

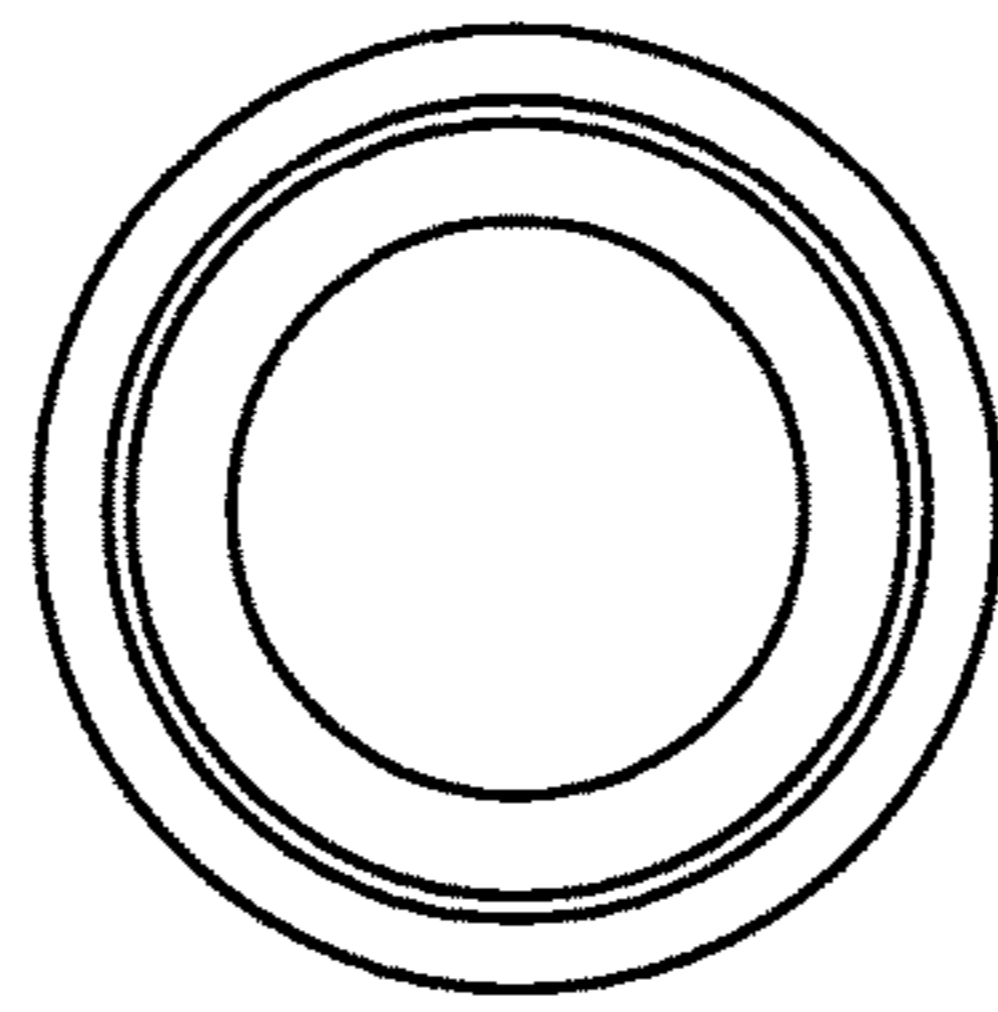

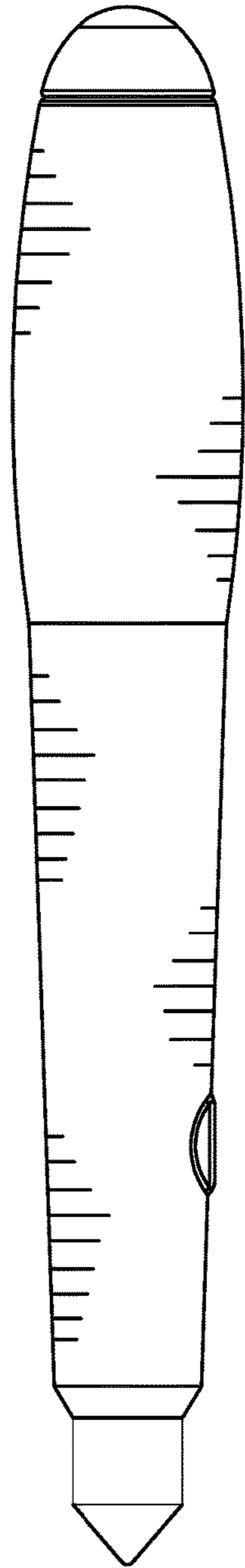

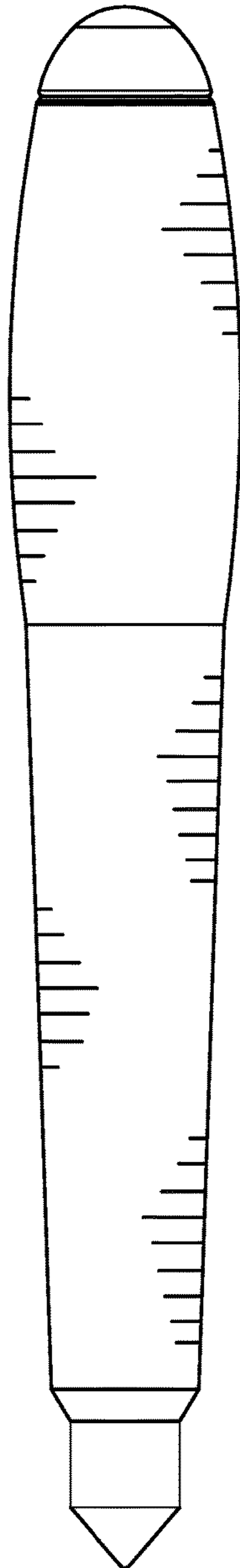

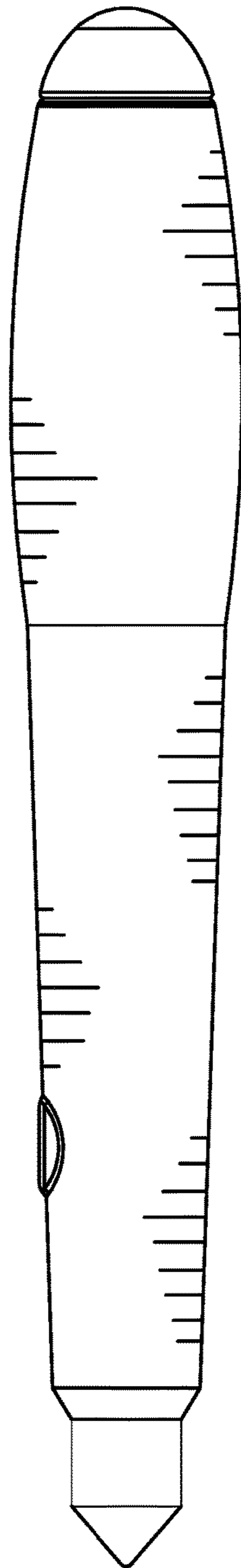

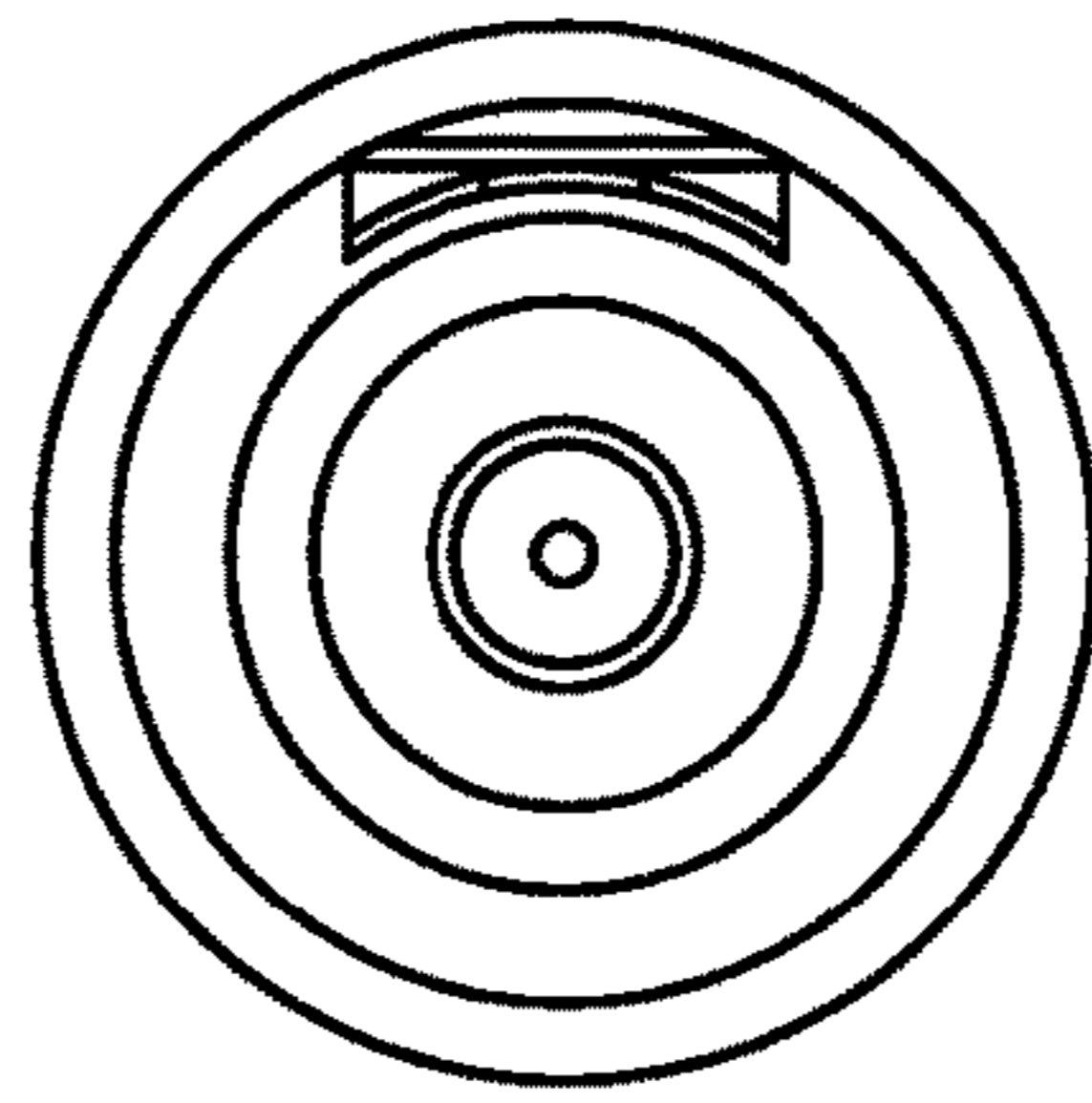
