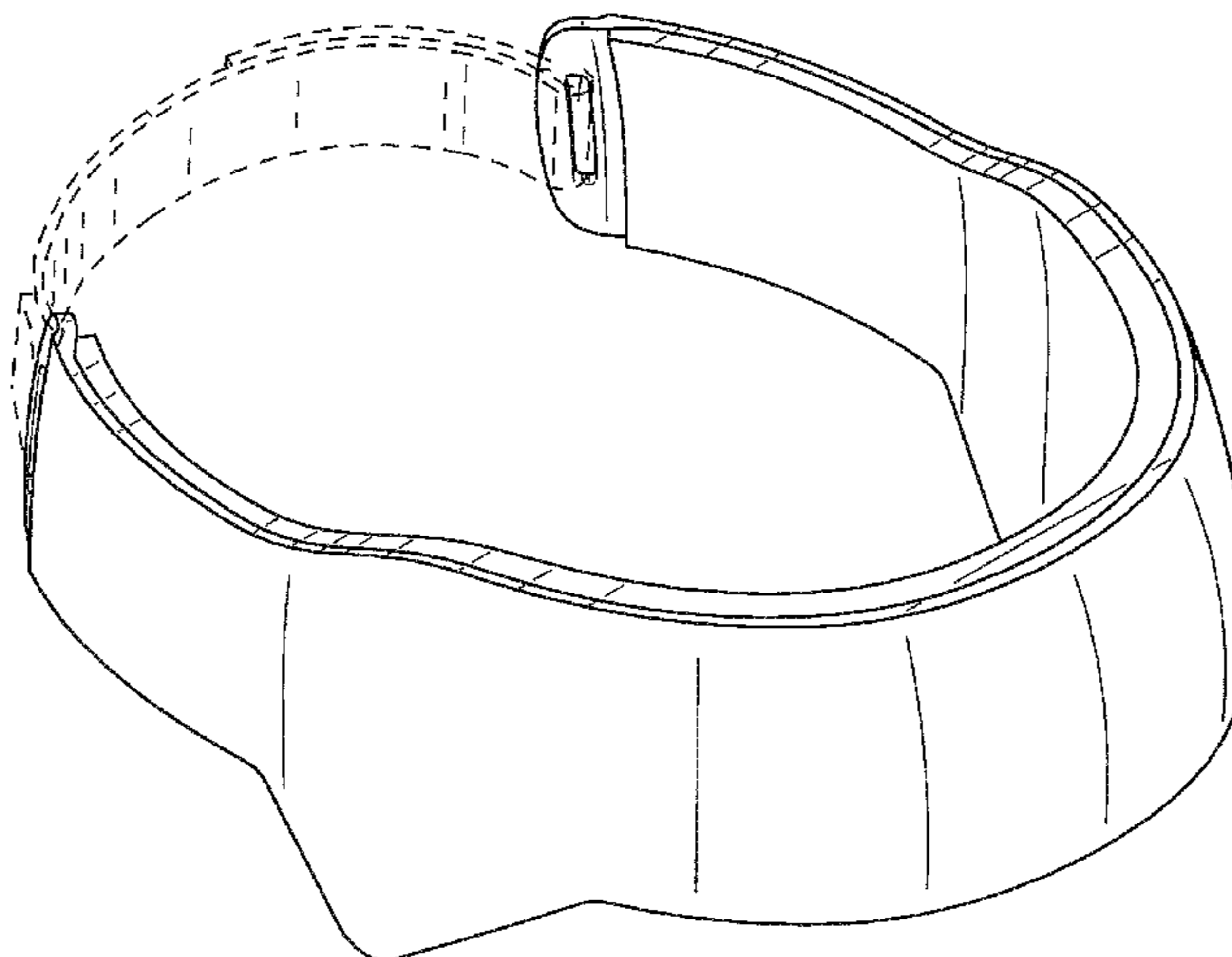
(57) **CLAIM**

The ornamental design for a protective liner for a cap, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a protective liner for a cap in accordance with my design;
FIG. 2 is a second perspective view thereof;
FIG. 3 is right side elevation view of the protective liner for a cap;
FIG. 4 is a bottom plan view of the protective liner for a cap;
FIG. 5 is a top plan view thereof;
FIG. 6 is a front elevation view thereof; and,
FIG. 7 is a rear elevation view thereof.

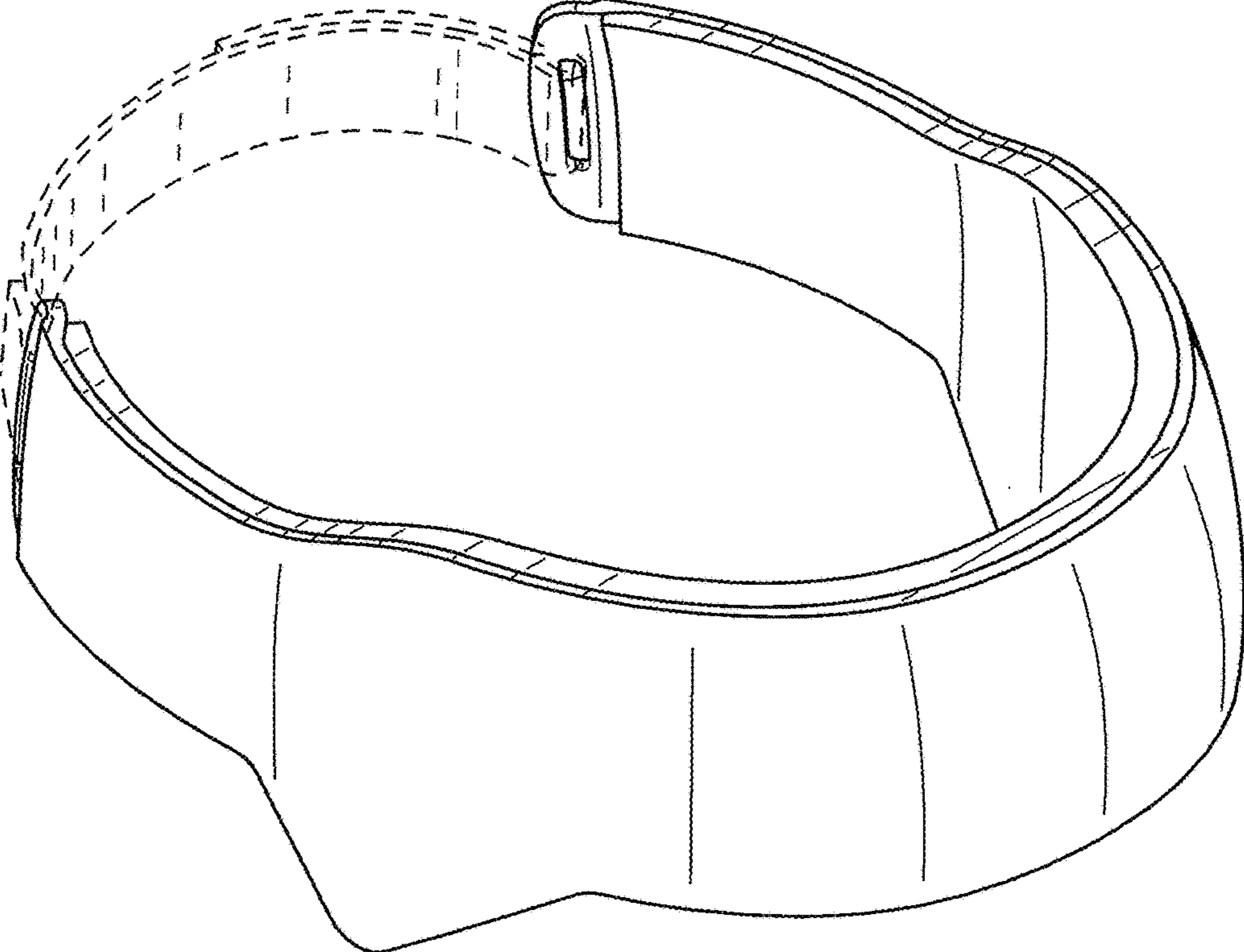

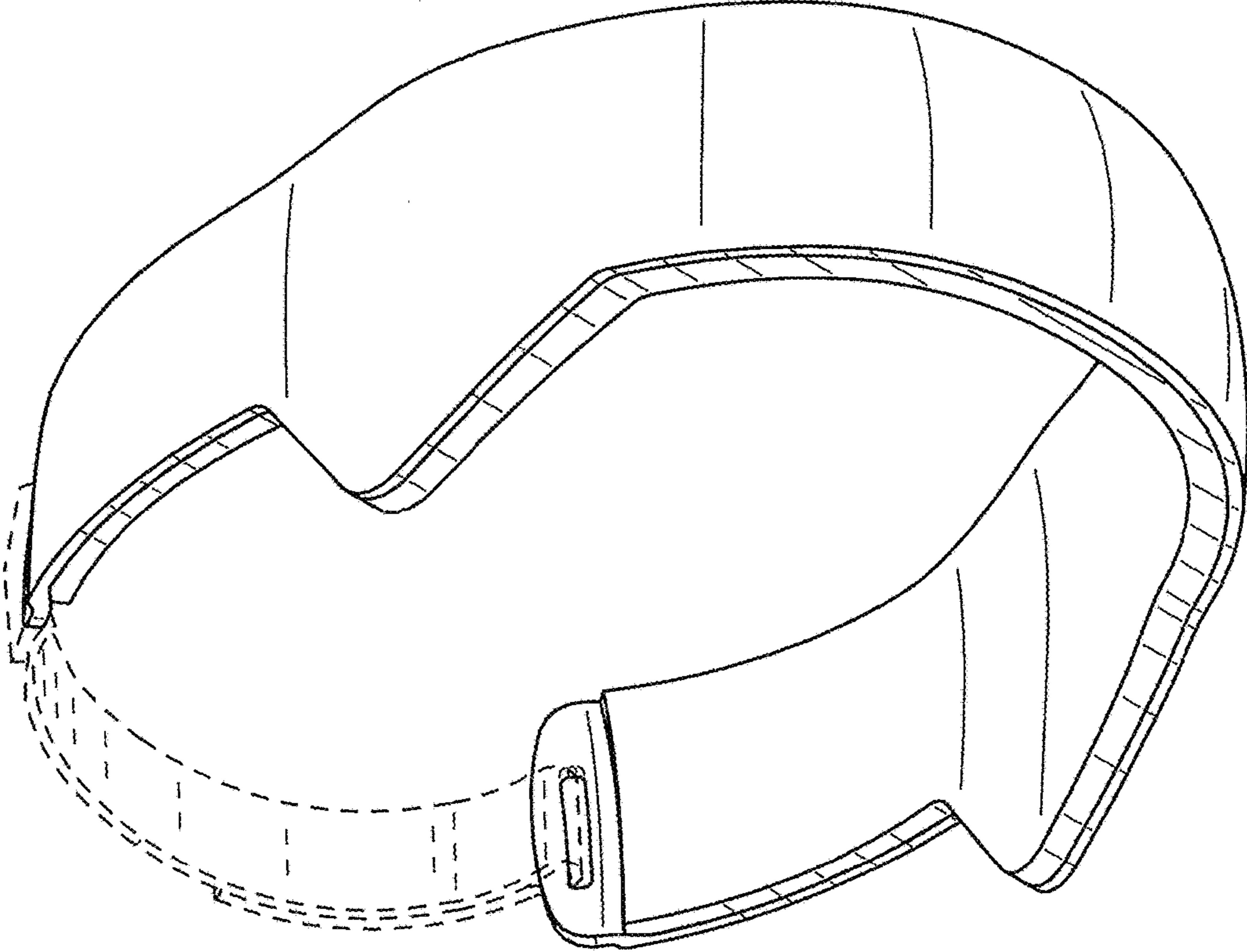

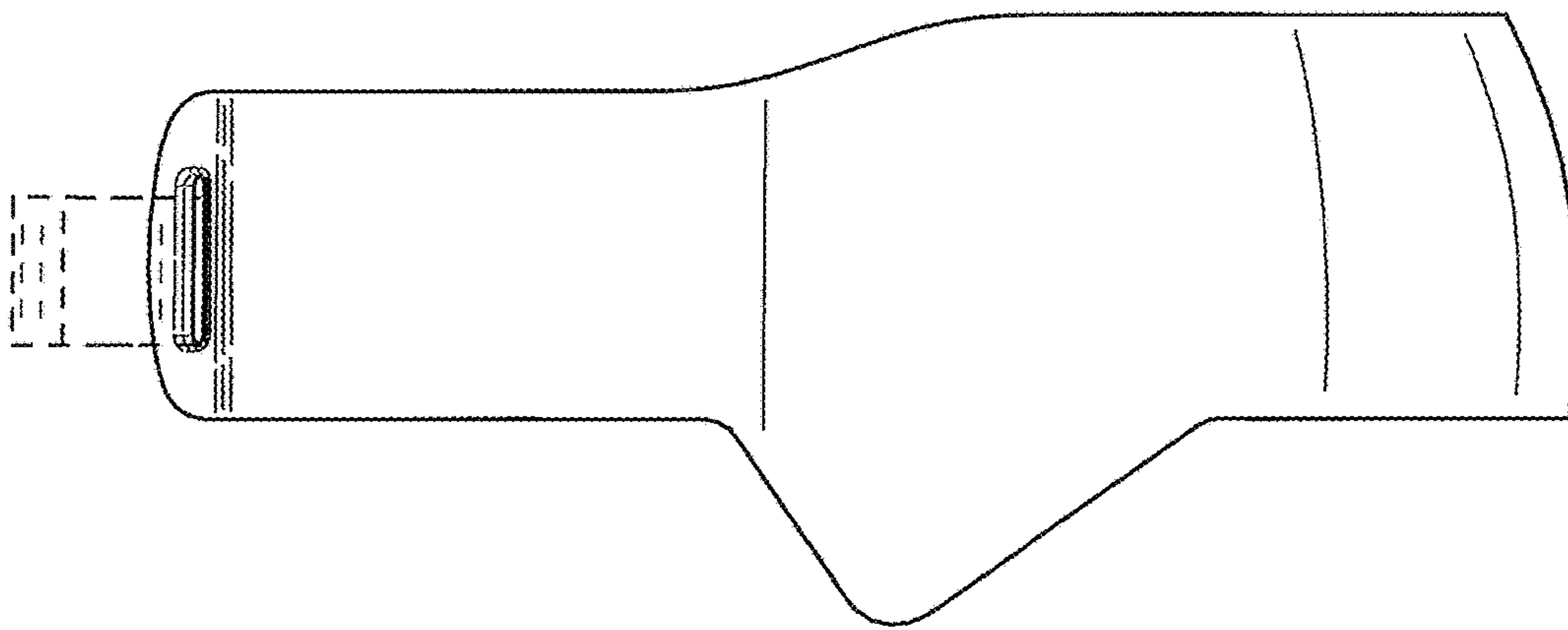

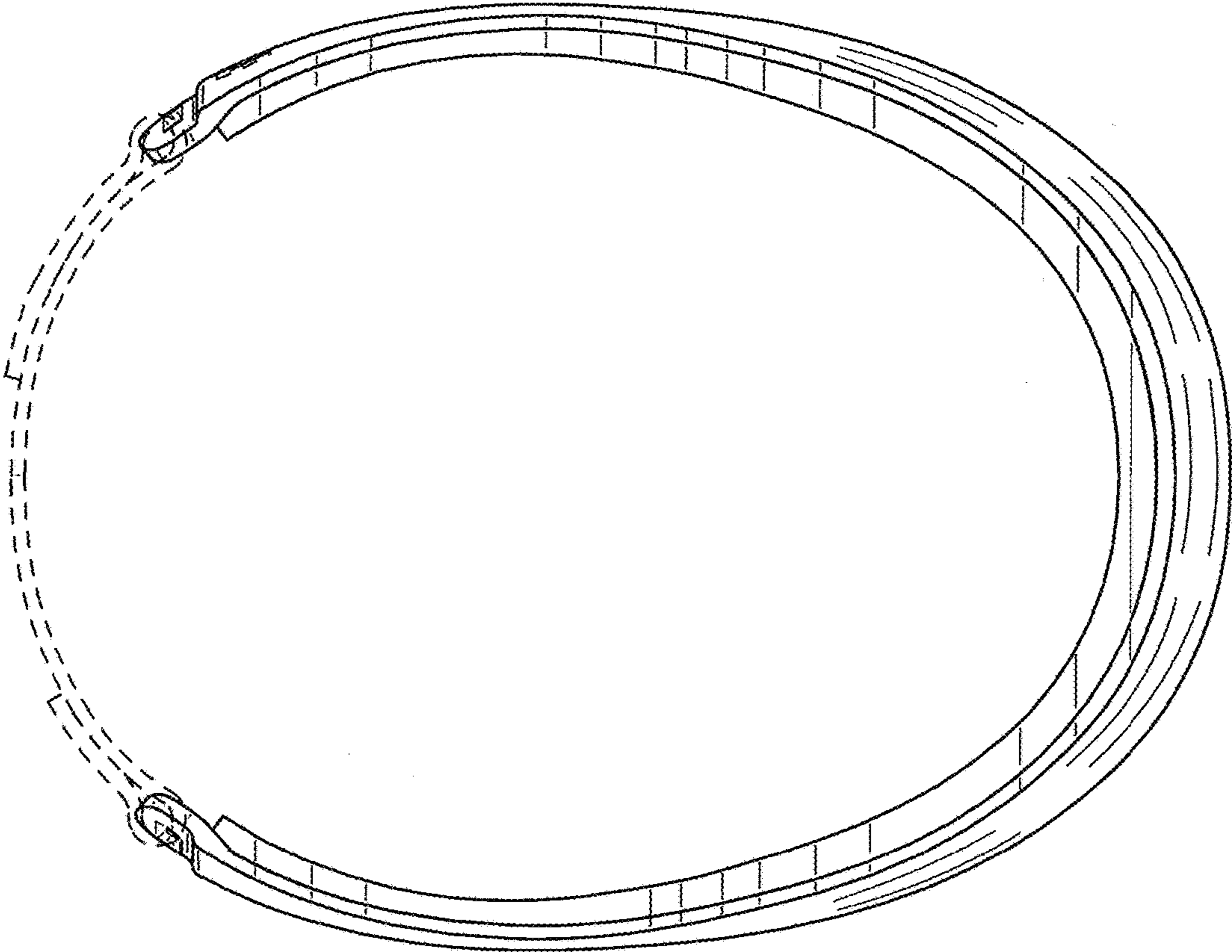

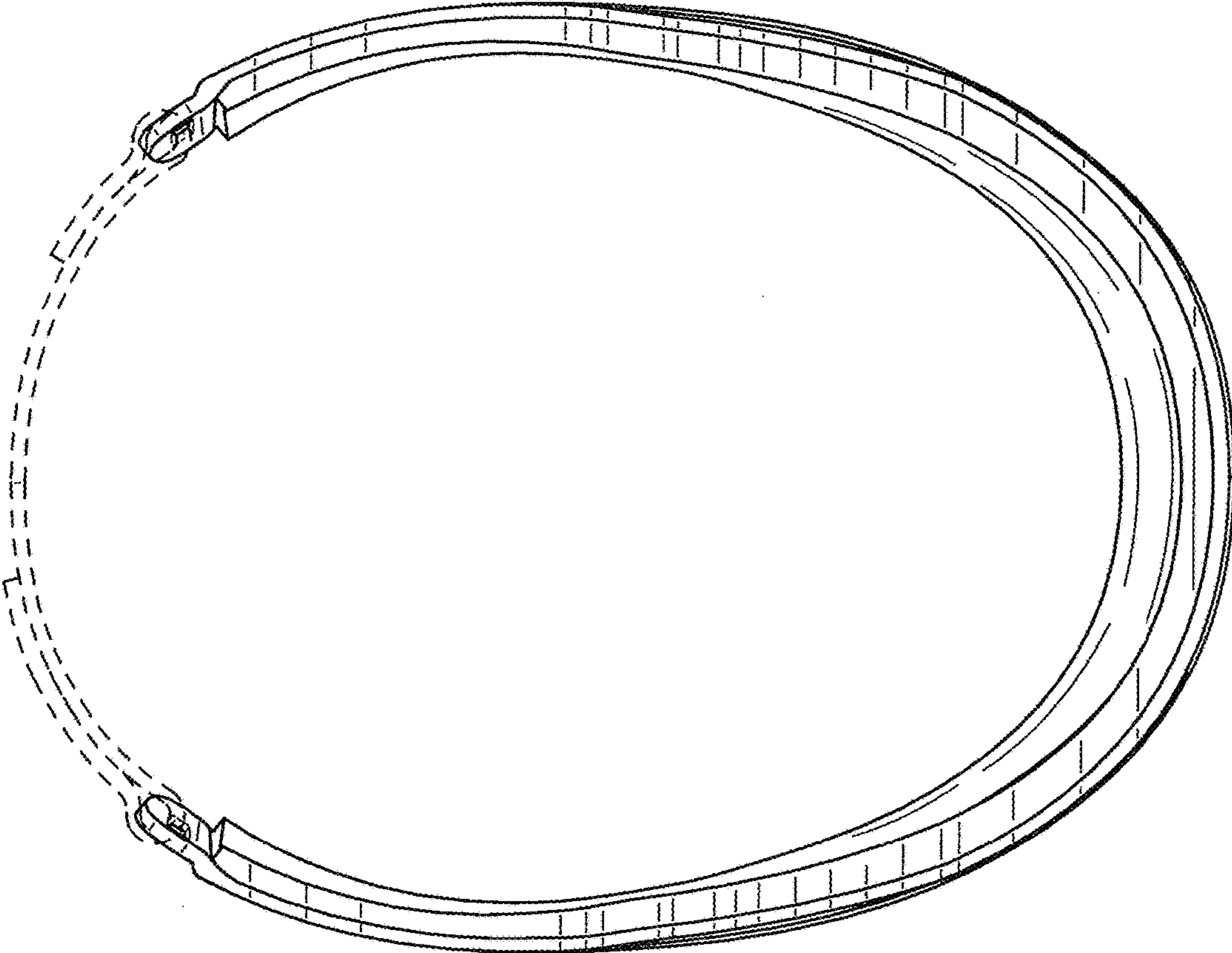

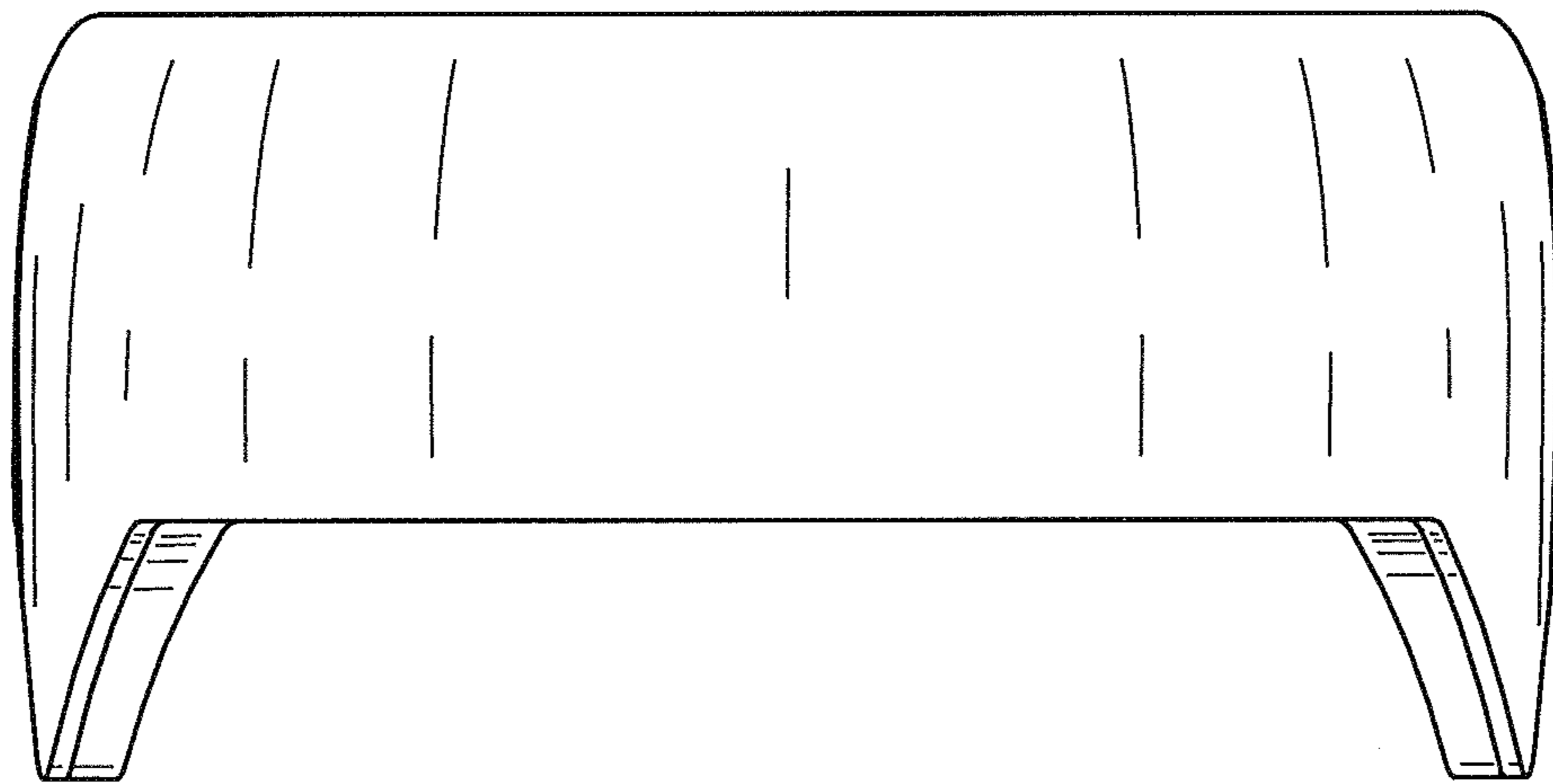

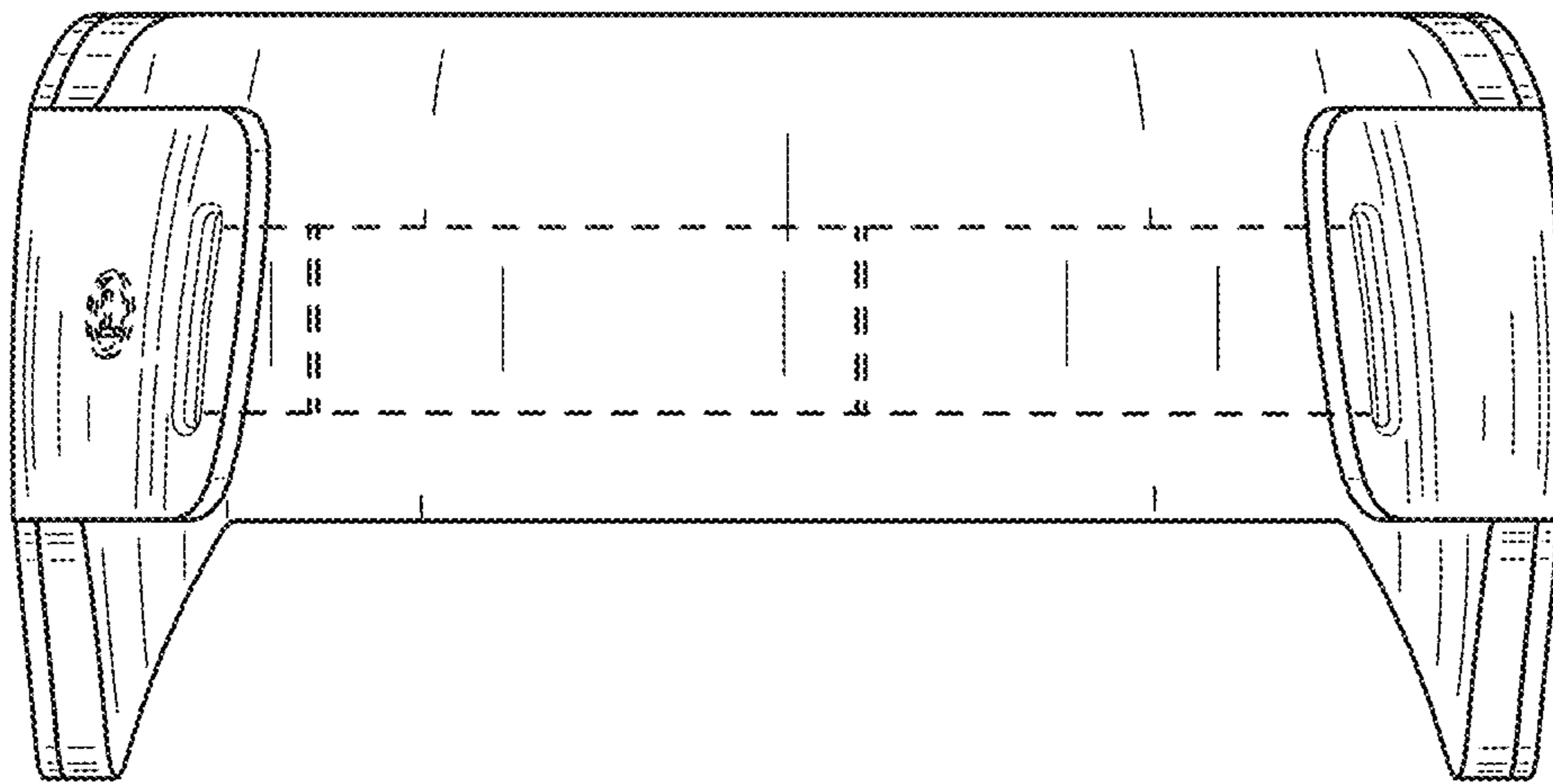
