(57) **CLAIM**

I claim the ornamental design for a glove with enhanced grip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a glove with enhanced grip, showing a first embodiment of my new design;

FIG. 2 is a front elevational view of FIG. 1;

FIG. 3 is a rear elevational view of FIG. 1;

FIG. 4 is a left-side elevational view of FIG. 1;

FIG. 5 is a right-side elevational view of FIG. 1;

FIG. 6 is a top plan view of FIG. 1;

FIG. 7 is a bottom plan view of FIG. 1;

FIG. 8 is a perspective view of a second embodiment thereof;

FIG. 9 is a front elevational view of FIG. 8;

FIG. 10 is a rear elevational view of FIG. 8;

FIG. 11 is a left-side elevational view of FIG. 8;

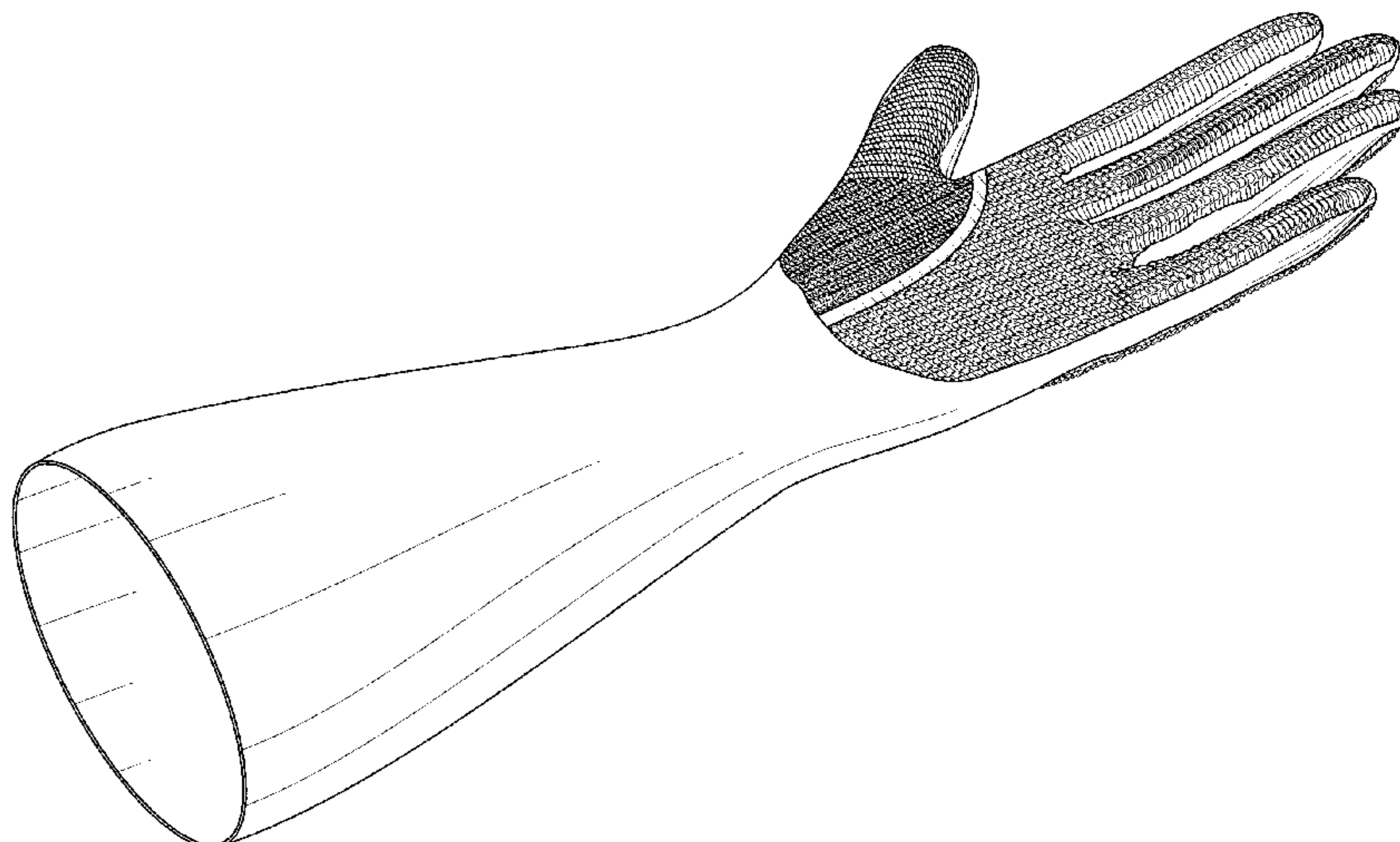
FIG. 12 is a right-side elevational view of FIG. 8;

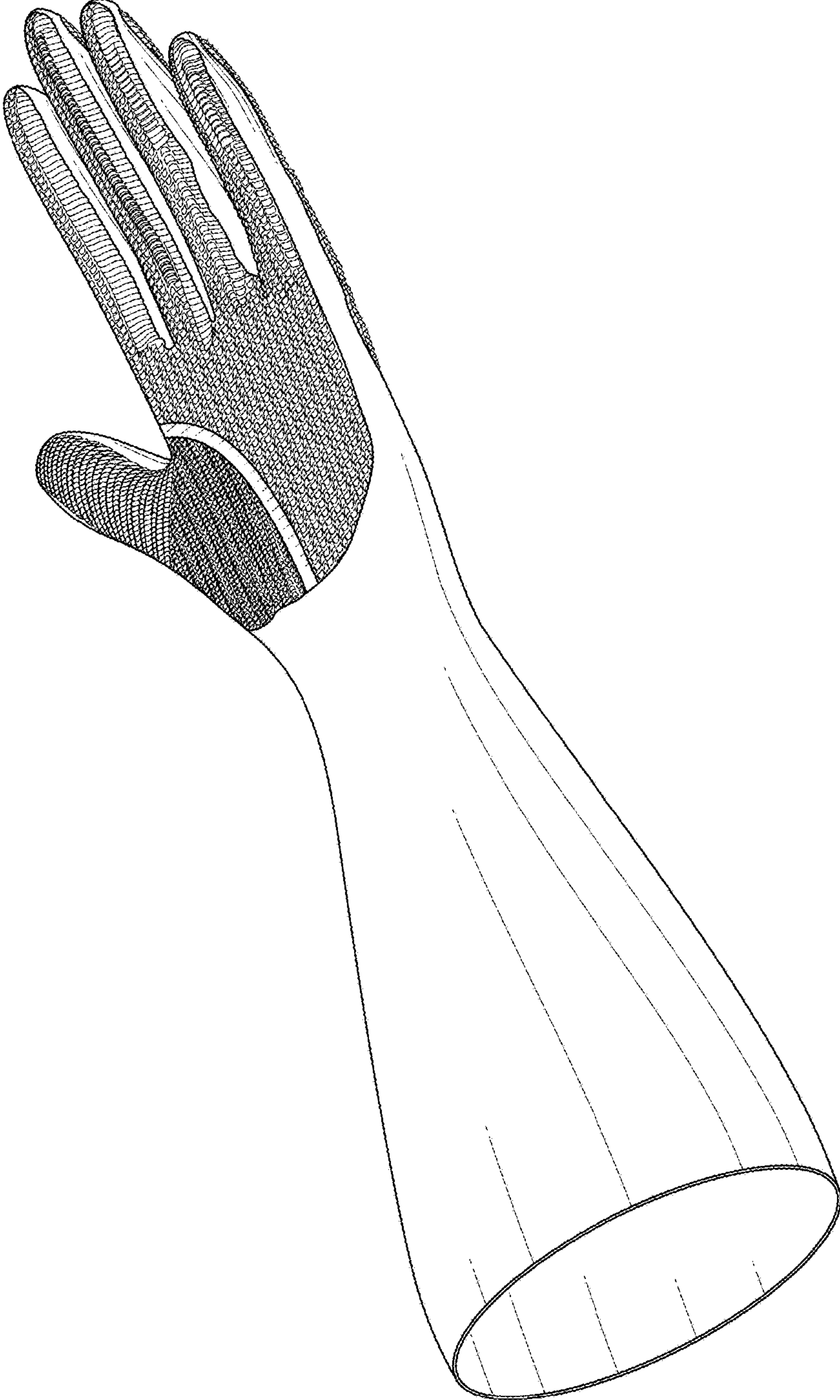

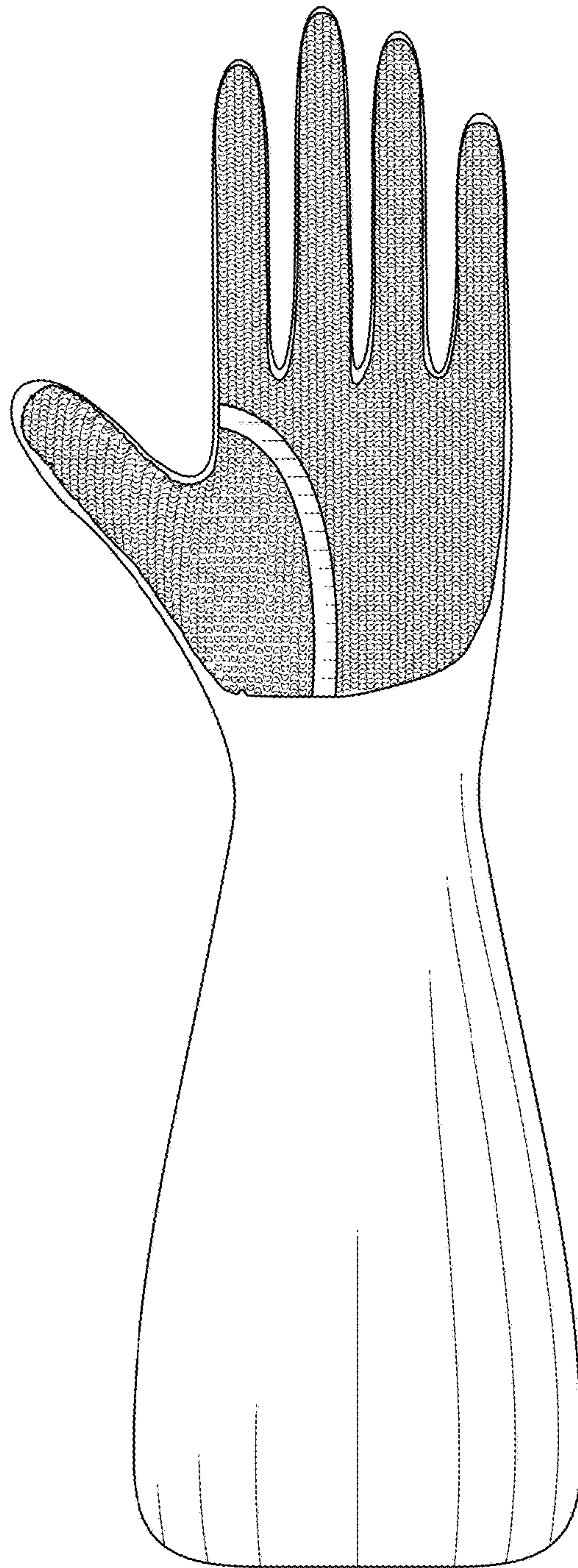

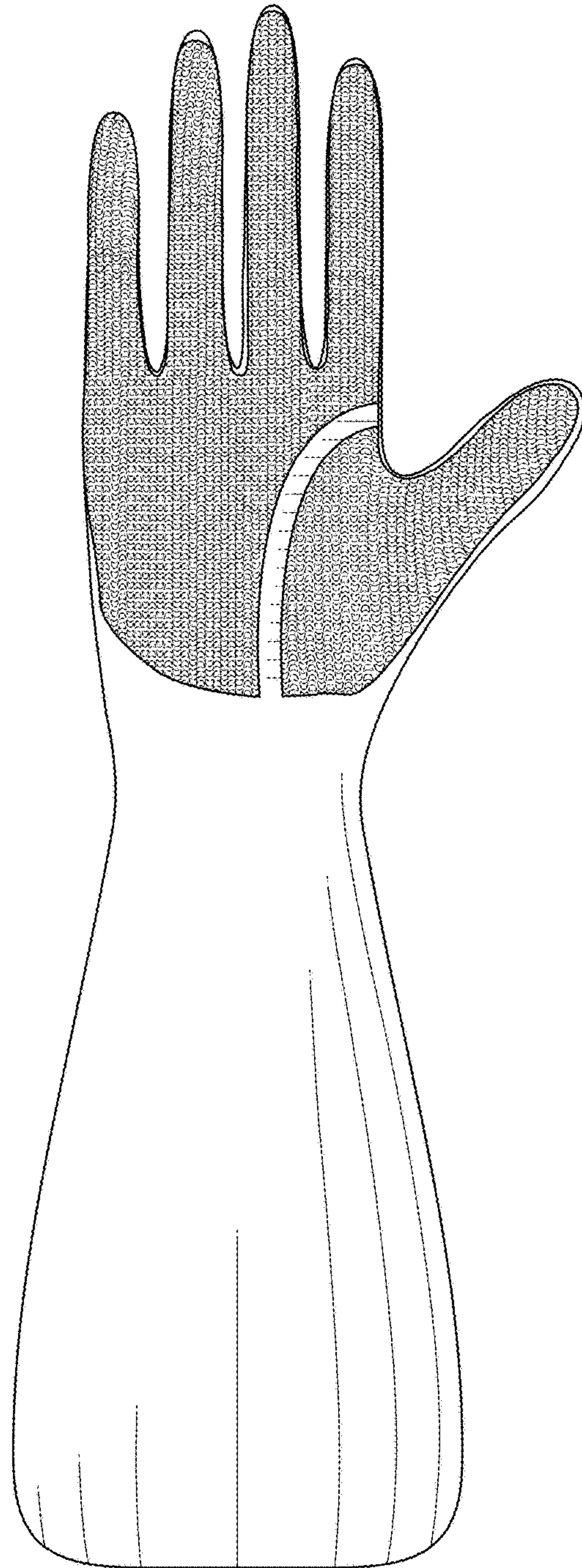

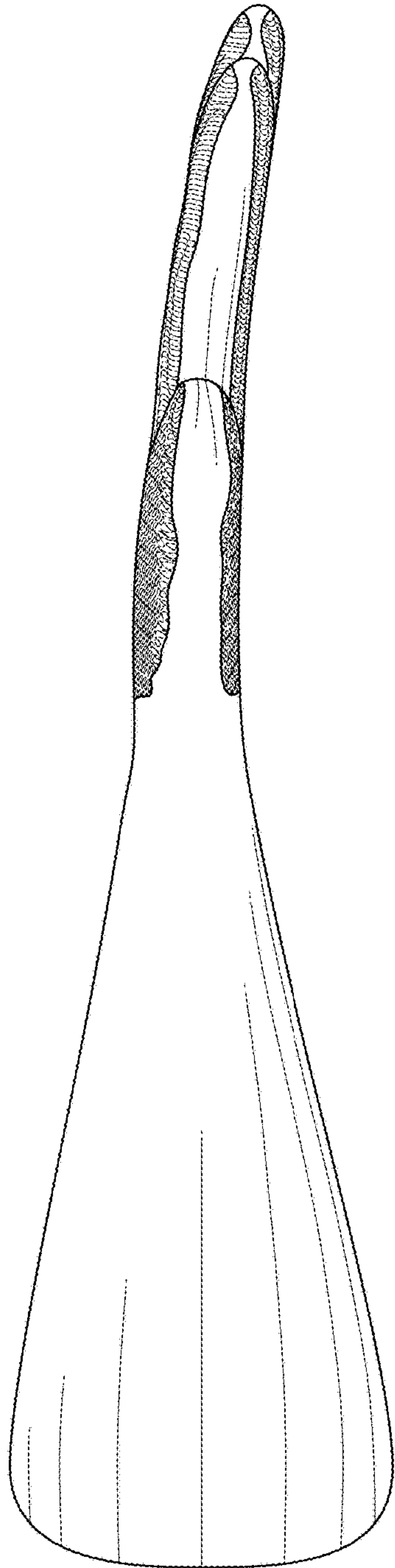

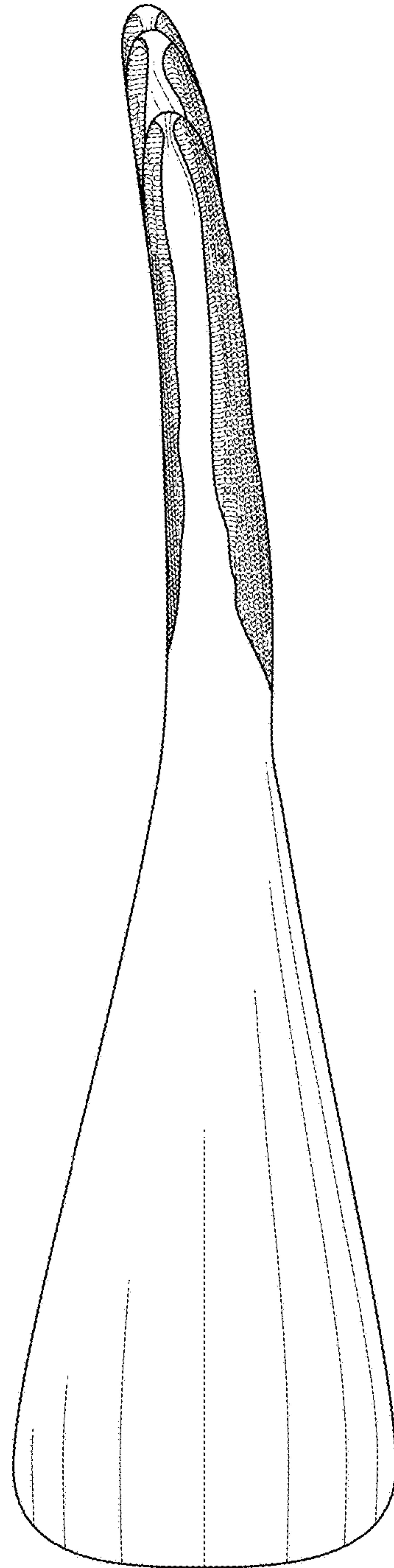

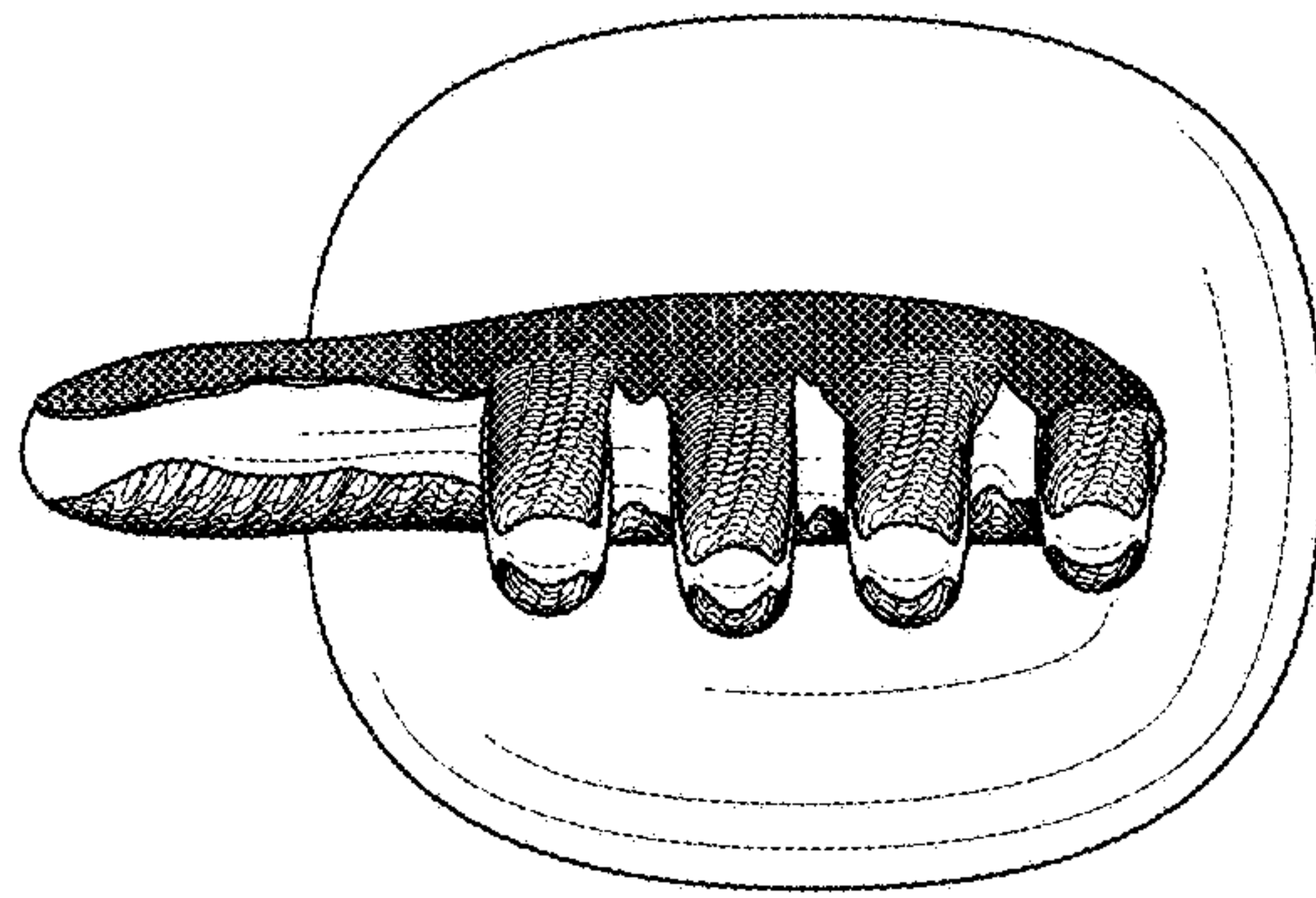

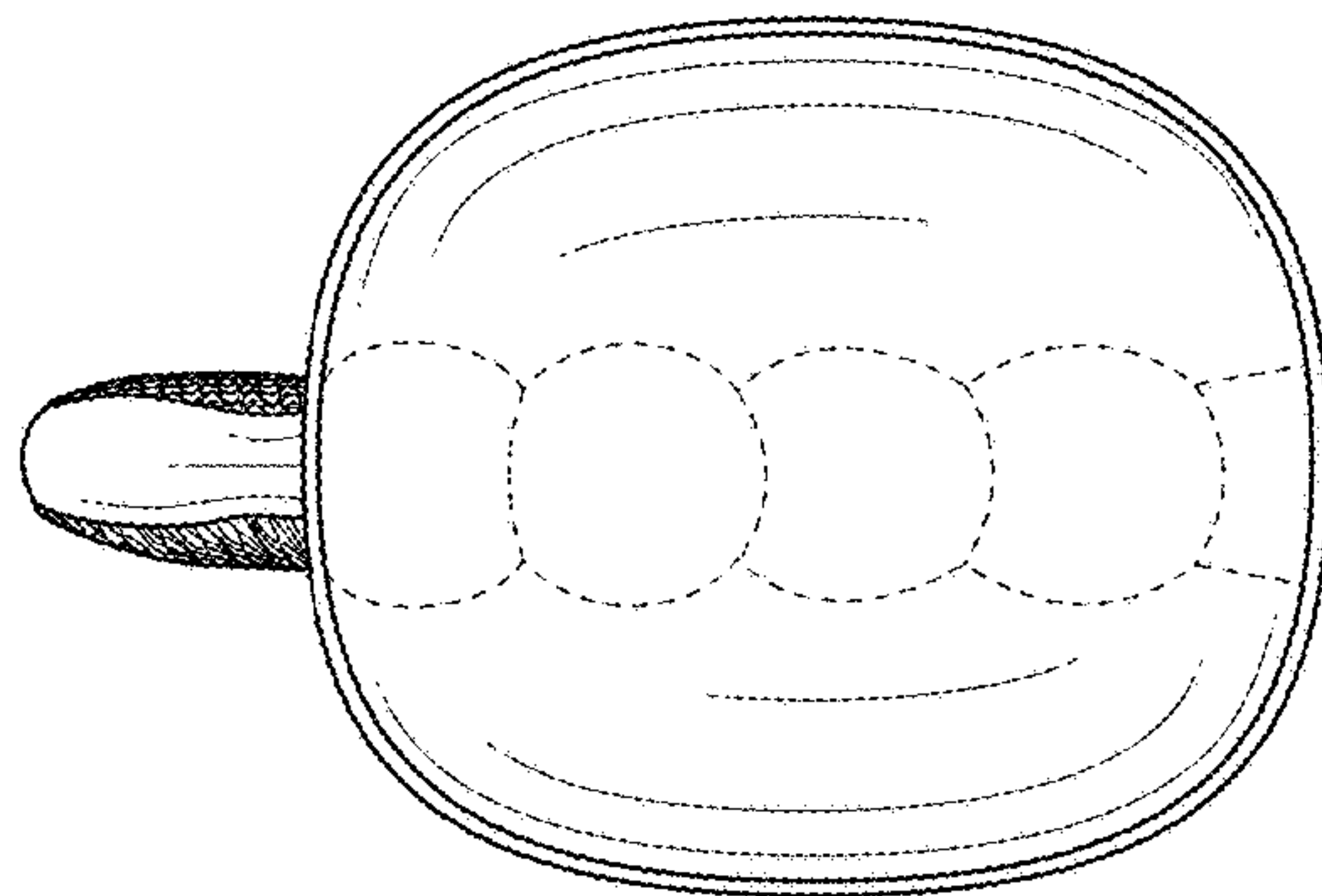

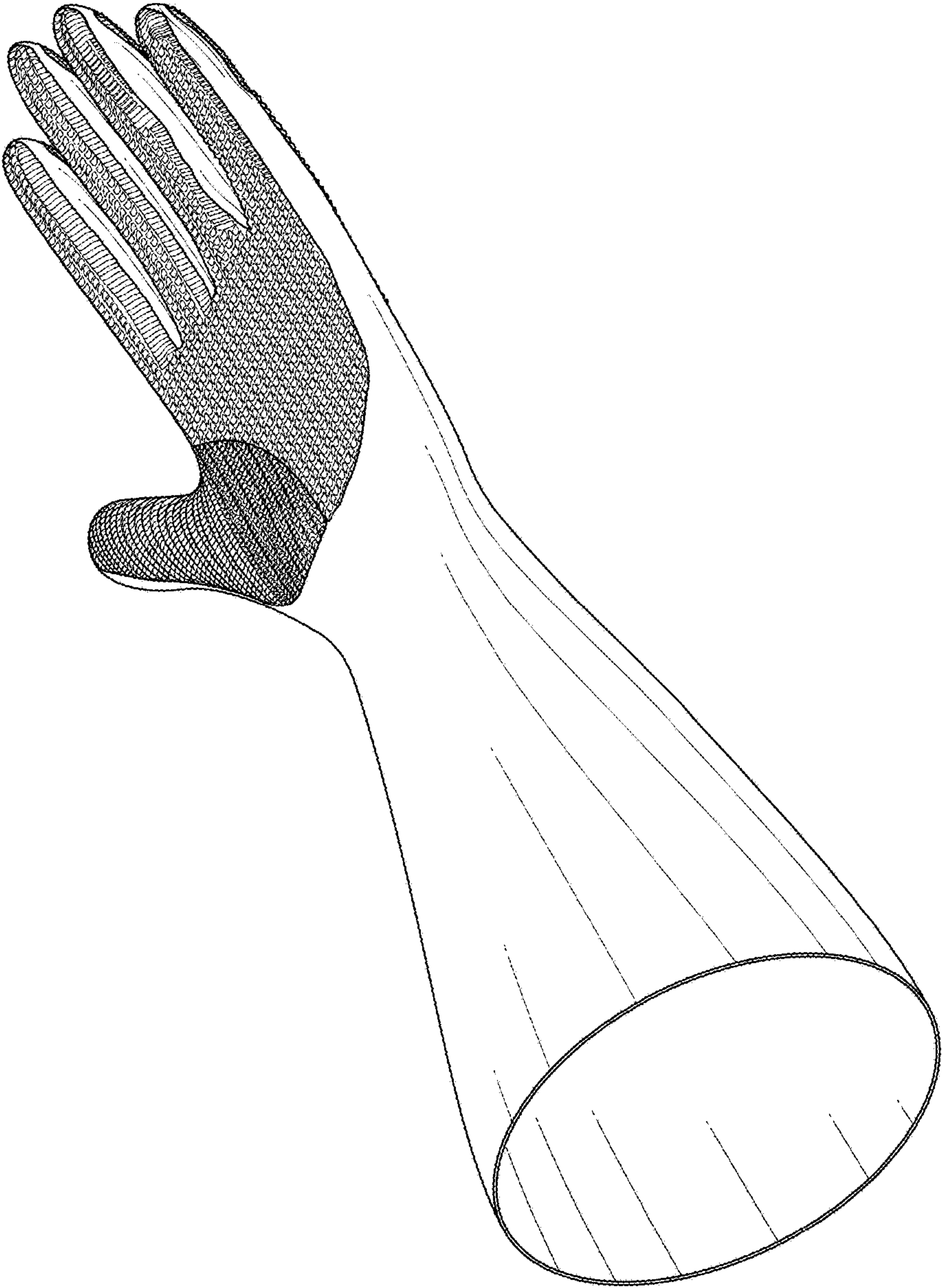

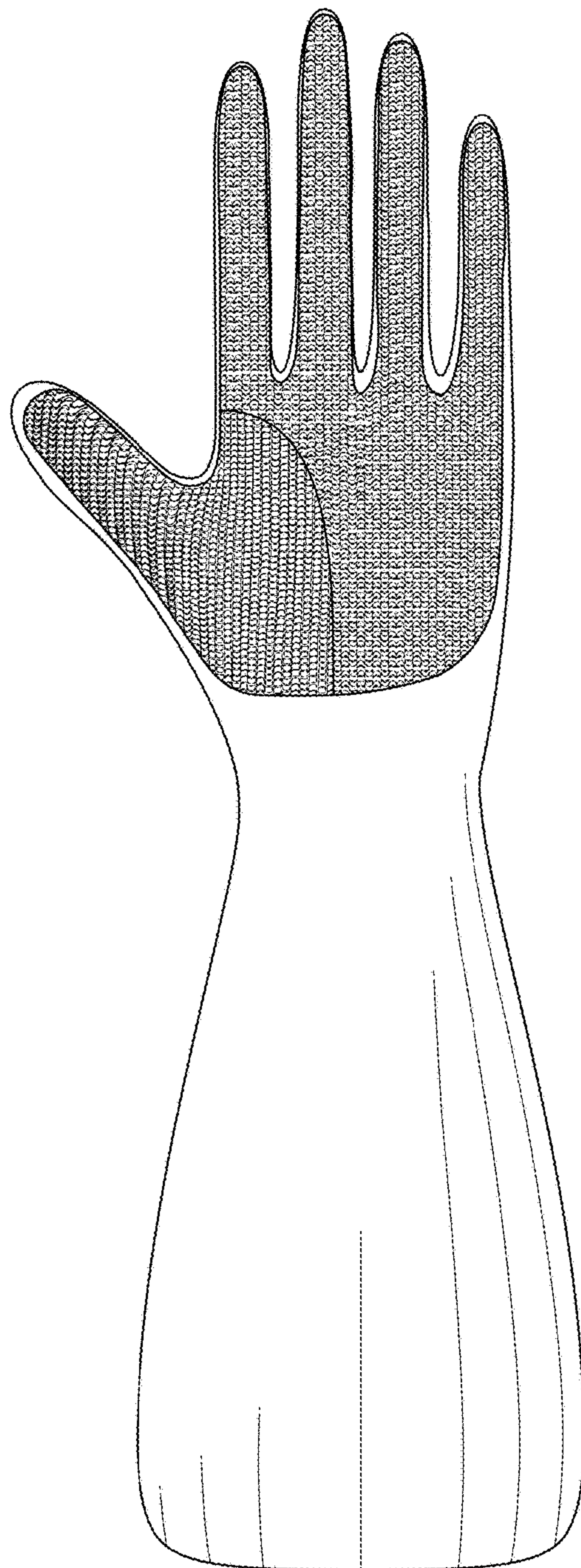

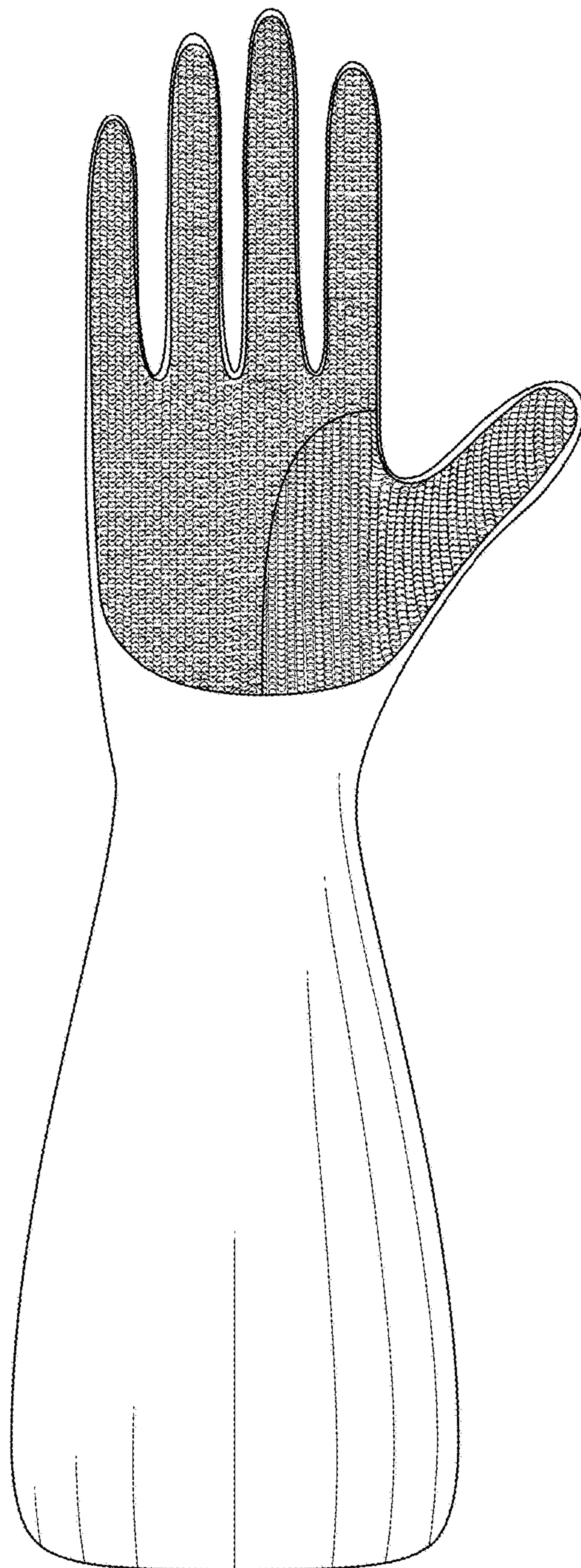

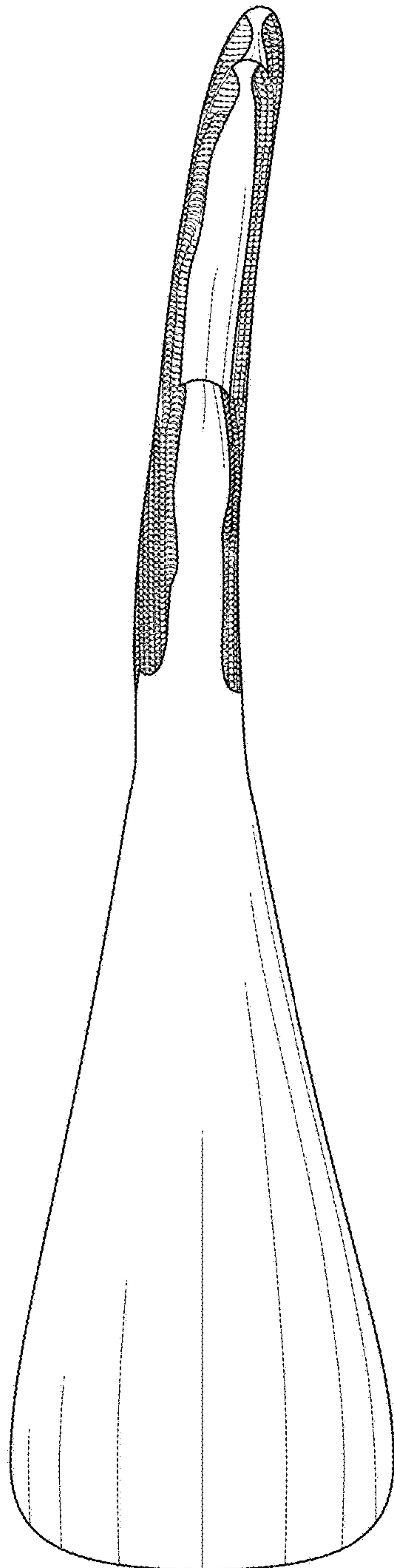

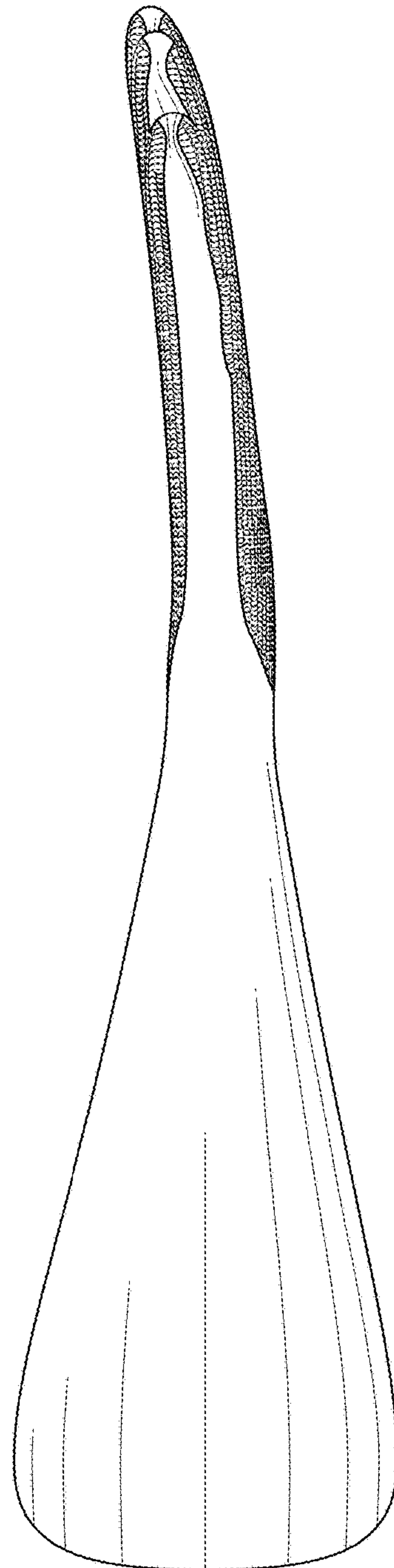

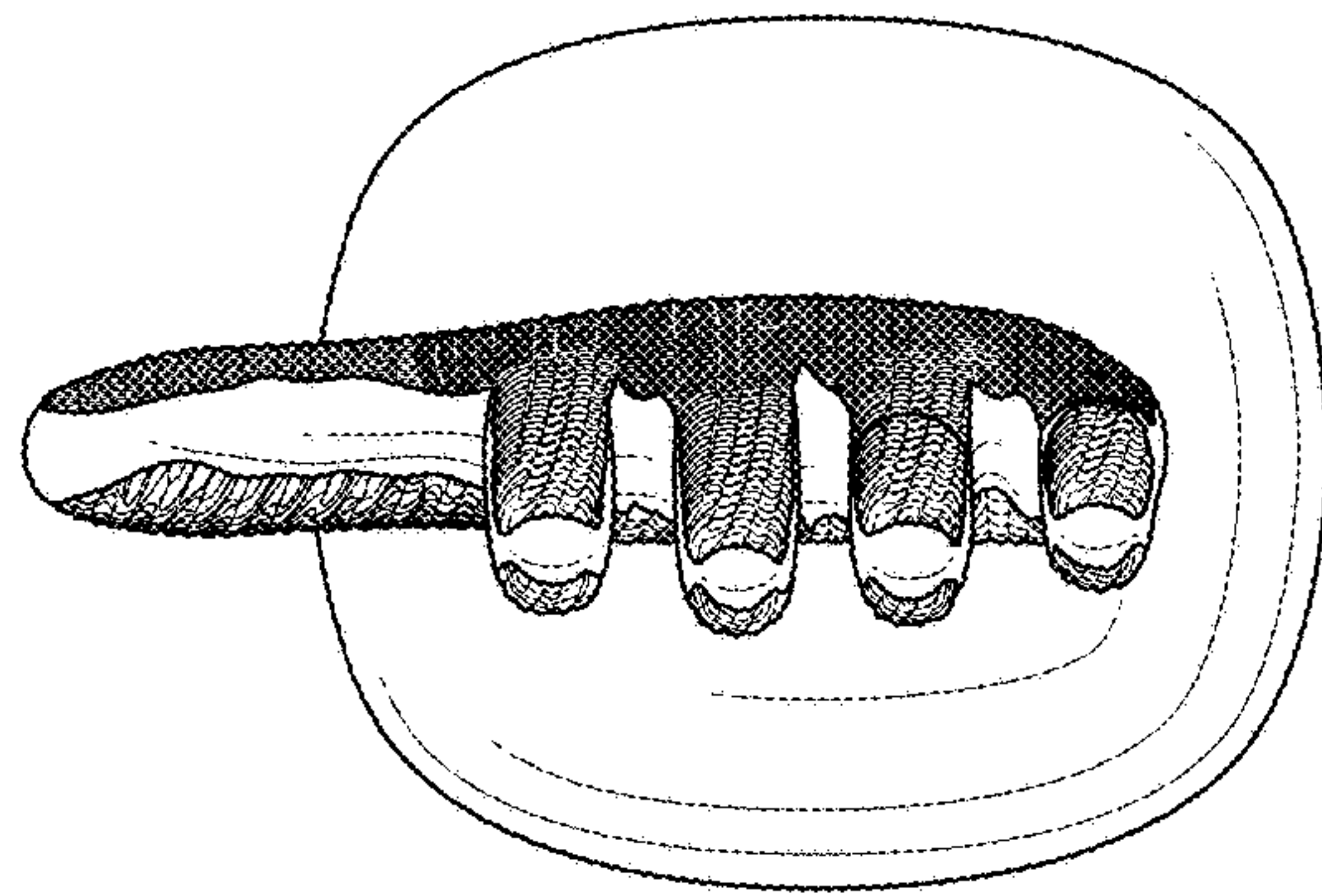

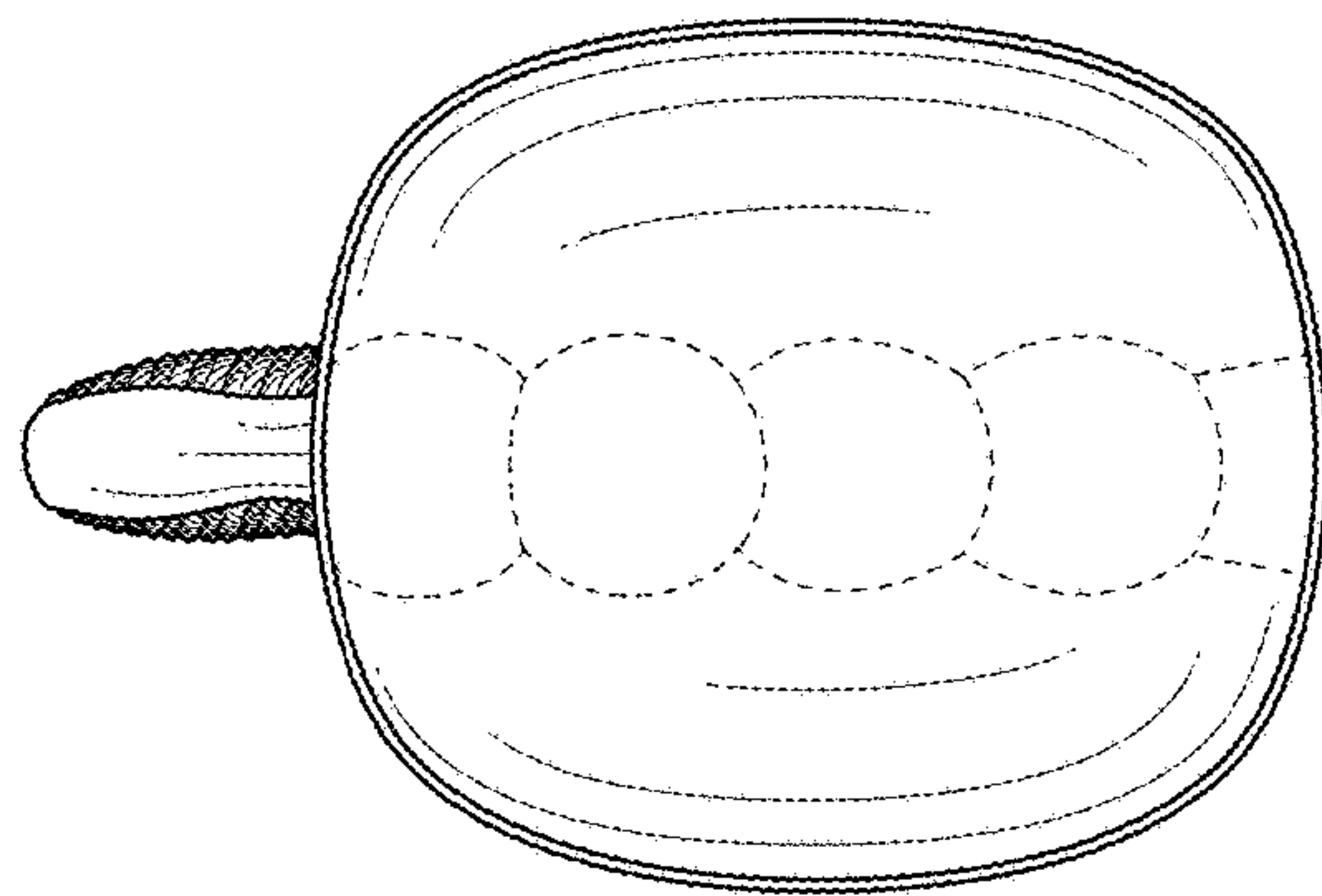
