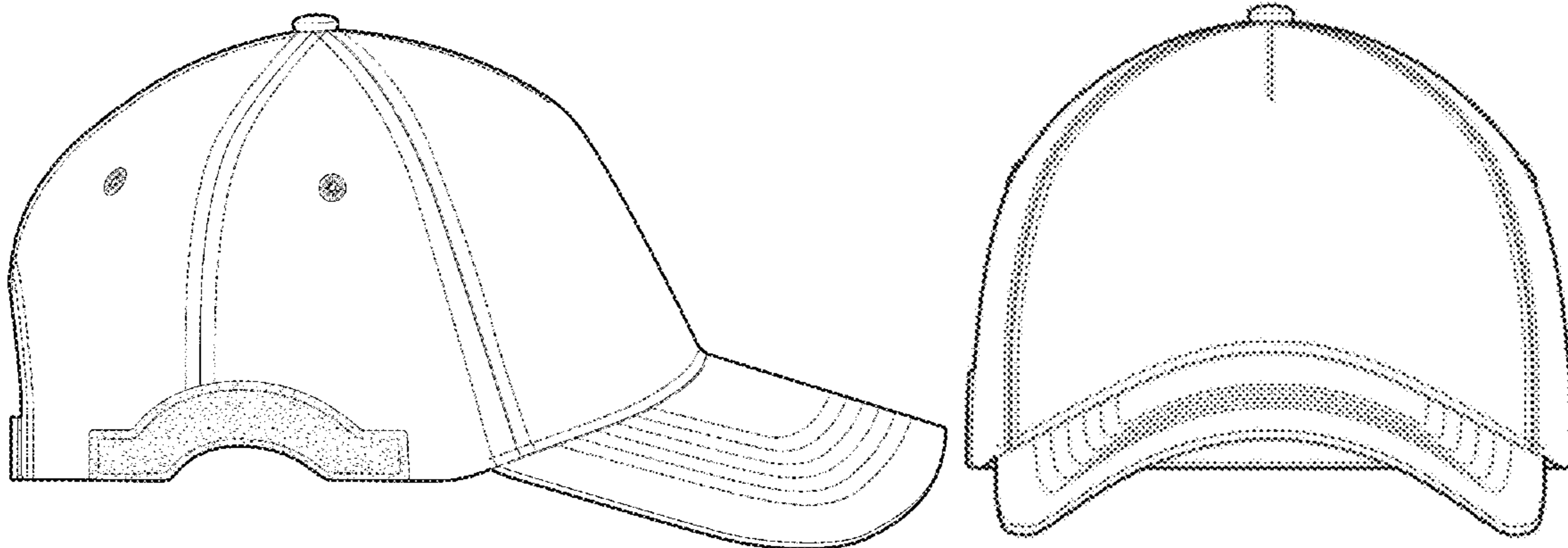
(57) **CLAIM**

I claim the ornamental design for the baseball cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective, front view of the baseball cap showing my new design;  
FIG. 2 is a right side elevation view thereof;  
FIG. 3 is a left side elevation view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a front elevation view thereof; and,

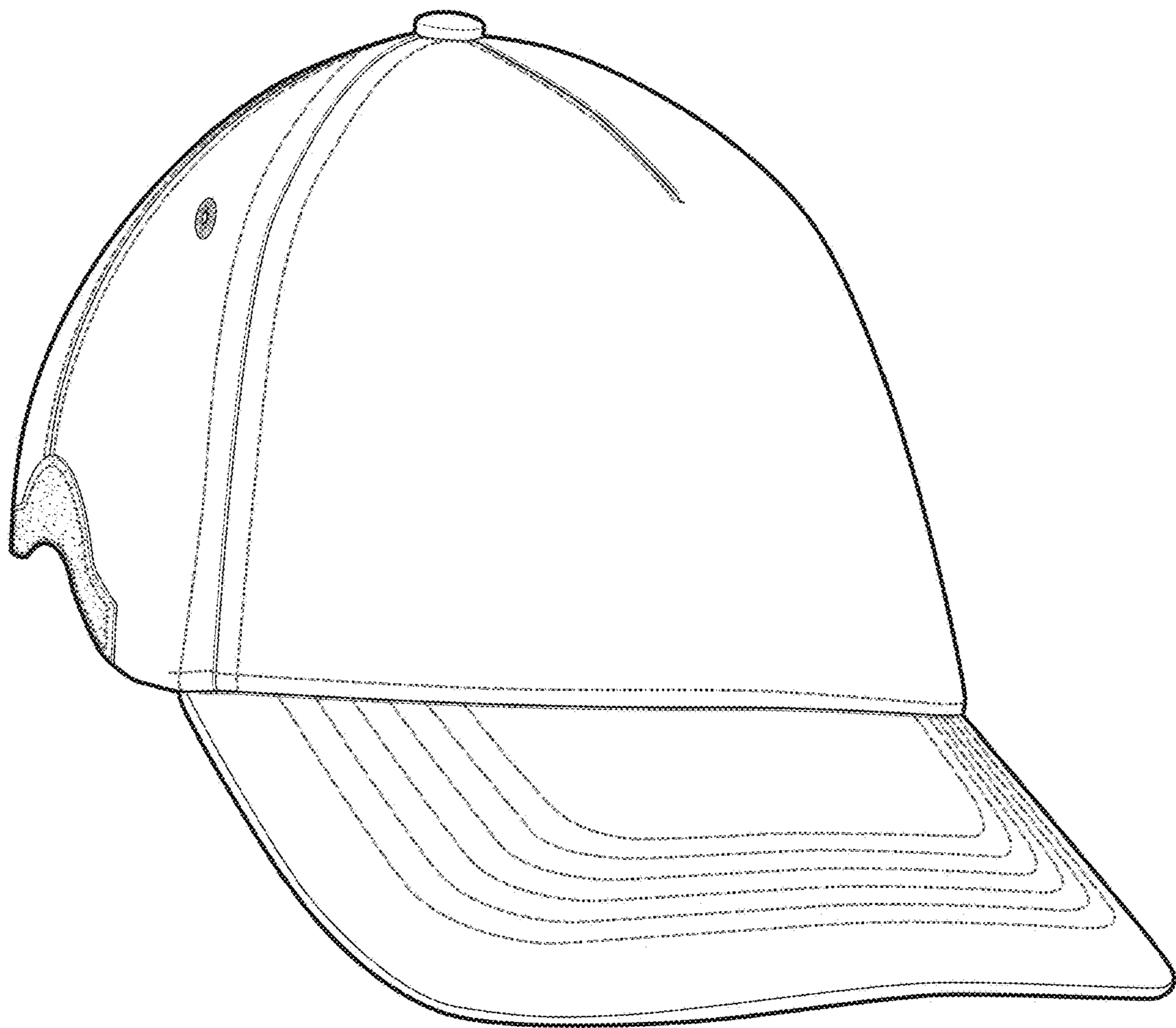

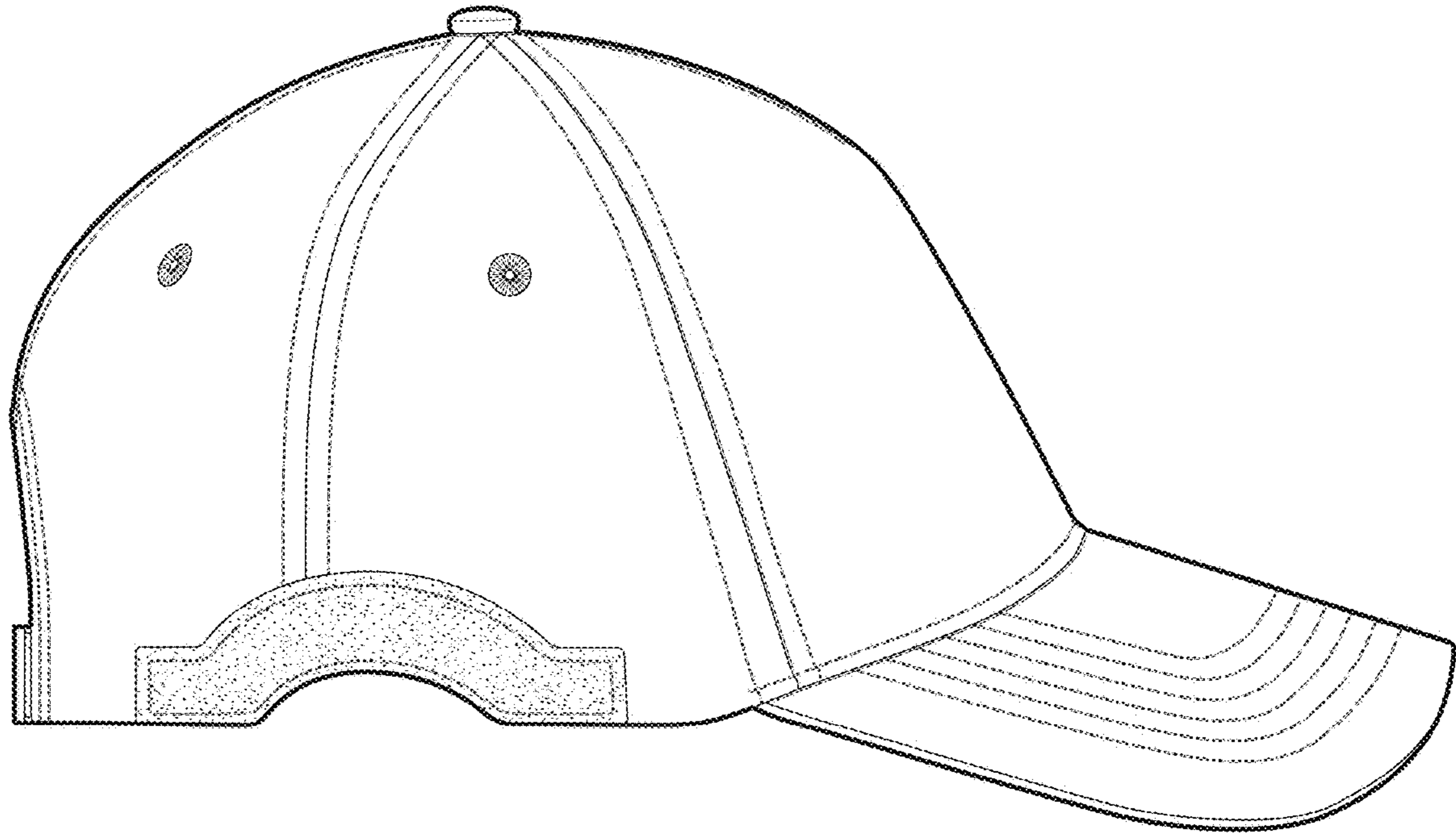

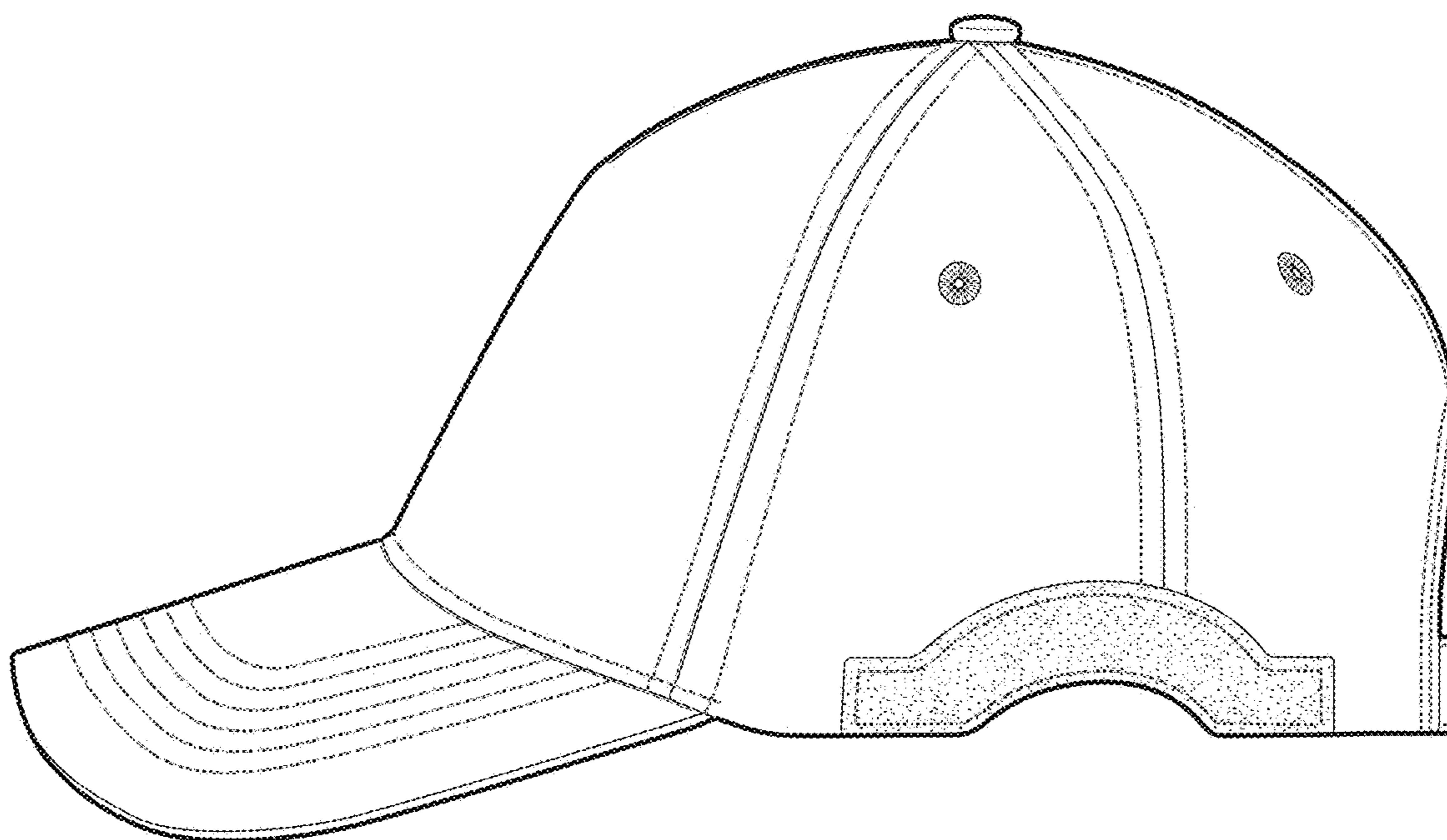

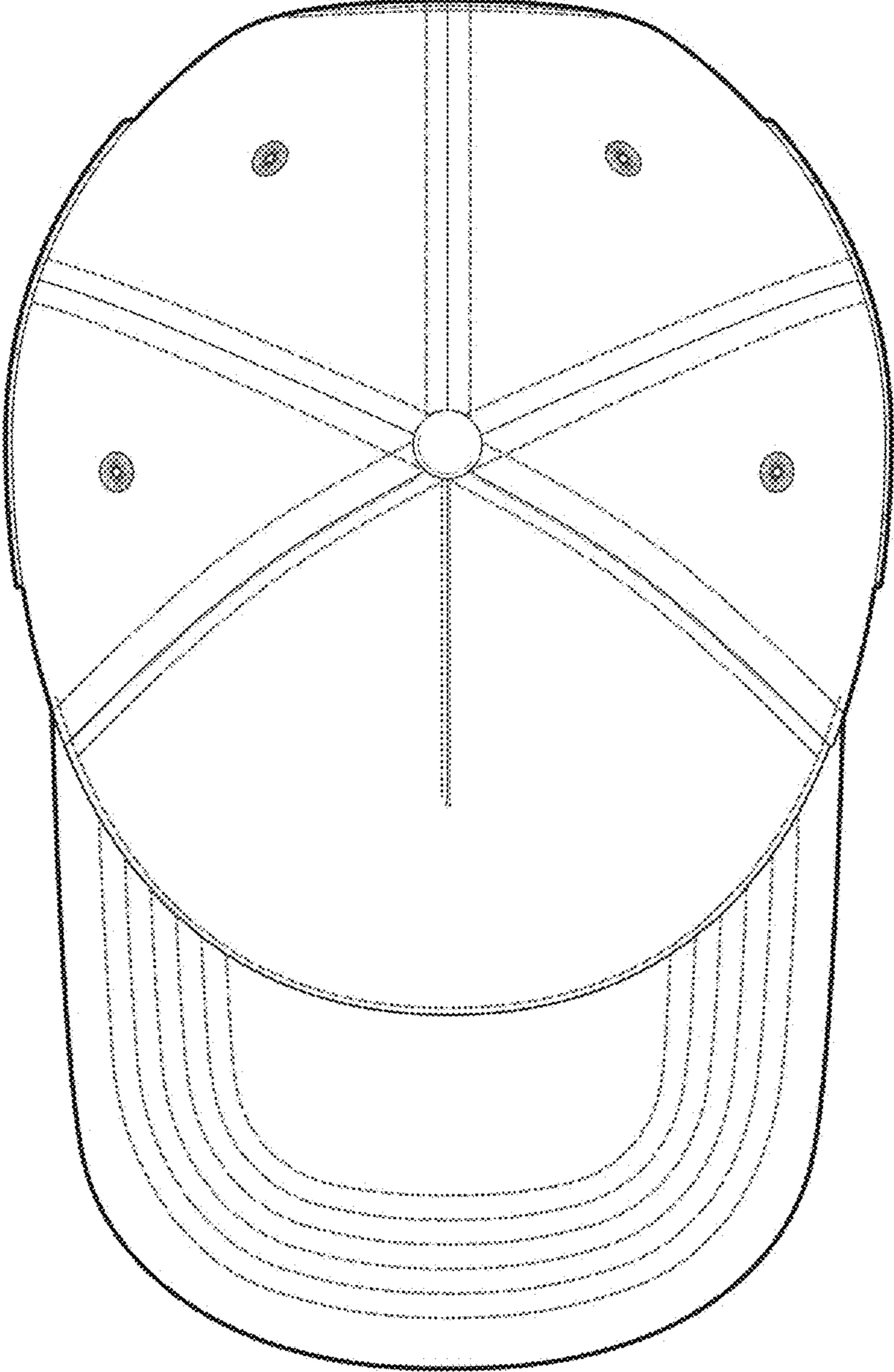

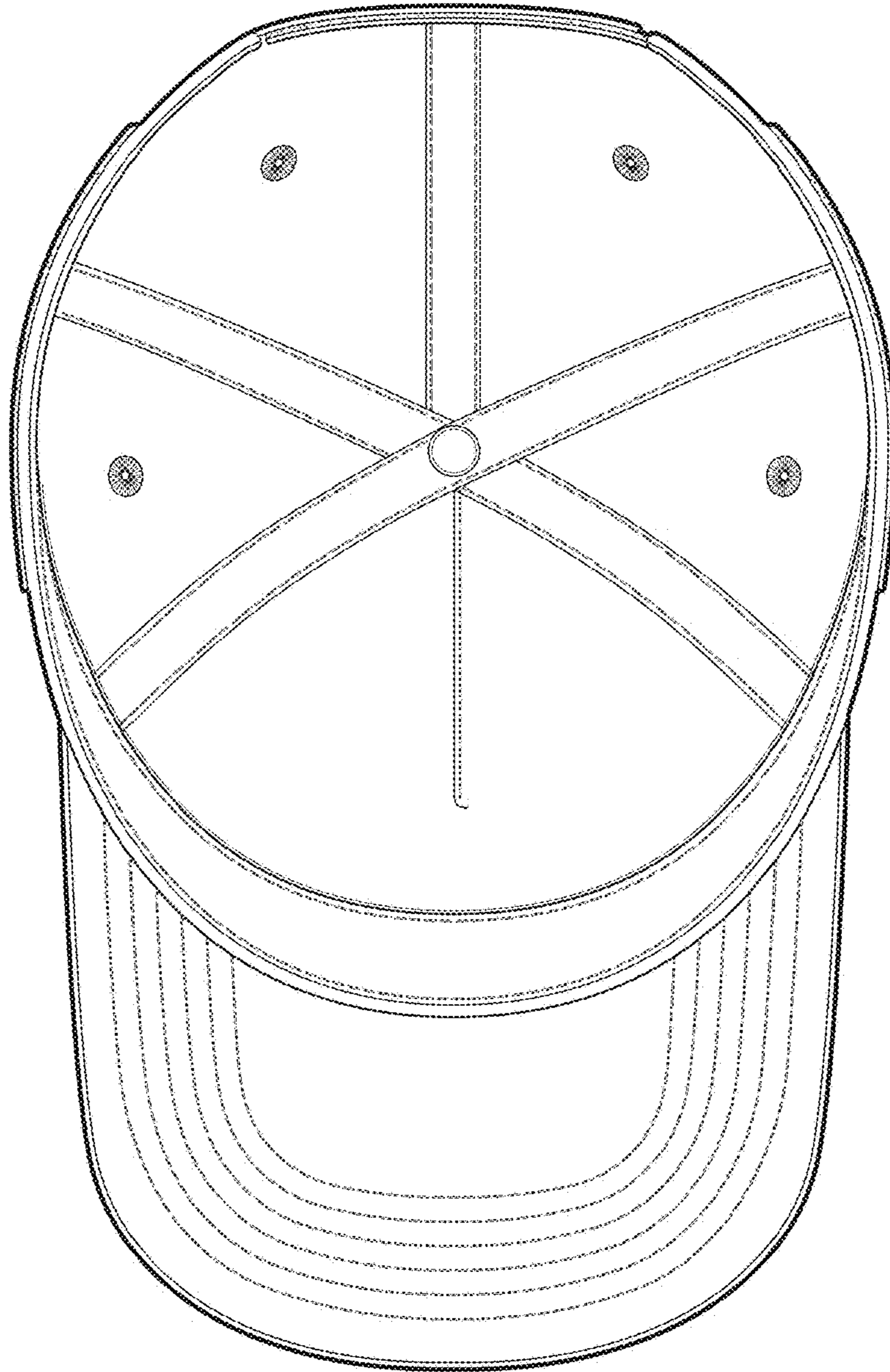

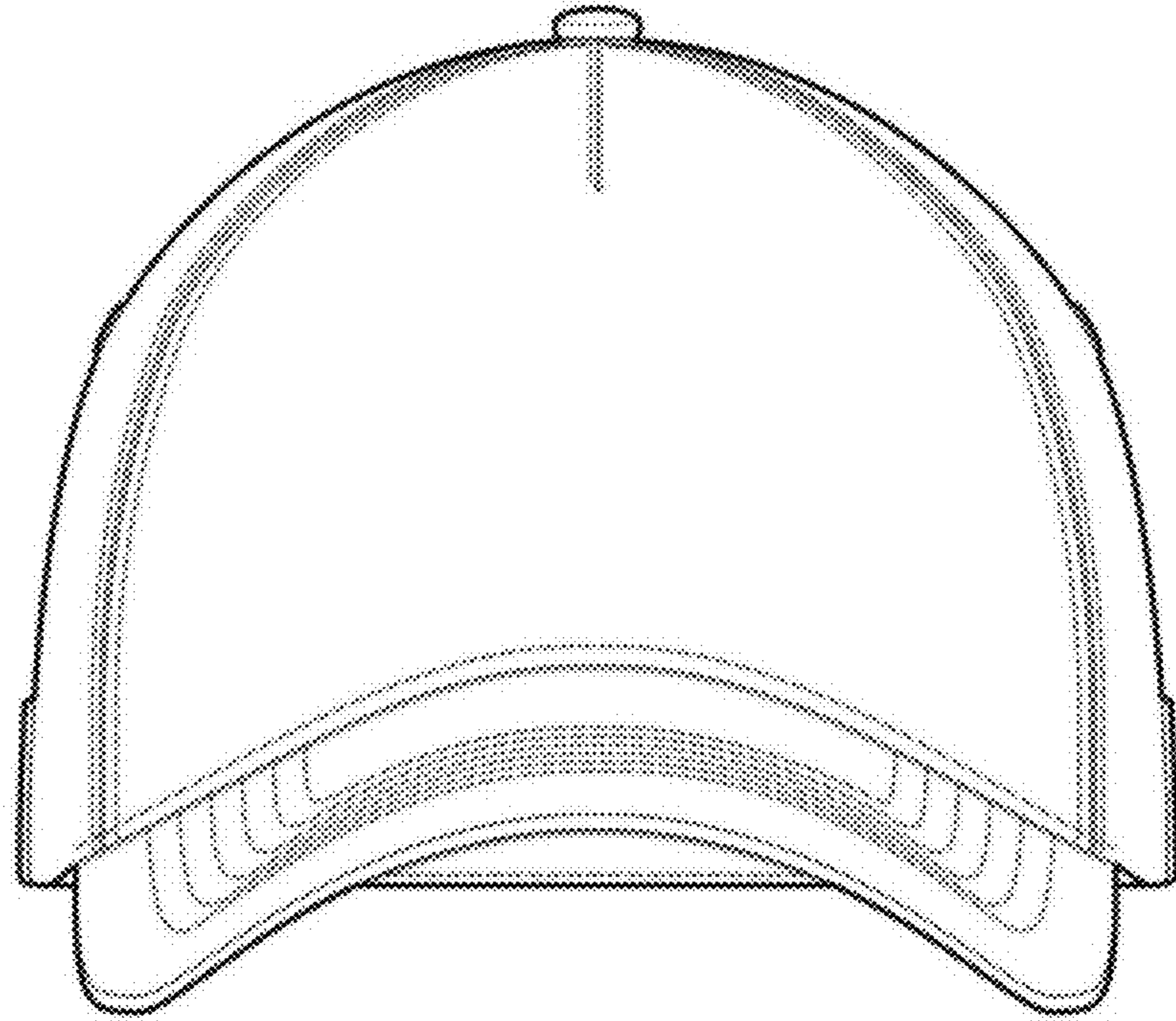

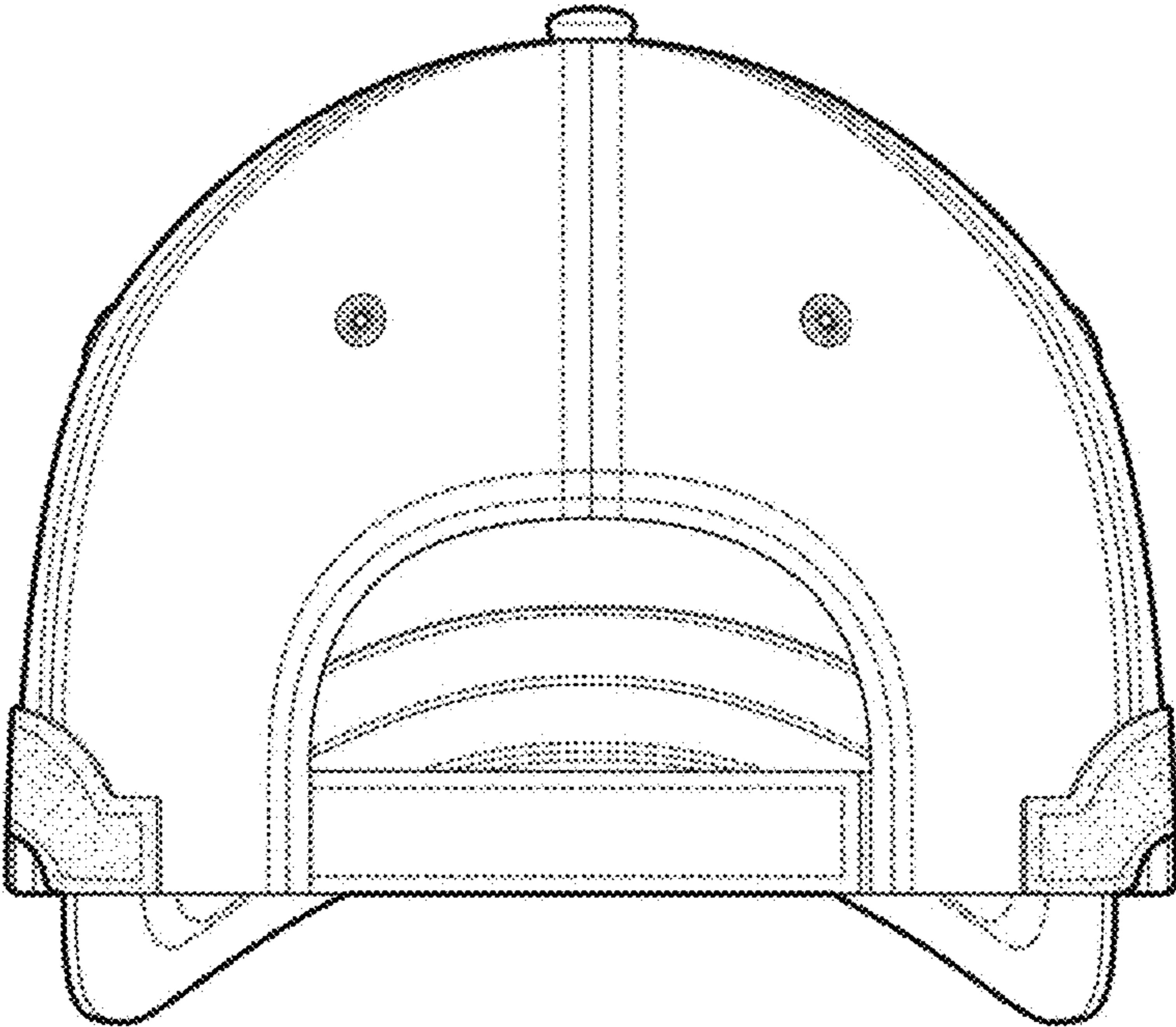
