DESCRIPTION

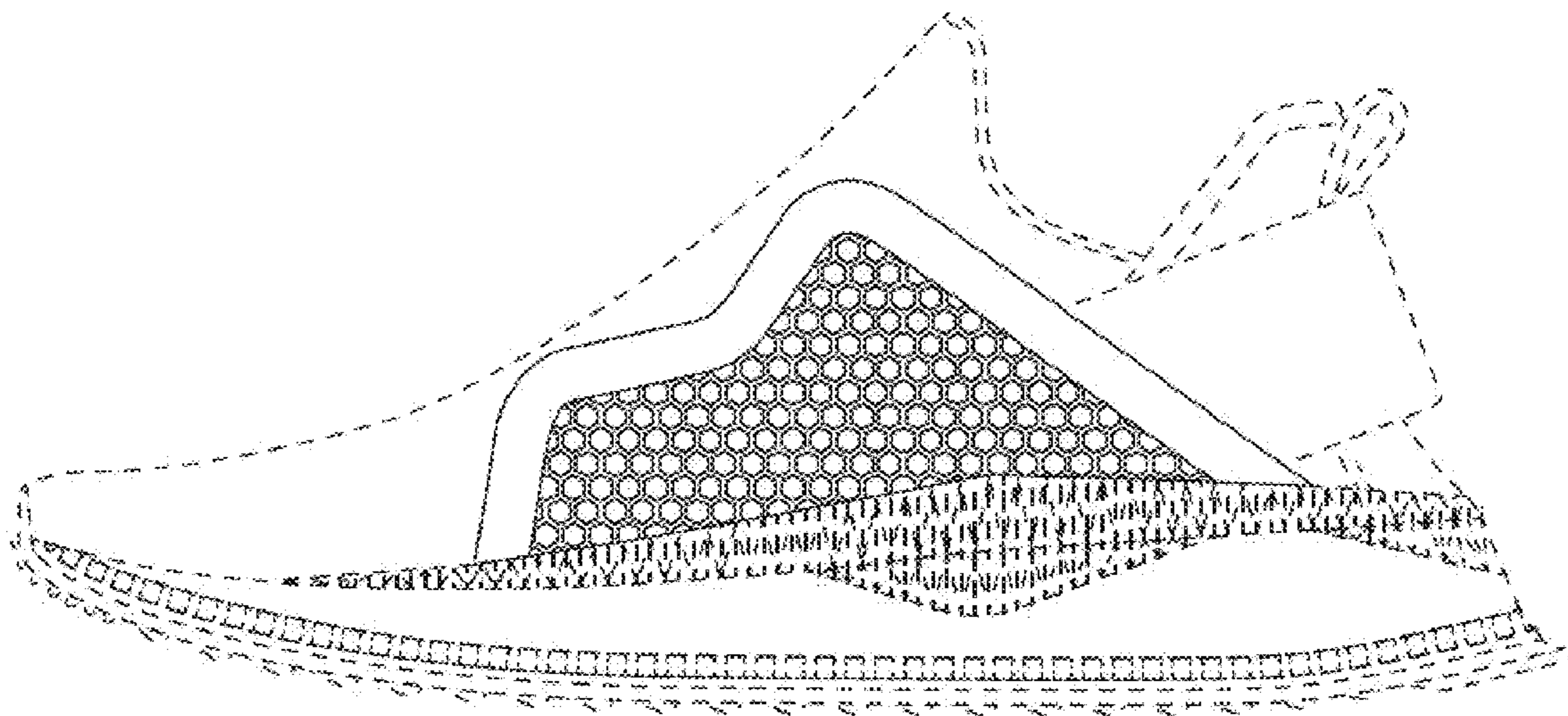
FIG. 1 is a top left front perspective view of the shoe upper showing my new design;

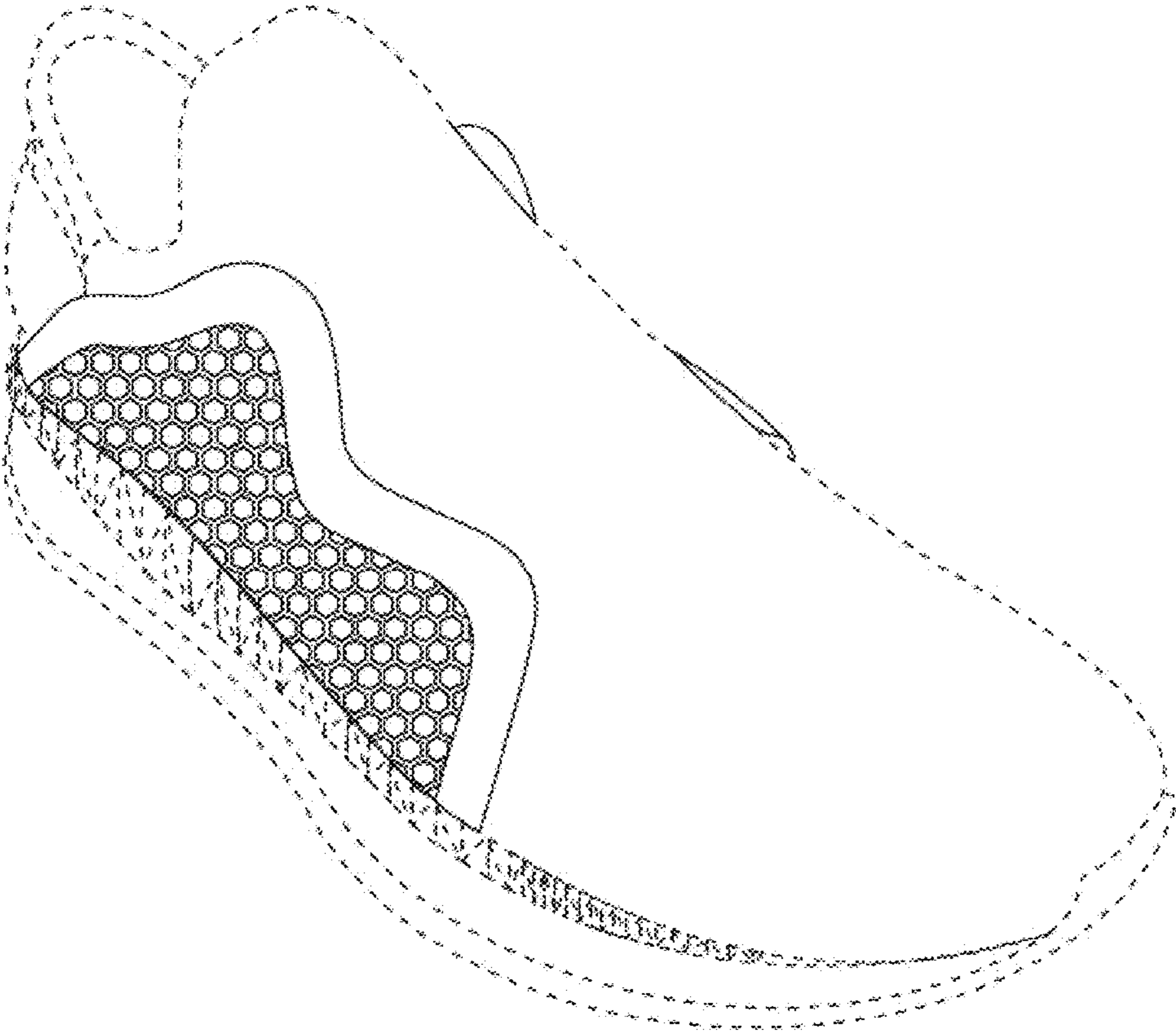

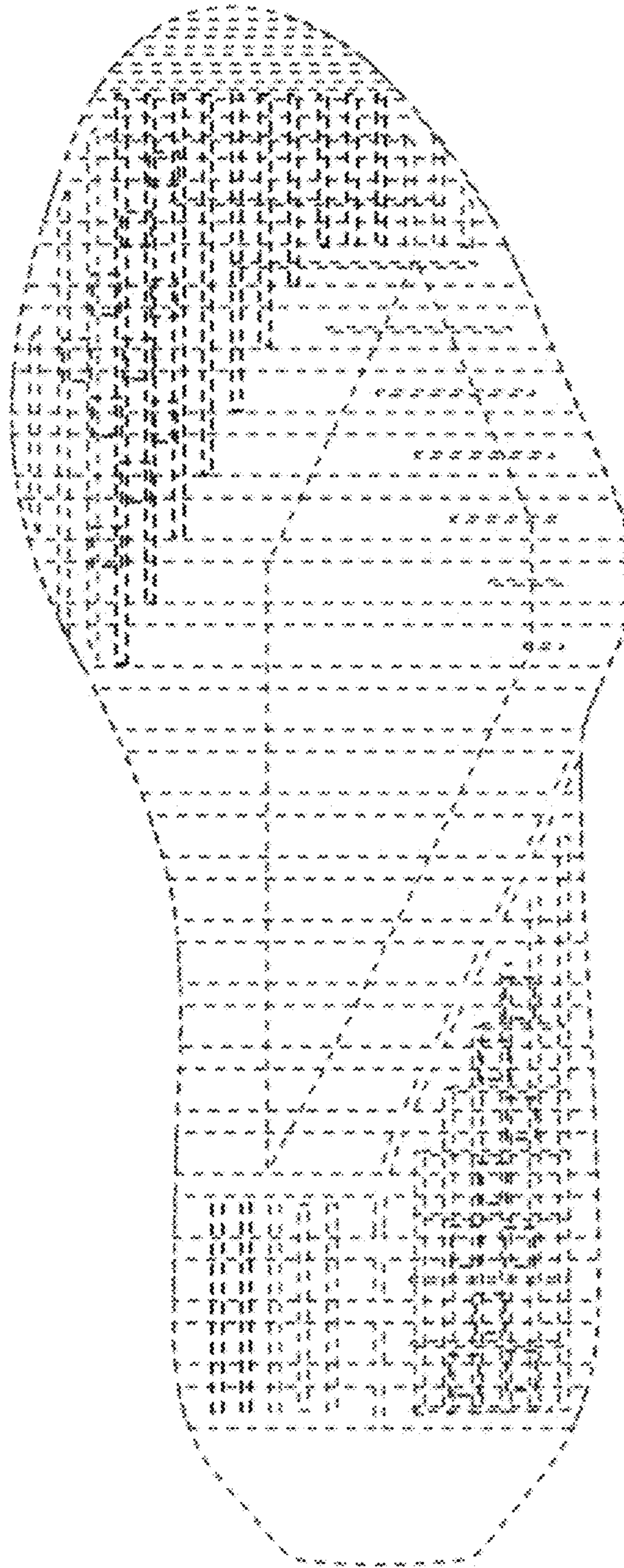

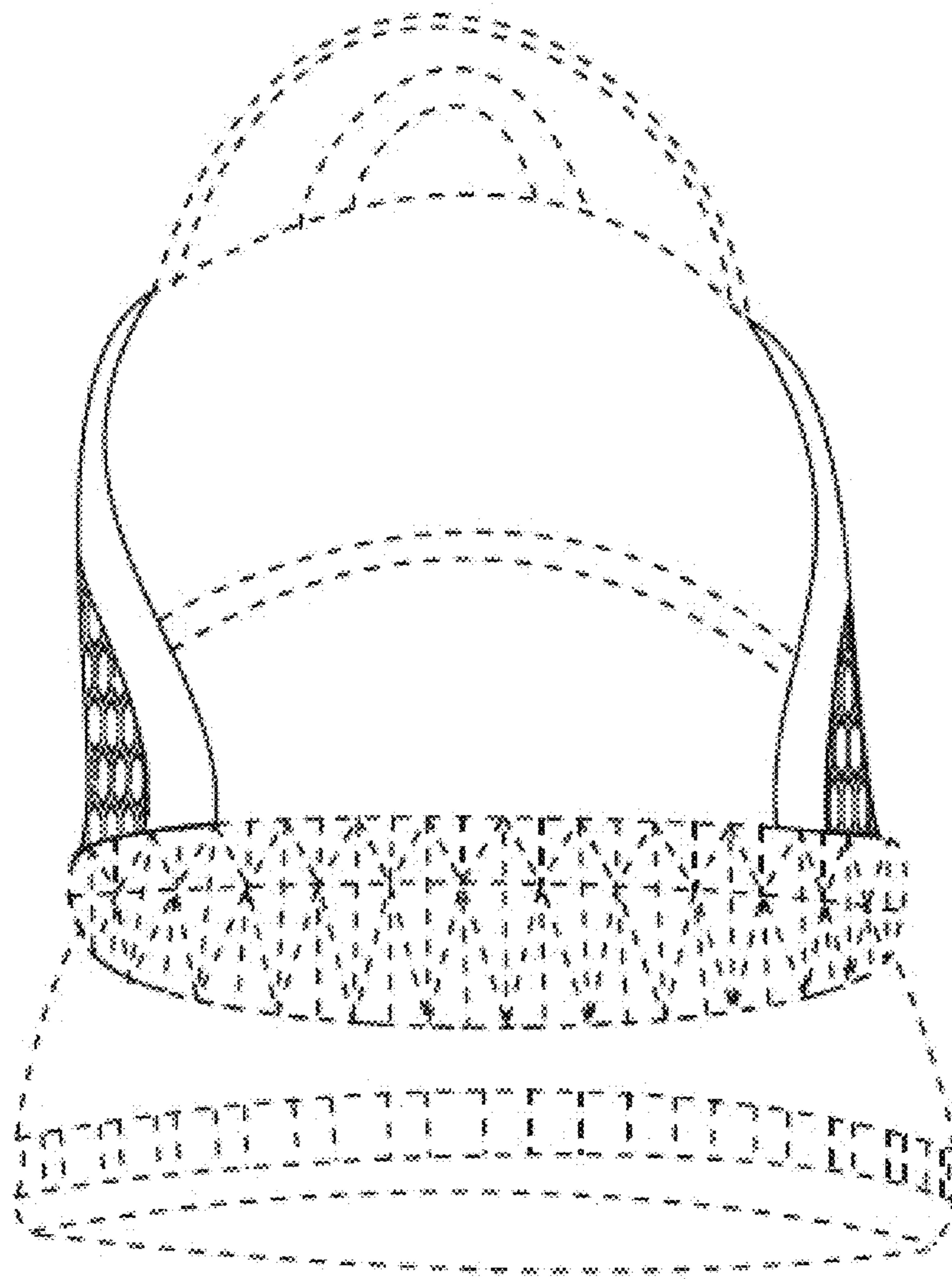

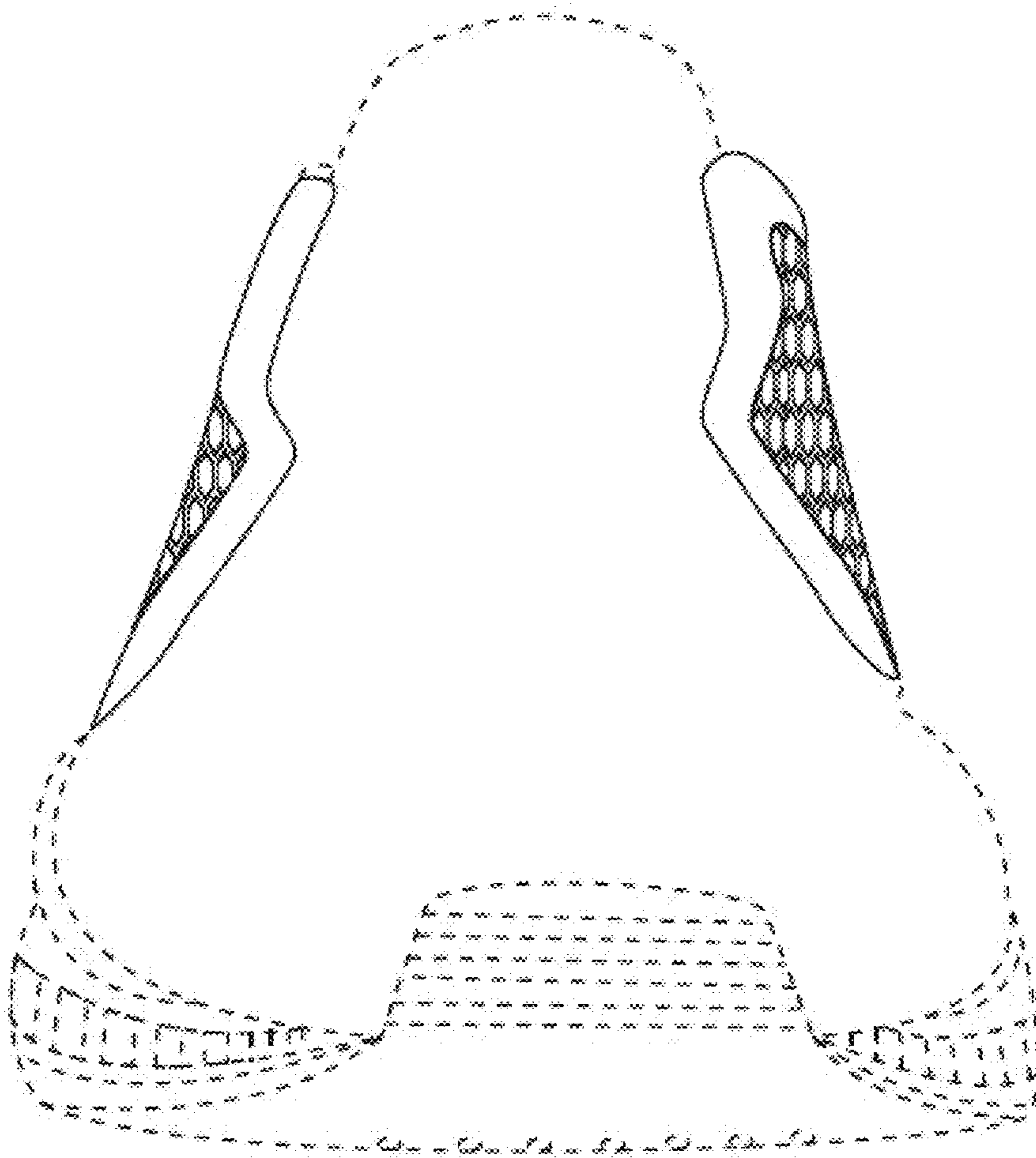

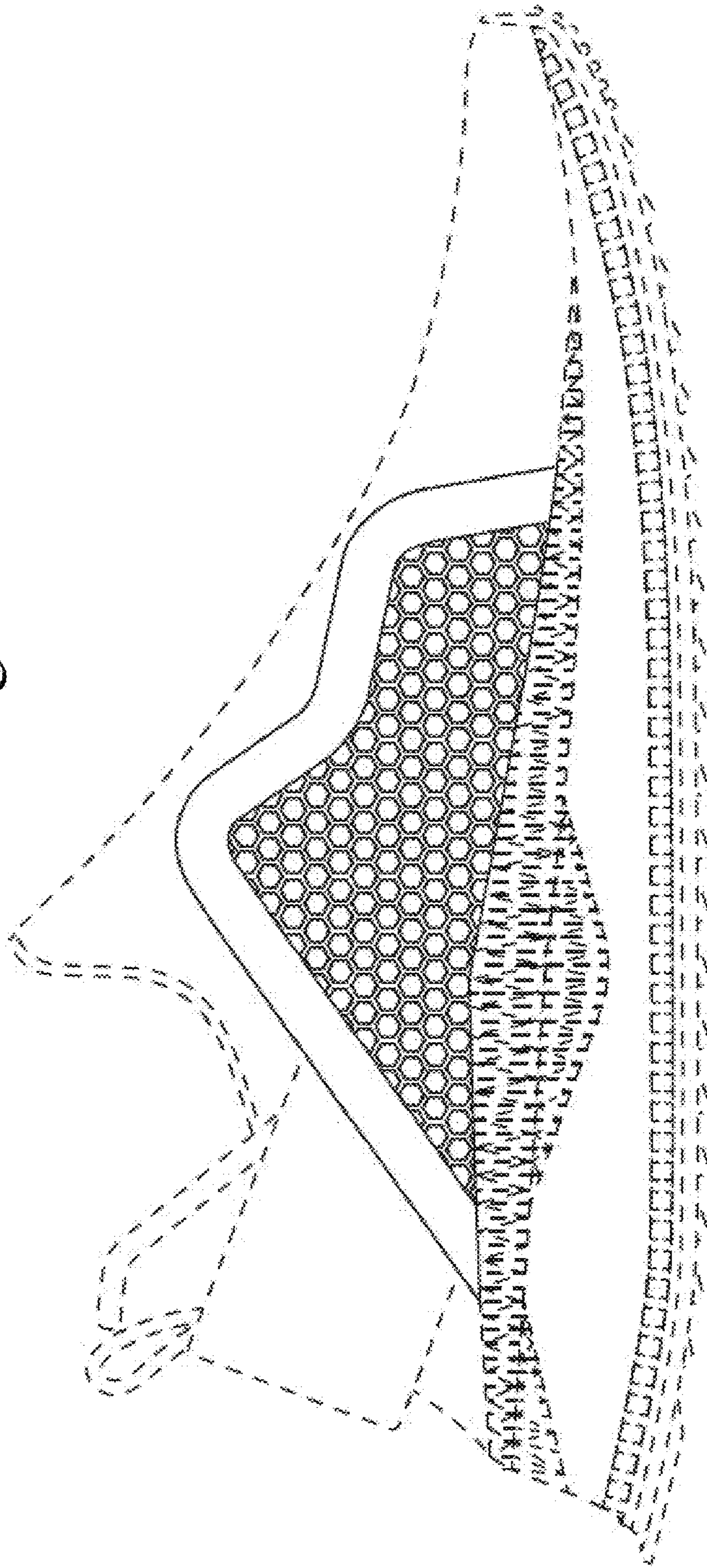
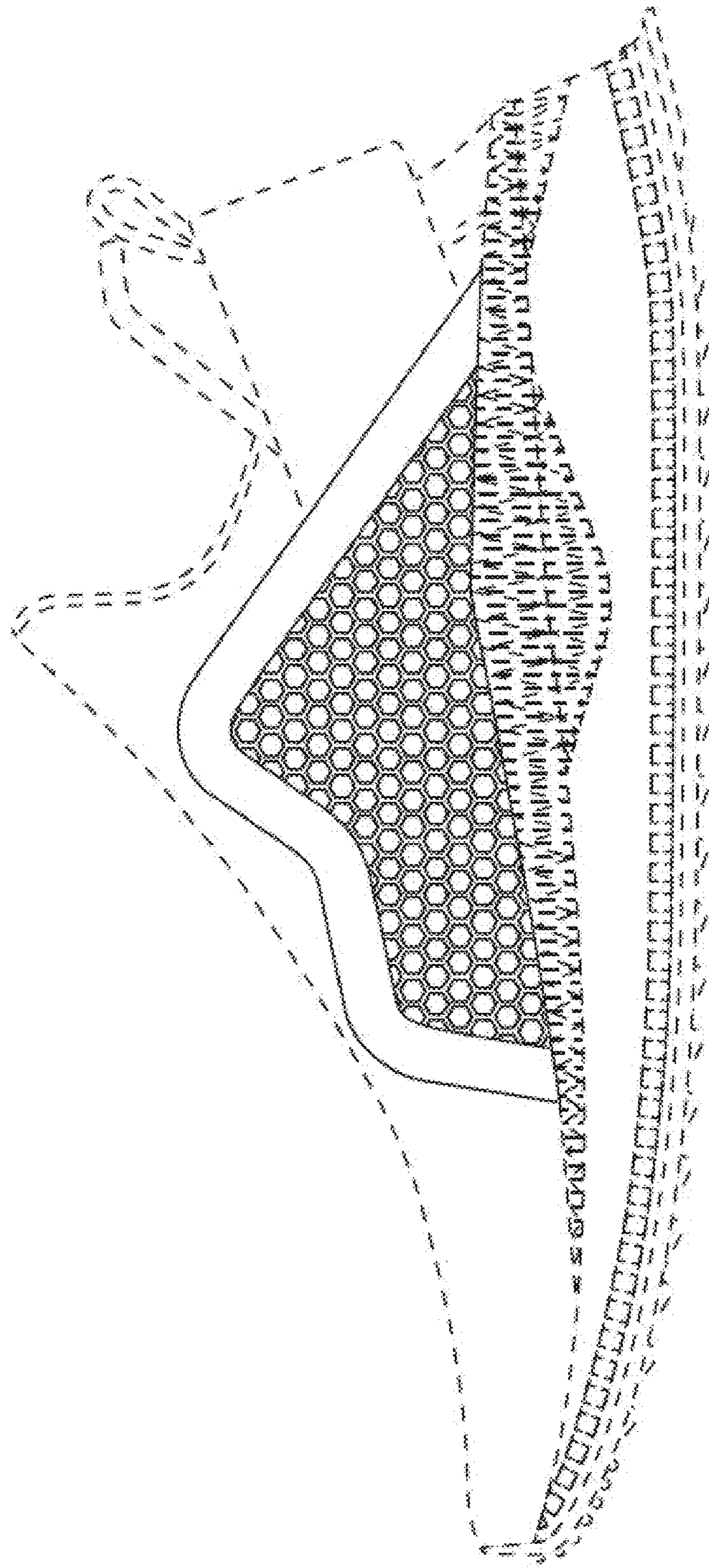

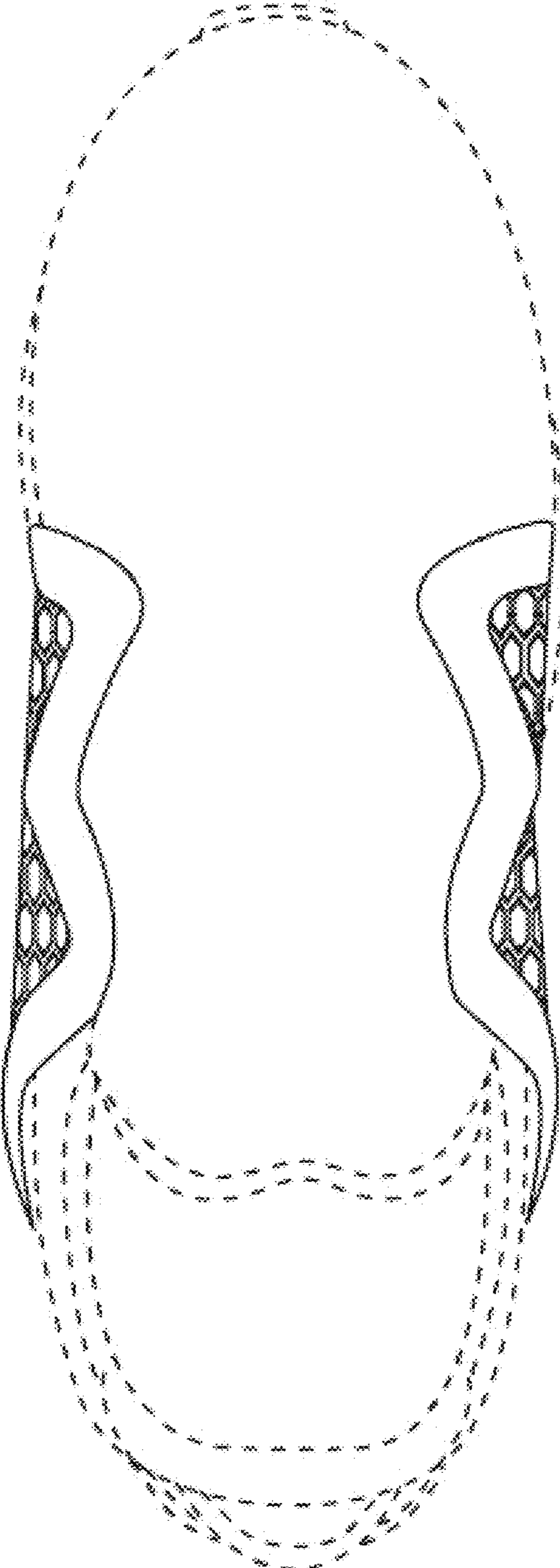
