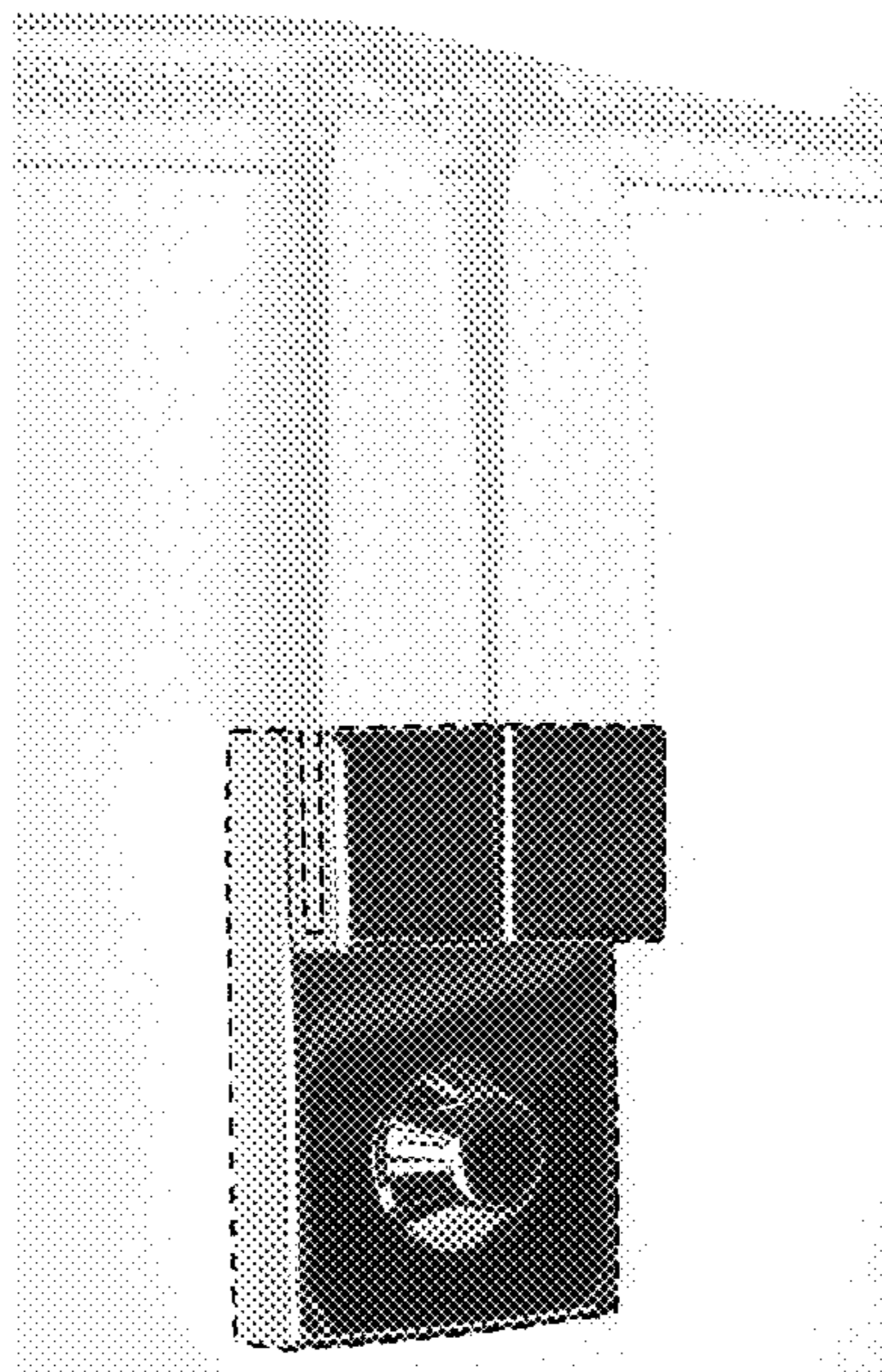
(57) **CLAIM**

The ornamental design for a closure applied to handbags, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a closure applied to handbags showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a front perspective view thereof shown in a different position; and,
FIG. 4 is a front view thereof.
The broken lines illustrate boundaries which form no part of the claimed design.
The faded portions outside the broken lines illustrate structure or features which form no part of the claimed design.
The portions within the broken lines form part of the claimed design.
The drawings include shadows and reflections which indicate contour, not surface ornamentation.

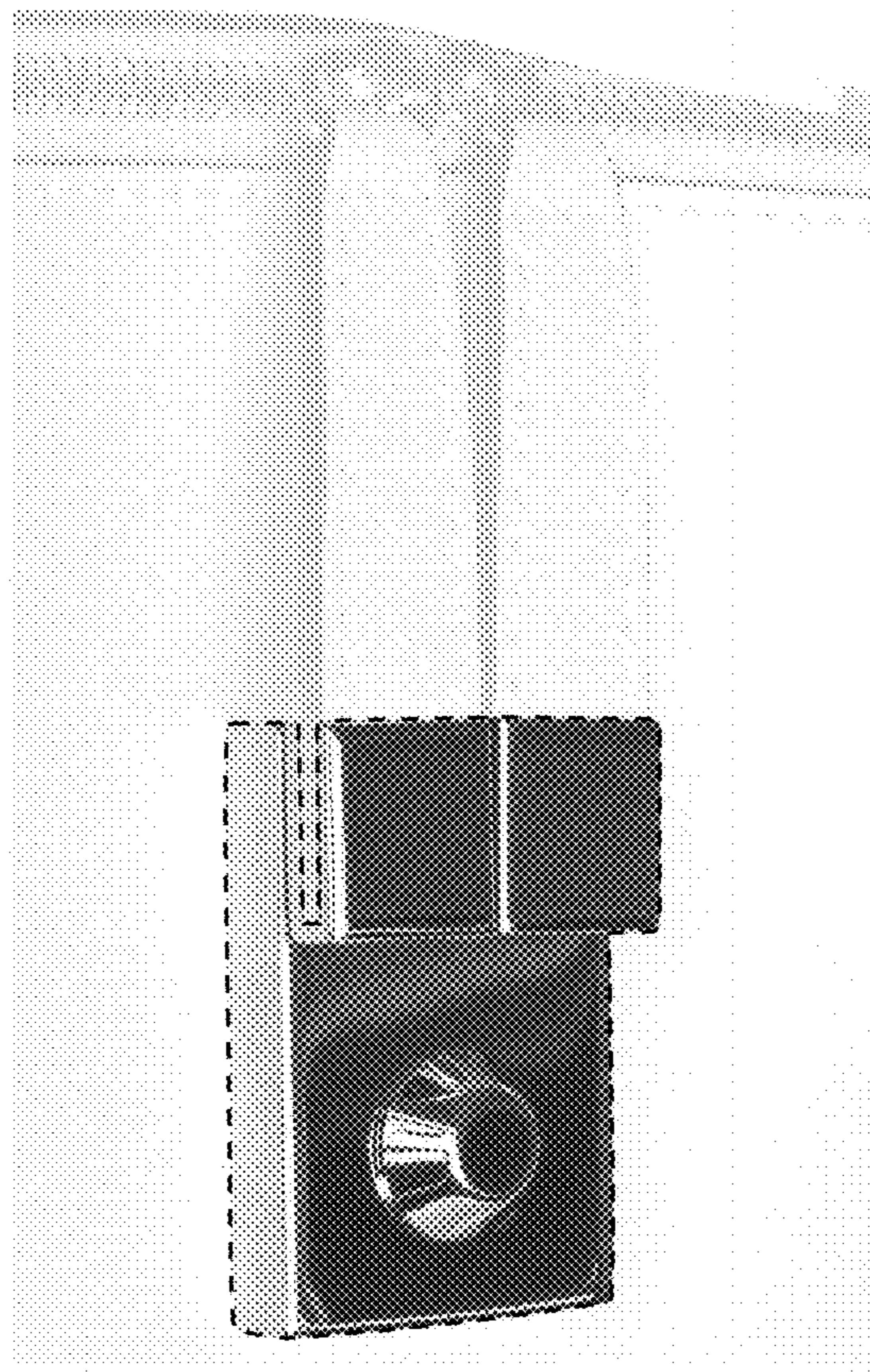

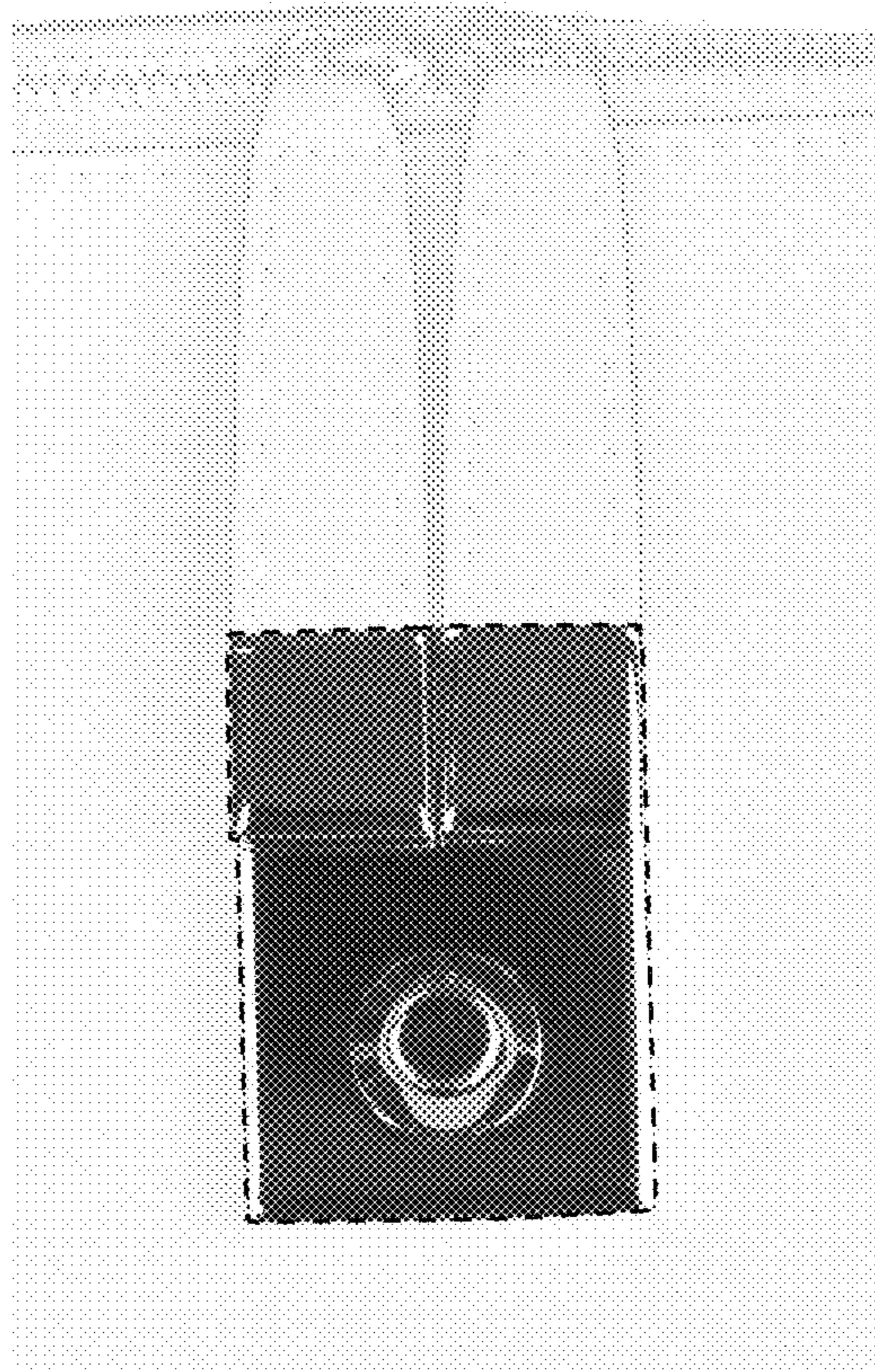

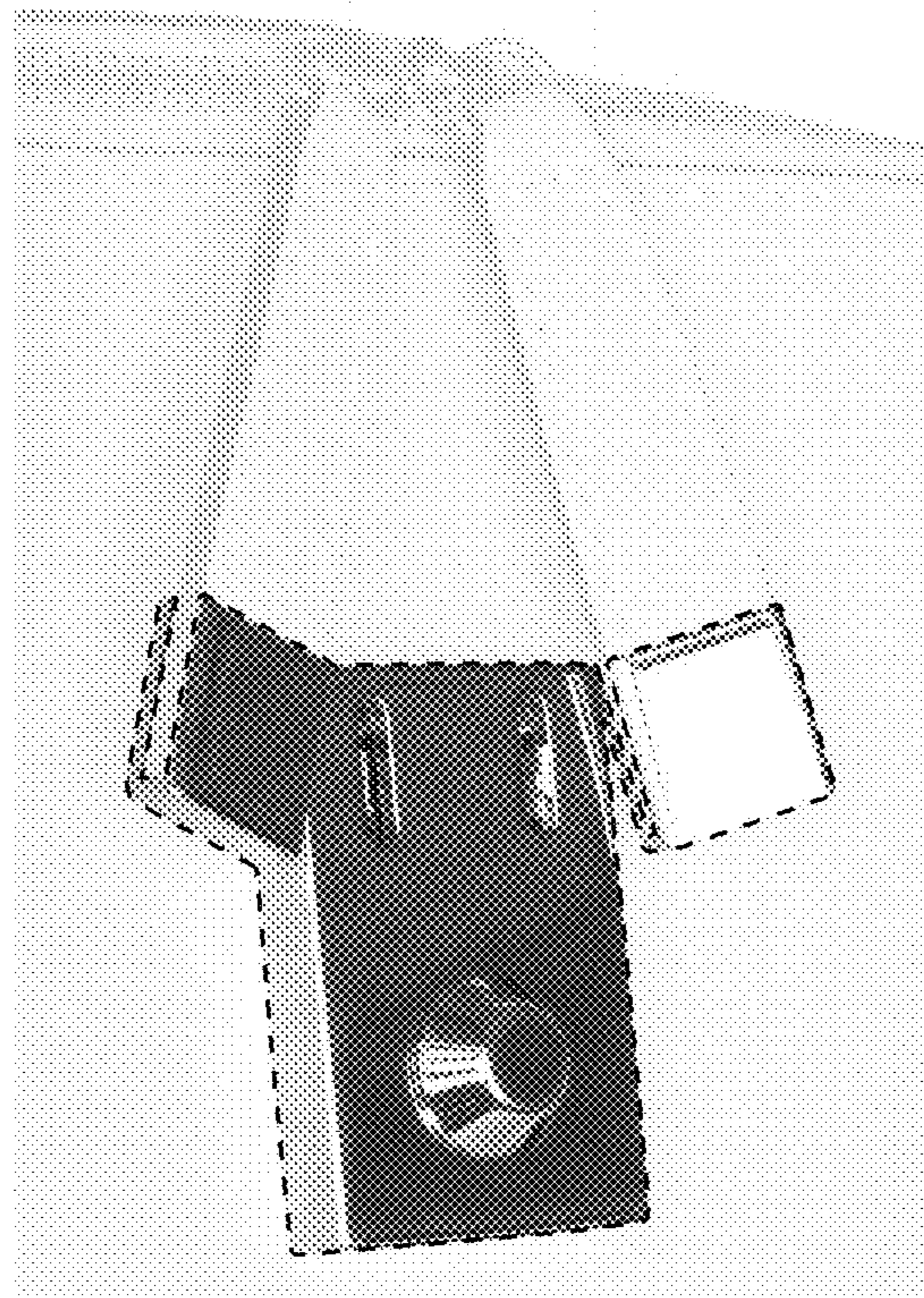

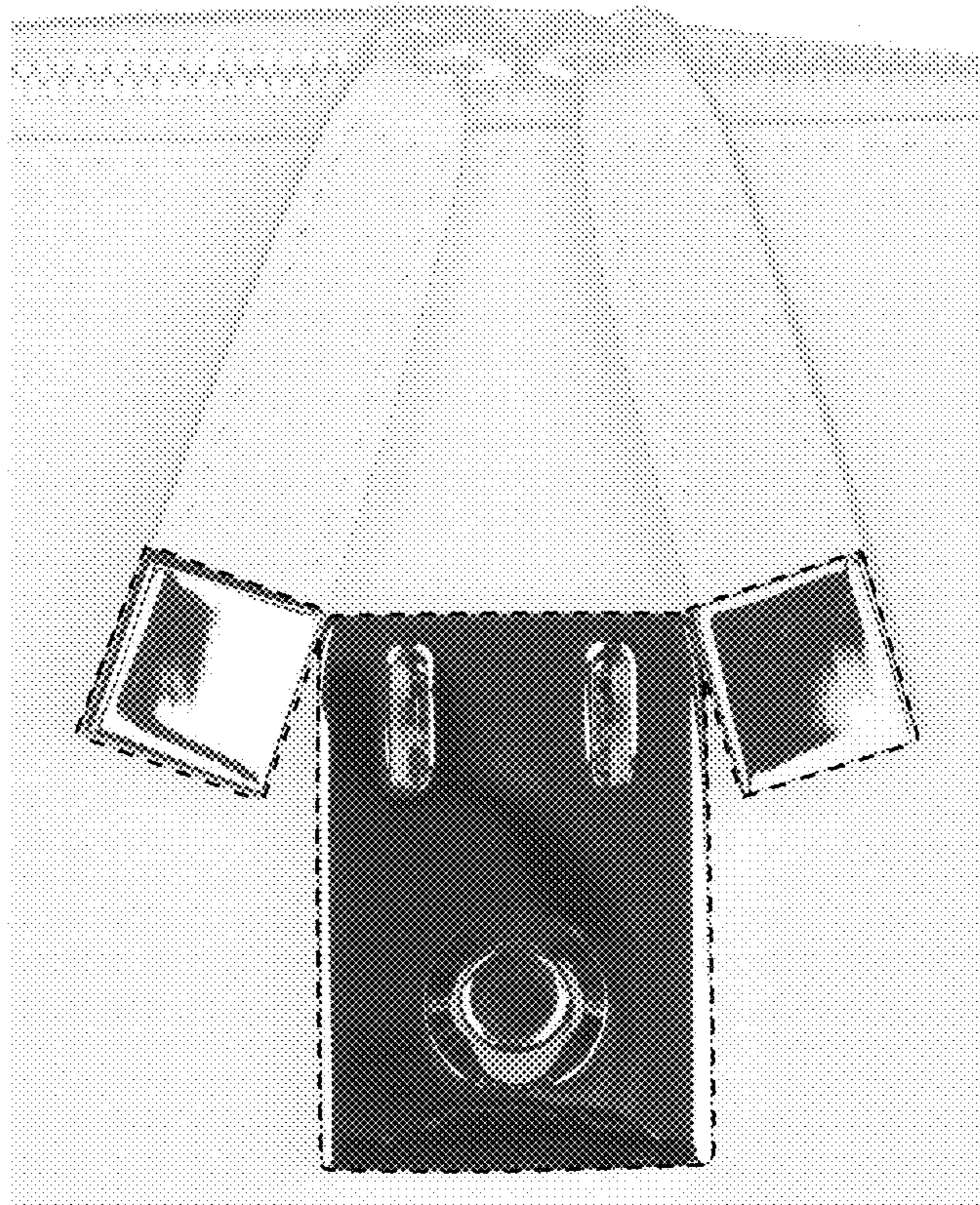
