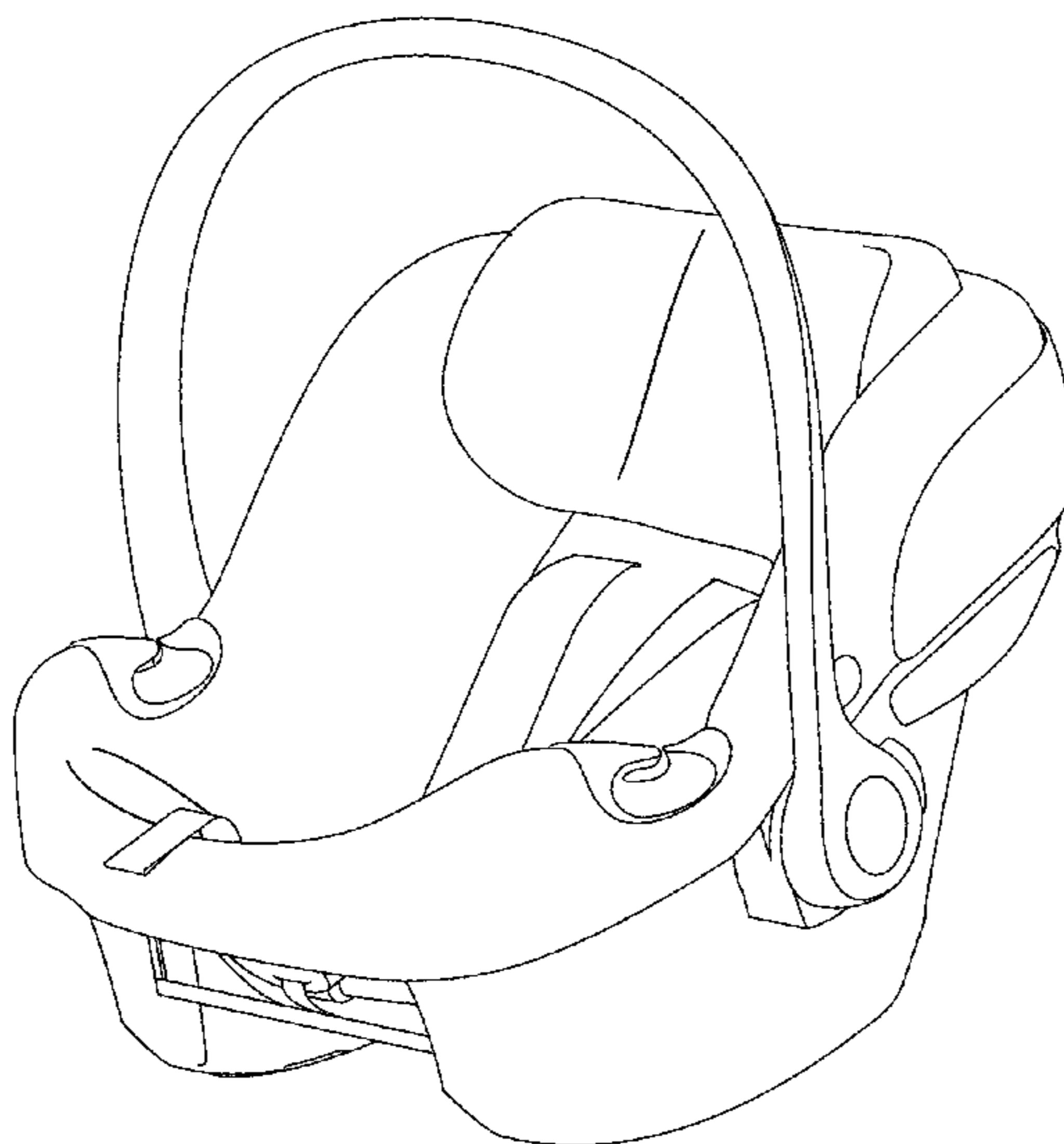
The ornamental design for a child safety seat for motor cars, as shown and described.

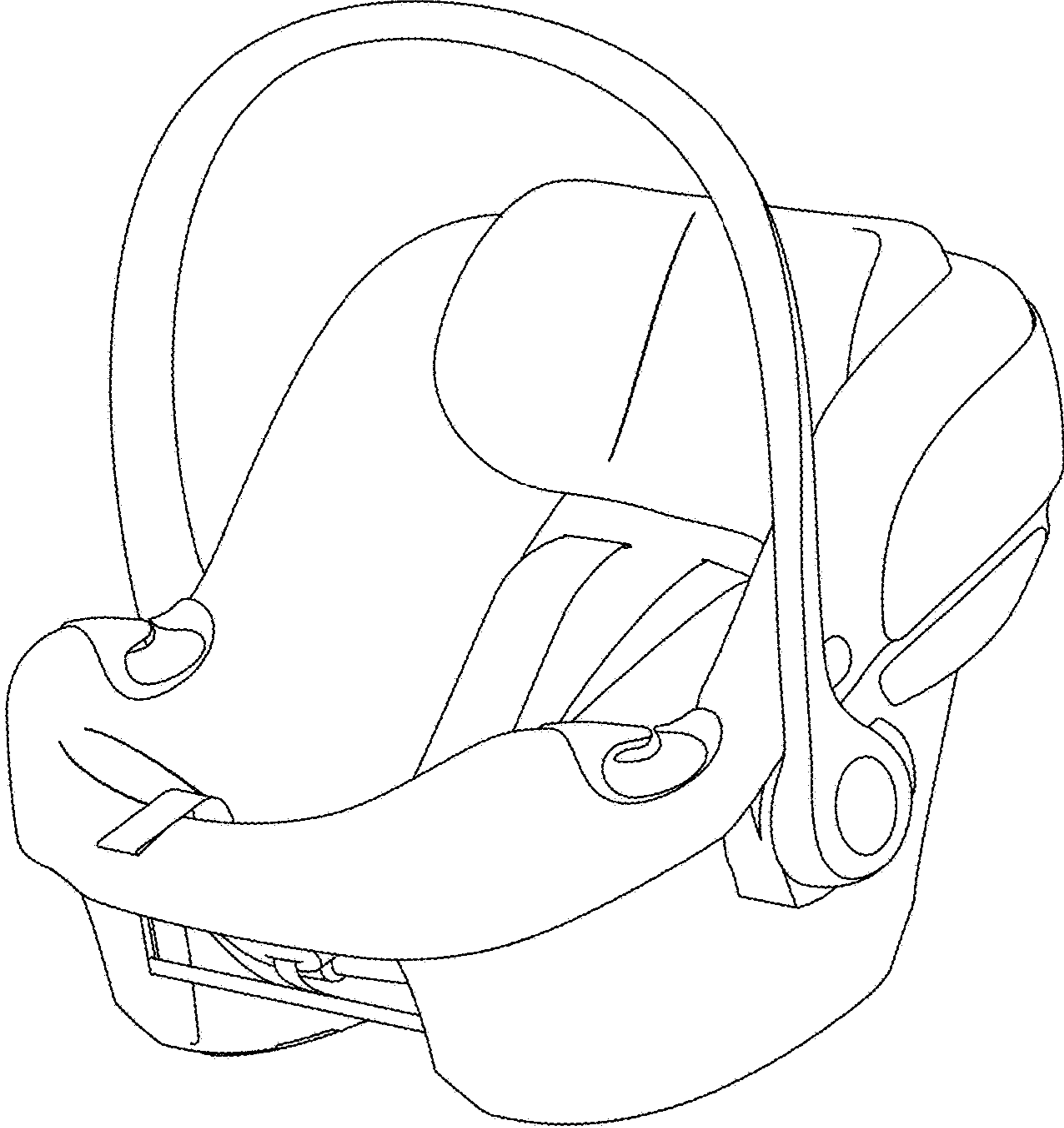
DESCRIPTION

- 1.7 is a bottom view.

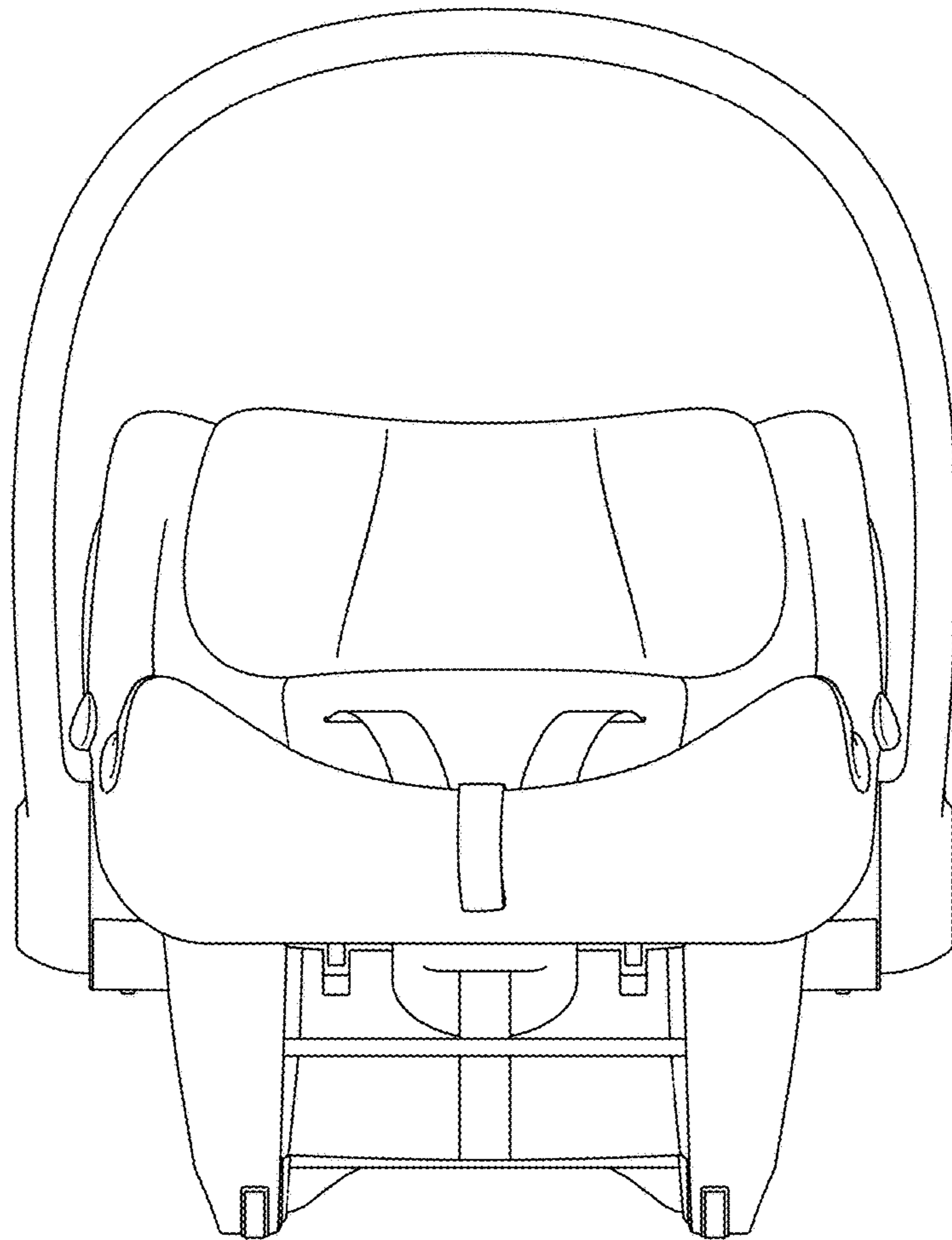
The broken lines and the area within the broken lines in the drawings depict portions of the child safety seats for motor cars that form no part of the claim.

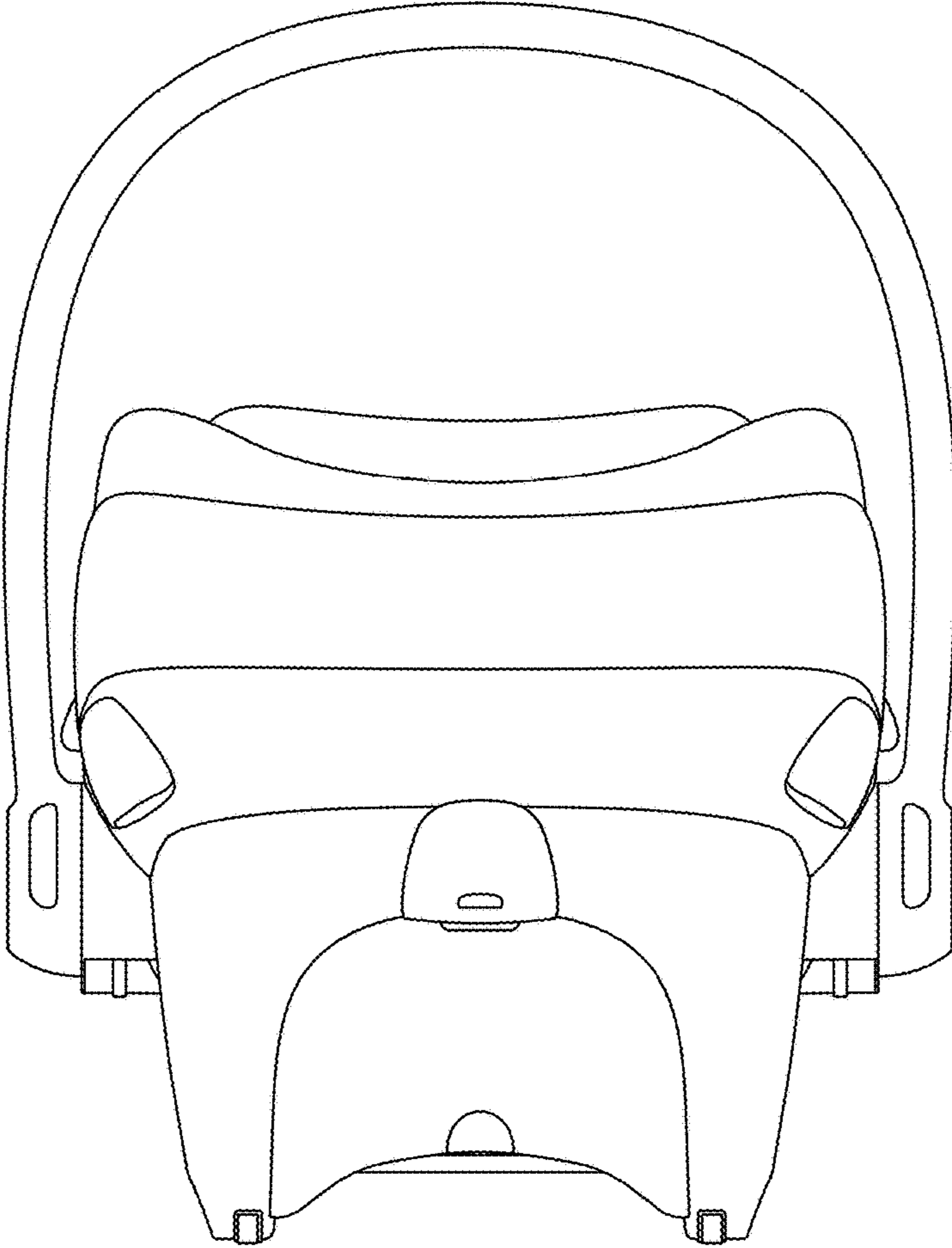




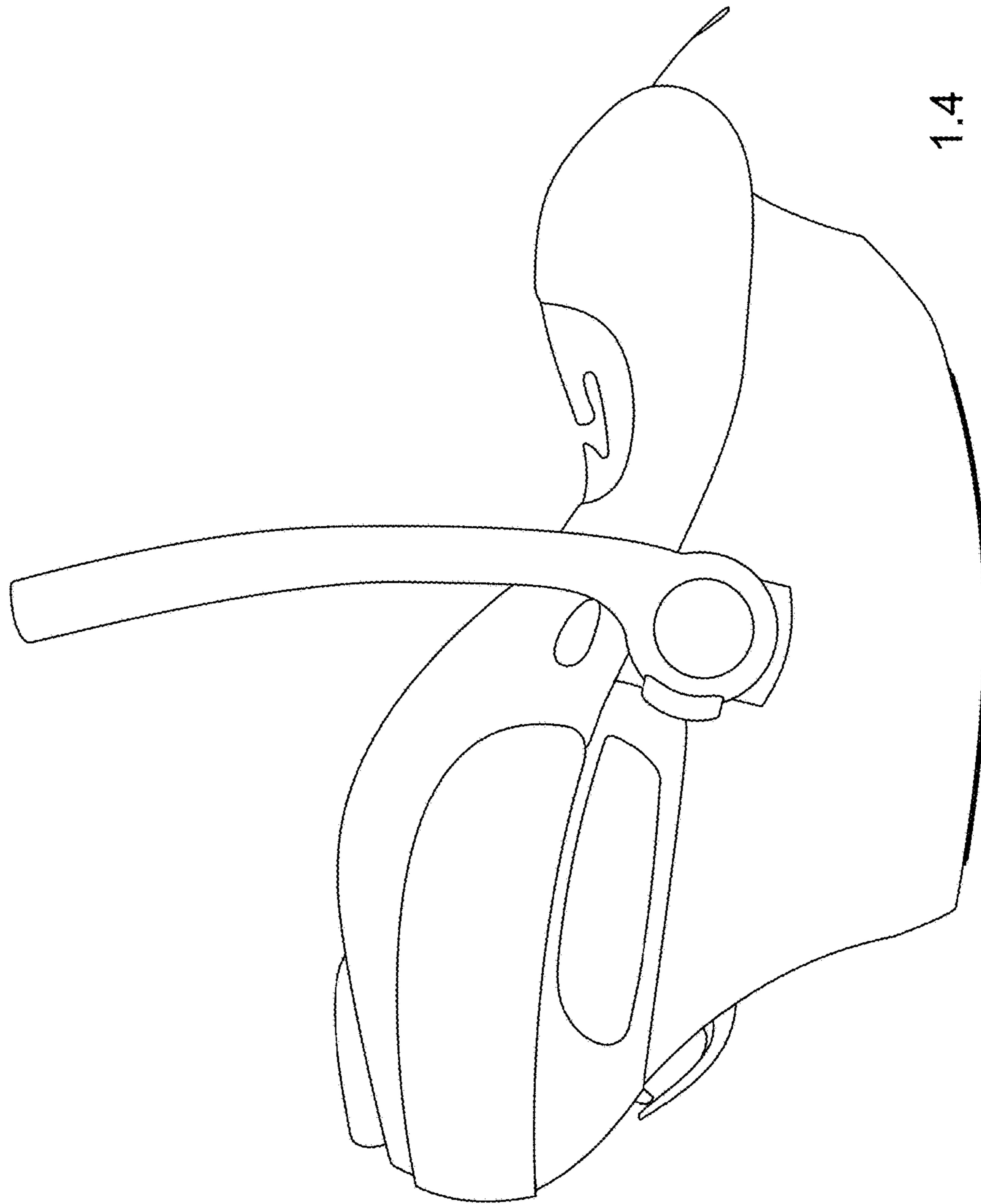

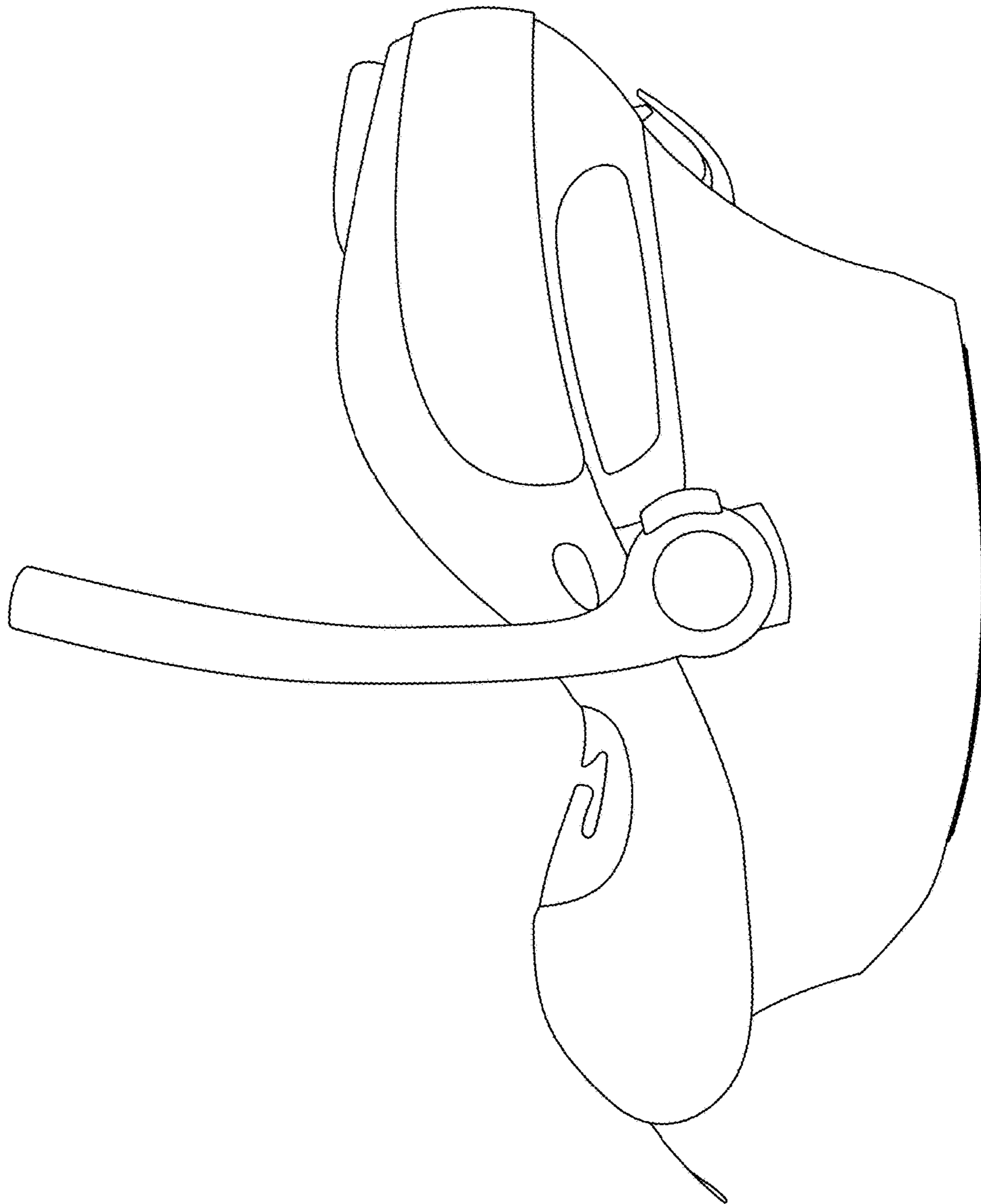

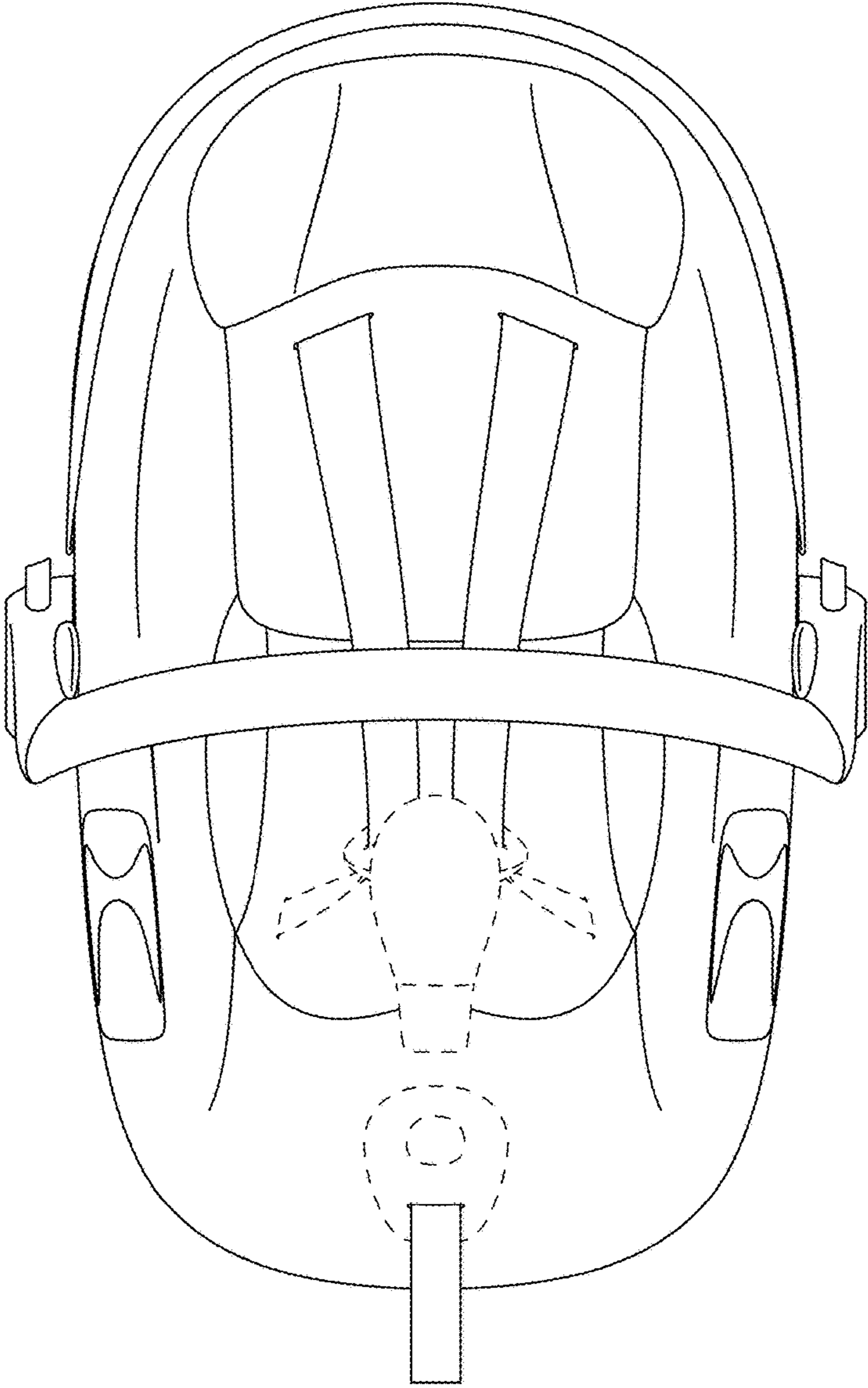

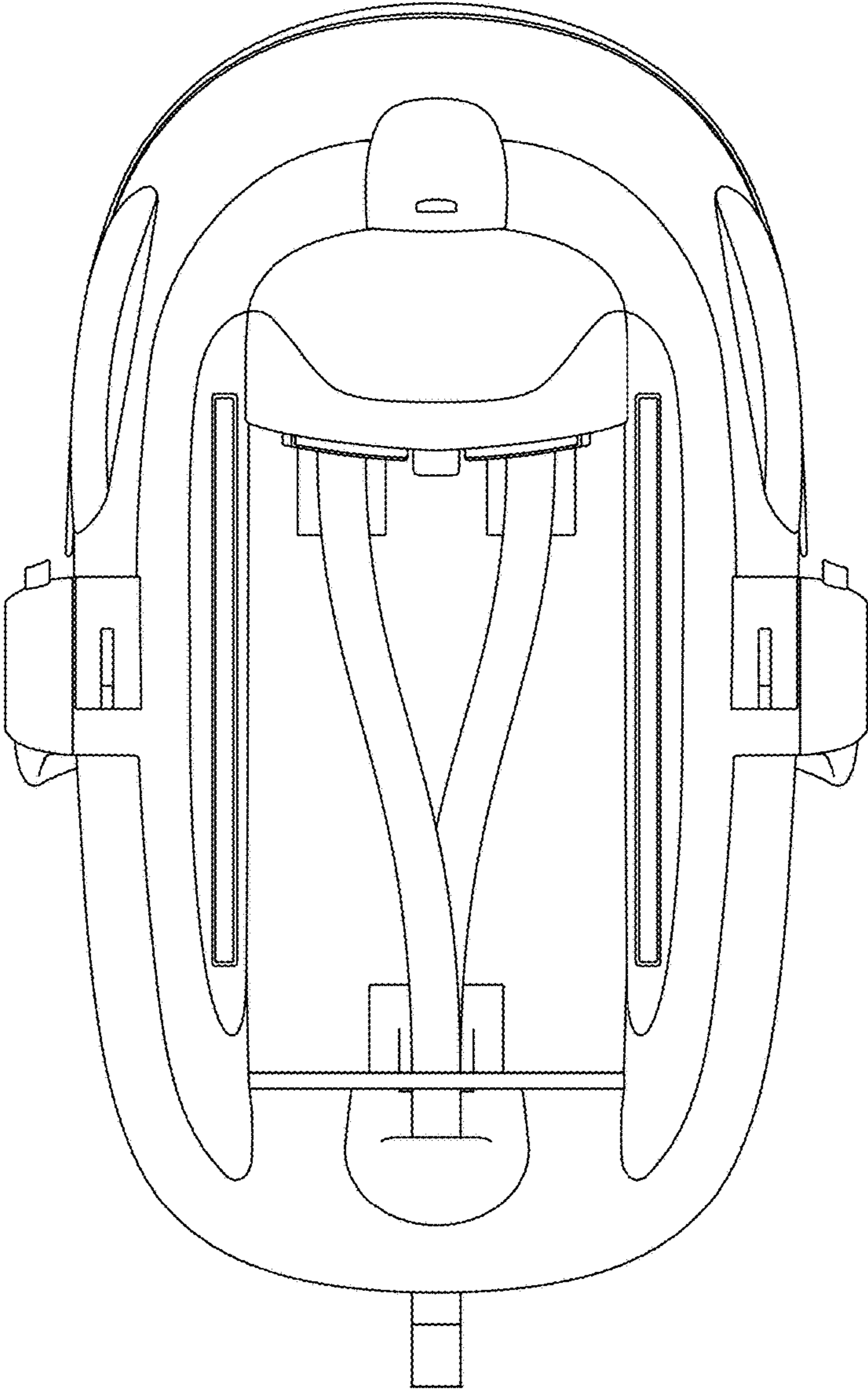
