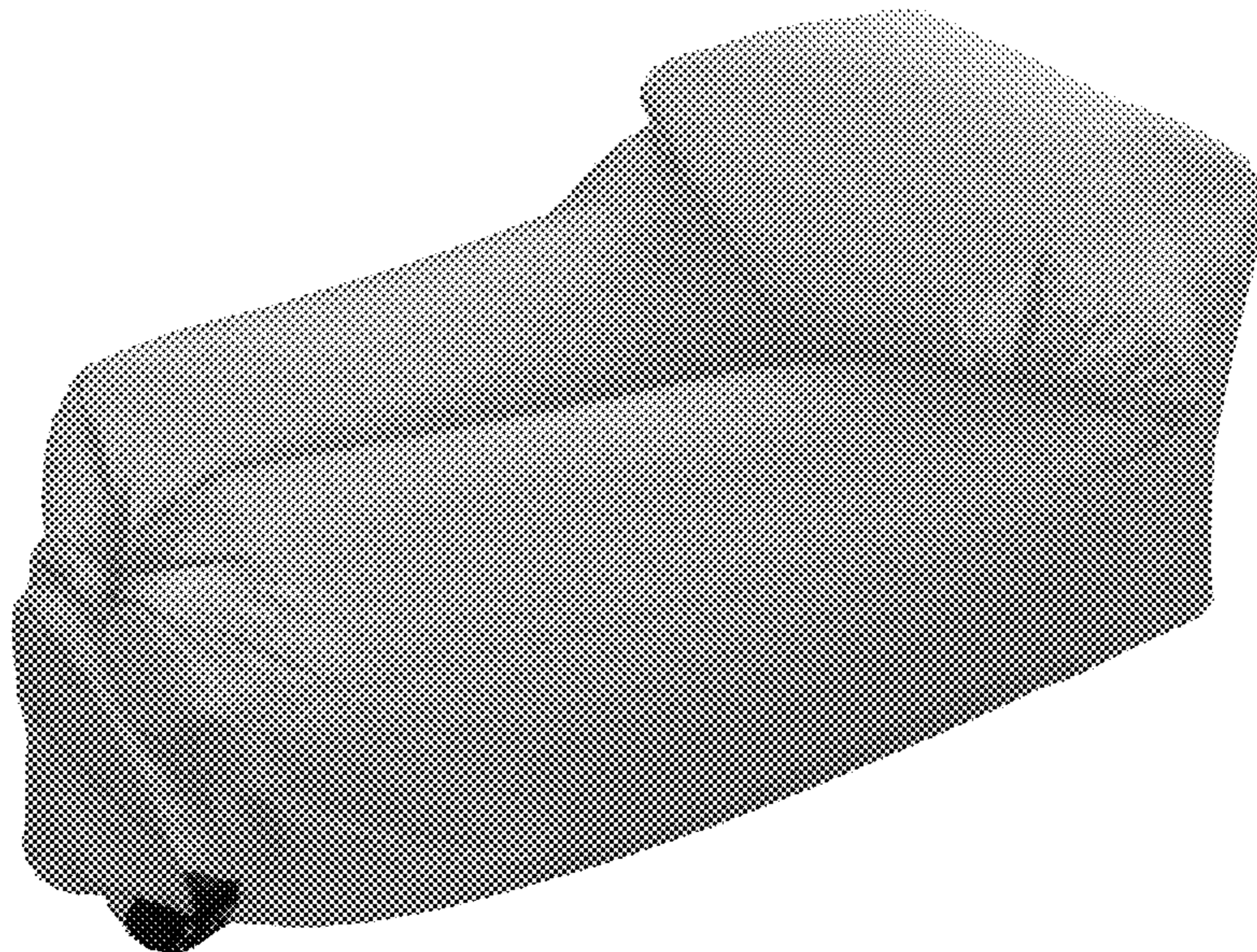
FIG. 1 is an upper front perspective of an inflatable kids lounge chair embodying my design;

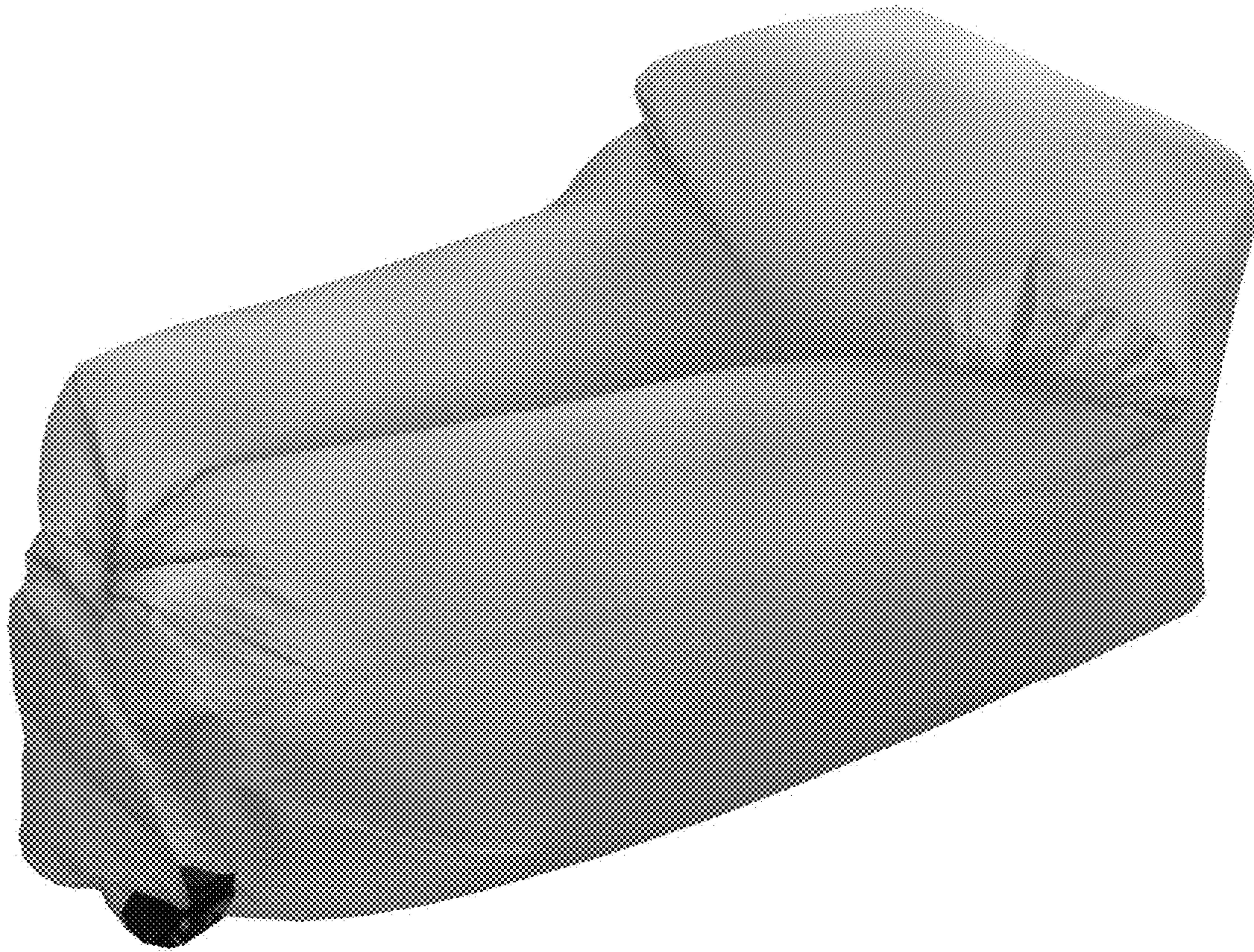

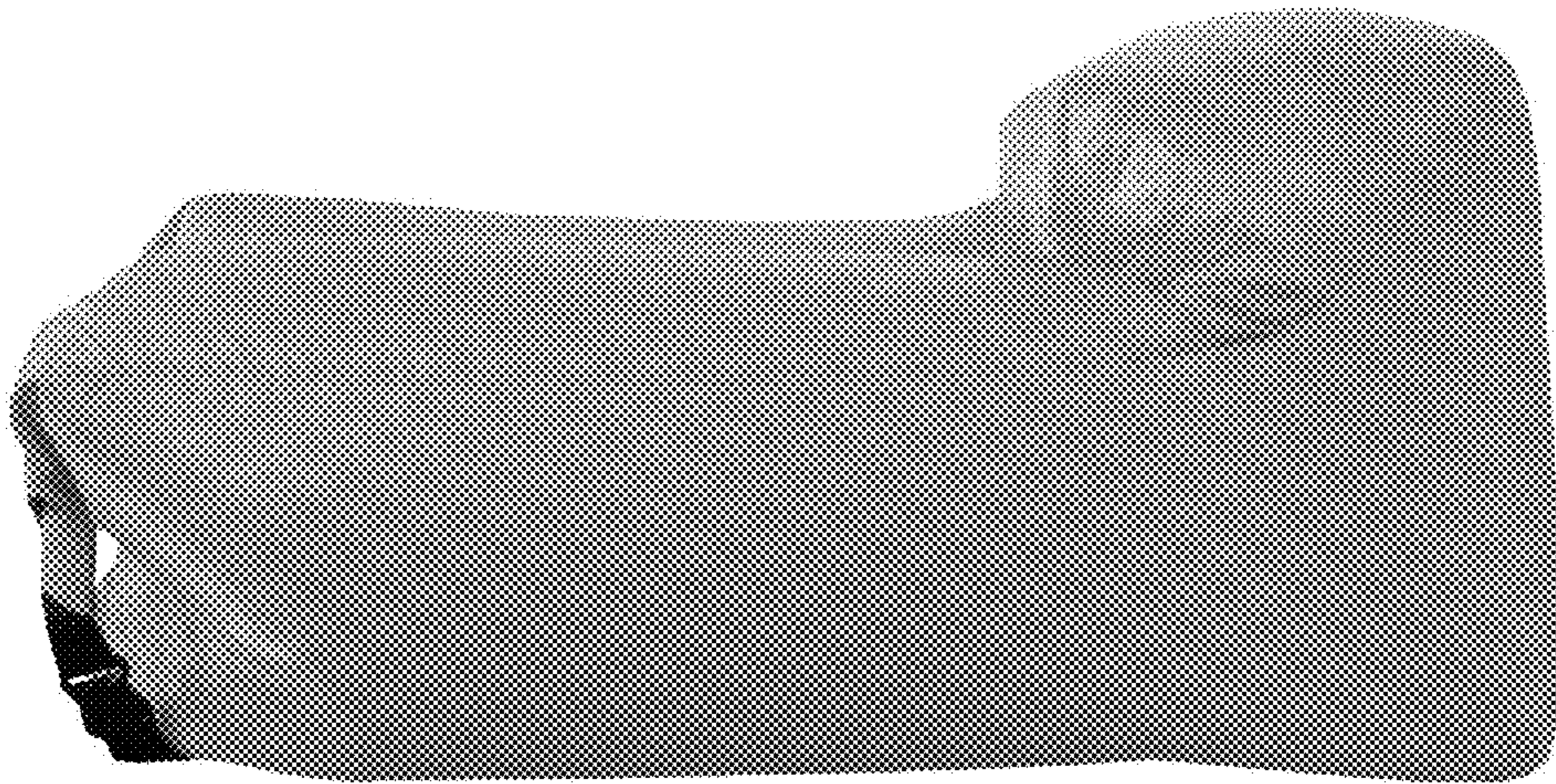

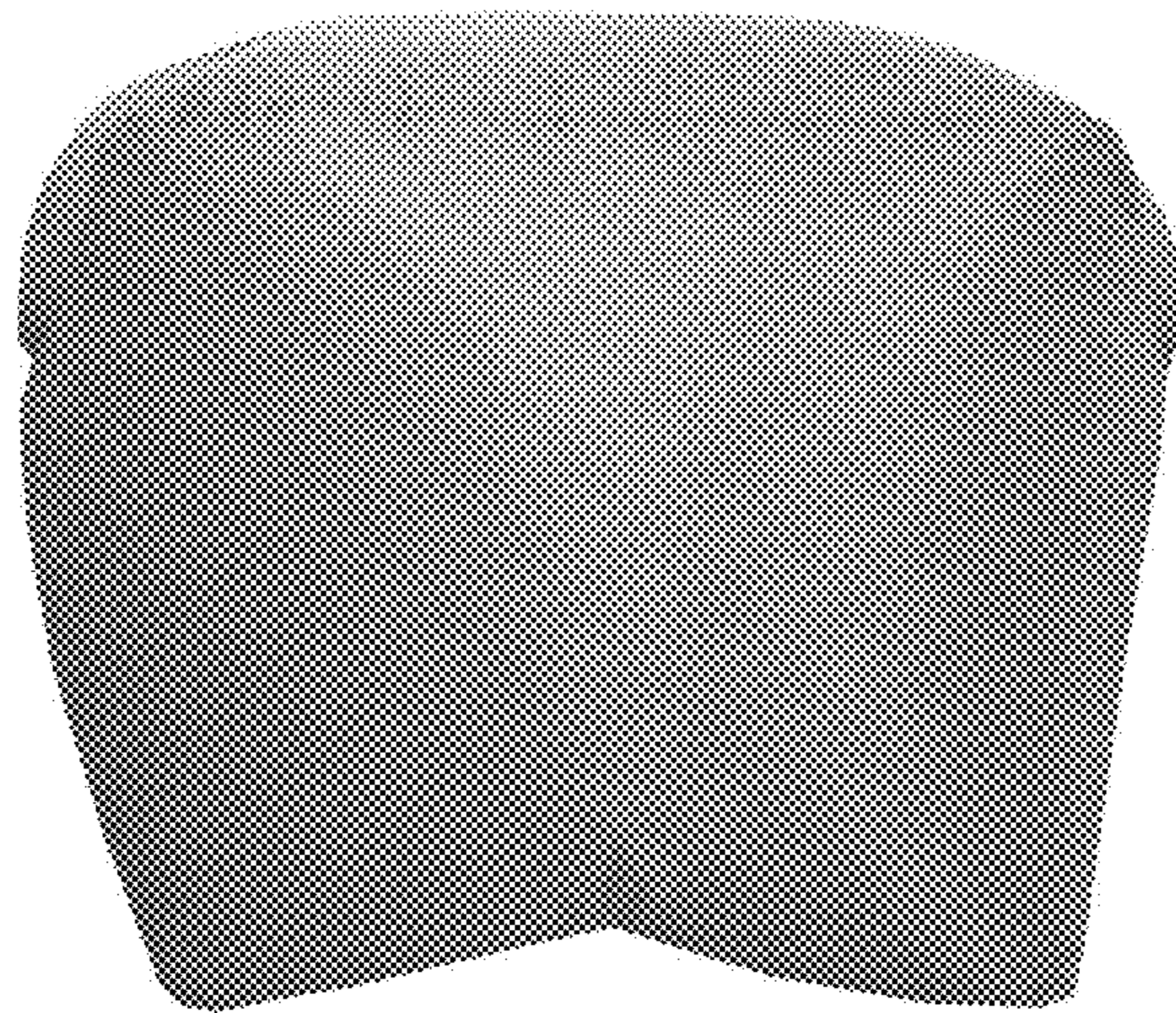

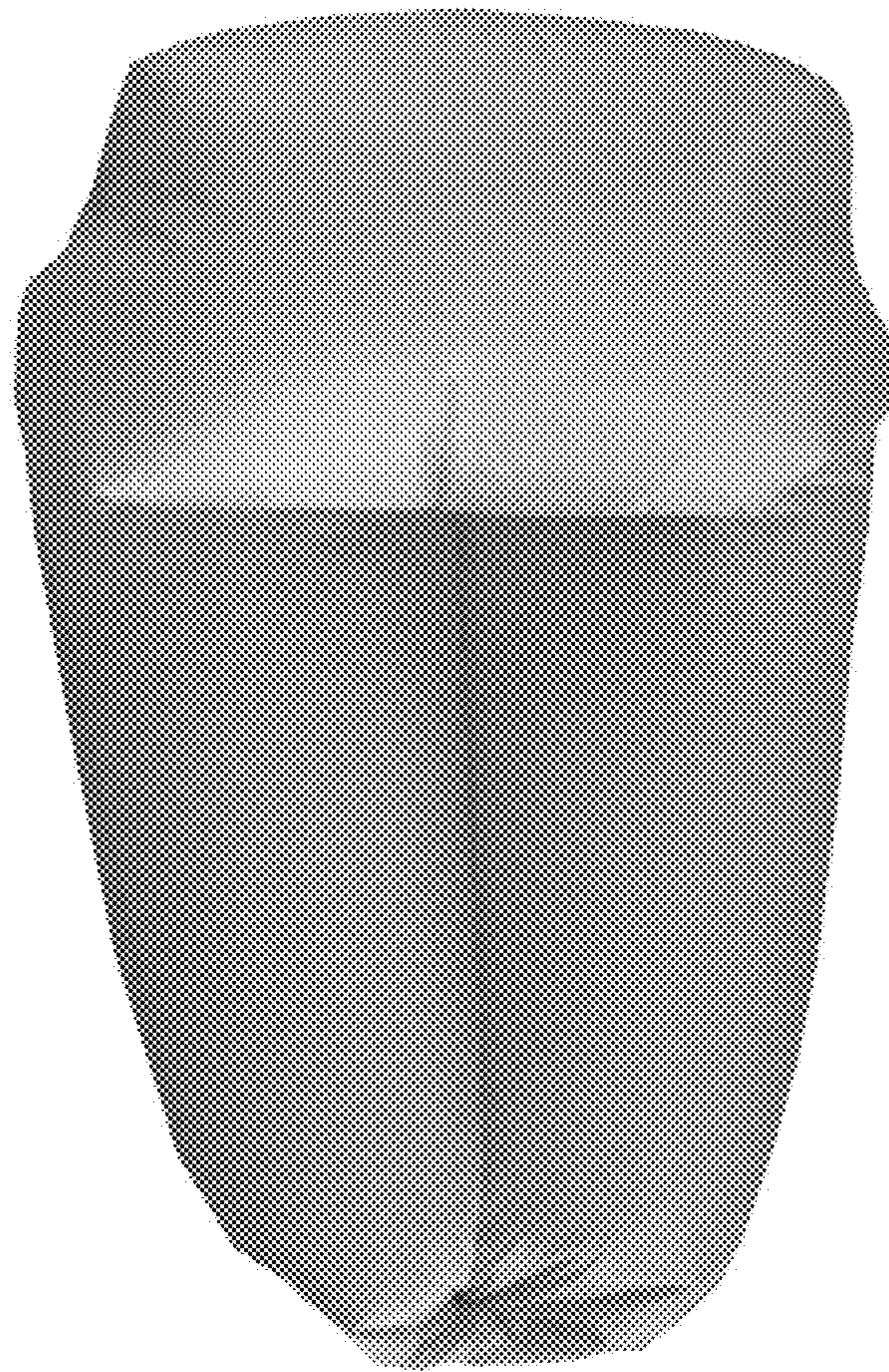

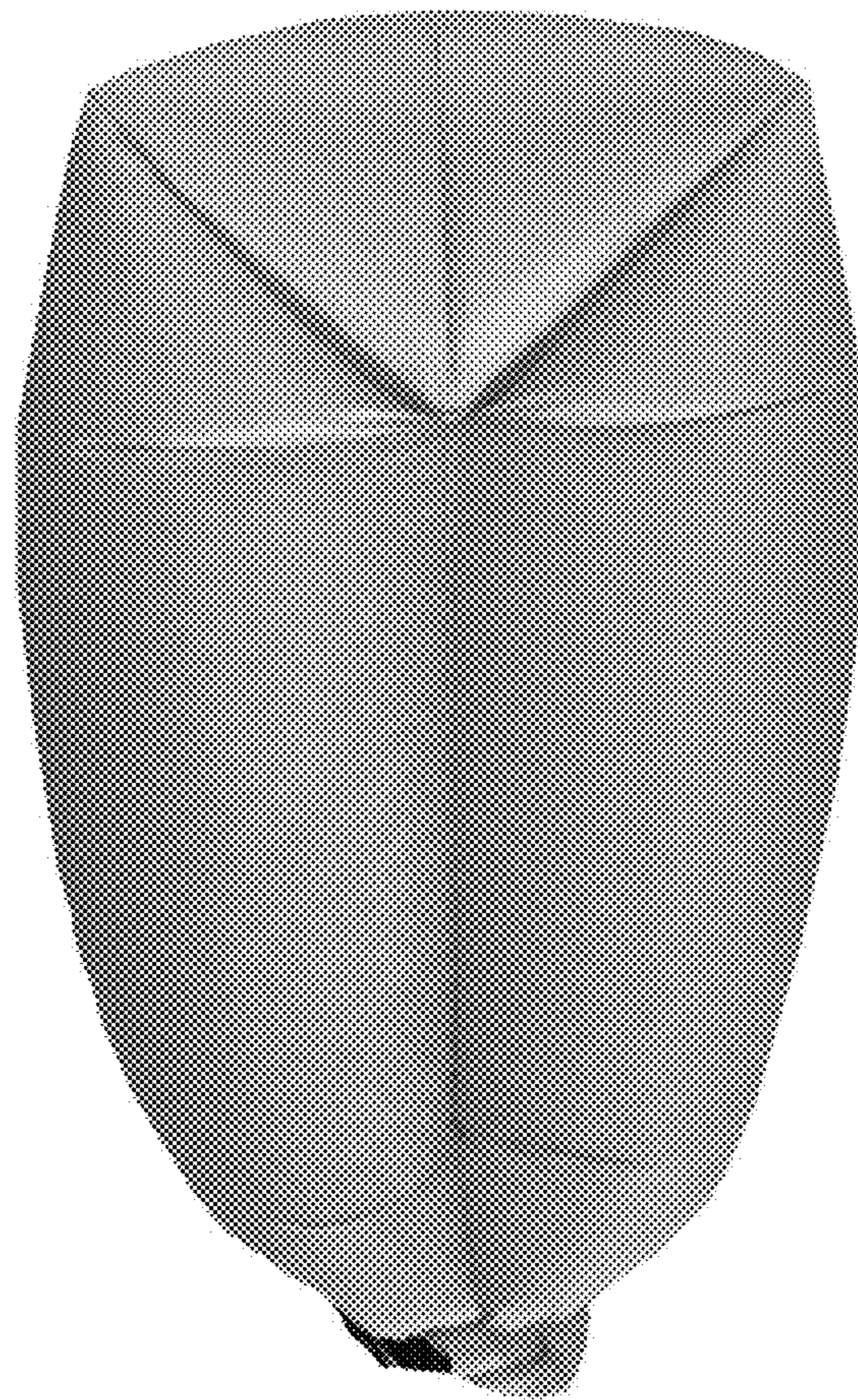

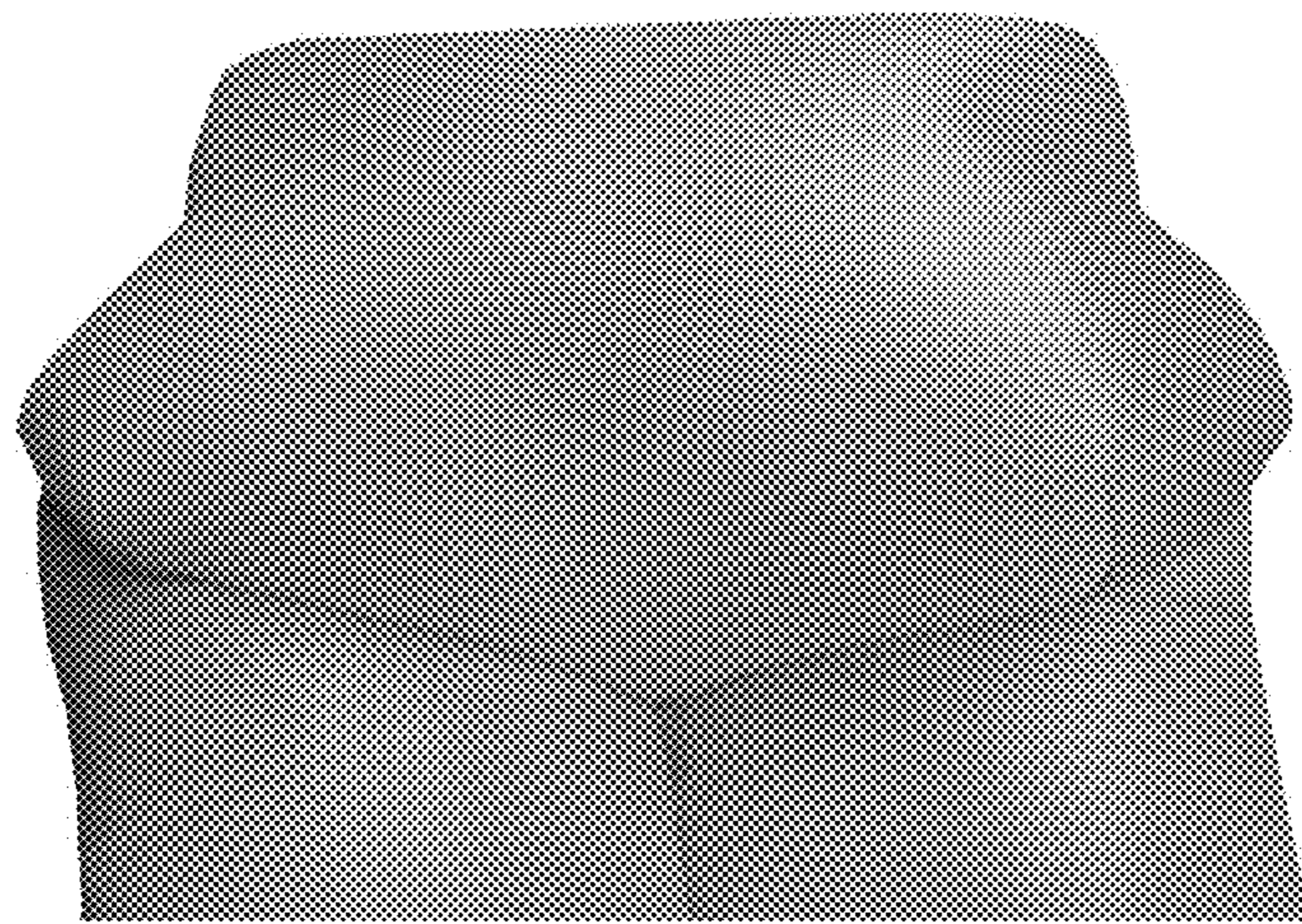
