DESCRIPTION

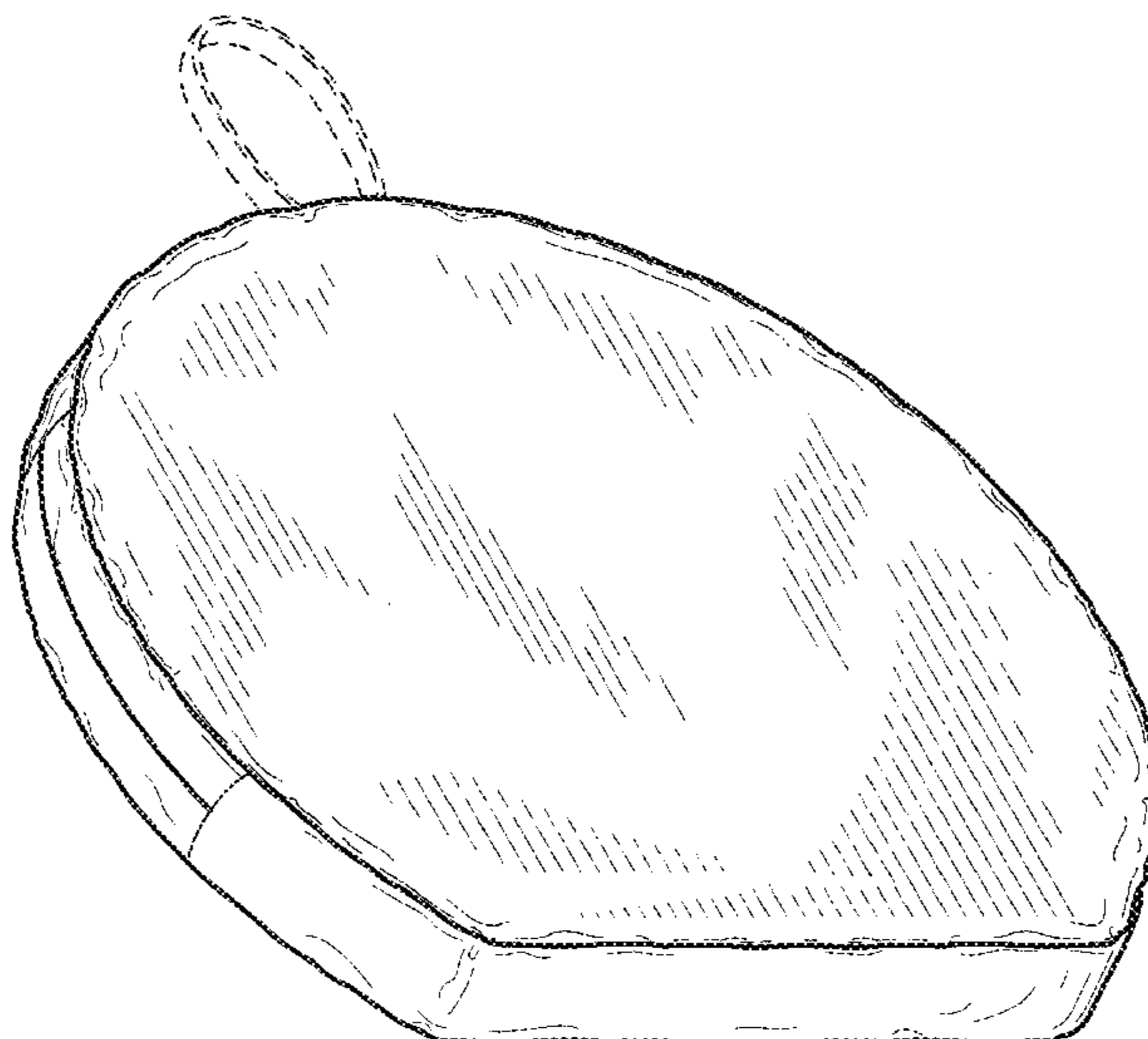

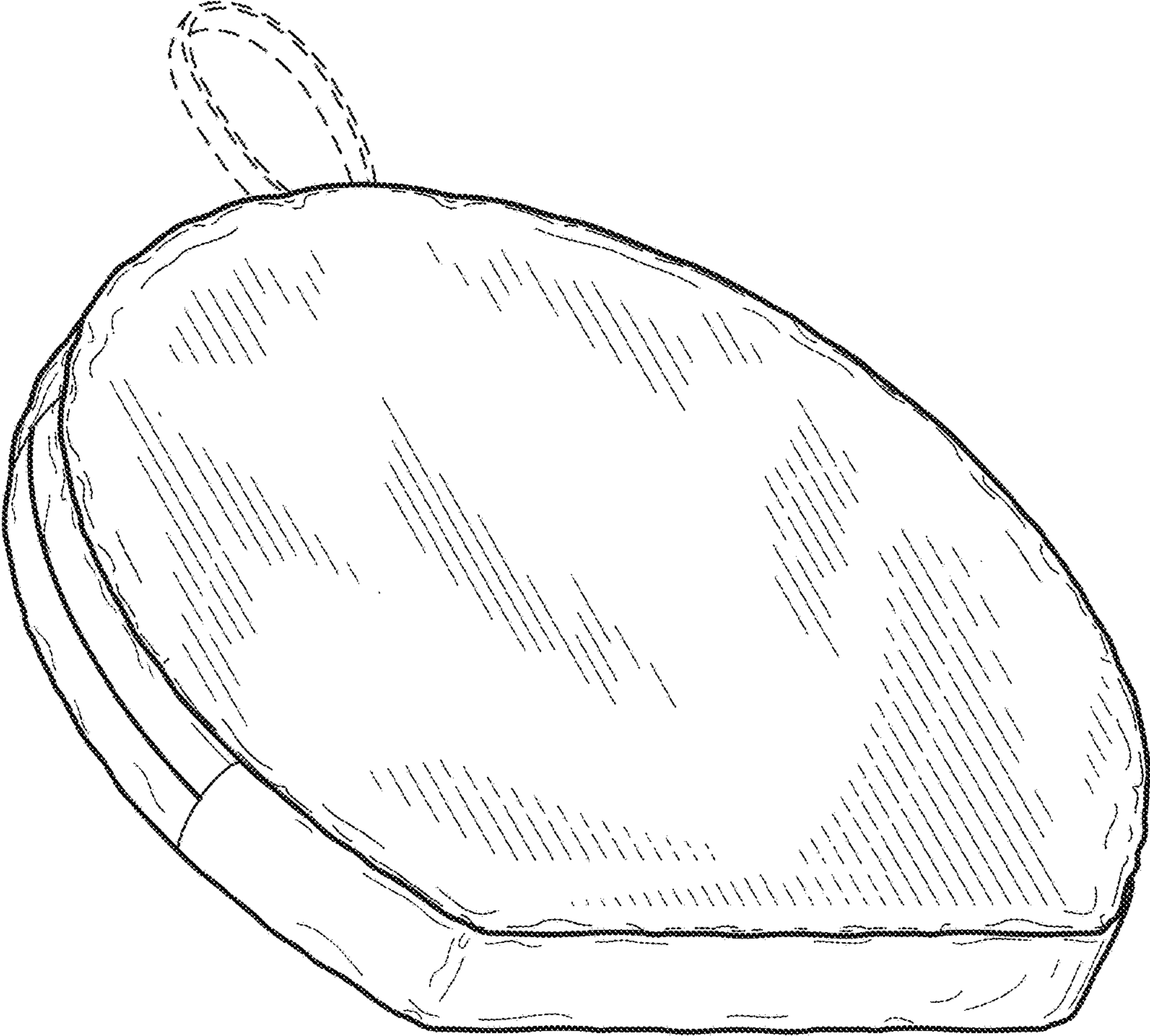

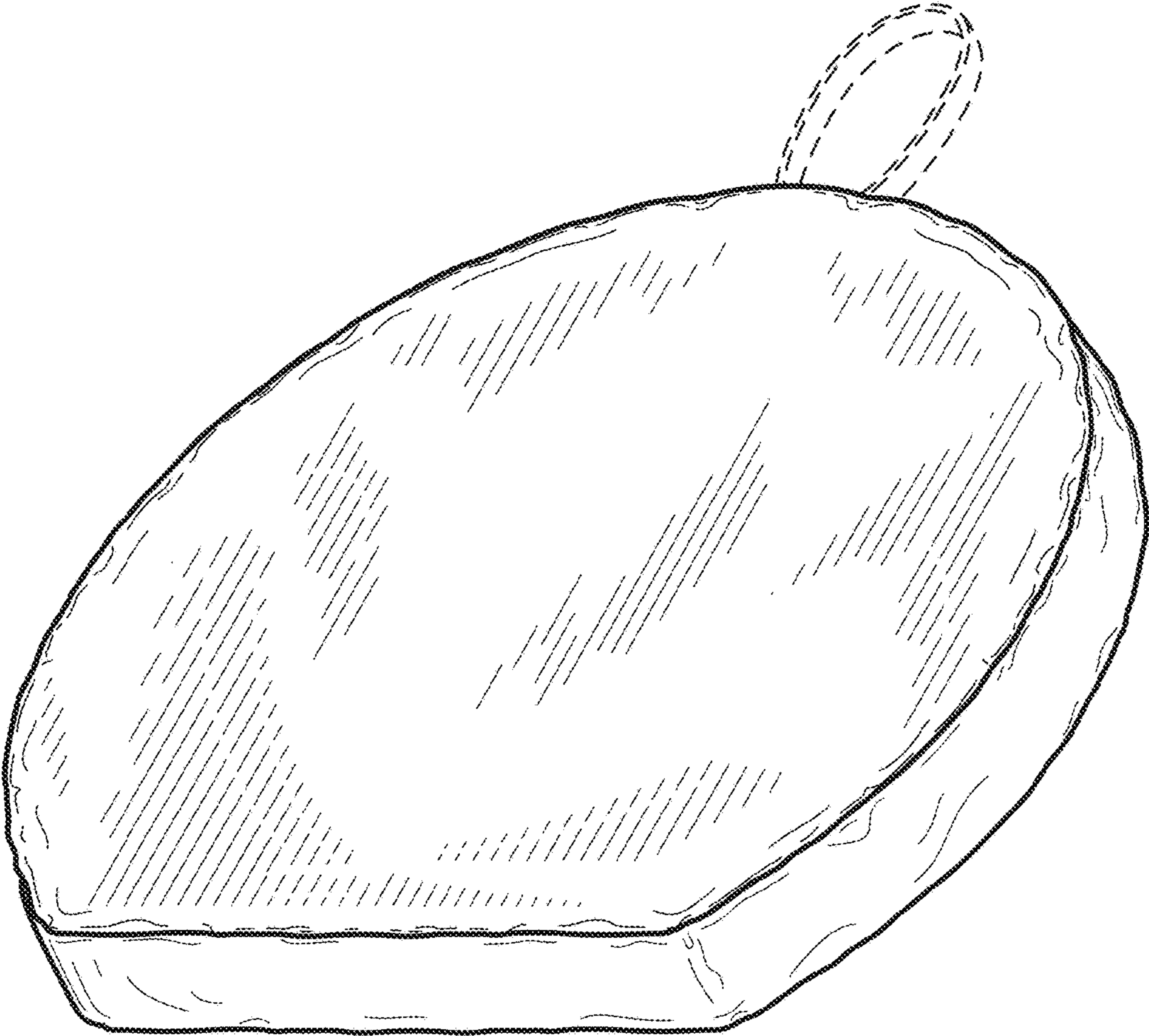

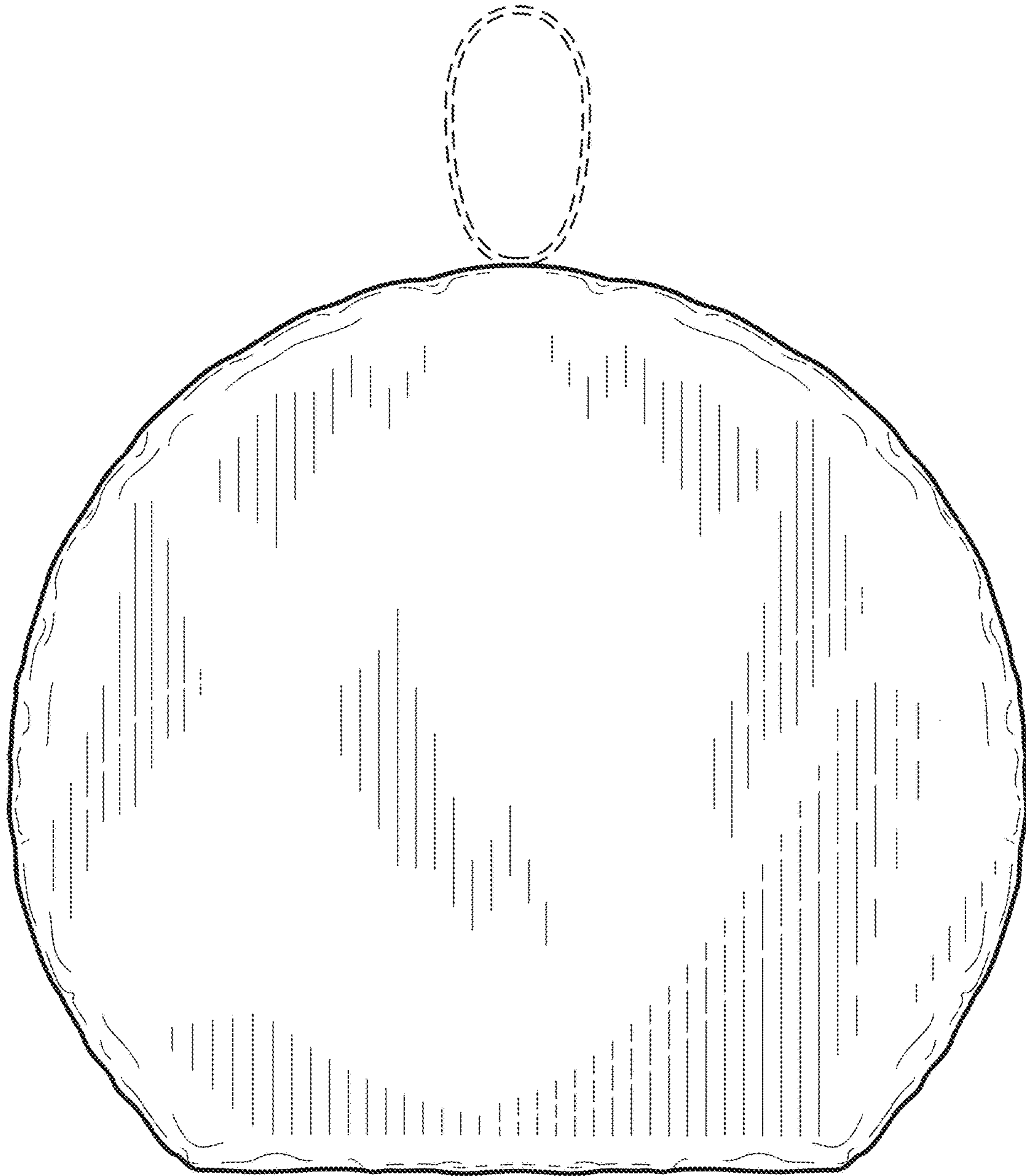

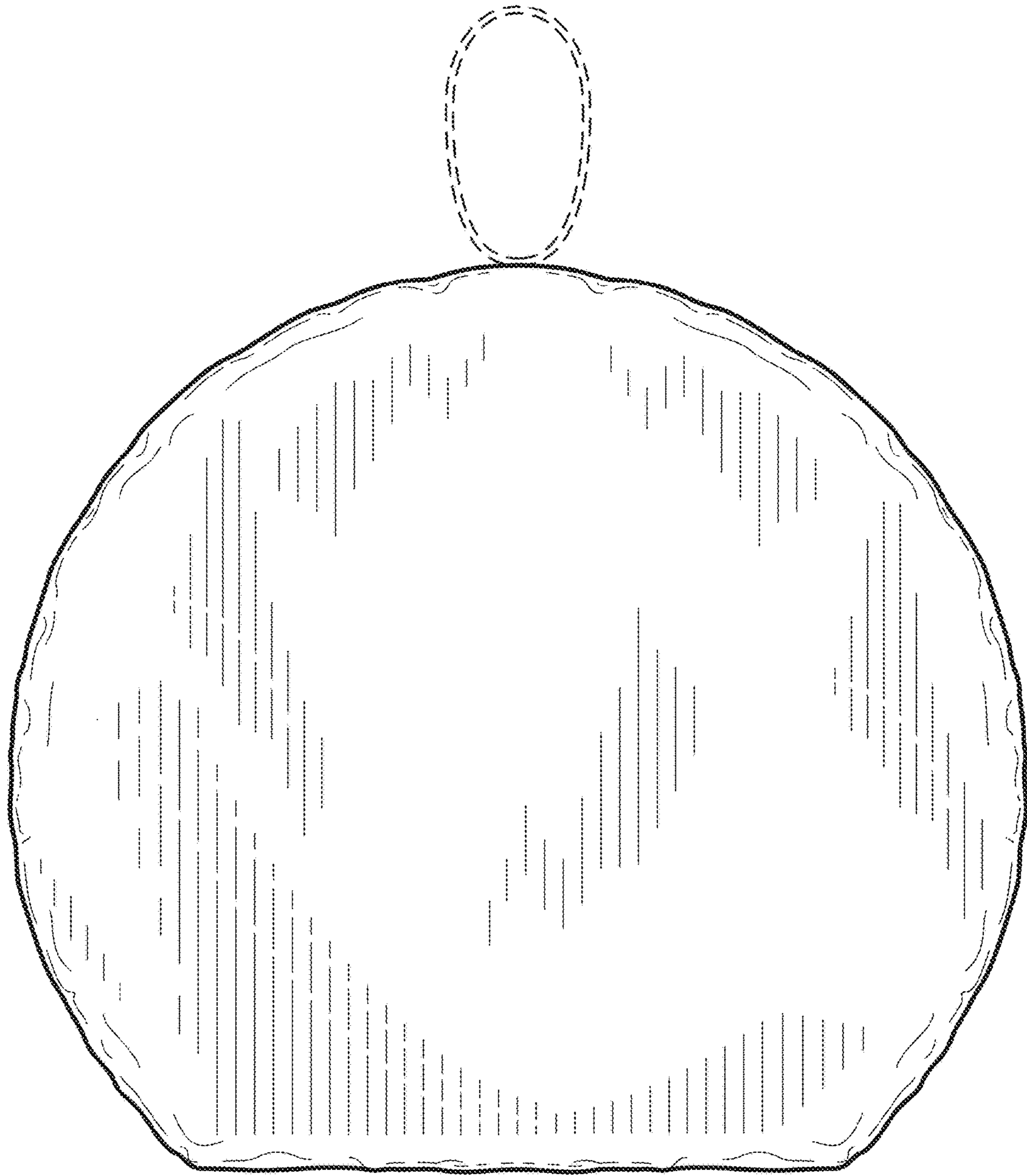

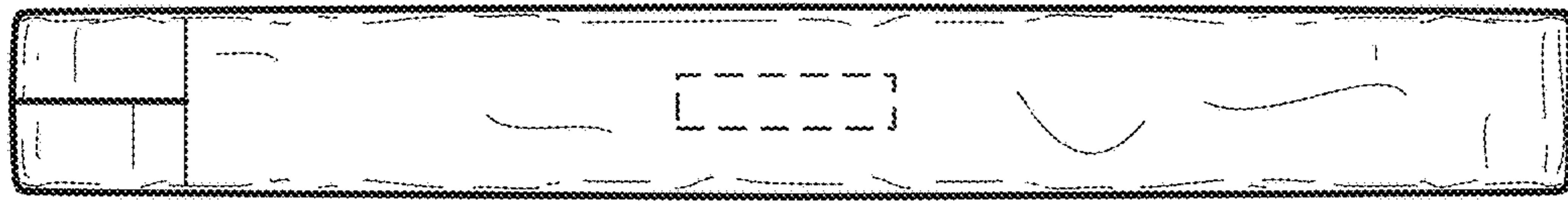

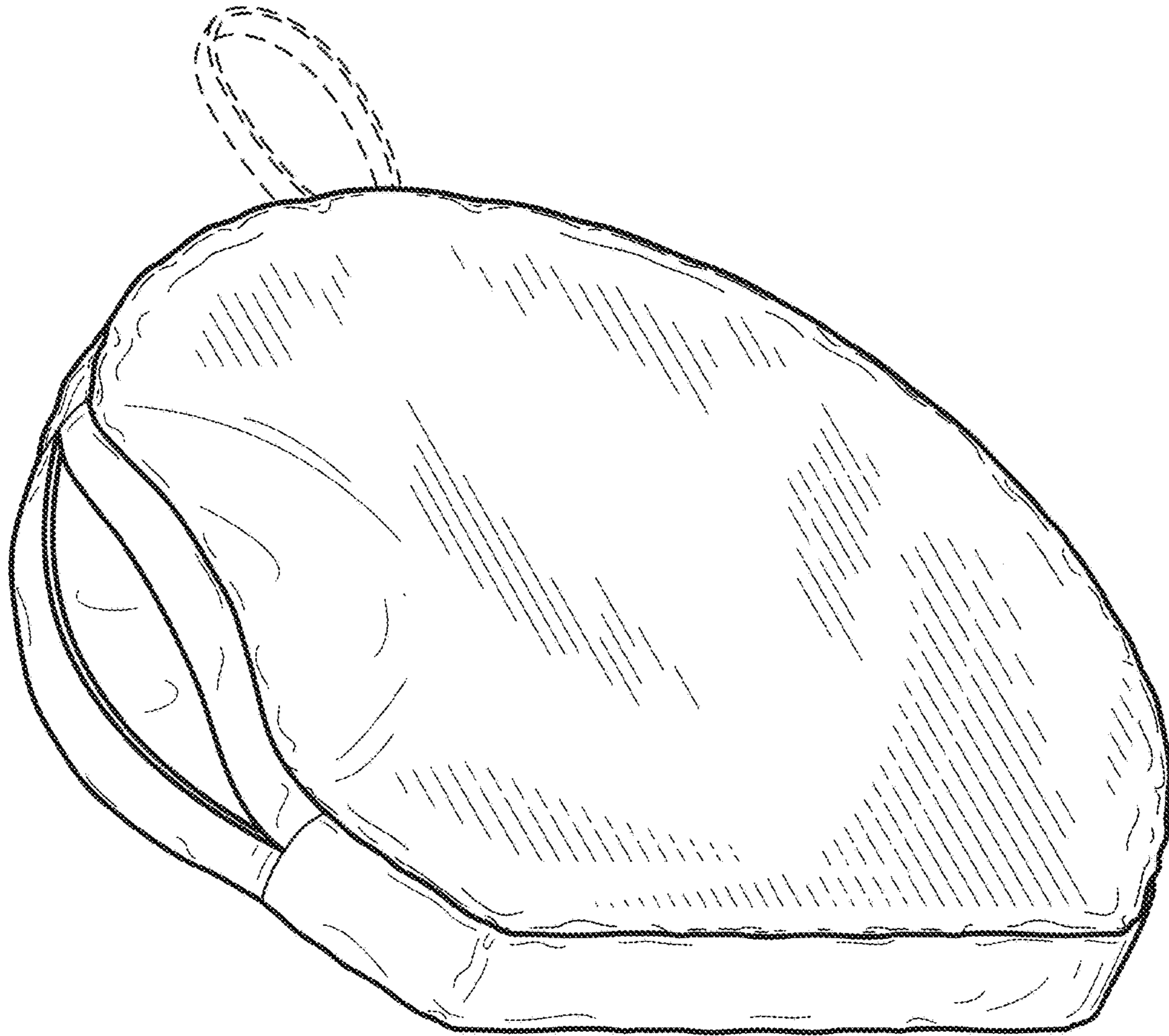
