(57) **CLAIM**

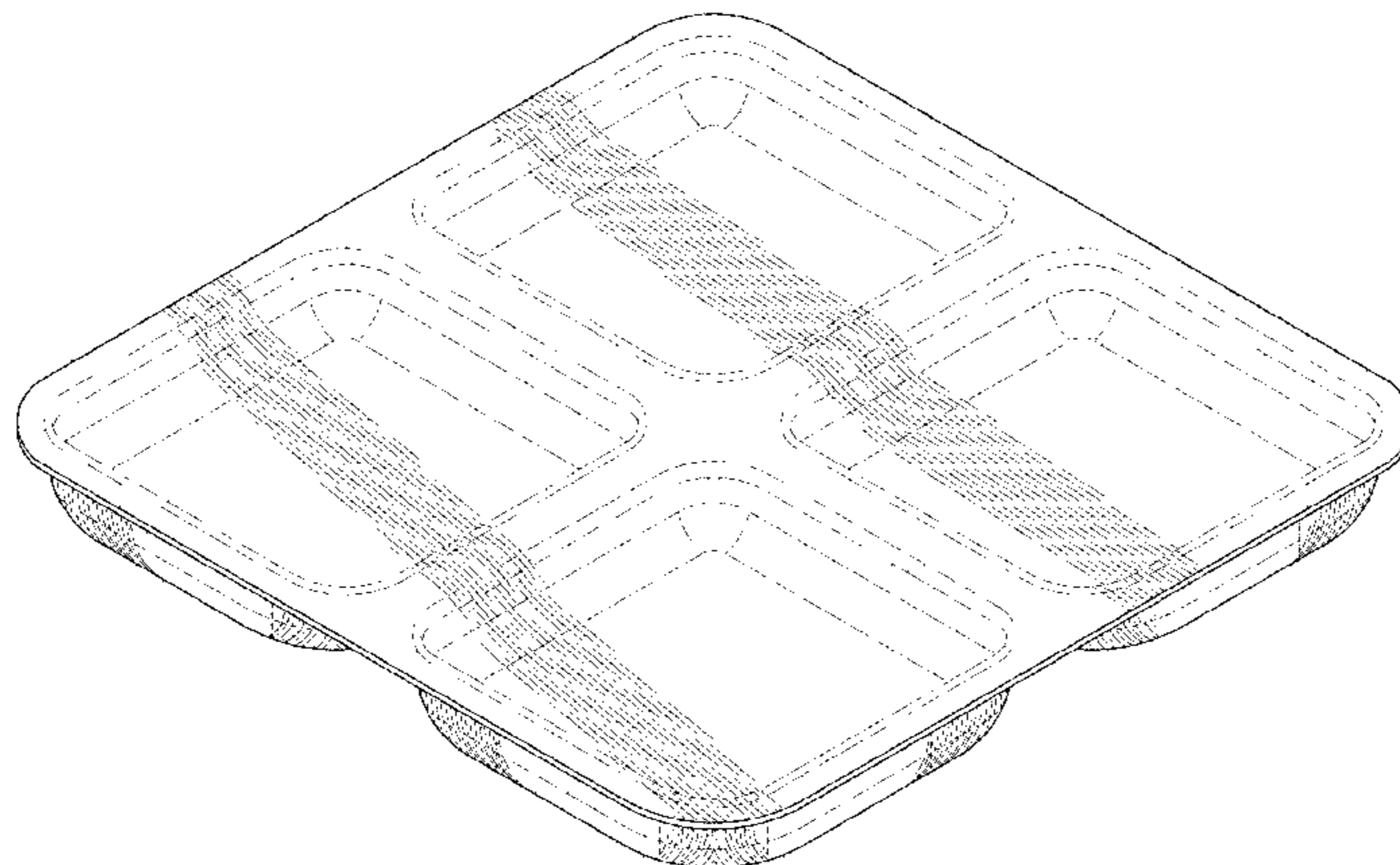
The ornamental design for a palm leaf dinnerware plate, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a palm leaf dinnerware plate according to the present disclosure; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

The palm leaf dinnerware plate is made from a compressed palm leaf material and accordingly has the texture and pattern of a compressed palm leaf.

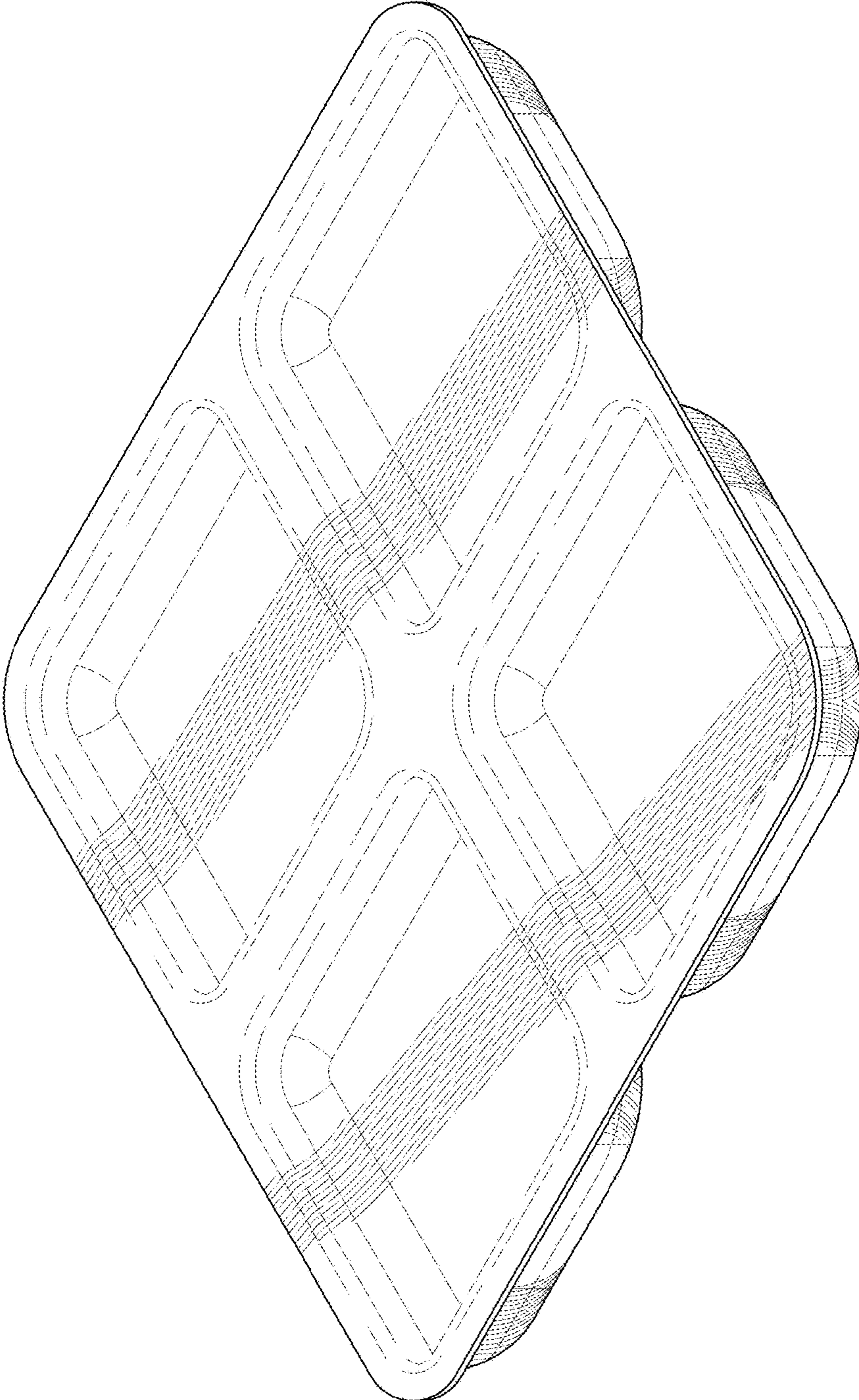

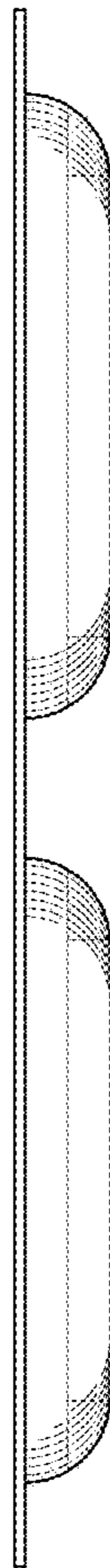

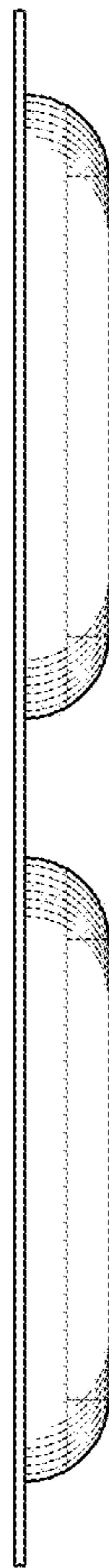

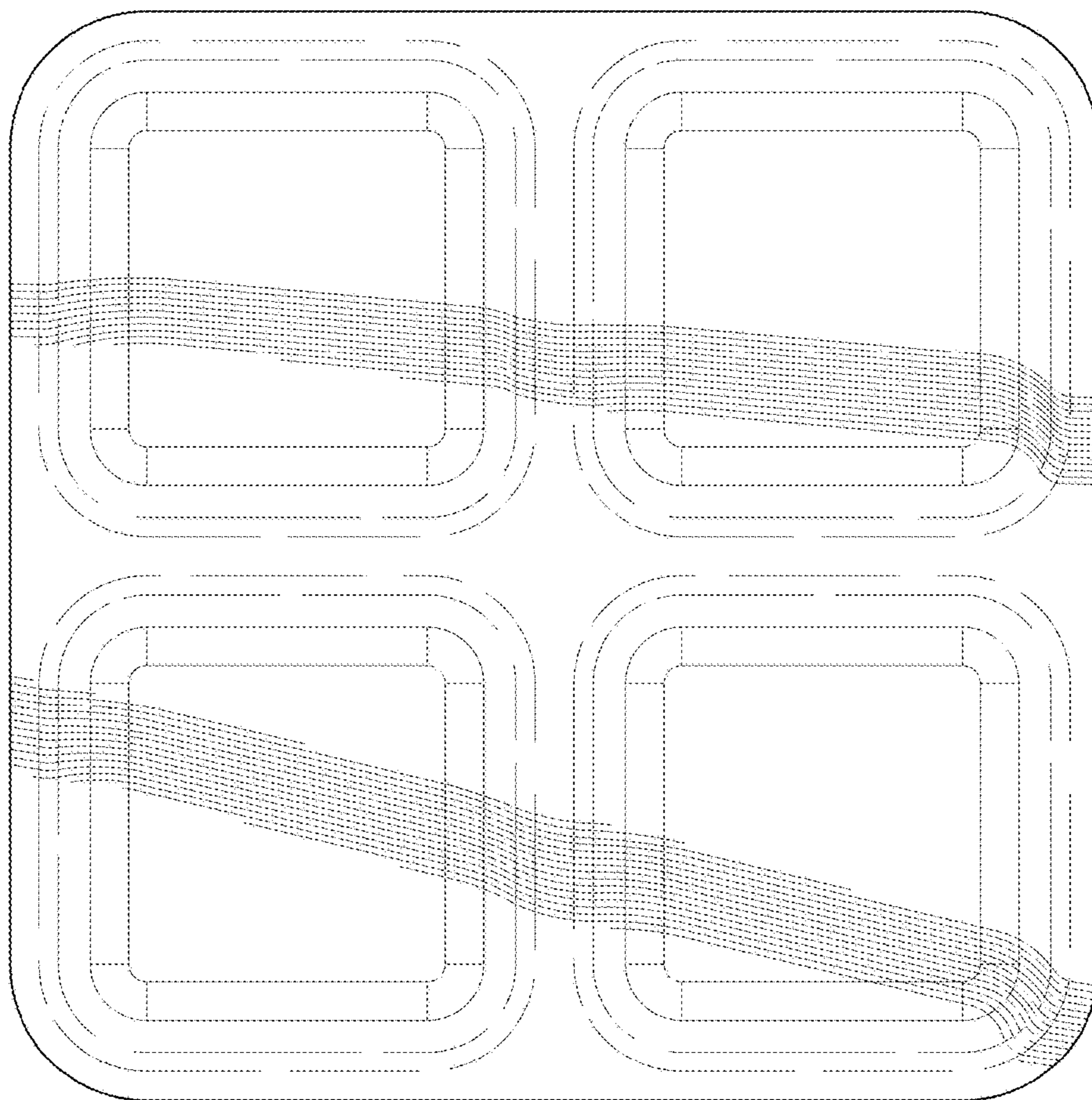

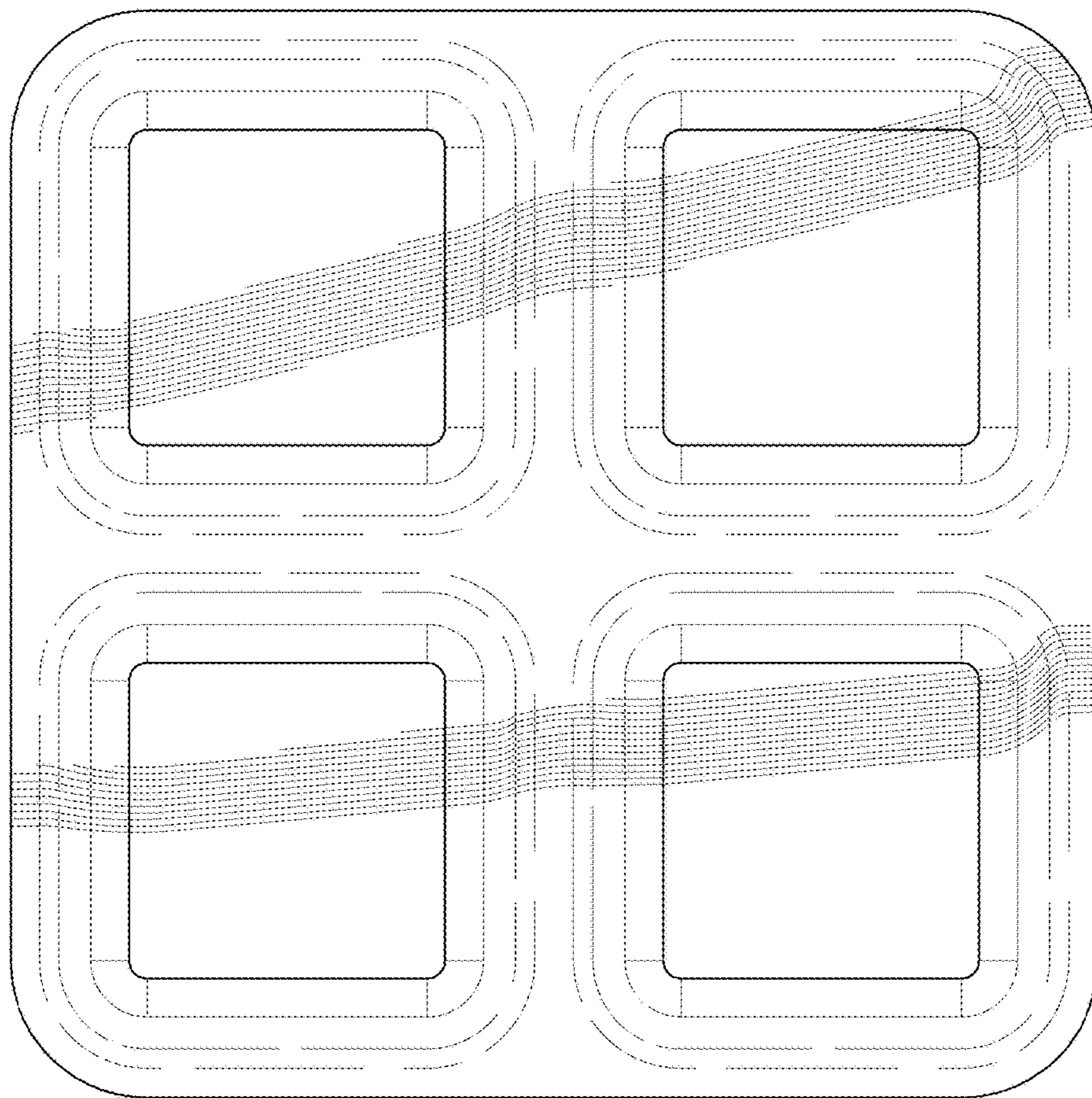
