The ornamental design for a torque sleeve, as shown and described.

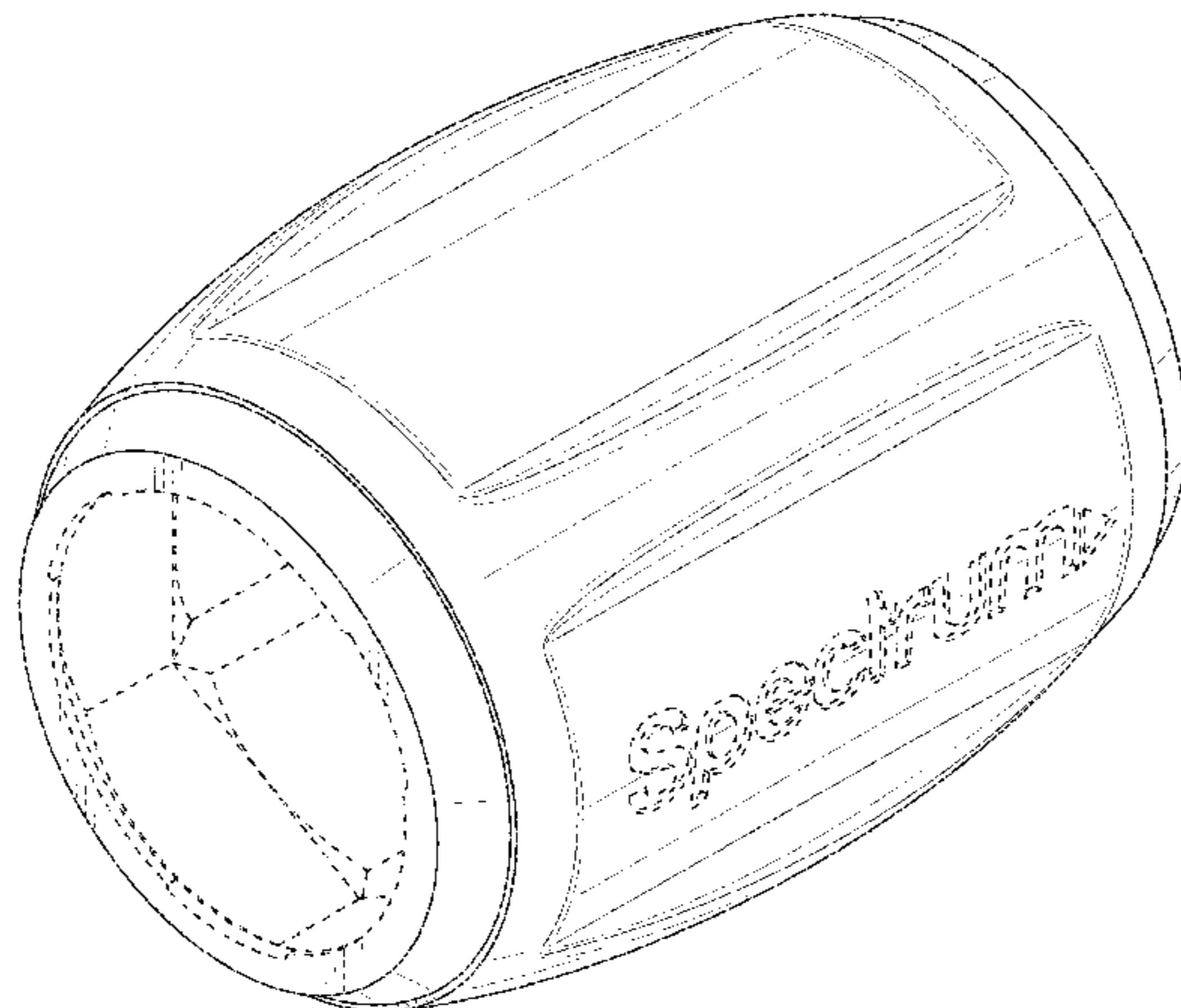
**DESCRIPTION**

FIG. 1 is a front, top, left-side view of the torque sleeve; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right-side elevational view thereof; FIG. 5 is a left-side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines in the drawings depict portions of the torque sleeve that form no part of the claimed design.

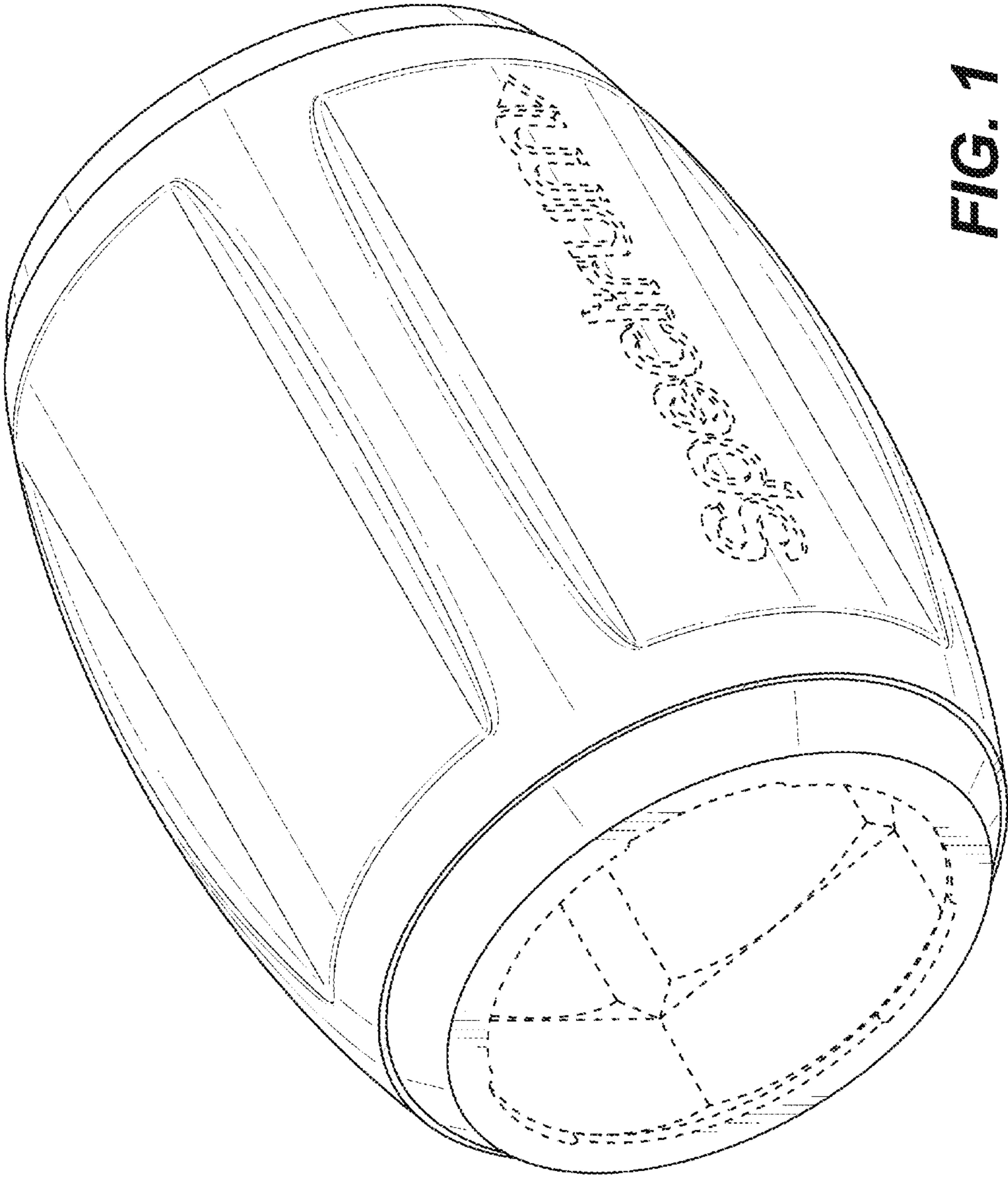

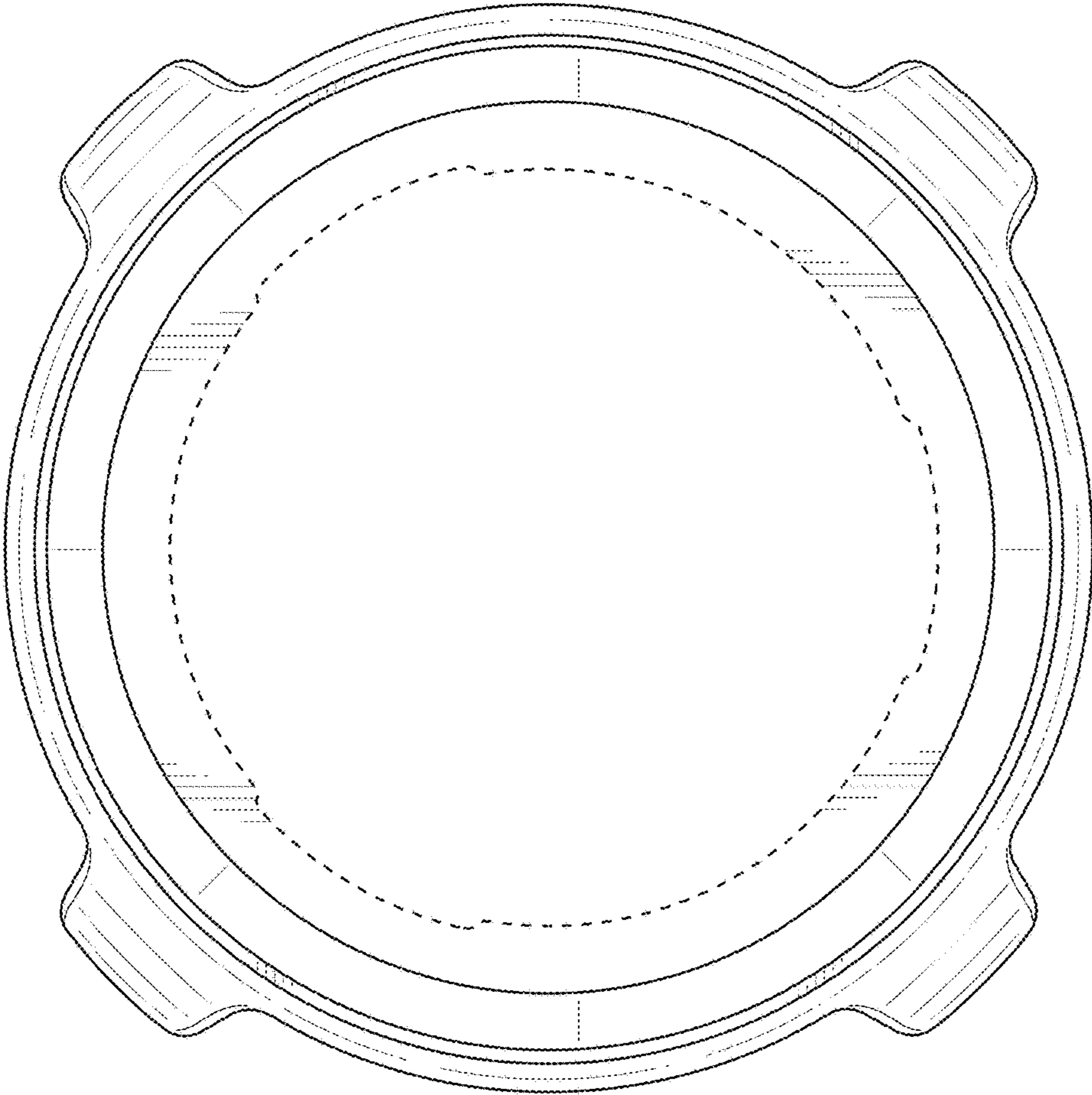

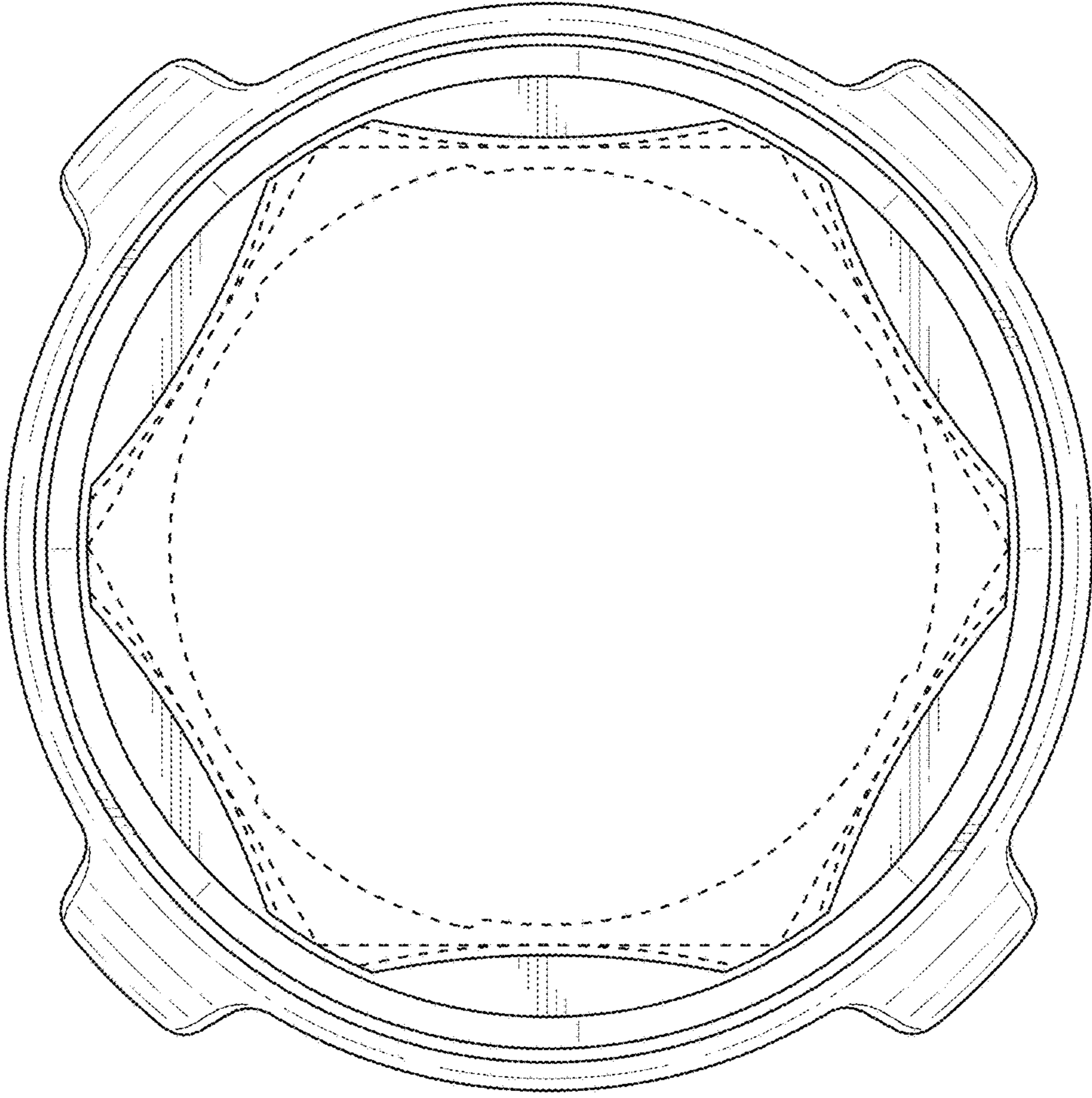
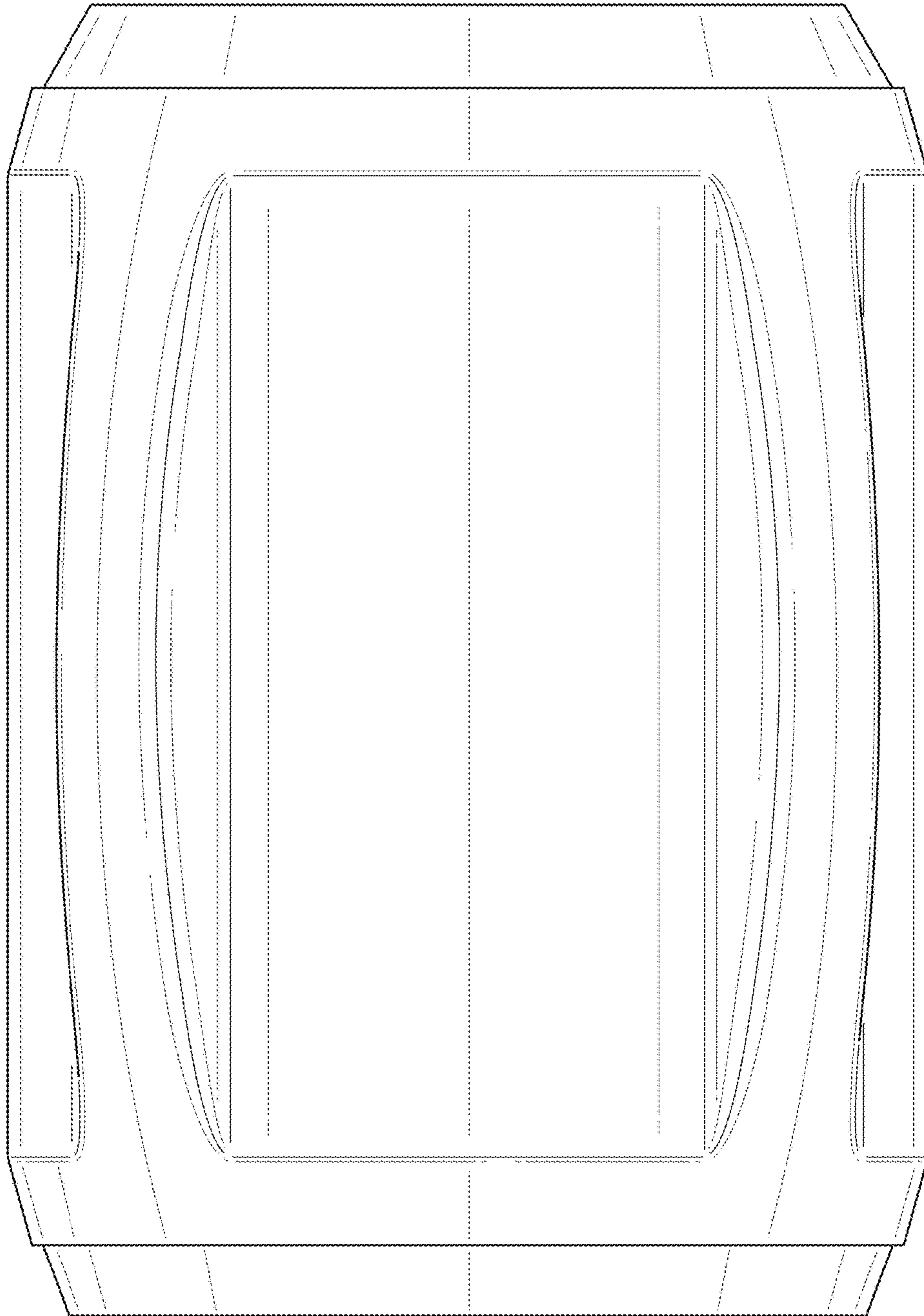
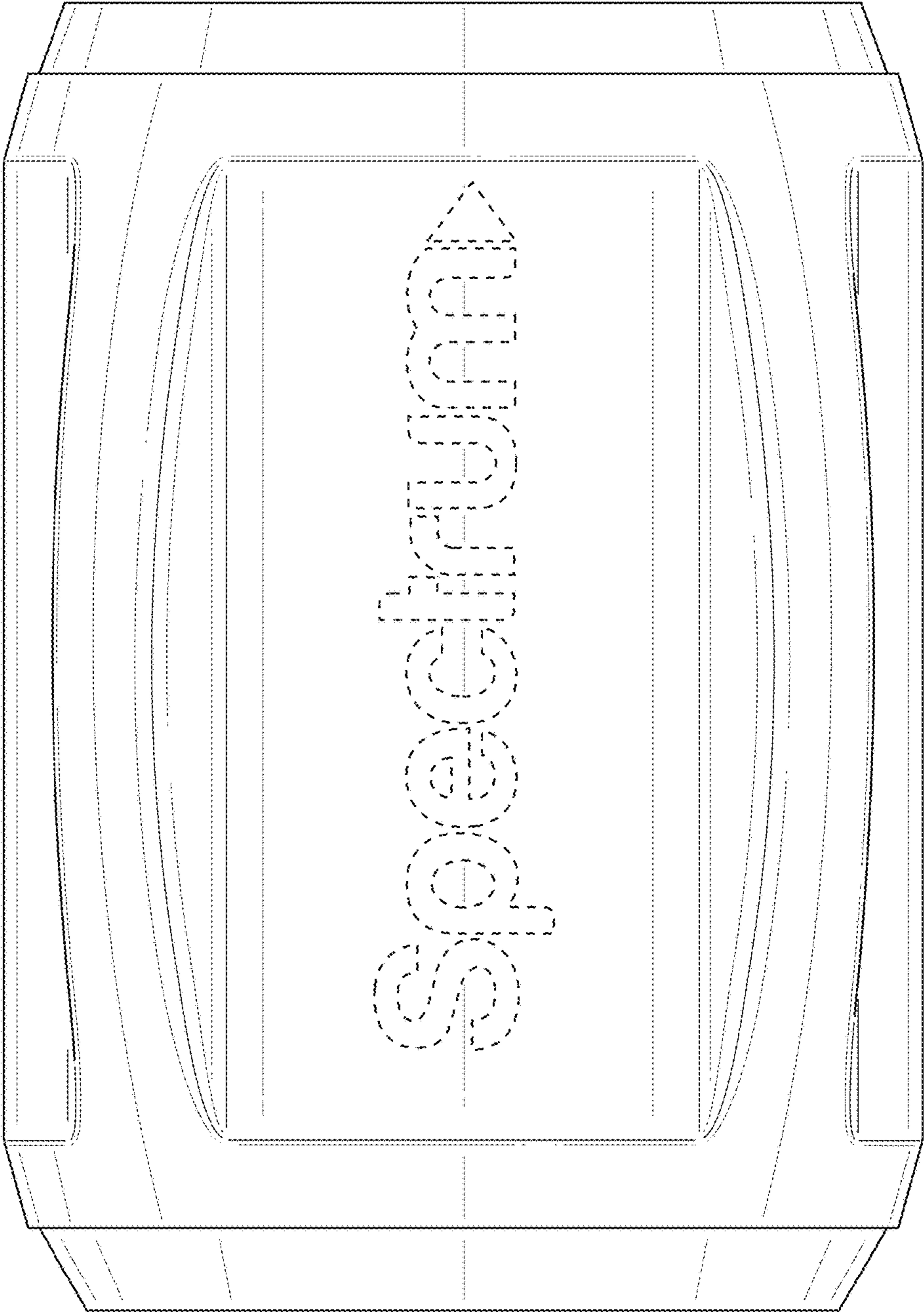


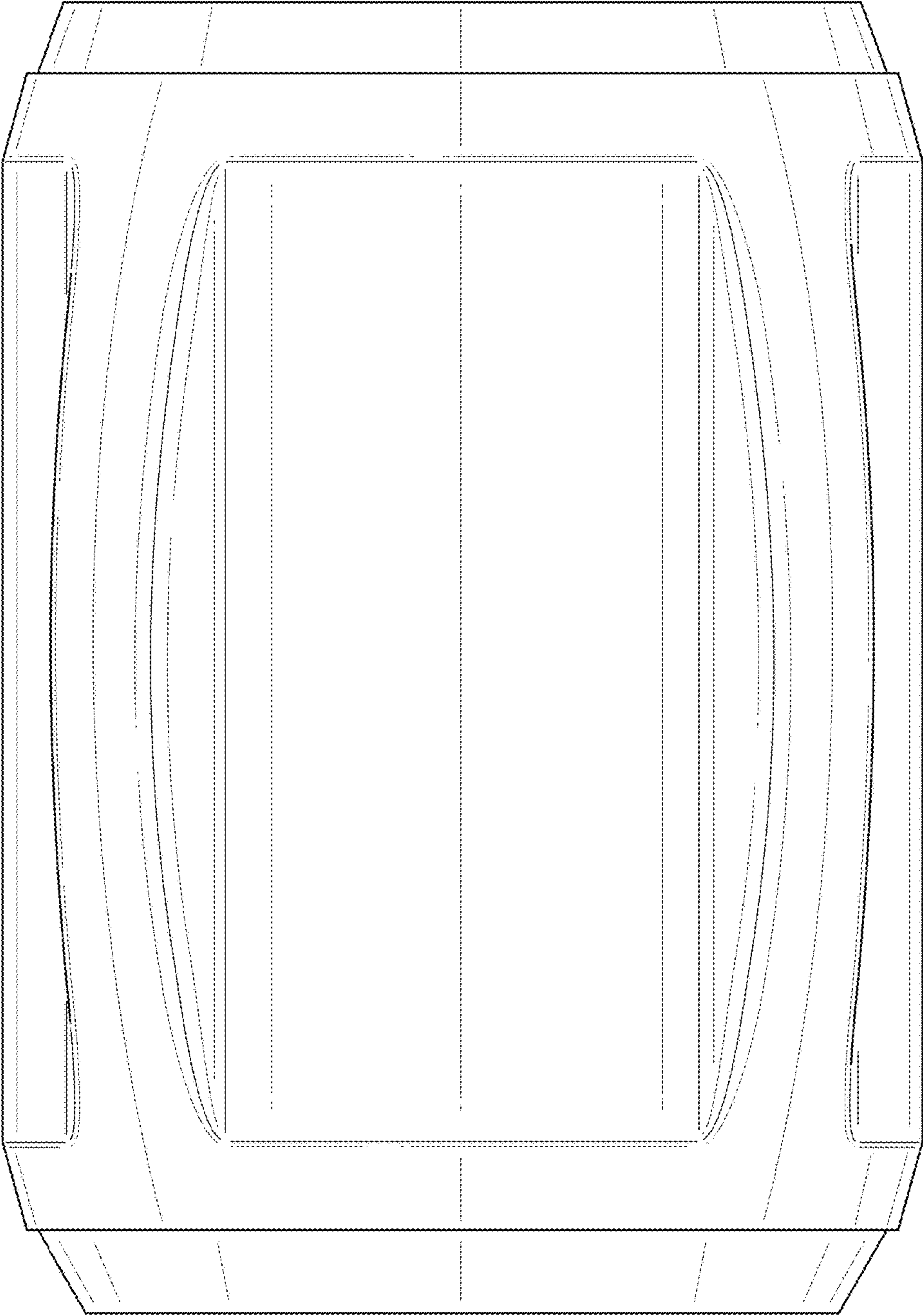

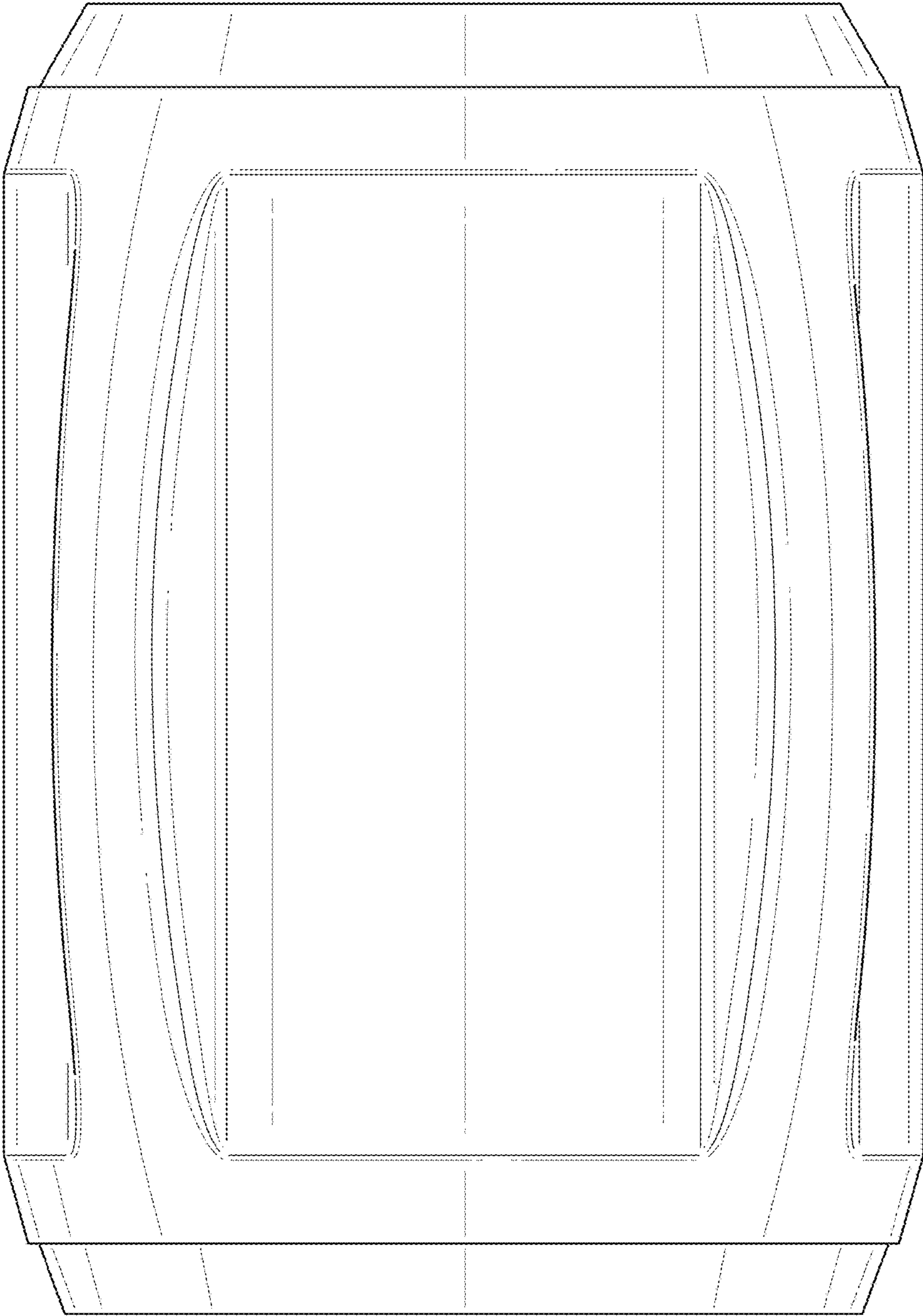
