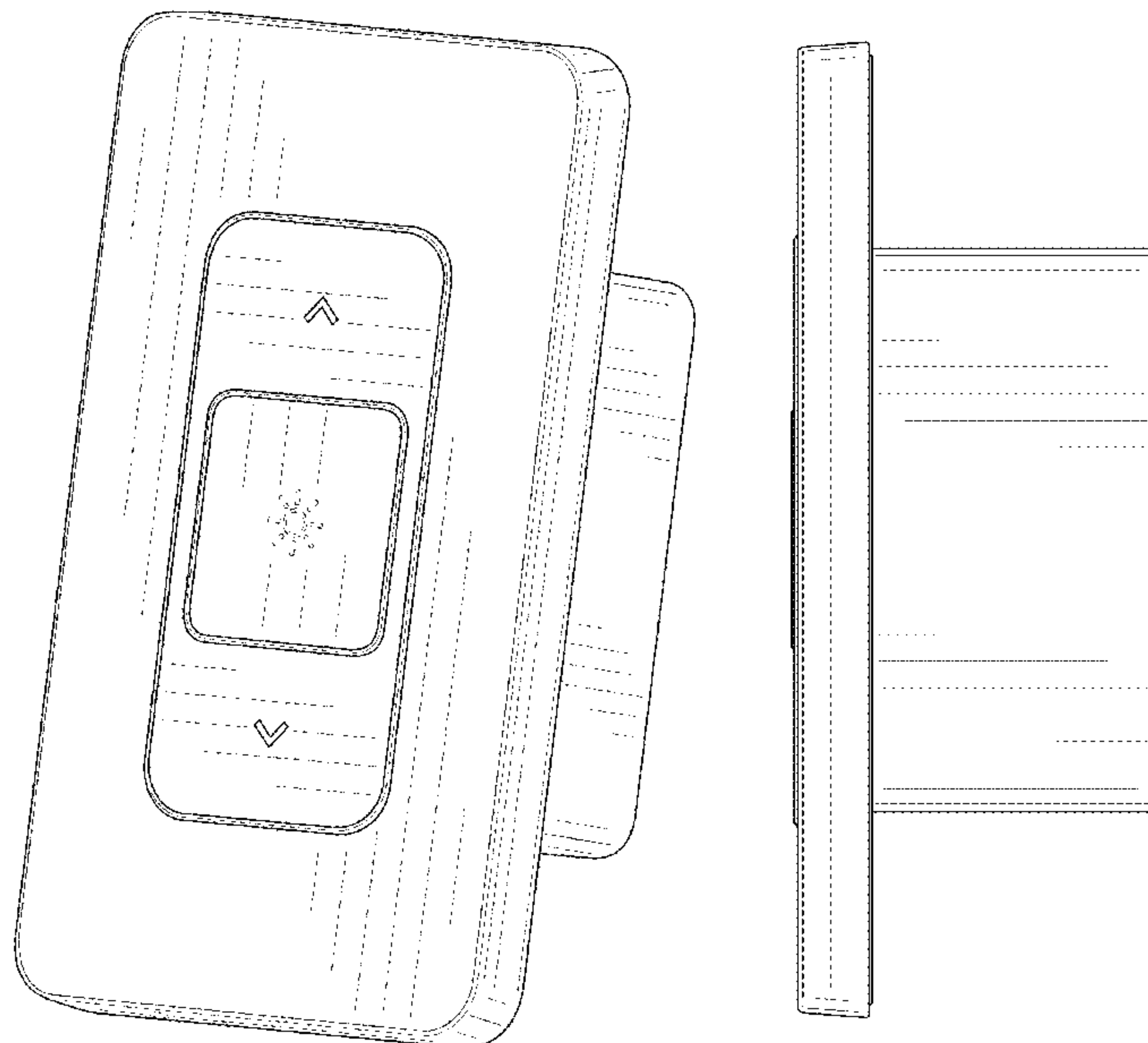

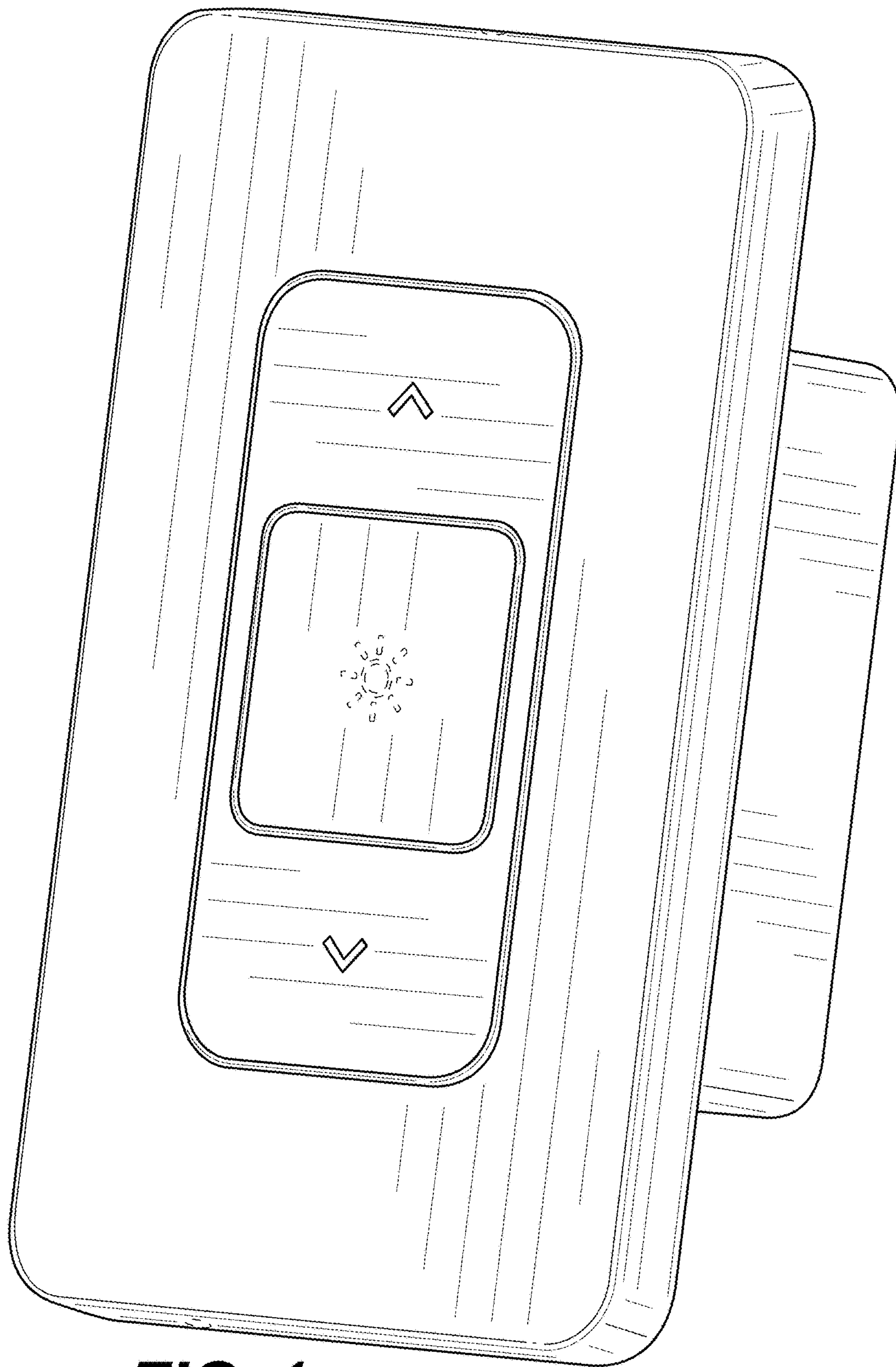
The ornamental design for a switch or a portion thereof, as shown and described.

**DESCRIPTION**

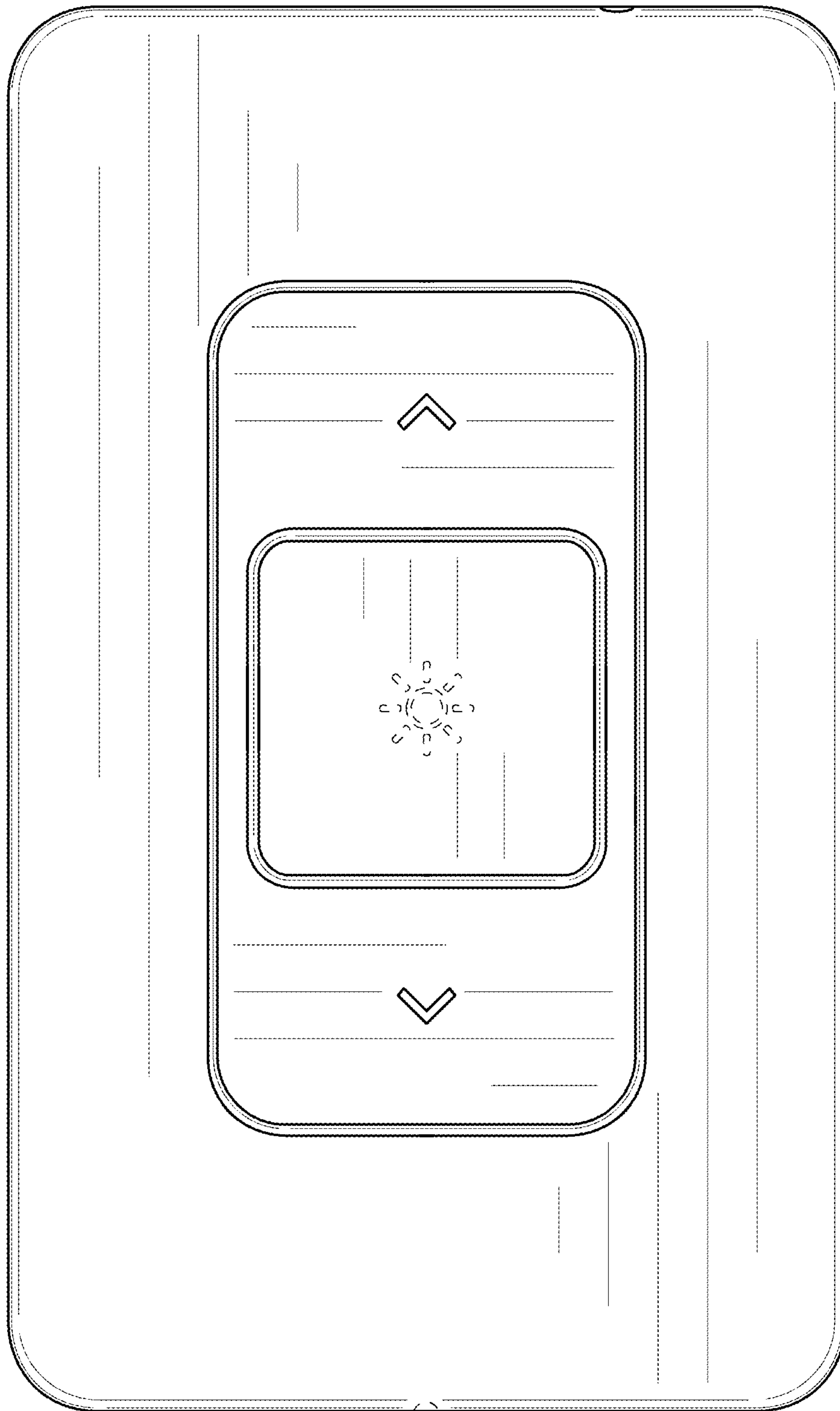
FIG. 1 is a perspective view of a switch showing our new design;

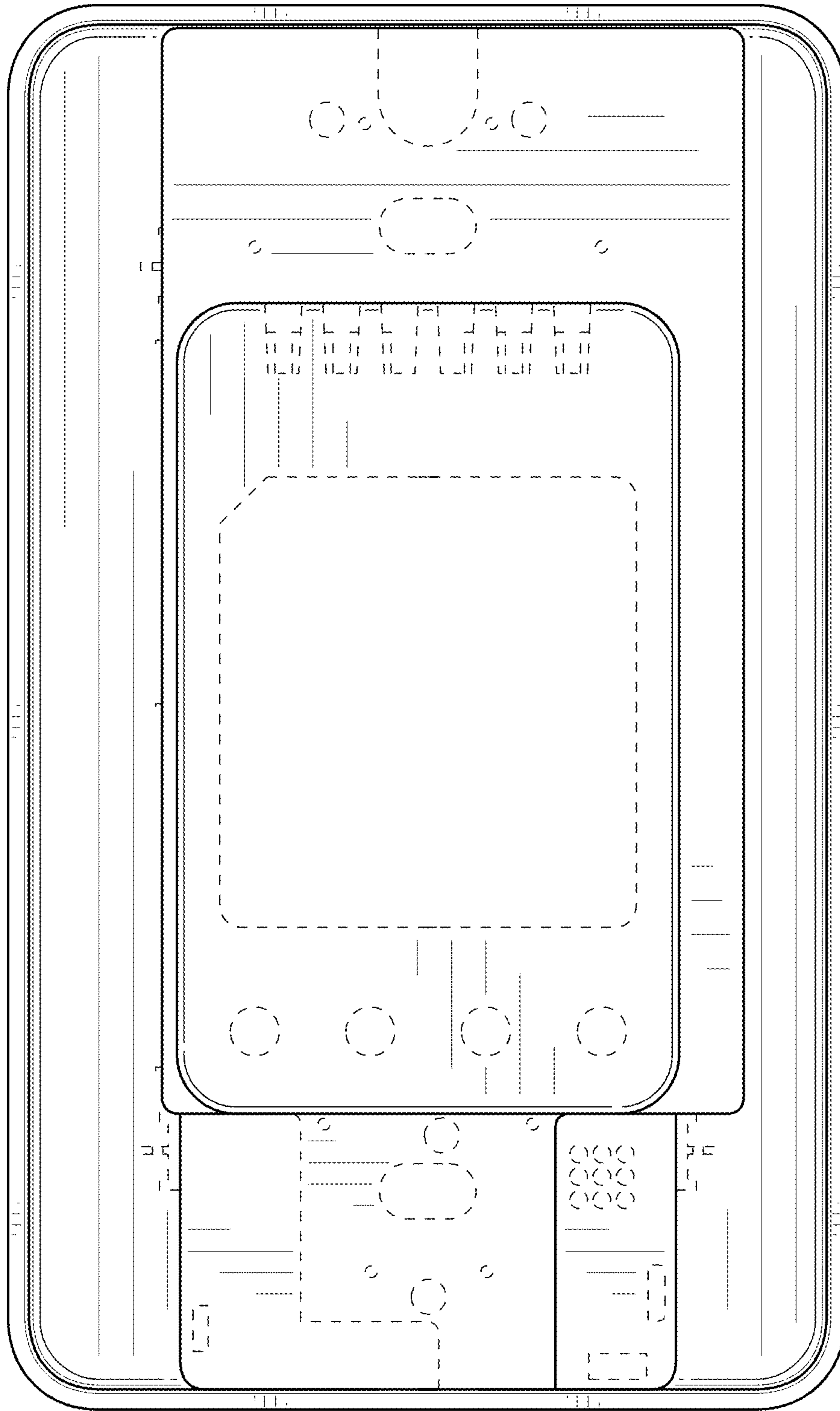

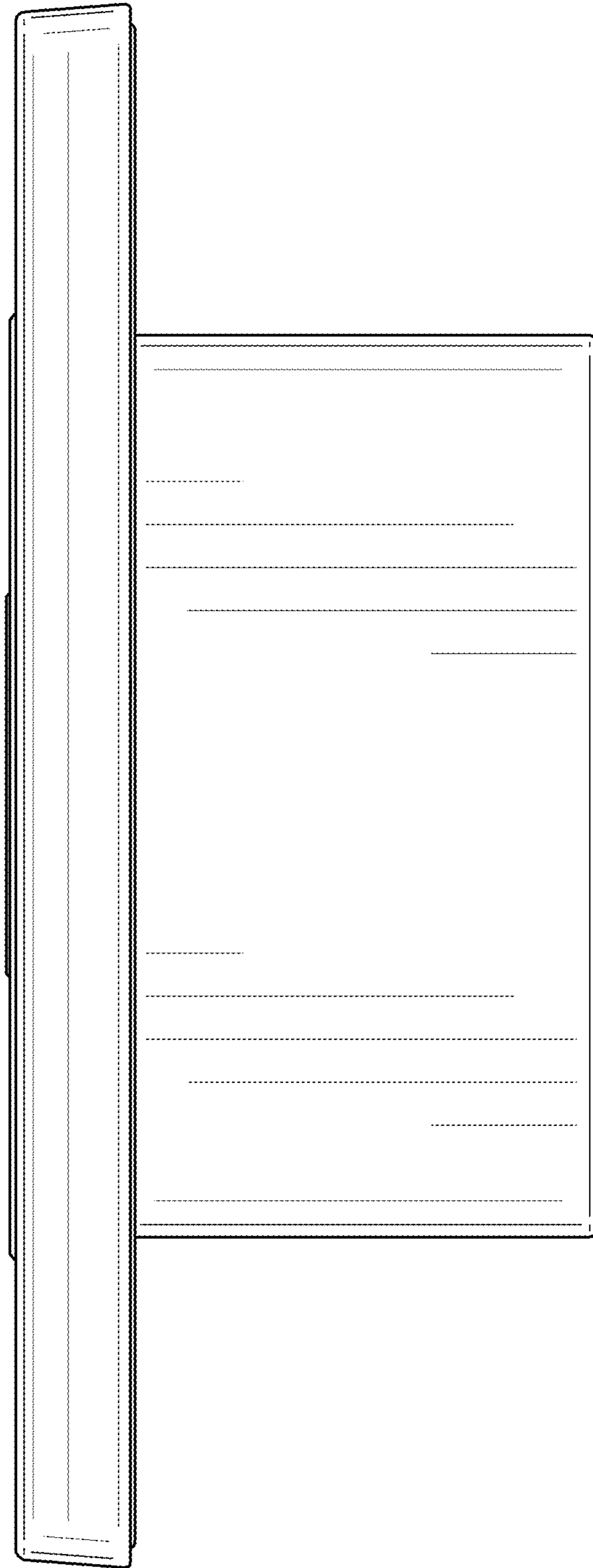

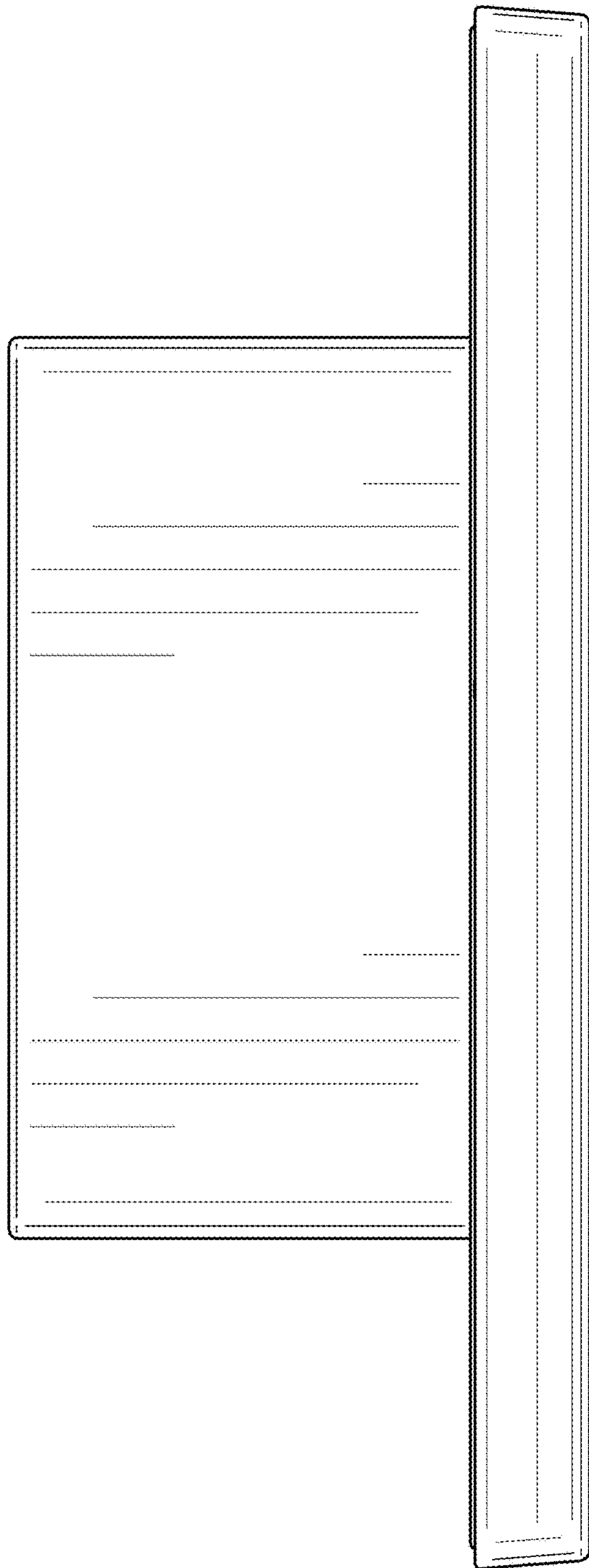

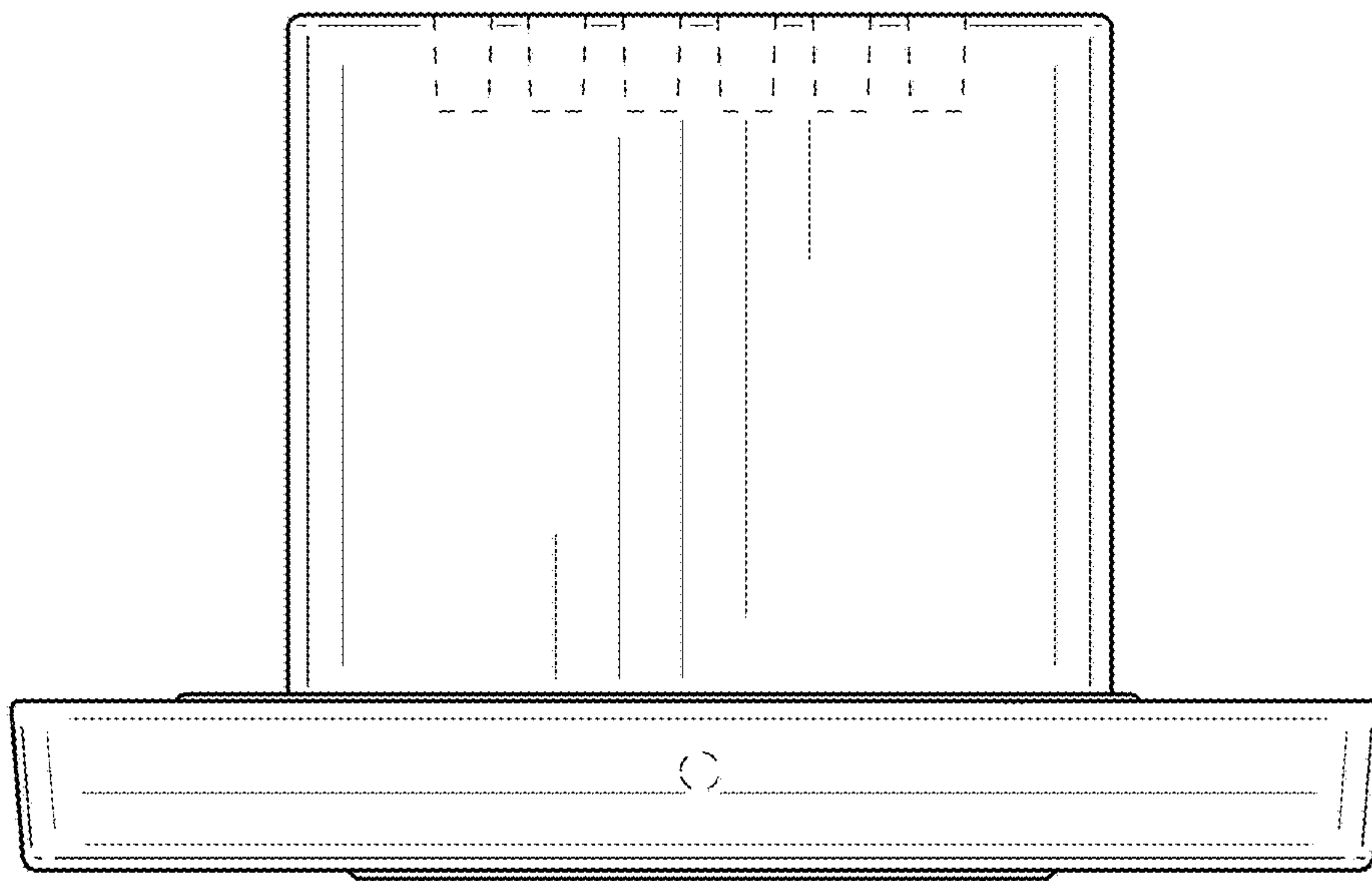




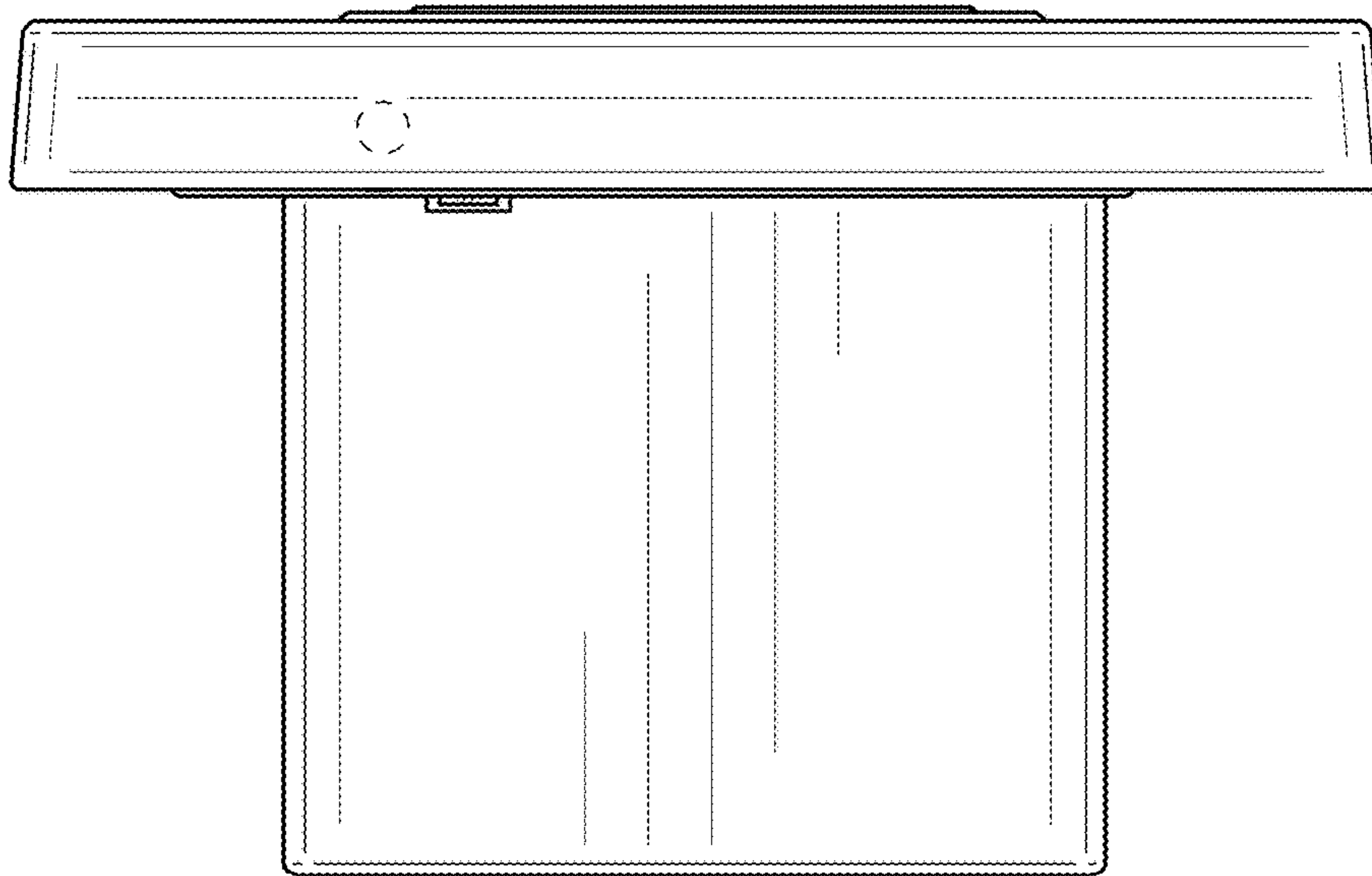
