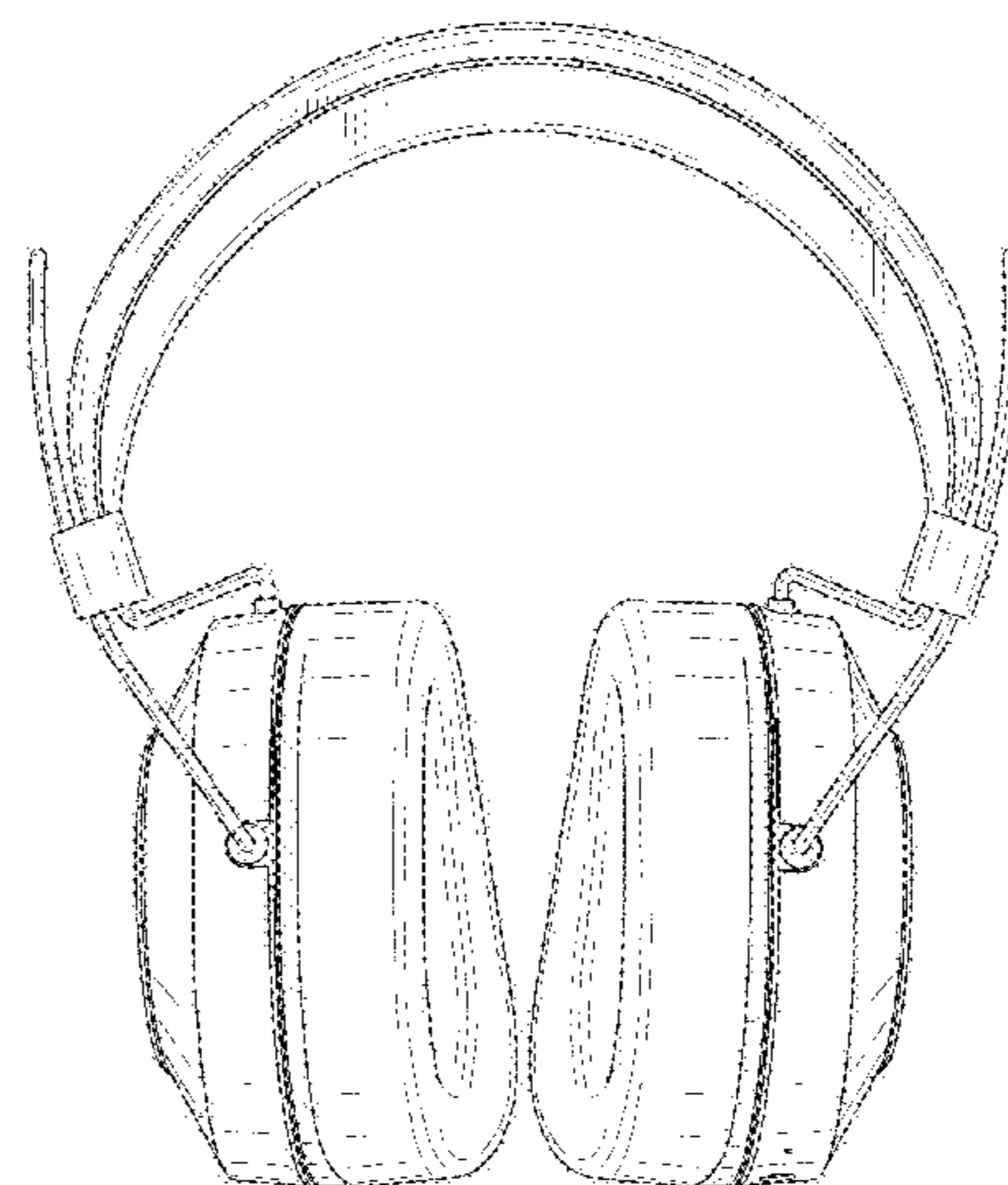
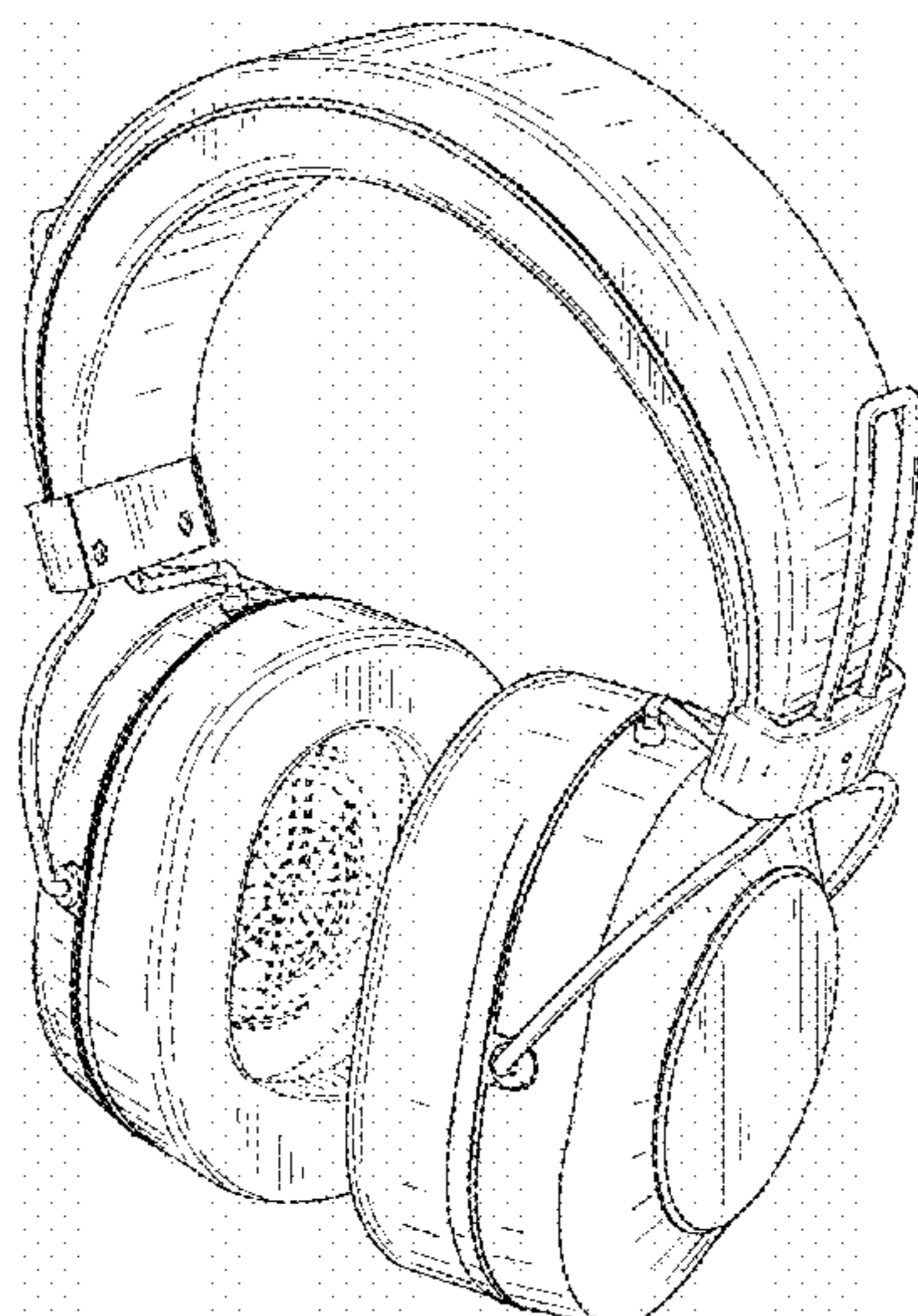
(57) **CLAIM**

The ornamental design for headphones, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right perspective view of a first embodiment of headphones showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side elevation view thereof; FIG. 7 is a right side elevation view thereof; FIG. 8 is a top, front, right perspective view of a second embodiment of headphones showing my new design; FIG. 9 is a front elevation view thereof; FIG. 10 is a rear elevation view thereof; FIG. 11 is a top plan view thereof; FIG. 12 is a bottom plan view thereof; FIG. 13 is a left side elevation view thereof; and, FIG. 14 is a right side elevation view thereof. The broken lines depict portions of the headphones that form no part of the claimed design.

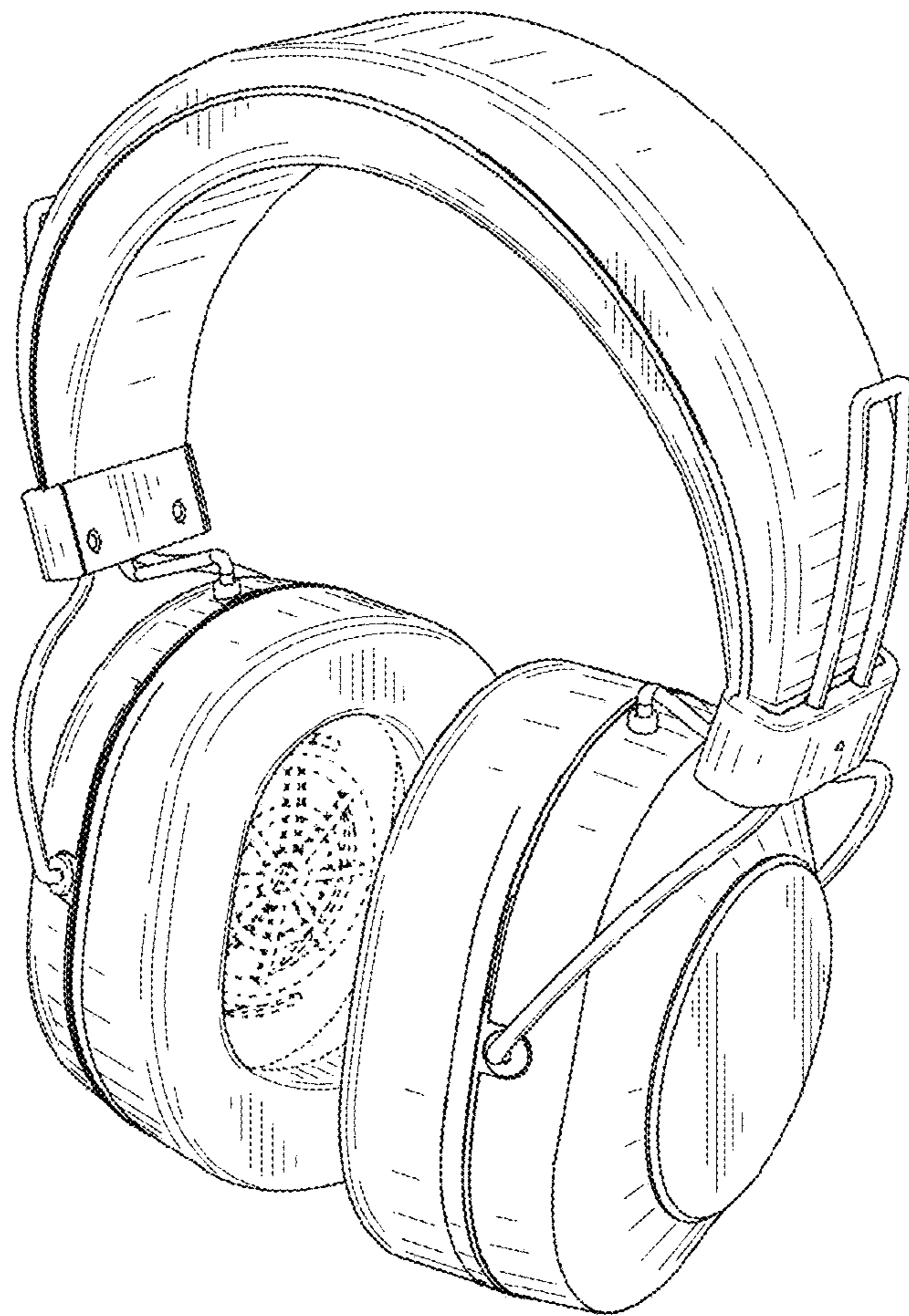

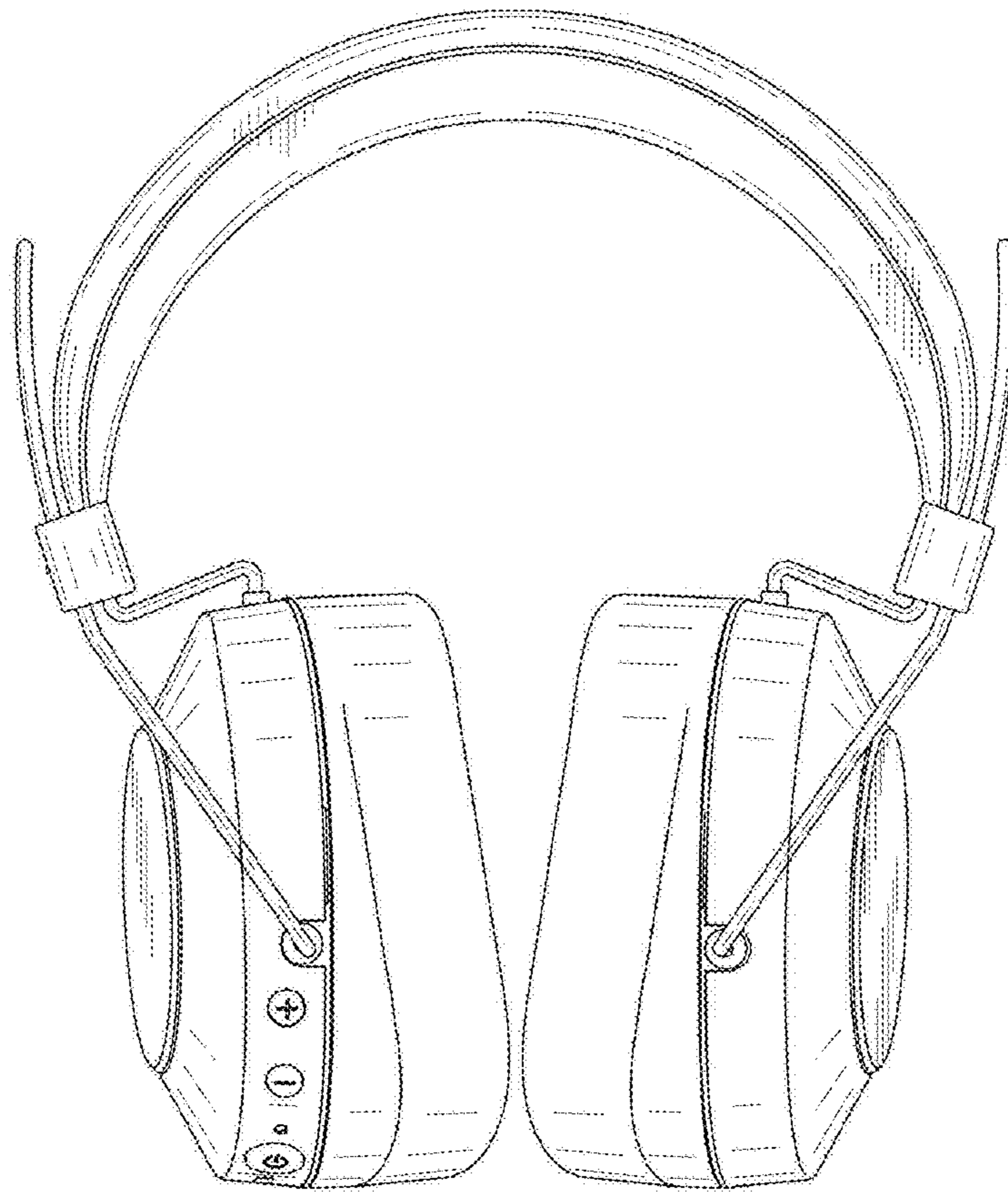

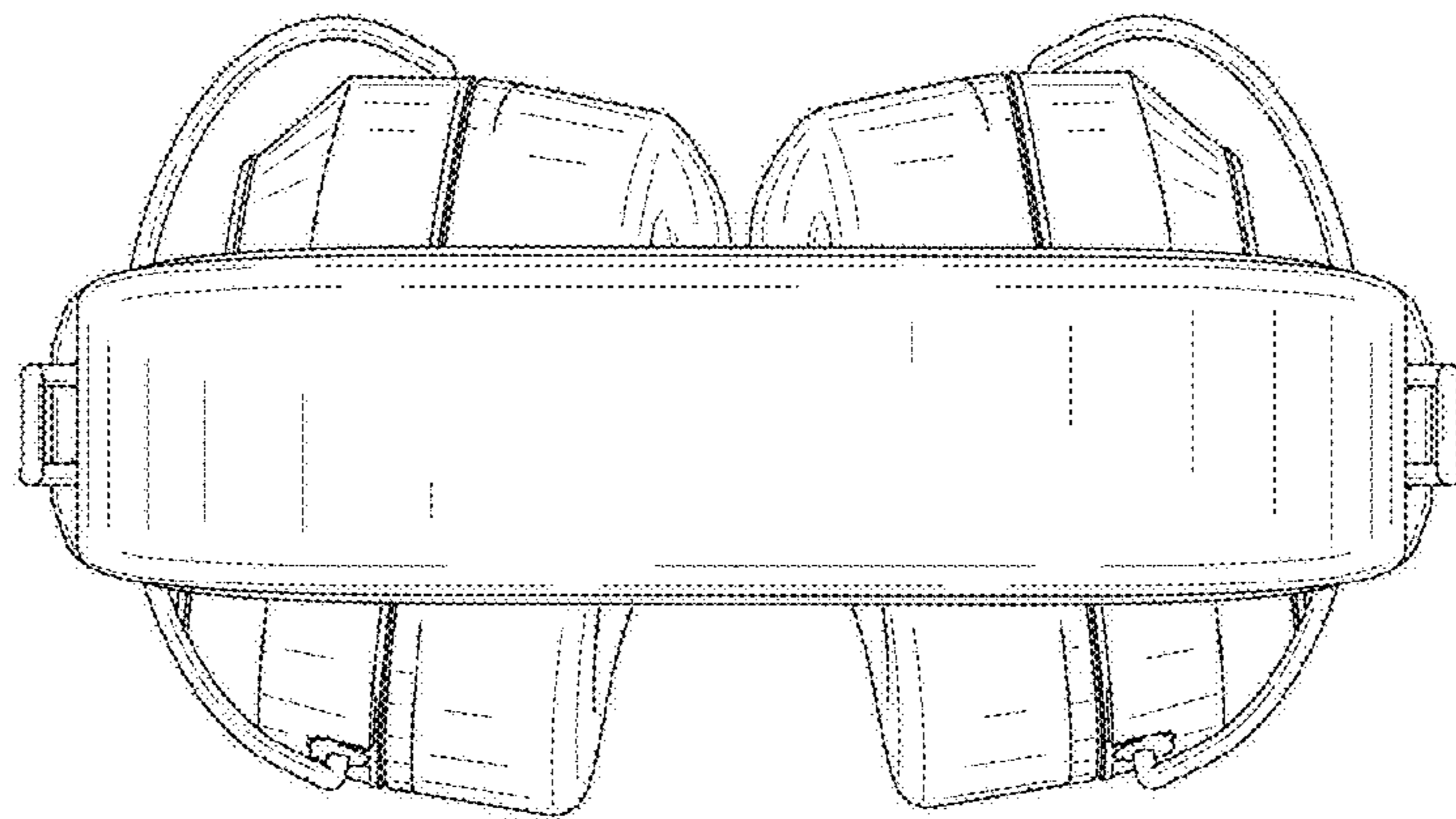

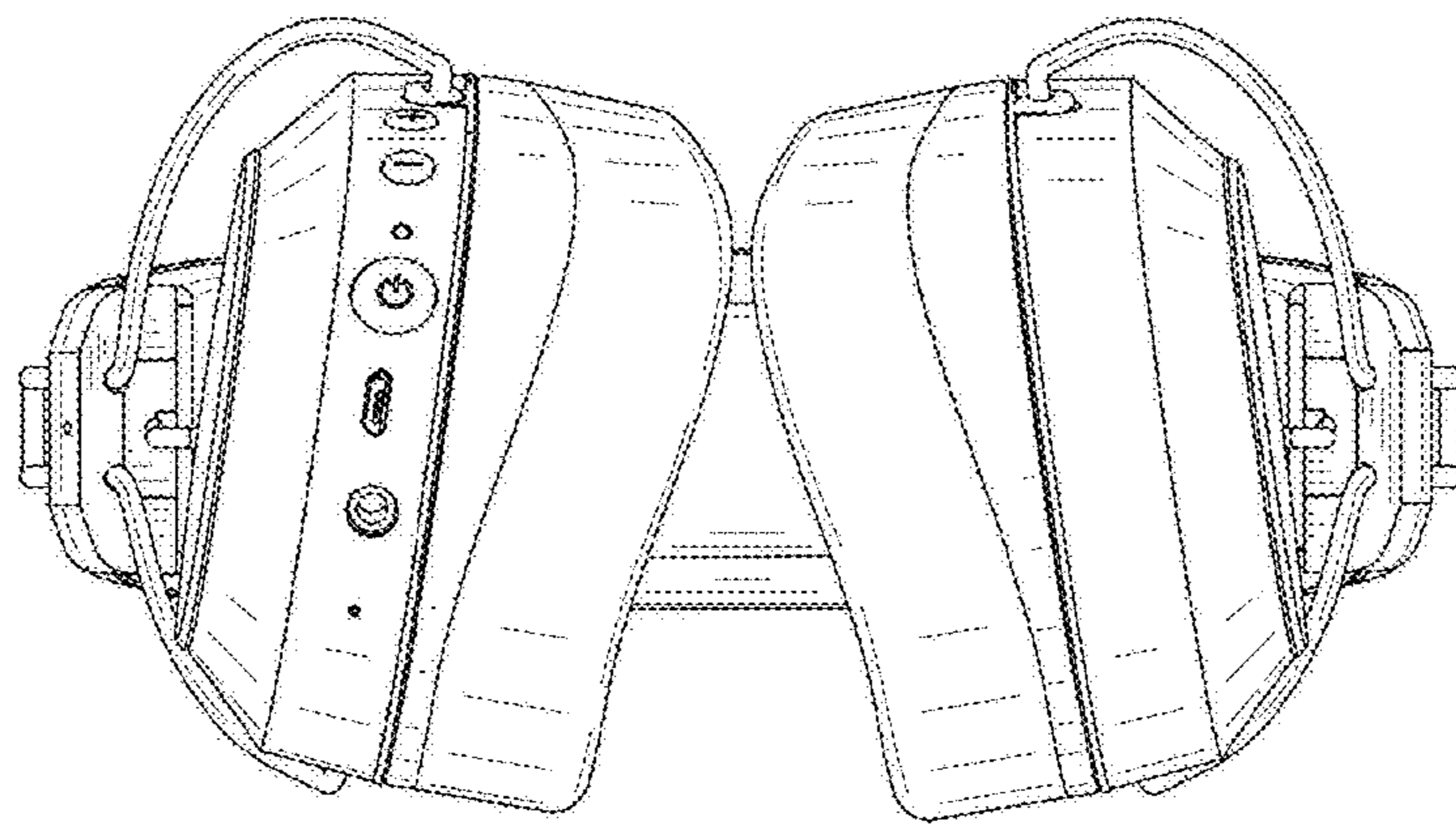

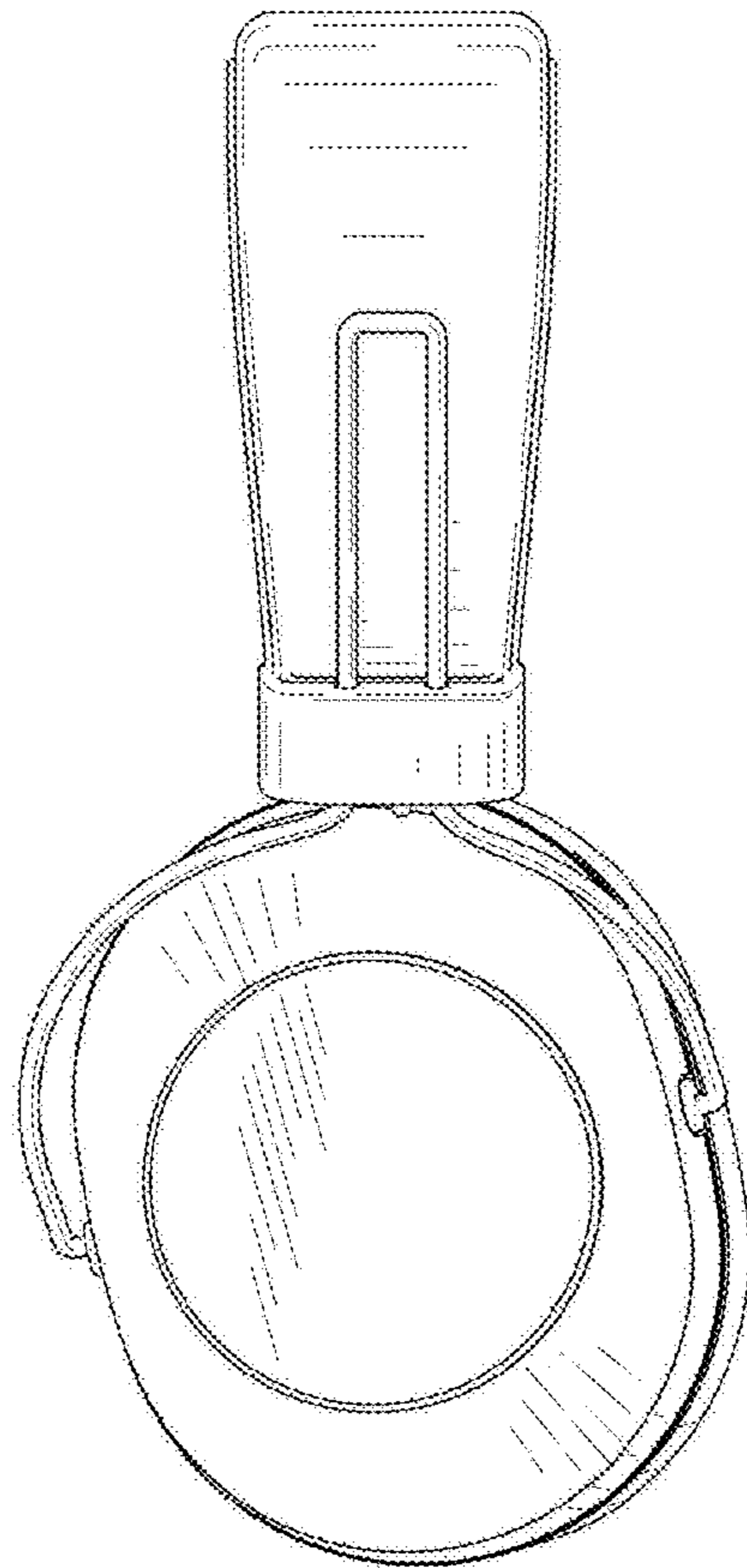

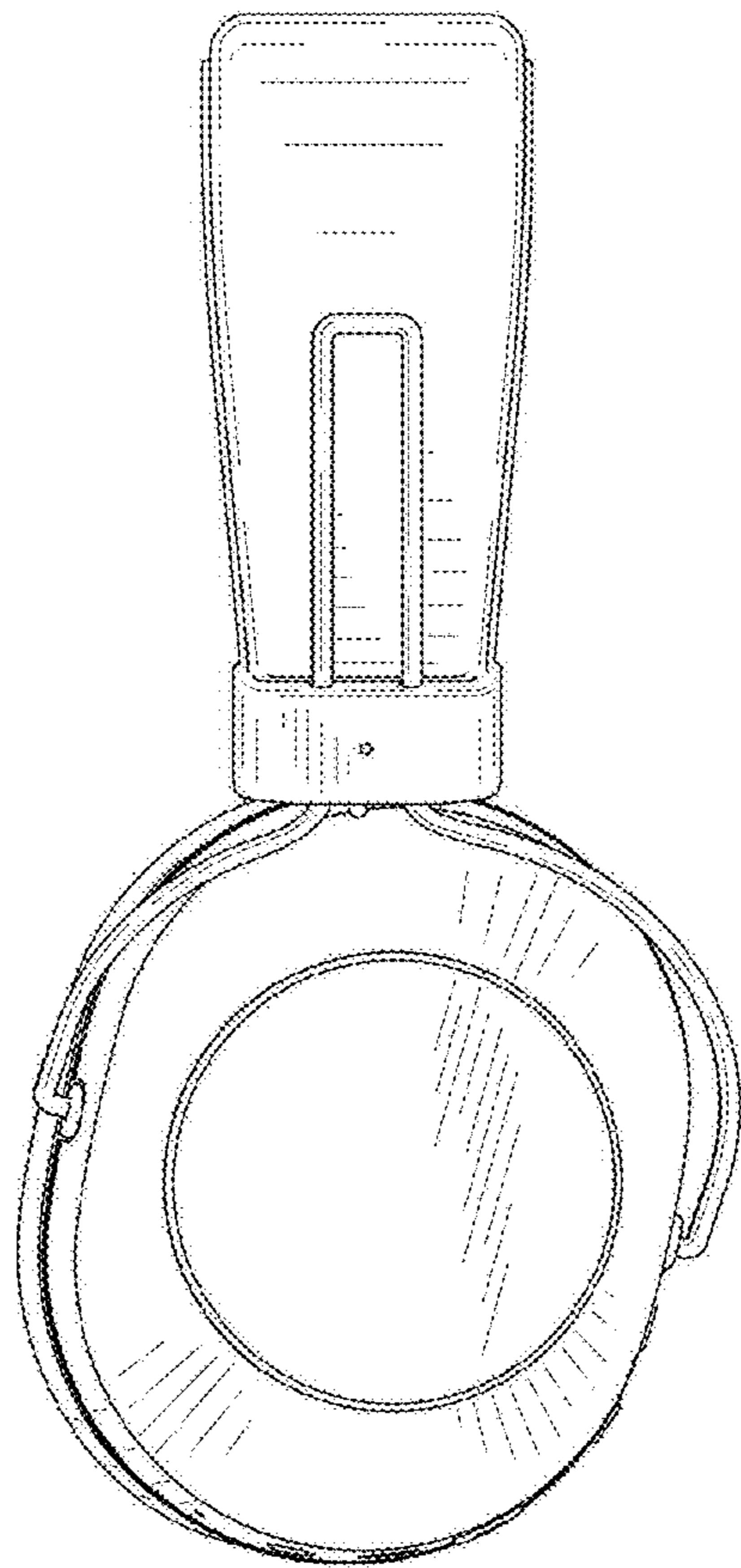

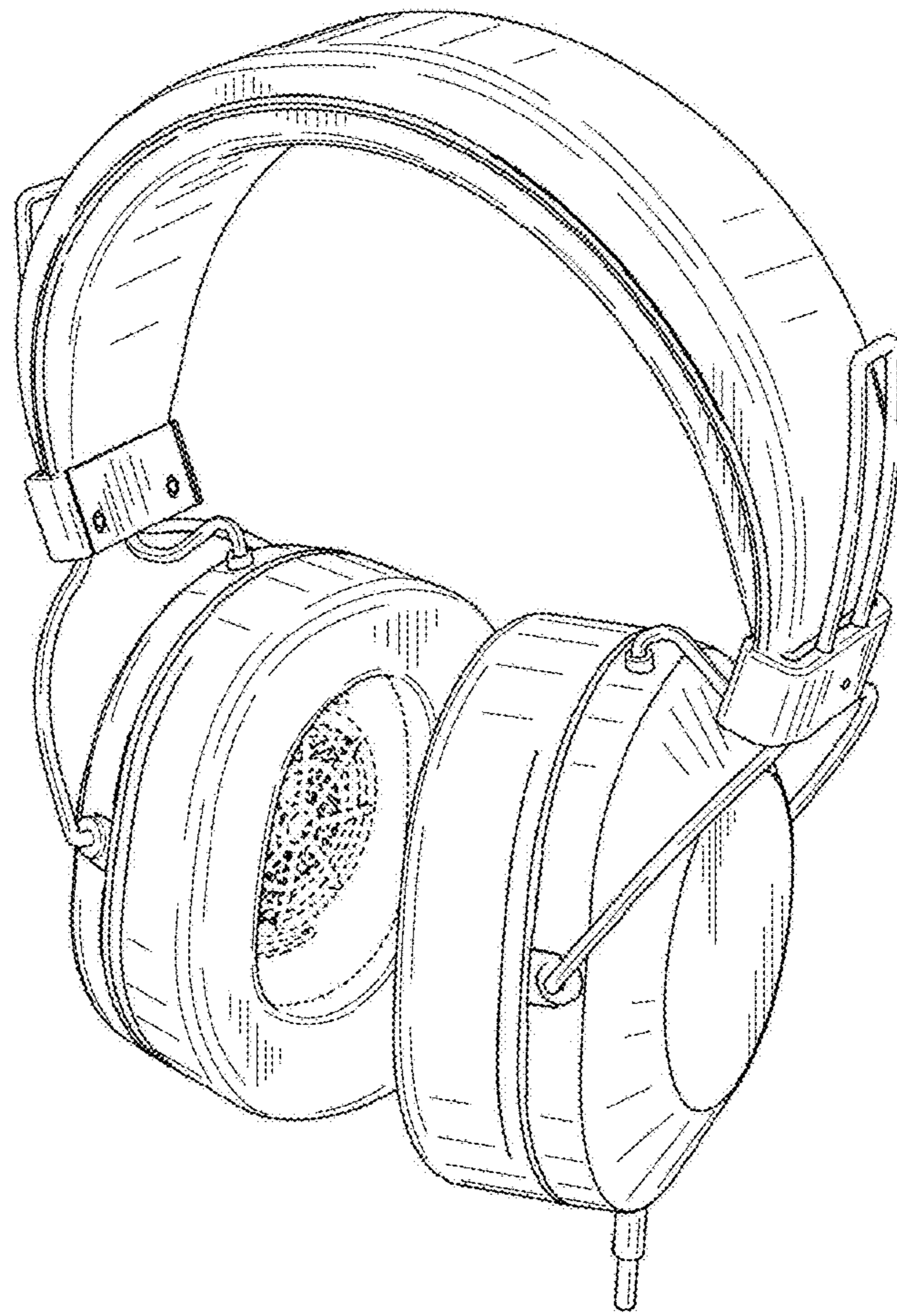

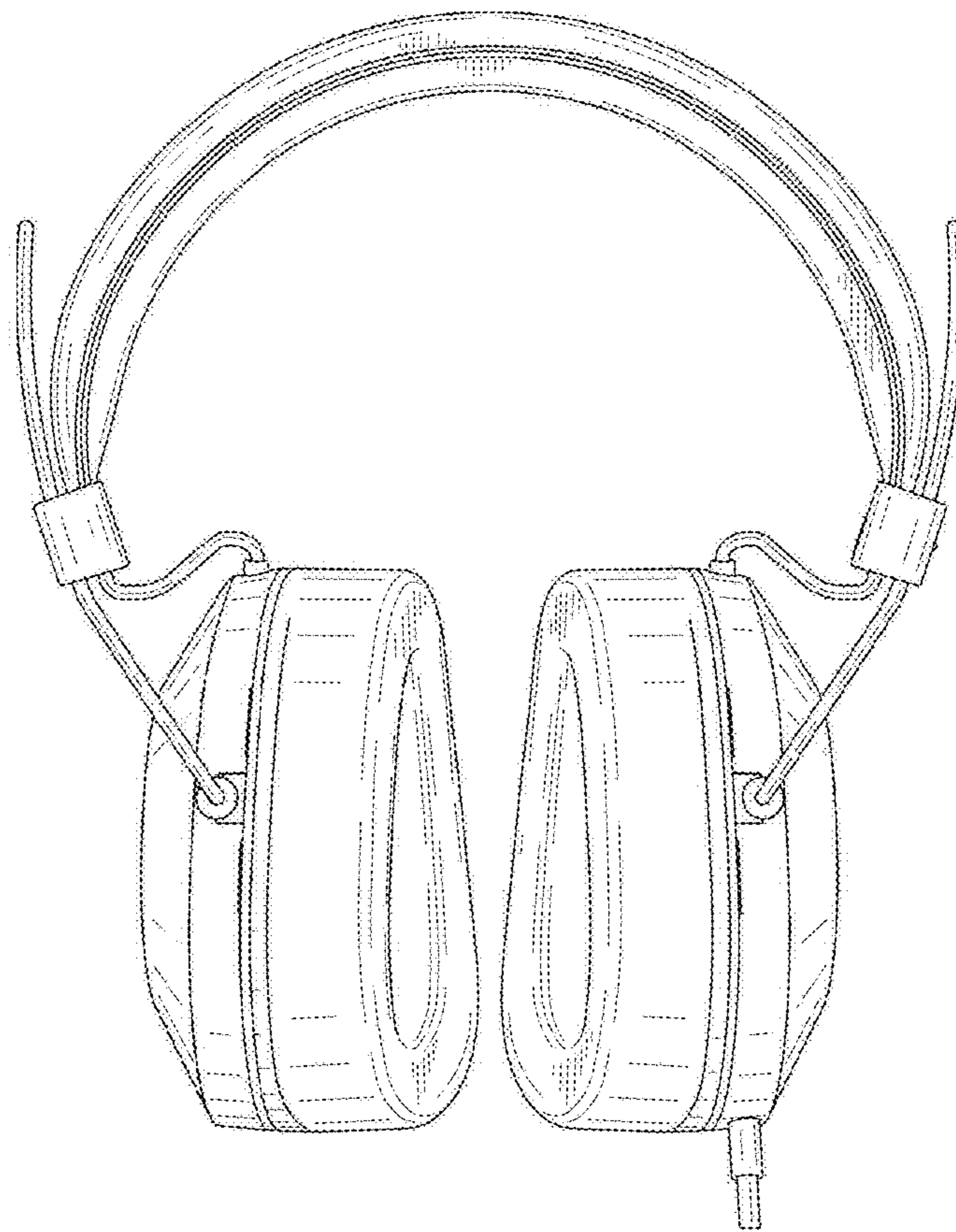

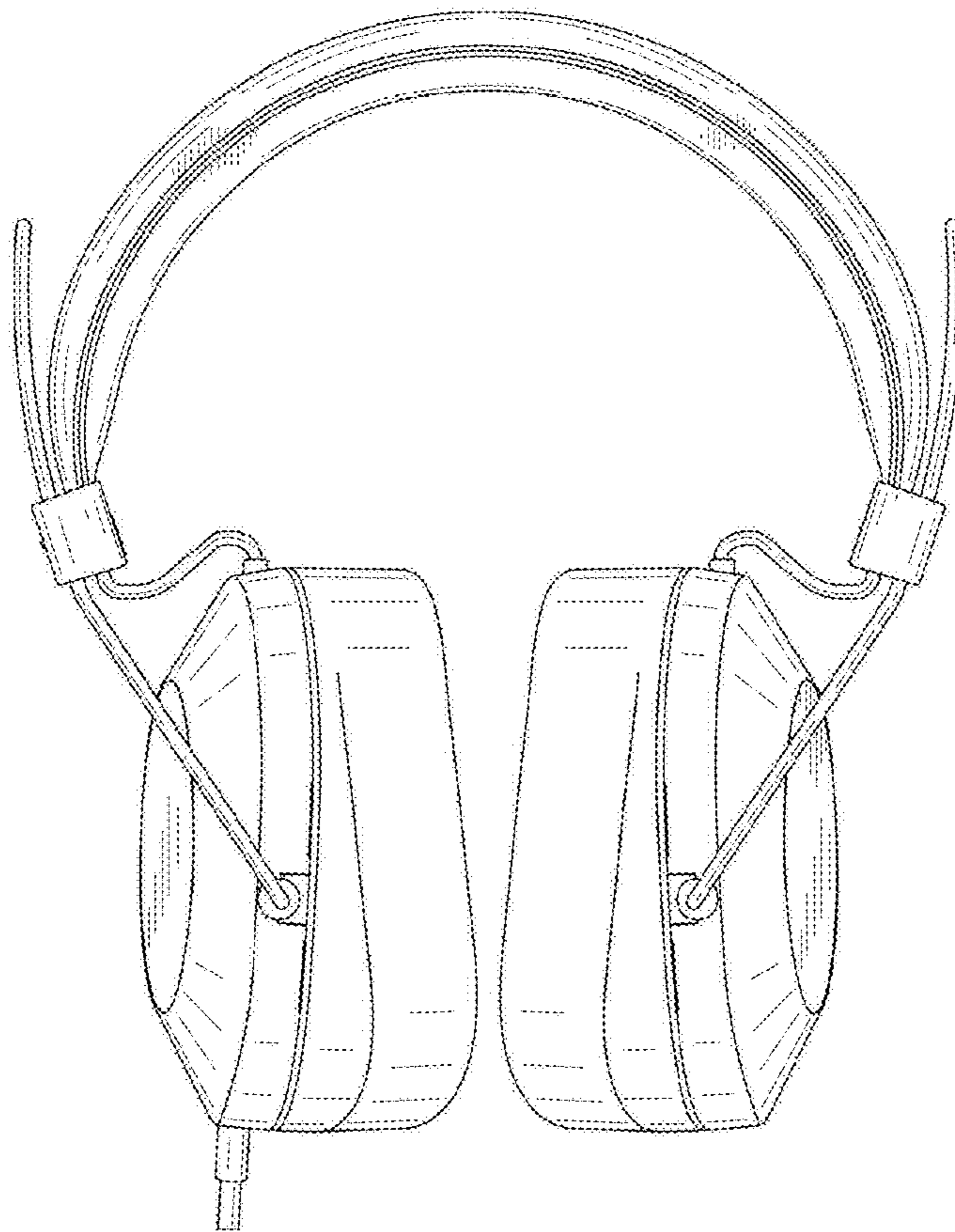

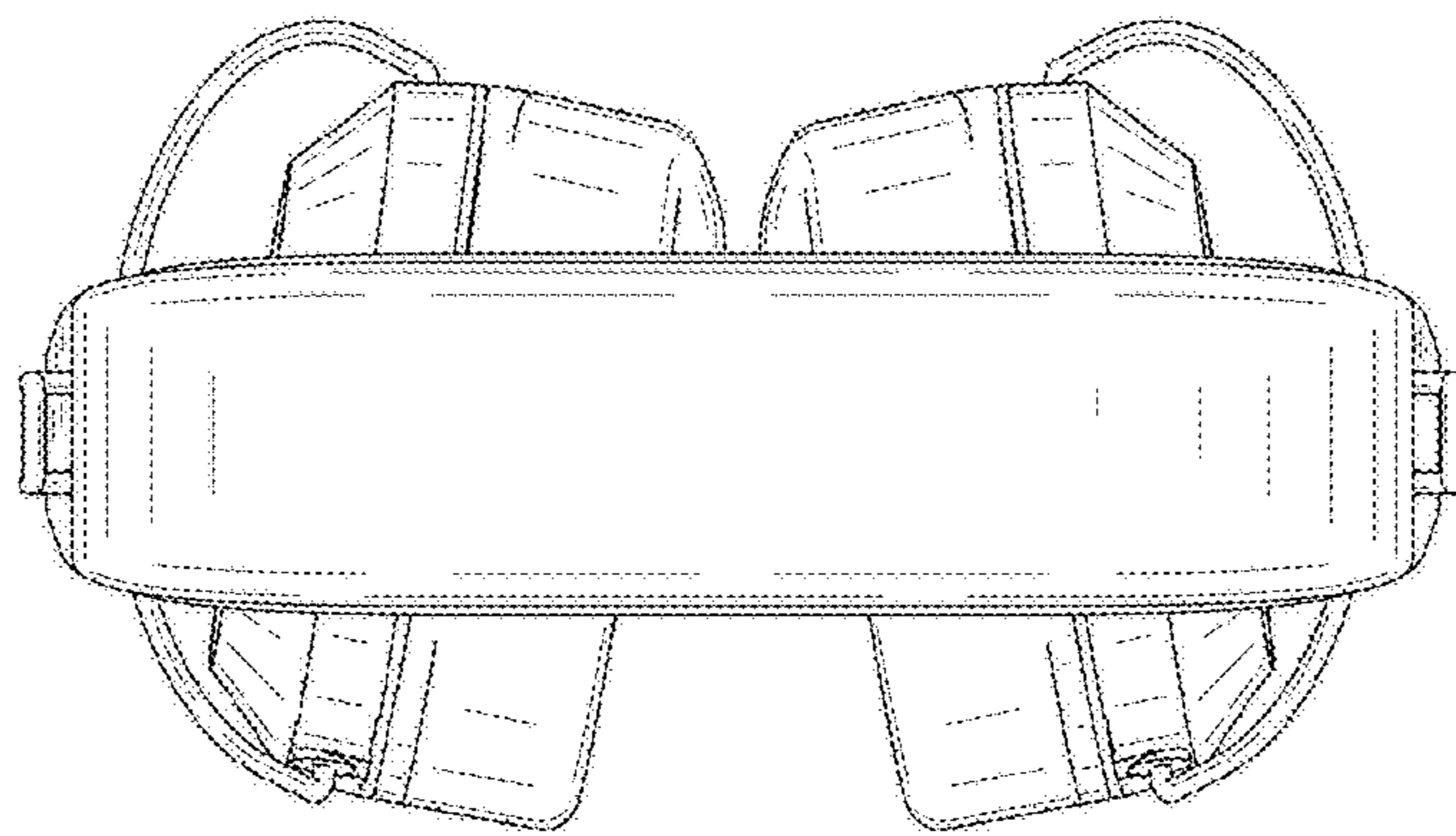

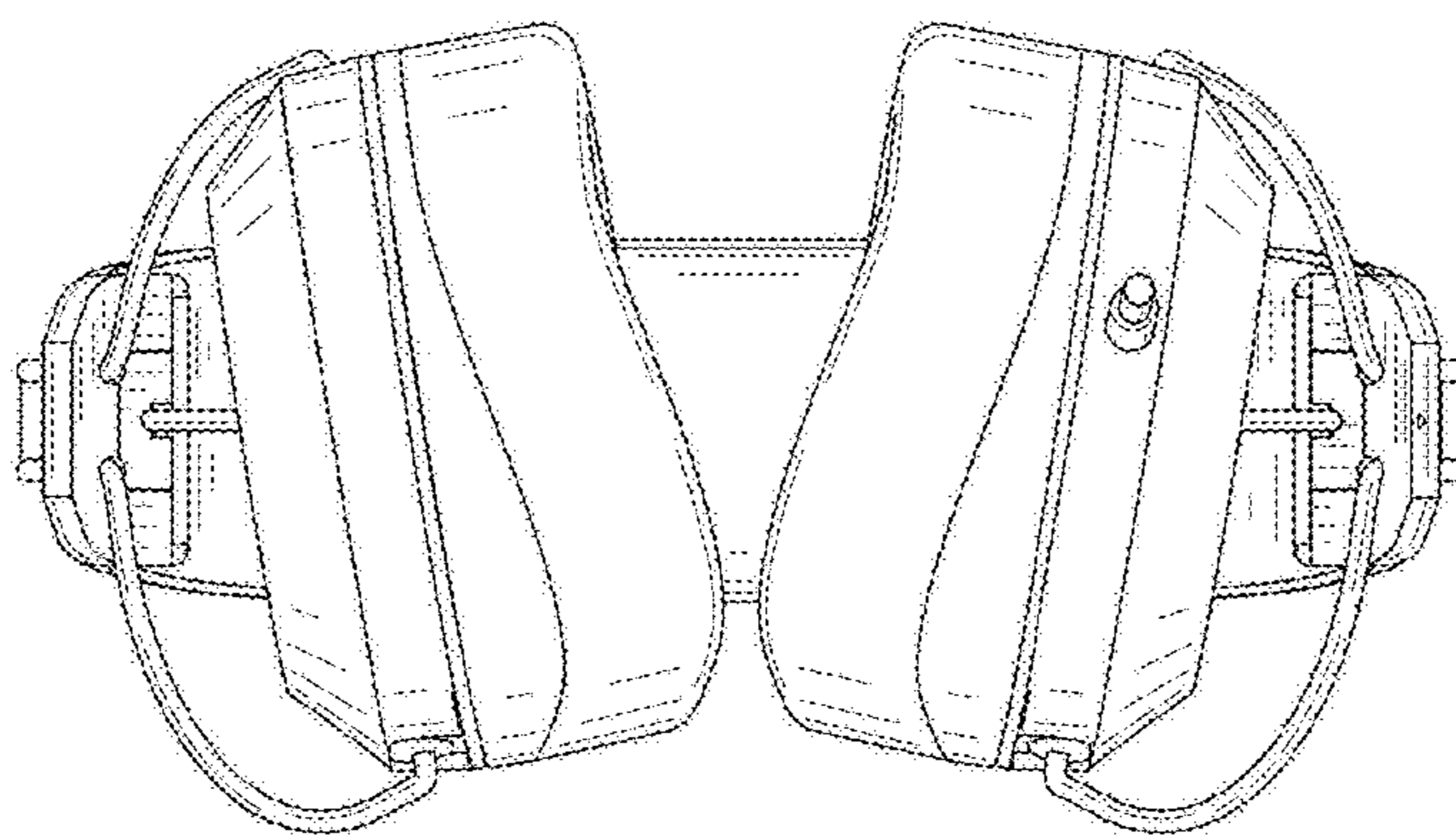

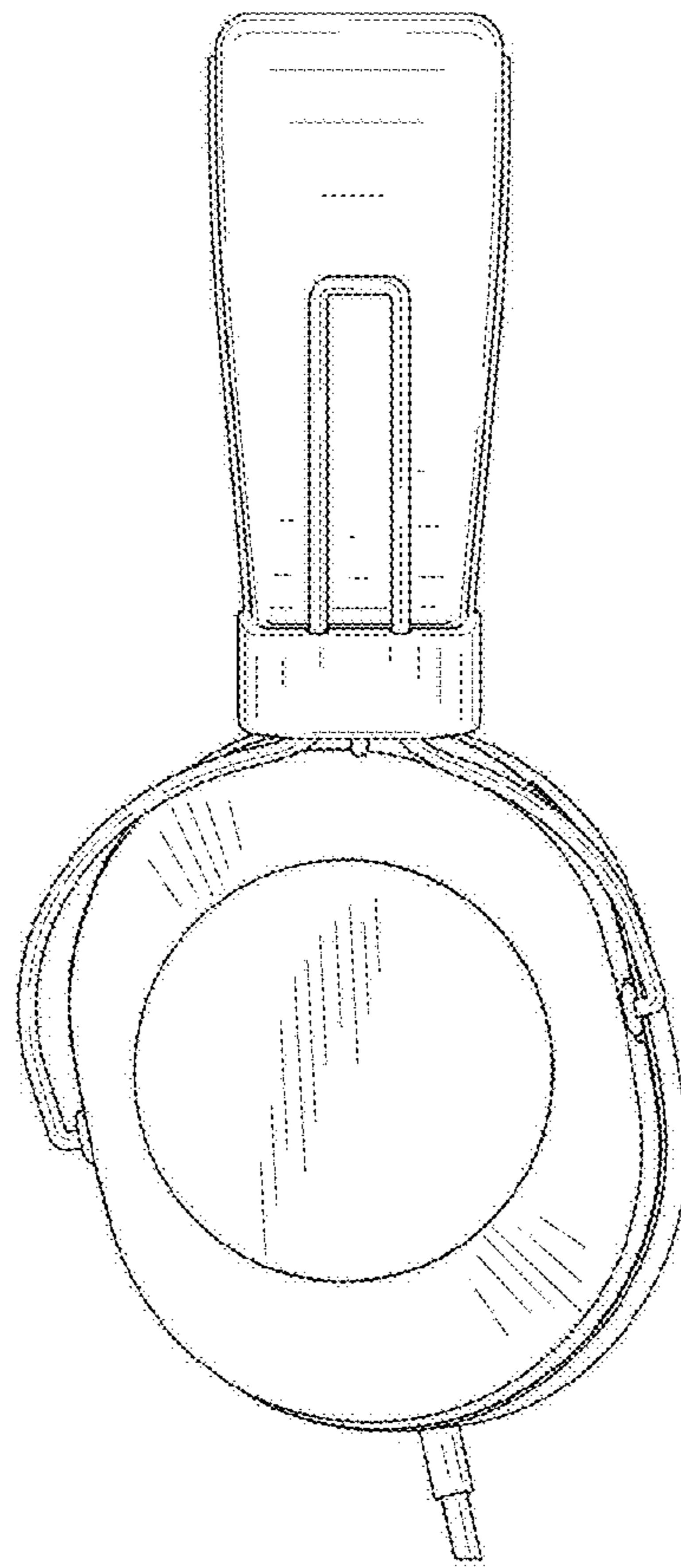

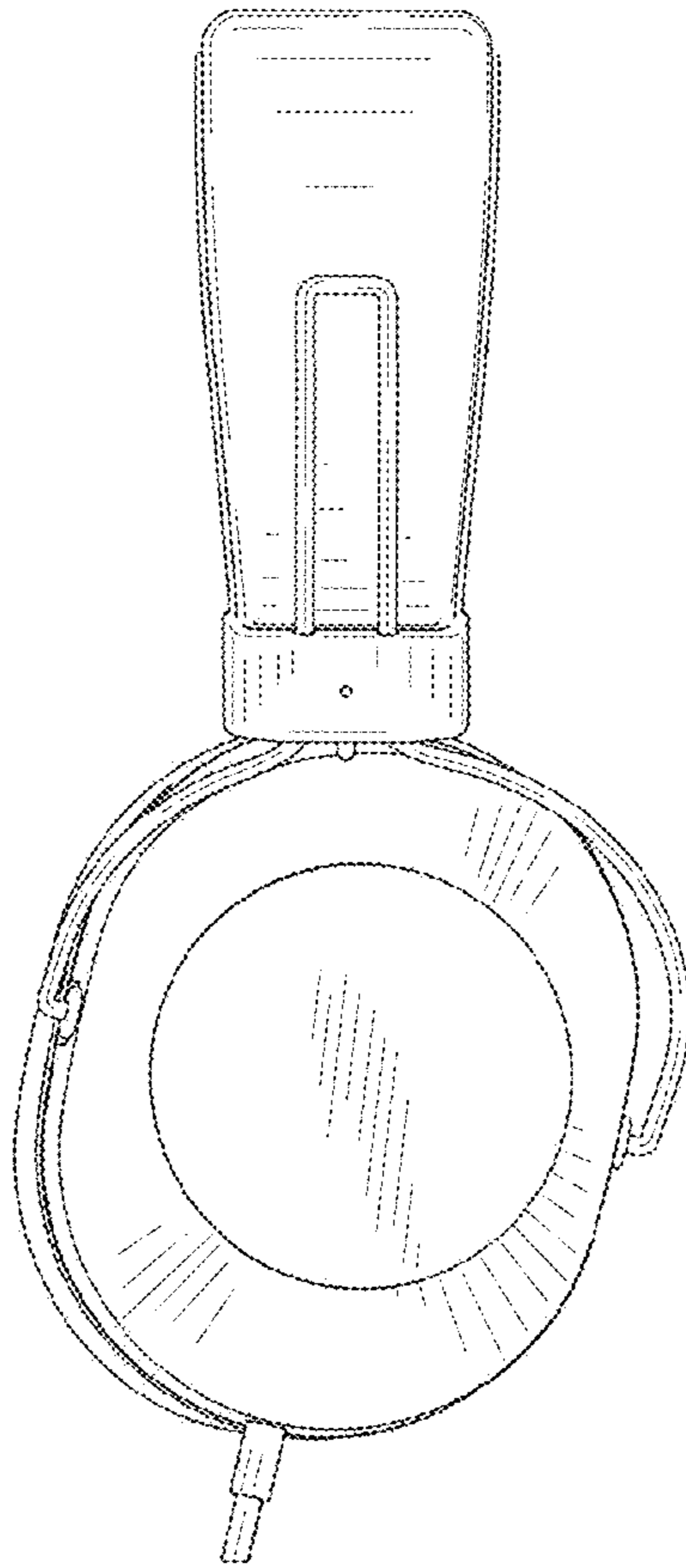
