The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

FIG. 8 is a eighth image thereof;

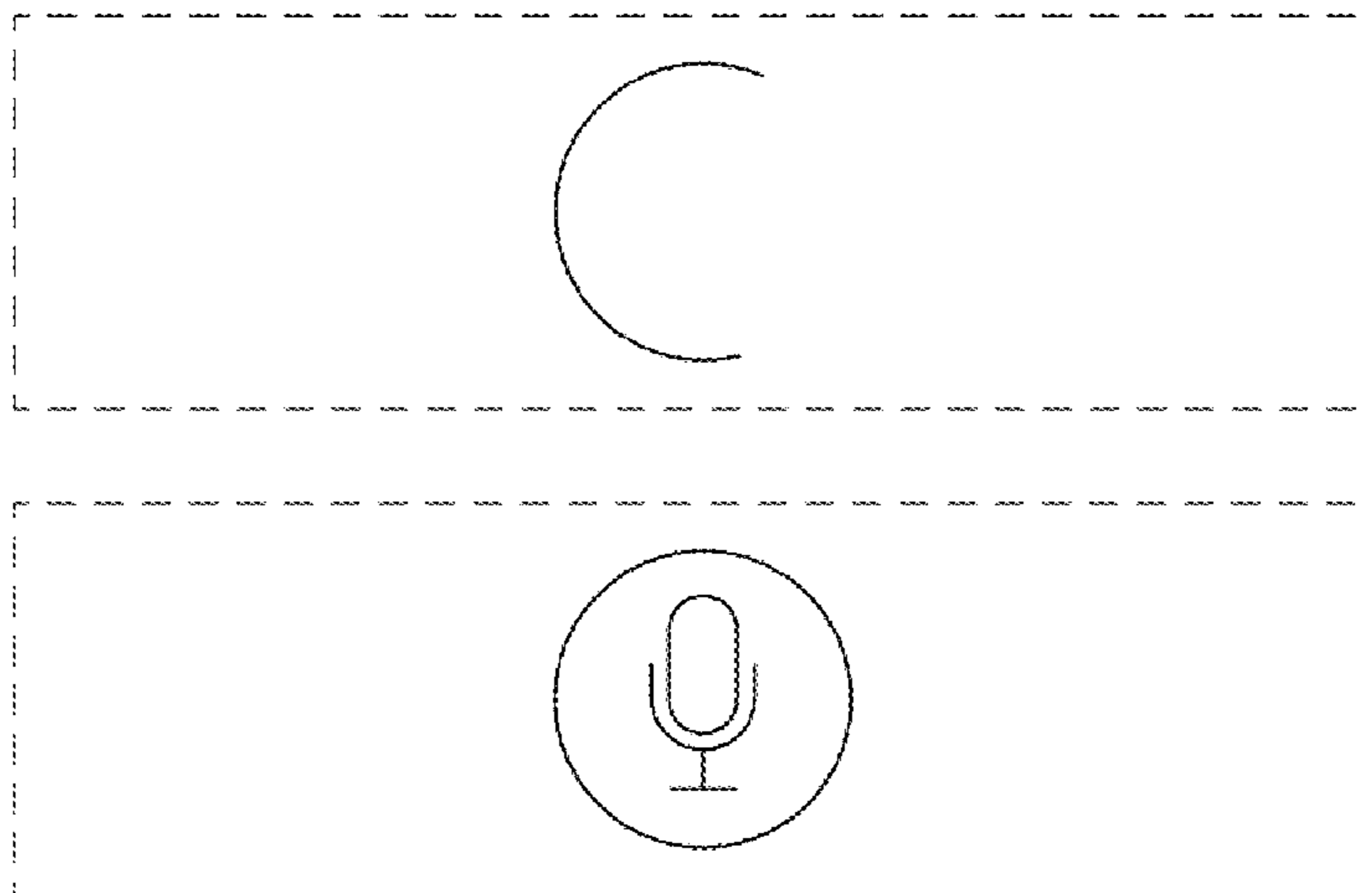
FIG. 9 is a ninth image thereof; and,

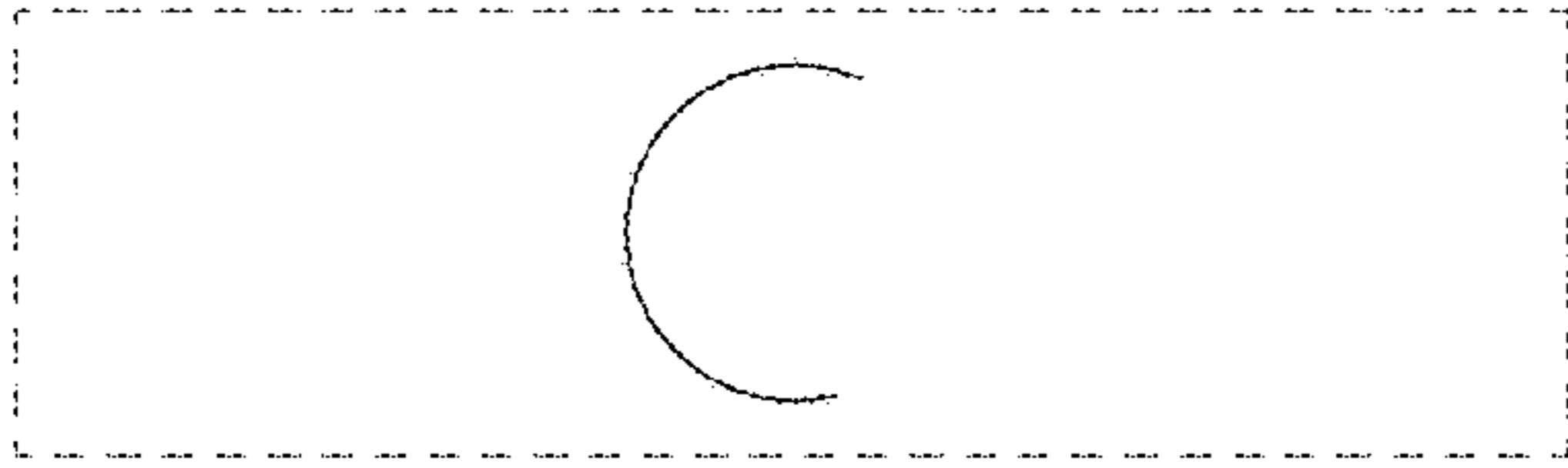

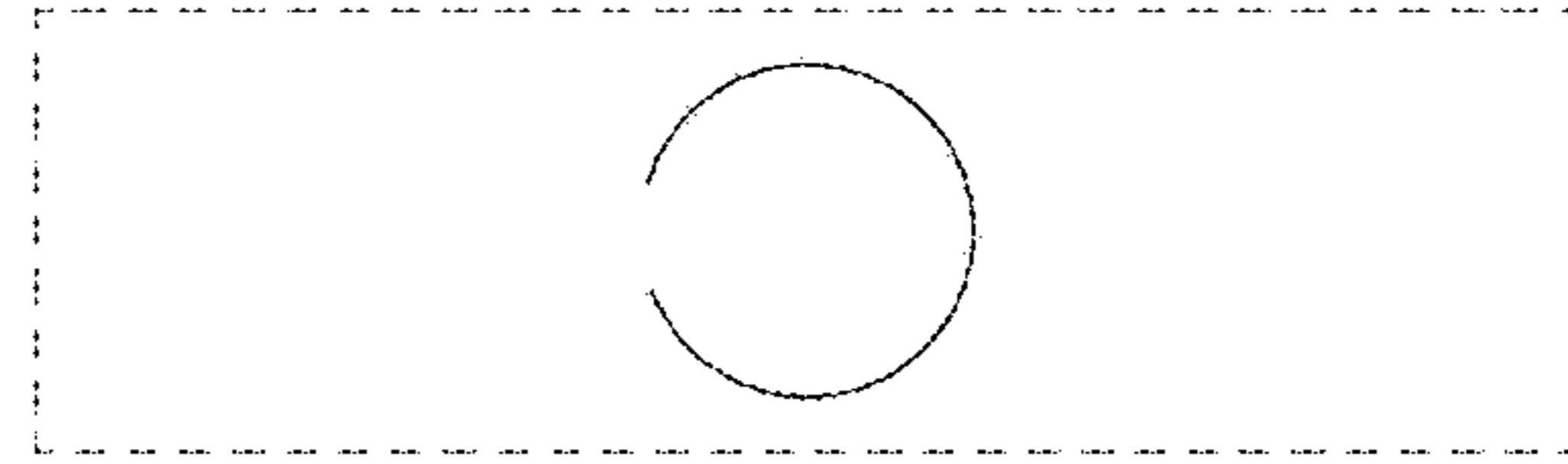

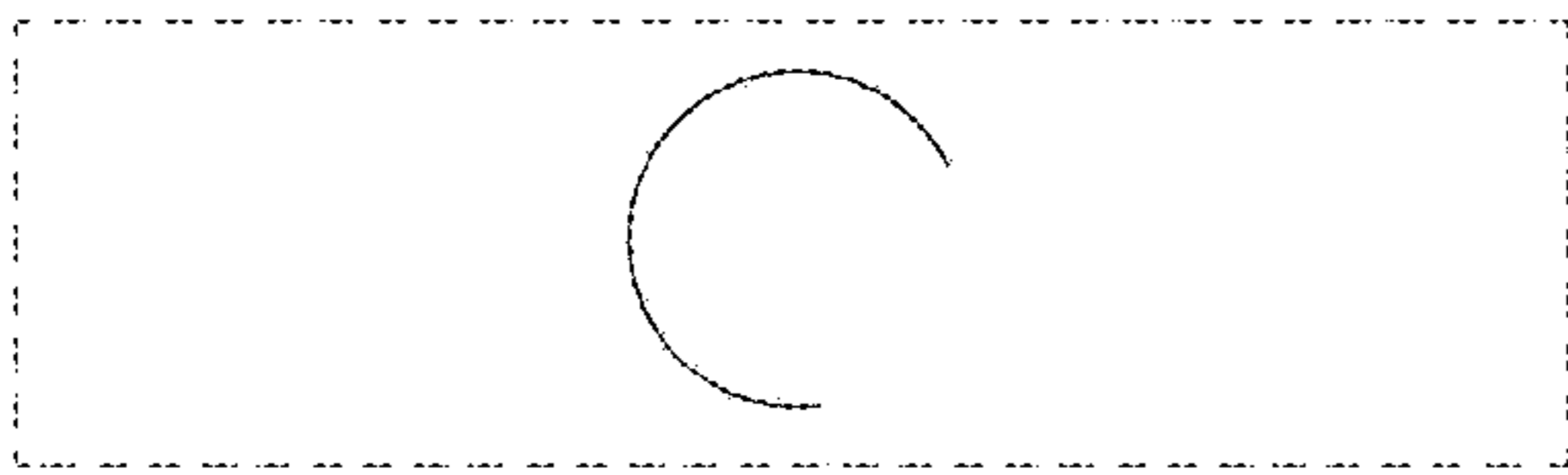

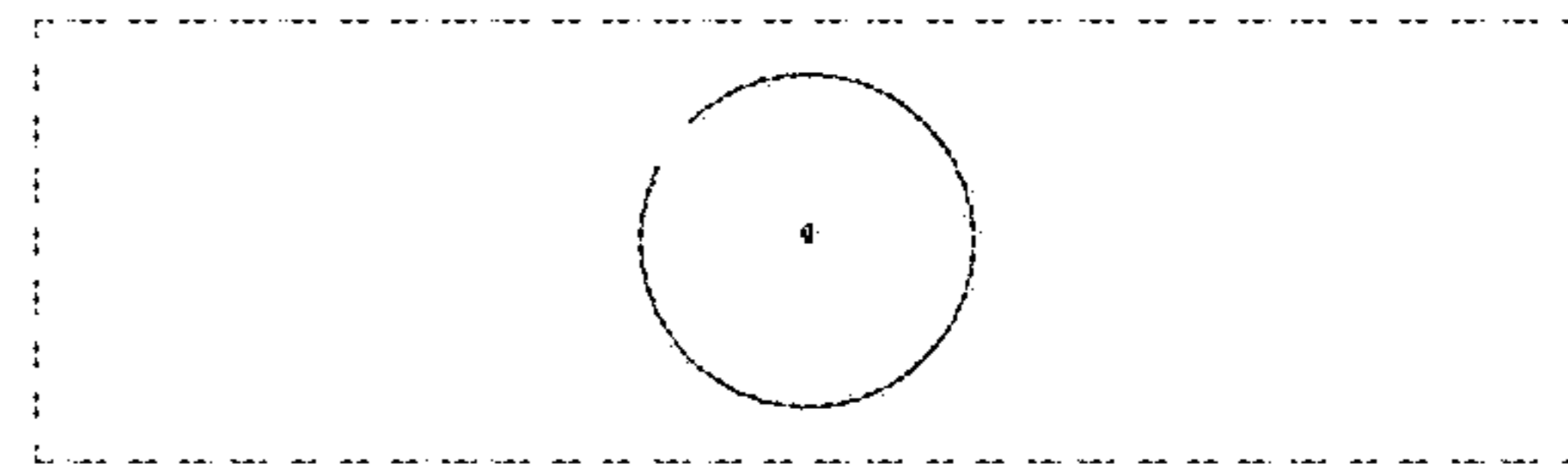

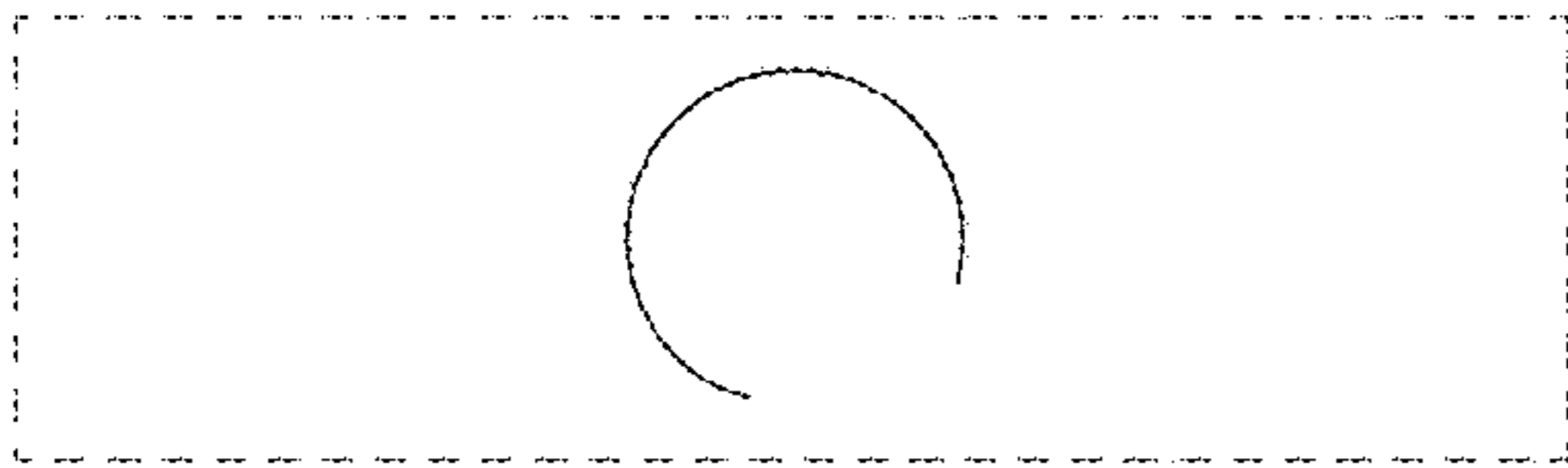

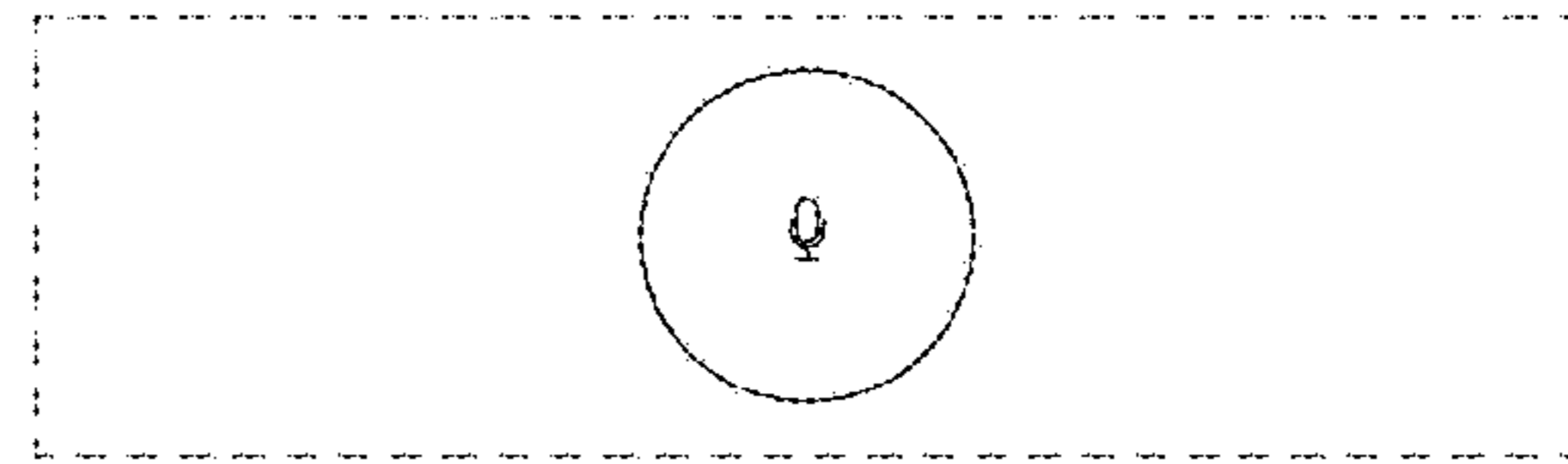

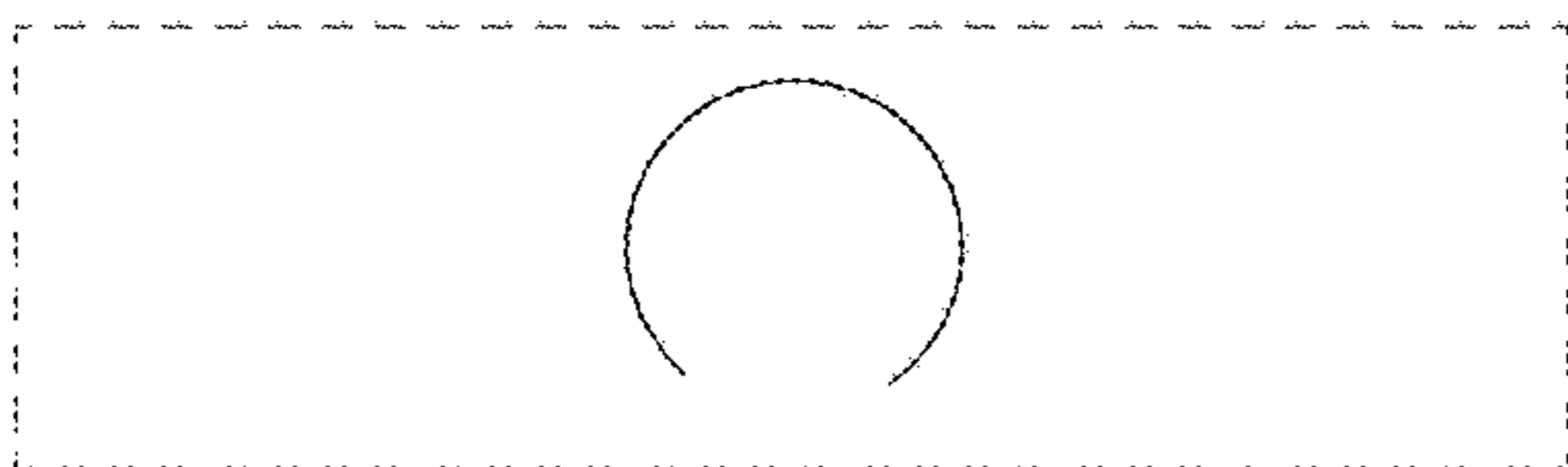

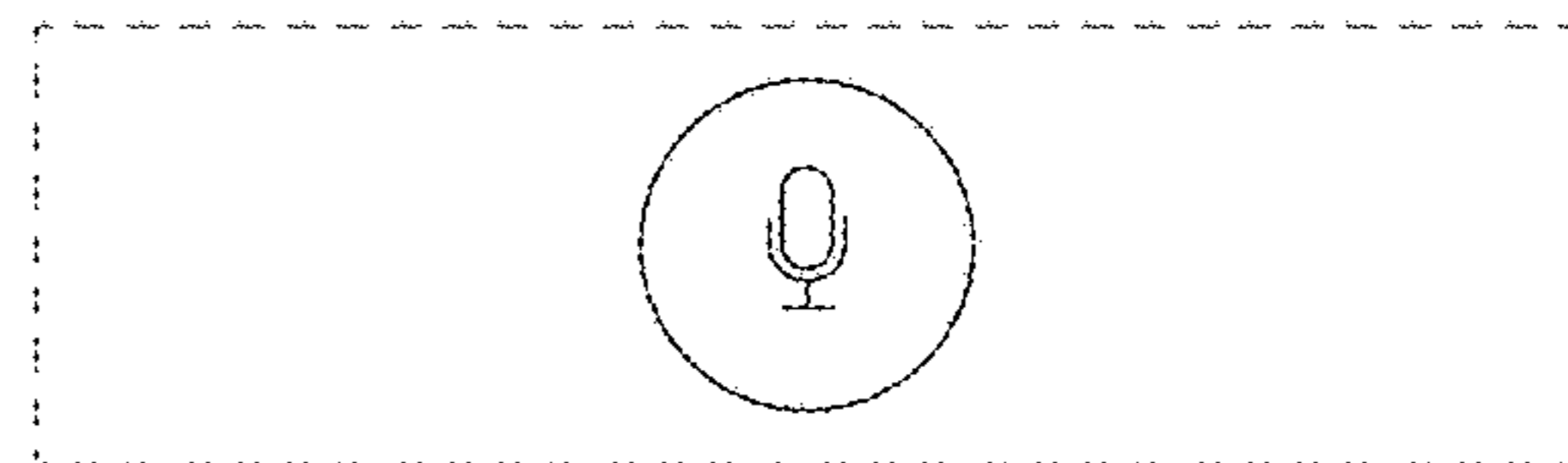

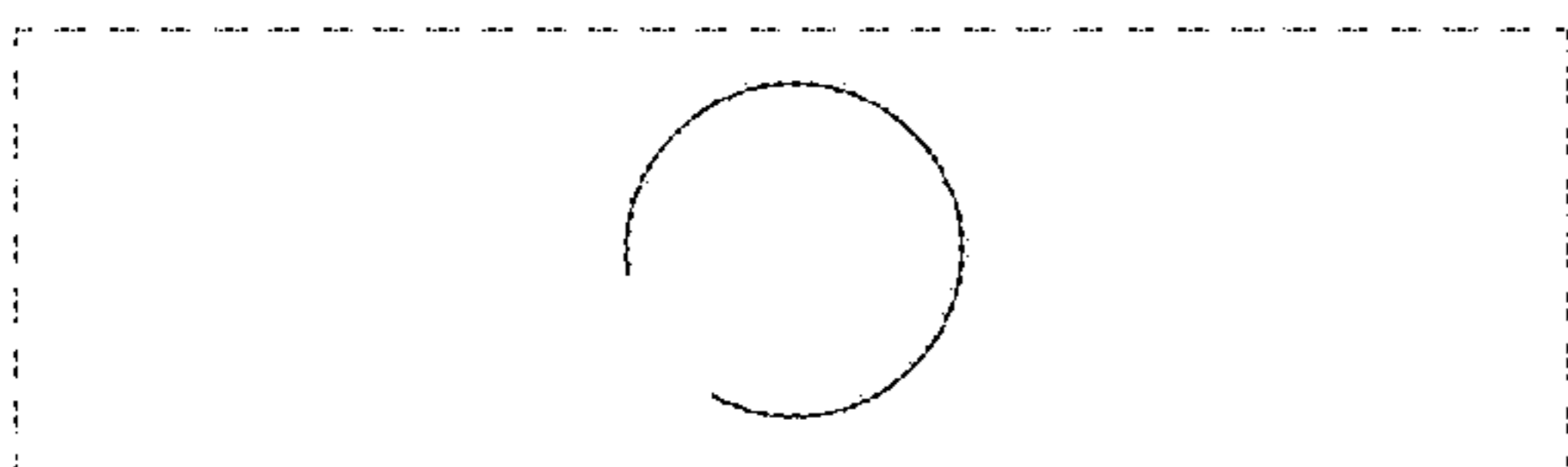

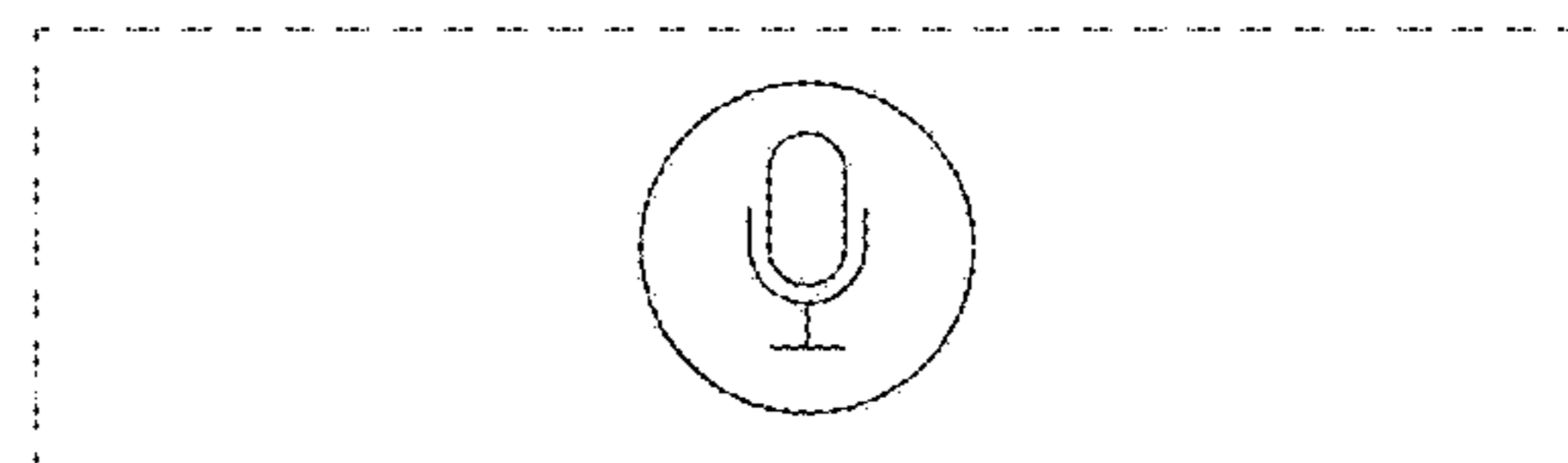
