DESCRIPTION

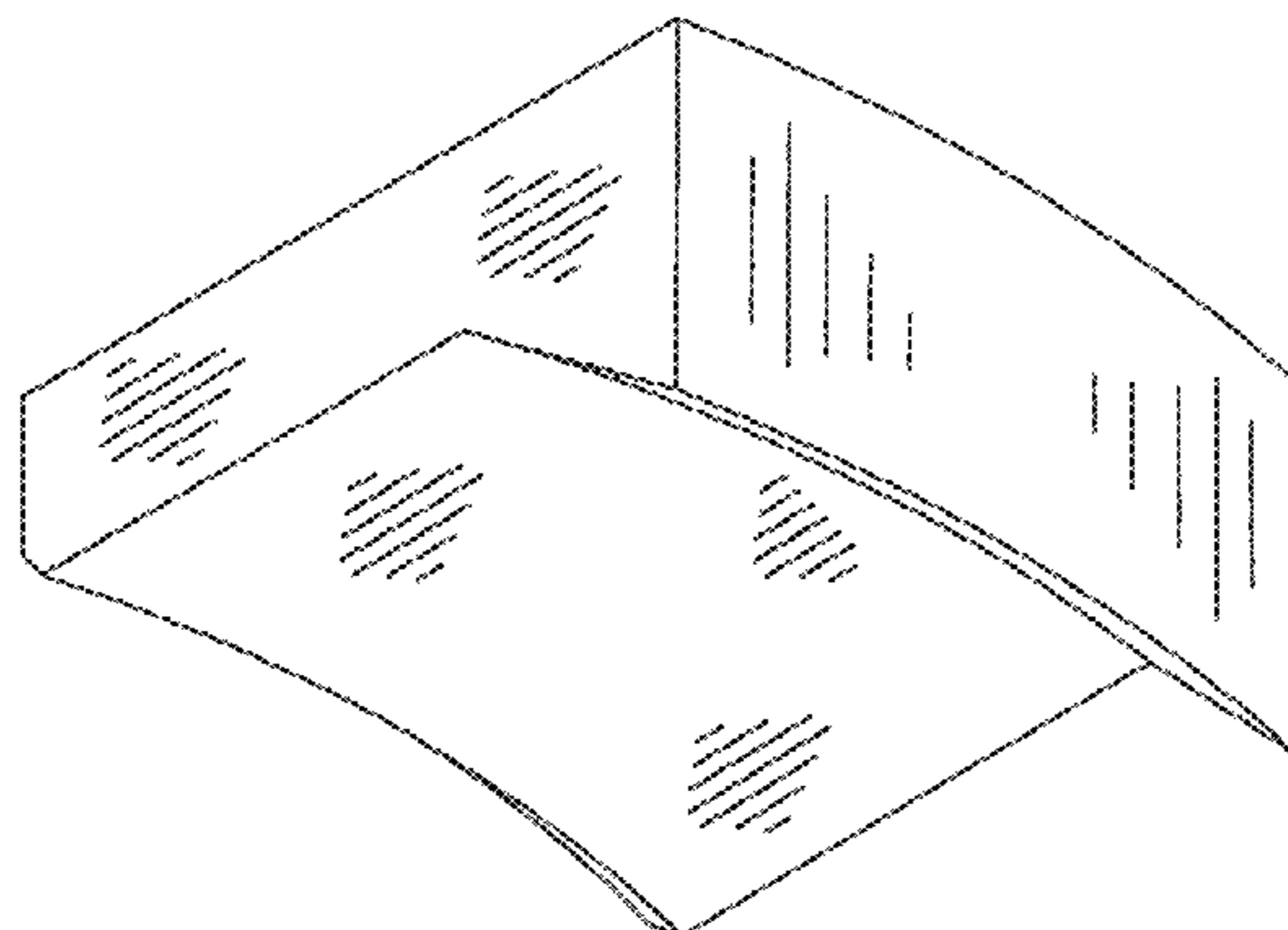
FIG. 1 is a lower perspective view of an RPM sensor for an automated clutch system showing my new design.

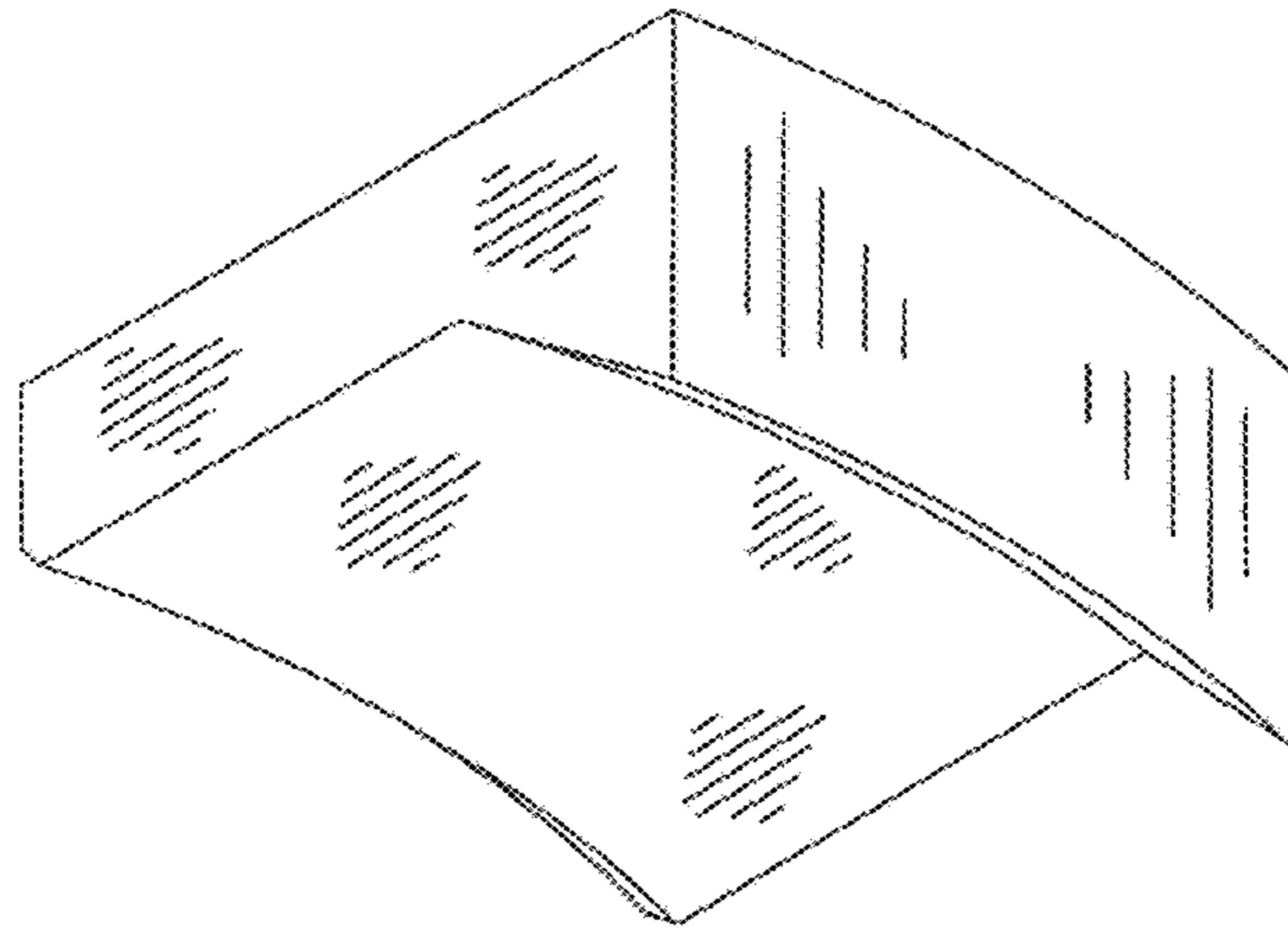

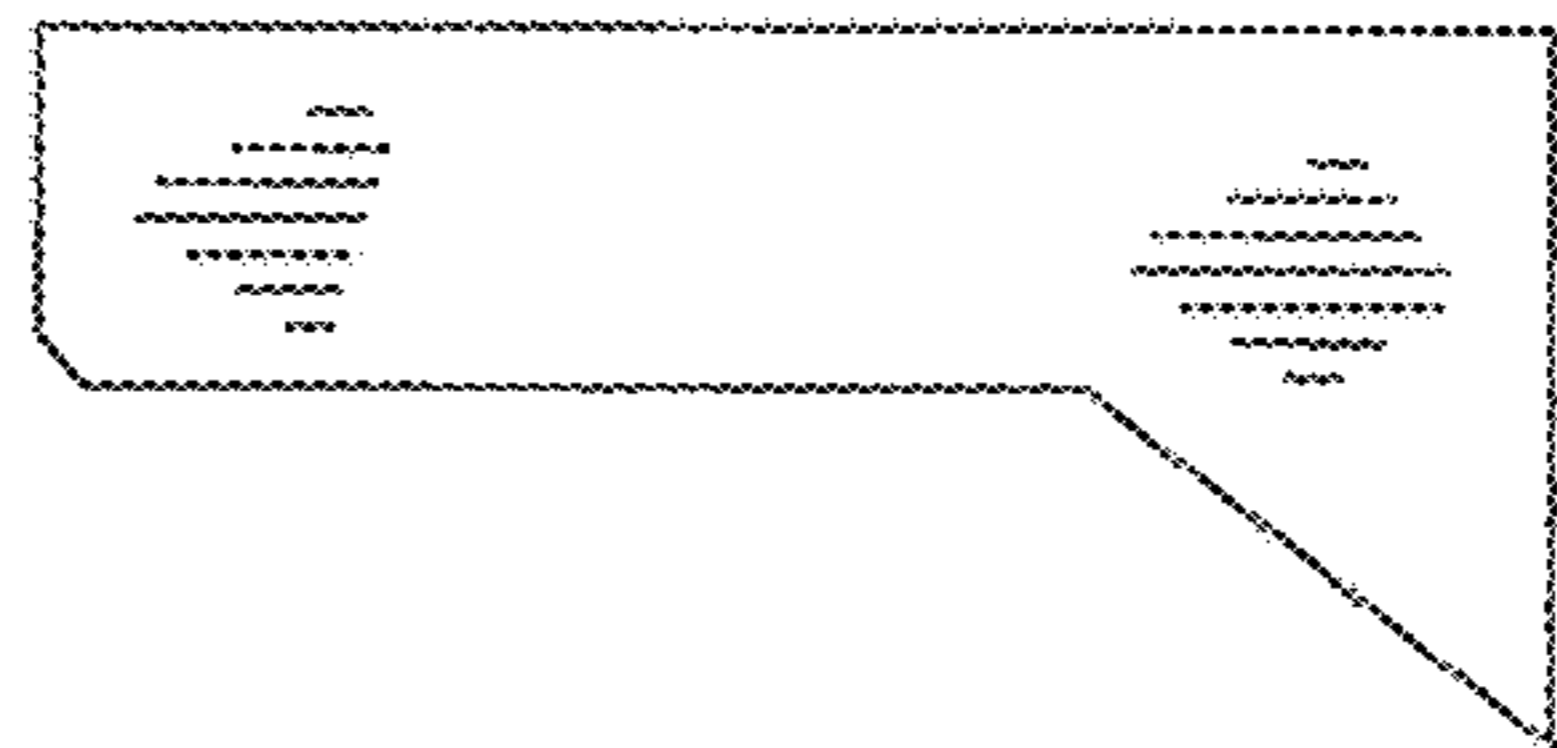

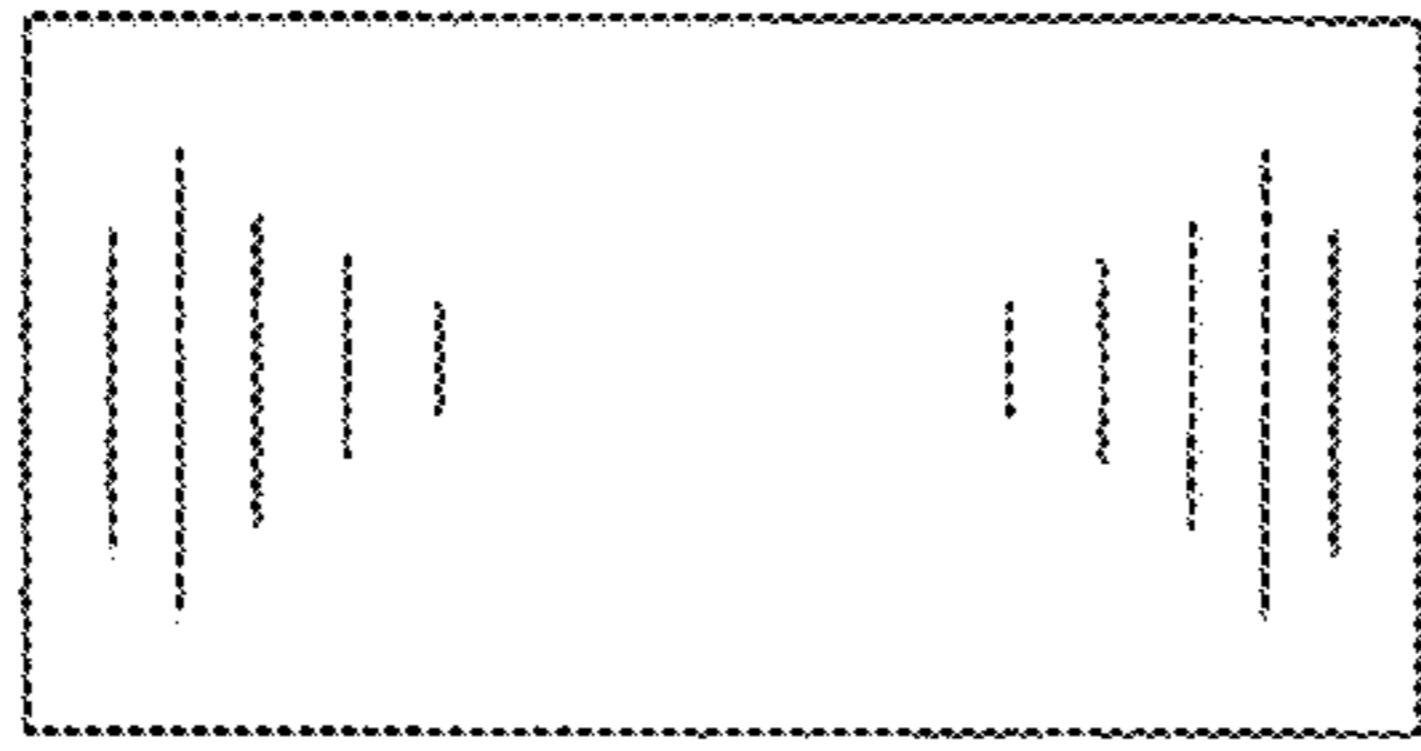

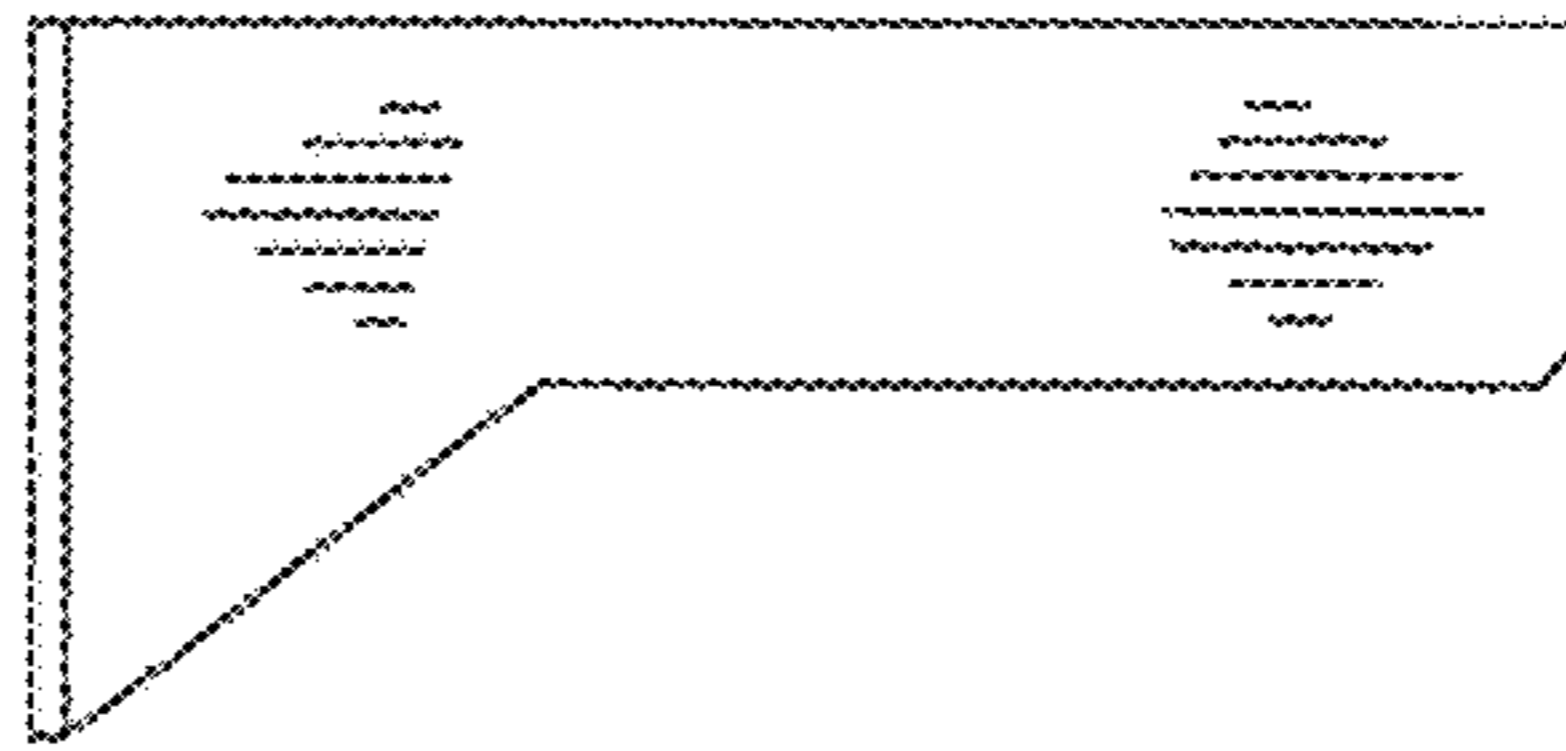

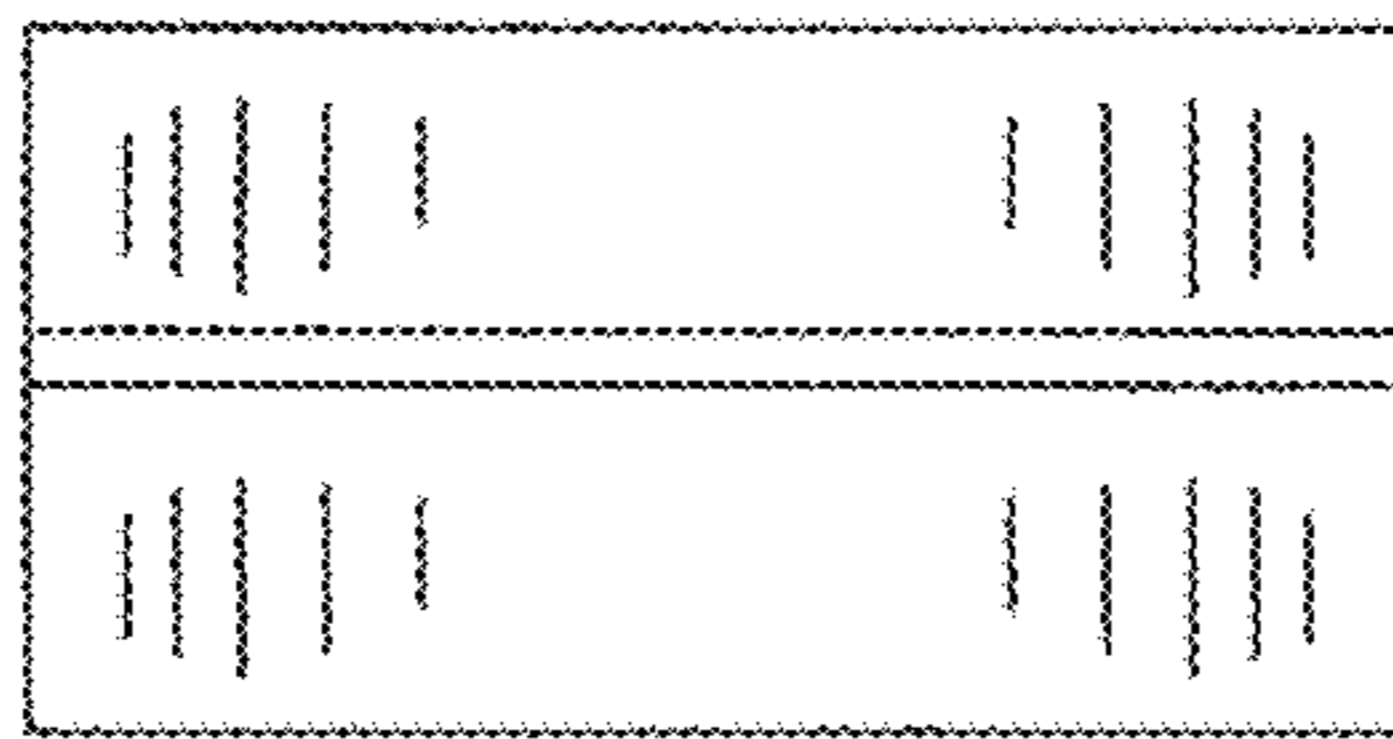

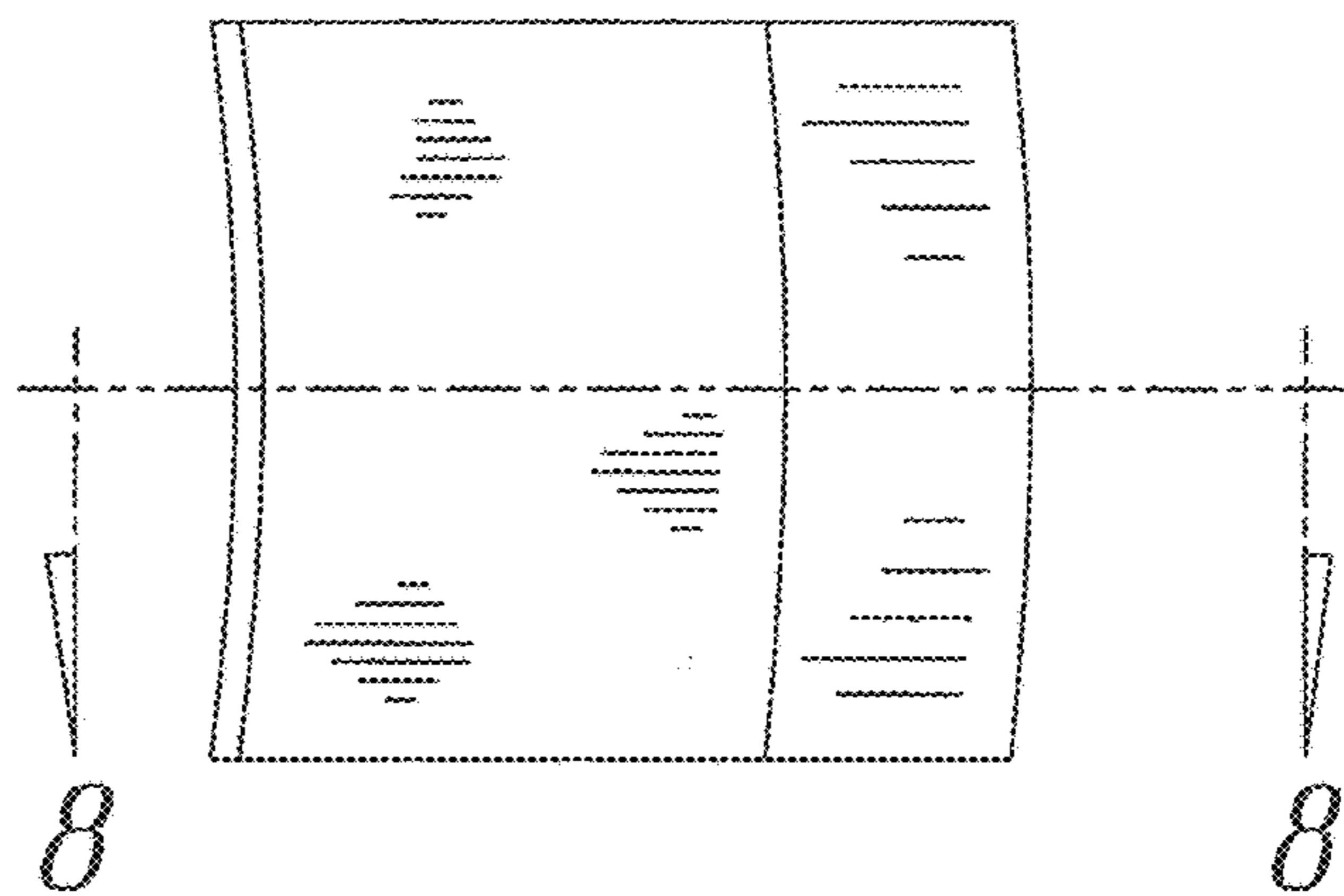

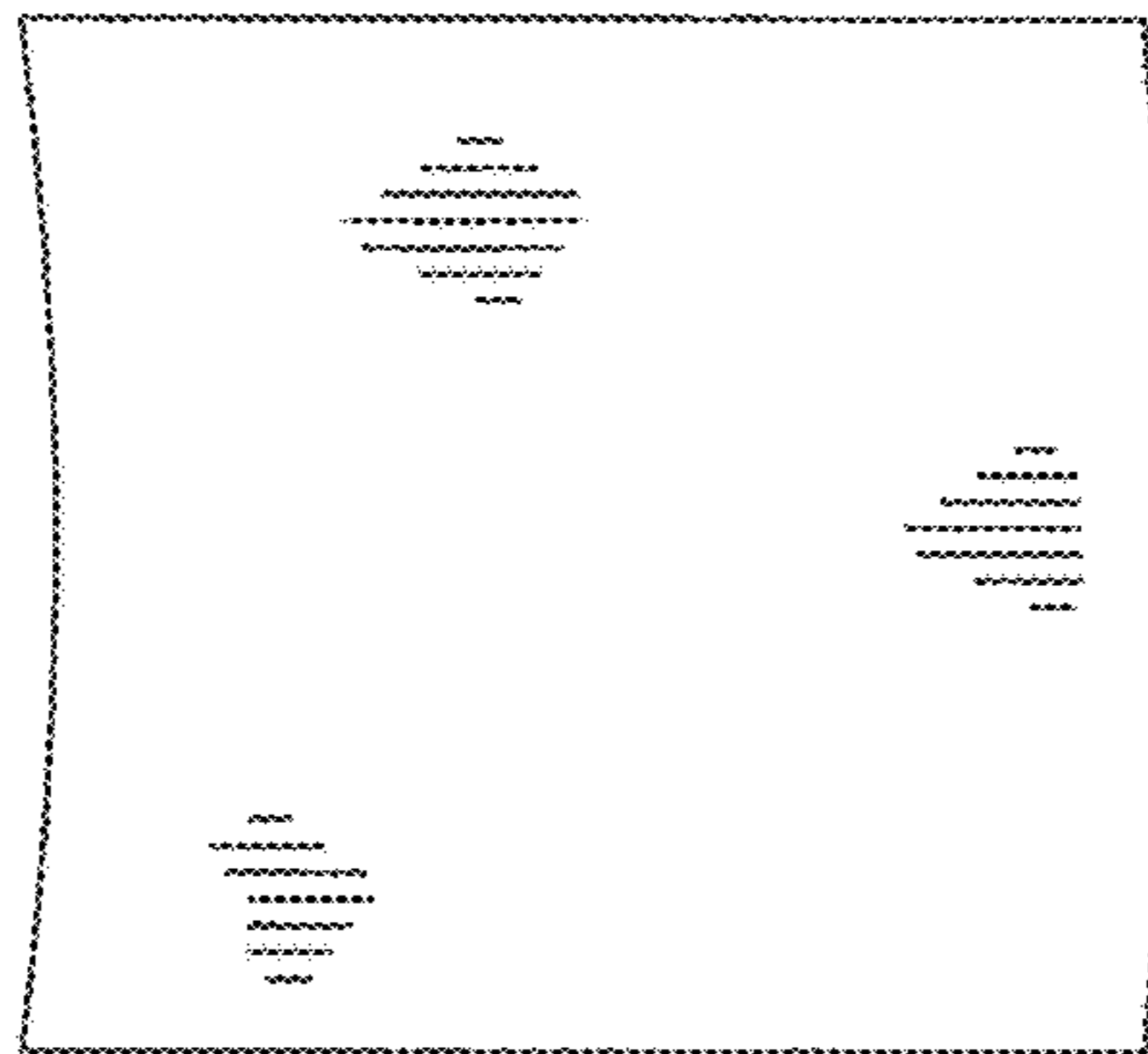
