(57) **CLAIM**

The ornamental design for a decorative display, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric top, front, and left side view of a decorative display showing our new design;  
FIG. 2 is a front elevational view of the decorative display of FIG. 1;  
FIG. 3 is a rear elevational view of the decorative display of FIG. 1;  
FIG. 4 is a left side elevational view of the decorative display of FIG. 1;  
FIG. 5 is a right side elevational view of the decorative display of FIG. 1;  
FIG. 6 is a top plan view of the decorative display of FIG. 1; and,  
FIG. 7 is a bottom plan view of the decorative display of FIG. 1.

The dashed lines are for the purpose of illustrating environmental structure, and form no part of the claimed design. The decorative display is made from a flexible material.

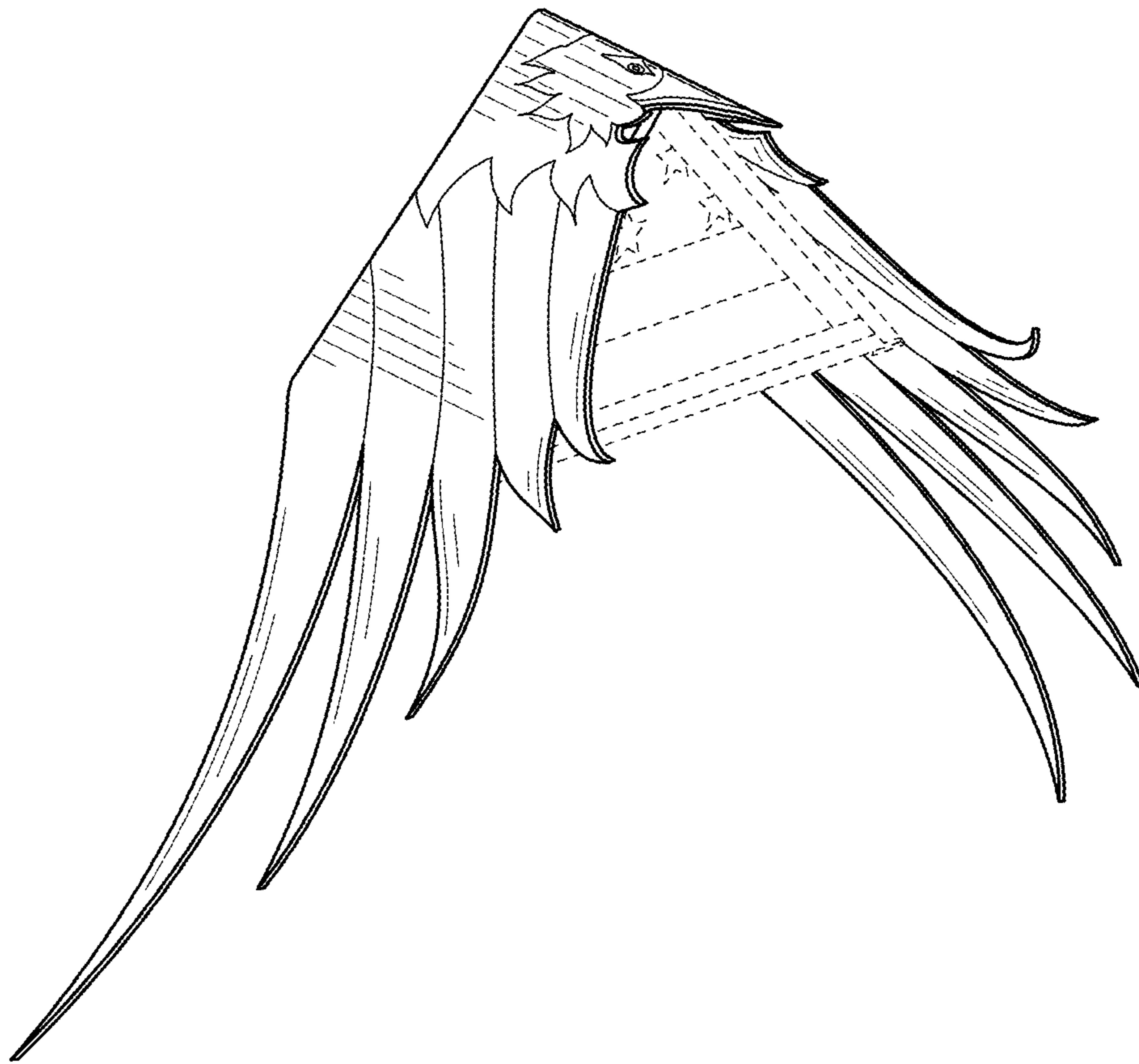

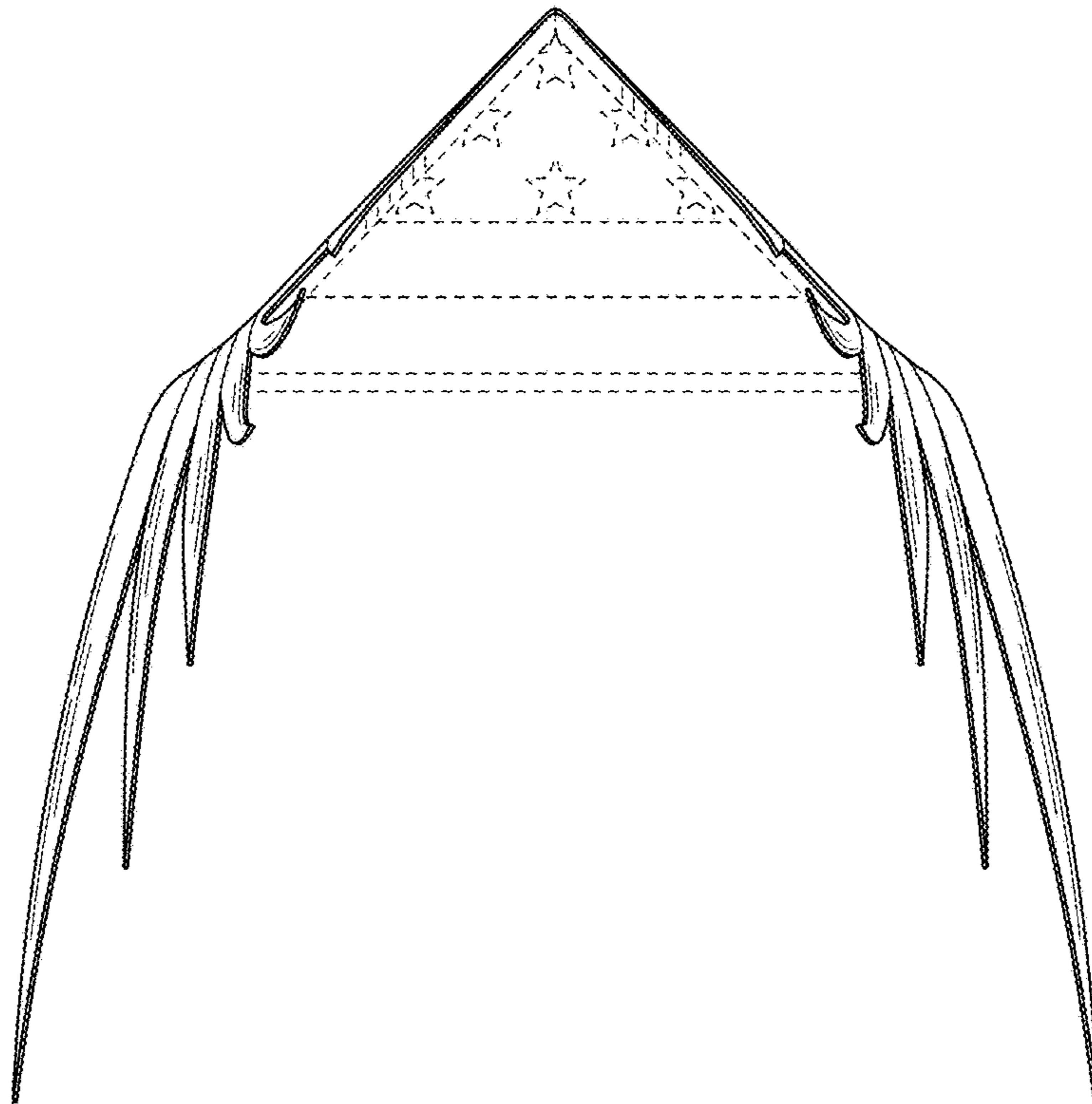

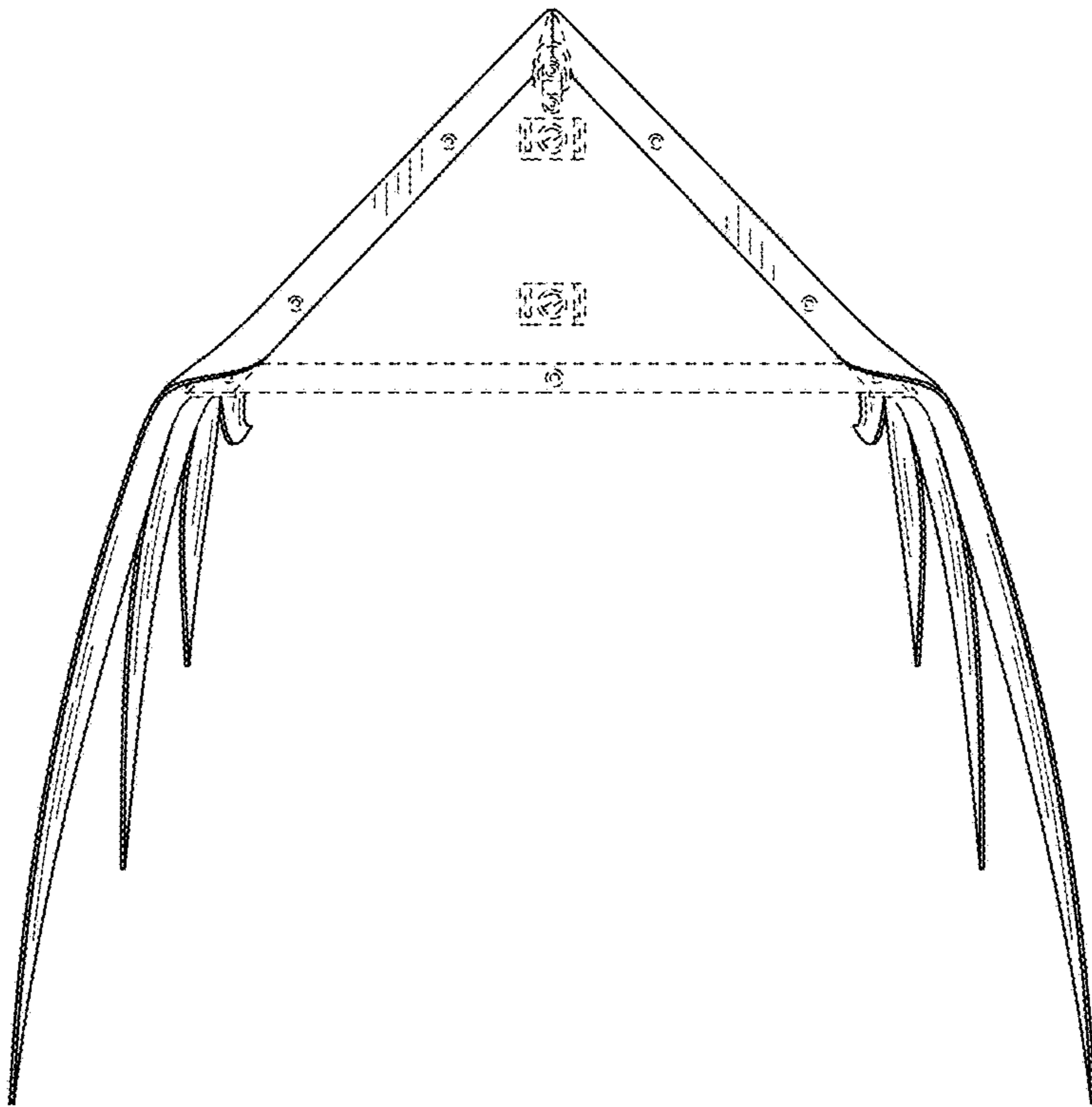




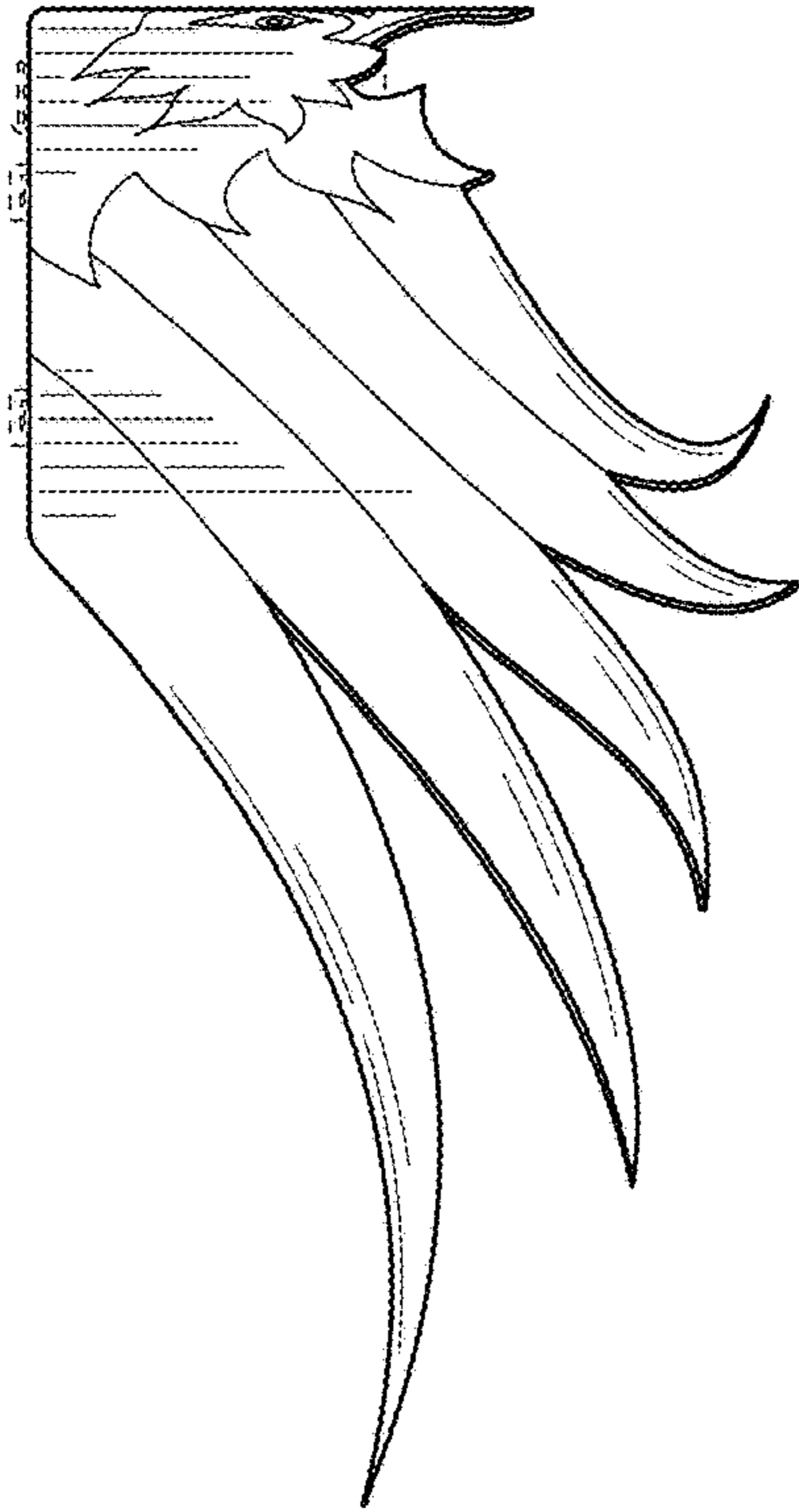

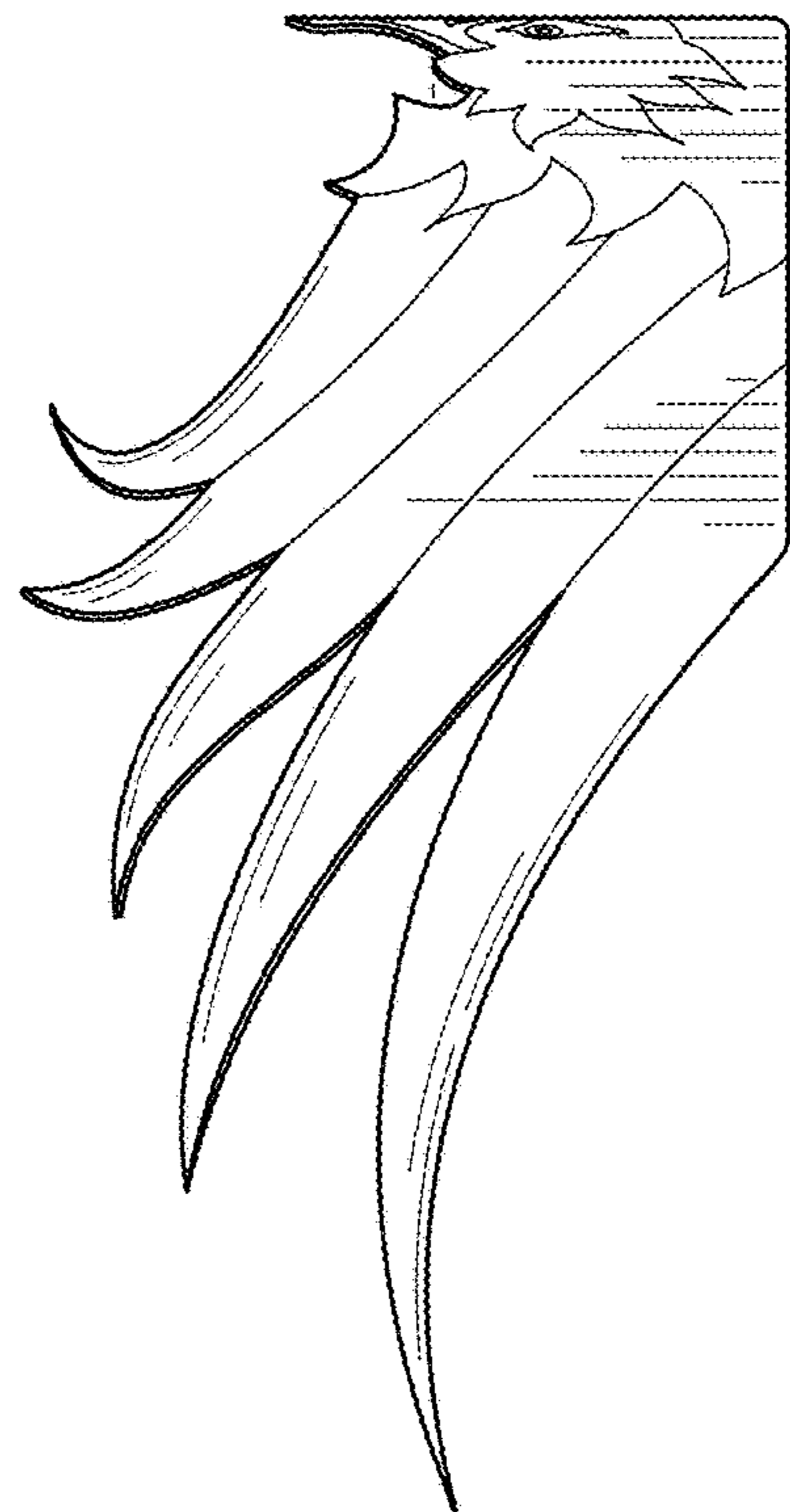

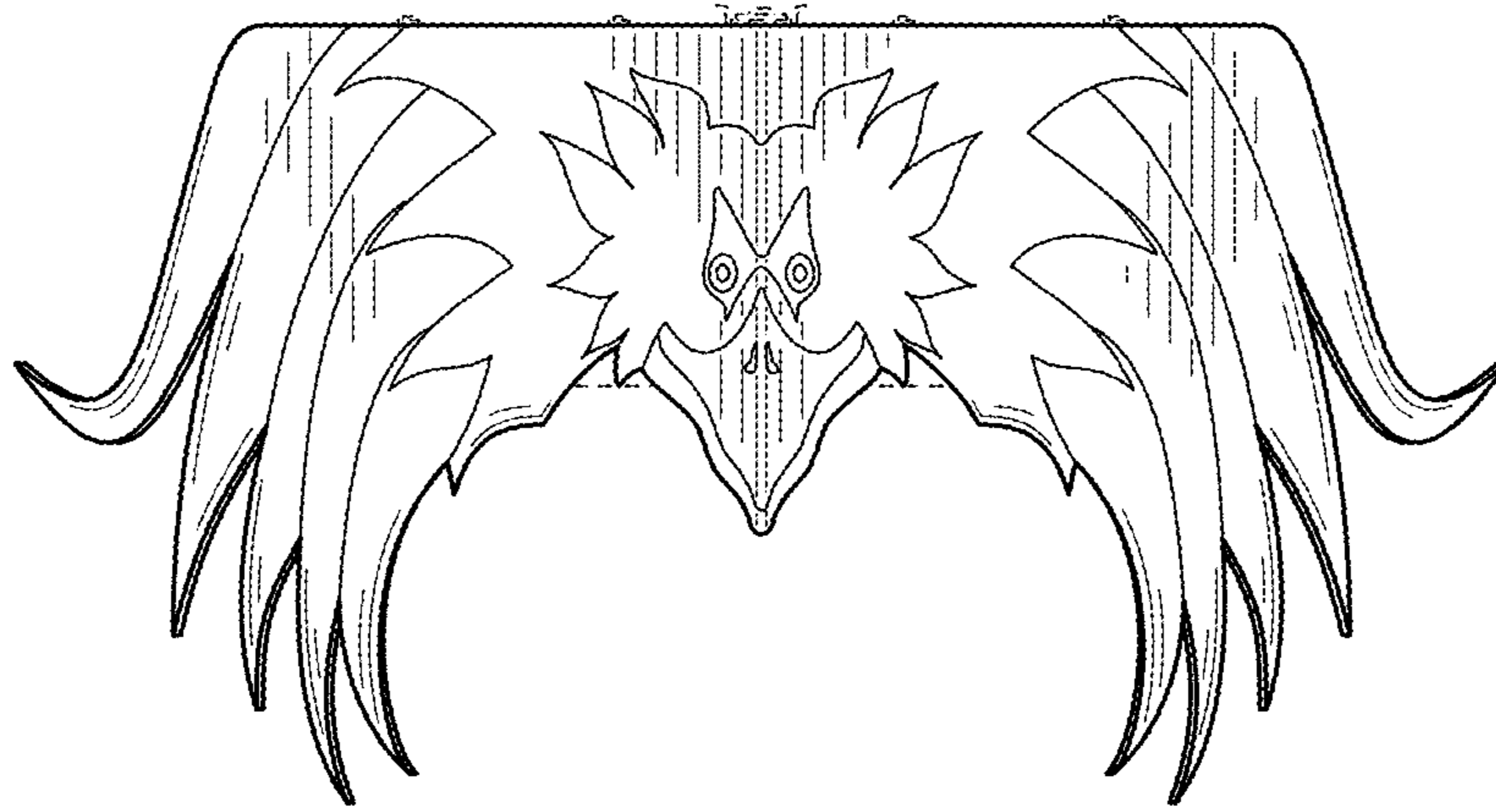

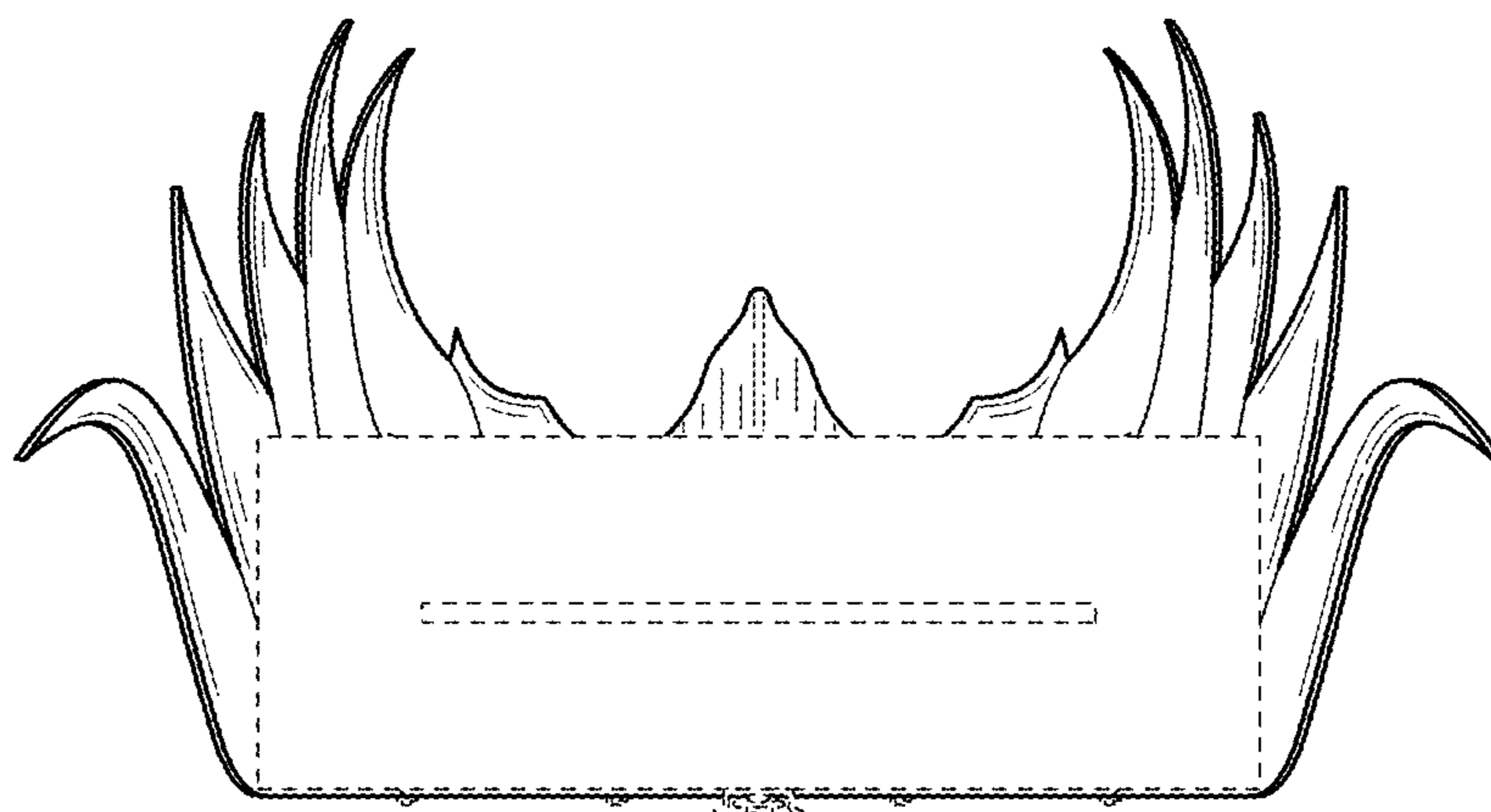
